

2 PETER IN RECENT RESEARCH: A BIBLIOGRAPHY

MICHAEL J. GILMOUR*

In a 1979 *JETS* article John Snyder called attention to the scholarly neglect of 2 Peter. To help address this situation, he provided a bibliography which he hoped would “stimulate a more aggressive and creative study of this still valuable letter.”¹ As the following bibliography suggests, there have been positive steps taken in this direction.² Two subsequent additions to Snyder’s collection filled out the state of affairs in scholarly analysis of this writing up to 1982.³ What follows is a collection of various contributions made to 2 Peter research since then.
