# A Priori Estimates for Free Boundary Problem of Incompressible Inviscid Magnetohydrodynamic Flows

#### Abstract

In the present paper, we prove the a priori estimates of Sobolev norms for a free boundary problem of the incompressible inviscid magnetohydrodynamics equations in all physical spatial dimensions $n=2$ and 3 by adopting a geometrical point of view used in Christodoulou and Lindblad (Commun Pure Appl Math 53:1536-1602, 2000), and estimating quantities such as the second fundamental form and the velocity of the free surface. We identify the well-posedness condition that the outer normal derivative of the total pressure including the fluid and magnetic pressures is negative on the free boundary, which is similar to the physical condition (Taylor sign condition) for the incompressible Euler equations of fluids.

## 1. Introduction

### 1.1. Formulation of the Problem and Main Results

In the present paper, we consider the following incompressible inviscid magnetohydrodynamics (MHD) equations

v_{t}+v \cdot \partial v+\partial p=\frac{1}{4 \pi}\left(B \cdot \partial B-\frac{1}{2} \partial|B|^{2}\right), & \text { in } \mathscr{D}  \tag{1.1a}\\
B_{t}+v \cdot \partial B=B \cdot \partial v, & \text { in } \mathscr{D}  \tag{1.1b}\\
\operatorname{div} v=0, \quad \operatorname{div} B=0, & \text { in } \mathscr{D} \tag{1.1c}
\end{align*}

describing the motion of conducting fluids in an electromagnetic field, where the velocity field of the fluids $v=\left(v_{1}, \ldots, v_{n}\right)$, the magnetic field $B=\left(B_{1}, \ldots, B_{n}\right)$, the fluid pressure $p$ and the domain $\mathscr{D} \subset[0, T] \times \mathbb{R}^{n}$ are the unknowns to be determined. Here $n \in\{2,3\}$ is the spatial dimension, $\frac{1}{4 \pi} B \cdot \partial B$ is the magnetic tension, $\frac{1}{8 \pi}|B|^{2}$ is the magnetic pressure, $p+\frac{1}{8 \pi}|B|^{2}$ is so called total pressure which will be denoted by $P$ in this paper, and $|B|=\left(\sum_{j=1}^{n} B_{j}^{2}\right)^{1 / 2}$ is the modulus of $B . \partial=\left(\partial_{1}, \ldots, \partial_{n}\right)$ and div are the usual gradient operator and spatial divergence under Eulerian coordinates.

Given a simply connected bounded domain $\mathscr{D}_{0} \subset \mathbb{R}^{n}$ and the initial data $v_{0}$ and $B_{0}$ satisfying the constraints $\operatorname{div} v_{0}=0$ and $\operatorname{div} B_{0}=0$, we want to find a set
$\mathscr{D} \subset[0, T] \times \mathbb{R}^{n}$ and the vector fields $v$ and $B$ solving (1.1) and satisfying the initial conditions:

Throughout the paper, we use the Einstein summation convention, that is, when an index variable appears twice in both the subscript and the superscript of a single term it implies summation of that term over all the values of the index.

Let $\mathscr{D}_{t}=\left\{x \in \mathbb{R}^{n}:(t, x) \in \mathscr{D}\right\}$, we also require the following boundary conditions on the free boundary $\partial \mathscr{D}_{t}$ :

for each $t \in[0, T]$ with $T>0$, where $\mathscr{N}$ is the exterior unit normal to $\partial \mathscr{D}_{t}$, $v_{\mathscr{N}}=\mathscr{N}^{i} v_{i}$, and $\kappa$ is the normal velocity of $\partial \mathscr{D}_{t}, \varsigma$ is a non-negative constant. Condition (1.3c) should be understood as the constraints on the initial data. Indeed, we will verify that the condition $B \cdot \mathscr{N}=0$ on $\partial \mathscr{D}_{t}$ holds for all $t \in[0, T]$ if it holds initially. We remark here on the physical meaning of the boundary conditions. Condition (1.3a) means that the boundary of $\mathscr{D}_{t}$ moves with the fluids, (1.3b) means that outside the fluid region $\mathscr{D}_{t}$ is the vacuum, the condition $B \cdot \mathscr{N}=0$ on $\mathscr{D}_{t}$ comes from the assumption that the boundary $\partial \mathscr{D}$ is a perfect conductor. Indeed, if we use $\mathbf{E}$ to denote the electric field induced by the magnetic field $B$, then the boundary condition $B \cdot \mathscr{N}=0$ on $\partial \mathscr{D}_{t}$ gives rise to $\mathbf{E} \times \mathscr{N}=0$ on $\partial \mathscr{D}_{t}$. The boundary condition $|B|=$ const on $\partial \mathscr{D}_{t}$ (the magnetic strength is constant on the boundary) is needed to guarantee that the total energy of the system is conserved, that is,

\frac{\mathrm{d}}{\mathrm{dt}} \int_{\mathscr{D}_{t}}\left(\frac{1}{2}|v|^{2}+\frac{1}{8 \pi}|B|^{2}\right)(t, x) \mathrm{d} x=0 .

Condition (1.3c) includes the widely used (e.g., [12]) zero magnetic field boundary condition as the special case, but it is much more general and physically reasonable.

In the classical plasma-vacuum interface problem (cf. [10,23]), suppose that the interface between the plasma region $\Omega_{p}(t)$ and the vacuum region $\Omega_{v}(t)$ is $\Gamma(t)$ which moves with the plasma, then it requires that (1.1) holds in the plasma region $\Omega_{p}(t)$, while in the vacuum region $\Omega_{v}(t)$, the vacuum magnetic field $\mathscr{B}$ satisfies

On the interface $\Gamma(t)$, it holds that

where $\mathscr{N}$ is the unit normal to $\Gamma(t)$. Therefore, the boundary conditions in (1.3) also model the plasma-vacuum problem for the case when $|\mathscr{B}|$ is constant.

We will prove a priori bounds for the free boundary problem (1.1)-(1.3) in Sobolev spaces under the following condition

where $\nabla_{\mathscr{N}}=\mathscr{N}^{i} \partial_{i}$. We assume that this condition holds initially, and will verify that it holds true within a period. For the free boundary problem of the motion of incompressible fluids in vacuum, without magnetic fields, the natural physical condition (cf. [2,4,5,8, 15-17,21,24,25,27]) reads that

which excludes the possibility of the Rayleigh-Taylor type instability (see [8]). In this paper, we find that the natural physical condition is (1.6) when the equations of magnetic field couple with the fluids equation. In fact, the quantity $p+\frac{1}{8 \pi}|B|^{2}$, the total pressure of the system, will play an important role in our analysis. Roughly speaking, the velocity tells the boundary where to move, and the boundary is the level set of the total pressure that determines the acceleration.

The free surface problem of the incompressible Euler equations of fluids has attracted much attention in the recent decades. Important progress has been made for flows with or without vorticity, and with or without surface tension. We refer readers to $[1,4,5,8,15-17,21,24,25,27]$.

On the other hand, there have been only few results on the interface problems for the MHD equations. This is due to the difficulties caused by the strong coupling between the velocity fields and magnetic fields. In this direction, the well-posedness of a linearized compressible plasma-vacuum interface problem was investigated in [23], and a stationary problem was studied in [9]. The current-vortex sheets problem was studied in [3] and [22]. For the incompressible viscous MHD equations, a free boundary problem in a simply connected domain of $\mathbb{R}^{3}$ was studied by a linearization technique and the construction of a sequence of successive approximations in [18] with an irrotational condition for magnetic fields in a part of the domain.

In this paper, we prove the a priori estimates for the free boundary problem (1.1)(1.3) in all physical spatial dimensions $n=2,3$ by adopting a geometrical point of view used in [4], and estimating quantities such as the second fundamental form and the velocity of the free surface. Denote the material derivative $D_{t}=\partial_{t}+v \cdot \partial$ and the total pressure $P=p+\frac{1}{8 \pi}|B|^{2}$, we can write the free boundary problem as

We will derive the energy estimates from which the Sobolev norms of $H^{s}\left(\mathscr{D}_{t}\right)$ $(\mathbb{N} \ni s \leqslant n+1)$ of solutions will be derived. For this purpose, we define the energy norms as follows: the zeroth-order energy, $E_{0}(t)$, is defined as the total energy of the system, that is,

which is conserved, that is,

The higher order energy norm has a boundary part and an interior part. The boundary part controls the norms of the second fundamental form of the free surface, the interior part controls the norms of the velocity, magnetic fields and hence the pressure. We will prove that the time derivatives of the energy norms are controlled by themselves. A crucial point in the construction of the higher order energy norms is that the time derivatives of the interior parts will, after integrating by parts, contribute some boundary terms that cancel the leading-order terms in the corresponding time derivatives of the boundary integrals. To this end, we need to project the equations for the total pressure $P=p+\frac{1}{8 \pi}|B|^{2}$ to the tangent space of the boundary. The orthogonal projection $\Pi$ to the tangent space of the boundary of a $(0, r)$ tensor $\alpha$ is defined to be the projection of each component along the normal:

with $\mathscr{N}^{j}=\delta^{i j} \mathscr{N}_{i}=\mathscr{N}_{j}$.
Let $\bar{\partial}_{i}=\Pi_{i}^{j} \partial_{j}$ be a tangential derivative. If $q=$ const on $\partial \mathscr{D}_{t}$, it follows that $\bar{\partial}_{i} q=0$ there and

where $\theta_{i j}=\bar{\partial}_{i} \mathscr{N}_{j}$ is the second fundamental form of $\partial \mathscr{D}_{t}$.
The higher order energies are defined as: for $r \geqslant 1$

where $I(r)=0$ if $r=1$ and $I(r)=1$ if $r>1$, so we do not need the boundary integral for $r=1$, and

Here $Q$ is a positive definite quadratic form which, when restricted to the boundary, is the inner product of the tangential components, that is, $Q(\alpha, \beta)=\langle\Pi \alpha, \Pi \beta\rangle$, and in the interior $Q(\alpha, \alpha)$ increases to the norm $|\alpha|^{2}$. To be more specific, let

Here $\eta$ is a smooth cutoff function satisfying $0 \leqslant \eta(d) \leqslant 1, \quad \eta(d)=1$ when $d<d_{0} / 4$ and $\eta(d)=0$ when $d>d_{0} / 2 . d_{0}$ is a fixed number that is smaller than the injectivity radius of the normal exponential map $\iota_{0}$, defined to be the largest number $t_{0}$ such that the map

The main theorems in this paper are as follows:
Theorem 1.1. For any smooth solution of the free boundary problem (1.8) for $0 \leqslant t \leqslant T$ satisfying

Theorem 1.2. Let $r \in\{2, \ldots, n+1\}$, then there exists a $T>0$ such that the following holds: For any smooth solution of the free boundary problem (1.8) for $0 \leqslant t \leqslant T$ satisfying

where the positive constants $C_{1}$ and $C_{2}$ depend on $K, K_{1}, M, M_{1}, L, 1 / \varepsilon$, Vol $\mathscr{D}_{t}$, $E_{0}(0), E_{1}(0), \ldots$, and $E_{r-1}(0)$.

Most of the a priori bounds (1.20)-(1.24) can be obtained from the energy norms by the elliptic estimates which are used to control all components of $\partial^{r} v$, $\partial^{r} B$ and $\partial^{r} p$ from the tangential components $\Pi \partial^{r} P$ in the energy norms, and a bound for the second fundamental form of the free boundary

for $r \geqslant 2$, which controls the regularity of the free boundary.
Since $E_{0}(t)=E_{0}(0)$ and $\operatorname{Vol} \mathscr{D}_{t}=\operatorname{Vol} \mathscr{D}_{0}$, recursively we can prove the following main theorem from Theorems 1.1, 1.2.

Theorem 1.3. Let

then any smooth solution of the free boundary problem for MHD equations (1.8) for $0 \leqslant t \leqslant T$ satisfies

In order to prove the above theorems, we need to use the elliptic estimates of the pressure $p$. However, the time derivative of $\Delta p$ involves a third-order term of the velocity which needs to be controlled by higher order energies. In order to overcome this difficulty, we work on the equations for the total pressure $P=p+\frac{1}{8 \pi}|B|^{2}$, instead of those for the fluid pressure $p$.

Before we close this introduction, we mention here some studies on viscous or inviscid MHD equations, including the Cauchy problem or initial boundary value problems for the fixed boundaries $[6,7,11-14,18-20,26]$ and the references therein.

The rest of this paper is organized as follows. In Section 1.2 we give more remarks on the motivations of the construction of the higher order energy functional $E_{r}(t)$ in (1.13) and outline of the proof of our theorems. In Section 2, we use the Lagrangian coordinates to transform the free boundary problem to a fixed initial boundary problem. The Lagrangian transformation induces a Riemannian metric on $\mathscr{D}_{0}$, for which we recall the time evolution properties derived in [4] and prove some new identities which will be used later. We also write the equations in Lagrangian coordinates, by using the covariant spatial derivatives with respect to the Riemannian metric induced by the Lagrangian transformation, instead of using the ordinary derivatives. In Section 3, we prove the conservation of the zeroth order energy $E_{0}(t)$, from which one can see that the boundary conditions on the magnetic fields $B$ is necessary for this energy conservation. We also prove in Section 3 that the condition $B \cdot \mathscr{N}=0$ on the boundary propagates along the boundary.

Section 4 is devoted to the first order energy estimates. In Section 5, we prove the higher order energy estimates by using the identities derived in Section 2, the time evolution property of the metric on the boundary induced by the above mentioned Riemannian metric induced by the Lagrangian transformation, the projection properties and the elliptic estimates. In the derivation of the higher order energy estimates in Section 5 some a priori assumptions are made which will be justified in Section 6. We also give an appendix on some estimates used in the previous sections, which are basically proved in [4].

### 1.2. Motivation of the Construction of Higher Order Energy Functional and Outline of the Proofs

We give more remarks on the motivations of the construction of the higher order energy functional $E_{r}(t)$ in (1.13) and outline of the proof of our theorems here. First, for divergence free vector fields, the $L^{2}$ norms of curl and tangential (or normal) derivatives control the $L^{2}$ norms of the derivatives of the vector fields [cf. (A.15)]. Therefore, the interior integral part in (1.13) controls the $L^{2}$ norms of $\partial^{r} v$ and $\partial^{r} B$. The reason for using $\partial^{r-1}$ curl $v$ and $\partial^{r-1}$ curl $B$ in the interior integral part of (1.13) is that it is relatively easy to obtain the estimates of the Sobolev norms of curl $v$ and curl $B$ by using the equations for them. The time derivative of the interior integral part of $E_{r}(t)$ produces a boundary integral term after the integration by parts, which cannot be bounded by the interior integral part of $E_{r}(t)$ directly. We need a boundary integral to cancel the leading term of it. The time derivative of the boundary integral $\int_{\partial \mathscr{D}}$ Q $Q\left(\partial^{r} P, \partial^{r} P\right) \vartheta \mathrm{d} S(r \geqq 2)$ in (1.13) which involves the projection of the $r$-th derivatives of the total pressure $P=p+\frac{1}{8 \pi}|B|^{2}$ to the tangent space of the boundary is constructed for this purpose, for example, when $r=2$, we make use of the following second-order equations for the velocity and the total pressure

One can use elliptic estimates to control all components of $\partial^{r} v, \partial^{r} B$ and $\partial^{r} P$ from the energy functional $E_{r}(t)$, by the Dirichlet problems of the elliptic equations for the total pressure $P$ and its Lagrangian time derivative $D_{t} P$ for which one has the boundary conditions $P=$ const and $D_{t} P=0$ on $\partial \mathscr{D}_{t}$ [the elliptic equation for $P$ can be obtained by taking the divergence of (1.8a), and the elliptic equation for
$D_{t} P$ can be obtained by taking $D_{t}$ of the elliptic equation for $P$ and using (1.33)]. It should be noted that a bound of the higher order energy functional $E_{r}(t)$ also gives the bound of $\left\|\bar{\partial}^{r-2} \theta\right\|_{L^{2}\left(\partial \mathscr{D}_{t}\right)}$ by using a higher-order version of the projection formula (1.12) and the physical condition (1.6). Once we have the bounds for the second fundamental form $\left\|\bar{\partial}^{s-2} \theta\right\|_{L^{2}\left(\partial \mathscr{D}_{t}\right)}(2 \leqq s \leqq r)$, we can get estimates for solution of the Dirichlet problems for the elliptic equations of $P$ and $D_{t} P$. We outline the proof of the main theorem as follows. For $r \geqq 2$, integration by parts gives:

From the Sobolev lemma (cf. [4]), the Hölder inequality and the assumption of Theorem 1.1, one can estimate the term (1.34) for $r=2$ and $r \geqslant 3$ separately.

The integral (1.35) can be bounded $C K E_{r}^{1 / 2}(t)\left\|\partial^{r} P\right\|_{L^{2}\left(\mathscr{D}_{t}\right)}$ by the Hölder inequality. The estimate for $\left\|\partial^{r} P\right\|_{L^{2}\left(\mathscr{D}_{t}\right)}$ can be obtained by the elliptic estimates, a higher-order version of the projection formula (1.12) and the physical condition (1.6). For the estimate of the boundary integral (1.36), we notice that the tangential derivative $P$ on $\partial \mathscr{D}_{t}$ vanishes to infer that

Since $D_{t} P=0$ on $\partial \mathscr{D}_{t}$, one can use the elliptic estimates to bound $\left\|\partial^{r} D_{t} P\right\|_{L^{2}\left(\mathscr{D}_{t}\right)}$ in terms of $\left\|\Pi \partial^{r} D_{t} P\right\|_{L^{2}\left(\partial \mathscr{D}_{t}\right)}$ and $\sum_{s \leqslant r-2}\left\|\partial^{s} \Delta D_{t} P\right\|_{L^{2}\left(\mathscr{D}_{t}\right)}$ under the a priori assumptions in Theorem 1.2. The estimate for $\left\|\Pi \partial^{r} D_{t} P\right\|_{L^{2}\left(\partial \mathscr{D}_{t}\right)}$ can be obtained from the higher-order version of the projection formula (1.12), in terms of $\|\theta\|_{L^{\infty}\left(\partial \mathscr{D}_{t}\right)}, \sum_{k \leqslant r-3}\left\|\bar{\partial}^{k} \theta\right\|_{L^{2}\left(\partial \mathscr{D}_{t}\right)}$ and $\sum_{k \leqslant r}\left\|\partial^{k} D_{t} P\right\|_{L^{2}\left(\mathscr{D}_{t}\right)}$. The estimate for $\left\|\partial^{s} \Delta D_{t} P\right\|_{L^{2}\left(\mathscr{D}_{t}\right)}$ can be obtained by the elliptic equation for $D_{t} P$ together with the boundary condition $D_{t} P=0$ on $\partial \mathscr{D}_{t}$.

Once we have the above estimates, the justification of a priori assumptions in Theorems 1.1 and 1.2 can mainly follow the argument in [4].

It is clear from the above discussion to see the role played by the total pressure $P=p+\frac{1}{8 \pi}|B|^{2}$, where the magnetic field $B$ comes in for which additional estimates are needed.

We will prove the above estimates by using the Lagrangian coordinates. One of the advantages of doing so is that we can work on a fixed domain.

## 2. Reformulation in Lagrangian Coordinates

Assume that we are given a velocity vector field $v(t, x)$ defined in a set $\mathscr{D} \subset$ $[0, T] \times \mathbb{R}^{n}$ such that the boundary of $\mathscr{D}_{t}=\{x:(t, x) \in \mathscr{D}\}$ moves with the velocity, that is, $(1, v) \in T(\partial \mathscr{D})$ which denotes the tangent space of $\partial \mathscr{D}$. We will now introduce Lagrangian or co-moving coordinates, that is, coordinates that are constant along the integral curves of the velocity vector field so that the boundary becomes fixed in these coordinates (cf. [4]). Let $x=x(t, y)=f_{t}(y)$ be the trajectory of the fluid given by

For each $t$, we will then have a change of coordinates $f_{t}: \Omega \rightarrow \mathscr{D}_{t}$, taking $y \rightarrow x(t, y)$. The Euclidean metric $\delta_{i j}$ in $\mathscr{D}_{t}$ then induces a metric

We will use covariant differentiation in $\Omega$ with respect to the metric $g_{a b}(t, y)$, since it corresponds to differentiation in $\mathscr{D}_{t}$ under the change of coordinates $\Omega \ni y \rightarrow x(t, y) \in \mathscr{D}_{t}$, and we will work in both coordinate systems. This also avoids possible singularities in the change of coordinates. We will denote covariant differentiation in the $y_{a}$-coordinates by $\nabla_{a}, a=0, \ldots, n$, and differentiation in the $x_{i}$-coordinates by $\partial_{i}, i=1, \ldots, n$. The covariant differentiation of a $(0, r)$ tensor $k(t, y)$ is the $(0, r+1)$ tensor given by

& +\frac{1}{\pi} \operatorname{sgn}(2-r) g^{a c} g^{A F} \nabla_{F}^{r-1}(\operatorname{curl} \beta)_{c d} \sum_{s=1}^{r-2}\binom{r}{s+1}\left(\left(\nabla^{1+s} u\right) \cdot \nabla^{r-s} \beta^{d}\right)_{A a} \\
& +\frac{1}{\pi} g^{a c} g^{b d} g^{A F} \nabla_{F}^{r-1}(\operatorname{curl} \beta)_{c d} \nabla_{A a}^{r} \beta^{e} \nabla_{b} u_{e} \\
& -\frac{1}{\pi} g^{a c} g^{A F} \nabla_{F}^{r-1}(\operatorname{curl} \beta)_{c d} \nabla_{A a}^{r} u^{e} \nabla_{e} \beta^{d} \\
& +\frac{1}{\pi} \nabla_{e}\left(g^{a c} g^{A F} \beta^{e} \nabla_{F}^{r-1}(\operatorname{curl} u)_{c d} \nabla_{A a}^{r} \beta^{d}\right) \\
& +\frac{1}{\pi} g^{a c} g^{A F} \nabla_{F}^{r-1}(\operatorname{curl} u)_{c d} \sum_{s=1}^{r}\binom{r}{s}\left(\nabla^{s} \beta^{e} \nabla^{r-s} \nabla_{e} \beta^{d}\right)_{A a} \\
& +\frac{1}{\pi} g^{a c} g^{A F} \nabla_{F}^{r-1}(\operatorname{curl} \beta)_{c d} \sum_{s=1}^{r}\binom{r}{s}\left(\nabla^{s} \beta^{e} \nabla^{r-s} \nabla_{e} u^{d}\right)_{A a} .

Noticing that $\beta \cdot N=0$ on $\partial \Omega$, then by the Hölder inequality and the Gauss formula, we get

Thus, we can easily obtain that the remainder integrals, that is, (5.13), (5.14), (5.15) and (5.17), can be controlled by $C(K, M, L, 1 / \varepsilon) E_{r}(t)$.

Therefore, we obtain

## 6. Justification of a Priori Assumptions

Let $\mathscr{K}(t)$ and $\varepsilon(t)$ be the maximum and minimum values, respectively, such that (5.6) and (5.7) hold at time $t$ :

& \quad \leqslant C\left(K_{1}, \mathscr{E}(0), E_{0}(0), \ldots, E_{n+1}(0), \operatorname{Vol} \Omega\right) \\
& \quad \times\left(1+\|\nabla u\|_{L^{\infty}(\partial \Omega)}+\|\nabla \beta\|_{L^{\infty}(\partial \Omega)}\right),

If $T$ is sufficiently small, it follows, after possibly making $\mathscr{T}>0$ smaller, that

Lemma 6.4 allows us to pick a $K_{1}$ depending only on initial conditions, while Lemma 6.3 gives us $\mathscr{T}>0$, that depends only on the initial conditions and $K_{1}$ such that, by Lemma $6.4,1 / \iota_{1} \leqslant K_{1}$ for $t \leqslant \mathscr{T}$. Thus, we immediately obtain the following theorem.

where $S \tilde{\otimes} R$ denotes some partial symmetrization of the tensor product $S \otimes R$, that is, a sum over some subset of the permutations of the indices divided by the number of permutations in that subset. Similarly, we let $S \cdot R$ denote a partial symmetrization of the dot product $S \cdot R$. Now we recall some identities:

\Pi \nabla^{4} q= & \bar{\nabla}^{4} q-\theta \tilde{\otimes}\left(5(\bar{\nabla} \theta) \cdot \bar{\nabla} q+8 \theta \cdot \bar{\nabla}^{2} q\right)-2(\bar{\nabla} \theta) \tilde{\otimes}(\theta \cdot \bar{\nabla} q) \\
& +\left(\bar{\nabla}^{2} \theta\right) \nabla_{N} q+4(\bar{\nabla} \theta) \tilde{\otimes} \bar{\nabla} \nabla_{N} q+6 \theta \tilde{\otimes} \bar{\nabla}^{2} \nabla_{N} q \\
& -3 \theta \tilde{\otimes}\left(\theta^{\sim} \theta\right) \nabla_{N} q+3 \theta \tilde{\otimes} \theta \nabla_{N}^{2} q . \tag{A.9}
\end{align*}

Definition A.1. Let $\mathscr{N}(\bar{x})$ be the outward unit normal to $\partial \mathscr{D}_{t}$ at $\bar{x} \in \partial \mathscr{D}_{t}$. Let $\operatorname{dist}\left(x_{1}, x_{2}\right)=\left|x_{1}-x_{2}\right|$ denote the Euclidean distance in $\mathbb{R}^{n}$, and for $\bar{x}_{1}, \bar{x}_{2} \in \partial \mathscr{D}_{t}$, let dist ${ }_{\partial \mathscr{D}_{t}}\left(\bar{x}_{1}, \bar{x}_{2}\right)$ denote the geodesic distance on the boundary.

Definition A.2. Let dist $\left(x, \partial \mathscr{D}_{t}\right)$ be the Euclidean distance from $x$ to the boundary. Let $\iota_{0}$ be the injectivity radius of the normal exponential map of $\partial \mathscr{D}_{t}$, that is, the largest number such that the map

& \text { given by }(\bar{x}, \iota) \quad \rightarrow x=\bar{x}+\iota \mathscr{N}(\bar{x}) \tag{A.10}
\end{align*}
$$

is an injection.
Definition A.3. Let $0<\varepsilon_{1}<2$ be a fixed number, and let $\iota_{1}=\iota_{1}\left(\varepsilon_{1}\right)$ the largest number such that

Lemma A.1. ([4, Lemma 3.9]) Let $N$ be the unit normal to $\partial \Omega$, and let $h_{a b}=$ $\frac{1}{2} D_{t} g_{a b}$. On $[0, T] \times \partial \Omega$, we have

where $h_{N N}=h_{a b} N^{a} N^{b}$. The volume element on $\partial \Omega$ satisfies

D_{t} d \mu_{\gamma}=\left(\operatorname{tr} h-h_{N N}\right) d \mu_{\gamma}=\left(\operatorname{tr} \theta u \cdot N+\gamma^{a b} \bar{\nabla}_{a} \bar{u}_{b}\right) d \mu_{\gamma} \tag{A.14}
\end{equation*}
$$

where $\bar{u}_{b}$ denotes the tangential component of $u_{b}$ to the boundary $\partial \Omega$.
Lemma A.2. (cf. [4, Lemma 5.5]) Let $w_{a}=w_{A a}=\nabla_{A}^{r} f_{a}, \nabla_{A}^{r}=\nabla_{a_{1}} \ldots \nabla_{a_{r}}$, $f$ be a $(0,1)$ tensor, and $\left[\nabla_{a}, \nabla_{b}\right]=0$. Let $\operatorname{div} w=\nabla_{a} w^{a}=\nabla^{r} \operatorname{div} f$, and let $(\operatorname{curl} w)_{a b}=\nabla_{a} w_{b}-\nabla_{b} w_{a}=\nabla^{r}(\operatorname{curl} f)_{a b}$. Then,

Lemma A.3. ([4, Proposition 5.8]) Let $\iota_{0}$ and $\iota_{1}$ be as in Definitions A. 2 and A.3, and suppose that $|\theta|+1 / \iota_{0} \leqslant K$ and $1 / \iota_{1} \leqslant K_{1}$. Then with $\tilde{K}=\min \left(K, K_{1}\right)$ we have, for any $r \geqslant 2$ and $\delta>0$,

& \leqslant \delta\left\|\Pi \nabla^{r} q\right\|_{L^{2}(\partial \Omega)}+C(1 / \delta, K, \operatorname{Vol} \Omega) \sum_{s \leqslant r-2}\left\|\nabla^{s} \delta q\right\|_{L^{2}(\Omega)} \tag{A.17}
\end{align*}

Lemma A.4. (cf. [4, Proposition 5.9]) Assume that $0 \leqslant r \leqslant 4$. Suppose that $|\theta| \leqslant$ $K$ and $\iota_{1} \geqslant 1 / K_{1}$, where $\iota_{1}$ is as in Definition 3.5 of [4]. If $q=0$ on $\partial \Omega$, then for $m=0,1$,

& \times \sum_{k \leqslant r-2+m}\left\|\nabla^{k} q\right\|_{L^{2}(\partial \Omega)} . \tag{A.18}

If, in addition, $\left|\nabla_{N} q\right| \geqslant \varepsilon>0$ and $\left|\nabla_{N} q\right| \geqslant 2 \varepsilon\left\|\nabla_{N} q\right\|_{L^{\infty}(\partial \Omega)}$, then

Lemma A.5. (cf. [4, Proposition 5.10] ) Assume that $0 \leqslant r \leqslant 4$ and that $|\theta|+$ $1 / \iota_{0} \leqslant K$. If $q=0$ on $\partial \Omega$, then

& \times\left(\left\|\nabla_{N} q\right\|_{L^{\infty}(\partial \Omega)}+\sum_{s=0}^{r-3}\left\|\nabla^{s} \delta q\right\|_{L^{2}(\Omega)}\right) . \tag{A.20}

Lemma A.6. ([4, Lemma A.1]) If $\alpha$ is $a(0, r)$ tensor, then with $a=k / m$ and $a$ constant $C$ that only depends on $m$ and $n$, such that

\frac{m}{s}=\frac{k}{p}+\frac{m-k}{q}, \quad 2 \leqslant p \leqslant s \leqslant q \leqslant \infty .

C_{0}^{-1} \gamma_{a b}^{0}(y) Z^{a} Z^{b} \leqslant \gamma_{a b}(t, y) Z^{a} Z^{b} \leqslant C_{0} \gamma_{a b}^{0}(y) Z^{a} Z^{b}, \quad \text { if } Z \in T(\Omega), \tag{A.23}
\end{equation*}
$$

where $\gamma_{a b}^{0}(y)=\gamma_{a b}(0, y)$. Then if $\alpha$ is a $(0, r)$ tensor,

& \|\alpha\|_{L^{(n-1) p /(n-1-k p)}(\partial \Omega)} \leqslant C\left(K_{1}\right) \sum_{\ell=0}^{k}\left\|\nabla^{\ell} \alpha\right\|_{L^{p}(\partial \Omega)}, \quad 1 \leqslant p<\frac{n-1}{k}, \\
& \|\alpha\|_{L^{\infty}(\partial \Omega)} \leqslant \delta\left\|\nabla^{k} \alpha\right\|_{L^{p}(\partial \Omega)}+C_{\delta}\left(K_{1}\right) \sum_{\ell=0}^{k-1}\left\|\nabla^{\ell} \alpha\right\|_{L^{p}(\partial \Omega)}, \quad k>\frac{n-1}{p}, \tag{A.24}
\end{align*}

for any $\delta>0$.
