# analysis of the spectral vanishing viscosity method for periodic conservation laws*

#### Abstract

We analyze the convergence of the spectral vanishing method for both the spectral and pseudospectral discretizations of the inviscid Burgers- equation. We prove that this kind of vanishing viscosity is responsible for a spectral decay of those Fourier coefficients located toward the end of the computed spectrum; consequently, the discretization error is shown to be spectrally small independent of whether the underlying solution is smooth or not. This in turn implies that the numerical solution remains uniformly bounded and convergence follows by compensated compactness arguments.

## INTRODUCTION

In this paper, we extend the analysis of the spectral vanishing viscosity method for stabilizing spectral approximations of nonlinear conservation laws. The spectral vanishing viscosity has been first introduced in [3], where it was shown that $L^{\infty}$-bounded spectral-Galerkin approximations converge strongly in $L_{1 o c}^{2}(x, t)$ to the exact entropy solutions of such conservation laws.

The analysis is performed on the $2 \pi$-periodic inviscid Burgers equation

submitted to the additional entropy condition

$$
\begin{equation*}
\frac{\partial}{\partial t}\left(\frac{u^{2}(x, t)}{2}\right)+\frac{\partial}{\partial x}\left(\frac{u^{3}(x, t)}{3}\right) \leq 0 \tag{1.2}
\end{equation*}
$$

which singles out the unique "physically relevant" weak solution of (1.1). Both the spectral-Galerkin and pseudospectral-collocation methods for (1.1), (1.2) are treated, and to this end we proceed as follows.

Denote by $S_{N} u(x, t)$ the spectral-Fourier projection of $u(x, t)$,
(1.3) $\quad S_{N} u(x, t)=\sum_{|k| \leq N} \hat{u}(k, t) e^{i k x}, \quad \hat{u}(k, t)=\frac{1}{2 \pi} \cdot \int_{0}^{2 \pi} u(x, t) e^{-i k x} d x$,
and let $I_{N} u(x, t)$ denote the pseudospectral-Fourier projection of $u(x, t)$, which interpolate $u(x, t)$ at the $2 N+1$ equidistant collocation points $x_{\nu}=\nu h, \quad h=\frac{2 \pi}{2 N+1}, \quad \nu=0, \cdots, 2 N$,
(1.4) $I_{N} u(x, t)=\sum_{|k|^{\prime} \leq N} \tilde{u}(k, t) e^{i k x}, \quad \tilde{u}(k, t)=\frac{h}{2 \pi} \cdot \sum_{v=0}^{2 N} u\left(x_{v}, t\right) e^{-i k x} v$.

These two projection operators differ by aliasing error-that is, we have

where the aliasing projection $A_{N}$ is given by [2]

Throughout this paper, we use

$$

P_{N}=S_{N}+a \cdot A_{N} \tag{1.7}
\end{equation*}

as a concise notation for the two kinds of Fourier projections: either with $a=0$, corresponding to the spectral projection, or with $a=1$ which corresponds to the pseudospectral interpolation.

We approximate the Fourier projection of the exact solution $P_{N} u(x, t)$, by an $N$-trigonometric polynomial, $u_{N}(x, t)$

which is determined by the approximate evolution equation

\begin{equation*}
\frac{\partial}{\partial t} u_{N}(x, t)+\frac{\partial}{\partial x}\left(P_{N} \frac{1}{2} u_{N}^{2}(x, t)\right)=\varepsilon \frac{\partial}{\partial x}\left(Q_{N} \frac{\partial}{\partial x} u_{N}(x, t)\right) \tag{1.9}
\end{equation*}
$$

The expression on the right-hand side of (1.9) represents the spectral vanishing viscosity term. Here $Q_{N}$ is the spectral viscosity operator which is defined as a convolution with a symmetric viscosity kernel $Q_{N}(x)$,

Q_{N} \frac{\partial}{\partial x} u_{N}(x, t)=Q_{N}(x) * \frac{\partial}{\partial x} u_{N}(x, t), \quad Q_{N}(x)=\sum_{|k| \leq N} \hat{Q}(k) e^{i k x} \tag{1.10}
\end{equation*}

In the spectral case where $a=0$, (1.9) amounts to

$$
\frac{\partial}{\partial t} u_{N}(x, t)+\frac{\partial}{\partial x}\left[S_{N} \frac{1}{2} u_{N}^{2}(x, t)\right]=\varepsilon \frac{\partial}{\partial x}\left[Q_{N}(x) * \frac{\partial}{\partial x} u_{N}(x, t)\right],
$$

consisting of a nonlinear system of ordinary differential equations for the Fourier coefficients, $\hat{u}_{k}(t)$, which are coupled through the standard spectral convolution treatment of the nonlinear term. The interpretation of the scheme (1.9) in the pseudospectral case where $a=1$ leads us to
$\frac{\partial}{\partial t} u_{N}\left(x_{\nu}, t\right)+\left.\frac{\partial}{\partial x}\left[I_{N} \frac{1}{2} u_{N}^{2}(x, t)\right]\right|_{x=x_{\nu}}=\left.\varepsilon \frac{\partial}{\partial x}\left[Q_{N}(x) * \frac{\partial}{\partial x} u_{N}(x, t)\right]\right|_{x=x_{v}}, 0 \leq \nu \leq 2 N$, and consists in a complete statement of a standard collocation method with a pseudospectral treatment of the nonlinear term.

In both the spectral and pseudospectral cases, the spectral viscosity operator can be efficiently implemented in the Fourier rather than the physical space, i.e.,
$\varepsilon \frac{\partial}{\partial x}\left(Q_{N} \frac{\partial}{\partial x} u_{N}(x, t)\right) \equiv \varepsilon \frac{\partial}{\partial x}\left[Q_{N}(x) * \frac{\partial}{\partial x} u_{N}(x, t)\right]=-\varepsilon \cdot \sum_{|k| \leq N} k^{2} \hat{Q}(k) \hat{u}_{k}(t) e^{i k x}$.

An essential ingredient of our spectral viscosity operator, $Q_{N}$, is that it
should operate only on the high portion of the spectrum, in order to retain the formal spectral accuracy of the method. Hence we make

ASSUMPTION I: There exists a constant $m \equiv m(N)<\frac{1}{4} N$, such that

Then, with $Q_{N}=I-R_{m}$, we can rewrite (1.9) as
(1.11) $\frac{\partial}{\partial t} u_{N}(x, t)+\frac{\partial}{\partial x}\left(P_{N} \frac{1}{2} u_{N}^{2}(x, t)\right)=\varepsilon \frac{\partial}{\partial x}\left[\left(I-R_{m}\right) \frac{\partial}{\partial x} u_{N}(x, t)\right]$,
where the corresponding kerne $1 R_{m}(x)$,

R_{m}(x)=\sum_{|k| \leq 2 m} \hat{R}(k) e^{i k x} \tag{1.12}

is a trigonometric polynomial of degree $\leq 2 m$, with Fourier coefficients

$$
\begin{cases}\hat{\mathrm{R}}(\mathrm{k}) \equiv 1, & |\mathrm{k}|<\mathrm{m}  \tag{1.13}\\ 0 \leq \hat{\mathrm{R}}(\mathrm{k}) \leq 1, & \mathrm{~m} \leq|\mathrm{k}| \leq 2 \mathrm{~m}\end{cases}
$$

In order to guarantee the uniform boundedness of our approximation, $u_{N}(x, t)$, we shall need to control the size of this kernel; we therefore make

ASSUMPTION II: There exists a constant such that

We remark that the assumption of a logarithmic upper bound for the size of $R_{m}(x)$ is plausible, since typical applications involve $\hat{R}(k)$ which decrease monotonically to zero and (1.14) is automatically fulfilled in such cases; consult Appendix A. To obtain, with the help of Assumption II, the promised uniform bound on $u_{N}(x, t)$, necessitates $L^{\infty}$-bounded initial data, $u_{N}(x, 0)$. For technical reasons we shall need the slightly stronger

ASSUMPTION III: There exists a constant such that

The spectral viscosity term on the right of (1.11) depends on two free parameters: the viscosity amplitude $\quad \varepsilon \equiv \varepsilon(N)$ and the effective size of the inviscid spectrum $m \equiv m(N)$. These two parameters should be chosen to ensure the convergence of the method. In [3] it has been proved that in the absence of such viscosity term, $\varepsilon=0$, strong as we11 as weak convergence to the exact entropy solution fails.

The main result of this paper asserts

Theorem 1.1: Consider the Fourier approximation (1.11) of either spectral or pseudospectral type. Let the spectral viscosity in (1.12) (1.14) be parameterized with $(\varepsilon, m)$ as follows
(1.15) $\quad \varepsilon \equiv \varepsilon(m) \sim \alpha \frac{1}{m^{2} \cdot\left\|R_{m}(\cdot)\right\|} L^{1}(x) \quad, \quad m \equiv m(N) \sim$ Const. $N^{\beta}, \quad 0<\beta<\frac{1}{4}$.

Then $u_{N}(x, t)$ converges boundedly a.e. to the unique entropy solution of the conservation law (1.1).

Let us examine for example the viscosity operator $Q_{N}=I-S_{m}$. Here $R_{m}(x)$ coincides with Dirichlet kernel $D_{m}(x)$, where [5, Chapter II]

D_{m}(x)=\sum_{|k| \leq m} e^{i k x} \equiv \frac{1}{2 \pi} \frac{\sin \left(m+\frac{1}{2}\right) x}{\sin \frac{1}{2} x}, \quad\left\|D_{m}(\cdot)\right\|_{L} 1^{1}(x) \sim \frac{4}{\pi^{2}} \log m
$$

so that Assumption II is fulfilled and Theorem 1.1 yields

Corollary 1.2: Consider the Fourier approximation
(1.16) $\quad \frac{\partial}{\partial t} u_{N}(x, t)+\frac{\partial}{\partial x}\left(P_{N} \frac{1}{2} u_{N}^{2}(x, t)\right)=\varepsilon \frac{\partial}{\partial x}\left[\left(I-S_{m}\right) \frac{\partial}{\partial x} u_{N}(x, t)\right]$,
with

$$
\text { (1.17) } \varepsilon=\varepsilon(N) \sim \text { Const. } \frac{N^{-2 \beta}}{\log N}, \quad m=m(N) \sim \text { Const. } N^{\beta}, \quad 0<\beta<\frac{1}{4}
$$

Then $u_{N}(x, t)$ converges boundedly a.e. to the unique entropy solution of the conservation law (1.1).

The spectral portion of this result $(a=0)$, was derived in [3, Theorem 4.1] under the assumption that the numerical solution $u_{N}(x, t)$ remains uniformly bounded. The extension of Corollary 1.2 includes the pseudospectral
approximation $(a=1)$, and in addition, thanks to the slightly more stringent parametrization than that of [3, Theorem 4.1], contains a proof of the previously assumed $\mathrm{L}^{\infty}$-bound.

In the last example the viscosity symbols $\hat{Q}(k)$ were discontinuous at $|k|=m$. It was suggested in [3] that the use of viscosity operators $\mathrm{Q}_{\mathrm{N}}$ with smoothly varying symbols would be advantageous for the spectral viscosity method in (1.9). As our second and final example we consider the simplest viscosity operator of this type, namely

\begin{cases}\hat{Q}(k) \equiv 0, & |k|<m, \\ \hat{Q}(k)=\frac{|k|-m}{m}, & m \leq|k| \leq 2 m, \\ \hat{Q}(k) \equiv 1, & 2 m<|k| \leq N .\end{cases}
$$

This kind of spectral viscosity is intimately related to the Fejer operator $F_{m}=\frac{1}{m} \cdot \sum_{k=0}^{m-1} S_{k}$ : if we let $K_{m}(x)$ denote the corresponding Fejer kernel [3, Chapter III]

K_{m}(x)=\sum_{|k| \leq m}\left(1-\frac{|k|}{m}\right) e^{i k x} \equiv \frac{2}{\pi m}\left(\frac{\sin \frac{1}{2} m x{ }^{2}}{\sin \frac{1}{2} x}\right)^{2}, \quad\left\|K_{m}(\cdot)\right\|_{L^{1}(x)}=1,
$$

then for $Q_{N}=I-R_{m}$ we have $R_{m}(x)=2 K_{2 m}(x)-K_{m}(x)$. Hence the kernel associated with

R_{m}=2 F_{2 m}-F_{m} \equiv \frac{1}{m} \cdot \sum_{k=m}^{2 m-1} S_{k}
$$

is $L^{1}$-uniformly bounded,

$$
\left\|R_{m}(\cdot)\right\|_{L^{1}(x)} \leq 2\left\|K_{2 m}(\cdot)\right\|_{L^{1}(x)}+\left\|K_{m}(\cdot)\right\|_{L^{1}(x)} \leq 3,
$$

so that Assumption II is fulfilled and Theorem 1.1 yields

Corollary 1.3: Consider the Fourier approximation
(1.18) $\quad \frac{\partial}{\partial t} u_{N}(x, t)+\frac{\partial}{\partial x}\left(P_{N} \frac{1}{2} u_{N}^{2}(x, t)\right)=\varepsilon \frac{\partial}{\partial x}\left[\left(I-\frac{1}{m} \cdot \sum_{k=m}^{2 m-1} S_{k}\right) \frac{\partial}{\partial x} u_{N}(x, t)\right]$,
with
(1.19) $\quad \varepsilon=\varepsilon(N) \sim$ Const. $N^{-2 \beta}, \quad m=m(N) \sim$ Const. $N^{\beta}, \quad 0<\beta<\frac{1}{4}$.

Then $u_{N}(x, t)$ converges boundedly a.e. to the unique entropy solution of the conservation law (1.1).

The paper is organized as follows. In Section 2 we derive a couple of basic $L^{2}$-type $a^{-}$priori energy estimates. In Section 3, these estimates are used in order to study the spectral decay rate of the Fourier coefficients. This in turn enables us, in Section 4, to obtain $L^{\infty}$ a priori estimate on the numerical solution. Finally, based on the a priori estimates prepared in Sections 2, 3, and 4, Theorem 1.1 is proved in Section 5 along the lines of [3], using compensated compactness arguments.

## 2. $\mathrm{L}^{2}$-TYPE A PRIORI ESTIMATES

We consider the approximate Fourier method (1.9) which we rewrite as
(2.1) $\frac{\partial}{\partial t} u_{N}+\frac{\partial}{\partial x}\left(\frac{1}{2} u_{N}^{2}\right)=\frac{\partial}{\partial x}\left[\left(I-P_{N}\right) \frac{1}{2} u_{N}^{2}\right]+\varepsilon \frac{\partial}{\partial x}\left[Q_{N} \frac{\partial}{\partial x} u_{N}\right] \equiv I+I I$.

In order to prove the convergence of this method we need a couple of a priori estimates on its solution. To this end, we multiply (2.1) by $u_{N}$

=u_{N} \frac{\partial}{\partial x}\left[\left(I-P_{N}\right) \frac{1}{2} u_{N}^{2}\right]+\varepsilon u_{N} \frac{\partial}{\partial x}\left[Q_{N} \frac{\partial}{\partial x} u_{N}\right] \equiv I I I+I V,
$$

and integrate over a $2 \pi$ period: the integral of the second term on the left vanishes by periodicity, and after integration by parts for the second term on the right we are left with
(2.3)
$\frac{1}{2} \frac{d}{d t}\left\|u_{N}(\cdot, t)\right\|_{L}^{2}(x)+\varepsilon \int_{0}^{2 \pi} \frac{\partial}{\partial x} u_{N}(x, t) Q_{N} \frac{\partial}{\partial x} u_{N}(x, t) d x=\int_{0}^{2 \pi} u_{N} \frac{\partial}{\partial x}\left[\left(I-P_{N}\right) \frac{1}{2} u_{N}^{2}\right] d x$.

Using (1.7) and the fact that $I-S_{N}$ is orthogonal to our $N$-space, we find that the right-hand side of (2.3) equals
$\int_{0}^{2 \pi} u_{N} \frac{\partial}{\partial x}\left[\left(I-P_{N}\right) \frac{1}{2} u_{N}^{2}\right] d x=-a \cdot \int_{0}^{2 \pi} u_{N} \frac{\partial}{\partial x}\left[A_{N} \frac{1}{2} u_{N}^{2}\right] d x=-a \cdot \sum_{|p| \underline{N}} \hat{u}_{-p} i p\left(A_{N} \frac{1}{2} u_{N}^{2}\right)_{p}$,
and by the aliasing relation (1.6), this does not exceed
$\int_{0}^{2 \pi} u_{N} \frac{\partial}{\partial x}\left[\left(I-P_{N}\right) \frac{1}{2} u_{N}^{2}\right] d x=\frac{a}{2} \sum_{|p+q+r|=2 N+1} i p \hat{u}_{p} \hat{u}_{q} \hat{u}_{r} \leq \frac{|a| N}{2} \sum_{|p+q+r|=2 N+1}\left|\hat{u}_{p}\right|\left|\hat{u}_{q}\right|\left|\hat{u}_{r}\right| \cdot$

In view of $|\mathrm{p}+\mathrm{q}+\mathrm{r}|=2 \mathrm{~N}+1$, at least two of the three indices $|\mathrm{p}| \leq \mathrm{N}$, $|q| \leq N$ and $|r| \leq N$ are greater in absolute value than $\frac{N}{2}$, and hence

Consequently, since $\hat{Q}(p)=\hat{Q}(q) \equiv 1$ for $|p|,|q| \geq \frac{N}{2}$, the expression on
the right of (2.3) can be upper bounded by
(2.4a) $\left.\int_{0}^{2 \pi} u_{N} \frac{\partial}{\partial x}\left[I-P_{N}\right) \frac{1}{2} u_{N}^{2}\right] d x \leq \frac{4|a|}{N} \cdot\left\|Q_{N} \frac{\partial}{\partial x} u_{N}(\cdot, t)\right\|_{L^{2}(x)}^{2} \cdot\left\|u_{N}(\cdot, t)\right\|{ }_{L}^{2}(x)$.

Moreover, since $0 \leq \hat{Q}(k) \leq 1$ we have for the second term on the left of (2.3)
(2.4b) $\quad \in \int_{0}^{2 \pi} \frac{\partial}{\partial x} u_{N}(x, t) Q_{N} \frac{\partial}{\partial x} u_{N}(x, t) d x=$

=\varepsilon \sum_{|k| \leq N} k^{2} \hat{Q}(k)\left|\hat{u}_{k}(t)\right|^{2} \geq \varepsilon\left\|Q_{N} \frac{\partial}{\partial x} u_{N}(\cdot, t)\right\|_{L}^{2}(x)

Inserting this together with (2.4a) into (2.3) we end up with


Thus, as long as
(2.6)

In particular, (2.7) implies that for $u_{N}(x, t)=\sum_{|k| \leq N} \hat{u}_{k}(t) e^{i k x}$ we have our first $L^{2}$-type $a^{-}$priori estimate
(2.8) $\left\|u_{N}(\cdot, t)\right\|_{L^{2}(x)}^{2}=\sum_{k \mid \leq N}\left|\hat{u}_{k}(t)\right|^{2} \leq E_{0}^{2}, \quad E_{0}=\left\|u_{N}(\cdot, t=0)\right\|_{L^{2}(x)} \leq$ Const $_{0}$.

Hence (2.6), (2.7) and consequently (2.8) prevail for all time provided (2.6) is valid at $t=0$, i.e., we require that in the pseudospectral case where a $=1$ we shall have

indeed, Assumption $I I$ tells us that this requirement is fulfilled, at least for sufficiently large $N$, for

The first term, $I \equiv \frac{\partial}{\partial x}\left[\left(I-P_{N}\right) \frac{1}{2} u_{N}^{2}\right]$, represents the discretization error, which includes spectral truncation errors $\frac{\partial}{\partial x}\left[\left(I-S_{N}\right) \frac{1}{2} u_{N}^{2}\right]$ as well as additional aliasing errors $-a \cdot \frac{\partial}{\partial x}\left[A_{N} \frac{1}{2} u_{N}^{2}\right]$ in the pseudospectral case. In this section, we borrow from Kreiss [1], in order to show that due to the second error term of spectral vanishing viscosity, $I I \equiv \varepsilon \frac{\partial}{\partial x}\left[Q_{N} \frac{\partial}{\partial x} u_{N}\right]$, there is spectral decay of the Fourier coefficients $\left|\hat{u}_{k}(t)\right|,|k|>\frac{1}{2} N$, and therefore, that the discretization error is spectrally small.

## 4. L ${ }^{\infty}$ A PRIORI ESTIMATE

The classical energy method can be used to show that the solution of (2.1) remains uniformly bounded during a small finite time. The method reflects the fact that for sufficiently smooth initial data, say with $\frac{\partial^{2}}{\partial x^{2}} u_{N}(x, t=0)$ which are $L^{2}$-bounded, the process of shock formation takes a finite time, during which $\frac{\partial}{\partial x} u_{N}(x, t)$ remains uniformly bounded and a couple of Sobolev norms could be a'priori estimated during that time.

For a brief initial time intervals, we can do better with regard to the smoothness of the initial data, as told by

Lemma 4.1: Consider the Fourier approximation (1.11) - (1.14) with initial data $u_{N}(x, t=0)$ such that Assumption III holds, i.e.,

By Corollary 3.4, the discretization error is negligibly small: using (3.19) and the fact that $\left(I-P_{N}\right) \frac{1}{2} u_{N}^{2}$ is a trigonometric polynomial of degree $\leq 2 N$, we have for any $s \geq 0$

$$
\begin{align*}
& \left\|\frac{\partial}{\partial x}\left[\left(I-P_{N}\right) \frac{1}{2} u_{N}^{2}(\cdot, t)\right]\right\|_{L^{2}(x)} \leq  \tag{4.6}\\
& \sqrt{2 N} \cdot\left\|\frac{\partial}{\partial x}\left[\left(I-P_{N}\right) \frac{1}{2} u_{N}^{2}(\cdot, t)\right]\right\|_{L^{2}(x)} \leq C_{s} N^{2} \cdot\left(N^{-s}+e^{-N^{3 / 2} \cdot t}\right)
\end{align*}
$$

Therefore, by Holder inequality, the first integral on the right of (4.5) does not exceed
$p \cdot \int_{0}^{2 \pi} u_{N}^{p-1} \frac{\partial}{\partial x}\left[\left(I-P_{N}\right) \frac{1}{2} u_{N}^{2}\right] d x \leq p \cdot\left\|u_{N}^{p-1}(\cdot, t)\right\|{ }_{L} q_{(x)} \cdot\left\|\frac{\partial}{\partial x}\left[\left(I-P_{N}\right) \frac{1}{2} u_{N}^{2}(\cdot, t)\right]\right\|_{L} p_{(x)} \leq$ (4.7)

$$
\leq p \cdot\left\|u_{N}(\cdot, t)\right\|_{L^{p}(x)}^{p-1} \cdot C_{s} \cdot\left(N^{2-s}+N^{2} e^{-N^{3 / 2} \cdot t}\right), \quad \frac{1}{p}+\frac{1}{q}=1
$$

The second integral on the right of (4.5), with $Q_{N}=I-R_{m}$, equals $p \cdot \int_{0}^{2 \pi} u_{N}^{p-1} \varepsilon \frac{\partial}{\partial x}\left[\left(I-R_{m}\right) \frac{\partial}{\partial x} u_{N}\right] d x=-\varepsilon p(p-1) \cdot \int_{0}^{2 \pi} u_{N}^{p-2}\left(\frac{\partial u_{N}}{\partial x}\right) d x-\varepsilon p \cdot \int_{0}^{2 \pi} u_{N}^{p-1} \frac{\partial^{2}}{\partial x^{2}}\left(R_{m} u_{N}\right) d x$.

The first term on the right hand side is negative for any even integer $p \geq 2 ; \quad$ for the second term we use Holder inequality as before, obtaining
(4.8a) $\quad \varepsilon p \cdot \int_{0}^{2 \pi} u_{N}^{p-1} \frac{\partial^{2}}{\partial x^{2}}\left(R_{m} u_{N}\right) d x \leq \varepsilon p\left\|u_{N}(\cdot, t)\right\|{ }_{L}^{p-1} p_{(x)} \cdot\left\|\frac{\partial^{2}}{\partial x^{2}}\left(R_{m} u_{N}\right)\right\|{ }_{L} p_{(x)} \cdot$

Now, since $R_{m} u_{N} \equiv R_{m}(x) * u_{N}(x, t)$ is a trigonometric polynomial of degree $\leq 2 \mathrm{~m}$, (consult (1.12)), we can estimate the $L^{P}(x)$ norm of its derivatives as follows [5, Chapter X]

\end{equation*}
$$

$$
\leq 4 m^{2}\left\|R_{m}(\cdot)\right\|_{L}^{1}(x) \cdot\left\|u_{N}(\cdot, t)\right\|_{L^{2}} p_{(x)}
$$

Using (4.8a) and (4.8b) we conclude that the second integral on the right of (4.5) is upper bounded by

$$
\begin{equation*}
p \cdot \int_{0}^{2 \pi} u_{N}^{p-1} \varepsilon \frac{\partial}{\partial x}\left[Q_{N} \frac{\partial}{\partial x} u_{N}\right] d x \leq 4 p \cdot \varepsilon m^{2} \cdot\left\|R_{m}(\cdot)\right\|{ }_{L}{ }^{1}(x) \cdot\left\|u_{N}(\cdot, t)\right\|_{L}^{p} p_{(x)}^{p} \tag{4.9}
\end{equation*}
$$

We recall that according to our parametrization (1.15), $\varepsilon \mathrm{m}^{2} \cdot\left\|\mathrm{R}_{\mathrm{m}}(\cdot)\right\|_{\mathrm{L}} 1_{(x)} \leq \alpha$. Hence, equipped with (4.7) and (4.9) we return to (4.5) to find that

& p\left\|u_{N}(\cdot, t)\right\|_{L^{p}(x)}^{p-1} \cdot \frac{d}{d t}\left\|u_{N}(\cdot, t)\right\| L_{(x)}^{p} \\
& \quad p\left\|u_{N}(\cdot, t)\right\|{ }_{L}^{p-1}\left[4 \alpha \cdot\left\|u_{N}(\cdot, t)\right\| L_{L}^{p}(x)+C_{s} \cdot\left(N^{2-s}+N^{2} e^{-N^{3 / 2} \cdot t}\right)\right],
\end{aligned}
$$

or, after division by the common factor of $p\left\|u_{N}(\cdot, t)\right\| \int_{L}^{p-1}(x)$,

$$
\frac{d}{d t}\left\|u_{N}(\cdot, t)\right\|_{L^{p}(x)} \leq 4 \alpha \cdot\left\|u_{N}(\cdot, t)\right\|_{L^{p}(x)}+c_{s} \cdot\left(N^{2-s}+N^{2} e^{-N^{3 / 2} \cdot t}\right)
$$

Finally, we integrate in time obtaining by Gronwall's inequality that for any $\quad 0 \leq t_{0} \leq t$,
(4.10)
$\left\|u_{N}(\cdot, t)\right\|_{L} p_{(x)} \leq e^{4 \alpha\left(t-t_{0}\right)} \cdot\left[\left\|u_{N}\left(\cdot, t_{0}\right)\right\|_{L} p_{(x)}+C_{S} \cdot\left(N^{2-s} \cdot\left(t-t_{0}\right)+\sqrt{N} \cdot e^{-N^{3 / 2} \cdot t_{0}}\right)\right]$.

Letting $p$ even tends to infinity, then (4.10) with $t_{0} \equiv t_{0}(N)=\frac{1}{8 \operatorname{Const}_{0} \cdot \mathrm{~N}}$ gives us
$(4.11) \quad\left\|u_{N}(\cdot, t)\right\|_{L_{(x)}} \leq e^{4 \alpha t} \cdot\left[\left\|u_{N}\left(\cdot, t_{0}\right)\right\|_{L^{\infty}(x)}+C_{s}\left(N^{2-s} \cdot t+\sqrt{N} e^{- \text {Const } \cdot \sqrt{N}}\right)\right]$
and together with Lemma 4.1 we conclude with the desired $L^{\infty}$ bound, namely,

Theorem 4.2: Consider the Fourier approximation (1.11)-(1.14). Then for any $s \geq 0$ there exist constants $\alpha>0$ and $C_{s}$ such that
(4.12)
$\left\|u_{N}(\cdot, t)\right\|_{L}^{\infty}(x) \leq e^{4 \alpha t} \cdot\left[4 \cdot \sum_{|k| \leq N}\left|\hat{u}_{k}(t=0)\right|+C_{s+2} \cdot\left(N^{-s} \cdot t+\sqrt{N} e^{-\operatorname{Const} \cdot \sqrt{N}}\right)\right]$.

Remarks: 1. We observe that the exponential time growth in (4.12) does not exceed $4 \alpha$ where $\alpha \sim \varepsilon m^{2} \cdot\left\|R_{m}(\cdot)\right\|_{L}{ }^{1}(x) \leq$ Const.
2. The a-priori $L P(x)$ estimate derived in (4.10) is valid for arbitrary $L^{2}$ bound initial data. We note, however, that the resulting $L^{\infty}$ bound in such case is not uniform with respect to the initial time $t_{0}$. That is, with arbitrary $L^{2}$-bounded initial data, the solution $\left\|_{N}(\cdot, t)\right\|_{L^{\infty}}(x)$ may still grow like $O(\sqrt{\mathrm{~N}})$. The point made in Lemma 4.1 was that with slightly strengthened regularity assumption on the initial data

$$
|k|_{\leq N}\left|\hat{u}_{k}(t=0)\right| \leq \text { Const }_{0}
$$

this growth is bounded for a brief time interval of length $\sim \frac{1}{N}$, after which the spectral viscosity becomes effective and guarantees the $L^{\infty}$ bound later on.

## 5. CONVERGENCE TO THE ENTRROPY SOLUTION

We follow [3], using compensated compactness arguments to conclude that $u_{N}(x, t)$ converges to the entropy solution of (1.1), (1.2).

Proof: (of Theorem 1.1). Consider the four terms on the right-hand side of (2.1) and (2.2). Using (3.18) together with (2.11) along the lines of [3, Lemma 3.1], we find that the term $I$ satisfies

& \leq\left\|\left(I-P_{N}\right) \frac{1}{2} u_{N}^{2}(\cdot, t)\right\|{ }_{L_{1 O C}}^{2}(x, t) \leq 4 E_{0} \cdot J_{0} \cdot \frac{1}{\sqrt{\varepsilon(N) \cdot N}} \underset{N \rightarrow \infty}{ } 0 .
\end{align*}
$$

Also, by the a'priori estimate (2.11) we have
(5.2)

\begin{aligned}
\| I I \equiv & \varepsilon \frac{\partial}{\partial x}\left[Q_{N} \frac{\partial}{\partial x} u_{N}\right] \|_{{ }_{H}^{l o C}}^{-1}(x, t) \\
& \leq \varepsilon \|_{N} \frac{\partial}{\partial x} u_{N}{ }_{L_{1 O C}}^{2}(x, t)
\end{aligned}
$$

Thus, in view of (5.1) and (5.2), the terms I and II on the right of (2.1) belong to the compact of $H_{1 o c}^{-1}(x, t)$.

Next we note that since $Q_{N}+R_{m}=I$ we have

\sqrt{\varepsilon}\left\|\frac{\partial}{\partial x} u_{N}\right\|_{L_{1 o c}}^{2}(x, t) \leq \sqrt{\varepsilon}\left\|Q_{N} \frac{\partial}{\partial x} u_{N}\right\|_{L_{1 o c}}^{2}(x, t) \quad+\sqrt{\varepsilon}\left\|\frac{\partial}{\partial x}\left(R_{m} u_{N}\right)\right\|_{L_{1 o c}}^{2}(x, t)
$$

The first term on the right is bounded by $J_{0}$; the second one--being the derivative of a trigonometric polynomial of degree $\leq 2 m$, does not exceed $\sqrt{\varepsilon} \cdot 2 \mathrm{~m} \cdot \| u_{N}{ }_{L_{L_{o c}}(x, t)} \leq$ Const. Consequently,

$$
\begin{equation*}
\sqrt{\varepsilon} \|_{\partial \mathrm{x}} \mathrm{u}_{\mathrm{N}}{ }_{\mathrm{L}_{\text {Loc }}^{2}}(\mathrm{x}, \mathrm{t}) \leq \text { Const. } \tag{5.3}
\end{equation*}
$$

Equipped with (5.3) we now turn to consider the right-hand side of (2.2). For the third term in (2.2),

\text { III }=u_{N} \frac{\partial}{\partial x}\left[\left(I-P_{N}\right) \frac{1}{2} u_{N}^{2}\right]=
$$

(5.4a)

$$
=\frac{\partial}{\partial x}\left[u_{N}\left(I-P_{N}\right) \frac{1}{2} u_{N}^{2}\right]-\frac{\partial}{\partial x} u_{N} \cdot\left(I-P_{N}\right) \frac{1}{2} u_{N}^{2} \equiv I I I_{1}+I I I_{2},
$$

we have by Theorem 4.2 and the estimate (5.1)
$\left\|I I I_{1} \equiv \frac{\partial}{\partial x}\left[u_{N}\left(I-P_{N}\right) \frac{1}{2} u_{N}^{2}\right]\right\|_{H_{1 o c}^{-1}(x, t)} \leq$
(5.4b)
$\leq\left\|u_{N}\left(I-P_{N}\right) \frac{1}{2} u_{N}^{2}\right\|_{L_{1 o c}}^{2}(x, t) \leq\left\|u_{N}(\cdot, t)\right\|_{L}^{\infty}(x) \quad \cdot\left\|\left(I-P_{N}\right) \frac{1}{2} u_{N}\right\|_{L_{1 o c}^{2}}^{2}(x, t) \xrightarrow[N \rightarrow \infty]{ } 0$,
and together with (5.3) we also have
$\left\|I I I_{2} \equiv \frac{\partial}{\partial x} u_{N} \cdot\left(I-P_{N}\right) \frac{1}{2} u_{N}^{2}\right\|_{L_{10 C}}^{1}(x, t)^{\leq}$
(5.4c)
$\leq \sqrt{\varepsilon}\left\|\frac{\partial}{\partial x} u_{N}^{\|} L_{10 c}^{2}(x, t) \cdot \frac{1}{\sqrt{\varepsilon}}\right\|\left(I-P_{N}\right) \frac{1}{2} u_{N}^{2} \|{ }_{L_{l o c}}^{2}(x, t) \leq$ Const. $4 E_{0} J_{0} \cdot \frac{1}{\varepsilon(N) \cdot \sqrt{N}} \xrightarrow[N+\infty]{ } 0$.
Finally, for the fourth term in (2.2),

=\varepsilon \frac{\partial}{\partial x}\left[u_{N} Q_{N} \frac{\partial}{\partial x} u_{N}\right]-\varepsilon \frac{\partial}{\partial x} u_{N} \cdot Q_{N} \frac{\partial}{\partial x} u_{N} \equiv I V_{1}+I V_{2},
$$

we have by (2.8), (2.11) and the uniform bound in Theorem 4.2,
(5.5b) $\quad\left\|I V_{1} \equiv \varepsilon \frac{\partial}{\partial x}\left[u_{N}{ }_{N} \frac{\partial}{\partial x} u_{N}\right]\right\|_{H_{l o c}^{-1}(x, t)^{\leq}}\left\|u_{N}(\cdot, t)\right\|_{L}^{\infty}(x) \quad \cdot \sqrt{\varepsilon(N)} \cdot J_{0} \underset{N+\infty}{ } 0$,
while $\quad I V_{2} \equiv-\varepsilon\left[Q_{N} \frac{\partial}{\partial x} u_{N}\right]^{2}+\varepsilon\left(I-Q_{N}\right) \frac{\partial}{\partial x} u_{N} \cdot Q_{N} \frac{\partial}{\partial x} u_{N} \quad$ satisfies
(5.5c) $\left\|I V_{2}\right\|_{L_{l o c}}^{1}(x, t)^{\leq \varepsilon \| Q_{N}} \frac{\partial}{\partial x} u_{N} \|_{L_{l o c}^{2}}^{2}(x, t)+$

$$
+\sqrt{\varepsilon}\left\|R_{m} \frac{\partial}{\partial x} u_{N}\right\|_{L_{l o c}^{2}(x, t)} \cdot \sqrt{\varepsilon}\left\|Q_{N} \quad \frac{\partial}{\partial x} u_{N}\right\|_{L_{l o c}}(x, t)

Therefore, by Murat's lemma, [4], the inequalities (5.4), (5.5) imply that the terms III and IV are also in the compact of $H_{1 o c}^{-1}(x, t)$. In summary, we have shown that the right hand sides of (2.1), (2.2) lie in the compact of $H_{l o c}^{-1}(x, t)$, and, according to Theorem 4.2, that $\left\|u_{N}(\cdot, t)\right\|_{L}^{\infty}(x)$ is bounded (in fact, $\| u_{N}{ }^{\|}{ }_{L} p_{(x, t)}$ with $p>6$ will do for our purpose). Hence we can apply the div-curl lemma [4] to the left-hand sides of (2.1), (2.2) and obtain that (a subsequence of) $u_{N}(x, t)$ converges strongly in $L_{l o c}^{2}(x, t)$ to a weak limit solution $\bar{u}(x, t)$.

Moreover, we claim that this limit is the entropy solution of (1.1). To verify this claim we show that the right-hand side of (2.2), III + IV, tends weakly to a negative measure. Indeed, by (5.4) and (5.5b) the terms III and IV 1 tend weakly to zero, and hence it is left to show that the term $\mathrm{IV}_{2}$,

tends weakly to a negative measure. To this end we proceed as in [3, Section 4] and rewrite $\mathrm{IV}_{2}$ in the form

Denote the three terms on the right of (5.6) by $\mathrm{IV}_{21}$, $\mathrm{IV}_{22}$ and $\mathrm{IV}_{23}$, respectively. By (2.11), $\mathrm{IV}_{21}$ tends weakly to a negative measure

\begin{equation*}
\underset{N \rightarrow \infty}{\operatorname{wlim}}\left[I V_{21} \equiv-\varepsilon\left[Q_{N} \frac{\partial}{\partial x} u_{N}\right]^{2}\right] \leq 0 . \tag{5.7a}
\end{equation*}

If we integrate the second term, $\mathrm{IV}_{22}$, against any $\mathrm{C}_{0}^{\infty}$ test function $\psi(x, t)$, we find

& \int_{x} \int_{t} \psi \cdot I V_{22} d x d t \leq \varepsilon \int_{x} \int_{t}\left|\frac{\partial \psi}{\partial x} \cdot \frac{\partial}{\partial x}\left(R_{m} u_{N}\right) \cdot Q_{N} u_{N}\right| d x d t \leq \\
& \leq \varepsilon\left\|\frac{\partial \psi}{\partial x}\right\|_{L_{1 o c}^{\infty}}^{\infty}(x, t) \cdot\left\|\frac{\partial}{\partial x}\left(R_{m} u_{N}\right)\right\|{ }_{L_{1 o c}}^{2}(x, t) \cdot\left\|Q_{N} u_{N}\right\|_{L_{1 o c}}^{2}(x, t)
\end{aligned}
$$

and since $R_{m} u_{N}$ is a trigonometric polynomial of degree $\leq 2 m$, this is less than
(5.7b) $\int_{x} \int_{t} \psi \cdot I V_{22} d x d t \leq \varepsilon \cdot\left\|\frac{\partial \psi}{\partial x}\right\|_{L_{l o c}^{\infty}(x, t)} \cdot 2 m \cdot\left\|u_{N}\right\|_{L_{1 o c}}^{2}(x, t)^{2} \leq$ Const. $\frac{1}{m(N)} \xrightarrow[N+\infty]{ } 0$.

Finally, for the third term

$$

we have
(5.7c) \|IV ${ }_{231} \equiv \varepsilon \frac{\partial^{2}}{\partial x^{2}}\left(R_{m} u_{N}\right) \cdot Q_{N}\left(u_{N}-\bar{u}\right) \| L_{10 c}^{1}(x, t)^{\leq}$

$$
\leq \varepsilon \cdot 4 m^{2} \cdot\left\|R_{m} u_{N}\right\|_{L_{l o c}}^{2}(x, t) \quad\left\|u_{N} \bar{u}\right\|_{L_{l o c}^{2}}(x, t)^{\leq C o n s t} \cdot\left\|u_{N}-\bar{u}\right\|_{L_{l o c}^{2}}(x, t) \quad \rightarrow 0,
$$

and since $\varepsilon R_{m} u_{N} \cdot Q_{N} \bar{u}$ tends weakly to zero, so does the term $I V_{232}$,

From (5.7a) - (5.7d) we conclude that the term $\mathrm{IV}_{2}$ in (5.6 )--and therefore that the right-hand side of (2.2), tends weakly to a negative measure. Thus, by taking the weak 1 imit of (2.2) we recover (1.2) for our limit solution $\bar{u}(x, t)$. Consequently, the strong $L_{\text {Doc }}^{2}$ limit of $u_{N}(x, t)=\bar{u}(x, t)$ is the unique entropy solution of (1.1) as asserted.

## APPENDIX

A. THE L ${ }^{1}$-LOGARITHMIC BOUND OF MONOTONE VISCOSITY KERNELS

We consider symmetric viscosity kernels of the form

$$
Q_{N}(x)=\sum_{\mid k T \leq 2 m} \hat{Q}(k) e^{i k x}+\sum_{2 m<|k| \leq N} e^{i k x}
$$

with monotonically increasing Fourier coefficients. Then, the kernels which correspond to $R_{m}=I-Q_{N}$, are symmetric polynomials of degree $\leq 2 m$
(a.1)

$$
R_{m}(x)=2 \cdot \sum_{|k| \leq 2 m} \hat{R}(k) \cos k x
$$

whose Fourier coefficients are monotonically decreasing, compare (1.13),

$$
\begin{equation*}
1 \geq \hat{R}(k)+\geq 0 \tag{a.2}
\end{equation*}
$$

Such kernels satisfy Assumption II above, as told by

Lemma A.1: There exists a constant such that

$$
\left\|R_{m}(\cdot)\right\|_{L^{1}(x)} \leq \text { Const.logm. }
$$

Proof: The result follows if we can show that $R_{m}(x)$ is majorized by Const.m and Const. $\frac{1}{|x|}$, for then we have

$$
\begin{aligned}
\left\|R_{m}(\cdot)\right\|_{L^{1}(x)} & \leq \int_{|x| \leq \frac{1}{m}} \text { Const } \cdot m \cdot d x+\int_{\frac{1}{m} \leq|x| \leq \pi} \text { Const. } \frac{1}{T x \mid} d x \leq \\
& \leq \frac{2}{m} \text { Const } \cdot m+2 \cdot \text { Const }\left.\cdot 1 \log |x|\right|_{x=\frac{1}{m}} ^{x=\pi} \leq \text { Const. log m. }
\end{aligned}
$$

Since $\quad 0 \leq \hat{R}(k) \leq 1 \quad$ we have

$$
\left|R_{m}(x)\right| \leq 2 \cdot \sum_{|k| \leq 2 m}|\hat{R}(k)| \leq 4 m ;
$$

furthermore, summation by parts yields

$$
\begin{aligned}
& \left|\sin \left(\frac{x}{2}\right) \cdot R_{m}(x)\right|=\left|\sum_{|k| \leq 2 m} \hat{R}(k) \cdot\left[\sin \left(k+\frac{1}{2}\right) x-\sin \left(k-\frac{1}{2}\right) x\right]\right| \leq \\
& \leq 4+\sum_{1 \leq|k| \leq 2 m-1}|\hat{R}(k+1)-\hat{R}(k)| \cdot\left|\sin \left(k+\frac{1}{2}\right) x\right|,
\end{aligned}
$$

and since $\hat{R}(k)$ are assumed to decrease monotonically

$$
\left|R_{m}(x)\right| \leq \frac{6}{\left|\sin \left(\frac{x}{2}\right)\right|} \leq \text { Const. } \frac{1}{|x|}
$$

which completes the proof.
B. THE DECAY RATE OF THE FOURIER COEFFICIENTS-REVISITED

In Section 3, we concluded that the quantities
$E_{k}(t) \equiv\left\|\left(I-S_{k}\right) u_{N}(\cdot, t)\right\|_{L^{2}(x)}$, satisfy for $k>m$, the recursive inequality (3.14)
(b.1)

$$
E_{2 k}(t) \leq \frac{E_{0} \cdot N^{2}}{2 \varepsilon \sqrt{k} \cdot k^{2}} \max _{\frac{t}{2} \leq \tau \leq t} E_{k}(\tau)+e^{-2 \varepsilon k^{2} t} \cdot E_{2 k}\left(\frac{t}{2}\right) .
$$

In this section we complete the details for the solution of these recurrence relations, and obtain that for $k>2^{s} \cdot m$ we have

$$
\begin{equation*}
E_{2 k}(t) \leq\left(\frac{8^{s_{E}} E_{0} \cdot N^{2}}{\varepsilon \sqrt{k} \cdot k^{2}}\right)^{s+1} \cdot E_{0}+\left(1+\frac{8^{s} E_{0} \cdot N^{2}}{\varepsilon \sqrt{k} \cdot k^{2}}\right)^{s} e^{-4^{-s+1} \cdot \varepsilon k^{2} t} \cdot E_{0} \tag{b.2}
\end{equation*}
$$

i.e., (3.15) holds. For $s=0$, (b.2) is reduced to (3.13); now assume that (b.2) is valid for any $k>2^{s} \cdot m$ : in particular, for $k>2^{s+1} \cdot m$ we can use (b.2) with $k$ replaced by $\frac{k}{2}, \frac{k}{2}>2^{s} \cdot m$, and obtain that
(b.3) $\max _{\frac{t}{2} \leq \tau \leq t} E_{k}(\tau) \leq\left(\frac{8^{s+1} E_{0} \cdot N^{2}}{\varepsilon \sqrt{k} \cdot k^{2}}\right)^{s+1} \cdot E_{0}+\left(1+\frac{8^{s+1} E_{0} N^{2}}{\varepsilon \sqrt{k} \cdot k^{2}}\right)^{s} \cdot e^{-4^{-s} \varepsilon k^{2} t} \cdot E_{0} \cdot$

Furthermore, we have
(b.4) $\quad E_{2 k}\left(\frac{t}{2}\right) \leq\left(\frac{8^{s} E_{0} N^{2}}{\varepsilon \sqrt{k} \cdot k^{2}}\right)^{s+1} \cdot E_{0}+\left(1+\frac{8^{s} E_{0} \cdot N^{2}}{\varepsilon \sqrt{k} \cdot k^{2}}\right)^{s} \cdot e^{-2 \cdot 4^{-s} \varepsilon k^{2} t} \cdot E_{0}$.

Using (b.3) and (b.4) to upper bound the right hand side of (b.1) we find

$$
\begin{aligned}
E_{2 k}(t) & \leq \frac{E_{0} \cdot N^{2}}{2 \varepsilon \sqrt{k} \cdot k^{2}} \cdot\left(\frac{8^{s+1} E_{0} \cdot N^{2}}{\varepsilon \sqrt{k} \cdot k^{2}}\right)^{s+1} \cdot E_{0}+ \\
& +\frac{E_{0} N^{2}}{2 \varepsilon \sqrt{k} \cdot k^{2}} \cdot\left(1+\frac{8^{s+1} E_{0} N^{2}}{\varepsilon \sqrt{k} \cdot k^{2}}\right)^{s} \cdot e^{-4^{-s} \varepsilon k^{2} t} \cdot E_{0} \\
& +e^{-2 \varepsilon k^{2} t} \cdot\left(\frac{8^{s} E_{0} N^{2}}{\varepsilon \sqrt{k} \cdot k^{2}}\right)^{s+1} \cdot E_{0} \\
& +e^{-2 \varepsilon k^{2} t} \cdot\left(1+\frac{8^{s} E_{0} N^{2}}{\varepsilon \sqrt{k} \cdot k^{2}}\right)^{s} \cdot e^{-2 \cdot 4^{-s} \varepsilon k^{2} t} \cdot E_{0} \cdot
\end{aligned}
$$

The first of the four terms on the right is less than $\left(\frac{8^{s+1} E_{0} \cdot N^{2}}{\varepsilon \sqrt{k} \cdot k^{2}}\right)^{s+2} \cdot E_{0}$; the sum of the remaining three terms does not exceed

$$
\left(1+\frac{8^{s+1} E_{0} \cdot N^{2}}{\varepsilon \sqrt{k} \cdot k^{2}}\right)^{s+1} \cdot e^{-4^{-s} \varepsilon k^{2} t} \cdot E_{0}
$$

and hence for $k>2^{s+1} \cdot m$ we have

$$
E_{2 k}(t) \leq\left(\frac{8^{s+1} E_{0} \cdot N^{2}}{\varepsilon \sqrt{k} \cdot k^{2}}\right)^{s+2} \cdot E_{0}+\left(1+\frac{8^{s+1} E_{0} \cdot N^{2}}{\varepsilon \sqrt{k} \cdot k^{2}}\right)^{s+1} e^{-4^{-s} \varepsilon k^{2} t} \cdot E_{0}
$$

which completes the induction proof of (b,4).
