Immunization of Health-care Personnel: Recommendations of the Advisory Committee on Immunization Practices (ACIP)

Goal

This activity will change the impact of competence and patient /client outcome by assisting hospital administrators, infection control practitioners, employee health clinicians, and HCP in Optimizing infection prevention and control programs. Disease- specific outbreak control measures are described in this report. Nationwide, ongoing implementation of these vaccine recommendations through well-managed vaccination programs could substantially reduce both the number of susceptible HCP in any setting in which they interact with patients and their risks for transmitting vaccine-preventable diseases to other personnel and patients.

2. The interval between administration of Td and Tdap might be <5 years as indicated in package insert.

The other Tdap product, Boostrix (GlaxoSmithKline Biologicals, Rixensart, Belgium), is labeled for use in persons aged ≥ 10 years. Until ACIP reviews the current recommendations on use of Tdap in persons aged ≥ 65 years, either Tdap product may be used in persons aged ≥ 65 years.
4. Meningococcal conjugate vaccines are licensed only as a single dose. The 2-dose series of meningococcal conjugate vaccine is recommended for persons with certain medical risk factors, and the booster dose of meningococcal
