# PSEUDO-MAXIMUM LIKELIHOOD ESTIMATION OF ARCH( $\infty$ ) MODELS

Strong consistency and asymptotic normality of the Gaussian pseudomaximum likelihood estimate of the parameters in a wide class of ARCH $(\infty)$ processes are established. The conditions are shown to hold in case of exponential and hyperbolic decay in the ARCH weights, though in the latter case a faster decay rate is required for the central limit theorem than for the law of large numbers. Particular parameterizations are discussed.

1. Introduction. $\operatorname{ARCH}(\infty)$ processes comprise a wide class of models for conditional heteroscedasticity in time series. Consider, for $t \in \mathbb{Z}=\{0, \pm 1, \ldots\}$, the equations

and $\left\{\varepsilon_{t}\right\}$ is a sequence of independent identically distributed (i.i.d.) unobservable real-valued random variables. We shall assume that a strictly stationary solution $x_{t}$ to (1) and (2) exists almost surely (a.s.) under (3), and call it an $\operatorname{ARCH}(\infty)$ process. We consider a parametric version, in which we know functions $\psi_{j}(\zeta)$ of the $r \times 1$ vector $\zeta$, for $r<\infty$, such that, for some unknown $\zeta_{0}$,

Also, $\omega_{0}$ is unknown and $x_{t}$ is unobservable but we observe

[^0]for some unknown $\mu_{0}$.
$\operatorname{ARCH}(\infty)$ processes, extending the $\operatorname{ARCH}(m), m<\infty$, process of Engle [11] and the $\operatorname{GARCH}(n, m)$ process of Bollerslev [4], were considered by Robinson [29] as a class of parametric alternatives in testing for serial independence of $y_{t}$. Empirical evidence of Whistler [35] and Ding, Granger and Engle [10] has suggested the possibility of long memory autocorrelation in the squares of financial data. Taking [contrary to the first requirement in (3)] $\omega_{0}=0$, such long memory in $x_{t}^{2}$ driven by (1) and (2) was considered by Robinson [29], the $\psi_{0 j}$ being the autoregressive weights of a fractionally integrated process, implying $\sum_{j=1}^{\infty} \psi_{0 j}=1$; see also Ding and Granger [9]. For such $\psi_{0 j}$, and the same objective function as was employed to generate the tests of Robinson [29], Koulikov [20] established asymptotic statistical properties of estimates of $\zeta_{0}$. On the other hand, under our assumption $\omega_{0}>0$, Giraitis, Kokoszka and Leipus [13] found that such $\psi_{0 j}$ are inconsistent with covariance stationarity of $x_{t}$, which holds when $\sum_{j=1}^{\infty} \psi_{0 j}<1$. Finite variance of $x_{t}$ implies summability of coefficients of a linear moving average in martingale differences representation of $x_{t}^{2}$; see [37]. In this paper we do not assume finite variance of $x_{t}$, but rather that $x_{t}$ has a finite fractional moment of degree less than 2. The first requirement in (3) was shown by Kazakevičius and Leipus [18] to be necessary for existence of an $x_{t}$ satisfying (1) and (2). The intermediate requirement in (3) is sufficient but not necessary for a.s. positivity of $\sigma_{t}^{2}$, and is imposed here to facilitate a clearer focus on the $\psi_{0 j}$, which decay, possibly slowly, but never vanish.

We wish to estimate the $(r+2) \times 1$ vector $\theta_{0}=\left(\omega_{0}, \mu_{0}, \zeta_{0}^{\prime}\right)^{\prime}$ on the basis of observations $y_{t}, t=1, \ldots, T$, the prime denoting transposition. The case when $\mu_{0}$ is known, for example, $\mu_{0}=0$, is covered by a simplified version of our treatment. If the $y_{t}$ were instead unobserved regression errors, we have $\mu_{0}=0$, but would then need to replace $x_{t}$ by residuals in what follows; the details of this extension would be relatively straightforward. Another relatively straightforward extension would cover simultaneous estimation of the regression parameters $\omega_{0}$ and $\zeta_{0}$, after replacing $\mu_{0}$ by a more general parametric function; as in (1), (2) and (5), efficiency gain is afforded by simultaneous estimation.

Under stronger restrictions than $\sum_{j=1}^{\infty} \psi_{0 j}<1$, Giraitis and Robinson [14] considered discrete-frequency Whittle estimation of $\zeta_{0}$, based on the squared observations $y_{t}^{2}$ (with $\mu_{0}$ known to be zero), this being asymptotically equivalent to constrained least squares regression of $y_{t}^{2}$ on the $y_{t-s}^{2}, s>0$, a method employed in special cases of (2) by Engle [11] and Bollerslev [4]. In these the spectral density of $y_{t}^{2}$, when it exists, has a convenient closed form. This property, along with availability of the fast Fourier transform, makes discrete-frequency Whittle estimation based on the $y_{t}^{2}$ a computationally attractive option for point estimation, even in very long financial time series. However, it has a number of disadvantages, as discussed by Giraitis and Robinson [14]: it is not only asymptotically inefficient under Gaussian $\varepsilon_{t}$, but never asymptotically efficient; it requires finiteness
of fourth moments of $y_{t}$ for consistency and of eighth moments for asymptotic normality, which are sometimes considered unacceptable for financial data; its limit covariance matrix is relatively complicated to estimate; it is less well motivated in ARCH models than in stochastic volatility and nonlinear moving average models, such as those of Taylor [33], Robinson and Zaffaroni [30, 31], Harvey [15], Breidt, Crato and de Lima [5] and Zaffaroni [36], where the actual likelihood is computationally relatively intractable, while Whittle estimation also plays a less special role in the short-memory-in- $y_{t}^{2}$ ARCH models of Giraitis and Robinson [14] than in the long-memory-in- $y_{t}^{2}$ models of the previous five references, where it entails automatic "compensation" for possible lack of square-integrability of the spectrum of $y_{t}^{2}$. Mikosch and Straumann [26] have shown that a finite fourth moment is necessary for consistency of Whittle estimates, and that convergence rates are slowed by fat tails in $\varepsilon_{t}$.

For Gaussian $\varepsilon_{t}$, a widely-used approximate maximum likelihood estimate is defined as follows. Denote by $\theta=\left(\omega, \mu, \zeta^{\prime}\right)^{\prime}$ any admissible value of $\theta_{0}$ and define

for $t \geq 1$, where $\mathbb{1}(\cdot)$ denotes the indicator function. Define also

where $\Theta$ is a prescribed compact subset of $\mathbb{R}^{r+2}$. The quantities with over-bar are introduced due to $y_{t}$ being unobservable for $t \leq 0 ; \tilde{\theta}_{T}$ is uncomputable. Because we do not assume Gaussianity in the asymptotic theory, we refer to $\hat{\theta}_{T}$ as a pseudomaximum likelihood estimate (PMLE).

We establish strong consistency of $\dot{\theta}_{T}$ and asymptotic normality of $T^{1 / 2}\left(\hat{\theta}_{T}-\right.$ $\left.\theta_{0}\right)$, as $T \rightarrow \infty$, for a class of $\psi_{j}(\zeta)$ sequences. In the case of the first property this is accomplished by first showing strong consistency of $\tilde{\theta}_{T}$ and then that $\hat{\theta}_{T}-\tilde{\theta}_{T} \rightarrow 0$, a.s. In the case of the second we likewise first show it for
$T^{1 / 2}\left(\tilde{\theta}_{T}-\theta_{0}\right)$ and then show that $\hat{\theta}_{T}-\tilde{\theta}_{T}=o_{p}\left(T^{-1 / 2}\right)$, but the latter property, and thus the asymptotic normality of $T^{1 / 2}\left(\hat{\theta}_{T}-\theta_{0}\right)$, is achieved only under a restricted set of possible $\zeta_{0}$ values, and this seems of practical concern in relation to some popular choices of the $\psi_{j}(\zeta)$. These results are presented in the following section, along with a description of regularity conditions and partial proof details. The structure of the proof is similar in several respects to earlier ones for the GARCH case of (2), especially that of Berkes, Horváth and Kokoszka [3]. Sections 3 and 4 apply the results to particular models.
2. Assumptions and main results. Our assumptions are as follows.

ASSUMPTION $\mathrm{A}(q), q \geq 2$. The $\varepsilon_{t}$ are i.i.d. random variables with $E \varepsilon_{0}=0$, $E \varepsilon_{0}^{2}=1, E\left|\varepsilon_{0}\right|^{q}<\infty$ and probability density function $f(\varepsilon)$ satisfying

for $b>-1$ and a function $L$ that is slowly varying at the origin.

Assumption B. There exist $\omega_{L}, \omega_{U}, \mu_{L}, \mu_{U}$ such that $0<\omega_{L}<\omega_{U}<\infty$, $-\infty<\mu_{L}<\mu_{U}<\infty$, and a compact set $\Upsilon \in R^{r}$ such that $\Theta=\left[\omega_{L}, \omega_{U}\right] \times$ $\left[\mu_{L}, \mu_{U}\right] \times \Upsilon$.

Assumption C. $\quad \theta_{0}$ is an interior point of $\Theta$.

Assumption D. For all $j \geq 1$,

where $K$ throughout denotes a generic, positive constant.

ASSUMPTION E. There exists a strictly stationary and ergodic solution $x_{t}$ to (1) and (2), and for some

with $\underline{d}$ as in Assumption D, we have

ASSUMPTION $\mathrm{F}(l)$. For all $j \geq 1, \psi_{j}(\zeta)$ has continuous $k$ th derivative on $\Upsilon$ such that, with $\zeta_{i}$ denoting the $i$ th element of $\zeta$,

ASSUMPTION G. For each $\zeta \in \Upsilon$, there exist integers $j_{i}=j_{i}(\zeta), i=1, \ldots, r$, such that $1 \leq j_{1}(\zeta)<\cdots<j_{r}(\zeta)<\infty$ and

Assumption H. There exists

Assumption $\mathrm{A}(q)$ allows some asymmetry in $\varepsilon_{t}$, but implies the less primitive condition (which does not even require existence of a density) employed in a similar context by Berkes, Horváth and Kokoszka [3]. Assumptions B and C are standard. Inequalities (7) and (13) together imply $d_{0} \geq \underline{d}$, while (8) with (3) is milder than monotonicity but implies $\psi_{0 j}=o\left(j^{-1}\right)$ as $j \rightarrow \infty$. We take $\eta>0$ in Assumption $\mathrm{F}(l)$ because $\psi_{j}(\zeta)<1$ for all large enough $j$, by (7). Assumption G is crucial to the proof of consistency, being used in Lemmas 9 and 10 to show that in the limit $\theta_{0}$ globally minimizes $Q_{T}(\theta)$; it also ensures nonsingularity of the matrix $H_{0}$ in Proposition 2 and Theorem 2 below. This and other assumptions are discussed in Sections 3 and 4 in connection with some parameterizations of interest.

We present asymptotic results for the uncomputable $\tilde{\theta}_{T}$ as propositions, those for $\hat{\theta}_{T}$ as theorems. All these, and the corollaries in Sections 3 and 4 and lemmas in Section 5, assume (1)-(5).

Proposition 1. For some $\delta>0$, let Assumptions $\mathrm{A}(2+\delta), \mathrm{B}, \mathrm{C}, \mathrm{D}, \mathrm{E}, \mathrm{F}(1)$ and G hold. Then

Proof. The proof follows as in, for example, [17], Theorem 6, from uniform a.s. convergence over $\Theta$ of $Q_{T}(\theta)$ to $Q(\theta)=E q_{0}(\theta)$ established in Lemma 7, the fact that $Q_{T}\left(\hat{\theta}_{T}\right) \leq Q_{T}(\theta)$, and Lemma 10 .

THEOREM 1. For some $\delta>0$, let Assumptions $\mathrm{A}(2+\delta), \mathrm{B}, \mathrm{C}, \mathrm{D}, \mathrm{E}, \mathrm{F}(1)$ and G hold. Then

Proof. From Lemmas 7 and $8, \bar{Q}_{T}(\theta)$ converges uniformly to $Q(\theta)$ a.s., whence the proof is as indicated for Proposition 1.

Denote by $\kappa_{j}$ the $j$ th cumulant of $\varepsilon_{t}$ and introduce

for $\tau_{0}=\tau_{0}\left(\theta_{0}\right), \tau_{t}(\theta)=(\partial / \partial \theta) \log \sigma_{t}^{2}(\theta)$, and $e_{2}$ the second column of the $(r+$ $2) \times(r+2)$ identity matrix. In case $\mu_{0}$ is known (e.g., to be zero), we omit the second row and column from $M$, and have instead $G_{0}=\left(2+\kappa_{4}\right) M, H_{0}=M$. In case $\varepsilon_{t}$ is Gaussian, $\kappa_{3}=\kappa_{4}=0$, so $G_{0}=2 H_{0}=2 M+P$.

Proposition 2. Let Assumptions A(4), B, C, D, E, F(3) and G hold. Then

By the mean value theorem,

where $\tilde{H}_{T}$ has as its $i$ th row the $i$ th row of $H_{T}(\theta)=T^{-1} \sum_{t=1}^{T} h_{t}(\theta)$ evaluated at $\theta=\tilde{\theta}_{T}^{(i)}$, where $h_{t}(\theta)=\left(\partial^{2} / \partial \theta \partial \theta^{\prime}\right) Q_{T}(\theta),\left\|\tilde{\theta}_{T}^{(i)}-\theta_{0}\right\| \leq\left\|\tilde{\theta}_{T}-\theta_{0}\right\|$, where
we define $\|A\|=\left\{\operatorname{tr}\left(A^{\prime} A\right)\right\}^{1 / 2}$ for any real matrix $A$. Now $u_{t}\left(\theta_{0}\right)=\tau_{t}\left(\theta_{0}\right)(1-$ $\left.\varepsilon_{t}^{2}\right)-2 e_{2} \varepsilon_{t} / \sigma_{t}$ is, by Lemmas 2,3 and 7 , a stationary ergodic martingale difference vector with finite variance, so from Brown [6] and the Cramér-Wold device, $T^{1 / 2} Q_{T}^{(1)}\left(\theta_{0}\right) \rightarrow_{d} N\left(0, G_{0}\right)$ as $T \rightarrow \infty$. Finally, by Lemma 7 and Theorem 1 , $\widetilde{H}_{T} \rightarrow_{p} H_{0}$, whence the proof is completed in standard fashion.

Define

Theorem 2. Let Assumptions A(4), B, C, D, E, F(3), G and H hold. Then

and $H_{0}^{-1} G_{0} H_{0}^{-1}$ is strongly consistently estimated by $\bar{H}_{T}^{-1}\left(\hat{\theta}_{T}\right) \bar{G}_{T}\left(\hat{\theta}_{T}\right) \bar{H}_{T}^{-1}\left(\hat{\theta}_{T}\right)$.
Proof. We have

where $\bar{Q}_{T}^{(1)}(\theta)=(\partial / \partial \theta) Q_{T}(\theta)$ and $\widehat{H}_{T}$ has as its $i$ th row the ith row of $\bar{H}_{T}(\theta)$ evaluated at $\theta=\hat{\theta}_{T}^{(i)}$, for $\left\|\hat{\theta}_{T}^{(i)}-\theta_{0}\right\| \leq\left\|\hat{\theta}_{T}-\theta_{0}\right\|$. Thus, from (16),

b_{1 t}=-\frac{\bar{\sigma}_{t}^{2(1)}\left(\sigma_{t}^{2}-\bar{\sigma}_{t}^{2}\right)}{\bar{\sigma}_{t}^{4}}, \quad b_{2 t}=\frac{\sigma_{t}^{2(1)}}{\sigma_{t}^{2}}-\frac{\bar{\sigma}_{t}^{2(1)}}{\bar{\sigma}_{t}^{2}}, \quad b_{3 t}=\frac{\sigma_{t}^{2}-\bar{\sigma}_{t}^{2}}{\bar{\sigma}_{t}^{2} \sigma_{t}}
$$

for $\bar{\sigma}_{t}^{2}=\bar{\sigma}_{t}^{2}\left(\theta_{0}\right), \quad \sigma_{t}^{2(1)}=\sigma_{t}^{2(1)}\left(\theta_{0}\right), \quad \bar{\sigma}_{t}^{2(1)}=\bar{\sigma}_{t}^{2(1)}\left(\theta_{0}\right)$, with $\sigma_{t}^{2(1)}(\theta)=$ $(\partial / \partial \theta) \sigma_{t}^{2}(\theta), \bar{\sigma}_{t}^{2(1)}(\theta)=(\partial / \partial \theta) \bar{\sigma}_{t}^{2}(\theta)$. We show that $B_{i T}=o_{p}\left(T^{1 / 2}\right), i=1,2,3$. For the remainder of this proof, we drop the zero subscript in $\psi_{0 j}$.

Consider first $B_{1 T}$. We have

Consider $B_{2 T}$. By independence of $\varepsilon_{t}$ and $b_{2 t}$, by the $c_{r}$-inequality when $\rho \leq \frac{1}{2}$, and by the inequality of von Bahr and Esseen [34] and the fact that the $\varepsilon_{t}^{2}$ are i.i.d. with mean 1 when $\rho>\frac{1}{2}$,

Thus, from Assumptions $\mathrm{F}(1)$ and H ,

& \leq \sigma_{t}^{-2}\left[2\left\{\sum_{j=t}^{\infty} \psi_{j}\right\}^{1 / 2}+\left\{\sum_{j=t}^{\infty}\left(\left\|\psi_{j}^{(1)}\right\|^{2} / \psi_{j}\right) x_{t-j}^{2}\right\}^{1 / 2}\right]\left\{\sum_{j=t}^{\infty} \psi_{j} x_{t-j}^{2}\right\}^{1 / 2} \\
& \leq K\left\{\left(\sum_{j=t}^{\infty} j^{-d_{0}-1}\right)^{1 / 2}+\left(\sum_{j=t}^{\infty} \psi_{j}^{1-2 \eta} x_{t-j}^{2}\right)^{1 / 2}\right\} \\
& \leq K\left[t^{-d_{0} / 2}+\left\{\sum_{j=t}^{\infty} j^{-\left(d_{0}+1\right)(1-2 \eta)} x_{t-j}^{2}\right\}^{1 / 2}\right]
\end{aligned}

so

applying the $c_{r}$-inequality when $\rho \leq \frac{1}{2}$ and von Bahr and Esseen [34] when $\rho>\frac{1}{2}$. Now $b_{3 t} \leq\left(\sigma_{t}^{2}-\bar{\sigma}_{t}^{2}\right)^{1 / 2} \bar{\sigma}_{t}^{-2}$, so from (20),

much as before. Thence, $B_{3 T}=o_{p}\left(T^{1 / 2}\right)$.
It remains to consider the last statement of the theorem, which follows on standard application of Propositions 1 and 2, Theorem 1 and Lemmas 7 and 8.

In earlier versions of this paper we checked the conditions in the case of $\operatorname{GARCH}(n, m)$ models in which the $\psi_{j}(\zeta)$ decay exponentially and we allow the possibility that the GARCH coefficients lie in a subspace of dimension less than $m+n$; the details are available from the authors on request. However, the literature on asymptotic theory for estimates of GARCH models is now extensive, recent references including [3, 7, 12, 16, 22, 32], along with investigations of the properties of the models themselves; see recently [2, 18, 25]. We focus instead on alternative models which have received less attention, and for which our theoretical framework is primarily intended.

We introduce the generating function

3. Fractional GARCH models. A slowly decaying class of $\mathrm{ARCH}(\infty)$ weights was considered by Robinson [29], Ding and Granger [9] and Koulikov [20], generated by

In these references $\omega_{0}=0$ was assumed in (2), but we assume $\omega_{0}>0$ and generalize (23) as follows. Introduce the functions $a_{j}=a_{j}(\zeta), b_{j}=b_{j}(\zeta)$ and, for $m \geq 1$, $n \geq 0, n+m \geq r$,

Now take $\psi(z ; \zeta)(22)$ to be given by

with $d=d(\zeta)$ satisfying

We call $x_{t}$ based on (29) a fractional GARCH, $\operatorname{FGARCH}\left(n, d_{0}, m\right)$ process, for $d_{0}=d\left(\zeta_{0}\right)$.

Corollary 1. Let $\psi(z ; \zeta)$ be given by (29) and (25) with $m \geq 1, n \geq 0$, and let $d$ and the $a_{j}, b_{j}$ be continuously differentiable. For some $\delta>0$, let Assumptions $\mathrm{A}(2+\delta), \mathrm{B}, \mathrm{C}$ and E hold, with all $\zeta \in \Upsilon$ satisfying (26)-(28), (30) and

Then (15) is true. Let also $d$ and the $a_{j}, b_{j}$ be thrice continuously differentiable and $d_{0}>\frac{1}{2}$. Then (17) is true.

Proof. Denoting by $c_{j}(j \geq 1)$ and $d_{j}(j \geq 0)$ the coefficients of $z^{j}$ in the expansions of $a(z ; \zeta) / b(z ; \zeta), z^{-1}\left\{1-(1-z)^{d}\right\}$, respectively, we have $\psi_{j}(\zeta)=$ $\sum_{k=0}^{j-1} c_{j-k} d_{k}, j \geq 1$. From [3], the $c_{j}$ are bounded above and below by positive, exponentially decaying sequences when $n \geq 1$, and are all nonnegative when $n=0$. Since the $d_{j}$ are all positive, it follows that (6) holds. Also, Stirling's approximation indicates that $j^{-d-1} / K \leq d_{j} \leq K j^{-d-1}$, so the $\psi_{j}(\zeta)$ satisfy the same inequalities. Compactness of $\Upsilon$, smoothness of $d$, and (30), imply $d(\zeta) \geq \underline{d}$, to check (7). The above argument indicates that $\psi_{0 j} \leq K j^{-d_{0}-1} \leq K k^{-d_{0}-1} \leq K \psi_{0 k}$ for $j>k \geq 1$, so (8) holds, and thus Assumption D. With regard to (11), note that $(\partial / \partial d) \psi(z ; \zeta)=-\{a(z ; \zeta) / b(z ; \zeta)\} z^{-1}(1-z)^{d} \ln (1-z)$, where the coefficient of $z^{j}$ in $-z^{-1}(1-z)^{d} \ln (1-z)$ is $\sum_{k=1}^{j} k^{-1} d_{j-k} \leq K(\ln j) j^{-d-1} \leq$
$K j^{-(d+1)(1-\eta)} \leq K \psi_{j}^{1-\eta}(\zeta)$ for any $\eta>0$. Derivatives with respect to the $a_{j}, b_{j}$ are dominated, and higher derivatives can be dealt with similarly, to complete the checking of Assumption $\mathrm{F}(l)$. To check Assumption G, suppress reference to $\zeta$ in $a, b, \psi$ and

Choose $j_{i}(\zeta)=i$ for $i=1, \ldots, m+n, \zeta \in \Upsilon$, leaving $j_{m+n+1}(\zeta)$ to be determined subsequently. Fix $\zeta$ and write $U=\Psi_{\left(j_{i}, \ldots, j_{r}\right)}(\zeta)$, partitioning it in the ratio $m+n: 1$ and calling its $(i, j)$ th submatrix $U_{i j}$. We first show that the $(m+n) \times(m+n)$ matrix $U_{11}$ is nonsingular. Write $R$ for the $n \times(m+n)$ matrix with $(i, j)$ th element $\gamma_{j-i}$, and $S$ for the $(m+n) \times(m+n)$ matrix with $(i, j)$ th element $\phi_{j-i+1}$, where $\phi_{j}=\gamma_{j}=0$ for $j \leq 0$, and for $j>0, \phi_{j}$ and $\gamma_{j}$ are respectively given by

these series converging absolutely for $|z| \leq 1$ in view of (30). Noting that $\psi_{j}^{(1)}$ is given by $(\partial / \partial \zeta) \psi(z)=\sum_{j=1}^{\infty} \psi_{j}^{(1)} z^{j}$, we find that the first $m$ rows of $U_{11}$ can be written $\left(I_{m}, O\right) S$, where $I_{m}$ is the $m$-rowed identity matrix, $O$ is the $m \times n$ matrix of zeroes and, when $n \geq 1$ the last $n$ rows of $U_{11}$ can be written $R S$. Now $S$ is upper-triangular with nonzero diagonal elements. Thus, for $n=0, U_{11}=S$ is nonsingular. For $n \geq 1, U_{11}$ is nonsingular if and only if the $n \times n$ matrix $R_{2}$ having $(i, j)$ th element $\gamma_{m+j-i}$ and consisting of the last $n$ columns of $R$ is nonsingular. This is not so if and only if the $\gamma_{j}, j=m, \ldots, m+n-1$, are generated by a homogeneous linear difference equation of degree $n-1$, that is, if there exist scalars $\lambda_{0}, \lambda_{1}, \ldots, \lambda_{n-1}$, not all zero, such that

But it follows from (25) and (27) that they are generated by the linear difference equation

where $\pi_{m}=a_{m}+b_{n} \gamma_{m-n}, \pi_{j}=b_{n} \gamma_{j-n}$ for $j=m+1, \ldots, m+n-1$. Since $b_{n} \neq 0$, the $\pi_{j}$ are all zero if and only if $\gamma_{m-n}=-a_{m} / b_{n}$ and $\gamma_{j}=0$ for $j=$ $m+1-n, \ldots, m-1$. But this implies $\gamma_{m}=0$ also, and thence, $\gamma_{j}=0$, all $j \geq m-$ $n+1$. For $m \leq n$, this is inconsistent with the requirement $a_{j}>0, j=1, \ldots, m$, and for $m>n$, it implies $a$ has a factor $b$, which is inconsistent with (28). Thus, $U_{11}$ is nonsingular when $n \geq 1$. Nonsingularity of $U$ follows if $U_{22} \neq U_{21} U_{11}^{-1} U_{12}$. For large enough $j_{m+n+1}=j_{m+n+1}(\zeta)$, this must be true because $U_{22}$ decays like $\left(\ln j_{m+n+1}\right) j_{m+n+1}^{-d-1}$, whereas the elements of $U_{12}$ are $O\left(\beta^{j_{m+n+1}}\right)$ for some $\beta \in$ $(0,1)$. Thus Assumption $G$ is true, and thence (15). Clearly (13) is true, so under the additional conditions so is Assumption H , and thence (17).

For $m=1, n=0,(29)$ reduces to (23) when $a_{1}=1$, while when $a_{1} \in(0,1)$, it gives model (4.24) of Ding and Granger [9]. The important difference between these two cases is that the covariance stationarity condition $\psi\left(1 ; \zeta_{0}\right)<1$ is satisfied in the second but not in the first. In general with (29), as with the GARCH model, $x_{t}$ is covariance stationary when $a\left(1 ; \zeta_{0}\right)<b\left(1 ; \zeta_{0}\right)$ but not otherwise. We compare (29) with

with $d$ again satisfying (30) and $a$ and $b$ again given as in (25), though we now allow $m=0$, meaning $a(z ; \zeta) \equiv 0$. Thus, with $m=n=0$, (31) reduces to (23). $\operatorname{ARCH}(\infty)$ models with $\psi$ given by (31) were proposed by Baillie, Bollerslev and Mikkelsen [1] and called $\operatorname{FIGARCH}\left(n, d_{0}, m\right)$. In general, though (31) also gives hyperbolically decaying $\psi_{0 j}$, it differs in some notable respects. Application of (26)-(28) again ensures positivity of $\psi_{j}(\zeta)$ in case of FGARCH and facilitates the above proof, but sufficient conditions in FIGARCH are less apparent in general, though Baillie, Bollerslev and Mikkelsen [1] indicated that they can be obtained. Also, unlike FGARCH, FIGARCH $x_{t}$ never has finite variance.

The requirement $d_{0}>\frac{1}{2}$ for the central limit theorem in Corollary 1 would also be imposed in a corresponding result for FIGARCH. This is automatically satisfied in GARCH models but if only $d_{0} \in\left(0, \frac{1}{2}\right]$ in (13) is possible in the general setting of Section 3, it appears that the asymptotic bias in $\hat{\theta}_{T}$ is of order at least $T^{-1 / 2}$, whereas that for $\tilde{\theta}_{T}$ is always $o\left(T^{-1 / 2}\right)$. Assumption H copes with the replacement of $\sigma_{t}^{2}(\theta)$ by $\bar{\sigma}_{t}^{2}(\theta)$, the truncation error varying inversely with $d_{0}$. Inspection of the proof of Theorem 2 indicates that this bias problem is due to the term $H^{-1} B_{1 T}$. The factor $\sigma_{t}^{2}-\bar{\sigma}_{t}^{2}$ in $b_{1 t}$ is nonnegative, and if $j^{-d_{0}-1}$ is an exact rate for $\psi_{0 j}$, $\sigma_{t}^{2}-\bar{\sigma}_{t}^{2}$ exceeds $t^{-d_{0}} / K$ as $t \rightarrow \infty$ with probability approaching one. So far as the factor $\bar{\sigma}_{t}^{2(1)} / \sigma_{t}^{4}$ in $b_{1 t}$ is concerned, the second element of $\bar{\sigma}^{2(1)}$ [see (18)] has zero mean, but the first is positive, and though the $\psi_{j}^{(1)}$ can have elements of either sign, whenever $d_{0} \leq \frac{1}{2}$ it seems unlikely that the last $r$ elements of $B_{1 T}$ can be
$o_{p}\left(T^{1 / 2}\right)$. Nor is there scope for relaxing (12) by strengthening other conditions. With regard to implications for choice of $\rho$, when $d_{0} \geq 2 \underline{d}+\frac{1}{2}$, (14) entails no restriction over (9).

Though results of Giraitis, Kokoszka and Leipus [13] indicate existence of a stationary solution of (1)-(3) when $\psi\left(1 ; \zeta_{0}\right)<1$, Kazakevičius and Leipus [19] have questioned the existence of strictly stationary FIGARCH processes, and thus the relevance of Assumption E here. The same reservations can be expressed about FGARCH when $a\left(1 ; \zeta_{0}\right) \geq b\left(1 ; \zeta_{0}\right)$, and more generally about $\operatorname{ARCH}(\infty)$ processes with $\psi\left(1 ; \zeta_{0}\right) \geq 1$. A sufficient condition for (10) can be deduced as follows. Recursive substitution gives

Thus, (10) holds if there is a $\rho$ satisfying (9) and (32). Recursive substitution and the $c_{r}$-inequality were also used by Nelson ([27], Corollary) to upper-bound $E\left|\sigma_{t}\right|^{2 \rho}$ in the $\operatorname{GARCH}(1,1)$ case, but he employed the simple dynamic structure available there, and (32) does not reduce to his necessary and sufficient condition.

If $\psi\left(1 ; \zeta_{0}\right)<1$, (32) adds nothing because we already know that $E x_{0}^{2}<\infty$ here, but if $\psi\left(1 ; \zeta_{0}\right) \geq 1$, the second factor on the left-hand side of (32) exceeds 1 and increases with $\rho$; the question is whether the first factor, which is less than 1 and decreases with $\rho$ [due to Assumption $\mathrm{A}(q)$ ], can over-compensate. Analytic verification of (32) for given $\zeta_{0}, \rho$ seems in general infeasible, and numerical verification highly problematic when the $\psi_{j}$ decay slowly. However, consider the family of densities

for $\gamma>0$, where $\alpha(\gamma)=\{\Gamma(\gamma) / \Gamma(3 \gamma)\}^{1 / 2}$ (also used by Nelson [28] to model the innovation of the exponential GARCH model). We have $E \varepsilon_{0}=0, E \varepsilon_{0}^{2}=1$ as necessary, Assumption $\mathrm{A}(q)$ is satisfied for all $q>0$, and $E\left|\varepsilon_{0}\right|^{2 \rho}=\Gamma((2 \rho+$ 1) $\gamma) /\left\{\Gamma(\gamma)^{1-\rho} \Gamma(3 \gamma)^{\rho}\right\}$. In case $\gamma=0.5$, (33) is the normal density, for which $\hat{\theta}_{T}$ is asymptotically efficient. Here $E\left|\varepsilon_{0}\right|^{2 \rho}=2^{\rho} \Gamma(\rho+0.5) / \sqrt{\pi}$, and numerical calculations for $\operatorname{FIGARCH}\left(0, d_{0}, 0\right)$ cast doubt on (32). In case $\gamma=1$, (33) is the Laplace density, with $E\left|\varepsilon_{0}\right|^{2 \rho}=2^{\rho-1} \Gamma(2 \rho+1)$. As $\gamma$ increases, $E\left|\varepsilon_{0}\right|^{2 \rho}$ can be made small for fixed $\rho<1$, for example, with $\rho=0.95$, it is 0.64 when $\gamma=10$ and 0.42 when $\gamma=20$.
4. Generalized exponential and hyperbolic models. $\operatorname{FGARCH}\left(n, d_{0}, m\right)$ [and $\operatorname{FIGARCH}\left(n, d_{0}, m\right)$ ] processes require $d_{0} \in(0,1)$. For $d=1$, (29) reduces to (23), and for $d>1$, at least one coefficient in the expansion of (23) is negative, leading to the possibility of negative $\psi_{j}(\zeta)$. Because FGARCH $\psi_{j}(\zeta)$ decay like $j^{-d-1}$, a large mathematical gap is left relative to GARCH processes. Even if exponential decay is anticipated, there is a case for more direct modeling of the $\psi_{j}(\zeta)$ than provided by $\operatorname{GARCH}(n, m)$, since it is the $\psi_{j}(\zeta)$ and their derivatives that must be formed in point and interval estimation based on the PMLE.

Consider the choices

where $d=d(\zeta)$ and the $e_{i}=e_{i}(\zeta), f_{i}=f_{i}(\zeta)$ are such that $\Upsilon$ satisfies

with $2 m+1 \geq r$. Given (1)-(4) and (22), we call $x_{t}$ generated by (34) a generalized exponential, $\operatorname{GEXP}(m)$, process, and $x_{t}$ generated by (35) a generalized hyperbolic, $\operatorname{GHYP}(m)$, process. Condition (38) is sufficient but not necessary for $\psi_{j}(\zeta)>0$, all $j \geq 1$. By choosing $m$ large enough in (34) or (35), any finite $\psi(1 ; \zeta)$ can be arbitrarily well approximated, but (34) and (35) can also achieve parsimony. For real $x \geq 1, x^{f} e^{-d x}$ and $(\ln x)^{f} x^{-d-1}$ decay monotonically if $f=0$, and for $f>0$, have single maxima at $f / d$ and $e^{f /(d+1)}$, respectively. Thus, with $m=1$ and $f_{1}=0$, we have monotonic decay in (34) and (35); otherwise, both can exhibit lack of monotonicity, while eventually decaying exponentially or hyperbolically. The scale factors in (34) and (35) are so expressed because $x^{f} e^{-d x}$ and $(\ln x)^{f} x^{-d-1}$ integrate over $(0, \infty)$ to $\Gamma(f+1) / d^{f+1}$ and $\Gamma(f+1) / d$, respectively, so that $\psi(1 ; \zeta) \bumpeq \sum_{i=1}^{m} e_{i}$ in both cases, but the approximation may
not be very close and the "integrated" case is less easy to distinguish than in GARCH and FGARCH models (though it would be possible to alternatively scale the weights by infinite sums to achieve equality).

The following corollary covers (34) and (35) simultaneously, and implies the special case when the $f_{i}$ are specified a priori, for example, to be nonnegative integers; strictly speaking, when the true value of $f_{1}$ is unknown, Assumption C prevents it from being zero.

Corollary 2. Let $\psi(z ; \zeta)$ be given by (22) and (34) or (35) with $m \geq 1$ and let $d$ and the $e_{i}, f_{i}$ be continuously differentiable. For some $\delta>0$, let Assumptions $\mathrm{A}(2+\delta), \mathrm{B}, \mathrm{C}$ and E hold, with all $\zeta \in \Upsilon$ satisfying (36)-(38) and

Then (15) is true. Let also $d$ and the $e_{i}, f_{i}$ be thrice continuously differentiable and Assumption $\mathrm{A}(4)$ hold, and $d_{0}=d\left(\zeta_{0}\right)>\frac{1}{2}$ in case of (35). Then (17) is true.

Proof. Given (36)-(38) and the proofs of Corollaries 1 and 2, the verification of Assumptions D and $\mathrm{F}(l)$ is straightforward. We check Assumption G for (35) only, a very similar type of proof holding for (34). We have

and $E$ is the diagonal matrix whose $(2 i-1)$ st diagonal element is $e_{i}$, and whose even diagonal elements are all 1 . Fixing $\zeta$, we show first that the leading $(r-1) \times(r-1)$ submatrix of $\Psi_{\left(j_{1}, \ldots, j_{r}\right)}(\zeta)$ has full rank, equivalently, that $U_{m}$ has full rank, where, for $i=1, \ldots, m$, the $(2 i) \times(2 i)$ matrix $U_{i}$ has $(k, \ell)$ th $2 \times 1$ sub-vector $u_{k j_{\ell}}, k=1, \ldots, i, \ell=1, \ldots, 2 i$. Suppose, for some $i=1, \ldots, m-1$ and given $j_{1}, \ldots, j_{2 i}$, that $U_{i}$ has full rank, and partition the rows and columns of $U_{i+1}$ in the ratio $2 i: 2$, calling its $(k, \ell)$ th submatrix $U_{k \ell}$ (so $U_{11}=U_{i}$ ). Take $j_{2 i+2}=j_{2 i+1}^{2}$. Because $\ln \ln x$ strictly increases in $x>1$, it follows that $U_{22}$ is nonsingular and $\left\|U_{22}^{-1}\right\|=O\left(\ln \ln j_{2 i+1} \ln ^{-f_{i+1}} j_{2 i+1}\right)$. Noting that $\left\|U_{12}\right\|=O\left(\ln \ln j_{2 i+1} \ln ^{f_{i}} j_{2 i+1}\right)$, while $U_{11}$ and $U_{21}$ depend only on $j_{1}, \ldots, j_{2 i}$, we can choose $j_{2 i+1}$ such that $U_{11}-U_{12} U_{22}^{-1} U_{21}$ differs negligibly from $U_{11}$. Thus, $U_{i+1}$ has full rank. Since, for $f_{1} \geq 0, U_{1}$ has full rank (e.g., when $j_{1}=1$, $j_{2}=2$ ), it follows by induction that $U_{m}$ has full rank. Since $v_{j}$ is dominated by a term of order $\ln ^{f_{m}+1} j$, while $\left\|u_{i j}\right\|=O\left(\ln \ln j \ln ^{f_{i}} j\right)$, a similar argument shows that $j_{r}$ can then be chosen large enough, to complete verification of Assumption G.
5. Technical lemmas. Define

With respect to (39), the first inequality follows from Jensen's inequality, the second is obvious, the third follows from Lemma 1, the fourth follows from the $c_{r}$-inequality, (7) and (9), while the last one is due to (10). The proof of (40) uses Lemma $1, \sigma_{t}^{2}(\theta) \geq \omega_{L},(10)$ and [23], page 121. To prove (41), $|\ln x| \leq x+x^{-1}$ for $x>0$ and Lemma 2 give

The previous version of the paper included a longer, independently obtained, proof of the following lemma which we have been able to shorten in one respect by using an idea of Berkes, Horváth and Kokoszka [3] in a corresponding lemma covering the $\operatorname{GARCH}(n, m)$ case.

E \sup _{\theta \in \Theta}\left\{\frac{\sum_{j=1}^{\infty}\left|\xi_{j}(\zeta)\right| x_{t-j}^{2}}{\sigma_{t}^{* 2}(\theta)}\right\}^{p}<\infty
$$

The above proof implies that also

$$
\sup _{\zeta \in \Upsilon}\left\{\sum_{j=1}^{\infty}\left|\xi_{j}(\zeta)\right|\right\}^{p}<\infty
$$

whence, the proof of (44) with $i_{1} \geq 3$ is concluded. Next take $i_{1}=2$. If $i_{2}>2$,

$$
\begin{equation*}
\frac{\partial^{k} \sigma_{t}^{2}(\theta)}{\partial \theta_{i_{1}} \cdots \partial \theta_{i_{k}}}=-2 \sum_{j=1}^{\infty} \xi_{j}(\zeta) x_{t-j}(\mu) \tag{46}
\end{equation*}
$$

where now $\xi_{j}(\zeta)=\partial^{k-1} \psi_{j}(\zeta) / \partial \zeta_{i_{2}-2} \cdots \partial \zeta_{i_{k}-2}$, while if $i_{2}=2, i_{3}>2$,

$$
\frac{\partial^{k} \sigma_{t}^{2}(\theta)}{\partial \theta_{i_{1}} \cdots \partial \theta_{i_{k}}}=-2 \sum_{j=1}^{\infty} \xi_{j}(\zeta)
$$

where now $\xi_{j}(\zeta)=\partial^{k-2} \psi_{j}(\zeta) / \partial \zeta_{i_{3}-2} \cdots \partial \zeta_{i_{k}-2}$. In the first of these cases the proof is seen to be very similar to that above after noting that, by the Cauchy inequality, (46) is bounded by

$$
K\left\{\sum_{j=1}^{\infty}\left|\xi_{j}(\zeta)\right| x_{t-j}^{2} \sum_{j=1}^{\infty}\left|\xi_{j}(\zeta)\right|\right\}^{1 / 2}+K \sum_{j=1}^{\infty}\left|\xi_{j}(\zeta)\right|,
$$

while in the second it is more immediate; we thus omit the details. We are left with the cases $i_{1}=i_{2}=i_{3}=2$ and $i_{1}=1$, both of which are trivial. The details for (45) are very similar (the truncations in numerator and denominator match), and are thus omitted.

Define

$$
g_{t}(\theta)=u_{t}(\theta) u_{t}^{\prime}(\theta), \quad G_{T}(\theta)=T^{-1} \sum_{t=1}^{T} g_{t}(\theta)
$$

LEMMA 7. For some $\delta>0$, under Assumptions $\mathrm{A}(2+\delta), \mathrm{B}, \mathrm{C}, \mathrm{D}, \mathrm{E}$ and $\mathrm{F}(1)$,

$$
\begin{equation*}
\sup _{\theta \in \Theta}\left|Q_{T}(\theta)-Q(\theta)\right| \rightarrow 0 \quad \text { a.s. as } T \rightarrow \infty \tag{47}
\end{equation*}
$$

and $Q(\theta)$ is continuous in $\theta$. If also Assumption $\mathrm{F}(2)$ holds,

$$
\begin{equation*}
\sup _{\theta \in \Theta}\left\|G_{T}(\theta)-G(\theta)\right\| \rightarrow 0 \quad \text { a.s. as } T \rightarrow \infty \tag{48}
\end{equation*}
$$

and $G(\theta)$ is continuous in $\theta$. If also Assumption $\mathrm{F}(3)$ holds,

$$
\begin{equation*}
\sup _{\theta \in \Theta}\left\|H_{T}(\theta)-H(\theta)\right\| \rightarrow 0 \quad \text { a.s. as } T \rightarrow \infty \tag{49}
\end{equation*}
$$

and $H(\theta)$ is continuous in $\theta$.
Proof. To prove (47), note first that, by Lemmas 1, 2, 3 and 5,

$$
\sup _{\Theta} E\left|q_{0}(\theta)\right| \leq \sup _{\Theta} E\left|\log \sigma_{0}^{2}(\theta)\right|+\sup _{\Theta} E \chi_{0}(\theta)<\infty .
$$

Thus, by ergodicity

$$
Q_{T}(\theta) \rightarrow Q(\theta) \quad \text { a.s. }
$$

for all $\theta \in \Theta$. Then uniform convergence follows on establishing the equicontinuity property

$$
\sup _{\tilde{\theta}:\|\tilde{\theta}-\theta\|<\varepsilon}\left|Q_{T}(\tilde{\theta})-Q_{T}(\theta)\right| \rightarrow 0 \quad \text { a.s. }
$$

as $\varepsilon \rightarrow 0$, and continuity of $Q(\theta)$. By the mean value theorem it suffices to show that

$$
\sup _{\Theta}\left\|\frac{\partial Q_{T}(\theta)}{\partial \theta}\right\|+\sup _{\Theta}\left\|\frac{\partial Q(\theta)}{\partial \theta}\right\|<\infty \quad \text { a.s. }
$$

which, by Loève ([23], page 121) and identity of distribution, is implied by $E \sup _{\Theta}\left\|u_{0}(\theta)\right\|<\infty$. By the definition of $u_{t}(\theta)$, and $x_{t}^{2}(\mu) \leq K\left(x_{t}^{2}+1\right)$, $\left\|v_{t}(\theta)\right\| \leq 2\left(\left|x_{t}\right|+1\right)$, we have

$$
\left\|u_{t}(\theta)\right\| \leq K\left[\left\|\tau_{t}(\theta)\right\|\left\{1+\varepsilon_{t}^{2} \frac{\sigma_{t}^{2}}{\sigma_{t}^{2}(\theta)}\right\}+\left|\varepsilon_{t}\right| \frac{\sigma_{t}}{\sigma_{t}(\theta)}+1\right] .
$$

Thus, $E \sup _{\Theta}\left\|u_{0}(\theta)\right\|$ is bounded by a constant times

$$
\begin{aligned}
& E \sup _{\Theta}\left\|\tau_{0}(\theta)\right\|+\left[E \sup _{\Theta}\left\{\frac{\sigma_{0}^{2}}{\sigma_{0}^{2}(\theta)}\right\}^{p}\right]^{1 / p}\left[E \sup _{\Theta}\left\|\tau_{0}(\theta)\right\|^{p /(p-1)}\right]^{1-1 / p} \\
& \quad+E \sup _{\Theta}\left\{\frac{\sigma_{0}}{\sigma_{0}(\theta)}\right\}+1
\end{aligned}
$$

for all $p>1$. On choosing $p<1+\delta / 2$, this is finite by Lemmas 5 and 6 . (Our use of Lemmas 5 and 6 is similar to Berkes, Horváth and Kokoszka's [3] use of their Lemmas 5.1 and 5.2 in the $\operatorname{GARCH}(n, m)$ case.) This completes the proof of (47). Then (48) and (49) follow by applying analogous arguments to those above, and so we omit the details; indeed, (48) and (49) are only used in the proof of consistency of $\bar{G}_{T}\left(\hat{\theta}_{T}\right), \bar{H}_{T}\left(\hat{\theta}_{T}\right)$ for $G_{0}, H_{0}$, where convergence over only a neighborhood of $\theta_{0}$ would suffice.

Lemma 8. Under Assumptions $\mathrm{A}(2+\delta), \mathrm{B}, \mathrm{C}, \mathrm{D}, \mathrm{E}$ and $\mathrm{F}(1)$,

$$
\begin{equation*}
\sup _{\theta \in \Theta}\left|Q_{T}(\theta)-\bar{Q}_{T}(\theta)\right| \rightarrow 0 \quad \text { a.s. as } T \rightarrow \infty \tag{50}
\end{equation*}
$$

If also Assumption $\mathrm{F}(2)$ holds,

$$
\begin{equation*}
\sup _{\theta \in \Theta}\left\|G_{T}(\theta)-\bar{G}_{T}(\theta)\right\| \rightarrow 0 \quad \text { a.s. as } T \rightarrow \infty \tag{51}
\end{equation*}
$$

If also Assumption $\mathrm{F}(3)$ holds,

$$
\begin{equation*}
\sup _{\theta \in \Theta}\left\|H_{T}(\theta)-\bar{H}_{T}(\theta)\right\| \rightarrow 0 \quad \text { a.s. as } T \rightarrow \infty \tag{52}
\end{equation*}
$$

Proof. We have $\hat{Q}_{T}(\theta)-Q_{T}(\theta)=A_{T}(\theta)+B_{T}(\theta)$, where

$$
A_{T}(\theta)=T^{-1} \sum_{t=1}^{T} \ln \left[\frac{\bar{\sigma}_{t}^{2}(\theta)}{\sigma_{t}^{2}(\theta)}\right], \quad B_{T}(\theta)=T^{-1} \sum_{t=1}^{T} x_{t}^{2}(\mu)\left\{\bar{\sigma}_{t}^{-2}(\theta)-\sigma_{t}^{-2}(\theta)\right\}
$$

Because

$$
\sigma_{t}^{2}(\theta)=\bar{\sigma}_{t}^{2}(\theta)+\sum_{j=0}^{\infty} \psi_{j+t}(\zeta) x_{-j}^{2}(\mu)
$$

$\ln (1+x) \leq x$ for $x>0$ and $\sigma_{t}^{2}(\theta) \geq \omega_{L}>0$, it follows that

$$
\begin{aligned}
\left|A_{T}(\theta)\right| & \leq K T^{-1} \sum_{t=1}^{T}\left\{\sigma_{t}^{2}(\theta)-\bar{\sigma}_{t}^{2}(\theta)\right\} \\
& \leq K T^{-1} \sum_{t=1}^{T} \sum_{j=t}^{\infty} \psi_{j}(\zeta) x_{t-j}^{2}(\mu) \\
& \leq K T^{-1} \sum_{t=0}^{\infty}\left\{\sum_{j=t+1}^{t+T} \psi_{j}(\zeta)\right\} x_{-t}^{2}(\mu) .
\end{aligned}
$$

Now from (7),

$$
\sup _{\zeta \in \Upsilon} \sum_{j=t+1}^{t+T} \psi_{j}(\zeta) \leq K \sum_{j=t+1}^{t+T} j^{-\underline{d}-1} \leq K \min (t+1, T)(t+1)^{-\underline{d}-1} .
$$

Thus,

$$
\begin{equation*}
\sup _{\Theta} A_{T}(\theta) \leq K T^{-1} \sum_{t=0}^{T}(t+1)^{-\underline{d}}\left(x_{-t}^{2}+1\right)+K \sum_{t=T}^{\infty} t^{-\underline{d}-1}\left(x_{-t}^{2}+1\right) . \tag{53}
\end{equation*}
$$

From the $c_{r}$-inequality, (9) and (10), $\sum_{t=1}^{\infty}(t+1)^{-\underline{d}-1} x_{-t}^{2}$ has finite $\rho$ th moment, and thus, by Loève ([23], page 121), is a.s. finite. Thus, the second term of (53) tends to zero a.s. as $T \rightarrow \infty$, while the first does so for the same reasons combined with the Kronecker lemma. Next,

$$
\begin{align*}
\left|B_{T}(\theta)\right| & \leq K T^{-1} \sum_{t=1}^{T} \chi_{t}(\theta) \sum_{j=t}^{\infty} \psi_{j}(\zeta) x_{t-j}^{2}(\mu) \\
& \leq K T^{-1} \sum_{t=1}^{T} \chi_{t}(\theta) \sum_{j=t}^{\infty} j^{-\underline{d}-1}\left(x_{t-j}^{2}+1\right) \tag{54}
\end{align*}
$$

From previous remarks, $\sum_{j=t}^{\infty} j^{-\underline{d}-1}\left(x_{t-j}^{2}+1\right) \rightarrow 0$ a.s. Also, for each $\theta$, a.s.

$$
T^{-1} \sum_{t=1}^{T} \chi_{t}(\theta) \rightarrow E \chi_{0}(\theta) \leq K\left\{E\left(\frac{\sigma_{0}^{2}}{\sigma_{0}^{2}(\theta)}\right)+1\right\} \leq K
$$

by ergodicity and Lemma 5 . Thus, (54) $\rightarrow 0$ a.s. by the Toeplitz lemma. The convergence is uniform in $\theta$ because, from the proof of Lemma 7, for all $\theta \in \Theta$,

$$
\sup _{\tilde{\theta}:\|\tilde{\theta}-\theta\|<\varepsilon}\left\|\chi_{0}(\tilde{\theta})-\chi_{0}(\theta)\right\| \rightarrow 0 \quad \text { a.s., }
$$

as $\varepsilon \rightarrow 0$. This completes the proof of (50). We omit the proofs of (51) and (52) as they involve the same kind of arguments.

Lemma 9. For some $\delta>0$, under Assumptions $\mathrm{A}(2+\delta), \mathrm{B}, \mathrm{C}, \mathrm{D}, \mathrm{E}, \mathrm{F}(1)$ and $\mathrm{G}, M(\theta)$ is finite and positive definite for all $\theta \in \Theta$.

Proof. Fix $\theta \in \Theta$. Finiteness of $M(\theta)$ follows from Lemma 6. Positive definiteness follows (by an argument similar to that of Lumsdaine [24] in the $\operatorname{GARCH}(1,1)$ case) if, for all nonnull $(r+2) \times 1$ vectors $\lambda, \lambda^{\prime} M(\theta) \lambda=$ $E\left\{\lambda^{\prime} \tau_{0}(\theta)\right\}^{2}>0$, that is, that

$$
\begin{equation*}
\lambda^{\prime} \tau_{0}(\theta) \sigma_{0}^{2}(\theta) \neq 0 \quad \text { a.s. } \tag{55}
\end{equation*}
$$

since $0<\sigma_{0}^{2}(\theta)<\infty$ a.s. Define

$$
\begin{aligned}
\tau_{t \omega}(\theta) & =\frac{\partial}{\partial \omega} \ln \sigma_{t}^{2}(\theta)=\sigma_{t}^{-2}(\theta) \\
\tau_{t \mu}(\theta) & =\frac{\partial}{\partial \gamma} \ln \sigma_{t}^{2}(\theta)=-2 \sigma_{t}^{-2}(\theta) \sum_{j=1}^{\infty} \psi_{j}(\zeta) x_{t-j}(\mu), \\
\tau_{t \zeta}(\theta) & =\frac{\partial}{\partial \zeta} \ln \sigma_{t}^{2}(\theta)=\sigma_{t}^{-2}(\theta) \sum_{j=1}^{\infty} \psi_{j}^{(1)}(\zeta) x_{t-j}^{2}(\mu),
\end{aligned}
$$

so that $\tau_{t}(\theta)=\left(\tau_{t \omega}(\theta), \tau_{t \mu}(\theta), \tau_{t \zeta}^{\prime}(\theta)\right)^{\prime}$. Write $\lambda=\left(\lambda_{1}, \lambda_{2}, \lambda_{3}^{\prime}\right)^{\prime}$, where $\lambda_{1}$ and $\lambda_{2}$ are scalar and $\lambda_{3}$ is $r \times 1$. Consider first the case $\lambda_{1}=\lambda_{2}=0, \lambda_{3} \neq 0$. Suppose (55) does not hold. Then we must have

$$
\sum_{j=1}^{\infty} \lambda_{3}^{\prime} \psi_{j}^{(1)}(\zeta) x_{t-j}^{2}(\mu)=0
$$

If $\lambda_{3}^{\prime} \psi_{1}^{(1)}(\zeta) \neq 0$, it follows that

$$
\begin{equation*}
\left(\sigma_{t-1} \varepsilon_{t-1}+\mu_{0}-\mu\right)^{2}=-\left\{\lambda_{3}^{\prime} \psi_{j}^{(1)}(\zeta)\right\}^{-1} \sum_{j=2}^{\infty} \lambda_{3}^{\prime} \psi_{j}^{(1)}(\zeta) x_{-j}^{2}(\mu) \tag{56}
\end{equation*}
$$

Since $\sigma_{t-1}>0$ a.s., the left-hand side involves the nondegenerate random variable $\varepsilon_{t-1}$, which is independent of the right-hand side, so (56) cannot hold. Thus, $\lambda_{3}^{\prime} \psi_{j}^{(1)}(\zeta)=0$. Repeated application of this argument indicates that, for all $\zeta$, $\lambda_{3}^{\prime} \psi_{j}^{(1)}(\zeta)=0, j=1, \ldots, j_{r}(\zeta)$. This is contradicted by Assumption G, so (56) cannot hold. Next consider the case $\lambda_{1}=0, \lambda_{2} \neq 0, \lambda_{3}=0$. If (56) does not hold, we must have

$$
\begin{equation*}
\sum_{j=1}^{\infty} \psi_{j}(\zeta) x_{t-j}(\mu)=0 \tag{57}
\end{equation*}
$$

Let $k$ be the smallest integer such that $\psi_{k}(\zeta) \neq 0$. Then (57) implies

$$
\varepsilon_{t-k}=\sigma_{t-k}^{-1}(\theta)\left\{\mu-\mu_{0}-\psi_{k}^{-1}(\zeta) \sum_{j=k+1}^{\infty} \psi_{j}(\theta) x_{t-j}(\mu)\right\} .
$$

But the left-hand side is nondegenerate and independent of the right-hand side, so (57) cannot hold. Next consider the case $\lambda_{1}=0, \lambda_{2} \neq 0, \lambda_{3} \neq 0$. If (55) is not true, then, taking $\lambda_{2}=1$, we must have

$$
\begin{equation*}
\sum_{j=1}^{\infty}\left\{\lambda_{3}^{\prime} \psi_{j}^{(1)}(\zeta) x_{t-j}(\mu)-2 \psi_{j}(\zeta)\right\} x_{t-j}(\mu)=0 \quad \text { a.s. } \tag{58}
\end{equation*}
$$

Let $k$ be the smallest integer such that either $\lambda_{3}^{\prime} \psi_{k}^{(1)}(\zeta) \neq 0$ or $\psi_{k}(\zeta) \neq 0$; the preceding argument indicates that there exists such $k$. Then we have

$$
\begin{gathered}
\left\{2 \psi_{k}(\zeta)-\lambda_{3}^{\prime} \psi_{k}^{(1)}(\zeta)\left(\sigma_{t-k} \varepsilon_{t-k}+\mu_{0}-\mu\right)\right\}\left\{\sigma_{t-k} \varepsilon_{t-k}+\mu_{0}-\mu\right\} \\
=\sum_{j=k+1}^{\infty}\left\{\lambda_{3}^{\prime} \psi_{j}^{(1)}(\zeta) x_{t-j}(\mu)-2 \psi_{j}(\zeta)\right\} x_{t-j}(\mu) \quad \text { a.s. }
\end{gathered}
$$

The left-hand side is a.s. nonzero and involves the nondegenerate random variable $\varepsilon_{t-k}$, which is independent of the right-hand side, so (58) cannot hold. We are left with the cases where $\lambda_{1} \neq 0$. Taking $\lambda_{1}=-1$ and noting that $\sigma_{t}^{2}(\theta) \tau_{t \omega}(\theta) \equiv 1$, the preceding arguments indicate that there exist no $\lambda_{2}$ and $\lambda_{3}$ such that

$$
\lambda_{2} \sigma_{t}^{2}(\theta) \tau_{t \mu}(\theta)+\lambda_{3}^{\prime} \sigma_{t}^{2}(\theta) \tau_{t \zeta}(\theta)=1 \quad \text { a.s. }
$$

Lemma 10. For some $\delta>0$, under Assumptions $\mathrm{A}(2+\delta), \mathrm{B}, \mathrm{C}, \mathrm{D}, \mathrm{E}, \mathrm{F}(1)$ and H ,

$$
\inf _{\substack{\theta \in \Theta \\ \theta \neq \theta_{0}}} Q(\theta)>Q\left(\theta_{0}\right) .
$$

Proof. We have

$$
Q(\theta)-Q\left(\theta_{0}\right)=E\left[\frac{\sigma_{0}^{2}}{\sigma^{2}(\theta)}-\ln \left\{\frac{\sigma_{0}^{2}}{\sigma^{2}(\theta)}\right\}-1\right]+\left(\mu-\mu_{0}\right)^{2} E\left[\frac{1}{\sigma_{0}^{2}(\theta)}\right]
$$

The second term on the right-hand side is zero only when $\mu=\mu_{0}$ and is positive otherwise. Because $x-\ln x-1 \geq 0$ for $x>0$, with equality only when $x=1$, it remains to show that

$$
\begin{equation*}
\ln \sigma_{0}^{2}(\theta)=\ln \sigma_{0}^{2} \quad \text { a.s., some } \theta \neq \theta_{0} . \tag{59}
\end{equation*}
$$

By the mean value theorem, (59) implies that $\left(\theta-\theta_{0}\right)^{\prime} \tau_{0}(\bar{\theta})=0$ a.s., for $\theta \neq \theta_{0}$ and some $\bar{\theta}$ such that $\left\|\bar{\theta}-\theta_{0}\right\| \leq\left\|\theta-\theta_{0}\right\|$. But by Lemma 9 there is no such $\bar{\theta}$.
