However, only limited studies have explored the impact of mobile eHealth literacy on the diabetes population. "

[14] found that some factors mediated the relationship between eHealth literacy and utilization of the health care services. " We conclude that "there have been only a few published studies to date exploring the linkage of mobile eHL to disease self-care behavior and glycemic control. Identification of the factors linking eHL to behavior and clinical outcomes in diabetes could have far-reaching utility, namely in the form of targeted interventions to address eHL limitations. "
