## Introduction:

The analysis of gene expression provides a description of a cell's potential functions and its response to extracellular signals. However, when researchers attempt to analyze gene expression *in vivo* they are confronted with the problem that all tissues contain a diverse array of different cell types with unique functions. Efforts to isolate a specific cell type for analysis based on sorting techniques can be successful but these additional manipulations are both time consuming and have been shown to alter transcription (Haimon et al., 2018). The brain is a particularly challenging tissue in which to quantitate gene expression and translation. A typical mouse brain is made up of around 75 million neurons, 23 million glial cells, 7 million endothelial cells and several million other miscellaneous cell types (Williams, 2000). Neurons are extremely diverse in terms of their expression of various neurotransmitters, neuropeptides, and receptors and typically these neurons are anatomically intermingled making them very difficult to separate for molecular analysis. *In situ* analysis of mRNA expression has been very useful in identifying the overall anatomical distribution of neurons expressing specific genes and the Allen Brain Institute has assembled a comprehensive database for both the mouse and human brain which is very useful. However, anatomical localization cannot define specific neuronal cell types. Characterization of the mRNA expression phenotype of specific neurons has progressed with the development of ribosome-tagging approaches, cell sorting based on promoter specific

3 expression of fluorescent marker proteins, and single-cell RNA-Seq. Each approach has  
4 advantages and disadvantages. In this protocol we describe a ribosome-tagging approach  
5 (RiboTag) which our lab developed (Sanz et al., 2009) and discuss the application of this  
6 approach to the analysis of polyribosome associated mRNA transcripts in specific populations of  
7 neurons. The RiboTag approach takes advantage of the hundreds of specific promoter-driven  
8 Cre recombinase transgenics currently available (Jackson Laboratories has more than 480  
9 lines) and others are being added at a rapid pace.  
10

11 There are two basic approaches involving the use of RiboTag as diagrammed in **Figure 1** and  
12 each has advantages and disadvantages. In the first approach we use a RiboTag mouse line in  
13 which the 60S ribosomal gene, *Rpl22*, was modified so that in the presence of Cre recombinase  
14 the last exon of *Rpl22* will be replaced with an HA-tagged exon effectively labeling the cell's  
15 polyribosomes so that they can be isolated by immunoprecipitation. These RiboTag mice are  
16 crossed to a Cre recombinase driver mouse line and the double heterozygotes are used for  
17 analysis. Immunoprecipitation of polyribosomes from neuronal tissue purifies only the  
18 polysomes that are tagged in the Cre-expressing cells. The mRNA from these polysomes is  
19 isolated and the transcripts analyzed by qRT-PCR or RNA-Seq. The second approach utilizes a  
20 *Rpl22-HA* construct in a flex or DIO virus (AAV) flanked by two different sets of loxP sites (Sanz  
21 et al., 2015). When the AAV-DIO-RiboTag is injected into a specific anatomical region of the  
22 brain of an adult mouse the *Rpl22-HA* is only expressed in the neurons that are actively  
23 expressing Cre recombinase and also infected by the AAV. After waiting several weeks for the  
24 *Rpl22-HA* to be expressed and incorporated into polyribosomes, tissue samples are isolated  
25 and used to immunoprecipitate HA-tagged polyribosomes followed by qRT-PCR or RNA-Seq.  
26 The viral approach requires accurate stereotaxic injections of virus and is more labor intensive  
27 but has the advantage that only adult neurons that still express the Cre transgenic will be  
28 targeted. The direct cross of RiboTag mice with Cre driver mice is easier to do but has the  
29 potential disadvantage that the *Rpl22-HA* could continue to be expressed in neurons that have  
30 differentiated from a progenitor population that expressed Cre recombinase at an earlier stage  
31 during development. One can take advantage of this difference by comparing results from the  
32 same brain region using the RiboTag mouse and the RiboTag virus using the same Cre driver  
33 transgenic. We have used this approach to demonstrate that embryonic *Pomc*-expressing  
34 progenitor neurons differentiate into both *Agrp* and *Kiss1* expressing neurons in the adult  
35 arcuate nucleus of the hypothalamus (Sanz et al., 2015).

41 **Basic Protocol 1** outlined below describes our methods in detail using the RiboTag mouse  
42 crossed with a specific Cre-recombinase expressing transgenic mouse to isolate polyribosomes  
43 by immunoprecipitation from brain homogenates and then further isolate RNA from both the  
44 input (original homogenate) and the immunoprecipitated (IP) polysomes. **Alternative Protocol**  
45 **1** describes the viral approach using stereotaxic injection of AAV-DIO-RiboTag into adult Cre-  
46 recombinase expressing mouse brain to avoid developmental activation of RiboTag expression.  
47 In **Support Protocol 1** we describe the breeding and genotyping of RiboTag mice and in  
48 **Support Protocol 2** we describe the analysis of captured RNA using qRT-PCR. **Basic**  
49 **Protocol 2** discusses the use of RiboTag mice crossed with a specific Cre transgenic line to  
50 identify the anatomical localization of RiboTag expression by immunohistochemistry. In **Basic**  
51 **Protocol 3** we describe the current approach our lab is using to produce DNA libraries for RNA-  
52 Seq. **Basic Protocol 4** describes the bioinformatic tools that we are using to analyze the RNA-  
53 Seq data. In the **Commentary** we will provide a discussion of these methods and identify some  
54 of the most critical parameters and potential trouble spots.

## BASIC PROTOCOL 1

### The RiboTag Assay

This approach has been described and updated in several publications from our laboratory (Quintana et al., 2012; Sanz et al., 2013; Sanz et al., 2015; Sanz et al., 2009) and is shown schematically in **Figure 1**. We have now introduced modifications that improve the efficiency of the immunocapture and therefore increase the RNA yields obtained in the immunoprecipitates. These modifications include using an indirect method for the immunocapture of HA-tagged polysomes (instead of the direct immunoprecipitation procedure described in the original publication) and using Protein A/G beads with a higher binding capacity for IgGs.

7 **Protocol steps:**  
8

9 *Harvest tissue*  
10

- 11 1. Euthanize mice using IACUC approved procedures such as carbon dioxide inhalation
- 12 2. Decapitate mice using large sharp surgical scissors
- 13 3. Make a midline incision in the skin and expose the skull
- 14 4. Using small scissors and a spatula remove the skull
- 15 5. Lift the brain out of the skull and use a spatula to section the optic and other cranial
- 16 6. Place the brain in a cold block or brain matrix for further dissection. Sampling tools such
- 17 7. as Harris Uni-cores can be used to punch the area of interest.

19  
20  
21 *Lysate preparation*  
22

- 23 7. Clean Dounce tissue grinder and dissection tools and rinse thoroughly with RNase-free
- 24 8. water (sterile water for irrigation can be used at this step). Air dry and place Dounce
- 25 9. homogenizer on ice.
- 26 8. Prepare the homogenization buffer as described in the **Reagents and Solutions** section
- 27 9. and keep on ice.
- 28 9. Dissect the tissue containing the cell type of interest. Specific areas or whole tissue can
- 29 10. be used in this approach.  
30 *A brain matrix and sampling tools such as brain punches or Harris Uni-Cores can be*  
31 *used to precisely dissect the area of interest. Dissected tissue or punches of the area*  
32 *of interest can either be flash-frozen in liquid nitrogen right after dissection and*  
33 *stored at -80°C for months or processed fresh.*
- 34 10. Place the tissue in the ice-cold Dounce homogenizer vessel containing a defined volume
- 35 11. of pre-chilled homogenization buffer and homogenize using 40 strokes of the loose-
- 36 12. fitting pestle (type A pestle), followed by 40 more strokes with the tight-fitting pestle (type
- 37 13. B pestle).  
38 *We typically use a 2-5% w/v ratio (for areas with a limited number of cells from the*  
39 *cell type of interest a pool of punches of the same area from different animals can be*  
40 *used to increase RNA yields). For small amounts of tissue (10-50mg tissue) we use*  
41 *the 2 ml Dounce and for 50-300mg we use the 7 ml Dounce.*
- 42 11. After homogenization, transfer lysate to a microtube on ice.
- 43 12. Clear the lysate at 10,000 x g for 10 min at 4°C using a refrigerated centrifuge.
- 44 13. Transfer the post-mitochondrial supernatant to a pre-chilled microcentrifuge tube on ice.
- 45 14. Discard resulting pellet.
- 46 14. Take a small aliquot of the cleared lysate (40-80 ul) and store it at -80°C for subsequent
- 47 15. Input analysis.

51 *Immunoprecipitation*  
52

- 53 15. Add 4 ul of the anti-Hemagglutinin (HA) antibody (Covance Anti-HA.11 Epitope Tag
- 54 16. Antibody) to 800 ul of the remaining cleared lysate and incubate for 4 hours at 4°C in a
- 55 16. microtube rotator with gentle mixing (end-over-end).
- 56 16. Prepare the magnetic protein A/G beads:
  - 57 • Thoroughly resuspend the beads by repeated inversion or gentle vortexing.

- Place a microtube magnetic stand on ice and transfer 200 ul of the resuspended beads to a clean microcentrifuge tube.
  - Place the tube into the magnetic stand on ice to collect the beads and remove and discard the storage buffer.
  - Add 400 ul of homogenization buffer and rotate end-over-end for 5 min to wash the beads.
  - Collect the beads with the magnetic stand, discard buffer.
17. Add the cleared lysate with the antibody to the beads. Incubate samples overnight at 4°C in a tube rotator with gentle end-over-end mixing.
  18. Next day, prepare the high salt buffer as described in the Reagents and Solutions section. Keep on ice.
    - a. Place samples into the magnetic stand on ice and remove supernatant (supernatant from the immunoprecipitation can be discarded or saved at -80°C for subsequent analysis).

*Leave tubes in the magnet for at least one minute to collect all the beads against the side of the tube.*
  19. With the tubes on the stand, add 800 ul of high salt buffer (**Reagents and Solutions**) to remove non-specific binding from the immunoprecipitate (IP). Transfer tubes to the rotator and wash the IP with gentle end-over-end mixing for 5 min at 4°C.
  20. Place samples into the magnetic stand on ice and remove supernatant
  21. Repeat high salt washes two more times with the same volume of high salt buffer for 5 min each, for a total of three washes.
  22. Resuspend beads in 800 ul of high salt buffer, mix on rotator for 5 min and transfer beads and buffer to a clean tube.

*This step helps remove any RNA or polyribosomes that might be sticking to the original tube.*
  23. Place tubes on the magnetic stand for at least 1 min, carefully remove all high salt buffer
  24. Add 350 ul of RLT buffer from the Qiagen's RNeasy extraction kit (mini or micro) supplemented with  $\beta$ -mercaptoethanol (provided with the kit).
  25. Remove tubes from stand and vortex samples for 30 seconds at RT.

*At this step samples can be stored at -80°C for subsequent RNA extraction or processed through the RNA extraction procedure.*

### RNA extraction

26. Place tubes containing IPs in RLT buffer (from Qiagen kit) into the magnetic stand for 1 min at RT to allow beads to be collected against the side of the tube
27. Transfer the clear RLT buffer containing RNA to a new microcentrifuge tube.
28. Proceed with RNA isolation with DNase digestion following Qiagen's RNeasy extraction kit directions.
29. To extract RNA from the Inputs (Step 6), bring input sample to 350 ul with RLT buffer supplemented with  $\beta$ -mercaptoethanol, vortex extensively and proceed to RNA extraction as described for IPs.

*RNA extraction using column-based kits should be performed at RT. However, eluted RNA should be kept on ice at all times. For long term storage, RNA is safely kept at -80°C for years. Whenever working with isolated RNA, always wear gloves to minimize RNase contamination, decontaminate working surfaces and use clean nuclease-free tubes and barrier pipette tips.*

3 30. Quantitate RNA using Quant-iT RiboGreen RNA Reagent (Thermo Fisher) or a  
4 Nanodrop-One (Thermo Fischer Sci) following the manufacturer's protocols.  
5 *If very low levels of RNA are expected (less than 2 ng/ul) the samples can be*  
6 *accurately quantitated by doing qRT-PCR using a house keeping gene such as*  
7 *Actb and comparing the results to known standard RNA solutions prepared with*  
8 *input RNA from the same tissue as detailed in **Support Protocol 2**.*

9  
10 31. Analyze RNA integrity on an Agilent 2100 Bioanalyzer system with the associated RNA  
11 6000 nano and pico kits (chose nano chips for samples 5-500 ng/ul, for samples with  
12 RNA concentrations < 5 ng/ul (down to 50 pg/ul) the pico chips should be used). Follow  
13 manufacturer's directions.

14 *Since most of the RNA isolated in Inputs and IPs is rRNA, the quality of mRNA is*  
15 *indirectly estimated by assessing the integrity of rRNA. A measure of RNA*  
16 *quality, the RNA integrity number (RIN), is also calculated by the software using*  
17 *an algorithm that assesses the electrophoretic traces of each sample. A RIN*  
18 *value of 7-10 indicates high quality RNA but RNA-Seq libraries can still be made*  
19 *and successfully analyzed starting with partially degraded RNA.*

## 23 **ALTERNATE PROTOCOL 1**

### 24 **Messenger RNA profiling using the RiboTag viral vector**

25  
26  
27 To overcome the limitations associated with developmental activation of Cre  
28 recombinase transgenes and allow cell type-specific mRNA profiling of adult cells using  
29 Cre-Driver lines, we have developed a Cre-dependent RiboTag viral vector based on  
30 AAV1 (AAV1-DIO-RiboTag) (Sanz et al., 2015), where RiboTag expression is dependent  
31 on the activity of the promoter driving Cre recombinase expression in adult mice. This  
32 viral vector was created by inserting the cDNA of the mouse ribosomal protein Rpl22  
33 gene fused to three hemagglutinin (HA) sequences (Rpl22 · 3HA), into a double-floxed  
34 inverse open reading frame (DIO) AAV construct. For easy visualization of transduced  
35 cells, this construct also contains an IRES sequence (IRES2) followed by the YFP  
36 coding sequence as shown in **Figure 1**.

#### 48 **Protocol steps:**

53 1. Define stereotaxic coordinates by locating the injection target in a mouse brain atlas  
54 such as the Paxinos and Franklin's "the Mouse Brain in Stereotaxic Coordinates"  
55

3 (Paxinos & Franklin, 2013) or the Allen institute for Brain Science's "Adult Mouse Brain  
4 Reference Atlas" (Dong)
- 5 2. Inject 0.2 to 0.5 ul of a RiboTag viral vector preparation ( $7 \times 10^{11}$  viral genomes/ml) at  
6 the target site using the defined coordinates.  
7 *Follow a stereotaxic injection protocol such as (Gore, Soden, & Zweifel, 2013).*  
8 *When targeting bilateral structures, inject each side. Injection volumes can be*  
9 *adjusted to the targeted area, or multiple injections performed to cover larger*  
10 *areas. Injecting different mice using the same coordinates and pooling the*  
11 *targeted areas after dissection helps correct for variability resulting from*  
12 *stereotaxic viral vector injections.*
  - 13 3. Allow at least 2 weeks for the viral vector to express Rpl22-HA. For RiboTag assays,  
14 good results are obtained when sacrificing animals at least 3 weeks after injections to  
15 allow for robust incorporation of Rpl22-HA into polyribosomes.
  - 16 4. Perform RiboTag immunoprecipitations as described in **Basic Protocol 1**
- 17  
18

19 All surgical procedures should be performed in accordance with protocols approved by your  
20 Institutional Animal Care Use Committee (IACUC).

### 23 **SUPPORT PROTOCOL 1** *Breeding and Genotyping of RiboTag Mice*

#### 24 **Breeding of RiboTag Mice:**

25 We maintain a live colony of RiboTag Breeders on a C57BL/6J background by mating  
26 homozygotes since they have no adverse phenotypes. Experimental mice for RiboTag  
27 assays are usually obtained by breeding male Cre recombinase-expressing mice to  
28 female homozygous RiboTag mice ( $Rpl22^{HA/HA}$ ). Therefore, experimental mice are  
29 always heterozygous for the RiboTag allele ( $Rpl22^{HA/+}$ ).  
30  
31  
32

#### 33 **PCR Genotyping:**

34 To genotype the RiboTag mice, a PCR was developed that includes the loxP site 5' to  
35 the wild-type exon 4 of  $Rpl22$ ; the wild-type PCR product is 242 bp, while the mutant  
36 product is about 290 bp. This PCR also distinguishes homozygous RiboTag mice, as the

39 offspring from RiboTag mice bred to Cre recombinase-expressing mouse lines  
40 (experimental mice) are genotyped for the presence of the Cre recombinase gene and  
41 the RiboTag allele using the PCR oligonucleotides and reaction conditions described

**Protocol steps:**

1. Extract DNA from mouse tail snips (2-5 mm) using a silica membrane column-based kit such as the NucleoSpin Tissue following manufacturer's directions.  
*We have also successfully used direct PCR kits that do not require prior DNA extraction such as the Phire Tissue Direct PCR Master Mix kit for RiboTag and Cre recombinase genotyping. DNA can also be extracted from tail samples by conventional methods using SDS/Protease K digestion, phenol/chloroform extraction, and ethanol precipitation.*
2. Prepare the DreamTaq PCR Master mix as follows: (per reaction) 13  $\mu$ l of water, 2  $\mu$ l of 10x DreamTaq green buffer, 2  $\mu$ l of 10mM dNTPs, 1  $\mu$ l of the forward oligo (10 $\mu$ M), 1  $\mu$ l of the reverse oligo (10 $\mu$ M), 0.1  $\mu$ l of DreamTaq polymerase. Mix gently and briefly centrifuge.
3. Add 19  $\mu$ l of the master mix to each well.
4. Add 1  $\mu$ l of tail DNA (~2 ng) to each reaction.
5. Mix and briefly centrifuge.
6. Place strips in the thermal cycler and run the appropriate program for each reaction. Thermal profile for RiboTag reactions is: 95°C for 2 min followed by 30 cycles of 95°C for 20 s, 57°C for 20 s, and 72°C for 30 s, with a final extension at 72°C for 5 min. Thermal profile for Cre reactions is 95°C for 2 min followed by 30 cycles of 95°C for 10 s, 63°C for 10 s, and 72°C for 40 s, with a final extension at 72°C for 5 min.
7. Prepare a 10% acrylamide gel by mixing (for two gels) 14 ml of water, 5 ml of 40% acrylamide-bis, 1ml of TBE 10x, 30  $\mu$ l of TEMED and 150  $\mu$ l of 10% APS. Allow gels to polymerize for 10-15 min.
8. Place gels into a vertical gel electrophoresis system, add buffer (0.5X TBE), and load DNA ladder and PCR reactions.
9. Run the electrophoresis at 175v (constant voltage) for 45 min.
10. Stain gels with SYBR safe and analyze PCR products under UV light.

### Detecting “Ectopic” Cre Recombination in tail DNA

Mouse lines driving Cre recombinase expression under cell type specific promoters should typically restrict RiboTag activation to the cell type of interest. However, transient expression of Cre recombinase during development is often observed in different Cre driver lines and can lead to recombination of the RiboTag allele in unexpected cell types. If this “ectopic” expression takes place in the fertilized egg or during early development, it will be detected during the RiboTag genotyping PCR and a “recombination” band will show up at ~350 bp. If recombination occurs in the fertilized egg the loxP band will be replaced by the “recombination” band. If Cre recombinase is expressed during early development, recombination of the RiboTag allele will only take place in a portion of the cells and both the loxP and the recombination band will show up during PCR analysis. If genotyping heterozygous animals (Rpl22<sup>HAV+</sup>), the wild-type band will always be present in the PCR assay independently of the potential recombination events that may take place on the floxed allele.

### SUPPORT PROTOCOL 2 qRT-PCR analysis

The success of the RiboTag procedure can be assessed by using qRT-PCR to evaluate whether specific mRNAs have been enriched during the isolation. Transcripts from the gene that is driving the Cre-recombinase in the specific cell types should be enriched in the IP RNA sample compared to the input RNA. We also recommend monitoring mRNAs that are not expected to be expressed in the targeted cells to verify that they are de-enriched in the IP. Quantitative RT-PCR may substitute for a more expensive and time-consuming analysis by RNA-Seq when only a small subset of transcripts need to be assessed.

We use the one step Brilliant II or III SYBR green kits from Agilent or RNA-Ct one step kits from Thermo Fisher Sci.

1. To confirm the specific isolation of transcripts from the cell type of study, we analyze RNA extracted from Inputs and IPs by single-step qRT-PCR. The enriched presence of known cell type-specific transcripts in the IPs compared to inputs indicates that the RiboTag isolation was successful.
2. Test samples for expression of transcripts specific to cell types in the dissected area other than the one of interest such as a glial marker when using a neuron-specific Cre transgenic. These are expected to appear depleted in the IPs when compared to inputs.
3. Perform qRT-PCR analysis for a housekeeping gene such as *Actb*. Normalizing all data to that standard can help correct for errors in RNA quantitation or differences in RNA quality. Adding equal amounts of RNA to the qRT-PCR reaction for all samples results in little variation in the CTs obtained for the housekeeping gene (less than 1 CT of difference is expected among all samples), which confirms RNA integrity in all samples and suitability of the housekeeping gene for data normalization.

### Protocol steps:

#### *Tissue preparation*

1. Transcardially perfuse mice with ice-cold phosphate-buffered saline (PBS) pH 7.4 containing 4% paraformaldehyde (PFA).  
*Perfusion with fixative solution reduces background resulting from endogenous mouse IgG detection when using anti-mouse secondary antibodies. If no primary antibodies raised in mouse are used for staining, brains can be directly fixed after removal by immersion in fixative for 12-24 h.*
2. Remove brains and postfix overnight at 4°C in PBS pH 7.4 containing 4% PFA.
3. Wash brains twice in ice-cold PBS pH 7.4
4. Immerse brains in an ice-cold solution of 30% sucrose in PBS pH 7.4. Specimens will float. Keep at 4°C until they sink (about 24 h)
5. Remove brains from the cryoprotective solution and pat dry to remove excess solution
6. Freeze in powdered dry ice for 5 min and store at -80 °C until sectioning.
7. Cryo-section brains in 30  $\mu$ m-slices using a freezing microtome. Collect sections from the area of interest for free-floating staining in PBS pH 7.4 with 0.02% sodium azide as preservative. Store sections at 4°.

8. Use a paint brush to transfer sections to wells containing Netwells inserts filled with PBS pH 7.4. Rinse sections once with PBS to remove preservative.
9. Block sections in PBS with 0.2% Triton X-100 and 10% normal donkey serum (NDS) for 1 h at room temperature with agitation.
10. Incubate overnight at 4°C with a primary antibody solution containing an anti-HA antibody such as the Zymed's rabbit anti-HA (#71-5500 Thermo Fisher Sci; use at 1:1000), or with a fluorophore-conjugated anti-HA antibody such as the Covance's Alexa Fluor 488-conjugated mouse anti-HA antibody (# A488-101L BioLegend, use at 1:500), in PBS pH 7.4 with 1% NDS and 0.2% Triton X-100.
- Fluorophore-conjugated antibodies allow for a direct visualization of the signal without secondary antibody detection. Using fluorophore-conjugated secondary antibodies will however provide an amplified signal.*
11. Wash sections three times for 5 minutes in PBS pH 7.4 with 0.2% Triton X-100. If a fluorophore-conjugated anti-HA antibody is used proceed to step 13.
12. Incubate with secondary antibody solution containing an anti-rabbit antibody conjugated to the fluorophore of choice (e.g., Alexa Fluor 488; Invitrogen; 1:500 in PBS pH 7.4 with 1% NDS and 0.2% Triton X-100) for 1 h at room temperature.
13. Wash sections three times for 5 minutes in PBS pH 7.4 with 0.2% Triton X-100
14. Mount stained sections onto slides for imaging using Fluoromount G with DAPI.
15. Seal the edge with nail polish and allow slides to dry for 1-2 hours before visualizing. Protect from light.
16. Slides can be stored at 4°C protected from light. For best results, slides should be analyzed within 1-2 weeks using the microscope of choice. Staining using anti-HA antibodies in Cre-positive RiboTag mice results in a strong perinuclear signal in the cell type of interest.
17. Image slides on a fluorescent microscope (standard or confocal) to visualize the Alexa Fluor 488 and DAPI.
- DAPI will bind DNA and light up the nuclei in all cells and Alexa fluorescence will only be present in the cells that are expressing RiboTag. Expect to see most of the RiboTag labeling in the cytoplasm where polyribosomes are abundant and in the nucleolar structures in the nucleus where ribosomes are being assembled.*

### BASIC PROTOCOL 3: RNA-Seq Library Preparation

There are many library preparation kits on the market but Trio RNASEq (NuGEN) has worked well in our hands. A detailed protocol is available on NuGEN's website (NuGEN). Briefly, 500 pg – 50 ng of total RNA in a volume of 10 ul is used as starting material for samples. We recommend using similar quantities of RNA for all samples that are going to be compared with each by RNA-Seq. We have good results starting with ~2 ng of total RNA.

15 **Convert isolated RNA from RiboTag into cDNA libraries**

- 16  
17 1. Perform DNase treatment using the Trio RNASeq kit.  
18

19 *Although DNA digestion is performed on the RNA purification column, the first*  
20 *step of the Trio RNASeq kit is to perform DNase treatment. It is extremely*  
21 *important to eliminate any residual DNA and the second DNase treatment does*  
22 *not result in any loss of sample.*  
23

- 24 2. Synthesize cDNA from the total RNA using reverse transcriptase primed with both oligo  
25 dT and random hexamers and then use DNA polymerase to produce a double stranded  
26 cDNA molecule  
27

28 *These primers include an RNA sequence at the 5' end that is not complementary*  
29 *and does not hybridize to the sample RNA. Then a second strand is made with a*  
30 *DNA polymerase (Dafforn et al., 2004; Kurn et al., 2005).*  
31

- 32  
33 3. Purify double stranded cDNA using silicon coated magnetic beads (AMPure XP,  
34 Beckman Coulter).  
35

36 *These beads are used several times throughout the protocol adding various*  
37 *amounts of a salt containing bead binding solution. By varying the salt*  
38 *concentration in the reaction, one is selecting for different fragment sizes, with*  
39 *more salt attracting almost all fragment sizes and less preferentially selecting for*  
40 *larger fragments (Boom et al., 1990; Melzak, Sherwood, Turner, & Haynes,*  
41 *1996).*  
42

- 43 4. Amplify the double-stranded cDNA using single primer isothermal amplification (SPIA).  
44

45 *RNase H is used to digest the RNA portion of the RNA / DNA heteroduplex at*  
46 *one end of the double stranded cDNA. A 5' RNA 3' DNA primer and a strong*  
47 *strand displacing DNA polymerase are used to make a single stranded cDNA*  
48 *that is the compliment to the original RNA. The process is continually repeated all*  
49 *at one temperature making many such copies (Dafforn et al., 2004; Kurn et al.,*  
50 *2005).*  
51

54 5. Fragment and repair ends of the cDNA

3 *The kit accomplishes this using an enzymatic process. After fragmentation*  
4 *adapters are ligated to either side of the cDNA with the 3' side receiving a unique*  
5 *nucleotide barcode that will be used to identify samples after sequencing.*

7

8 6. PCR Amplification of cDNA products.  
9

10 *The kit uses two PCR amplifications with a targeted step in between designed to*  
11 *deplete any cDNAs that would have been made from ribosomal RNA. Oligo*  
12 *probes are designed to bind to rRNA derived cDNA, extend that product, then*  
13 *restriction enzymes target these cleaving the adaptors off these products*  
14 *essentially eliminating them from the library.*  
15  
16

17 **Quantify cDNA libraries**  
18

19 *Even starting at the low end of the kit's range 500 pg of total RNA, one ends up with*  
20 *micrograms of cDNA. This needs to be greatly diluted before sequencing. To get the*  
21 *best results from the sequencer the cDNA libraries must be loaded on at a precise*  
22 *quantity. As well, each sample that will be multiplexed together should be loaded in*  
23 *equal quantities. The most accurate way to quantify the cDNA libraries is using qPCR*  
24 *against the adaptors on the cDNA fragments. Again, there are many kits on the market*  
25 *that can accomplish this but NEBNext has worked well in our hands.*  
26

27 *Four standard samples come with the kit ranging from 0.01 pM to 10 pM. In order to fall*  
28 *within these one needs to make serial dilutions of the libraries and use a range of those*  
29 *samples to quantify. In our hands 1:100,000 and 1:1,000,000 are the two dilutions that*  
30 *will fall between the given standards. Our libraries are most often between 0.1 and 1 μM.*  
31  
32

33 *A detailed user manual is available on NEB's website (NEB, 2017).*  
34

35 **Denature and dilute libraries**  
36

37 *The day of the sequencing run, libraries need to be denatured and diluted. A detailed*  
38 *protocol is available on Illumina's website (Illumina, 2018a).*

- 39 1. Make a 1 nM dilution of each sample to be multiplexed together using a portion of the  
40 libraries made earlier. Add an equal amount of each 1 nM sample to a master sample.
- 41 2. Add 20 uL of the master sample to 20 uL of 0.2 M NaOH. Mix by pipetting half of the  
42 volume 10 to 20 times. Incubate for 5 minutes.
- 43 3. Add 20 uL 0.2 M Tris pH 7 to neutralize the NaOH. Mix well by pipetting.
- 44 4. Add 940 uL of prechilled HT buffer provided with the NextSeq reagents to make a 20 pM  
45 dilution. Vortex briefly then spin the contents down. Keep the 20 pM sample on ice until  
46 you are ready to make the final dilution.
- 47 5. Add 117 uL of the 20 pM sample to 1183 uL of prechilled HT buffer for a final dilution of  
48 1.8 pM in 1.3 mL. Vortex briefly then spin the contents down. Keep this on ice until you  
49 are ready to load this on the sequencer.  
50

51 **Sequencing**  
52

- 53 1. Thaw reagents cartridge at 4 degrees overnight. Take the reagents cartridge and flow  
54 cell out of the refrigerator 30 minutes to an hour before your sequencing run. Ensure all  
55 reagent have thawed before proceeding.  
56  
57  
58  
59  
60

2. From the NextSeq500's software interface select *Sequence*.
3. Following the instructions on screen, load the flow cell.
4. Empty the spent reagents container into the appropriate waste container, then reload. Load buffer cartridge.
5. Pierce the foil covering reservoir 10 on the reagent cartridge with a pipette tip. Then load the full volume of the 1.8 pM sample into reservoir 10. Load the reagent cartridge onto the NextSeq500.
6. Specify the run parameters on the setup screen. Assign a name to *Run Name*, enter 75 into *Read 1* and 8 into *Index 1*.

*Single end reads may be sufficient for gene expression quantification and differential gene expression analysis. Running paired end reads will increase alignment confidence for specific isoforms and for novel transcript discovery. In this case you would enter 75 into "Read 2". NextSeq high output cartridges are rated for 400 million single end or 200 million paired end reads.*

7. Select *Next*, the system will run through a number of checks. Once it has finished with these select *Start*.

*A detailed user guide including instructions for loading reagents and sample onto the NextSeq sequencer is available on Illumina's website (Illumina, 2018b).*

*Once reagents and sample have been loaded on the NextSeq and the sequencing run has begun, the multiplexed sample is washed over the flow cell where cDNA molecules with adaptors hybridize to an oligo lawn with complementary sequences. A DNA polymerase makes a compliment to the original cDNA molecule primed from the oligo attached to the flow cell, the double stranded cDNA is denatured, and the original cDNA molecule is washed away. The attached compliment binds a second oligo attached to the flow cell, and is copied by a DNA polymerase in a process called bridge amplification. The process is repeated many times over until a cluster of cDNA molecules grows that will be large enough for the sequencer to read. Fluorescently labeled dNTPs are washed over the flow cell where they incorporate into the growing DNA strand primed off the template attached to the flow cell. This process is used to identify the sequence of both the DNA library fragments made from the original samples and the nucleotide barcode ligated to that DNA that identifies which sample it comes from (Illumina, 2016).*

#### **BASIC PROTOCOL 4: RNA-Seq Bioinformatics**

The analysis of RNA-Seq data can be done using a variety of open source or proprietary programs. If you are using a Core Facility to do RNA-Seq they are also likely to be able to analyze the data for you or at least assist you in the basic steps to obtain the aligned datasets. We build the libraries and run the RNA-Seq ourselves and use the methods described below to analyze the data.

**Convert BCL files to FASTQ files**

Illumina sequencers generate per cycle base call (BCL) files. However, most informatic programs take FASTQ or FASTA files as input. Bcl2fastq2 software is able to convert the files, as well as, demultiplex samples. A detailed user guide is available on Illumina's website including system requirements for the software (Illumina, 2017b).

1. Create a sample sheet with sample names, numbers, and corresponding nucleotide barcodes. This is saved as a .csv in the following format:

2. Run the bcl2fastq2 in Terminal (denoted with \$ hereafter) with the following options:

Explanation:

blc2fastq – calls the program.

minimum-trimmed-read-length – specifies a length to not trim if trimming adapters will result in a read of less than this length. In these cases, the adapter portion will be masked by replacing base calls with Ns. By specifying 0 we are telling the program to trim adapters no matter the remaining length of the read. Default is 35.

mask-short-adapter-reads – specifies a length of a read that if it falls below will be masked by Ns. By specifying 0 we are instructing the program not to do this. Default is 22 (must be set equal or lower than minimum-trimmed-read-length).

no-lane-splitting – this option instructs the program to include all reads for each given sample in one file. Without this option the NextSeq will give four files for each sample, one for each of lanes 1-4. If the researcher is planning to upload FASTQs to Illumina's basespace.com they should not call this option as basespace will only accept sample files that do have lanes split.

-o – specifies the output folder.

-R – specifies the run folder or where the BCL files are located.

--sample-sheet – points to where the sample sheet is located.

### Trim and filter FASTQ files

- Trim the first 5 base calls and filter out low quality reads. FASTX-Toolkit tools can accomplish this with the following command:

Commonly known as a “for loop”.

for i in sample1 sample2 sample3 etc – is a list of your samples to iterate over.

do X – could be any command. This command will then iterate over your list.

done – tells the command to stop.

\$i – is the placeholder where the list of samples will be substituted in.

zcat – looks at a compressed file.

| – called a pipe, it sends information from first command to the next command.

fastx\_trimmer -f 6 – this option says trim the first 5 base calls and keep everything from 6 onward.

fastq\_quality\_filter -q 25 -p 80 – this option says only keep reads with a quality score of 25 or higher on at least 80% of the base calls.

-z – is the option to compress output file.

-o – is the name of file or directory name/name of file.

### Align FASTQ files to a reference genome

We use TopHat2 (Kim et al., 2013; Trapnell, Pachter, & Salzberg, 2009) for alignment against GRCm38/mm10 UCSC. Useful links to reference genomes with prebuilt bowtie indexes and GTF transcript annotation files can be found here: <http://ccb.jhu.edu/software/tophat/igenomes.shtml>. A detailed protocol for TopHat has been published elsewhere (Trapnell et al., 2012).

4. Use the following command for alignments:

tophat2 – is a program that performs alignment.

-p 8 – specifies the number of CPU processors to use. Check your system information and set this at or below the total number of logical cores on the computer running the software.

-G – points to directory and .gtf file.

-o – points to output directory and /\$i – is the placeholder for sample.

Sequence/Bowtie2Index/genome – points to directory with index files.

folder\_with\_fastqs/\$i.fastq.gz – points to directory and fastq files. This is the actual sequencing data.

## Quantify and compute differential gene expression

We use cuffdiff of cufflinks (Roberts, Trapnell, Donaghey, Rinn, & Pachter, 2011; Trapnell et al., 2013; Trapnell et al., 2010) to compute differential gene expression. A detailed protocol has been published elsewhere (Trapnell et al., 2012).

cuffdiff – is a program to test for differential gene expression.

-L – name of your two conditions e.g. control, treatment or input, IP.

-b – this option corrects for RNA-seq read coverage bias (Roberts et al., 2011).

-u – this option performs an initial estimate to improve accuracy when weighting reads mapping to multiple locations.

*We run cuffdiff first on inputs vs IPs within conditions and then IP vs IP across conditions. In some cases, one may only be asking what is unique about these cells within this tissue. In which case one would only compare input to IP. It is important to note that genes that are expressed widely in the total population of neurons will not show up as differentially expressed even if they are expressed in the targeted neuron population. The difference between IP and input will only be significant when a transcript is preferentially expressed in the HA-tagged neuron population.*

## Visualize results

Use R within RStudio to visualize your results utilizing tidy, dplyr, and ggplot2 packages (Wickham, 2016).

The example below assumes the three cuffdiff output folders are saved in the working directory the R-project is started in.

*Cuffdiff includes a column in the output file gene\_exp.diff labeled "significant" that can be useful while graphing data assigning different colors to the binomial values ("yes" or "no"). However, we find it useful to append additional columns that can specify other criteria, for example, both statistically significant and meaningfully different.*

11. In the example below, we are using 2-fold again.

12. A common graph made with RNA-Seq data is a volcano plot. This plots p-value vs fold change, usually both have been log transformed. One can now use the newly created "DE" column to highlight genes that are both 2-fold different and statistically different.

*By saving the plot as an object ("volcplot") it is easy to call up the object and modify various aspects experimenting with different options until one is satisfied with the plot's appearance. Below we have modified the default colors of the points to black and red, drawn a horizontal line where the corrected p-value is 0.05, drawn lines indicating where the fold change is 2-fold, and selected a different theme (Figure 2A). We like the way theme\_classic and theme\_bw look but this is purely a matter of preference.*

KCl (Sigma; cat. No. P9541).

- Prepare a 1M stock solution and store at 4°C

MgCl<sub>2</sub> (Sigma; cat. No. 63068).

- Prepare a 1M stock solution and store at 4°C

Nonidet P-40 Substitute, 10% (w/v) solution (Roche, cat. No. 11 332 473 001)

Cycloheximide (Sigma, cat. No. C7698).

- Prepare a 5mg/ml stock solution and store at -20°C.

Heparin (Sigma; cat. No. H3393).

- Prepare a 100 mg/ml stock solution and store at 4°C.

Phosphate buffered saline (PBS), tablets (Millipore, cat. No. 524650-1EA).

- Prepare at 1x with water.

Paraformaldehyde (Sigma cat. No. P6148).

- Prepare a 4% solution in PBS 1x. Adjust pH to 7.4. Prepare fresh and store at 4°C.

**Optional:** *The addition of 1% sodium deoxycholate (DOC) to the homogenization buffer reduces some of the non-specific background. We have shown that DOC does not significantly reduce the purification of specific polysomes and suggest testing it in your experiments.*

*Homogenization buffer is prepared by adding defined volumes of stock solutions for Tris (1.5M pH 7.4), KCl (1M) and MgCl<sub>2</sub> (1M) to nuclease free water to achieve the final concentrations described above in the desired volume. Right before homogenization, buffer is supplemented with DTT, protease inhibitors, RNasin, heparin and cycloheximide.*

**High salt buffer:**

- 50 mM Tris pH 7.5
- 300 mM KCl
- 12 mM MgCl<sub>2</sub>
- 1% Nonidet P-40
- 0.5 mM DTT
- 100 ug/mL cycloheximide

*Prepare using Tris, KCl and MgCl<sub>2</sub> stock solutions. Add DTT and Cycloheximide right before using.*

**COMMENTARY****Background Information**

It has been a little over 10 years since the first development of cell-type specific ribosome tagging strategies that permitted the analysis of a cell's translome (the mRNAs engaged on polyribosomes) (Heiman et al., 2008). The original technique utilized BAC transgenic mice that were engineered to express a GFP-tagged 60S ribosomal subunit protein (Rpl10a) behind a cell type specific promoter. Antibodies directed against GFP were used to immunoprecipitate the tagged polyribosomes from which mRNA could then be isolated and analyzed by qRT-PCR, microarray, or RNA-Seq. This approach required the generation of novel BAC transgenic mice specific for each cell type and did not take advantage of the many tissue specific Cre recombinase mouse lines that were already developed.

We developed an alternative approach described in this RiboTag protocol in which an HA-tagged ribosomal protein (Rpl22) is conditionally expressed from the mouse genome by the action of Cre recombinase (Sanz et al., 2009). This approach takes advantage of the constantly expanding diversity of cell type specific Cre recombinase expressing mouse lines. Both approaches suffer from the same limitation: the investigator must have already identified a gene promoter that is specific for the cell type of interest. Although it is unlikely that subtypes of neurons can be uniquely defined by the expression of a single Cre recombinase transgene, the ribosome tagging strategies have facilitated analysis of the mRNAs engaged with polyribosomes in many neuronal cell types and can also be used to study the regulation of specific genes *in vivo*.

One alternative approach that has rapidly been adopted by neuroscientists is single cell transcript analysis by direct RNA-Seq. A single anatomical structure such as the arcuate nucleus of the hypothalamus is dissociated into single cells, the transcripts from each cell are uniquely barcoded, and the RNA is analyzed by RNA-Seq. Clustering analysis is used to identify unique cell types including neurons and glial cells, and then the neurons can be further clustered into discreet sub-types based on their transcript phenotype. This unbiased approach is very useful to explore the full range of neurons in a specific anatomical location and will rapidly leading to transcriptome phenotypes for all of the neurons and glial cells in a mouse brain. One limitation of this approach is that relatively non-abundant transcripts escape detection due to the large number of different cell types being sequenced en masse. Another limitation is that the techniques that must be used to obtain single cells, especially starting with the brain, can cause alterations in gene expression (e.g. induction of immediate early genes) (Moffitt et al., 2018; van den Brink et al., 2017) and may also lose transcripts that are sequestered in neuronal processes where they are also likely to be under translational control.

3 The ribosome capture approaches like RiboTag will only isolate mRNAs that have ribosomes

## 7 **Critical Parameters and Troubleshooting**

8  
9 **1. Cell type Specificity:** The specificity of the RiboTag analysis depends on the  
10 specificity of the Cre recombinase transgenic mouse line and every effort should be made to  
11 verify that the Cre transgenic drives expression of Rpl22-HA in the appropriate cell type and  
12 does not give rise to ectopic expression in other tissues that would interfere with the analysis. It  
13 is important to check that recombination of the RiboTag allele is not occurring during early  
14 development giving rise to mice with variable expression in many other cell types. This can be  
15 done by analyzing expression of Rpl22-HA by immunohistochemistry and comparing it to a  
16 marker for the cells of interest as described in **Basic Protocol 2**. We also routinely screen for  
17 RiboTag recombination in tail DNA during genotyping as described in the **Support Protocol 1**.  
18 This will help identify mice that have undergone recombination of the RiboTag allele during early  
19 development and they should be removed from the cohort to be studied as adults.  
20  
21

22 **2. Background and Controls:** When we analyze the RNA from a RiboTag experiment  
23 we find that the immunoprecipitated polysomes still contain mRNAs from cells that are not  
24 expressing Cre recombinase and Rpl22-HA (e.g. glial cells). These transcripts are depleted in  
25 the IP (IP/input ratios <0.3) but since some are abundantly expressed, they will still appear at  
26 significant levels in the IP. As described in **Basic Protocol 4** we advise analyzing both the input  
27 and IP RNA and then considering whether to filter out background gene transcripts that are  
28 depleted. In some of our experiments we are interested in gene transcripts which are enriched in  
29 the cell type being studied and help define a unique phenotype for those neurons. In addition to  
30 the background of depleted mRNAs seen in the IP we have observed that the IP may also contain  
31 enriched transcripts from genes that are clearly not expressed in the cell type of interest. These  
32 false positives can confound the data and we suggest doing a control IP experiment starting with  
33 equivalent tissue from a mouse that does not express RiboTag. Transcripts that enrich in the  
34 absence of Rpl22-HA expression are artifacts of the technique and should be eliminated from the  
35 specific transcripts isolated when Rpl22-HA is expressed. As described in the protocol we have  
36 recently been able to reduce the capture of these artifactually enriched genes by including an  
37 ionic detergent, sodium deoxycholate, in the initial homogenization buffer.  
38  
39

40 **3. Anticipated Results and Statistical Analysis:** Each tissue homogenate yields two  
41 RNA-Seq libraries, an input and an IP. We typically run 8-16 RNA-Seq libraries on a NextSeq  
42 500/550 flow cell and expect to have 25-50 million aligned reads for each library. Statistical  
43 analysis of this data requires at least 3 replicates making these experiments quite expensive in  
44 terms of reagents. If one is trying to phenotype the cells the first analysis would be to determine  
45 all of the expressed genes comparing IP to input and then to rank those transcripts by the ratio  
46 of IP to input. Transcripts that come up as enriched in a control IP from a mouse that does not  
47 express RiboTag should be removed from this transcript phenotype. If the animals have been  
48 treated with pharmacologic agents or exposed to physiological challenges, transcripts that  
49 change between samples can be identified and statistically analyzed as described in **Basic**  
50 **Protocol 4**. It is very helpful to correlate the specific transcripts that are enriched in the Cre-  
51 expressing cells with the *in situ* hybridization results from the Allen Mouse Brain Atlas.  
52 Specificity can also be confirmed using RNAscope (Advanced Cell Diagnostics) to colocalize  
53 transcripts in the anatomical region of interest. One can also confirm results by qRT-PCR  
54 starting with either the original RNA samples or qPCR with the DNA libraries.

3 The RiboTag approach is ideally suited to studying the dynamic regulation of genes in a  
4 specific neuronal population. Transcripts can be induced within minutes after the addition of  
5 hormones and drugs or changes in nutritional or environmental conditions. When an mRNA is  
6 specifically induced in the RiboTag targeted cell but constitutively expressed in neighboring  
7 cells, the level of transcripts in the IP will increase and the enrichment (IP/input) will also  
8 increase. If a gene like *Fos* is induced in all of the cells in the tissue being analyzed, then you  
9 will see an increase in IP transcripts for *Fos* but no change in enrichment.

10 **Translational control:** RiboTag techniques will only isolate mRNAs that have  
11 ribosomes bound and this implies that these mRNAs are being actively translated. However, it  
12 is important to consider that RiboTag is not going to be very sensitive to how many ribosomes  
13 are engaged on a particular mRNA. For example, if an mRNA is under translational control and  
14 only has 2-3 ribosomes in the repressed state and 12 or more ribosomes when induced, the  
15 efficiency of immunoprecipitation may not change enough to be a quantitative indicator of  
16 translational activity. Ribosomes may also remain attached to mRNAs even when elongation  
17 and active synthesis of protein is repressed.  
18

19  
20 **4. Time Considerations:** One of the advantages of the RiboTag procedure is that  
21 once the animals are obtained either by mating RiboTag mice with a specific Cre driver  
22 transgenic or stereotaxically injecting AAV-RiboTag virus and waiting for RiboTag expression,  
23 the immunoprecipitation of specific RNA can be completed in a day. Production of DNA  
24 libraries for RNA-Seq and DNA sequencing can be completed in a few more days. The most  
25 time-consuming step is the analysis of results and this depends on what questions are being  
26 asked and the number of different tissues and conditions being studied.

## 21 FIGURE LEGENDS

### 22 **Figure 1. Cartoon comparing the RiboTag mouse and AAV-DIO-RiboTag approaches**

23  
24 On the left side, the Rpl22 locus was modified by homologous recombination to insert LoxP  
25 sites on either end of the last exon (Ex4) of the Rpl22 gene and a duplicated Ex4 with an HA tag  
26 was inserted downstream. The CRE-Driver mouse removes the WT Ex4 sequence in specific  
27 cells and the transcript now splices in Ex4-HA (shown in green). Polyribosomes from cells  
28 expressing the Ex4-HA are recovered from a lysate by immunoprecipitation (IP) with an  
29 antibody directed against HA and magnetic beads coated with an artificial Protein A/G peptide.  
30 RNA is isolated from the IP polyribosomes and RNA is also isolated from the lysate. Gene  
31 expression analysis is done by RNA-Seq. On the right side the DIO-RiboTag viral vector is  
32 shown schematically. In the presence of Cre-recombinase the Rpl22-HA-IRES-YFP cassette is  
33 flipped and locked in the ON configuration so that the eIF1a promoter now drives expression of  
34 Rpl22-HA in specific cells. RNA is isolated from the IP and compared with the input.

39 **Figure 2. Example plots of hypothetical RNA Seq data. A,** Volcano plot of data with log  
40 base 2 transformed fold change (condition A vs condition B) plotted on the x axis and negative  
41 natural log transformed corrected p-value (q-value) plotted on the y axis. The solid horizontal  
42 line denotes where q-value is equal to 0.05. The two solid vertical lines denote where fold  
43 change is equal to 2 (or -2). Data points are colored red if they are both 2-fold different and have  
44 a q-value less than 0.05; otherwise they are black. **B,** Scatter plot of data with log2 transformed  
45 fragments per kilobase million (FPKM) plotted on the x axis for condition A and the y axis for  
46 condition B. As in **A** data points are colored red if they are both 2-fold different and have a q-  
47 value less than 0.05; otherwise they are black. **C,** Box plots for Gene A for condition A and B.  
48 FPKM are plotted on the y axis with the two conditions represented side by side on the x axis.  
49 **D,** Bar graphs denoting mean plus or minus standard error of the mean (SEM) for Gene A for  
50 condition A and B. FPKM are plotted on the y axis with the two conditions represented side by  
51 side on the x axis. Individual data points are superimposed on top of the bars for greater data  
52 reporting transparency. DE, differentially expressed.

# RiboTag: Ribosomal Tagging Strategy to Analyze Cell Type Specific mRNA Expression In Vivo

## Abstract:

Ribosome tagging has become a very useful *in vivo* approach for analyzing gene expression and mRNA translation in specific cell types that are difficult and time consuming to isolate by conventional methods. The approach is based on selectively expressing an HA-tagged ribosomal protein in a target cell type and then using antibodies against HA to purify the polysomes and associated mRNAs from the target cell. The original approach makes use of a mouse line (RiboTag) harboring a modified allele of *Rpl22* (*Rpl22-HA*) that is induced by the action of Cre recombinase. The *Rpl22-HA* gene can also be introduced into the animal by stereotaxic injections of an AAV-DIO-Rpl22-HA that is then activated in Cre-expressing cells. Both methods for tagging ribosomes facilitate the immunoprecipitation of ribosome bound mRNAs and their analysis by qRT-PCR or RNA-Seq. This protocol will discuss the technical procedures and describe important considerations relevant to the analysis of the data.

## Introduction:

The analysis of gene expression provides a description of a cell's potential functions and its response to extracellular signals. However, when researchers attempt to analyze gene expression *in vivo* they are confronted with the problem that all tissues contain a diverse array of different cell types with unique functions. Efforts to isolate a specific cell type for analysis based on sorting techniques can be successful but these additional manipulations are both time consuming and have been shown to alter transcription (Haimon et al., 2018). The brain is a particularly challenging tissue in which to quantitate gene expression and translation. A typical mouse brain is made up of around 75 million neurons, 23 million glial cells, 7 million endothelial cells and several million other miscellaneous cell types (Williams, 2000). Neurons are extremely diverse in terms of their expression of various neurotransmitters, neuropeptides, and receptors and typically these neurons are anatomically intermingled making them very difficult to separate for molecular analysis. *In situ* analysis of mRNA expression has been very useful in identifying the overall anatomical distribution of neurons expressing specific genes and the Allen Brain Institute has assembled a comprehensive database for both the mouse and human brain which is very useful. However, anatomical localization cannot define specific neuronal cell types. Characterization of the mRNA expression phenotype of specific neurons has progressed with the development of ribosome-tagging approaches, cell sorting based on promoter specific expression of fluorescent marker proteins, and single-cell RNA-Seq. Each approach has advantages and disadvantages. In this protocol we describe a ribosome-tagging approach

(RiboTag) which our lab developed (Sanz et al., 2009) and discuss the application of this approach to the analysis of polyribosome associated mRNA transcripts in specific populations of neurons. The RiboTag approach takes advantage of the hundreds of specific promoter-driven Cre recombinase transgenics currently available (Jackson Laboratories has more than 480 lines) and others are being added at a rapid pace.

There are two basic approaches involving the use of RiboTag as diagrammed in **Figure 1** and each has advantages and disadvantages. In the first approach we use a RiboTag mouse line in which the 60S ribosomal gene, *Rpl22*, was modified so that in the presence of Cre recombinase the last exon of *Rpl22* will be replaced with an HA-tagged exon effectively labeling the cell's polyribosomes so that they can be isolated by immunoprecipitation. These RiboTag mice are crossed to a Cre recombinase driver mouse line and the double heterozygotes are used for analysis. Immunoprecipitation of polyribosomes from neuronal tissue purifies only the polysomes that are tagged in the Cre-expressing cells. The mRNA from these polysomes is isolated and the transcripts analyzed by qRT-PCR or RNA-Seq. The second approach utilizes a *Rpl22-HA* construct in a flex or DIO virus (AAV) flanked by two different sets of loxP sites (Sanz et al., 2015). When the AAV-DIO-RiboTag is injected into a specific anatomical region of the brain of an adult mouse the *Rpl22-HA* is only expressed in the neurons that are actively expressing Cre recombinase and also infected by the AAV. After waiting several weeks for the *Rpl22-HA* to be expressed and incorporated into polyribosomes, tissue samples are isolated and used to immunoprecipitate HA-tagged polyribosomes followed by qRT-PCR or RNA-Seq. The viral approach requires accurate stereotaxic injections of virus and is more labor intensive but has the advantage that only adult neurons that still express the Cre transgenic will be targeted. The direct cross of RiboTag mice with Cre driver mice is easier to do but has the potential disadvantage that the *Rpl22-HA* could continue to be expressed in neurons that have differentiated from a progenitor population that expressed Cre recombinase at an earlier stage during development. One can take advantage of this difference by comparing results from the same brain region using the RiboTag mouse and the RiboTag virus using the same Cre driver transgenic. We have used this approach to demonstrate that embryonic *Pomc*-expressing progenitor neurons differentiate into both *Agrp* and *Kiss1* expressing neurons in the adult arcuate nucleus of the hypothalamus (Sanz et al., 2015).

**Basic Protocol 1** outlined below describes our methods in detail using the RiboTag mouse crossed with a specific Cre-recombinase expressing transgenic mouse to isolate polyribosomes by immunoprecipitation from brain homogenates and then further isolate RNA from both the input (original homogenate) and the immunoprecipitated (IP) polysomes. **Alternative Protocol 1** describes the viral approach using stereotaxic injection of AAV-DIO-RiboTag into adult Cre-recombinase expressing mouse brain to avoid developmental activation of RiboTag expression. In **Support Protocol 1** we describe the breeding and genotyping of RiboTag mice and in **Support Protocol 2** we describe the analysis of captured RNA using qRT-PCR. **Basic Protocol 2** discusses the use of RiboTag mice crossed with a specific Cre transgenic line to identify the anatomical localization of RiboTag expression by immunohistochemistry. In **Basic Protocol 3** we describe the current approach our lab is using to produce DNA libraries for RNA-Seq. **Basic Protocol 4** describes the bioinformatic tools that we are using to analyze the RNA-Seq data. In the **Commentary** we will provide a discussion of these methods and identify some of the most critical parameters and potential trouble spots.

## BASIC PROTOCOL 1

## The RiboTag Assay

This approach has been described and updated in several publications from our laboratory (Quintana et al., 2012; Sanz et al., 2013; Sanz et al., 2015; Sanz et al., 2009) and is shown schematically in **Figure 1**. We have now introduced modifications that improve the efficiency of the immunocapture and therefore increase the RNA yields obtained in the immunoprecipitates. These modifications include using an indirect method for the immunocapture of HA-tagged polysomes (instead of the direct immunoprecipitation procedure described in the original publication) and using Protein A/G beads with a higher binding capacity for IgGs.

## Protocol steps:

### Harvest tissue

1. Euthanize mice using IACUC approved procedures such as carbon dioxide inhalation
2. Decapitate mice using large sharp surgical scissors
3. Make a midline incision in the skin and expose the skull
4. Using small scissors and a spatula remove the skull
5. Lift the brain out of the skull and use a spatula to section the optic and other cranial nerves
6. Place the brain in a cold block or brain matrix for further dissection. Sampling tools such as Harris Uni-cores can be used to punch the area of interest.

### Lysate preparation

7. Clean Dounce tissue grinder and dissection tools and rinse thoroughly with RNase-free water (sterile water for irrigation can be used at this step). Air dry and place Dounce homogenizer on ice.
8. Prepare the homogenization buffer as described in the **Reagents and Solutions** section and keep on ice.
9. Dissect the tissue containing the cell type of interest. Specific areas or whole tissue can be used in this approach.  
*A brain matrix and sampling tools such as brain punches or Harris Uni-Cores can be used to precisely dissect the area of interest. Dissected tissue or punches of the area of interest can either be flash-frozen in liquid nitrogen right after dissection and stored at -80°C for months or processed fresh.*
10. Place the tissue in the ice-cold Dounce homogenizer vessel containing a defined volume of pre-chilled homogenization buffer and homogenize using 40 strokes of the loose-fitting pestle (type A pestle), followed by 40 more strokes with the tight-fitting pestle (type B pestle).  
*We typically use a 2-5% w/v ratio (for areas with a limited number of cells from the cell type of interest a pool of punches of the same area from different animals can be used to increase RNA yields). For small amounts of tissue (10-50mg tissue) we use the 2 ml Dounce and for 50-300mg we use the 7 ml Dounce.*
11. After homogenization, transfer lysate to a microtube on ice.
12. Clear the lysate at 10,000 x g for 10 min at 4°C using a refrigerated centrifuge.
13. Transfer the post-mitochondrial supernatant to a pre-chilled microcentrifuge tube on ice. Discard resulting pellet.
14. Take a small aliquot of the cleared lysate (40-80 ul) and store it at -80°C for subsequent Input analysis.

### Immunoprecipitation

15. Add 4 ul of the anti-Hemagglutinin (HA) antibody (Covance Anti-HA.11 Epitope Tag Antibody) to 800 ul of the remaining cleared lysate and incubate for 4 hours at 4°C in a microtube rotator with gentle mixing (end-over-end).
16. Prepare the magnetic protein A/G beads:
  - Thoroughly resuspend the beads by repeated inversion or gentle vortexing.
  - Place a microtube magnetic stand on ice and transfer 200 ul of the resuspended beads to a clean microcentrifuge tube.

- Place the tube into the magnetic stand on ice to collect the beads and remove and discard the storage buffer.
  - Add 400 ul of homogenization buffer and rotate end-over-end for 5 min to wash the beads.
  - Collect the beads with the magnetic stand, discard buffer.
17. Add the cleared lysate with the antibody to the beads. Incubate samples overnight at 4°C in a tube rotator with gentle end-over-end mixing.
  18. Next day, prepare the high salt buffer as described in the Reagents and Solutions section. Keep on ice.
    - a. Place samples into the magnetic stand on ice and remove supernatant (supernatant from the immunoprecipitation can be discarded or saved at -80°C for subsequent analysis).

*Leave tubes in the magnet for at least one minute to collect all the beads against the side of the tube.*
  19. With the tubes on the stand, add 800 ul of high salt buffer (**Reagents and Solutions**) to remove non-specific binding from the immunoprecipitate (IP). Transfer tubes to the rotator and wash the IP with gentle end-over-end mixing for 5 min at 4°C.
  20. Place samples into the magnetic stand on ice and remove supernatant
  21. Repeat high salt washes two more times with the same volume of high salt buffer for 5 min each, for a total of three washes.
  22. Resuspend beads in 800 ul of high salt buffer, mix on rotator for 5 min and transfer beads and buffer to a clean tube.

*This step helps remove any RNA or polyribosomes that might be sticking to the original tube.*
  23. Place tubes on the magnetic stand for at least 1 min, carefully remove all high salt buffer
  24. Add 350 ul of RLT buffer from the Qiagen's RNeasy extraction kit (mini or micro) supplemented with  $\beta$ -mercaptoethanol (provided with the kit).
  25. Remove tubes from stand and vortex samples for 30 seconds at RT.

*At this step samples can be stored at -80°C for subsequent RNA extraction or processed through the RNA extraction procedure.*

### RNA extraction

26. Place tubes containing IPs in RLT buffer (from Qiagen kit) into the magnetic stand for 1 min at RT to allow beads to be collected against the side of the tube
27. Transfer the clear RLT buffer containing RNA to a new microcentrifuge tube.
28. Proceed with RNA isolation with DNase digestion following Qiagen's RNeasy extraction kit directions.
29. To extract RNA from the Inputs (Step 6), bring input sample to 350 ul with RLT buffer supplemented with  $\beta$ -mercaptoethanol, vortex extensively and proceed to RNA extraction as described for IPs.

*RNA extraction using column-based kits should be performed at RT. However, eluted RNA should be kept on ice at all times. For long term storage, RNA is safely kept at -80°C for years. Whenever working with isolated RNA, always wear gloves to minimize RNase contamination, decontaminate working surfaces and use clean nuclease-free tubes and barrier pipette tips.*
30. Quantitate RNA using Quant-iT RiboGreen RNA Reagent (Thermo Fisher) or a Nanodrop-One (Thermo Fischer Sci) following the manufacturer's protocols.

2  
3 *If very low levels of RNA are expected (less than 2 ng/ul) the samples can be*  
4 *accurately quantitated by doing qRT-PCR using a house keeping gene such as*  
5 *Actb and comparing the results to known standard RNA solutions prepared with*  
6 *input RNA from the same tissue as detailed in **Support Protocol 2**.*

- 7  
8 31. Analyze RNA integrity on an Agilent 2100 Bioanalyzer system with the associated RNA  
9 6000 nano and pico kits (chose nano chips for samples 5-500 ng/ul, for samples with  
10 RNA concentrations < 5 ng/ul (down to 50 pg/ul) the pico chips should be used). Follow  
11 manufacturer's directions.

12 *Since most of the RNA isolated in Inputs and IPs is rRNA, the quality of mRNA is*  
13 *indirectly estimated by assessing the integrity of rRNA. A measure of RNA*  
14 *quality, the RNA integrity number (RIN), is also calculated by the software using*  
15 *an algorithm that assesses the electrophoretic traces of each sample. A RIN*  
16 *value of 7-10 indicates high quality RNA but RNA-Seq libraries can still be made*  
17 *and successfully analyzed starting with partially degraded RNA.*

## 21 **ALTERNATE PROTOCOL 1**

### 23 **Messenger RNA profiling using the RiboTag viral vector**

24  
25 To overcome the limitations associated with developmental activation of Cre  
26 recombinase transgenes and allow cell type-specific mRNA profiling of adult cells using  
27 Cre-Driver lines, we have developed a Cre-dependent RiboTag viral vector based on  
28 AAV1 (AAV1-DIO-RiboTag) (Sanz et al., 2015), where RiboTag expression is dependent  
29 on the activity of the promoter driving Cre recombinase expression in adult mice. This  
30 viral vector was created by inserting the cDNA of the mouse ribosomal protein Rpl22  
31 gene fused to three hemagglutinin (HA) sequences (Rpl22 · 3HA), into a double-floxed  
32 inverse open reading frame (DIO) AAV construct. For easy visualization of transduced  
33 cells, this construct also contains an IRES sequence (IRES2) followed by the YFP  
34 coding sequence as shown in **Figure 1**.

2. Inject 0.2 to 0.5 ul of a RiboTag viral vector preparation ( $7 \times 10^{11}$  viral genomes/ml) at the target site using the defined coordinates.  
*Follow a stereotaxic injection protocol such as (Gore, Soden, & Zweifel, 2013). When targeting bilateral structures, inject each side. Injection volumes can be adjusted to the targeted area, or multiple injections performed to cover larger areas. Injecting different mice using the same coordinates and pooling the targeted areas after dissection helps correct for variability resulting from stereotaxic viral vector injections.*
3. Allow at least 2 weeks for the viral vector to express Rpl22-HA. For RiboTag assays, good results are obtained when sacrificing animals at least 3 weeks after injections to allow for robust incorporation of Rpl22-HA into polyribosomes.
4. Perform RiboTag immunoprecipitations as described in **Basic Protocol 1**

All surgical procedures should be performed in accordance with protocols approved by your Institutional Animal Care Use Committee (IACUC).

## SUPPORT PROTOCOL 1 *Breeding and Genotyping of RiboTag Mice*

### **Breeding of RiboTag Mice:**

We maintain a live colony of RiboTag Breeders on a C57BL/6J background by mating homozygotes since they have no adverse phenotypes. Experimental mice for RiboTag assays are usually obtained by breeding male Cre recombinase-expressing mice to female homozygous RiboTag mice ( $Rpl22^{HA/HA}$ ). Therefore, experimental mice are always heterozygous for the RiboTag allele ( $Rpl22^{HA/+}$ ).

### **PCR Genotyping:**

To genotype the RiboTag mice, a PCR was developed that includes the loxP site 5' to the wild-type exon 4 of  $Rpl22$ ; the wild-type PCR product is 242 bp, while the mutant product is about 290 bp. This PCR also distinguishes homozygous RiboTag mice, as the 5' oligo corresponding to the intron between exons 3 and 4 of  $Rpl22$  is not present in the repeated segment of intron preceding the C-terminal  $Rpl22^{HA}$  exon 4. Resulting offspring from RiboTag mice bred to Cre recombinase-expressing mouse lines (experimental mice) are genotyped for the presence of the Cre recombinase gene and the RiboTag allele using the PCR oligonucleotides and reaction conditions described below

#### **Protocol steps:**

1. Extract DNA from mouse tail snips (2-5 mm) using a silica membrane column-based kit such as the NucleoSpin Tissue following manufacturer's directions.  
*We have also successfully used direct PCR kits that do not require prior DNA extraction such as the Phire Tissue Direct PCR Master Mix kit for RiboTag and Cre recombinase genotyping. DNA can also be extracted from tail samples by conventional methods using SDS/Protease K digestion, phenol/chloroform extraction, and ethanol precipitation.*
2. Prepare the DreamTaq PCR Master mix as follows: (per reaction) 13  $\mu$ l of water, 2  $\mu$ l of 10x DreamTaq green buffer, 2  $\mu$ l of 10mM dNTPs, 1  $\mu$ l of the forward oligo (10uM), 1  $\mu$ l of the reverse oligo (10uM), 0.1  $\mu$ l of DreamTaq polymerase. Mix gently and briefly centrifuge.
3. Add 19  $\mu$ l of the master mix to each well.
4. Add 1  $\mu$ l of tail DNA (~2 ng) to each reaction.
5. Mix and briefly centrifuge.
6. Place strips in the thermal cycler and run the appropriate program for each reaction. Thermal profile for RiboTag reactions is: 95°C for 2 min followed by 30 cycles of 95°C for 20 s, 57°C for 20 s, and 72°C for 30 s, with a final extension at 72°C for 5 min. Thermal profile for Cre reactions is 95°C for 2 min followed by 30 cycles of 95°C for 10 s, 63°C for 10 s, and 72°C for 40 s, with a final extension at 72°C for 5 min.
7. Prepare a 10% acrylamide gel by mixing (for two gels) 14 ml of water, 5 ml of 40% acrylamide-bis, 1ml of TBE 10x, 30  $\mu$ l of TEMED and 150  $\mu$ l of 10% APS. Allow gels to polymerize for 10-15 min.
8. Place gels into a vertical gel electrophoresis system, add buffer (0.5X TBE), and load DNA ladder and PCR reactions.
9. Run the electrophoresis at 175v (constant voltage) for 45 min.
10. Stain gels with SYBR safe and analyze PCR products under UV light.

#### **Detecting "Ectopic" Cre Recombination in tail DNA**

1  
2  
3 Mouse lines driving Cre recombinase expression under cell type specific promoters  
4 should typically restrict RiboTag activation to the cell type of interest. However, transient  
5 expression of Cre recombinase during development is often observed in different Cre  
6 driver lines and can lead to recombination of the RiboTag allele in unexpected cell types.  
7 If this “ectopic” expression takes place in the fertilized egg or during early development,  
8 it will be detected during the RiboTag genotyping PCR and a “recombination” band will  
9 show up at ~350 bp. If recombination occurs in the fertilized egg the loxP band will be  
10 replaced by the “recombination” band. If Cre recombinase is expressed during early  
11 development, recombination of the RiboTag allele will only take place in a portion of the  
12 cells and both the loxP and the recombination band will show up during PCR analysis. If  
13 genotyping heterozygous animals (Rpl22<sup>HA/+</sup>), the wild-type band will always be present  
14 in the PCR assay independently of the potential recombination events that may take  
15 place on the floxed allele.  
16  
17  
18  
19

## 20 **SUPPORT PROTOCOL 2** *qRT-PCR analysis*

21 The success of the RiboTag procedure can be assessed by using qRT-PCR to evaluate  
22 whether specific mRNAs have been enriched during the isolation. Transcripts from the gene  
23 that is driving the Cre-recombinase in the specific cell types should be enriched in the IP RNA  
24 sample compared to the input RNA. We also recommend monitoring mRNAs that are not  
25 expected to be expressed in the targeted cells to verify that they are de-enriched in the IP.  
26 Quantitative RT-PCR may substitute for a more expensive and time-consuming analysis by  
27 RNA-Seq when only a small subset of transcripts need to be assessed.

- 41 1. To confirm the specific isolation of transcripts from the cell type of study, we analyze  
42 RNA extracted from Inputs and IPs by single-step qRT-PCR. The enriched presence of  
43 known cell type-specific transcripts in the IPs compared to inputs indicates that the  
44 RiboTag isolation was successful.
- 45 2. Test samples for expression of transcripts specific to cell types in the dissected area  
46 other than the one of interest such as a glial marker when using a neuron-specific Cre  
47 transgenic. These are expected to appear depleted in the IPs when compared to inputs.
- 48 3. Perform qRT-PCR analysis for a housekeeping gene such as *Actb*. Normalizing all data  
49 to that standard can help correct for errors in RNA quantitation or differences in RNA  
50 quality. Adding equal amounts of RNA to the qRT-PCR reaction for all samples results in  
51 little variation in the CTs obtained for the housekeeping gene (less than 1 CT of  
52 difference is expected among all samples), which confirms RNA integrity in all samples  
53 and suitability of the housekeeping gene for data normalization.

## BASIC PROTOCOL 2: RiboTag mice as a reporter mouse line for direct visualization of Cre recombination

### Protocol steps:

#### *Tissue preparation*

1. Transcardially perfuse mice with ice-cold phosphate-buffered saline (PBS) pH 7.4 containing 4% paraformaldehyde (PFA).  
*Perfusion with fixative solution reduces background resulting from endogenous mouse IgG detection when using anti-mouse secondary antibodies. If no primary antibodies raised in mouse are used for staining, brains can be directly fixed after removal by immersion in fixative for 12-24 h.*
2. Remove brains and postfix overnight at 4°C in PBS pH 7.4 containing 4% PFA.
3. Wash brains twice in ice-cold PBS pH 7.4
4. Immerse brains in an ice-cold solution of 30% sucrose in PBS pH 7.4. Specimens will float. Keep at 4°C until they sink (about 24 h)
5. Remove brains from the cryoprotective solution and pat dry to remove excess solution
6. Freeze in powdered dry ice for 5 min and store at -80 °C until sectioning.
7. Cryo-section brains in 30 µm-slices using a freezing microtome. Collect sections from the area of interest for free-floating staining in PBS pH 7.4 with 0.02% sodium azide as preservative. Store sections at 4°.

#### *Immunofluorescence*

8. Use a paint brush to transfer sections to wells containing Netwells inserts filled with PBS pH 7.4. Rinse sections once with PBS to remove preservative.

9. Block sections in PBS with 0.2% Triton X-100 and 10% normal donkey serum (NDS) for 1 h at room temperature with agitation.
10. Incubate overnight at 4°C with a primary antibody solution containing an anti-HA antibody such as the Zymed's rabbit anti-HA (#71-5500 Thermo Fisher Sci; use at 1:1000), or with a fluorophore-conjugated anti-HA antibody such as the Covance's Alexa Fluor 488-conjugated mouse anti-HA antibody (# A488-101L BioLegend, use at 1:500), in PBS pH 7.4 with 1% NDS and 0.2% Triton X-100.
11. Wash sections three times for 5 minutes in PBS pH 7.4 with 0.2% Triton X-100. If a fluorophore-conjugated anti-HA antibody is used proceed to step 13.
12. Incubate with secondary antibody solution containing an anti-rabbit antibody conjugated to the fluorophore of choice (e.g., Alexa Fluor 488; Invitrogen; 1:500 in PBS pH 7.4 with 1% NDS and 0.2% Triton X-100) for 1 h at room temperature.
13. Wash sections three times for 5 minutes in PBS pH 7.4 with 0.2% Triton X-100
14. Mount stained sections onto slides for imaging using Fluoromount G with DAPI.
15. Seal the edge with nail polish and allow slides to dry for 1-2 hours before visualizing. Protect from light.
16. Slides can be stored at 4°C protected from light. For best results, slides should be analyzed within 1-2 weeks using the microscope of choice. Staining using anti-HA antibodies in Cre-positive RiboTag mice results in a strong perinuclear signal in the cell type of interest.
17. Image slides on a fluorescent microscope (standard or confocal) to visualize the Alexa Fluor 488 and DAPI.

*Fluorophore-conjugated antibodies allow for a direct visualization of the signal without secondary antibody detection. Using fluorophore-conjugated secondary antibodies will however provide an amplified signal.*

*DAPI will bind DNA and light up the nuclei in all cells and Alexa fluorescence will only be present in the cells that are expressing RiboTag. Expect to see most of the RiboTag labeling in the cytoplasm where polyribosomes are abundant and in the nucleolar structures in the nucleus where ribosomes are being assembled.*

### **BASIC PROTOCOL 3: RNA-Seq Library Preparation**

There are many library preparation kits on the market but Trio RNaseq (NuGEN) has worked well in our hands. A detailed protocol is available on NuGEN's website (NuGEN). Briefly, 500 pg – 50 ng of total RNA in a volume of 10 ul is used as starting material for samples. We recommend using similar quantities of RNA for all samples that are going to be compared with each by RNA-Seq. We have good results starting with ~2 ng of total RNA.

15 1. Perform DNase treatment using the Trio RNASeq kit.  
16

17 *Although DNA digestion is performed on the RNA purification column, the first*  
18 *step of the Trio RNASeq kit is to perform DNase treatment. It is extremely*  
19 *important to eliminate any residual DNA and the second DNase treatment does*  
20 *not result in any loss of sample.*  
21

- 22 2. Synthesize cDNA from the total RNA using reverse transcriptase primed with both oligo  
23 dT and random hexamers and then use DNA polymerase to produce a double stranded  
24 cDNA molecule  
25

26 *These primers include an RNA sequence at the 5' end that is not complementary*  
27 *and does not hybridize to the sample RNA. Then a second strand is made with a*  
28 *DNA polymerase (Dafforn et al., 2004; Kurn et al., 2005).*  
29

- 30 3. Purify double stranded cDNA using silicon coated magnetic beads (AMPure XP,  
31 Beckman Coulter).  
32

33 *These beads are used several times throughout the protocol adding various*  
34 *amounts of a salt containing bead binding solution. By varying the salt*  
35 *concentration in the reaction, one is selecting for different fragment sizes, with*  
36 *more salt attracting almost all fragment sizes and less preferentially selecting for*  
37 *larger fragments (Boom et al., 1990; Melzak, Sherwood, Turner, & Haynes,*  
38 *1996).*  
39  
40

- 41 4. Amplify the double-stranded cDNA using single primer isothermal amplification (SPIA).  
42

43 *RNase H is used to digest the RNA portion of the RNA / DNA heteroduplex at*  
44 *one end of the double stranded cDNA. A 5' RNA 3' DNA primer and a strong*  
45 *strand displacing DNA polymerase are used to make a single stranded cDNA*  
46 *that is the compliment to the original RNA. The process is continually repeated all*  
47 *at one temperature making many such copies (Dafforn et al., 2004; Kurn et al.,*  
48 *2005).*  
49

- 50  
51 5. Fragment and repair ends of the cDNA  
52

53 *The kit accomplishes this using an enzymatic process. After fragmentation*  
54 *adapters are ligated to either side of the cDNA with the 3' side receiving a unique*  
55 *nucleotide barcode that will be used to identify samples after sequencing.*  
56  
57  
58  
59  
60

## 6. PCR Amplification of cDNA products.

*The kit uses two PCR amplifications with a targeted step in between designed to deplete any cDNAs that would have been made from ribosomal RNA. Oligo probes are designed to bind to rRNA derived cDNA, extend that product, then restriction enzymes target these cleaving the adaptors off these products essentially eliminating them from the library.*

### Quantify cDNA libraries

*Even starting at the low end of the kit's range 500 pg of total RNA, one ends up with micrograms of cDNA. This needs to be greatly diluted before sequencing. To get the best results from the sequencer the cDNA libraries must be loaded on at a precise quantity. As well, each sample that will be multiplexed together should be loaded in equal quantities. The most accurate way to quantify the cDNA libraries is using qPCR against the adaptors on the cDNA fragments. Again, there are many kits on the market that can accomplish this but NEBNext has worked well in our hands.*

*Four standard samples come with the kit ranging from 0.01 pM to 10 pM. In order to fall within these one needs to make serial dilutions of the libraries and use a range of those samples to quantify. In our hands 1:100,000 and 1:1,000,000 are the two dilutions that will fall between the given standards. Our libraries are most often between 0.1 and 1  $\mu$ M.*

*A detailed user manual is available on NEB's website (NEB, 2017).*

### Denature and dilute libraries

*The day of the sequencing run, libraries need to be denatured and diluted. A detailed protocol is available on Illumina's website (Illumina, 2018a).*

1. Make a 1 nM dilution of each sample to be multiplexed together using a portion of the libraries made earlier. Add an equal amount of each 1 nM sample to a master sample.
2. Add 20  $\mu$ L of the master sample to 20  $\mu$ L of 0.2 M NaOH. Mix by pipetting half of the volume 10 to 20 times. Incubate for 5 minutes.
3. Add 20  $\mu$ L 0.2 M Tris pH 7 to neutralize the NaOH. Mix well by pipetting.
4. Add 940  $\mu$ L of prechilled HT buffer provided with the NextSeq reagents to make a 20 pM dilution. Vortex briefly then spin the contents down. Keep the 20 pM sample on ice until you are ready to make the final dilution.
5. Add 117  $\mu$ L of the 20 pM sample to 1183  $\mu$ L of prechilled HT buffer for a final dilution of 1.8 pM in 1.3 mL. Vortex briefly then spin the contents down. Keep this on ice until you are ready to load this on the sequencer.

### Sequencing

1. Thaw reagents cartridge at 4 degrees overnight. Take the reagents cartridge and flow cell out of the refrigerator 30 minutes to an hour before your sequencing run. Ensure all reagent have thawed before proceeding.
2. From the NextSeq500's software interface select *Sequence*.
3. Following the instructions on screen, load the flow cell.

Running paired end reads will increase alignment confidence for specific isoforms and for novel transcript discovery. In this case you would enter 75 into "Read 2". NextSeq high output cartridges are rated for 400 million single end or 200 million paired end reads.*

21 *A detailed user guide including instructions for loading reagents and sample onto the NextSeq sequencer is available on Illumina's website (Illumina, 2018b).*

22 *Once reagents and sample have been loaded on the NextSeq and the sequencing run has begun, the multiplexed sample is washed over the flow cell where cDNA molecules with adaptors hybridize to an oligo lawn with complementary sequences. A DNA polymerase makes a compliment to the original cDNA molecule primed from the oligo attached to the flow cell, the double stranded cDNA is denatured, and the original cDNA molecule is washed away. The attached compliment binds a second oligo attached to the flow cell, and is copied by a DNA polymerase in a process called bridge amplification. The process is repeated many times over until a cluster of cDNA molecules grows that will be large enough for the sequencer to read. Fluorescently labeled dNTPs are washed over the flow cell where they incorporate into the growing DNA strand primed off the template attached to the flow cell. This process is used to identify the sequence of both the DNA library fragments made from the original samples and the nucleotide barcode ligated to that DNA that identifies which sample it comes from (Illumina, 2016).*

#### 43 **BASIC PROTOCOL 4: RNA-Seq Bioinformatics**

We build the libraries and run the RNA-Seq ourselves and use the methods described below to analyze the data.

*We run cuffdiff first on inputs vs IPs within conditions and then IP vs IP across conditions. In some cases, one may only be asking what is unique about these cells within this tissue. In which case one would only compare input to IP. It is important to note that genes that are expressed widely in the total population of*

neurons will not show up as differentially expressed even if they are expressed in the targeted neuron population. The difference between IP and input will only be significant when a transcript is preferentially expressed in the HA-tagged neuron population.

***Optional:** The addition of 1% sodium deoxycholate (DOC) to the homogenization buffer reduces some of the non-specific background. We have shown that DOC does not significantly reduce the purification of specific polysomes and suggest testing it in your experiments.*

*Homogenization buffer is prepared by adding defined volumes of stock solutions for Tris (1.5M pH 7.4), KCl (1M) and MgCl<sub>2</sub> (1M) to nuclease free water to achieve the final concentrations described above in the desired volume. Right before homogenization, buffer is supplemented with DTT, protease inhibitors, RNasin, heparin and cycloheximide.*

## COMMENTARY

### Background Information

It has been a little over 10 years since the first development of cell-type specific ribosome tagging strategies that permitted the analysis of a cell's translome (the mRNAs engaged on polyribosomes) (Heiman et al., 2008). The original technique utilized BAC transgenic mice that were engineered to express a GFP-tagged 60S ribosomal subunit protein (Rpl10a) behind a cell type specific promoter. Antibodies directed against GFP were used to immunoprecipitate the tagged polyribosomes from which mRNA could then be isolated and analyzed by qRT-PCR, microarray, or RNA-Seq. This approach required the generation of novel BAC transgenic mice specific for each cell type and did not take advantage of the many tissue specific Cre recombinase mouse lines that were already developed.

We developed an alternative approach described in this RiboTag protocol in which an HA-tagged ribosomal protein (Rpl22) is conditionally expressed from the mouse genome by the action of Cre recombinase (Sanz et al., 2009). This approach takes advantage of the constantly expanding diversity of cell type specific Cre recombinase expressing mouse lines. Both approaches suffer from the same limitation: the investigator must have already identified a gene promoter that is specific for the cell type of interest. Although it is unlikely that subtypes of neurons can be uniquely defined by the expression of a single Cre recombinase transgene, the ribosome tagging strategies have facilitated analysis of the mRNAs engaged with polyribosomes in many neuronal cell types and can also be used to study the regulation of specific genes *in vivo*.

One alternative approach that has rapidly been adopted by neuroscientists is single cell transcript analysis by direct RNA-Seq. A single anatomical structure such as the arcuate nucleus of the hypothalamus is dissociated into single cells, the transcripts from each cell are uniquely barcoded, and the RNA is analyzed by RNA-Seq. Clustering analysis is used to identify unique cell types including neurons and glial cells, and then the neurons can be further clustered into discreet sub-types based on their transcript phenotype. This unbiased approach is very useful to explore the full range of neurons in a specific anatomical location and will rapidly leading to transcriptome phenotypes for all of the neurons and glial cells in a mouse brain. One limitation of this approach is that relatively non-abundant transcripts escape detection due to the large number of different cell types being sequenced en masse. Another limitation is that the techniques that must be used to obtain single cells, especially starting with the brain, can cause alterations in gene expression (e.g. induction of immediate early genes) (Moffitt et al., 2018; van den Brink et al., 2017) and may also lose transcripts that are sequestered in neuronal processes where they are also likely to be under translational control. The ribosome capture approaches like RiboTag will only isolate mRNAs that have ribosomes bound to them and are expected to be actively translated into protein.

## Critical Parameters and Troubleshooting

**1. Cell type Specificity:** The specificity of the RiboTag analysis depends on the specificity of the Cre recombinase transgenic mouse line and every effort should be made to verify that the Cre transgenic drives expression of Rpl22-HA in the appropriate cell type and does not give rise to ectopic expression in other tissues that would interfere with the analysis. It is important to check that recombination of the RiboTag allele is not occurring during early development giving rise to mice with variable expression in many other cell types. This can be done by analyzing expression of Rpl22-HA by immunohistochemistry and comparing it to a marker for the cells of interest as described in **Basic Protocol 2**. We also routinely screen for RiboTag recombination in tail DNA during genotyping as described in the **Support Protocol 1**. This will help identify mice that have undergone recombination of the RiboTag allele during early development and they should be removed from the cohort to be studied as adults.

**2. Background and Controls:** When we analyze the RNA from a RiboTag experiment we find that the immunoprecipitated polysomes still contain mRNAs from cells that are not expressing Cre recombinase and Rpl22-HA (e.g. glial cells). These transcripts are depleted in the IP (IP/input ratios <0.3) but since some are abundantly expressed, they will still appear at significant levels in the IP. As described in **Basic Protocol 4** we advise analyzing both the input and IP RNA and then considering whether to filter out background gene transcripts that are depleted. In some of our experiments we are interested in gene transcripts which are enriched in the cell type being studied and help define a unique phenotype for those neurons. In addition to the background of depleted mRNAs seen in the IP we have observed that the IP may also contain enriched transcripts from genes that are clearly not expressed in the cell type of interest. These false positives can confound the data and we suggest doing a control IP experiment starting with equivalent tissue from a mouse that does not express RiboTag. Transcripts that enrich in the absence of Rpl22-HA expression are artifacts of the technique and should be eliminated from the specific transcripts isolated when Rpl22-HA is expressed. As described in the protocol we have recently been able to reduce the capture of these artifactually enriched genes by including an ionic detergent, sodium deoxycholate, in the initial homogenization buffer.

**3. Anticipated Results and Statistical Analysis:** Each tissue homogenate yields two RNA-Seq libraries, an input and an IP. We typically run 8-16 RNA-Seq libraries on a NextSeq 500/550 flow cell and expect to have 25-50 million aligned reads for each library. Statistical analysis of this data requires at least 3 replicates making these experiments quite expensive in terms of reagents. If one is trying to phenotype the cells the first analysis would be to determine all of the expressed genes comparing IP to input and then to rank those transcripts by the ratio of IP to input. Transcripts that come up as enriched in a control IP from a mouse that does not express RiboTag should be removed from this transcript phenotype. If the animals have been treated with pharmacologic agents or exposed to physiological challenges, transcripts that change between samples can be identified and statistically analyzed as described in **Basic Protocol 4**. It is very helpful to correlate the specific transcripts that are enriched in the Cre-expressing cells with the *in situ* hybridization results from the Allen Mouse Brain Atlas. Specificity can also be confirmed using RNAscope (Advanced Cell Diagnostics) to colocalize transcripts in the anatomical region of interest. One can also confirm results by qRT-PCR starting with either the original RNA samples or qPCR with the DNA libraries.

The RiboTag approach is ideally suited to studying the dynamic regulation of genes in a specific neuronal population. Transcripts can be induced within minutes after the addition of hormones and drugs or changes in nutritional or environmental conditions. When an mRNA is specifically induced in the RiboTag targeted cell but constitutively expressed in neighboring cells, the level of transcripts in the IP will increase and the enrichment (IP/input) will also

3 increase. If a gene like *Fos* is induced in all of the cells in the tissue being analyzed, then you  
4 will see an increase in IP transcripts for *Fos* but no change in enrichment.

5 **Translational control:** RiboTag techniques will only isolate mRNAs that have  
6 ribosomes bound and this implies that these mRNAs are being actively translated. However, it  
7 is important to consider that RiboTag is not going to be very sensitive to how many ribosomes  
8 are engaged on a particular mRNA. For example, if an mRNA is under translational control and  
9 only has 2-3 ribosomes in the repressed state and 12 or more ribosomes when induced, the  
10 efficiency of immunoprecipitation may not change enough to be a quantitative indicator of  
11 translational activity. Ribosomes may also remain attached to mRNAs even when elongation  
12 and active synthesis of protein is repressed.  
13

14 **4. Time Considerations:** One of the advantages of the RiboTag procedure is that  
15 once the animals are obtained either by mating RiboTag mice with a specific Cre driver  
16 transgenic or stereotaxically injecting AAV-RiboTag virus and waiting for RiboTag expression,  
17 the immunoprecipitation of specific RNA can be completed in a day. Production of DNA  
18 libraries for RNA-Seq and DNA sequencing can be completed in a few more days. The most  
19 time-consuming step is the analysis of results and this depends on what questions are being  
20 asked and the number of different tissues and conditions being studied.

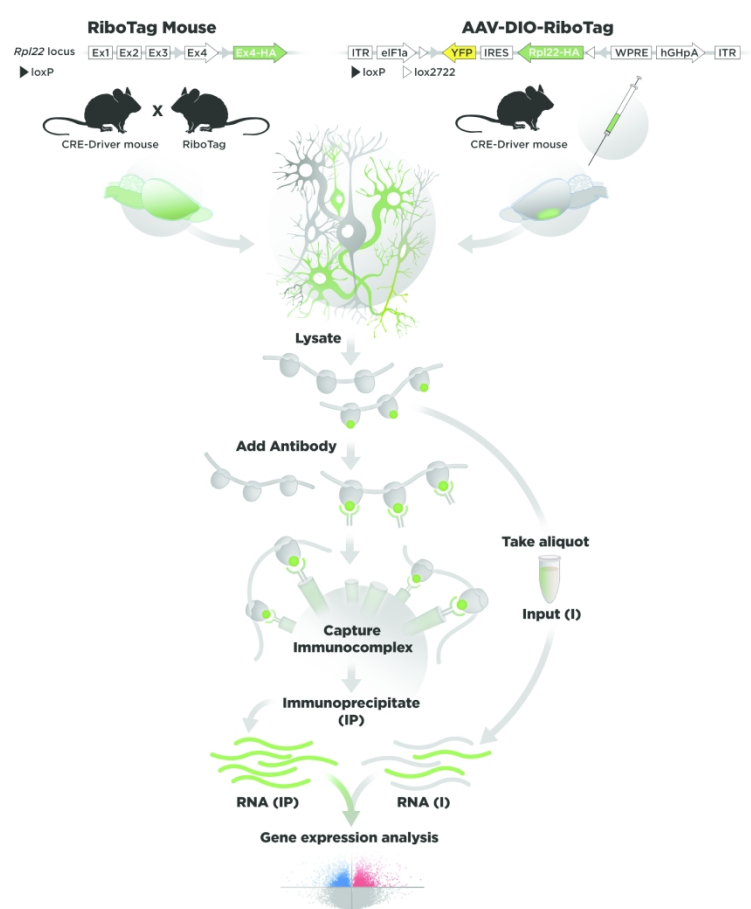
### 16 **Figure 1. Cartoon comparing the RiboTag mouse and AAV-DIO-RiboTag approaches**

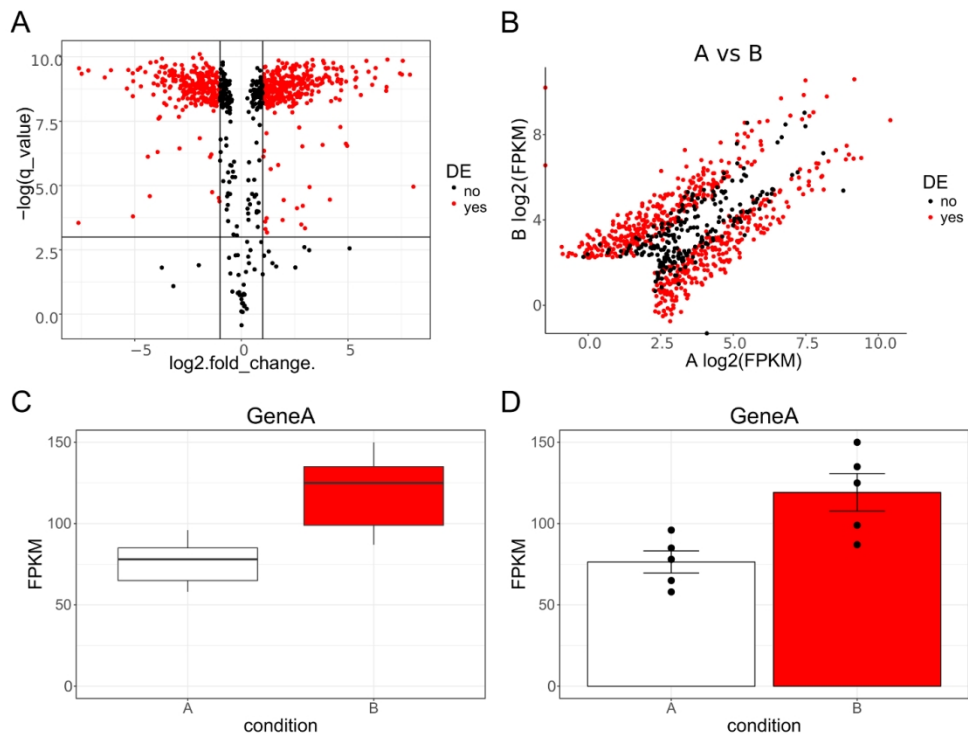
17 On the left side, the Rpl22 locus was modified by homologous recombination to insert LoxP  
18 sites on either end of the last exon (Ex4) of the Rpl22 gene and a duplicated Ex4 with an HA tag  
19 was inserted downstream. The CRE-Driver mouse removes the WT Ex4 sequence in specific  
20 cells and the transcript now splices in Ex4-HA (shown in green). Polyribosomes from cells  
21 expressing the Ex4-HA are recovered from a lysate by immunoprecipitation (IP) with an  
22 antibody directed against HA and magnetic beads coated with an artificial Protein A/G peptide.  
23 RNA is isolated from the IP polyribosomes and RNA is also isolated from the lysate. Gene  
24 expression analysis is done by RNA-Seq. On the right side the DIO-RiboTag viral vector is  
25 shown schematically. In the presence of Cre-recombinase the Rpl22-HA-IRES-YFP cassette is  
26 flipped and locked in the ON configuration so that the eIF1a promoter now drives expression of  
27 Rpl22-HA in specific cells. RNA is isolated from the IP and compared with the input.

32 **Figure 2. Example plots of hypothetical RNA Seq data. A,** Volcano plot of data with log  
33 base 2 transformed fold change (condition A vs condition B) plotted on the x axis and negative  
34 natural log transformed corrected p-value (q-value) plotted on the y axis. The solid horizontal  
35 line denotes where q-value is equal to 0.05. The two solid vertical lines denote where fold  
36 change is equal to 2 (or -2). Data points are colored red if they are both 2-fold different and have  
37 a q-value less than 0.05; otherwise they are black. **B,** Scatter plot of data with log2 transformed  
38 fragments per kilobase million (FPKM) plotted on the x axis for condition A and the y axis for  
39 condition B. As in **A** data points are colored red if they are both 2-fold different and have a q-  
40 value less than 0.05; otherwise they are black. **C,** Box plots for Gene A for condition A and B.  
41 FPKM are plotted on the y axis with the two conditions represented side by side on the x axis.  
42 **D,** Bar graphs denoting mean plus or minus standard error of the mean (SEM) for Gene A for  
43 condition A and B. FPKM are plotted on the y axis with the two conditions represented side by  
44 side on the x axis. Individual data points are superimposed on top of the bars for greater data  
45 reporting transparency. DE, differentially expressed.
