STRATIFIED HYPERKÄHLER SPACES FROM SEMISIMPLE LIE ALGEBRAS

Abstract. We study singular hyperkähler quotients of the cotangent bundle of a complex semisimple Lie group as stratified spaces whose strata are hyperkähler. We focus on one particular case where the stratification satisfies the frontier condition and the partial order on the set of strata can be described explicitly by Lie theoretic data.

1. Introduction

Let G be a complex reductive group, or equivalently, the complexification $K_{\mathbb{C}}$ of a compact connected Lie group K. Kronheimer [K] showed that the cotangent bundle T^*G can be endowed with a hyperkähler structure. That is, there exist three complex structures I_1, I_2, I_3 on T^*G that are Kähler with respect to a common metric and satisfy $I_1I_2I_3 = -1$. Moreover, the action of $K \times K$ on G by left and right multiplications lifts to an action on T^*G which preserves the hyperkähler structure and has a hyperkähler moment map, i.e., a moment map for each of the three Kähler forms [DS1, Lem. 2]. By the hyperkähler quotient construction [HKLR, §3(D)], we can thus produce many examples of hyperkähler manifolds by taking hyperkähler quotients of T^*G by closed subgroups of $K \times K$.

These quotients, of course, might have singularities. For example, Dancer [Da, pp. 88–89] showed that the hyperkähler quotient of $T^*SL(2,\mathbb{C})$ by $U(1) \times U(1)$ at level zero is isomorphic to the D_2 -surface $x^2 - zy^2 = z$: a complex surface with two isolated singularities. Nevertheless, hyperkähler quotients by non-free actions can always be partitioned into locally closed manifolds each carrying a hyperkähler structure [DS2, Thm. 2.1]. This is the orbit type partition and is analogous to Sjamaar–Lerman results on singular symplectic quotients [SL]. Moreover, since the pieces are locally closed, these partitions have an additional structure: a partial

order given by $S \leq T$ if $S \subseteq \overline{T}$. The partition is said to satisfy the *frontier* condition if $S \cap \overline{T} \neq \emptyset \Rightarrow S \leq T$. We say that a locally finite partition into locally closed manifolds is a *stratification* if it satisfies the frontier condition. For example, the orbit type partition of a singular symplectic quotient is a stratification, but it is not known if the same is true for hyperkähler quotients.

In this paper, we study certain hyperkähler quotients of T^*G by closed subgroups of $K \times K$ and describe their decomposition into hyperkähler manifolds and the partial order on it. More precisely, we focus on a generalization of Dancer's example above to any complex semisimple group G. That is, we consider the hyperkähler quotient of T^*G by $T_K \times T_K$, where T_K is a maximal torus in K. In particular, we will show that in this case, the orbit type partition is a stratification.

Although the definition involves a group G, the quotient will be shown to depend only on the underlying Lie algebra \mathfrak{g} . Thus, we denote it by $\mathcal{D}(\mathfrak{g})$. The structure of the stratification of $\mathcal{D}(\mathfrak{g})$ is particularly rich and can be described combinatorially from the root system Φ of \mathfrak{g} . We will show that the set of strata is in bijection with the set of root subsystems of Φ and the partial order corresponds to inclusions of subsystems. In particular, we can compute the stratification structure of $\mathcal{D}(\mathfrak{g})$ explicitly for any given \mathfrak{g} (see §6 for examples).

The strata can also be described individually. Denote by $\mathcal{D}(\mathfrak{g})_{\Psi}$ the stratum corresponding to a root subsystem $\Psi \subseteq \Phi$. Then, there is always a top stratum $\mathcal{D}(\mathfrak{g})_{\text{top}} := \mathcal{D}(\mathfrak{g})_{\Phi}$ and a bottom stratum $\mathcal{D}(\mathfrak{g})_{\text{bottom}} := \mathcal{D}(\mathfrak{g})_{\varnothing}$. We will show that $\mathcal{D}(\mathfrak{g})_{\text{top}}$ is a connected open dense subset of real dimension $4(\dim \mathfrak{g} - 2 \operatorname{rk} \mathfrak{g})$ and $\mathcal{D}(\mathfrak{g})_{\text{bottom}}$ a finite set of |W| elements, where W is the Weyl group of \mathfrak{g} . Note that this generalizes Dancer's example that $\mathcal{D}(\mathfrak{sl}(2,\mathbb{C}))$ is a complex surface with two isolated singularities. To describe the intermediate strata, let \mathfrak{g}_{Ψ} be a semisimple Lie algebra with root system Ψ and W_{Ψ} the Weyl group of \mathfrak{g}_{Ψ} . Then, for any root subsystem $\Psi \subseteq \Phi$, the stratum $\mathcal{D}(\mathfrak{g})_{\Psi}$ is isomorphic as a hyperkähler manifold to a disjoint union of $|W|/|W_{\Psi}|$ copies of $\mathcal{D}(\mathfrak{g}_{\Psi})_{\text{top}}$.

We will also describe a coarser stratification which keeps the property that the strata are disjoint unions of copies of spaces $\mathcal{D}(\mathfrak{g}_{\Psi})_{\mathrm{top}}$. In this case, the set of strata is in bijection with the set of root subsystems modulo the Weyl group action, or equivalently, the set of conjugacy classes of regular semisimple subalgebras of \mathfrak{g} .

To obtain these results, we will first prove a Kempf-Ness type theorem for the hyperkähler quotient of T^*G by any closed subgroup H of $K \times K$. That is, we will show that the hyperkähler quotient is homeomorphic to the GIT quotient $\operatorname{Spec}(\mathbb{C}[\mu_{\mathbb{C}}^{-1}(0)]^{H_{\mathbb{C}}})$ where $\mu_{\mathbb{C}}$ is the complex part of the hyperkähler moment map. This requires first showing that T^*G has global Kähler potentials that are proper, and we give a complete proof of that fact. With this theorem, we can study $\mathcal{D}(\mathfrak{g})$ and its orbit type partition algebraically and obtain the above results. The proofs about the stratification of $\mathcal{D}(\mathfrak{g})$ rely on the fact that we are quotienting by a torus and hence can use a weight decomposition.

Organization of the paper. In §2, we give the necessary background on stratified spaces, singular hyperkähler quotients, root subsystems, and the hyperkähler space T^*G . We then state precisely the results of this paper in §3. We prove the Kempf–Ness type theorem in §4, and prove all facts about the stratification of $\mathcal{D}(\mathfrak{g})$ in §5. Finally, we give examples in §6.

2. Preliminaries

2.1. Stratified spaces and singular quotients

Stratified spaces are generalizations of manifolds that allow singularities. Roughly speaking, they are spaces that can be decomposed into manifolds (of possibly different dimensions) which fit together nicely. There is no universally agreed definition of stratified spaces but, for the purpose of this paper, we use the following one (cf. [SL, Def. 1.1] [DK, Def. 2.7.3]).

Definition 2.1. Let M be a topological space. A *stratification* of M is a partition \mathcal{P} of M satisfying the following conditions:

- Manifold condition. The elements of \mathcal{P} are topological manifolds in the subspace topology.
- Local condition. \mathcal{P} is locally finite and its elements are locally closed.
- Frontier condition. For all $S, T \in \mathcal{P}$, we have $S \cap \overline{T} \neq \emptyset \Rightarrow S \subseteq \overline{T}$.

The elements of \mathcal{P} are called the *strata* and the pair (M, \mathcal{P}) a *stratified space*.

There is a natural relation on the partition \mathcal{P} of a stratified space M given by $S \leq T$ if $S \subseteq \overline{T}$. It follows from the local closedness of the strata that this relation is a partial order. We call (\mathcal{P}, \leq) the *stratification poset* and view it as an abstract partially ordered set (poset). In this framework, the frontier condition is equivalent to

$$\overline{S} = \bigcup_{T < S} T$$
, for all $S \in \mathcal{P}$.

Thus, the stratification poset (\mathcal{P}, \leq) provides key structural information about M: it captures the precise way in which the strata fit together. One of the main goals of this paper is to describe this poset for the space $\mathcal{D}(\mathfrak{g})$ in terms of combinatorial data associated to \mathfrak{g} .

We will use *Hasse diagrams* to visualize the stratification posets. These are the diagrams obtained by drawing a node for each $i \in \mathcal{P}$ and an edge upward from node i to node j if i < j but there is no k such that i < k < j. In particular, the highest dimensional strata are on the top and lowest dimensional ones on the bottom. For example, the following figure represents a stratification of the filled equilateral triangle and the corresponding Hasse diagram:

$$M =$$

Many interesting examples of stratified spaces come from quotients by non-free actions. We review next three classes of examples.

Smooth quotients. If a compact Lie group K acts smoothly, but not necessarily freely, on a smooth manifold M, then the quotient M/K has a natural stratification. It is described as follows. For each closed subgroup $H \subseteq K$, let (H) be the conjugacy class of H in K. We say that $p \in M$ has orbit type (H) if its stabilizer subgroup K_p is in (H), and denote the set of points of orbit type (H) by

$$M_{(H)} := \{ p \in M : K_p \in (H) \}.$$

The orbit type partition $\mathcal{P} = \{M_{(K_p)}/K : p \in M\}$ is a stratification of M/G in the sense of Definition 2.1, except for the fact that the strata may have connected components of different dimensions. In any case, we can refine the partition to get a genuine stratification. See [DK, §2.7] for details.

Kähler quotients. Recall that if M is a symplectic manifold, K a compact Lie group acting freely on M by preserving the symplectic form, and $\mu: M \to \mathfrak{k}^*$ a moment map for this action, then the Marsden–Weinstein reduction [MW]

$$M/\!\!/ K := \mu^{-1}(0)/K$$

is a smooth symplectic manifold (we consider only quotients at level zero in this paper). Moreover, if M is Kähler and K preserves the Kähler structure, then $M/\!\!/ K$ is also Kähler [HKLR, Thm. 3.1] and is called the Kähler quotient of M by K. Sjamaar–Lerman [SL] generalized this construction to non-free actions by showing that $M/\!\!/ K$ has a natural stratification in which the strata are Kähler. The strata are $(M/\!\!/ K)_{(K_p)} := \mu^{-1}(0)_{(K_p)}/K$ for $p \in \mu^{-1}(0)$ with the quotient metric and the Kähler form is characterized by the fact that its pullback to $\mu^{-1}(0)_{(K_p)}$ is the restriction of the Kähler form of M. (Again the strata may not be of pure dimension, but we can refine the partition.)

Hyperkähler quotients. Some of the results of Sjamaar–Lerman for singular Kähler quotients have analogues in hyperkähler geometry. Let M be a hyperkähler manifold with complex structures I_1, I_2, I_3 and corresponding Kähler forms $\omega_1, \omega_2, \omega_3$. If K is a compact Lie group acting on M by preserving the hyperkähler structure, then a hyperkähler moment map is a map $\mu = (\mu_1, \mu_2, \mu_3) : M \to (\mathfrak{k}^*)^3$ such that μ_i is a moment map with respect to ω_i . We call the triple (M, K, μ) a tri-Hamiltonian space. A standard result of [HKLR, Thm. 3.2] says that, if K acts freely, the hyperkähler quotient

$$M/\!\!/\!/K := \mu^{-1}(0)/K$$

is smooth and hyperkähler in a canonical way.

More generally, Dancer–Swann [DS2, Thm. 2.1] proved that, for non-free K-actions, $M /\!\!/\!/ K$ can be partitioned into smooth hyperkähler manifolds. As for Kähler quotients, this is the *orbit type partition*

$$\mathcal{P} = \{ (M /\!/\!/ K)_{(K_n)} : p \in \mu^{-1}(0) \}$$

where $(M/\!\!//K)_{(H)} := \mu^{-1}(0)_{(H)}/K$. Thus, the manifold condition is satisfied and it follows from the results on smooth quotients that the local condition also holds.

However, it is not known if the frontier condition holds. The issue is that to prove this condition in the Kähler case, Sjamaar–Lerman use a local normal form for the moment map, but there is no known equivalent in the hyperkähler setting.

The space $\mathcal{D}(\mathfrak{g})$ that we study in this paper is an example of a hyperkähler quotient by a non-free action whose orbit type partition is a stratification.

2.2. Root subsystems and regular subalgebras

The stratification poset of $\mathcal{D}(\mathfrak{g})$ is very rich and its description in terms of Lie theoretic data will occupy a good part of the paper. A crucial ingredient is the notion of root subsystems and regular subalgebras, which we review in this section. The results of this section can be found, for example, in [OV, Chap. 6].

Let \mathfrak{g} be a complex semisimple Lie algebra with Cartan subalgebra \mathfrak{t} , $\Phi \subseteq \mathfrak{t}^*$ the set of roots, and $\mathfrak{g} = \mathfrak{t} \oplus \bigoplus_{\alpha \in \Phi} \mathfrak{g}_{\alpha}$ the Cartan decomposition. A subset Ψ of Φ is called a *root subsystem* if

- (1) $\alpha, \beta \in \Psi$ and $\alpha + \beta \in \Phi \Rightarrow \alpha + \beta \in \Psi$,
- (2) $\alpha \in \Psi \iff -\alpha \in \Psi$.

Equivalently, Ψ is a root subsystem if $(\operatorname{span}_{\mathbb{Z}} \Psi) \cap \Phi = \Psi$. A root subsystem is always a root system itself. We use the notation $\Psi \leq \Phi$ to say that Ψ is a root subsystem of Φ . This gives a *partial order* on the set of root subsystems.

Root subsystems are closely related to the notion of regular subalgebras. Recall that a subalgebra $\mathfrak h$ of $\mathfrak g$ is called regular if there exists a Cartan subalgebra $\mathfrak t$ of $\mathfrak g$ such that $[\mathfrak t,\mathfrak h]\subseteq\mathfrak h$ (this notion was studied by Dynkin [Dy] who introduced this terminology). We denote by $\mathcal C_{\mathfrak g}$ the set of conjugacy classes of regular semisimple subalgebras of $\mathfrak g$. Since all Cartan subalgebras are conjugate, every element of $\mathcal C_{\mathfrak g}$ has a representative which is regular with respect to a fixed Cartan subalgebra $\mathfrak t$.

Proposition 2.1. The set of semisimple subalgebras of \mathfrak{g} that are regular with respect to \mathfrak{t} is in one-to-one correspondence with the set of root subsystems of Φ . The correspondence associates to $\Psi \leq \Phi$ the subalgebra

$$\mathfrak{g}_{\Psi} := \mathfrak{t}_{\Psi} \oplus \bigoplus_{\alpha \in \Psi} \mathfrak{g}_{\alpha},\tag{1}$$

where \mathfrak{t}_{Ψ} is the span of the coroots h_{α} for $\alpha \in \Psi$.

Recall that if k is the number of simple factors of \mathfrak{g} , there is an $(\mathbb{R}_{>0})^k$ family of non-degenerate symmetric invariant bilinear forms on \mathfrak{g} which are positive definite on the real span of the coroots. We call those bilinear forms *admissible*. Equivalently, a bilinear form is admissible if its restriction to some (and hence all) compact real form(s) is negative definite. For example, the Killing form is admissible.

Proposition 2.2. Any admissible bilinear form on \mathfrak{g} remains admissible on \mathfrak{g}_{Ψ} . Also, \mathfrak{t}_{Ψ} is a Cartan subalgebra of \mathfrak{g}_{Ψ} , (1) is the corresponding Cartan decomposition, and the map $\mathfrak{t}^* \to \mathfrak{t}_{\Psi}^*$ restricts to an isomorphism of abstract root systems from $\operatorname{span}_{\mathbb{R}} \Psi$ to the root system of \mathfrak{g}_{Ψ} with respect to the above bilinear form.

Let $W_{\mathfrak{g}} = W_{\Phi} = W(\mathfrak{g}, \mathfrak{t})$ be the Weyl group of \mathfrak{g} with respect to \mathfrak{t} . It acts on the set of root subsystems by $w \cdot \Psi := \{w \cdot \alpha : \alpha \in \Psi\}$.

Proposition 2.3. Let Ψ_1 and Ψ_2 be two root subsystems. Then, $\mathfrak{g}_{\Psi_1} = \mathfrak{g}_{\Psi_2}$ if and only if there exists $w \in W_{\Phi}$ such that $w \cdot \Psi_1 = \Psi_2$. Thus, the map $\Psi \mapsto \mathfrak{g}_{\Psi}$ descends to a bijection {root subsystems of Φ }/ $W_{\Phi} \to \mathcal{C}_{\mathfrak{g}}$.

There is also a natural partial order on $C_{\mathfrak{g}}$ induced by inclusion: we say that $[\mathfrak{h}_1] \leq [\mathfrak{h}_2]$ if there exists an inner automorphism φ of \mathfrak{g} such that $\varphi(\mathfrak{h}_1) \subseteq \mathfrak{h}_2$.

Let \mathfrak{h} be a regular semisimple subalgebra of \mathfrak{g} , say $\mathfrak{h} = \mathfrak{g}_{\Psi}$ for some $\Psi \subseteq \Phi$. Then, the Weyl group $W_{\mathfrak{h}}$ of \mathfrak{h} can be viewed as a subgroup of $W_{\mathfrak{g}}$, namely, the one generated by the simple reflections s_{α} for $\alpha \in \Psi$. In particular, the index $|W_{\mathfrak{g}}:W_{\mathfrak{h}}|:=|W_{\mathfrak{g}}|/|W_{\mathfrak{h}}|$ is a well-defined positive integer. We define the *embedding number* of \mathfrak{h} in \mathfrak{g} to be

$$m_{\mathfrak{g}}(\mathfrak{h}) = |W_{\mathfrak{g}} : W_{\mathfrak{h}}||\{w \cdot \Psi : w \in W_{\mathfrak{g}}\}|, \tag{2}$$

where the second factor is the number of root subsystems in the $W_{\mathfrak{g}}$ -orbit of Ψ . The embedding number is thus a positive integer which depends on the particular way in which \mathfrak{h} embeds in \mathfrak{g} . It depends only on the conjugacy class of \mathfrak{h} and hence descends to a map $m_{\mathfrak{g}}: \mathcal{C}_{\mathfrak{g}} \to \mathbb{N}$. Note that we always have $m_{\mathfrak{g}}(\mathfrak{g}) = 1$ and $m_{\mathfrak{g}}(0) = |W_{\mathfrak{g}}|$. These numbers will be important for our study of the stratified space $\mathcal{D}(\mathfrak{g})$, as they will count the number of connected components of the strata.

2.3. The hyperkähler space T^*G

Let G be a complex reductive group. Then, T^*G , being the cotangent bundle of a complex manifold, has a canonical holomorphic symplectic form. Kronheimer [K] showed that there is a hyperkähler structure on T^*G compatible with this form. In other words, if I_1, I_2, I_3 are the three complex structures of this hyperkähler structure and $\omega_1, \omega_2, \omega_3$ the associated Kähler forms, then I_1 is the natural complex structure on T^*G and $\omega_2 + i\omega_3$ the canonical holomorphic-symplectic form. This hyperkähler structure is constructed by an infinite-dimensional version of the hyperkähler quotient construction where the role of the moment map is played by a system of nonlinear ODEs called the *Nahm equations*. It requires a choice of a compact real form K of G and an invariant inner-product on $\mathfrak{k} = \text{Lie}(K)$. However, since all compact real forms are conjugate, the hyperkähler structure does not depend on K in an essential way. But it does depend on the invariant inner-product on \mathfrak{k} , or equivalently, on an admissible bilinear form on $\mathfrak{g} = \text{Lie}(G)$.

Recall that for any hyperkähler manifold (M,g,I_1,I_2,I_3) , if $(a_1,a_2,a_3) \in \mathbb{R}^3$ lies in the 2-sphere, then the endomorphism $a_1I_1+a_2I_2+a_3I_3$ is a complex structure with respect to which (M,g) is Kähler. Hence, M has a 2-sphere of complex structures. In the case of T^*G , there is an isometric SO(3)-action which rotates these complex structures so, from the point of view of Kähler geometry, they are all equivalent.

The hyperkähler space T^*G also has a large group of symmetries: Dancer–Swann [DS1] showed that the action of $K \times K$ on G by left and right multiplications lifts to an action on T^*G which preserves the hyperkähler structure and has a canonical hyperkähler moment map (which comes from evaluating solutions to Nahm equations at the endpoints of the interval on which they are defined [DS1, Lem. 2]). Moreover, this action commutes with the SO(3)-action.

Let H be a closed subgroup of $K \times K$ and μ the induced hyperkähler moment map for the action of H on T^*G , i.e., the composition of Dancer–Swann's hyperkähler moment map $T^*G \to (\mathfrak{k} \times \mathfrak{k})^* \otimes \mathbb{R}^3$ with the restriction map $(\mathfrak{k} \times \mathfrak{k})^* \otimes \mathbb{R}^3 \to$ $\mathfrak{h}^* \otimes \mathbb{R}^3$. Write $\mu_{\mathbb{C}} := \mu_2 + i\mu_3$ for the *complex part* of μ and $\mu_{\mathbb{R}} := \mu_1$ for the *real* part of μ . There is an algebraic description of $\mu_{\mathbb{C}}$ which is useful for computations. First, there is a complex algebraic isomorphism $T^*G \to G \times \mathfrak{g}^*$ given by translating every cotangent space to the identity using left multiplication. On the latter space, the action of $K \times K$ is $(a,b) \cdot (g,\xi) = (agb^{-1}, \mathrm{Ad}_b^* \, \xi)$ and this extends to an algebraic action of $G \times G$ which preserves the canonical holomorphic-symplectic form. Then, $\mu_{\mathbb{C}}$ is the composition of the map

$$G \times \mathfrak{g}^* \longrightarrow \mathfrak{g}^* \times \mathfrak{g}^*, \quad (g, \xi) \longmapsto (\mathrm{Ad}_g^* \xi, -\xi)$$
 (3)

with the restriction $\mathfrak{g}^* \times \mathfrak{g}^* \to \mathfrak{h}_{\mathbb{C}}^*$ and is a holomorphic-symplectic moment map for the action of $H_{\mathbb{C}} \subseteq G \times G$ on T^*G . See [DS1, §4] and [B, §2] for details.

3. Statement of results

In this section, we state precisely the main results of this paper. The proofs will be in the subsequent sections.

Let G be a connected complex semisimple Lie group, K a compact real form of G, and H a closed subgroup of $K \times K$. There is a canonical hyperkähler moment map for the action of $K \times K$ on T^*G [DS1, §3], which is in fact unique since here K is semisimple. Let $\mu = (\mu_{\mathbb{R}}, \mu_{\mathbb{C}})$ be the induced hyperkähler moment map for the H-action as in §2.3. By §2.1, the hyperkähler quotient $T^*G/\!\!/\!/H$ can be partitioned into smooth hyperkähler manifolds, but it is not known if this is a stratification in the sense of Definition 2.1.

We first give an algebraic description of the topological space $T^*G/\!\!/\!/H$ and its orbit type partition which works for all H and needs no reference to the hyperkähler setting. Recall that the set of polystable points $\mu_{\mathbb{C}}^{-1}(0)^{\mathrm{ps}}$ is the set of points in $\mu_{\mathbb{C}}^{-1}(0)$ whose $H_{\mathbb{C}}$ -orbit is closed. The inclusion $\mu_{\mathbb{C}}^{-1}(0)^{\mathrm{ps}} \hookrightarrow \mu_{\mathbb{C}}^{-1}(0)$ descends to a bijection from $\mu_{\mathbb{C}}^{-1}(0)^{\mathrm{ps}}/H_{\mathbb{C}}$ to the GIT quotient $\mathrm{Spec}(\mathbb{C}[\mu_{\mathbb{C}}^{-1}(0)]^{H_{\mathbb{C}}})$ [L1, §I.1] and, moreover, this map is a homeomorphism in the Euclidean topology [L2, §2.1] [FC, Thm. 2.1]. Thus, the $H_{\mathbb{C}}$ -orbit type partition on $\mu_{\mathbb{C}}^{-1}(0)^{\mathrm{ps}}/H_{\mathbb{C}}$ induces a partition on $\mathrm{Spec}(\mathbb{C}[\mu_{\mathbb{C}}^{-1}(0)]^{H_{\mathbb{C}}})$ sometimes called the algebraic or Luna stratification [L1, §III.2], [PV, §6.9].

Theorem 3.1. We have $\mu^{-1}(0) \subseteq \mu_{\mathbb{C}}^{-1}(0)^{ps}$ and this inclusion induces a homeomorphism

$$T^*G/\!\!/\!/ H \longrightarrow \mu_{\mathbb{C}}^{-1}(0)^{\mathrm{ps}}/H_{\mathbb{C}} = \mathrm{Spec}(\mathbb{C}[\mu_{\mathbb{C}}^{-1}(0)]^{H_{\mathbb{C}}}).$$

Moreover, the H-orbit type partition of $T^*G/\!\!/\!/H$ coincides with the $H_{\mathbb{C}}$ -orbit type partition of $\mu_{\mathbb{C}}^{-1}(0)^{\mathrm{ps}}/H_{\mathbb{C}}$ and the homeomorphism restricts to biholomorphisms on the strata.

The proof follows from a slight generalization of the classic Kempf–Ness theorem to varieties with global Kähler potentials. The main step is to show that every point is analytically semistable, i.e., that the closure of the $H_{\mathbb{C}}$ -orbit of every point in $\mu_{\mathbb{C}}^{-1}(0)$ intersects $\mu_{\mathbb{R}}^{-1}(0)$. One has to go to the gauge-theoretic point of view using Nahm equations and do some analysis since $\mu_{\mathbb{R}}$ has no explicit algebraic description as a map on T^*G (the issue is that the passage from T^*G to Nahm equations relies on an existence result in analysis and hence is not explicit). Note that the theorem implies that the pieces in the orbit type partition of $\mu_{\mathbb{C}}^{-1}(0)^{\mathrm{ps}}/H_{\mathbb{C}}$ are smooth, which is not immediately obvious since $\mu_{\mathbb{C}}^{-1}(0)$ might be singular. In

addition, the theorem says that with respect to any element in the 2-sphere of complex structures, $T^*G/\!\!/\!/H$ has the structure of a complex affine variety.

We are mostly interested in the special case

$$\mathcal{D}(G) := T^*G/\!/\!/(T_K \times T_K)$$

where T_K is a maximal torus in K. Note that $\mathcal{D}(G)$ does not depend on the choice of maximal torus since they are all conjugate. On the other hand, the hyperkähler structure does depend on the choice of admissible bilinear form on \mathfrak{g} . A crucial ingredient in the description of $\mathcal{D}(G)$ is that, in fact, it depends *only* on \mathfrak{g} and its bilinear form. More precisely:

Theorem 3.2. Let \tilde{G} be the universal cover of G. Then, there is a homeomorphism $\mathcal{D}(\tilde{G}) \to \mathcal{D}(G)$ which preserves the orbit type partition and restricts to hyperkähler isomorphisms on the strata.

This justifies the notation $\mathcal{D}(\mathfrak{g})$ instead of $\mathcal{D}(G)$. The main point about taking $H = T_K \times T_K$ is that the GIT quotient $\operatorname{Spec}(\mathbb{C}[\mu_{\mathbb{C}}^{-1}(0)]^{H_{\mathbb{C}}})$ can be studied with a weight decomposition. This enables us to prove:

Theorem 3.3. The orbit type partition of $\mathcal{D}(\mathfrak{g})$ is a stratification.

More precisely, the proof relies on an explicit description of the orbit type partition. Let $\mathcal{O} \subseteq \mathfrak{g}$ be a regular semisimple adjoint orbit and consider the action of $T := (T_K)_{\mathbb{C}}$ on the cotangent bundle $T^*\mathcal{O} \subseteq \mathfrak{g} \times \mathfrak{g}^*$ by $t \cdot (X, \eta) = (\mathrm{Ad}_t X, \mathrm{Ad}_t^* \eta)$. Let \mathfrak{t}° be the annihilator of \mathfrak{t} in \mathfrak{g}^* . Using Theorem 3.1, we get the following description, which is well suited for computations.

Proposition 3.4. The space $\mathcal{D}(\mathfrak{g})$ is homeomorphic to $(T^*\mathcal{O} \cap (\mathfrak{g} \times \mathfrak{t}^{\circ}))^{ps}/T$. Moreover, the $(T_K \times T_K)$ -orbit type partition of $\mathcal{D}(\mathfrak{g})$ coincides with the T-orbit type partition of $(T^*\mathcal{O} \cap (\mathfrak{g} \times \mathfrak{t}^{\circ}))^{ps}/T$.

In particular, the orbit type strata of $\mathcal{D}(\mathfrak{g})$ are of the form $(T^*\mathcal{O} \cap (\mathfrak{g} \times \mathfrak{t}^{\circ}))_Z^{\mathrm{ps}}/T$ for some closed subgroups Z of T (we use the subscript Z instead of (Z) since T is abelian). Let Φ be the root system of \mathfrak{g} and view it as a subset of $\mathrm{Hom}(T,\mathbb{C}^*)$. For every root subsystem $\Psi \leq \Phi$, let

$$Z_{\Psi} := \{ t \in T : \alpha(t) = 1 \text{ for all } \alpha \in \Psi \}$$

$$\mathcal{D}(\mathfrak{g})_{\Psi} := (T^* \mathcal{O} \cap (\mathfrak{g} \times \mathfrak{t}^{\circ}))_{Z_{\Psi}}^{\text{ps}} / T.$$
 (4)

Theorem 3.5. The map

 $\{ root \ subsystems \ of \ \Phi \} \rightarrow \{ orbit \ type \ strata \ of \ \mathcal{D}(\mathfrak{g}) \}, \quad \Psi \mapsto \mathcal{D}(\mathfrak{g})_{\Psi}$

is an isomorphism of posets.

In particular, there is a top stratum $\mathcal{D}(\mathfrak{g})_{\text{top}} := \mathcal{D}(\mathfrak{g})_{\Phi}$ corresponding to the root system Φ itself and a bottom stratum $\mathcal{D}(\mathfrak{g})_{\text{bottom}} := \mathcal{D}(\mathfrak{g})_{\varnothing}$ corresponding to the trivial root subsystem \varnothing . Recall from §2.2 that any admissible bilinear form on \mathfrak{g} remains admissible on \mathfrak{g}_{Ψ} . Hence, it induces a natural hyperkähler structure on $\mathcal{D}(\mathfrak{g}_{\Psi})_{\text{top}}$. Let W be the Weyl group of \mathfrak{g} and W_{Ψ} the Weyl group of \mathfrak{g}_{Ψ} .

Theorem 3.6.

- (1) $\mathcal{D}(\mathfrak{g})_{\text{top}}$ is a connected open dense subset of real dimension $4(\dim \mathfrak{g} 2 \operatorname{rk} \mathfrak{g})$.
- (2) $\mathcal{D}(\mathfrak{g})_{\text{bottom}}$ is a finite set of |W| elements.
- (3) For all $\Psi \leq \Phi$, the stratum $\mathcal{D}(\mathfrak{g})_{\Psi}$ is isomorphic as a hyperkähler manifold to a disjoint union of $|W:W_{\Psi}|$ copies of $\mathcal{D}(\mathfrak{g}_{\Psi})_{\text{top}}$.

A stratification can always be refined arbitrarily by taking submanifolds of the strata. It is thus desirable to get a stratification as coarse as possible. We describe next one way of coarsening the orbit type stratification of $\mathcal{D}(\mathfrak{g})$. Recall from §2.2 that $\mathcal{C}_{\mathfrak{g}}$ is the set of conjugacy classes of regular semisimple subalgebras of \mathfrak{g} and $m_{\mathfrak{g}}:\mathcal{C}_{\mathfrak{g}}\to\mathbb{N}$ the map of embedding numbers (2). For each $[\mathfrak{h}]\in\mathcal{C}_{\mathfrak{g}}$, let

$$\mathcal{D}(\mathfrak{g})_{[\mathfrak{h}]} := igcup_{[\mathfrak{g}_{\Psi}] = [\mathfrak{h}]} \mathcal{D}(\mathfrak{g})_{\Psi}.$$

Theorem 3.7. The partition $\mathcal{P} = \{\mathcal{D}(\mathfrak{g})_{[\mathfrak{h}]} : [\mathfrak{h}] \in \mathcal{C}_{\mathfrak{g}} \}$ is a stratification of $\mathcal{D}(\mathfrak{g})$ and the map $\mathcal{C}_{\mathfrak{g}} \to \mathcal{P}$, $[\mathfrak{h}] \mapsto \mathcal{D}(\mathfrak{g})_{[\mathfrak{h}]}$ an isomorphism of posets. Moreover, $\mathcal{D}(\mathfrak{g})_{[\mathfrak{g}]} = \mathcal{D}(\mathfrak{g})_{\mathrm{top}}$, $\mathcal{D}(\mathfrak{g})_{[0]} = \mathcal{D}(\mathfrak{g})_{\mathrm{bottom}}$ and $\mathcal{D}(\mathfrak{g})_{[\mathfrak{h}]}$ is isomorphic as a hyperkähler manifold to a disjoint union of $m_{\mathfrak{g}}(\mathfrak{h})$ copies of $\mathcal{D}(\mathfrak{h})_{\mathrm{top}}$.

We will give examples of this stratification in §6.

4. A Kempf–Ness theorem for $T^*G/\!\!/\!/H$

The purpose of this section is to prove Theorem 3.1 relating the hyperkähler quotient $T^*G/\!\!/\!\!/H$ with the GIT quotient $\operatorname{Spec}(\mathbb{C}[\mu_{\mathbb{C}}^{-1}(0)]^{H_{\mathbb{C}}})$.

4.1. Kähler quotients with global Kähler potentials

Let G be a complex reductive group with maximal compact subgroup K and M a smooth complex affine variety on which G acts algebraically.

Recall that the Kempf–Ness theorem [KN], [PV, §6.12], [Sc, Cor. 4.7] states that if $M \subseteq \mathbb{C}^n$ is endowed with the standard Kähler structure and G acts linearly on \mathbb{C}^n and K by isometries, then there is a canonical moment map μ for the action of K on M such that the Kähler quotient $\mu^{-1}(0)/K$ is homeomorphic to the GIT quotient $\operatorname{Spec}(\mathbb{C}[M]^G)$. However, in our case, the Kähler structures on T^*G cannot be obtained from embeddings in \mathbb{C}^n , so we need a slight generalization of this theorem.

More precisely, suppose that M has a Kähler structure (compatible with its natural complex structure) which is induced by a global Kähler potential $f \in C^{\infty}(M,\mathbb{R})$ that is K-invariant, proper and bounded from below. For example, if M is isometrically embedded in \mathbb{C}^n , f can be the norm function. Let I be the complex structure of M and $\omega = 2i\partial\bar{\partial}f$ the Kähler form. For each $X \in \mathfrak{k}$, let $X^{\#}$ be the vector field on M induced by the K-action and define

$$\mu: M \to \mathfrak{k}^*, \quad \mu(p)(X) = df(IX_p^{\#})$$

for all $p \in M$ and $X \in \mathfrak{k}$.

Proposition 4.1. The map μ is a moment map for the action of K on M.

Proof. We have $\omega = -d\alpha$ where $\alpha = i(\partial - \bar{\partial})f$. Moreover, $df(IX^{\#}) = \alpha(X^{\#})$ so $i_{X^{\#}}\alpha = \mu^{X}$ where $\mu^{X}(p) := \mu(p)(X)$. Now, the Lie derivative $\mathcal{L}_{X^{\#}}$ commutes with ∂ and $\bar{\partial}$ since K acts by biholomorphisms, so $\mathcal{L}_{X^{\#}}\alpha = i(\partial - \bar{\partial})\mathcal{L}_{X^{\#}}f = 0$, by K-invariance of f. Hence, $i_{X^{\#}}\omega = d(i_{X^{\#}}\alpha) = d\mu^{X}$. To prove K-equivariance of μ , define, for all $k \in K$, the map $\psi_{k} : M \to M$, $p \mapsto k \cdot p$. Then, $df \circ I \circ d\psi_{k} = d(f \circ \psi_{k}) \circ I = df \circ I$ and $X_{k:p}^{\#} = d\psi_{k}((\mathrm{Ad}_{k^{-1}}X)_{p}^{\#})$, so

$$\mu(k \cdot p)(X) = df(I(d\psi_k((\mathrm{Ad}_{k^{-1}} X)_p^{\#}))) = df(I(\mathrm{Ad}_{k^{-1}} X)_p^{\#}) = \mu(p)(\mathrm{Ad}_{k^{-1}} X).$$

Hence, $\mu(k \cdot p) = \operatorname{Ad}_{k}^{*} \mu(p)$ for all $k \in K$ and $p \in M$.

Proposition 4.2. We have $\mu^{-1}(0) \subseteq M^{\mathrm{ps}}$ and this inclusion induces a homeomorphism $\mu^{-1}(0)/K \to M^{\mathrm{ps}}/G = \mathrm{Spec}(\mathbb{C}[M]^G)$. Moreover, the K-orbit type partition of $\mu^{-1}(0)/K$ coincides with the G-orbit type partition of M^{ps}/G and the homeomorphism restricts to biholomorphisms on the strata.

Proof. Let $M^{\text{a-ss}}$ be the set of $p \in M$ such that the closure of $G \cdot p$ intersects $\mu^{-1}(0)$ and let $M^{\text{a-ps}}$ be the set of $p \in M^{\text{a-ss}}$ such that $G \cdot p$ is closed in $M^{\text{a-ss}}$ ('a-ss' stands for analytically semistable and 'a-ps' stands for analytically polystable). Then, Sjamaar showed that $\mu^{-1}(0) \subseteq M^{\text{a-ps}}$ [Sj, Prop. 2.4] and that this inclusion descends to a homeomorphism $\mu^{-1}(0)/K \to M^{\text{a-ps}}/G$ [Sj, Rem. 2.6] (see also [HL]) with the desired properties regarding orbit type partitions [Sj, Thm. 2.10]. Thus, it suffices to show that $M^{\text{a-ss}} = M$, so that $M^{\text{a-ps}} = M^{\text{ps}}$. This is proved by adapting the standard proof of the Kempf-Ness theorem, replacing the norm function by f. Let $p_0 \in M$. Since G acts algebraically, there is a closed orbit $G \cdot q_0$ in $\overline{G \cdot p_0}$. We claim that $G \cdot q_0$ intersects $\mu^{-1}(0)$. Since f is proper and bounded from below, $f(G \cdot q_0)$ attains a minimum $f(g_0 \cdot q_0)$ for some $g_0 \in G$. Thus, by defining $F_p : G \to \mathbb{R}$, $F_p(g) = f(g \cdot p)$, we get $(dF_{q_0})_{g_0} = 0$. Moreover, if $R_g : G \to G$, R(a) = ag then $F_{g \cdot p} = F_p \circ R_g$, so $(dF_{g_0 \cdot q_0})_1 = 0$. Then, for all $X \in \mathfrak{k}$ we have $(dF_p)_1(iX) = df(IX_p^{\#}) = \mu(p)(X)$, so in particular $\mu(g_0 \cdot q_0)(X) = (dF_{q_0 \cdot q_0})_1(iX) = 0$. Hence, $\mu(g_0 \cdot q_0) = 0$, so $\overline{G} \cdot p_0$ intersects $\mu^{-1}(0)$. \square

4.2. Application to $T^*G/\!\!/\!/H$

We want to apply Proposition 4.2 to certain Kähler potentials on T^*G . These potentials are obtained from the *Nahm equations*, i.e., the system of ordinary differential equations

$$\dot{T}_1 = [T_2, T_3], \quad \dot{T}_2 = [T_3, T_1], \quad \dot{T}_3 = [T_1, T_2],$$

where the T_i 's take values in \mathfrak{k} . For each $X \in \mathfrak{k}^3$, let T^X be the maximally extended solution to Nahm equations with initial condition $T^X(0) = X$. Let W be the open set of $X \in \mathfrak{k}^3$ such that T^X is defined at least on [0,1]. Then, Dancer–Swann [DS1, §3] showed that W is star-shaped about $0, K \times W$ is diffeomorphic to T^*G , and there is a global Kähler potential for the complex structure I_1 of T^*G given by

$$F: K \times W \to \mathbb{R}, \quad (k, X) \mapsto \int_0^1 ||T_1^X(t)||^2 + ||T_2^X(t)||^2 dt.$$

The diffeomorphism $T^*G \cong K \times W$ intertwines the standard $K \times K$ -action on T^*G with the action $(a,b) \cdot (k,X) = (akb^{-1}, \mathrm{Ad}_b X)$ on $K \times W$, so F is $K \times K$ -invariant and bounded from below. The main difficulty is to show that F is proper. Since F is independent of K, it suffices to show that the maps

$$f_i: W \to \mathbb{R}, \quad X \mapsto \int_0^1 ||T_i^X(t)||^2 dt$$

are proper (the sum of two real-valued functions that are proper and bounded from below is proper). We prove this by the following three lemmas.

Lemma 4.3. Let T be a solution to Nahm equations on an interval I. Then, $||T_i||^2$ is convex on I for all i.

Proof. We have $\frac{d}{dt}||T_1||^2 = 2\langle T_1, \dot{T}_1 \rangle = 2\langle T_1, [T_2, T_3] \rangle$ so

$$\begin{split} \frac{d^2}{dt^2} \|T_1\|^2 &= 2\langle \dot{T}_1, [T_2, T_3] \rangle + 2\langle T_1, [\dot{T}_2, T_3] + [T_2, \dot{T}_3] \rangle \\ &= 2\langle \dot{T}_1, [T_2, T_3] \rangle + 2\langle [T_3, T_1], \dot{T}_2 \rangle + 2\langle [T_1, T_2], \dot{T}_3] \rangle \\ &= 2\|[T_2, T_3]\|^2 + 2\|[T_3, T_1]\|^2 + 2\|[T_1, T_2]\|^2. \end{split}$$

Similar statements hold for $||T_2||^2$ and $||T_3||^2$. \square

Lemma 4.4. Let T be a solution to Nahm equations on [0, s). If $\int_0^s ||T_i||^2 dt < \infty$ for some i, then T can be extended past s.

Proof. Let $F: \mathfrak{k}^3 \to \mathfrak{k}^3$, $F(X_1, X_2, X_3) = ([X_2, X_3], [X_3, X_1], [X_1, X_2])$ so that Nahm equations become $\dot{T}(t) = F(T(t))$. We want to show that there exists $t_0 < s$ such that the unique solution to the initial value problem $\dot{S}(t) = F(S(t))$, $S(t_0) = T(t_0)$ exists on $[t_0, t_0 + \varepsilon)$ for some $\varepsilon > s - t_0$. From the existence and uniqueness theorem for first-order systems of ODEs, ε can be taken to be b/M where b > 0 and

$$M = \sup\{||F(X)|| : ||X - T(t_0)|| \le b\};$$

see [CL, Chap.1 (Thm. 2.3 and 5th paragraph of p. 19)]. Note that F is a homogeneous polynomial of degree 2, so there exists C > 0 such that $||F(X)|| \le C||X||^2$ for all $X \in \mathfrak{k}^3$. Hence, $M \le C(||T(t_0)|| + b)^2$ and it suffices to show that there exists $t_0 < s$ and b > 0 such that

$$\frac{b}{C(\|T(t_0)\|+b)^2} > s - t_0.$$
 (5)

We have $\frac{d}{dt}\|T_1\|^2=2\langle T_1,[T_2,T_3]\rangle=2\langle [T_1,T_2],T_3\rangle=\frac{d}{dt}\|T_3\|^2$ and similarly $\frac{d}{dt}\|T_2\|^2=\frac{d}{dt}\|T_1\|^2$, so the maps $\|T_i\|^2$ differ by constants. Hence, since $\int_0^s\|T_i\|^2dt<\infty$ for some i, we also have $\int_0^s\|T\|^2dt<\infty$. Moreover, $\|T\|^2$ is convex (Lemma 4.3) so the fact that $\int_0^s\|T\|^2dt<\infty$ implies that there exists $\delta>0$ such that $\|T(t)\|^2<\frac{1}{s-t}$ for all $t\in(s-\delta,s)$. Let b>C. By taking δ small enough, we may assume that $C(1+b\sqrt{\delta})^2< b$. Then, for all $t_0\in(s-\delta,s)$ we have

$$C(s-t_0)(||T(t_0)||+b)^2 < C(s-t_0)\left(\frac{1}{\sqrt{s-t_0}}+b\right)^2 = C\left(1+b\sqrt{s-t_0}\right)^2 < b$$

and hence (5) follows. \square

Lemma 4.5. The maps f_i for i = 1, 2, 3 are proper.

Proof. We need to show that $f_i^{-1}([0,A])$ is compact for all A > 0. We first show that $f_i^{-1}([0,A])$ is bounded, and then that it is closed in \mathfrak{k}^3 (which does not follow from continuity since the domain W of f_i is open in \mathfrak{k}^3).

Let $\varepsilon > 0$ be such that $S_{\varepsilon} := \{X \in \mathfrak{k}^3 : ||X|| = \varepsilon\} \subseteq W$. Then, $f_i(S_{\varepsilon})$ is compact and hence attains a minimum M > 0. Let $X \in \mathfrak{k}^3$ with $||X|| > \varepsilon$ and write X = sY where $Y \in S_{\varepsilon}$ and s > 1. Then, $T^{sY}(t) = sT^Y(st)$, so

$$f_i(X) = \int_0^1 \|sT_i^Y(st)\|^2 dt = s \int_0^s \|T_i^Y(t)\|^2 dt \ge s \int_0^1 \|T_i^Y(t)\|^2 dt = sf_i(Y) \ge sM.$$

Since $||X|| = s\varepsilon$, we get $||X|| \le \frac{\varepsilon}{M} f_i(X)$ and hence $f_i^{-1}([0, A])$ is bounded for all A > 0.

To show that $f_i^{-1}([0,A])$ is closed in \mathfrak{k}^3 , let $X_n \in W$ be a sequence that converges to some $X \in \mathfrak{k}^3$ and satisfies $f_i(X_n) \leq A$ for all n. Suppose, for contradiction, that $X \notin W$. Since W is star-shaped about 0, we must have $\{t>0: tX \in W\} = (0,s)$ for some s<1. Moreover, $f_i(tX)=t\int_0^t \|T_i^X(u)\|^2 du \to \infty$ as $t\to s$, as otherwise T^X is defined on [0,s] by Lemma 4.4 so $T^{sX}(t)=sT^X(st)$ is defined on [0,1] and hence $sX \in W$. Thus, there exists t< s such that $f_i(tX)>A$. But $tX \in W$, so there exists t>0 such that the open ball $B_r(tX)$ is contained in W and $f_i(Y)>A$ for all $Y \in B_r(tX)$. Let n be such that $X_n \in B_r(X)$. Then, $|tX_n-tX|< tr< r$ so $f_i(tX_n)>A$. But since t<1 we have $f_i(X_n)=\int_0^1 \|T_i^{X_n}(u)\|^2 du \geq t\int_0^t \|T_i^{X_n}(u)\|^2 du = f_i(tX_n)>A$, a contradiction. Thus, $X \in W$ and hence $f_i^{-1}([0,A])$ is closed in \mathfrak{k}^3 . \square

By the isometric SO(3)-action rotating the complex structures, we have proved:

Proposition 4.6. Let I be any element in the 2-sphere of complex structures on T^*G . Then, there is a global Kähler potential for I which is $K \times K$ -invariant, proper, and bounded from below.

We can now prove the relation between $TG/\!\!/\!\!/H$ and $\operatorname{Spec}(\mathbb{C}[\mu_{\mathbb{C}}^{-1}(0)]^{H_{\mathbb{C}}})$:

Proof of Theorem 3.1. Denote by $\mu_{\mathbb{R}}^H$ and $\mu_{\mathbb{R}}^{K \times K}$ the moment maps for H and $K \times K$ on T^*G that we are getting from the Kähler potential F as in Proposition 4.1. Then, $\mu_{\mathbb{R}}^H$ is equal to the composition of $\mu_{\mathbb{R}}^{K \times K}$ with the projection $\mathfrak{k}^* \times \mathfrak{k}^* \to \mathfrak{h}^*$. Moreover, since G is semisimple, so is $K \times K$, and hence moment maps for $K \times K$ are unique. Thus, $\mu_{\mathbb{R}}^H$ must be the same moment map as the one considered in Theorem 3.1. Since F is proper, we can apply Proposition 4.2 to the Kähler quotient $\mu_{\mathbb{R}}^{-1}(0)/H$. The hyperkähler quotient $T^*G/\!\!/\!/H$ is obtained by taking the subspace of $\mu_{\mathbb{R}}^{-1}(0)/H$ given by $\mu_{\mathbb{C}}^{-1}(0) \cap \mu_{\mathbb{R}}^{-1}(0)/H$, so we get the theorem. \square

5. Stratification of $\mathcal{D}(\mathfrak{g})$ into hyperkähler manifolds

5.1. $\mathcal{D}(G)$ depends only on the Lie algebra of G

In this section we prove Theorem 3.2 which says that $\mathcal{D}(G) := T^*G/\!\!/\!/(T_K \times T_K)$ depends only on the Lie algebra \mathfrak{g} of G. This will be used in §5.3 to identify the

strata of $\mathcal{D}(\mathfrak{g}) := \mathcal{D}(G)$ as the top stratum of spaces $\mathcal{D}(\mathfrak{h})$ for some semisimple subalgebras $\mathfrak{h} \subseteq \mathfrak{g}$ (Theorem 3.6).

The first step is the explicit algebraic expression for $\mathcal{D}(G)$ claimed in Proposition 3.4. By Theorem 3.1 we have $\mathcal{D}(G) = \mu_{\mathbb{C}}^{-1}(0)^{\mathrm{ps}}/(T \times T)$ and from (3),

$$\mu_{\mathbb{C}}^{-1}(0) = \{(g, \xi) \in G \times \mathfrak{t}^{\circ} : \operatorname{Ad}_{q}^{*} \xi \in \mathfrak{t}^{\circ}\}.$$

Let \mathcal{O} be a regular semisimple orbit in \mathfrak{g} , say $\mathcal{O} = G \cdot \tau$ for some $\tau \in \mathfrak{t}^{\mathrm{reg}}$. Then, the map $G \to \mathcal{O}$, $g \mapsto \mathrm{Ad}_g \tau$ is a principal T-bundle and the associated vector bundle $G \times_T \mathfrak{t}^{\circ}$ (using the coadjoint action on \mathfrak{t}°) is isomorphic to the cotangent bundle $T^*\mathcal{O}$ via $(g, \xi) \mapsto (\mathrm{Ad}_g \tau, \mathrm{Ad}_g^* \xi)$ (see, e.g., [CG, Lem. 1.4.9]). Thus, we have

$$\mathcal{D}(G) = \{(g, \xi) \in G \times_T \mathfrak{t}^{\circ} : \operatorname{Ad}_q^* \xi \in \mathfrak{t}^{\circ}\}^{\operatorname{ps}}/T = (T^*\mathcal{O} \cap (\mathfrak{g} \times \mathfrak{t}^{\circ}))^{\operatorname{ps}}/T,$$

where T acts on $T^*\mathcal{O} \subseteq \mathfrak{g} \times \mathfrak{g}^*$ by the adjoint and coadjoint actions. Moreover, the action of T on $G \times \mathfrak{t}^\circ$ is free so the $(T \times T)$ -orbit type partition of $\mathcal{D}(G)$ coincides with the T-orbit type partition of $(T^*\mathcal{O} \cap (\mathfrak{g} \times \mathfrak{t}^\circ))^{\mathrm{ps}}/T$. Another way of viewing this is to use reduction in stages [SL, §4] to get $\mathcal{D}(G) = (T^*G/\!/\!/(1 \times T_K))/\!/\!/(T_K \times 1)$ and note that by Theorem 3.1, $T^*G/\!/\!/(1 \times T_K) = G \times_T \mathfrak{t}^\circ = T^*\mathcal{O}$.

We already see that $\mathcal{D}(G)$ depends only on \mathfrak{g} as an algebraic variety since $T^*\mathcal{O}\cap (\mathfrak{g}\times \mathfrak{t}^\circ)$ depends only on \mathfrak{g} and T acts by the adjoint representation. Moreover, we have proved Proposition 3.4. But it remains to show that the hyperkähler structures on the strata are also independent of coverings.

If a group K acts on a set M and $A \subseteq K$, let $M_A := \{p \in M : K_p = A\}$. The following simple observation will be useful here and in §5.3.

Lemma 5.1. Let (M, K, μ) and (N, L, ν) be tri-Hamiltonian spaces, $f: K \to L$ a Lie group homomorphism and $F: M \to N$ an f-equivariant hyperkähler map (isometric, tri-holomorphic and tri-symplectomorphic) which sends $\mu^{-1}(0)$ to $\nu^{-1}(0)$. If K and L act freely, then F descends to a hyperkähler map $\bar{F}: M/\!/\!/K \to N/\!/\!/L$. More generally, if $F(M_A) \subseteq N_B$ for some $A \subseteq K$ and $B \subseteq L$, then the restriction $\bar{F}: (M/\!/\!/K)_{(A)} \to (N/\!/\!/L)_{(B)}$ is a hyperkähler map.


Proof. Suppose first that K and L act freely. Since the three symplectic forms on $M/\!\!/K$ are uniquely characterized by the fact that their pullback to $\mu^{-1}(0)$ are the restrictions of the symplectic forms of M [HKLR, proof of Thm. 3.2] (and similarly for $N/\!\!/L$), it is immediate that \bar{F} is a symplectomorphism for each of them. A hyperkähler structure is uniquely determined by its metric and three symplectic forms, so it suffices to show that \bar{F} is an isometry. Let g be the metric on M and $\pi:\mu^{-1}(0)\to\mu^{-1}(0)/K$ the quotient map. Then, π is a principal K-bundle and the metric \bar{g} on $\mu^{-1}(0)/K$ is uniquely determined by $\pi^*\bar{g}(u,v)=g(u,v)$ for all horizontal tangent vectors u,v on $\mu^{-1}(0)$. A similar statement holds for the metric \bar{h} on $N/\!\!/L$. Since F is an isometry and is f-equivariant, it follows that \bar{F} maps horizontal vectors of $\mu^{-1}(0)$ to horizontal vectors of $\nu^{-1}(0)$. Let $\rho:\nu^{-1}(0)\to\nu^{-1}(0)/L$ be the quotient map. Then, for all horizontal vectors u,v on $\mu^{-1}(0)$, we have $\pi^*(\bar{F}^*\bar{h})(u,v)=F^*\rho^*\bar{h}(u,v)=\rho^*\bar{h}(dF(u),dF(v))=h(dF(u),dF(v))=g(u,v)$, so $\bar{F}^*\bar{h}=\bar{g}$.

Now suppose that $F(M_A) \subseteq N_B$ for some $A \subseteq K$ and $B \subseteq L$. Recall from [DS2, §2] that M_A is a hyperkähler submanifold of M on which $N_G(A)/A$ acts freely and

 $(M_A, N_G(A)/A, \mu|_{M_A})$ is a tri-Hamiltonian space. The hyperkähler structure on $(M/\!\!/\!/K)_{(A)} = \mu^{-1}(0)_{(A)}/K$ is given by identifying this space with $M_A/\!\!/\!/(N_G(A)/A)$. Thus, we may repeat the argument above with M and N replaced by M_A and N_B . \square

We can now prove Theorem 3.2. The idea is to use Lemma 5.1 on the covering $T^*\tilde{G} \to T^*G$ and show that the map $\mathcal{D}(\tilde{G}) \to \mathcal{D}(G)$ that it induces is a homeomorphism preserving the stratifications.

Proof of Theorem 3.2. Let $\pi: \tilde{G} \to G$ be the covering map and \tilde{K} , K maximal compact subgroups of \tilde{G} and G respectively with the same Lie algebra $\mathfrak{k} \subseteq \mathfrak{g}$. Then, the map $F: \tilde{G} \times \mathfrak{g} \to G \times \mathfrak{g}$, $(g,X) \mapsto (\pi(g),X)$ is hyperkähler since it descends from the identity map on the space of solutions to Nahm equations on \mathfrak{k} (see the description of Kronheimer [K]). Let $T_{\tilde{K}}$ and T_K be maximal tori in \tilde{K} and K respectively, with the same Lie algebra $\mathfrak{t}_{\mathfrak{k}} \subseteq \mathfrak{k}$. Then, F is equivariant with respect to the covering $T_{\tilde{K}} \times T_{\tilde{K}} \to T_K \times T_K$. Moreover, if $\tilde{\mu}$ and μ are the moment maps for the actions of $T_{\tilde{K}} \times T_{\tilde{K}}$ and $T_K \times T_K$ respectively, then $\mu \circ F = \tilde{\mu}$ so F maps $\tilde{\mu}^{-1}(0)$ to $\mu^{-1}(0)$. Thus, Lemma 5.1 ensures that F descends to a continuous map $\tilde{F}: \mathcal{D}(\tilde{G}) \to \mathcal{D}(G)$ which is hyperkähler on the strata that it preserves. But, the diagram



commutes, where the vertical and bottom maps are homeomorphisms preserving the orbit type partition, so \bar{F} is also a homeomorphism preserving the orbit type partition. By Lemma 5.1, \bar{F} restricts to hyperkähler maps on the strata, and since they are also homeomorphisms, they are hyperkähler isomorphisms. \Box

We may now use the notation $\mathcal{D}(\mathfrak{g})$ instead of $\mathcal{D}(G)$.

5.2. Stratification poset

Recall that the relation $S \leq T$ if $S \subseteq \overline{T}$ on a partition \mathcal{P} of a topological space is a partial order whenever the elements of \mathcal{P} are locally closed. In particular, this holds for the orbit type partition of $\mathcal{D}(\mathfrak{g})$. To prove that this partition also satisfies the frontier condition (and hence is a stratification), we will first prove Theorem 3.5 identifying the poset of strata with the poset of root subsystems. The frontier condition will then be an easy consequence of this identification.

By Proposition 3.4, the $(T_K \times T_K)$ -orbit type decomposition of $\mathcal{D}(\mathfrak{g})$ is the same as the T-orbit type decomposition of $(T^*\mathcal{O} \cap (\mathfrak{g} \times \mathfrak{t}^{\circ}))^{\mathrm{ps}}/T$. It will be convenient to identify \mathfrak{g}^* with \mathfrak{g} using the non-degenerate invariant bilinear form, and hence \mathfrak{t}° with $\mathfrak{t}^{\perp} \subseteq \mathfrak{g}$. Then, $\mathcal{D}(\mathfrak{g}) = (T\mathcal{O} \cap (\mathfrak{g} \times \mathfrak{t}^{\perp}))^{\mathrm{ps}}/T$, where T acts by the adjoint action on both factors. Thus, the orbit type partition of $\mathcal{D}(\mathfrak{g})$ is of the form $\mathcal{P} = \{\mathcal{D}(\mathfrak{g})_Z : Z \in \mathcal{I}\}$ for some collection \mathcal{I} of closed subgroups of T (where $\mathcal{D}(\mathfrak{g})_Z = (T\mathcal{O} \cap (\mathfrak{g} \times \mathfrak{t}^{\perp})_Z^{\mathrm{ps}}/T)$. Our first objective is to identify the collection \mathcal{I} precisely. Let Φ be the root system of \mathfrak{g} with respect to \mathfrak{t} . We use the same notation as in (4) for Z_{Ψ} and $\mathcal{D}(\mathfrak{g})_{\Psi}$.

Lemma 5.2. The stabilizer subgroup of $(X,Y) \in \mathfrak{g} \times \mathfrak{g}$ under the adjoint T-action is $Z_{\Phi(X,Y)}$, where

$$\Phi(X,Y) = \Phi \cap \operatorname{span}_{\mathbb{Z}} \{ \alpha \in \Phi : (X_{\alpha}, Y_{\alpha}) \neq (0,0) \}.$$

Moreover, $\Phi(X,Y)$ is a root subsystem of Φ .

Proof. Let $\Phi'(X,Y) = \{\alpha \in \Phi : (X_{\alpha},Y_{\alpha}) \neq (0,0)\}$. The weights spaces for the action of T on $\mathfrak{g} \times \mathfrak{g}$ are $\mathfrak{g}_{\alpha} \times \mathfrak{g}_{\alpha}$ for $\alpha \in \Phi \cup \{0\}$. Thus, t fixes (X,Y) if and only if $t \in Z_{\Phi'(X,Y)}$, so we want to show that $Z_{\Phi'(X,Y)} = Z_{\Phi(X,Y)}$. Since $\Phi'(X,Y) \subseteq \Phi(X,Y)$ we have $Z_{\Phi(X,Y)} \subseteq Z_{\Phi'(X,Y)}$. Conversely, let $t \in Z_{\Phi'(X,Y)}$ and $\beta \in \Phi(X,Y)$. Then, $\beta = \sum_{\alpha \in \Phi'(X,Y)} n_{\alpha} \alpha$ for some $n_{\alpha} \in \mathbb{Z}$, so $\beta(t) = \prod_{\alpha \in \Phi'(X,Y)} \alpha(t)^{n_{\alpha}} = 1$.

Any set of the form $\Phi \cap \operatorname{span}_{\mathbb{Z}} \Psi$ for some subset $\Psi \subseteq \Phi$ is a root subsystem, so $\Phi(X,Y)$ is a root subsystem. \square

This means that there is some collection \mathcal{J} of root subsystems of Φ such that the orbit type partition is $\mathcal{P} = \{\mathcal{D}(\mathfrak{g})_{\Psi} : \Psi \in \mathcal{J}\}$. The next lemma shows that \mathcal{J} is, in fact, the set of *all* root subsystems of Φ .

Lemma 5.3. $\mathcal{D}(\mathfrak{g})_{\Psi} \neq \emptyset$ for any root subsystem $\Psi \leq \Phi$.

Proof. Take $0 \neq X_{\alpha} \in \mathfrak{g}_{\alpha}$ for all $\alpha \in \Psi$ and let $X = \sum_{\alpha \in \Psi} X_{\alpha}$. Then, $(\tau, X) \in (T\mathcal{O} \cap (\mathfrak{g} \times \mathfrak{t}^{\perp}))$. Recall that a point is polystable if and only if 0 is in the interior of the convex hull of its set of weights [PV, Prop. 6.15]. Thus, (τ, X) is polystable since its set of weights is precisely $\Psi \cup \{0\}$ and we have $\alpha \in \Psi \iff -\alpha \in \Psi$. Moreover, $\Phi(\tau, X) = \Phi \cap \operatorname{span}_{\mathbb{Z}} \Psi = \Psi$, so $(\tau, X) \in (T\mathcal{O} \cap (\mathfrak{g} \times \mathfrak{t}^{\perp}))_{Z_{\Psi}}^{\operatorname{ps}}/T = \mathcal{D}(\mathfrak{g})_{\Psi}$. \square

In other words, we have shown that the map $\Psi \mapsto \mathcal{D}(\mathfrak{g})_{\Psi}$ in Theorem 3.5 is surjective. The next lemma shows that it is injective.

Lemma 5.4. Let Ψ_1 and Ψ_2 be two root subsystems. Then, $\mathcal{D}(\mathfrak{g})_{\Psi_1} = \mathcal{D}(\mathfrak{g})_{\Psi_2}$ if and only if $\Psi_1 = \Psi_2$.

Proof. The only non-trivial part is to show that if $Z_{\Psi_1} = Z_{\Psi_2}$ then $\Psi_1 = \Psi_2$. It suffices to show that if Ψ is a root subsystem and $\alpha \in \Phi$ is such that $\alpha(t) = 1$ for all $t \in Z_{\Psi}$, then $\alpha \in \Psi$. By viewing α as an element of \mathfrak{t}^* , we want to show that if $\alpha(H) \in 2\pi i \mathbb{Z}$ for all $H \in \mathfrak{t}$ such that $\{\beta(H) : \beta \in \Psi\} \subseteq 2\pi i \mathbb{Z}$, then $\alpha \in \Psi$. Let $\beta_1, \ldots, \beta_k \in \Psi$ be a set of simple roots and complete it to a basis $\{\beta_1, \ldots, \beta_n\}$ for \mathfrak{t}^* . Let H_1, \ldots, H_n be the dual basis in \mathfrak{t} . Then, $\alpha = a_1\beta_1 + \cdots + a_n\beta_n$ and since $\beta_i(2\pi i H_j) \in 2\pi i \mathbb{Z}$, the assumption on α implies that $2\pi i a_j = \alpha(2\pi i H_j) \in 2\pi i \mathbb{Z}$ so $a_j \in \mathbb{Z}$. Moreover, for all $H \in \operatorname{span}\{H_{k+1}, \ldots, H_n\}$ we have $\beta(H) = 0$ for all $\beta \in \Psi$, so $\alpha(H) = (a_{k+1}\beta_{k+1} + \cdots + a_n\beta_n)(H) \in 2\pi i \mathbb{Z}$. Thus, $a_{k+1}\beta_{k+1} + \cdots + a_n\beta_n = 0$ and hence $\alpha \in (\operatorname{span}_{\mathbb{Z}} \Psi) \cap \Phi = \Psi$. \square

Thus, $\Psi \mapsto \mathcal{D}(\mathfrak{g})_{\Psi}$ is a bijection from the set of root subsystems of Φ to the set of orbit type strata of $\mathcal{D}(\mathfrak{g})$. It remains to show that it is an isomorphism of posets. The crucial ingredient is the following result:

Proposition 5.5. For all $\Psi \leq \Phi$ we have

$$\overline{\mathcal{D}(\mathfrak{g})_{\Psi}} = \bigcup_{\chi \leq \Psi} \mathcal{D}(\mathfrak{g})_{\chi}.$$

Moreover, $\mathcal{D}(\mathfrak{g})_{\Psi}$ is also the Zariski-closure of $\mathcal{D}(\mathfrak{g})_{\Psi}$, and $\mathcal{D}(\mathfrak{g})_{\Psi}$ is Zariski-locally-closed.

Proof. Let $\mathfrak{g}'_{\Psi} = \mathfrak{t} \oplus \bigoplus_{\alpha \in \Psi} \mathfrak{g}_{\alpha}$ (which is slightly different than the \mathfrak{g}_{Ψ} defined in §2.2), $M = T\mathcal{O} \cap (\mathfrak{g} \times \mathfrak{t}^{\perp})$ and $M_{\Psi} = M \cap (\mathfrak{g}'_{\Psi} \times \mathfrak{g}'_{\Psi})$. We claim that $M_{Z_{\Psi}} \subseteq M_{\Psi}$. Indeed, if $(X,Y) \in M_{Z_{\Psi}}$ then by Lemma 5.2, $Z_{\Psi} = Z_{\Phi(X,Y)}$ and by the proof of Lemma 5.4 this implies $\Psi = \Phi(X,Y)$. Thus, $\{\alpha \in \Phi : (X_{\alpha},Y_{\alpha}) \neq (0,0)\} \subseteq \Psi$, so $(X,Y) \in M_{\Psi}$. Hence, $\mathcal{D}(\mathfrak{g})_{\Psi} = M_{Z_{\Psi}}^{\mathrm{ps}}/T = (M_{\Psi})_{Z_{\Psi}}^{\mathrm{ps}}/T$. Moreover, $(M_{\Psi})_{Z_{\Psi}}^{\mathrm{ps}}$ is Zariski-open in M_{Ψ} since $(M_{\Psi})_{Z_{\Psi}}^{\mathrm{ps}} = (M_{\Psi})^{\mathrm{s}} \cap (M_{\Psi})_{Z_{\Psi}}$, where $(M_{\Psi})^{\mathrm{s}}$ is the set of stable points (which is always Zariski-open) and Z_{Ψ} is the kernel of the action of T on M_{Ψ} so $(M_{\Psi})_{Z_{\Psi}}$ is Zariski-open in M_{Ψ} (see [PV, Prop. 7.2]). Hence, $\overline{\mathcal{D}}(\mathfrak{g})_{\Psi} = M_{\Psi}^{\mathrm{ps}}/T = \mathrm{Spec}(\mathbb{C}[M_{\Psi}]^T)$ is Zariski-closed in $\mathcal{D}(\mathfrak{g})$, and so $\overline{\mathcal{D}(\mathfrak{g})_{\Psi}}$ is the Zariski-closure of $\mathcal{D}(\mathfrak{g})_{\Psi}$. Since $(M_{\Psi})_{Z_{\Psi}}^{\mathrm{ps}}$ is Zariski-open in M_{Ψ} , so is its image in M_{Ψ}^{ps}/T , so $\mathcal{D}(\mathfrak{g})_{\Psi}$ is Zariski-locally-closed. Now, by decomposing M_{Ψ}^{ps}/T by T-orbit types, we get

$$\overline{\mathcal{D}(\mathfrak{g})_{\Psi}} = \bigcup_{\chi \leq \Psi} (M_{\Psi})_{Z_{\chi}}^{\mathrm{ps}} / T = \bigcup_{\chi \leq \Psi} M_{Z_{\chi}}^{\mathrm{ps}} / T = \bigcup_{\chi \leq \Psi} \mathcal{D}(\mathfrak{g})_{\chi}. \qquad \Box$$

In particular, this proposition shows that $\Psi_1 \leq \Psi_2$ if and only if $\mathcal{D}(\mathfrak{g})_{\Psi_1} \leq \mathcal{D}(\mathfrak{g})_{\Psi_2}$, so the map $\Psi \mapsto \mathcal{D}(\mathfrak{g})_{\Psi}$ is an isomorphism of posets, and we have proved Theorem 3.5. Moreover, it now follows easily that the partition is a stratification:

Proof of Theorem 3.3. In general, the orbit type decomposition of a hyperkähler quotient satisfies the manifold and local conditions, so it suffices to show frontier condition. Suppose that $\mathcal{D}(\mathfrak{g})_{\Psi_1} \cap \overline{\mathcal{D}(\mathfrak{g})_{\Psi_2}} \neq \emptyset$ for some $\Psi_1, \Psi_2 \leq \Phi$. By Proposition 5.5, this implies $\mathcal{D}(\mathfrak{g})_{\Psi_1} \cap \mathcal{D}(\mathfrak{g})_{\chi} \neq \emptyset$ for some $\chi \leq \Psi_2$, and hence $\mathcal{D}(\mathfrak{g})_{\Psi_1} = \mathcal{D}(\mathfrak{g})_{\chi}$. By Lemma 5.4, we get $\Psi_1 = \chi$ so $\mathcal{D}(\mathfrak{g})_{\Psi_1} \subseteq \overline{\mathcal{D}(\mathfrak{g})_{\Psi_2}}$.

5.3. Description of the strata

Now that we know that the orbit type partition of $\mathcal{D}(\mathfrak{g})$ is of the form $\{\mathcal{D}(\mathfrak{g})_{\Psi} : \Psi \leq \Phi\}$, our next goal is to describe the strata $\mathcal{D}(\mathfrak{g})_{\Psi}$ individually.

First note that since Φ is a greatest element in the poset of root subsystems, $\mathcal{D}(\mathfrak{g})_{\Phi}$ is dense in $\mathcal{D}(\mathfrak{g})$. We denote this top stratum by $\mathcal{D}(\mathfrak{g})_{\text{top}} := \mathcal{D}(\mathfrak{g})_{\Phi}$.

Proposition 5.6. The stratum $\mathcal{D}(\mathfrak{g})_{top}$ is Zariski-open, connected, and of real dimension $4(\dim \mathfrak{g} - 2 \operatorname{rk} \mathfrak{g})$.

Proof. By Proposition 5.5, $\mathcal{D}(\mathfrak{g})_{\text{top}}$ is Zariski-locally-closed in $\mathcal{D}(\mathfrak{g})$. But its Zariski-closure is the same as its standard closure which is $\mathcal{D}(\mathfrak{g})$, so $\mathcal{D}(\mathfrak{g})_{\text{top}}$ is Zariski-open in $\mathcal{D}(\mathfrak{g})$. Since $\mathcal{D}(\mathfrak{g})$ is a GIT quotient of the connected space $T\mathcal{O}\cap(\mathfrak{g}\times\mathfrak{t}^{\perp})$, it is connected. Thus, $\mathcal{D}(\mathfrak{g})_{\text{top}}$ is connected since it is Zariski-open in $\mathcal{D}(\mathfrak{g})$. The set of stable points of $T\mathcal{O}\cap(\mathfrak{g}\times\mathfrak{t}^{\perp})$ is non-empty (for example, it contains (τ,X) if $X_{\alpha}\neq 0$ for all $\alpha\in\Phi$), so the complex algebraic dimension of $\mathcal{D}(\mathfrak{g})$ is $\dim_{\mathbb{C}}(T\mathcal{O}\cap\mathfrak{g})$

 $(\mathfrak{g} \times \mathfrak{t}^{\perp}))$ - rk \mathfrak{g} . Moreover, the smooth map $T\mathcal{O} \to \mathfrak{t}$, $(X,Y) \mapsto \pi_{\mathfrak{t}}(Y)$ (where $\pi_{\mathfrak{t}}$ is the orthogonal projection $\mathfrak{g} \to \mathfrak{t}$) has full rank at a generic point, so

$$\dim_{\mathbb{C}}(T\mathcal{O}\cap(\mathfrak{g}\times\mathfrak{t}^{\perp}))=\dim_{\mathbb{C}}(T\mathcal{O})-\mathrm{rk}\,\mathfrak{g}=2\dim\mathfrak{g}-3\,\mathrm{rk}\,\mathfrak{g},$$

and hence $\dim_{\mathbb{C}} \mathcal{D}(\mathfrak{g}) = 2 \dim \mathfrak{g} - 4 \operatorname{rk} \mathfrak{g}$. Since $\mathcal{D}(\mathfrak{g})_{\operatorname{top}}$ is open in $\mathcal{D}(\mathfrak{g})$, it has the same complex dimension. \square

Let Ψ be a root subsystem of Φ , W_{Ψ} be the Weyl group of Ψ , and $|W_{\Phi}:W_{\Psi}|$ the index of W_{Ψ} in W_{Φ} . The rest of this section is devoted to the proof that $\mathcal{D}(\mathfrak{g})_{\Psi}$ is a disjoint union of $|W_{\Phi}:W_{\Psi}|$ copies of $\mathcal{D}(\mathfrak{g}_{\Psi})_{\text{top}}$ (Theorem 3.6).

Lemma 5.7. The connected subgroup G_{Ψ} of G with Lie algebra \mathfrak{g}_{Ψ} is closed and has a compact real form $K_{\Psi} \subseteq K$.

Proof. Since the Killing form of \mathfrak{g} remains nondegenerate on \mathfrak{g}_{Ψ} (Proposition 2.2) we have $\mathfrak{g} = \mathfrak{g}_{\Psi} \oplus \mathfrak{g}_{\Psi}^{\perp}$ and it follows that $\mathfrak{g}_{\Psi} = (\mathfrak{k}_{\Psi})_{\mathbb{C}}$ where $\mathfrak{k}_{\Psi} = \mathfrak{g}_{\Psi} \cap \mathfrak{k}$. Moreover, semisimple subgroups of compact Lie groups are closed, so the connected subgroup K_{Ψ} of K with Lie algebra \mathfrak{k}_{Ψ} is closed. Hence, $G_{\Psi} := (K_{\Psi})_{\mathbb{C}}$ is a closed connected subgroup of G with Lie algebra \mathfrak{g}_{Ψ} . \square

Recall that \mathfrak{t}_{Ψ} is the span of the coroots of Ψ and is a Cartan subalgebra of \mathfrak{g}_{Ψ} . Let $\mathfrak{z}_{\Psi} = \operatorname{Lie}(Z_{\Psi}) = \{h \in \mathfrak{t} : \alpha(h) = 0, \forall \alpha \in \Psi\}$ so that $\mathfrak{t} = \mathfrak{z}_{\Psi} \oplus \mathfrak{t}_{\Psi}$. Then, $\mathfrak{z}_{\Psi} \oplus \mathfrak{g}_{\Psi} = \mathfrak{t} \oplus \bigoplus_{\alpha \in \Psi} \mathfrak{g}_{\alpha}$ and is a reductive Lie algebra with semisimple factor \mathfrak{g}_{Ψ} .

Lemma 5.8. The intersection $\mathcal{O} \cap (\mathfrak{z}_{\Psi} \oplus \mathfrak{g}_{\Psi})$ has $|W_{\Phi}: W_{\Psi}|$ connected components, each of the form $\zeta + \mathcal{O}_{\Psi}$ for some $\zeta \in \mathfrak{z}_{\Psi}$ and \mathcal{O}_{Ψ} a regular semisimple G_{Ψ} -orbit in \mathfrak{g}_{Ψ} .

Proof. Since $\mathcal{O} \cap (\mathfrak{z}_{\Psi} \oplus \mathfrak{g}_{\Psi})$ is G_{Ψ} -invariant, it is a union of G_{Ψ} -orbits. But G_{Ψ} acts trivially on \mathfrak{z}_{Ψ} , so they are of the form $\zeta + \mathcal{O}_{\Psi}$ where $\zeta \in \mathfrak{z}_{\Psi}$ and \mathcal{O}_{Ψ} is a regular semisimple G_{Ψ} -orbit in \mathfrak{g}_{Ψ} . From the classification of semisimple orbits [CM, §2.2], \mathcal{O}_{Ψ} intersects \mathfrak{t}_{Ψ} in precisely $|W_{\Psi}|$ elements. Hence $(\zeta + \mathcal{O}_{\Psi}) \cap \mathfrak{t}$ contains exactly $|W_{\Psi}|$ elements. But $(\mathcal{O} \cap (\mathfrak{z}_{\Psi} \oplus \mathfrak{g}_{\Psi})) \cap \mathfrak{t} = \mathcal{O} \cap \mathfrak{t}$ contains exactly $|W_{\Phi}|$ elements, so there must be exactly $|W_{\Phi}|/|W_{\Psi}| = |W_{\Phi} : W_{\Psi}|$ of these G_{Ψ} -orbits. Moreover, semisimple orbits are closed, so $\zeta + \mathcal{O}_{\Psi}$ is closed in $\mathcal{O} \cap (\mathfrak{z}_{\Psi} \oplus \mathfrak{g}_{\Psi})$. Since there are only finitely many of them, they are also open in $\mathcal{O} \cap (\mathfrak{z}_{\Psi} \oplus \mathfrak{g}_{\Psi})$, and hence they are the connected components. \square

Proposition 5.9. For all $\Psi \leq \Phi$, $\mathcal{D}(\mathfrak{g})_{\Psi}$ is isomorphic as a hyperkähler manifold to a disjoint union of $|W_{\Phi}:W_{\Psi}|$ copies of $\mathcal{D}(\mathfrak{g}_{\Psi})_{\text{top}}$.

Proof. Let $T_{K_{\Psi}}$ be the maximal torus in K_{Ψ} with Lie algebra $\mathfrak{t}_{\Psi} \cap \mathfrak{k}$ and $T_{\Psi} = (T_{K_{\Psi}})_{\mathbb{C}}$ the maximal torus in G_{Ψ} with Lie algebra \mathfrak{t}_{Ψ} . Recall from the proof of Proposition 5.5 that $\mathcal{D}(\mathfrak{g})_{\Psi} = (M_{\Psi})_{Z_{\Psi}}^{\mathrm{ps}}/T$, where $M = T\mathcal{O} \cap (\mathfrak{g} \times \mathfrak{t}^{\perp})$ and $M_{\Psi} = M \cap ((\mathfrak{z}_{\Psi} \oplus \mathfrak{g}_{\Psi}) \times (\mathfrak{z}_{\Psi} \oplus \mathfrak{g}_{\Psi}))$. Thus, by Lemma 5.8, $\mathcal{D}(\mathfrak{g})_{\Psi}$ is a disjoint union of sets of the form $(T(\zeta + \mathcal{O}_{\Psi}) \cap (\mathfrak{g} \times \mathfrak{t}^{\perp}))_{Z_{\Psi}}^{\mathrm{ps}}/T$ for $\zeta \in \mathfrak{z}_{\Psi}$ and $\mathcal{O}_{\Psi} \subseteq \mathfrak{g}_{\Psi}$. These sets are homeomorphic to the top stratum $\mathcal{D}(\mathfrak{g}_{\Psi})_{\mathrm{top}} = (T\mathcal{O}_{\Psi} \cap (\mathfrak{g}_{\Psi} \times \mathfrak{t}_{\Psi}^{\perp}))_{Z_{\Psi} \cap T_{\Psi}}^{\mathrm{ps}}/T_{\Psi}$ via the map $(X, Y) \mapsto (\zeta + X, Y)$, and hence it suffices to show this map is hyperkähler. We will show that it descends from a hyperkähler map $T^*G_{\Psi} \to T^*G$ and conclude that it is hyperkähler by Lemma 5.1.

Since \mathcal{O}_{Ψ} is semisimple, we have $\mathcal{O}_{\Psi} = G_{\Psi} \cdot h$ for some $h \in \mathfrak{t}_{\Psi}$. Thus, $\zeta + h \in (\zeta + \mathcal{O}_{\Psi}) \cap \mathfrak{t} \subseteq \mathcal{O} \cap \mathfrak{t}$ and hence $\zeta + h = w \cdot \tau$ for some $w \in W$. Let $k \in N_K(T_K)$ be a representative of w. Then, the composition

$$F: G_{\Psi} \times \mathfrak{g}_{\Psi} \hookrightarrow G \times \mathfrak{g} \to G \times \mathfrak{g}, \quad (g, X) \mapsto (gk, \operatorname{Ad}_{k^{-1}} X)$$

is hyperkähler since this is just the action of $(1, k^{-1}) \in K \times K$. Moreover, it is equivariant with respect to the Lie group homomorphism $T_{K_{\Psi}} \times T_{K_{\Psi}} \to T_K \times T_K$, $(s,t) \mapsto (s,k^{-1}tk)$ and maps the zero level set of the moment for $T_{K_{\Psi}} \times T_{K_{\Psi}}$ to that of $T_K \times T_K$. Therefore, Lemma 5.1 applies and we get a continuous map $\bar{F}: \mathcal{D}(\mathfrak{g}_{\Psi}) \to \mathcal{D}(\mathfrak{g})$ which is hyperkähler on the strata that it preserves. For all $g \in G_{\Psi}$ we have $\zeta + \mathrm{Ad}_g h = \mathrm{Ad}_g(\zeta + h) = \mathrm{Ad}_{gk} \tau$, so the diagram

$$T^*G_{\Psi}/\!\!/\!/(T_{K_{\Psi}} \times T_{K_{\Psi}}) \xrightarrow{\bar{F}} T^*G/\!\!/\!/(T_K \times T_K)$$

$$\downarrow \cong \qquad \qquad \downarrow \cong$$

$$(T\mathcal{O}_{\Psi} \cap (\mathfrak{g}_{\Psi} \times \mathfrak{t}_{\Psi}^{\perp}))^{\mathrm{ps}}/T_{\Psi} \longrightarrow (T\mathcal{O} \cap (\mathfrak{g} \times \mathfrak{t}^{\perp}))^{\mathrm{ps}}/T$$

commutes, where the bottom map is $(\operatorname{Ad}_g h, \operatorname{Ad}_g X) \mapsto (\zeta + \operatorname{Ad}_g h, \operatorname{Ad}_g X)$ and the vertical maps are the usual homeomorphism as in Proposition 3.4. The restriction of the bottom map to $\mathcal{D}(\mathfrak{g}_{\Psi})_{\text{top}}$ is the map considered earlier, and hence $\mathcal{D}(\mathfrak{g}_{\Psi})_{\text{top}}$ is hyperkähler isomorphic to the connected components of $\mathcal{D}(\mathfrak{g})_{\Psi}$ corresponding to $\zeta + \mathcal{O}_{\Psi}$. \square

Corollary 5.10. The stratum $\mathcal{D}(\mathfrak{g})_{\mathrm{bottom}} := \mathcal{D}(\mathfrak{g})_{\varnothing}$ is a finite set of $|W_{\Phi}|$ elements.

Proof. By Proposition 5.9, $\mathcal{D}(\mathfrak{g})_{\text{bottom}}$ is a disjoint union of $|W_{\Phi}|$ copies of $\mathcal{D}(\mathfrak{g}_{\varnothing})_{\text{top}} = \mathcal{D}(0)_{\text{top}}$, and $\mathcal{D}(0)_{\text{top}}$ is just a point by Proposition 5.6. \square

Proposition 5.6, Proposition 5.9 and Corollary 5.10 together prove Theorem 3.6.

5.4. A coarser stratification

The goal of this section is to prove Theorem 3.7 about the coarser partition $\mathcal{P} = \{\mathcal{D}(\mathfrak{g})_{[\mathfrak{h}]} : [\mathfrak{h}] \in \mathcal{C}_{\mathfrak{g}}\}$. Let $[\mathfrak{h}] = [\mathfrak{g}_{\Psi}] \in \mathcal{C}_{\mathfrak{g}}$ where $\Psi \leq \Phi$. Then, by Proposition 2.3, we have

$$\mathcal{D}(\mathfrak{g})_{[\mathfrak{g}_{\Psi}]} = igcup_{w \in W_{oldsymbol{\Phi}}} \mathcal{D}(\mathfrak{g})_{w \cdot \Psi}.$$

Let $\{w \cdot \Psi : w \in W_{\Phi}\} = \{w_1 \cdot \Psi, \dots, w_n \cdot \Psi\}$, where the $w_i \cdot \Psi$'s are distinct. Then, $n|W_{\Phi}: W_{\Psi}|$ is the embedding number $m_{\mathfrak{g}}(\mathfrak{g}_{\Psi})$ introduced in §2.2, and

$$\mathcal{D}(\mathfrak{g})_{[\mathfrak{g}_{\Psi}]} = \bigcup_{i=1}^{n} \mathcal{D}(\mathfrak{g})_{w_{i} \cdot \Psi}.$$

Lemma 5.11. The above union is a topological disjoint union.

Proof. It suffices to show that if $u, v \in W_{\Phi}$ and $\overline{\mathcal{D}(\mathfrak{g})_{u \cdot \Psi}} \cap \mathcal{D}(\mathfrak{g})_{v \cdot \Psi} \neq \emptyset$ then $u \cdot \Psi = v \cdot \Psi$. By Proposition 5.5, we have

$$\overline{\mathcal{D}(\mathfrak{g})_{u\cdot\Psi}}\cap\mathcal{D}(\mathfrak{g})_{v\cdot\Psi}=\bigcup_{\chi\leq u\cdot\Psi}\mathcal{D}(\mathfrak{g})_{\chi}\cap\mathcal{D}(\mathfrak{g})_{v\cdot\Psi},$$

so there exists $\chi \leq u \cdot \Psi$ such that $\mathcal{D}(\mathfrak{g})_{\chi} \cap \mathcal{D}(\mathfrak{g})_{v \cdot \Psi} \neq \emptyset$. Hence, $v \cdot \Psi = \chi \subseteq u \cdot \Psi$ so $v \cdot \Psi = u \cdot \Psi$. \square

In particular, Lemma 5.11 says that each piece $\mathcal{D}(\mathfrak{g})_{[\mathfrak{h}]}$ in \mathcal{P} is a topological manifold and is locally closed. Moreover, by combining with Proposition 5.9, we get that $\mathcal{D}(\mathfrak{g})_{[\mathfrak{h}]}$ has $m_{\mathfrak{g}}(\mathfrak{h})$ connected components, each isomorphic to $\mathcal{D}(\mathfrak{h})_{\text{top}}$ as a hyperkähler manifold. Now, recall that $\mathcal{C}_{\mathfrak{g}}$ has a partial order \leq induced by inclusion.

Lemma 5.12. For all $[\mathfrak{h}] \in \mathcal{C}_{\mathfrak{g}}$, we have

$$\overline{\mathcal{D}(\mathfrak{g})_{[\mathfrak{h}]}} = \bigcup_{[\mathfrak{q}] \leq [\mathfrak{h}]} \mathcal{D}(\mathfrak{g})_{[\mathfrak{q}]}.$$

Proof. Let Ψ be such that $[\mathfrak{h}] = [\mathfrak{g}_{\Psi}]$. If we let $[\Psi]$ be the equivalence class of Ψ in {root subsystems of Φ }/ W_{Φ} , we get

$$\begin{split} \overline{\mathcal{D}(\mathfrak{g})_{[\mathfrak{g}_{\Psi}]}} &= \bigcup_{w \in W} \overline{\mathcal{D}(\mathfrak{g})_{w \cdot \Psi}} = \bigcup_{w \in W} \bigcup_{\chi \leq w \cdot \Psi} \mathcal{D}(\mathfrak{g})_{\chi} = \bigcup_{[\chi] \leq [\Psi]} \bigcup_{w \in W} \mathcal{D}(\mathfrak{g})_{w \cdot \chi} \\ &= \bigcup_{[\chi] \leq [\Psi]} \mathcal{D}(\mathfrak{g})_{[\mathfrak{g}_{\chi}]} = \bigcup_{[\mathfrak{q}] \leq [\mathfrak{h}]} \mathcal{D}(\mathfrak{g})_{[\mathfrak{q}]}. \end{split}$$

It is then immediate that $[\mathfrak{h}_1] \leq [\mathfrak{h}_2]$ if and only if $\mathcal{D}(\mathfrak{g})_{[\mathfrak{h}_1]} \leq \mathcal{D}(\mathfrak{g})_{[\mathfrak{h}_2]}$, so the map $\mathcal{C}_{\mathfrak{g}} \to \mathcal{P}$, $[\mathfrak{h}] \mapsto \mathcal{D}(\mathfrak{g})_{[\mathfrak{h}]}$ is an isomorphism of posets. Moreover, the frontier condition now follows easily as in §5.2. This concludes the proof of Theorem 3.7.

6. Examples

In this section we look at specific examples of $\mathcal{D}(\mathfrak{g})$ and describe their stratification into hyperkähler manifolds explicitly. We will focus on the coarser stratification whose set of strata is isomorphic to the partially ordered set $\mathcal{C}_{\mathfrak{g}}$ of conjugacy classes of regular semisimple subalgebras (Theorem 3.7). We will draw Hasse diagrams where each node is of the form mL where L is the Lie algebra isomorphism class of a conjugacy class $[\mathfrak{h}] \in \mathcal{C}_{\mathfrak{g}}$ and m its embedding number. In other words, a node of the form mL in the Hasse diagram represents a stratum which is isomorphic as a hyperkähler manifold to a disjoint union of m copies of $\mathcal{D}(L)_{\text{top}}$. We write isomorphism classes of Lie algebras multiplicatively, e.g., $L = \mathsf{A}_1^2\mathsf{B}_2$ is $\mathfrak{sl}(2,\mathbb{C}) \oplus \mathfrak{so}(5,\mathbb{C})$.

6.1. $\mathfrak{sl}(2,\mathbb{C})$

The root system Φ of $\mathfrak{sl}(2,\mathbb{C})$ embeds in \mathbb{R}^2 as:

Thus, the root subsystems are just Φ itself and the empty set. They both determine a conjugacy class in $\mathcal{C}_{\mathfrak{g}}$, and the embedding numbers are $m(\mathfrak{sl}(2,\mathbb{C}))=1$ and m(0)=|W|=2, so the Hasse diagram is:



We can see from this diagram that $\mathcal{D}(\mathfrak{sl}(2,\mathbb{C}))$ consists of a smooth open dense subset and two isolated singularities. This agrees with Dancer's computation [Da, pp. 88–99] that $\mathcal{D}(\mathfrak{sl}(2,\mathbb{C}))$ is the D_2 -surface, i.e., the affine variety in \mathbb{C}^3 cut out by the equation $x^2 - zy^2 = z$.

6.2. The exceptional Lie algebra \mathfrak{g}_2


The root system of \mathfrak{g}_2 embeds in \mathbb{R}^2 as:




The six long roots form an A_2 subsystem:




It is fixed by the Weyl group, so the embedding number is $|W_{\mathsf{G}_2}|/|W_{\mathsf{A}_2}| = 12/6 = 2$. There are three A_1^2 subsystems:



They are in the same W-orbit, so they determine a single conjugacy class in $C_{\mathfrak{g}_2}$ with embedding number $3|W_{G_2}|/|W_{\mathsf{A}_1^2}|=3\cdot 12/4=9$. There are three A_1 subsystems formed by the long roots:




They are in the same W-orbit and the embedding number is $3\cdot12/2 = 18$. Similarly, the short roots form three A_1 subsystems



which are W-conjugate and have embedding number 18. Finally, the empty set




forms a root subsystem with embedding number $|W_{G_2}|=12$. Therefore, the stratification structure of $\mathcal{D}(\mathfrak{g}_2)$ can be written symbolically as:





For example, we see from this diagram that on the boundary of the open dense stratum $\mathcal{D}(\mathfrak{g}_2)_{\mathrm{top}}$ there are two copies of the space $\mathcal{D}(\mathfrak{sl}(3,\mathbb{C}))_{\mathrm{top}}$. Also, the set of most singular points is a finite set of 12 elements.

6.3. All simple Lie algebras of rank ≤ 4

The computations outlined for $\mathfrak{sl}(2,\mathbb{C})$ and \mathfrak{g}_2 can be implemented on a computer. We have done that for all simple Lie algebras of rank ≤ 4 . The diagrams are arranged so that a node m'L' is higher than a node mL if and only if $\dim \mathcal{D}(L')_{\text{top}} > \dim \mathcal{D}(L)_{\text{top}}$.
