ON THE STRUCTURE OF PARETO-OPTIMA IN AN INFINITE HORIZON ECONOMY WHERE AGENTS HAVE RECURSIVE PREFERENCES

ABSTRACT

ON THE STRUCTURE OF PARETO-OPTIMA IN AN INFINITE HORIZO ECONOMY WHERE AGENTS HAVE RECURSIVE PREFERENCES

This article generalizes the one-agents growth theory with discounting to the case of several agents with recursive preferences. In a multiconsumption goods world, we show that, under some regularity conditions, any Pareto-optimum can be viewed as the trajectory of a dynamical system. The state space can be chosen to be either the product of the space of capitals by the (n-1)-simplex or the state of couples, capital-utilities achievable by (n-1) agents from that capital. We define and study the properties of generalized value functions. A generalized Euler's equation is introduced. It is then being used to give uniqueness and local stability conditions for a steady state.

RESUME

STRUCTURE DES OPTIMA DE PARETO DANS UNE ECONOMIE A HORIZON INFINI OU LES AGENTS ONT DES PREFERENCES RECURSIVES

Cet article généralise la théorie de la croissance à un agent qui utilise un critère de choix avec taux d'escompte au cas de plusieurs agents avec préférences récursives. Dans un monde à plusieurs biens de consommation, on montre que sous certaines conditions on peut représenter tout optimum de Pareto comme trajectoire d'un système dynamique. On peut prendre comme espace des états, soit le produit de l'espace des biens de capital par le (n-1)-simplexe, soit l'espace des couples capital et utilités réalisables par (n-1) agents à partir de ce stock de capital. On introduit des fonctions-valeurs généralisées ainsi qu'une équation d'Euler généralisée. On l'utilise par la suite pour donner des conditions d'unicité et de stabilité locale de l'état stationnaire.

INTRODUCTION

These last years attention has focused on the dynamics of equilibrium models where agents are infinitely lived. Becker [1980], Bewley [1982], Yano [1984], [1985], Coles [1985] [1986] have studied the dynamics of intertemporal equilibrium allocations when agents have separable preferences. The last three authors have shown that if agents have the same discount factor and if it is sufficiently close to one then in equilibrium the economy has the well known turnpike property of optimal growth.

On the other hand, following Koopmans' work [1960], [1969], Iwai [1972], Benhabib et ali [1985] for the one agent case, Lucas and Stokey [1984] and Benhabib et ali [1986] studied the dynamics of Pareto-optimal allocations in models where agents have recursive preferences. They all assumed basically the existence of one consumption good only. The purpose of this paper is to carry on this last work one step further in a more general setting. (We use many consumption goods) and to generalize well-known results of growth theory.

In order to do so, we introduce in section one an economy with m infinitely lived agents and a producer at each date. An initial stock is given. Agents have recursive preferences, the technology is markovian and time invariant. In section two, we show that under strict concavity and differentiability assumptions on utilities and strict convexity assumptions on production any Pareto optimal sequence may be viewed as the trajectory of a dynamical system. The state space can be chosen to be the product of the capital space by the simplex (capital-utility weights assigned to agents) or the space of capital and utilities achievable by n-1 agents from that capital stock. In section three, we generalize the one-agent value function. This can be done in two ways according to the state space chosen, as shown by Lucas and Stokey [1984] and Benhabib et ali [1986]. We extend their definitions to the multi-consumtion goods case and study the properties of the generalised value functions. In part four, we generalize "Euler's equations".

We then first use these equations to give sufficient conditions of existence and uniqueness of stationary states in the multi-consumption goods case (our approach is based on Brock [1973] and Burmeister [1980]).We then extend Mangasarian's result [1966] that any bounded sequence that satisfies Euler's generalised equations is in fact optimal.

We conclude with a couple of examples. The first one extends slightly Benhabib et ali's [1986].

In the second one agents have separable utilities and same discount factor, we thus get a turnpike theorem for discount factors close to one.

I - THE MODEL

I.1 - Generalities :

We consider an economy with n consumers each of whom lives for an infinite number of periods t=1,2.... There are m consumption goods and p capital goods. The commodity space is then $(R_{+}^{m})^{\infty} \times (R_{+}^{p})^{\infty}$. We shall use in R^{h} and $(R^{h})^{\infty}$ (h = m or p) the following conventional notations : in R^{h} , $z' \ge z \iff \forall j = 1 \dots h$ $z'_{j} \ge z_{j}$ $z' > z \iff z' \ge z$ and $z' \ne z$ $z' > z \iff \forall j = 1 \dots h$ $z'_{j} > z_{j}$

in $(\mathbb{R}^{h})^{\infty}, \underline{z}' \geq \underline{z} \iff \forall t \geq 0 \ \underline{z}'_{t} \geq \underline{z}_{t}; \ \underline{z}' \geq \underline{z} \iff \underline{z}' \geq \underline{z} \text{ and } \underline{z}' \neq \underline{z}$ T will denote the shift on sequences. For $\underline{x} = (\underline{x}_{0}, \underline{x}_{1}, \ldots), \ \underline{T}_{\infty} = (\underline{x}_{1}, \underline{x}_{2}, \ldots).$

The economy is described by the list

 $E = \left((R_{+}^{m})^{\infty}, W^{i}, i \in I = \{1, ..., n\}, (R_{+}^{p})^{\infty}, B, k_{o} \right)$. We shall define below each element of this list.

I.2 - Recursive preferences :

Let $x_t^i = (x_{t1}^i, \dots, x_{tm}^i) \in R_+^m$ denote the quantity agent i consumes at date t. Let $x^i = (x_0^i, x_1^i, \dots)$ denote the infinite sequence of agent i consumptions. Let X be the space of consumption sequences $(R_+^m)^\infty$ endowed with the product topology. Let us recall that this topology is metrisable and that one can for example define $\widetilde{d}(x, y)$ by

$$\widetilde{d}(x,y) = \sum_{i=0}^{\infty} \left[\frac{d(x_i,y_i)}{1+d(x_i,y_i)} \right] \frac{1}{2^i} \text{ where } d \text{ is any distance in } \mathbb{R}^m. \text{ Since } d(Tx,Ty) \leq 2 \ d(x,y), T \text{ is a continuous map from } X \text{ into } X.$$

Let S be the space of bounded continuous functions from X into R_+ endowed with the sup norm $||u|| = \sup u(x)$. $x \in X$ Following Beals and Koopmans [1969] and Lucas and Stokey [1984] we shall assume that preferences are representable by a utility function which belongs to a class that we next define.

A function $W : R_+^m \times R_+ \to R_+$ is an <u>aggregator</u> function if it satisfies the following properties :

W1 : continuous and satisfies $W(x,0) \leq M, \forall x$

W2 : concave

W3 : W(0,0) = 0

W4 : $(x,z) \leq (x',z')$ and $(x,z) \neq (x',z')$ implies W(x,z) < W(x',z'); and for some $0 \leq \beta < 1$

W5 : $|W(x,z) - W(x,z')| \leq \beta |z-z'|$ for all $x \in R^m_+$ and all $z, z' \in R$. We have the following theorem :

THEOREM I.1 :

Every aggregator W defines an operator on S as follows $T_W u(x) = W(x_0, u(T(x)))$. T_W is a contraction. There exists a unique $u \in S$ such that $T_W u = u$ with the following properties :

- (i) u is concave (strictly concave whenever W is strictly concave in x)
- (ii) Non decreasing
- (iii) u(0) = 0

 $\begin{array}{l} \underline{Proof} & : \mbox{ Let us first prove that } T_W \mbox{ defines an operator on } S \ . \ Note that \\ T_W u & is continuous on S \ as composite of continuous maps. } T_W u \ is bounded since \\ \left|T_W u(\underline{x}) - W(\underline{x}_0, 0)\right| & \leq \beta \ u(\underline{Tx}) & \leq \beta \| u \| \ by \ W_5 \ and therefore \\ \sup | \ T_W u(\underline{x})| < M + \beta \| u \| \ . \\ \begin{array}{c} \underline{x} \in X \end{array}$

It follows from W_5 that T_W is a β -contraction on S since $|T_W^u(\underline{x}) - T_W^v(\underline{x})| \leq \beta ||u(T\underline{x})| - v(T|\underline{x})| \leq \beta ||u-v||$, $\forall \underline{x}$.

As T_W maps concave, non decreasing maps into themselves, T_W has a unique fixed point which is concave and non decreasing. As $u(0) = T_W u(0) =$ W(0,u(0)) and is unique, u(0) = 0.

If W is strictly concave in x, then u is also strictly concave. This can be proved by induction. Let \underline{x} and \underline{x}' be such that $\underline{x}_0 \neq \underline{x}_0'$ then $u(\lambda \underline{x} + (1-\lambda)\underline{x}') = W(\lambda \underline{x}_0 + (1-\lambda) \underline{x}_0', u(\lambda \underline{T}(\underline{x}) + (1-\lambda) \underline{T}(\underline{x}')))$ $> \lambda W(\underline{x}_0, u(\underline{T}(\underline{x})) + (1-\lambda) W(\underline{x}_0', u(\underline{T}(\underline{x}')) = \lambda u(\underline{x}) + (1-\lambda) u(\underline{x}')$

Now let \underline{x} and \underline{x}' be such that $x_i = x_i' \forall i < j$ and $x_j \neq x_j'$ Then $u(\lambda T^j(\underline{x}) + (1-\lambda)T^j(\underline{x}')) > \lambda u(T^j(\underline{x})) + (1-\lambda) u(T^j\underline{x}')$ as $u(T^{j-1}(\underline{x})) = W(x_{j-1}, u(T^j(\underline{x})))$ and since W satisfies W_4 we have $u(\lambda T^{j-1}(\underline{x}) + (1-\lambda) T^{j-1}(\underline{x}')) > \lambda u(T^{j-1}(\underline{x})) + (1-\lambda) u(T^{j-1}(\underline{x}'))$ and therefore $u(\lambda \underline{x} + (1-\lambda)\underline{x}') > \lambda u(\underline{x}) + (1-\lambda) u(\underline{x}')$, by the induction hypothesis.

Example I.1 : The discounted case.

Let $v : R_{+}^{m} + R^{+}$ be a continuous, concave, uniformly bounded function such that v(0) = 0. Let $W(x,z) = v(x) + \beta z$. Then it can be easily verified that all the properties $W_{1} - W_{5}$ are fulfilled.

Let $u(\underline{x}) = \sum_{0}^{\infty} \beta^{t} v(x_{t})$. Since v is uniformly bounded u is well defined and satisfies $u(\underline{x}) = W(x_{0}, u(T(\underline{x})))$. It is therefore the unique solution to the functional equation $T_{W} u = u$.

Therefore the classical growth theory and intertemporal general equilibrium theory with discounted preferences is a particular case of the theory we shall develop.

<u>Remark 1.1</u>: Note that we work with a weaker topology then Lucas and Stokey [1984] who use ℓ_+^m . All proofs concerning compactness and continuity are thus much easier. Moreover notice that we have weakened their hypotheses that $W(x,y) \leq M \quad \forall x, \forall y$ into $W(x,0) \leq M, \forall x$ in order to be able to apply it to linearly separable preferences.

<u>Remark 1.2</u>: If W is assumed to be continuous and satisfies $W_2 - W_5$ it is still possible to associate with it a utility function (not necesseraly bounded). Indeed let $X = k_+^m$ and S' be the space of continuous function f on X such that $\sup \frac{|f(x)|}{1+||x||_{\infty}} < \infty$. Then it can easily be shown that S' endowed with the norm $||f||_S$, $= \sup \frac{|f(x)|}{1+||x||_{\infty}}$ is a Banach space. As W is concave, there exists a C > 0 such that $W(x,0) \leq C(1+||x||)$. Therefore with W we can associate an operator on S' as follows $T_W u(x) = W(x_0, uT(x))$. Indeed from W_5 we have that $|W(x_0, u(T(x)) - W(x_0, 0)| \leq \beta (1+||x||_{\infty})$ and therefore $|W(x_0, u(T(x)))| \leq (\beta ||u||_S, + C)(1+||x||_{\infty})$. Moreover T_W u is continuous on k_+^m therefore $T_W(u) \in S'$. However the counterpart of this weakened hypotheses is as in Montrucchio [1984] a stronger assumption on the production set so as to get a bounded utility set.

<u>Remark 1.3</u>: The aggregator W defined above can be viewed as an extension of the one defined in Koopmans [1960] and Koopmans et ali [1964]. Indeed consider a function $\mathcal{V}: \mathbb{R}_+ \times \mathbb{R}_+ \to \mathbb{R}_+$ that satisfies $W_1 - W_5$. Let $C: \mathbb{R}_+^m \to \mathbb{R}_+$ be any concave, strictly increasing function that verifies C(0) = 0. Then $W(x,z) = \mathcal{V}(C(x),z)$ is an aggregator function in the sense defined above.

1.3 - Stationary Markovian technology :

The technology at date t will be assumed to depend only on the vector of capital stocks $K_t = (K_{t1}, \dots, K_{tp}) \in R_+^p$ on hand at the beginning of t and the production possibilities will be assumed to be invariant in time.

Given a stock k we shall assume the existence of a set of pairs (x,y)of current consumption goods and beginning of next period capital stocks that are jointly producible $B(k) \subseteq R_{+}^{m} \times R_{+}^{p}$, so that the technology is characterized by a correspondence $B : R_{+}^{p} \rightarrow R_{+}^{m} \times R_{+}^{p}$ with the following properties : BO : B is continuous

B1 : for each k, B(k) is compact and convex

B2 : $(x,y) \in B(k)$ and $0 \le (x',y') \le (x,y)$ implies $(x',y') \in B(k)$ B3 : $k' \le k$ implies $B(k') \subseteq B(k)$ B4 : if $(x,y) \in B(k)$ and $(x',y') \in B(k')$, then

$$\left((\theta \mathbf{x} + (1-\theta)\mathbf{x'}), (\theta \mathbf{y} + (1-\theta)\mathbf{y'})\right) \in \mathbf{B} (\theta \mathbf{k} + (1-\theta)\mathbf{k'})$$

for $\theta \in [0,1]$

B5 : $(x,y) \in B(0) \Rightarrow y = 0$ and there exists x > 0 $(x,0) \in B(0)$. B6 : k > 0 implies that there exist x > 0, y > 0, $(x,y) \in B(k)$.

This last hypothesis implies that from a non zero initial capital stock one can generate capital and consumptions sequences that are not zero at each date. All others hypotheses are standard.

<u>Example 1.2</u>: Let F(k,x,y) from $\mathbb{R}^{p}_{+} \times \mathbb{R}^{m}_{+} \times \mathbb{R}^{p}_{+} \to \mathbb{R}$ be a continuous convex function, increasing in x and y and strictly decreasing in k. Let $F(0,x,y) \leq 0$ imply y = 0 and $F(0,0,0) \leq 0$. Then let $B(k) = \{(x,y), F(k,x,y) \leq 0\}$ then B satisfies $B_{0} \leq B_{6}$.

I.4 - Feasible consumption paths. Utility set :

In what follows let us denote by $\hat{\mathbf{x}} = \sum_{i} \mathbf{x}^{i}$, $\hat{\mathbf{x}}_{t} = \sum_{i} \mathbf{x}^{i}$, $\hat{\mathbf{x}} = \sum_{i} \mathbf{x}^{i}$. For x and x' in \mathbb{R}^{h} , h=1,m,n or p, let $\mathbf{x}^{\lambda} = \lambda \mathbf{x} + (1-\lambda)\mathbf{x}'$, $\lambda \in]0,1[$.

Given k_0 the initial stock a feasible allocation path is a couple $(x,k) \in X^m \times (\mathbb{R}^p_+)^\infty$ such that $(\hat{x}_t, k_{t+1}) \in B(k_t) \forall t \ge 0$. We denote by $X(k_0)$ the set of all $x \in X^m$ which are feasible. Let us also define feasible consumption paths as follows

 $C(k_0) = \{x \in X, (x_t, k_{t+1}) \in B(k_t) \forall t \ge 0 \text{ for some } k \in (R_+^p)^{\infty}, k_0 \text{ given} \}$ It can be rewritten as follows : $C(k_0) = \{x \in X, \exists k_1 \in R_+^p, (x_0, k_1) \in B(k_0) \text{ and } T x \in C(k_1) \}$

The correspondence $C : R^{p}_{+} \rightarrow X$ has the following properties :

THEOREM I.2 :

- (1) $\forall k_0, C(k_0)$ is convex compact. If $x \in C(k_0)$ and $x' \leq x$ then $x' \in C(k_0)$
- (2) The correspondence $k \rightarrow C(k)$ has a closed graph and is lower semi-continuous
- (3) $\forall \lambda \in [0,1], \lambda C(k_0) + (1-\lambda) C(k_0) \subseteq C(\lambda k_0 + (1-\lambda) k_0)$
- (4) $k' \leq k$ implies $C(k') \subseteq C(k)$.

<u>Proof</u>: (1) The convexity of C(k) follows from B_1 and B_4 . To prove that $C(k_0)$ is compact let $\Gamma(k_0) = \{(x,k) \in X \times (R_+^p)^{\infty}, x \in C(k_0)\}$, let Π^i , i = 1, 2 denote the ith projection of $R_+^m \times R_+^p$ on the ith factor. Let $\Pi^1 B(k_0) = C_0(k_0)$, $\Pi^2 B(k_0) = K_1(k_0)$, and define by induction $\Pi^1 B(K_t(k_0)) = C_{t+1}(k_0)$, $\Pi^2 B(K_t(k_0)) = K_{t+1}(k_0)$. As Π^i and B are continuous so are the correspondences C_t . Moreover they are compact valued as B is compact valued.

As $\Gamma(k_0) \subseteq \int_0^\infty C_t(k_0) \propto \int_0^\infty K_{t+1}(k_0)$, it follows from Tychonov's theorem that $\Gamma(k_0)$ is relatively compact. Moreover $\Gamma(k_0)$ is closed since $B(k_0)$ is closed and B is upper semi-continuous. Therefore $\Gamma(k_0)$ is compact and so is $C(k_0)$ its projection on X.

(2) Since B(k) is closed for every k and the correspondence $k \rightarrow B(k)$ has a closed graph, the correspondence $k \rightarrow C(k)$ has a closed graph. To prove its lower semi-continuity let $k_0^n \rightarrow k_0$ and $(\underline{x}) \in C(k_0)$. Let $(\underline{x}, \underline{k}) \in \Gamma(k_0)$. Then $(\underline{x}_0, \underline{k}_1) \in B(k_0)$. As B is continuous there exists a sequence $(\underline{x}_0^n, \underline{k}_1^n) \in B(\underline{k}_0^n)$ converging towards $(\underline{x}_0, \underline{k}_1)$. Similarly there exists a sequence $(\underline{x}_1^n, \underline{k}_2^n) \in B(\underline{k}_1^n)$, $(\underline{x}_1^n, \underline{k}_2^n) \rightarrow (\underline{x}_1, \underline{k}_2)$. One constructs by induction a sequence $(\underline{x}_t^n, \underline{k}_{t+1}^n) \in B(\underline{k}_t^n)$, such that $(\underline{x}_t^n, \underline{k}_{t+1}^n) \rightarrow (\underline{x}_t, \underline{k}_{t+1})$. Therefore $\underline{x}^n \in C(\underline{k}_0^n)$ and \underline{x}^n converges towards \underline{x} .

(3) and (4) that follow from B4 and B3 respectively are omitted. \square

Following Negishi' [1960] we now introduce the utility set $U(k_0)$ the set of utility vectors which can be reached by attainable allocations :

$$U(k_0) = \left\{ (u^i(x^i)) : \hat{x} \in C(k_0) \right\}$$

Let $\Phi : X \to X^m$ be defined as follows : $\Phi(x) = \{(x^i) \in X^m, \hat{x} = x'\}$

It will be shown in appendix one that Φ is continuous.

Let $\widetilde{U} : X^{m} \to R^{n}_{+}$ denote the function $\widetilde{U}(\underline{x}) = (u^{1}(\underline{x}^{1}), u^{2}(\underline{x}^{2}), \dots u^{n}(\underline{x}^{n}))$ \widetilde{V} is clearly continuous and $U(k) = \widetilde{U}(\Phi(C(k)))$

U(k) has the following properties :

THEOREM I.3 :

- (1) For every k, U(k) is compact, convex (strictly if all uⁱ are strictly concave) and satisfies free disposal : ∀u EU(k), 0 ≤ u' ≤ u implies u' EU(k).
- (2) $U(\lambda k + (1-\lambda) k') \ge \lambda U(k) + (1-\lambda)U(k')$. (The inclusion is strict if all the W^{i} are strictly concave).
- (3) $\forall k > 0$ there exists z >> 0 such that $z \in U(k)$
- (4) The correspondence from $R_{+}^{p} \rightarrow R_{+}^{n}$: $k \rightarrow U(k)$ is continuous.

<u>Proof</u>: (1) The (strict) convexity of U(k) follows from the convexity of B(k) and the (strict) concavity of the u^i . Compactness of U(k) follows from the compactness of C(k) and the continuity of Φ and U. Free disposal follows from the fact that $x \in C(k)$ implies $x' \in C(k)$ for every $x' \leq x$.

(2) Let $\underline{x} \in C(k)$ and $\underline{x}' \in C(k')$ be such that $\sum_{i} \underline{x}^{i} = \underline{x}$ and $\sum_{i} \underline{x}'^{i} = \underline{x}'$. Then $\lambda \underline{x} + (1-\lambda) \underline{x}' \in C(\lambda k + (1-\lambda) k')$ by theorem I.2 (c). For some i, $x^{i} \neq x'^{i}$, $u^{i} (\lambda \underline{x}^{i} + (1-\lambda) \underline{x}'^{i}) > \lambda u^{i} (\underline{x}^{i}) + (1-\lambda) u^{i} (\underline{x}'^{i})$ and for $j \neq i$ $u^{j} (\lambda \underline{x}^{j} + (1-\lambda) \underline{x}'^{j}) \ge \lambda u^{j} (\underline{x}^{j}) + (1-\lambda) u^{j} (\underline{x}'^{j})$ which proves 2. (3) By assumptions B_{5} and B_{6} , there exists x > 0, $y \ge 0$ such that $(x,y) \in B(k)$ therefore $x_{j} > 0$ for some j. Let us consider the following consumption sequences : $x_{0j}^{i} = \frac{1}{n} x_{j}$ and $x_{0l}^{i} = 0$ $\forall i, \forall l \ne j, x_{tj}^{i} = 0$, $\forall t \ge 1, \forall i, \forall j$.

By $W_3, u^i (x^i) > 0 \forall i$.

(4) U is lower semi-continuous and has a closed graph as composite of lower semi-continuous correspondences and maps with a closed graph. The u^{i} being uniformly bounded, U(k) belongs to some fixed compact set for every k. U is therefore upper semi-continuous.

II - PARETO-OPTIMALITY

 $\underline{x} \in X(k_0)$ is Pareto-optimal if there exists no $\underline{x}' \in X(k_0)$ with $\widetilde{U}(\underline{x}') > \widetilde{U}(\underline{x})$. We shall denote by $\widehat{U}(k_0)$ the image by U of the Pareto-optima corresponding to the initial stock k. It is a classical result that $\widehat{U}(k)$ is compact for every k and homeomorphic to the unit simplex Δ^{n-1} of \mathbb{R}^n , the homeomorphism being the "radial projection" on Δ^{n-1} (see Mas-Colell [1985] page 154).

For further use the rest of this section is devoted to show that under some further regularity conditions on the technology and on preferences, for every k, the Pareto frontier is homeomorphic to Δ^{n-1} the homeomorphism being the map from $\Delta^{n-1} \rightarrow \widehat{U}(k)$, $\theta \rightarrow \arg \max \sum_{i=1}^{n} \theta^{i} u^{i}$, $(u^{i}) \in \widehat{U}(k)$.

Let us first quote the following result

LEMMA II.1 :

The correspondence $k \rightarrow \hat{U}(k)$ has a closed graph.

We shall now on assume the following.

- B₄ Biss For every $k \ge 0$, $k' \ge 0$, $k \ne k'$ if $(x,y) \in B(k)$ and $(x,y') \in B(k')$ then there exists $x' \ge x$, $x' \ne x$ such that $(x', y^{\lambda}) \in B(k^{\lambda})$. W₂ Biss For every i, Wⁱ is strictly concave in x.
- W₆ For every i, Wⁱ is C¹ on $R_{++}^{m} \times R_{+}$ and satisfies the following boundary conditions.

W₇ (1) Inada conditions

(2) If $x_j^i = 0$ for all j = 1 ... h then $W^i(x^i, z^i)$ is a C^1 function of x_p^i , p > h and z^i .

We first prove the following lemma :

LEMMA II.2 :

For every $u \in \hat{U}(k)$ there exists a unique triple $((x^i), y, (z^i))$ in $\mathbb{R}^{mn}_+ \times \mathbb{R}^p_+ \times \mathbb{R}^n_+$ such that $W^i(x^i, z^i) = u^i, \forall i$ $(\hat{x}, y) \in B(k)$ and $z \in U(y)$. The map e from graph \hat{U} into $\mathbb{R}^{mn}_+ \times \mathbb{R}^p_+ \times \mathbb{R}^n_+$, $(k, u) \to ((x^i), y, (z^i))$ is continuous.

<u>Proof</u>: Let k be fixed and $u \in \widehat{U}(k)$. Since the W^{i} are strictly concave there exist unique (x^{i}) , such that $u^{i} = W^{i}(x^{i}, z^{i}) \forall i$. Uniqueness of the associated y follows from B4 biss. To prove uniqueness of (z^{i}) assume $(x,y) \in B(k)$ and z and $z' \in U(y)$. Since U(y) is strictly convex, z^{λ} belongs to $\widehat{U(y)}$. Thus there exists $z'' > z^{\lambda}$, $z'' \in U(y)$. Therefore $u_{i} < W^{i}(x^{i}, z''^{i}) \forall i$, which contredicts the pareto optimality of u.

To show the continuity of e, let $k_{v} \neq k$ and $u_{v} \neq u$. Let $((x_{v}^{i}), y_{v}, (z_{v}^{i})) = e(k_{v}, u_{v})$. As \hat{U} has a closed graph, $(k, u) \in \text{graph} \hat{U}$. Let K_{o} be any fixed compact set such that k_{v} and k belong to K_{o} . Let $B(K_{o}) = U = B(k)$. Then $e(k_{v}, u_{v}) \in (\Pi^{1}B(Ko))^{n} \times \Pi^{1}B(Ko) \times U(\Pi^{2}B(Ko)), \forall v$ $k \in K_{o}$

Let $((\bar{x}^{i}), \bar{y}, (\bar{z}^{i}))$ be a limit point of the sequence. Then $W^{i}(\bar{x}^{i}, \bar{z}^{i}) = u^{i}$ by continuity of $W^{i}, (\bar{x}, \bar{y}) \in B(k)$ since B has a closed graph and $\bar{z} \in U(\bar{y})$ since U has a closed graph. Therefore $((\bar{x}^{i}), \bar{y}, (\bar{z}^{i})) = e(k, u)$ $\bar{x}^{i} = x^{i}, \bar{y} = y, \bar{z}^{i} = z^{i}$. Therefore $x_{v}^{i} \neq x^{i}, z_{v}^{i} \neq z^{i} \forall i$ and $y_{v} \neq y$. \Box

We next have the following basic proposition :

PROPOSITION II.1 : Consider the problem (P)

<u>Proof</u>: Let k et θ be fixed. The maximisation problem stated above is equivalent to max $\sum_{\xi \in U(k)} \theta^{i} \xi^{i}$. The solution $\hat{\xi}$ is unique since U(k)

is strictly convex and belongs to U(k). By lemma II.1, there exist a unique triple $((x^{i}) y, (z^{i}))$ which solve the initial problem P.

<u>Proof of b</u>: Suppose that there exists ℓ such that $\overline{x}_{j}^{\ell} > 0$ and i with $\theta^{i} > 0$ and $\overline{x}_{j}^{i} = 0$. Let all quantities, production and utilities be unchanged except the consumption of the j^{th} good by agents ℓ and i. Let $\varepsilon > 0$ be such that $\overline{x}_{j}^{\ell} > \varepsilon$. Let $x_{j}^{\ell} = \overline{x}_{j}^{\ell} - \varepsilon$ and $x_{j}^{i} = \varepsilon$. Let $\Delta W = \theta^{i} W^{i}(x^{i}, \overline{z}^{i}) + \theta^{\ell} W^{\ell}(x^{i}, \overline{z}^{\ell}) - \theta^{i} W^{i}(\overline{x}^{i}, \overline{z}^{i}) - \theta^{\ell} W^{\ell}(\overline{x}^{\ell}, \overline{z}^{\ell})$. By $W_{7} \forall A, \exists \varepsilon' > 0$ $x_{j}^{*i} < \varepsilon$ implies $W^{i}(x^{*i}, \overline{z}^{i}) - W^{i}(\overline{x}^{i}, \overline{z}^{i}) > A \varepsilon'$. <u>Proof of c</u>: Suppose that $\theta^{\ell} > 0$ and $\overline{x}^{\ell} = 0$. It then follows from b) that $\overline{x}^{j} = 0 \forall j$. Let $(x,y) \in B(k)$ be such that $x_{r} > 0$ for some good r and $x_{q} = 0 \forall q \neq r$, (existence of (x,y) follows from B_{6} and B_{2}). Thus $\Delta W \ge \lambda [A|x|\theta^{\ell} - \beta \sum_{i} \theta^{i} |\overline{z}^{i} - \widetilde{z}^{i}|]$. Choose A so that this last quantity is positive and $\lambda < \frac{\varepsilon}{|x|}$. Then $\Delta W > 0$ a contradiction.

<u>Proof of d</u>: Assume that $\theta^{\ell} > 0$ and $\overline{x}_{j}^{\ell} = 0 \quad \forall j = 1 \dots h$, h < m. It then follows from b) that $\overline{x}_{j}^{i} = 0 \quad \forall i \in I$, $\forall j = 1 \dots h$. Let $B'(k) = B(k) \cap \{\{0\} \times \dots \{0\} \times \mathbb{R}_{+}^{m-h}\} \times \mathbb{R}_{+}^{p}$. Let $\widetilde{B}'(k)$ be its projection on $\mathbb{R}_{+}^{m-h} \times \mathbb{R}_{+}^{p}$. Let $P(k) = \{(x,z), \exists y, (x,y) \in B'(k), z \in U(y)\}$ and $\widetilde{P}(k)$ be its projection on $\mathbb{R}^{m-h}_{+} \times \mathbb{R}^{n}_{+}$. Define $\widetilde{W}^{i}(\widetilde{x}, z^{i}) = W^{i}((0, \widetilde{x}), z^{i})$ for $\widetilde{x} \in \mathbb{R}^{m-h}_{+}$, $(0, \widetilde{x}) \in \mathbb{R}^{m}_{+}$. Consider the restricted problem

Clearly $((\widetilde{x}^{i}), \overline{y}, (\overline{z}^{i}))$ is a solution to that problem. We shall apply Aubin-Ekeland [1984] lemma p.223. Let A be the linear operator from $\mathbb{R}^{mn}_{+} \times \mathbb{R}^{n}_{+} \to \mathbb{R}^{m-h}_{+} \times \mathbb{R}^{n}_{+}$ defined as follows $A((x^{i}), (z^{i})) = (\sum_{i} \widetilde{x}^{i}, (z^{i}))$. The problem we study is

It thus suffices to show that there exists a strictly positive element in $\widetilde{P}(k)$. Under B_{6} and by theorem I.3 there exists an element $(x,y) \in B'(k)$ such that y > 0 and $z \in U(y)$, z >> 0. Let $x^{\lambda} = \lambda \widetilde{\overline{x}} + (1-\lambda)x$, y^{λ} and z^{λ} . Then $(x^{\lambda}, y^{\lambda}) \in \widetilde{B}(k)$ by B_{4} , $x^{\lambda} >> 0$ in \mathbb{R}^{m-h}_{+} and $z^{\lambda} >> 0$. So the slater condition is verified. Let A^{*} denote the adjoint of A. By Aubin-Ekeland [1984] lemma there exists $a \quad \widetilde{q} \in \mathbb{R}^{m-h}_{+} \times \mathbb{R}^{m}_{+}$ such that $\partial(\sum_{i} \theta^{i} W^{i}(\overline{x^{i}}, \overline{z^{i}})) = A^{*} \overline{q}$. We thus have $\theta^{i} \quad \frac{\partial W^{i}}{\partial x^{i}_{h}}(\overline{x^{i}}, \overline{z^{i}}) = \theta^{j} \quad \frac{\partial W^{j}}{\partial x^{j}_{h}}(\overline{x^{j}}, \overline{z^{j}}) \quad \forall i, j \in J$, $h \in H$. \Box

Then Γ_1 and Γ_2 are continuous and the optimisation problem is max { $\sum_i \theta^i W^i(x^i, z^i)$, $((x^i), y, (z^i)) \in \Gamma_1(k) \cap \Gamma_2(k)$ }. It follows from the maximum principle that the unique optimal solution is a continuous function of (k, θ) .

Let us next recall the following definition :

<u>Definition</u>: Let $U \subseteq \mathbb{R}^{n}_{+}$. A vector $\overline{u} \in U$ is supported by $\theta \in \Delta^{n-1}$ if \overline{u} maximizes $\sum_{i} \theta^{i} u^{i}$ subject to $u \in U$. We have the following result:

THEOREM II.1 :

Let $(k, u) \in \text{graph } \hat{U}$. Then there exists a unique θ that supports u. The map φ from graph \hat{U} onto Δ^{n-1} , $(k, u) \xrightarrow{\varphi} \theta$ is continuous.

<u>Proof</u>: Let $u \in \hat{U}(k)$ be given. Then there exists a θ that supports u (see Mas-Colell 1985 p.125). Let (\bar{x}^i) , \bar{y} , (\bar{z}^i) be the unique triple associated to u by lemma II.2.

We then have $\sum_{i} \theta^{i} W^{i}(\overline{x}^{i}, \overline{z}^{i}) = \sum_{i} \theta^{i} u^{i} = \max \{\sum_{i} \theta^{i} W^{i}(x^{i}, y^{i}), (\widehat{x}, y) \in B(k) z \in U(y) \}$. Let us show that θ is unique. It follows from proposition II.1.c that $\overline{x}^{i} = 0$ implies $\theta^{i} = 0$. Let us then consider $J = \{i, \overline{x}^{i} \neq 0\}$ and $H = \{h, \overline{x}_{h}^{i} \neq 0 \forall i \in J\}$. Let h be fixed in H. Then (θ^{i}) is uniquely determined by the linear system $\theta^{i} \frac{\partial W^{i}}{\partial x_{h}^{i}} (\overline{x}^{i}, \overline{z}^{i}) = \theta^{j} \frac{\partial W^{j}}{\partial x_{h}^{j}} (\overline{x}^{j}, \overline{z}^{i}) \forall i, j \in J$ To prove the continuity of φ , let (k_{y}, u_{y}) converge to $(\overline{k}, \overline{u})$. Then by lemma II.1, $(\overline{k}, \overline{u}) \in \operatorname{graph} \widehat{U}$. There exists

let (k_{v}, u_{v}) converge to (k, u). Then by lemma II.1, $(k, u) \in \text{graph } u$. There exists a sequence θ_{v} that supports u_{v} , therefore $\sum_{i} \theta_{v}^{i} u_{v}^{i} \ge \sum_{i} \theta_{v}^{i} u^{i} \forall u \in U(k_{v})$, $\forall v$. Pick $u' \in U(\overline{k})$ then since U is continuous, there exists a sequence $u_{v}' \in U(k_{v})$ such that $u_{v}' \Rightarrow u'$. Let θ be a limit point of θ_{v} . Then one has $\sum_{i} \theta_{v}^{i} u_{v}^{i} \ge \sum_{i} \theta_{v}^{i} u_{v}'^{i}$ for every vand therefore $\sum_{i} \theta^{i} \overline{u^{i}} \ge \sum_{i} \theta^{i} u'^{i}$. This implies that θ supports \overline{u} . As it is $unique, \theta_{v}$ converge towards θ .

<u>Remark II.1</u> : For every fixed k, the map $u \rightarrow \theta$ is a continuous bijection, it is therefore a homeomorphism. We thus have another homeomorphism of the set of Pareto-optima and the unit simplex besides the radial projection. <u>THEOREM II.2</u> :

All Pareto-optima are described by a trajectory of the dynamical system $\tau(k,\theta)$ on $\mathbb{R}^p_+ \times \Delta^{n-1}$ obtained as follows:

let $(x^{i}(k,\theta)), y(k,\theta), (z^{i}(k,\theta))$ be the optimal solution of P. Then $\tau(k,\theta) = (y(k,\theta), \varphi(y(k,\theta), (z^{i}(k,\theta)))$ <u>Proof</u>: let k and $v \in \hat{U}(k)$ be given. By remark II.1, $v \in \Delta^{n-1}$ corresponds to a unique $\theta \in \Delta^{n-1}$. By solving (P), one gets $((x^{i}(k,\theta)), y(k,\theta), (z^{i}(k,\theta)))$. Let $w(k,\theta) = \phi(y(k,\theta), (z^{i}(k,\theta)))$.

Let the decision maker solve a similar problem with initial data (y,w). Then the whole trajectory corresponding to the Pareto-optima can thus be reconstructed.

Let us compute $\tau(k,\theta)$ in the case of separable agregators with different discount factor.

<u>Example II.1</u>: Let $W^{i}(x^{i}, z^{i}) = u^{i}(x^{i}) + \beta^{i} z^{i}$. Let k and θ be given. We need to solve

 $\max \left\{ \sum_{i} \theta^{i} u^{i}(x^{i}) + \sum_{i} \beta^{i} \theta^{i} z^{i}, (\hat{x}, y) \in B(k), z \in U(y) \right\}.$ Let $\theta'^{i} = \frac{\theta^{i} \beta^{i}}{\sum_{i} \theta^{j} \beta^{j}}$. Then it is equivalent to :

 $\max \{ \sum_{i} \theta^{i} u^{i}(x^{i}) + (\sum_{i} \beta^{i} \theta^{i}) (\sum_{i} \theta^{i} z^{i}), (\hat{x}, y) \in B(k), z \in U(y) \}$

The problem being separable, one chooses first z, y given so as to max { $\sum_{i} \theta^{i} z^{i}$, $z \in U(y)$ }. Let $v(y, \theta')$ denote the maximum value. Then one solve :

 $\max \left\{ \sum_{i} \theta^{i} u^{i}(x^{i}) + \left(\sum_{i} \beta^{i} \theta^{i} \right) v(y,\theta'), (\hat{x},y) \in B(k) \right\}.$

Thus θ'^{i} supports z^{i} , $\forall y$ which implies $\varphi(y,z) = \theta'$, $\forall y$. Therefore $\tau(k,\theta) = (y(k,\theta),\theta')$. The dynamics of θ is independent of that of y. It can easily be shown that the map $\theta \neq \theta'$ has all vertex of the simplex as fixed points and an extra point $\theta^{i} = \frac{1}{q} \forall i$ such that $\beta^{i} = \max_{j} \beta^{j}$ and q equals the number of such i and $\theta^{j} = 0$ otherwise. The vertex are unstable fixed point and the last fixed point is globally attractive. Consider now an agent $\beta^{i} \leq \max \beta^{j}$, let B(k) belong to a fixed compact set K_{o} , then $x^{i}(k_{t},\theta_{t}) \neq 0$ (since $x^{i}(k,\theta)$ is continuous and $x^{i}(k,\theta) =$ $= 0 \quad \forall k \quad \text{if} \quad \theta^{i} = 0$), where $(k_{t},\theta_{t}) = \tau^{t}(k,\theta)$. One can therefore easily rediscover Ramsey's result but one cannot say anything about the path of capital stocks.

An alternative way of describing a trajectory.

As it has been shown by Benhabib and ali [1986] one can parametrise the trajectory in a different way. Let Π^{-1} be the map from $\mathbb{R}^n \to \mathbb{R}^{n-1}$ defined by $\Pi^{-1}(x_1 \dots x_n) = (x_2 \dots x_n)$. Let (k, z_0^2, \dots, z_0^n) belong to the graph of $\Pi^{-1}U(k)$. Consider the following problem

 $\max W^{1}(x^{1},z_{1}^{1}), W^{i}(x^{i},z_{1}^{i}) \geq z_{0}^{i}, i \geq 2/(\sum_{i}^{\Sigma} x^{i},y) \in B(k)(z_{1}^{i}) \in U(y).$

It can be easily shown that under W_2 biss and B_4 biss there is a unique solution $x^i(k, (z_0^i)), y(k, (z_0^i)), z_1^i(k, (z_0^i))$ and the map from $i \ge 2$ Graph $\Pi^{-1} U$ into $(\mathbb{R}^{mn}_+) \times \mathbb{R}^p_+ \times \mathbb{R}^n$, $(k, (z_0^i)) \rightarrow (x^i(k, z), y(k, z), z^i(k, z))$ is continuous.

The trajectory can therefore be described step by step. This definition does not require any differentiability assumption on the W^i .

In some cases, Lucas and Stokey's parametrisation may be more useful (as in the case of separable utilities) in other cases Benhabib and ali's one may be more interesting.

III - VALUE FUNCTIONS

In this section, we introduce two generalized versions of the value function of optimal growth, one is due to Lucas and Stokey [1984], the other to Benhabib et ali [1986]. We study their properties, continuity, concavity and differentiability.

Lucas and Stokey's value function

Let

PROPOSITION III.1 :

- a) The map from $\mathbb{R}^p_+ \times \Delta^{n-1} \to \mathbb{R}$, $(k, \theta) \to V(k, \theta)$ is continuous
- b) Under B_4 and W_2 , for every θ , the map from $\mathbb{R}^p_+ \to \mathbb{R}^+$ $k \to V(k, \theta)$ is strictly concave in k. Under W_2 , W_6 , W_7 for every fixed k, the map from Δ^{n-1} into \mathbb{R}^+ , $\theta \to V(k, \theta)$ is strictly convex.

<u>Proof</u>: The proofs of a) and first statement of b) are omitted. Let us prove the strict convexity in θ . Let $(x^{i}(k,\theta)), (z^{i}(k,\theta))$ denote the optimal solution conrresponding to θ . Let θ and θ' be given, $\theta^{\lambda} = \lambda \theta + (1-\lambda)\theta'$. It follows from lemma II.1 and proposition II.1 that $\theta \neq \theta'$ implies $(x^{i}(k,\theta)) \neq (x^{i}(k,\theta')) \neq (x^{i}(k,\theta^{\lambda}))$. Therefore $V(k,\theta^{\lambda}) = \sum_{i} \theta^{i\lambda} W^{i}(x^{i\lambda},z^{i\lambda}) = \lambda \sum_{i} \theta^{i} W^{i}(x^{i\lambda},z^{i\lambda}) + (1-\lambda) \sum_{i} \theta^{i} W^{i}(x^{i\lambda},z^{i\lambda})$ $< \lambda V(k,\theta) + (1-\lambda) V(k,\theta') \square$

In order to study the differentiability properties of $v(k,\theta)$ we introduce the following auxiliary function. Let

One can also differentiate with respect to x^i , y and z^i Bellman's generalized equation and use theorem III.2. For further use let us use a direct approach. When the production function is separable, given μ , equation (13) uniquely determines y for μ near one. Finally we shall use (19) in order to show that μ is uniquely determined.

We prove first that given μ near one, (16), (17), (20) and (21) have a unique solution (x, z, θ, λ) . It is sufficient to prove that the determinant of the Jacobian matrix of this system has a constant sign. This matrix is a follows:

Multiplying every (nm + n + j) column, for $j = 1, \ldots, n$, by $\frac{1}{\lambda}$, and adding it to the last column, we get a determinant which last column and last row are zero except the $(nm + 2n + 1)^{\text{th}}$ element of the $(nm + 2n + 1)^{\text{th}}$ column which is equal to $\frac{1}{\lambda}$. Hence the determinant of this matrix is $\frac{D}{\lambda}$ where D is the determinant of the $(nm \times 2n) \times (nm + 2n)$ principal matrix obtained by deleting the last column and last line. For $\mu = 1$, an argument similar to that of proposition III.2 shows that the principal matrix has a determinant different from zero. As this determinant is a continuous function of $(x^{i})_{i\in I}, (z^{i})_{i\in I}, (\theta^{i})_{i\in I}$ and λ , it keeps a constant sign on $\mathbf{\hat{R}}_{+}^{mm} \times \mathbf{\hat{R}}_{+}^{n} \times \mathbf{\hat{\Delta}}^{n} \times \mathbf{\hat{R}}_{+}^{n}$. By a standard argument based on degree theory, $((x^{i}), (z^{i}), (\theta^{i}))$ and λ are uniquely determined for $\mu = 1$. The assumption made seems to be too strong. One way to relax it is to suppose. as in Burmester [1980], that the technology is regular in the sense of Burmester-Turnovsky.

<u>Remark IV.2</u>: If the technology is regular in the sense of Burmeister-Turnovsky, then the value of the variations of the capital is always negative at the equilibrium rate of interest. Indeed $\frac{\partial \Phi_2}{\partial k_j}$ can be viewed as the equilibrium price of capital k_j and μ is related to the equilibrium rate of interest r by the expression $\mu = \frac{1}{1+r}$.

Let us know consider the consumption side and the function $\Phi_1(x(\mu)) = \widetilde{\Phi}_1(\mu)$. As Lucas and Stokey [1984] we shall show that $\widetilde{\Phi}_1$ is a decreasing function of μ .

Let us try to motivate the "increasing marginal impatience" assumption that we next make.

Consider a stationary path

We define marginal impatience by the condition $\frac{d\mu^i}{dz^i} \leq 0$, i.e. when the utility level of a constant path increases, the ratio between the marginal variations of utility due to changes in the same amount in second and first period decreases. (Examples of \mathcal{V} functions that satisfy that property can be found in Koopmans and Ali [1964]. The following condition can be viewed as its generalisation :

Let $\mathbb{E}_{1} \oplus \mathbb{E}_{2}$ be a decomposition of $\mathbb{R}^{2(p+m-1)}$ such that $T_{1} = T_{/\mathbb{E}_{1}}$ has eigenvalues λ_{i} , $i = 1 \dots p+m-1$ and similarly for \mathbb{E}_{2} . Assume moreover the following regularity condition :

"Regularity condition"

The projection of E_1 on $\mathbb{R}^{p+m-1} \times \{0\}$ is an isomorphism.

Then optimal solutions corresponding to initial condition $(k_{o}, (z_{o}^{1})_{i\geq 2})$ close to the stationary state $(k^{*}, (z^{i})_{i\geq 2}^{*})$ converge towards it. The argument is Scheinkman's [1976] page 25. Given any $(k_{o}(z_{o}^{i})_{i\geq 2})$ sufficiently close to $(k^{*}, (z^{i})_{i\geq 2}^{*})$, one can find by the regularity condition a unique $(k_{1}, (z_{1}^{i})_{i>2})$ such that $(k_{o}, (z_{o}^{i})_{1\geq 2}, k_{1}, (z_{1}^{i})_{1\geq 2})$ is on the stable manifold of the steady state. The path generated by Euler's system with these initial conditions is locally stable. By theorem IV.2, it is optimal.

Example 1 :

Suppose that we have <u>one</u> consumption good and <u>one</u> capital good and a production function $\hat{\mathbf{x}} = G(\mathbf{k}, \mathbf{y})$, which is stricly concave, twice continuously differentiable, and verifies $\frac{\partial G}{\partial \mathbf{k}} < 0$, $\frac{\partial G}{\partial \mathbf{y}} > 0$. Assume to simplify that the steady state is unique and that the utility functions W^{i} verify the normality condition for future utility at the steady state :


<u>Proof</u>: By remark IV.3, it suffices to prove that, the steady state is a saddle point of the linearised Euler's equation and that the regularity condition is fulfilled. The proof that the steady state is a saddle point is omitted since it is tedious and similar to theorem 1 in Benhabib and Ali [1985]. The proof of the regularity condition can be found in the Apendix.

Moreover if the matrix $\begin{pmatrix} A & B \\ t_B & C \end{pmatrix}$ is positive definite, then, when $\beta = 1$, the corresponding characteristic roots are not on the unit-circle (see Levhari and Leviatan [1972]); therefore for β near one the steady-state is a saddle-point.

We prove now that the matrix

$$\begin{pmatrix} A & B \\ t_B & C \end{pmatrix}$$
 is positive definite.

Tedious computations show that

$$\begin{pmatrix} \mathbf{t}_{\mathbf{x}}, \mathbf{t}_{\mathbf{y}} \end{pmatrix} \begin{pmatrix} \mathbf{A} & \mathbf{B} \\ \mathbf{t}_{\mathbf{B}} & \mathbf{C} \end{pmatrix} \begin{pmatrix} \mathbf{x} \\ \mathbf{y} \end{pmatrix} = \begin{pmatrix} \sum_{j} \mathbf{x}_{j} & \frac{\partial \mathbf{F}}{\partial \mathbf{k}_{j}} \end{pmatrix}^{2} + \begin{pmatrix} \sum_{j} \mathbf{x}_{j} & \frac{\partial \mathbf{F}}{\partial \mathbf{y}_{j}} \end{pmatrix} \begin{pmatrix} \sum_{j} \mathbf{y}_{j} & \frac{\partial \mathbf{F}}{\partial \mathbf{k}_{j}} \end{pmatrix}$$

+
$$\begin{pmatrix} \sum_{j} \mathbf{y}_{j} & \frac{\partial \mathbf{F}}{\partial \mathbf{k}_{j}} \end{pmatrix} \begin{pmatrix} \sum_{k} \mathbf{x}_{k} & \frac{\partial \mathbf{F}}{\partial \mathbf{y}_{k}} \end{pmatrix} + \begin{pmatrix} \sum_{j} \mathbf{y}_{j} & \frac{\partial \mathbf{F}}{\partial \mathbf{y}_{j}} \end{pmatrix}^{2} + \begin{pmatrix} \mathbf{t}_{\mathbf{x}}, \mathbf{t}_{t} \end{pmatrix} \mathbf{L} \begin{pmatrix} \mathbf{x} \\ \mathbf{y} \end{pmatrix},$$

where L is the hessian of F with respect to (k,y) at a steady state. Since $\frac{\partial F}{\partial y_j} = -\beta \frac{\partial F}{\partial k_j}$ at a steady state, the L.H.S. of the previous relation is equal to

$$\left(\sum_{j} x_{j} \frac{\partial F}{\partial k_{j}}\right)^{2} - 2\beta \left(\sum_{j} x_{j} \frac{\partial F}{\partial k_{j}}\right) \left(\sum_{j} y_{j} \frac{\partial F}{\partial k_{j}}\right) + \beta^{2} \left(\sum_{j} y_{j} \frac{\partial F}{\partial k_{j}}\right)^{2} \left(t_{x}, t_{y}\right) L\left(x_{y}\right)$$

and, hence, is strictly positive, if $\begin{pmatrix} t & t \\ x, & y \end{pmatrix} \neq 0$.

A method similair to that of Scheinkman's [1976] can be used to show that the regularity condition is fulfilled for β sufficiently close to one.

One can summarize the results established above in the following corollary :

COROLLARY IV.2 :

Under assumptions $W_1 - W_4$, those of Theorem III.1 and B_g , there exist $\varepsilon_1 > 0$, $\varepsilon_2 > 0$ such that, if one has: $\forall j, \forall \ell$, $\left\| \frac{\partial F}{\partial x_j \partial y_\ell} \right\| \le \varepsilon_1$, $\left\| \frac{\partial F}{\partial x_j \partial k_\ell} \right\| \le \varepsilon_1$ and $1 - \varepsilon_2 \le \beta < 1$

then the optimal path $((x_t^i), k_t)$ converges when $t \rightarrow \infty$.

Remark IV.4 :

In the case of linear aggregator function with the same discount factor, one has a continuum of stationary points which depend on (θ_o^i) except when the production function is separable. In that case the steady state of the path (k_t) given by Euler's equations is independent of (θ_o^i) .

Appendix 1

Lemma A.1.

Let G be a continuous, convex compact valued correspondence form \mathbb{R}^{m} into \mathbb{R}^{m} . Assume $x^{o} \in int G(k^{o})$, then there exist a neighbourhood $V(k^{o})$ of k^{o} such that for every k in $V(k^{o})$, x^{o} belongs to G(k).

<u>Proof</u>: Let $x^{\circ} \in int G(k^{\circ})$. Then there exists a ball $B(x^{\circ}, \rho)$ centered at x° and with radius ρ included in $G(k^{\circ})$. Since G is lower semicontinuous, there exists a neighbourhood of k° such that for every k in $V_1(k^{\circ})$, $G(k) \cap B(x^{\circ}, \rho) \neq \Phi$.

Assume that the conclusion is false. Then there exists a sequence k^n , $k^n \rightarrow k^o$ such that $G(k^n) \cap B(x^o, \rho) \neq \Phi$ but $x^o \notin G(k^n)$. Let \overline{x}^n denote the projection of x^o on $G(k^n)$ and let y^n be diametrically opposed to \overline{x}^n in $B(x^o, \rho)$, so that \overline{x}^n is also the projection of y^n on

 $G(k^{n})$. Then, $\|\bar{x}^{n} - x^{o}\| = \min \{ \|z - x^{o}\|, z \in G(k^{n}) \} \rightarrow 0$ as $n \rightarrow \infty$.

Thus \bar{x}^n converges to x. On the other hand, let y be a cluster point of the sequence y^n . We have $d(y,G(k^0)) = \lim_n d(y_n,G(k^n)) \ge \rho$ so that y $\notin G(k^0)$. On the contrary by construction $y \in S(x^0,\rho) \subset G(k^0)$ a contradiction. Proof of the "regularity condition" in example I. p.32

Define $\xi_t = (k_t, (z_t^i)_{i \ge 2}) \in \mathbb{R} \times \mathbb{R}^{n-1}$

It has been shown in Benhabib et ali [1985] that the Euler system in a neighbourhood of the steady state is equivalent to :

$$(\xi_{t+1}, \xi_{t+2}) = F(\xi_t, \xi_{t+1})$$

The Jacobian matrix DF calculated at the steady state has the following form :

$$\mathsf{DF} = \begin{bmatrix} \mathbf{0} & \mathbf{I} \\ -\mathbf{f'} \mathbf{I} & \mathbf{A} \end{bmatrix}$$

Where A and I (identity matrix) are $(n \times n)$ - matrices and f' is a positive scalar. It has been proven in Benhabib et ali [1985] that :

i) DF has 2 n eigenvalues r_i , i=1,...,2n ; $0 < |r_i| < 1$ for i < n, and $|r_i| > 1$ for i > n.

ii) A is similar to a positive definite matrix with positive eigenvalues γ_i strictly greater than 1 + f'.

Let E, denote the stable subspace of DF.

It can be defined as follows :

$$\mathsf{E}_{1} \left\{ (\mathsf{Q}_{1} \lor, \mathsf{Q}_{2} \lor), \lor \in \mathsf{R}^{\mathsf{n}} \right\}$$

where Q_1 and Q_2 are (n x n)-matrices.

One has to prove this assertion :

or in other words $\det Q_1 \neq 0$.

If it is not the case, and since E_1 is n-dimensional, then there exists (0, v), with $v \neq 0$, which belongs to E_1 . That means that $DF^t\begin{pmatrix} 0\\ v \end{pmatrix} \neq 0$ when $t \neq \infty$.

Since there exists P such that :

$$P^{-1} \land P = \Gamma = \begin{pmatrix} \gamma_1 & 0 \\ 0 & \gamma_n \end{pmatrix}$$

Then

DF

$$t \begin{pmatrix} 0 \\ v \end{pmatrix} = \begin{pmatrix} P & 0 \\ 0 & P \end{pmatrix} \begin{pmatrix} 0 & I \\ -f'I & r \end{pmatrix} t \begin{pmatrix} 0 \\ W \end{pmatrix}, W = P^{-1} v \neq 0.$$

Let (W_i) be the coordinates of W.

One can easily check that

$$\begin{pmatrix} 0 & I \\ -f' & I & r \end{pmatrix}^{t} \begin{pmatrix} 0 \\ W \end{pmatrix} = \begin{pmatrix} (\beta_{i,t} & W_{i})_{i=1,\ldots,n}, & (\beta_{i,t+1} & W_{i})_{i=1,\ldots,n} \end{pmatrix}$$

where the sequence $\left\{ \beta_{i,t} \right\}$ verifies the induction relation :

 $\beta_{i,t+1} = \gamma_i \beta_{i,t} - f' \beta_{i,t-1}$

with initial values $\beta_{i,0} = 0$, $\beta_{i,1} = 1$

Thus : $\beta_{i,t} = \lambda_{i,1} r_{i,1}^{t} + \lambda_{i,2} r_{i,2}^{t}$

where $r_{i,1}$, $r_{i,2}$ are the positive roots of the characteristic equation $r^2 - \gamma_i r + f' = 0$.

Furthermore : $r_{i,1} < 1$, $r_{i,2} > 1$

Since, $\beta_{i,0} = 0$, and $\beta_{i,1} = 1$ one has $\lambda_{i,2} \neq 0$

As $W \neq 0$ there exists i_0 such that $\begin{vmatrix} \beta_{i_0}, t & W_{i_0} \end{vmatrix} + + \cdots$ when $t \neq + \infty$, yielding a contradiction.

<u>Lemma A2</u> - Let Σ be the correspondence from R_{+}^{m} into $(R_{+}^{m})^{n}$ defined as follows : $\Sigma(x) = \left\{ (x^{i}) \in (R_{+}^{m})^{n}, \begin{array}{c} n \\ \Sigma \end{array} \right\} \times \left\{ x^{i} = x \right\}$. Then Σ is compact convex valued and continuous.

Proof I is trivially compact convex valued and has a closed graph.

Let us show that it is lower semi-continuous : let \hat{x} be fixed in R_{+}^{m} . Assume $\hat{x}_{1} = \ldots = \hat{x}_{1} = 0$ and $\hat{x}_{1+1} > 0 \ldots \hat{x}_{m} > 0$.

Let $(x^{i}) \in \Sigma(\hat{x})$ ie $\Sigma x^{i} = \hat{x}$. This implies $x^{i}_{h} = 0$, $\forall i$, $\forall h = 1...1$.

Let $\hat{x}_v \rightarrow \hat{x}$. En particular $\hat{x}_{vh} \rightarrow 0$ for h = 1...1.

Let $1 \le h \le 1$, define $x_{vh}^{i} = \frac{\hat{x}_{vh}}{n}$ then $x_{vh}^{i} \rightarrow 0$ and $\sum_{i} x_{vh}^{i} = \hat{x}_{vh}$

Let $h \ge 1 + 1$, then there exist j(h), $\varepsilon > 0$ such that $x_h^j > \varepsilon$.

There exists v_0 such that $v > v_0$ implies $|x_{vh} - x_{h}| < \varepsilon$.

Let
$$x_{vh}^{ij} = \hat{x}_{vh} - \hat{x}_{h}^{i} + x_{h}^{j} > 0$$
 and for $i \neq j(h)$, $x_{vh}^{i} = x_{h}^{i}$

Then $\Sigma \times_{vh}^{i} = \hat{X}_{vh}$ and $\times_{vh}^{i} \rightarrow \times_{h}^{i} \forall i$.

<u>Proposition</u> - The correspondence from X into X^m

 $\mathbf{A}(\mathbf{x}) = \left\{ \begin{array}{c} (\mathbf{x}^{i}) & \mathbf{\epsilon} \end{array} \right\} \mathbf{x}^{m}, \ \mathbf{x} \\ \mathbf{x}^{i} = \mathbf{x} \end{array} \right\} \text{ is continuous.}$

<u>Proof</u> - X^{m} being endowed with the product topology, it suffices to show that each "coordinate map", $\underset{\sim}{\times} \rightarrow \{(x_{t}^{i}) \in (R_{+}^{m})^{n}, \underset{i}{\Sigma} x_{t}^{i} = x_{t}\}$ is continuous. This last map is the composite of the ""the projection" with Σ defined above and is therefore continuous.
