Preface to "Surface Chemistry and Catalysis"

1. Background

Nowadays, heterogeneous catalysis plays a prominent role. The majority of industrial chemical processes, involving the manufacturing of commodity chemicals, pharmaceuticals, clean fuels, etc., as well as pollution abatement technologies, have a common catalytic origin. As catalysis proceeds at the surface, it is of paramount importance to gain insight into the fundamental understanding of local surface chemistry, which in turn governs the catalytic performance. The deep understanding at the atomic level of a catalyst surface could pave the way towards the design of novel catalytic systems for real-life energy and environmental applications.

Thanks to surface science we can obtain profound insight into the structure of a surface, the chemical state of active sites, the interfacial reactivity, the way molecules bind and react, the role of surface defects and imperfections (e.g., surface oxygen vacancies), and the mode of action of various surface promoters/poisons. To elucidate the aforementioned surface phenomena, sophisticated techniques in combination with theoretical studies are necessary to reveal the composition and the structure/morphology of the surface as well as the chemical entity of adsorbed species. Moreover, time-resolved methods are required to investigate the dynamic phenomena occurring at the surface, such as adsorption/desorption, diffusion and chemical reactions. Under this perspective, it was clearly revealed, based on the recently published review articles by the Guest Editor, that the complete elucidation of a catalytic phenomenon (e.g., metal-support interactions [1]) or the fundamental understanding of a specific catalytic process (e.g., N₂O decomposition [2]) requires a holistic approach involving the combination of advanced ex situ experimental and theoretical studies with in situ operando studies.

2. This Special Issue

In light of the above aspects, the present themed issue aims to cover the recent advances in "surface chemistry and catalysis" that can be obtained by means of advanced characterization techniques, computational calculations and time-resolved methods, with particular emphasis on the structure-activity relationships (SARs). It consists of 14 high-quality papers, involving: a comprehensive review article on the surface analysis techniques that can be employed to elucidate the phenomenon of electrochemical promotion in catalysis [3]; two theoretical studies (Density

Functional Theory, DFT) on H_2O dissociation and its implications in catalysis [4,5]; two mechanistic studies by means of temperature-programmed desorption/surface reaction (TPD/TPSR) and/or operando spectroscopy on N_2O formation over NO_x storage-reduction (NSR) catalysts [6] and on methanol reforming over cobalt catalysts [7]; two articles on H_2 production by the steam reforming of ethanol [8] or diesel [9] over transition metal-based catalysts; two articles on the production of commercial fuels by Fisher-Tropsch synthesis [10,11]; two articles on Au-catalyzed CO oxidation [12] and preferential CO oxidation [13]; and three experimental investigations regarding the structure-activity correlation of NO oxidation to NO_2 over Mn-Co binary oxides [14], cyclohexene oxidation on TiZrCo mixed oxides [15] and alkene epoxidation on silica nanoparticles [16].

Contribution Highlights

The comprehensive review of González-Cobos J. and de Lucas-Consuegra A. [3] addresses the latest contributions made in the field of surface analysis towards the fundamental understanding of the Electrochemical Promotion of Catalysis (EPOC). The authors clearly revealed that the combination of in situ and ex situ surface analysis techniques, such as SEM, XPS, STM, SPEM, UPS, can provide the basis of a better understanding of the alkali-induced promotional effects. This multifunctional surface approach allows the authors to gain insight into the local surface structure of promoter species as well as of back-spillover phenomena taking place under electrochemical promotion conditions. Given the paramount importance of alkali promoters in catalysis, the results presented in this review can shed some light into the underlying mechanism of electrochemical promotion, also paving the way towards the design of highly active conventional heterogeneous catalysts.

Kilin D. and co-workers [4] investigated, by means of DFT calculations combined with density matrix equations of motion, the charge transfer mechanism involved in H_2O dissociation over titanium-doped microporous silica. The results revealed that silica substrates contain electrons and hole trap states, which could facilitate the water splitting. This provided strong evidence towards the key role of the substrate in the electron/hole dynamic processes involved in H_2O dissociation. In this regard, the fine-tuning of metal and/or substrate characteristics could lead to the optimization of (photo)catalytic efficiency.

In a similar manner, Wang W. et al. [5] explored, by means of DFT calculations, the adsorption of H_2O and its dissociation fragments (OH, H and O) on clean and O-pre-adsorbed Fe(100) surfaces. It was demonstrated that interactions between the different adsorbates and catalyst surface followed the order: $H_2O < OH < H < O$. More interestingly, it was revealed that both the H abstraction from the H_2O molecule and the subsequent OH dissociation are favored over O-pre-adsorbed Fe(100) surfaces. The results confirmed that the presence of pre-adsorbed oxygen on

the catalyst surface can notably enhance the H_2O dissociation, opening new horizons towards the development of more efficient catalysts.

In a comprehensive mechanistic study by Forzatti P. and co-workers [6], the origin of N_2O formation over Pt-BaO/Al $_2O_3$ and Rh-BaO/Al $_2O_3$ model NSR catalysts was investigated by micro-reactor transient reactivity experiments and operando Fourier transform infrared (FT-IR) spectroscopy. It was clearly revealed that N_2O formation involves the coupling of undissociated NO molecules with N-adspecies formed via NO dissociation onto the reduced metal sites. In this regard, the N_2O formation is dependent on the oxidation state of the metal sites. At high temperatures, where the reductants effectively keep the metal sites in a fully reduced state, complete NO dissociation is achieved, thus hindering the N_2O formation. In contrast, at low temperatures, where the reductants start to reduce the active sites, the N_2O formation is favored.

The adsorption characteristics of methanol and its reforming products over Co-Mn catalysts were systematically investigated by Papadopoulou E. and Ioannides T. [7] through temperature-programmed desorption (TPD) studies. The influence of various parameters, in relation to the synthesis procedure and the Co/Mn ratio, into adsorptive properties was systematically explored in order to gain insight into the structure-activity relationships. The results indicated that the activity differences can be mainly related to the relative population and the nature of active sites. In particular, Co and Mn sites were considered to be responsible for H₂ desorption at low and high temperatures, respectively, whereas the interfacial sites can be considered for the intermediate temperature H₂ desorption.

Konsolakis et al. [8] reported on the Ethanol Steam Reforming (ESR) of various transition metals (Ni, Co, Cu, Fe) supported on CeO₂ with particular attention to surface chemistry aspects. A complementary surface characterization study was undertaken to reveal the impact of metal entity and/or metal-support interactions on the reforming activity. The results revealed the excellent reforming performance of Co/CeO₂ catalysts, both in terms of H₂ yield and life-time stability. The latter was attributed, inter alia, to the high oxygen mobility of cobalt-ceria binary oxides, mainly linked with the high population of lattice oxygen species. This factor can be considered responsible for the facile gasification of the carbonaceous species, thus preventing catalyst deactivation.

The impact of structural promoters (La, Ba, Ce) on the Diesel Steam Reforming (DSR) of Ni/Al_2O_3 catalysts was explored in detail by Tribalis A. et al. [9]. Incorporation of dopants into the Al_2O_3 carrier was found to be always beneficial, but to a different extent, depending on the nature of the promoter. The optimum performance, in terms of activity and stability, was obtained by simultaneously doping the Al_2O_3 support with Ba and La modifiers. On the basis of a complimentary surface characterization study, the latter was attributed to the increase

of dispersion and reducibility of the Ni phase in conjunction with the decrease of the support acidity.

Lopez L. et al. [10] comparatively explored the catalytic performance of Rh/MCM-41 and Rh/SiO₂ catalysts for ethanol synthesis from syngas. The obtained differences in activity and selectivity were attributed, on the basis of complementary catalytic and surface characterization studies, to the different concentrations of water vapor in the pores of Rh/MCM-41. The latter was considered responsible for the enhanced formation of CO₂ and H₂ over Rh/MCM-41 catalysts through the water-gas-shift-reaction (WGSR).

De la Osa A.R. et al. [11] investigated Fisher-Tropsch synthesis (FTS) over Co/SiC catalysts with particular emphasis on the impact of cobalt precursor (nitrate, acetate, chloride, citrate) on FTS activity. Surface titration techniques along with an extended characterization by TPR and TEM were employed to gain insight into the structure-activity correlation. It was found that the nature of the precursor notably affects the acid/base properties as well as the metallic particle size, with great consequences on the FTS activity and chain growth probability. Cobalt nitrate provided the optimum activity and selectivity to C_5^+ , which was attributed to the higher particle size, degree of reduction and basicity as compared to the other precursors.

Cui H.-Z. et al. [12] studied low-temperature CO oxidation over Au/FeO_x catalysts, employing two different types of iron oxide supports, i.e., hydroxylated (Fe-OH) and dehydrated (Fe-O) iron oxides, and different preparation procedures (precipitation pH, calcination temperature). Surface characterization by a series of advanced characterization techniques, i.e., high-resolution transmission electron microscopy (HRTEM), X-ray photoelectron spectroscopy (XPS) and X-ray absorption near edge structure (XANES) spectroscopy, was carried out to explore the relationship between the nature of the oxide matrix and the catalytic activity. The results revealed that the surface chemistry of Au nanoparticles can be notably influenced by the nature of the support as well as by the preparation procedure following, with vast consequences on the catalytic activity. Metallic gold particles strongly interacting with the oxide carrier were determined as the active sites for CO oxidation.

Widmann D. and co-workers [13] explored, in a comprehensive manner, the underlying mechanism of the CO-PROX reaction over Au/TiO_2 catalysts by means of quantitative temporal analysis of products (TAP) reactor measurements. The authors concluded that CO and H_2 are oxidized by the same active oxygen species under PROX conditions, independently of the CO/H_2 ratio; both CO and H_2 compete for TiO_2 surface lattice oxygen located at the perimeter sites of the metal-support interface. In light of these findings, the authors suggested that the strategies for more selective Au catalysts should focus on the fine-tuning of the support material and/or the metal-support interface perimeter sites.

Qiu L. et al. [14] investigated the low-temperature oxidation of NO to NO $_2$ over Co-Mo/TiO $_2$ catalysts with particular attention to the impact of Co loading and the calcination temperature. Cobalt incorporation into Mo/TiO $_2$ catalysts in conjunction with calcination at moderate temperatures (300–400 $^{\circ}$ C) resulted in the optimum oxidation performance. By means of various surface characterization techniques, a close correlation between the redox characteristics (Mn oxidation state, amount of surface adsorbed oxygen) and the NO oxidation performance was revealed.

Liu T. et al. [15] investigated the aerobic oxidation of cyclohexene to value-added chemicals over TiZrCo metallic catalysts. High conversion of cyclohexene (>90%) accompanied by high selectivity to 2-cyclohexen-1-one (ca. 58%) was obtained by this particular catalyst, and these are among the highest values reported. Surface characterization revealed that CoO and $\rm Co_3O_4$ are the active sites contributing to the superior performance of TiZrCo catalysts.

Finally, Li X. et al. [16] examined the cyclooctene epoxidation over phosphotungstate-based ionic silica nanoparticles. The novel synthesized silica network was extremely active for cyclooctene epoxidation, offering almost complete conversion and selectivity to epoxy-cycloocten at 70 °C. The superior efficiency of the as-synthesized material as compared to bare SiO₂ nanoparticles was ascribed, based on an extended characterization study, to their optimal textural and structural/morphological characteristics.

In summary, the aforementioned special issue highlights the ongoing importance of the "surface chemistry approach", from both theoretical and experimental points of view, towards the fundamental understanding of catalytic phenomena. I am very pleased to serve as the Guest Editor of this thematic issue involving 14 high-quality studies on the interfacial discipline of "surface chemistry and catalysis". Firstly, I would like to express my gratitude to Professor Keith Hohn, Editor-in-chief of the Catalysts journal, for his kind invitation to organize this thematic issue. Special thanks to the editorial staff of Catalysts, particularly to Senior Assistant Editor Ms. Mary Fan, for their efforts and continuous support. Moreover, I am most appreciative to all authors for their contributions and hard work in revising them as well as to all reviewers for their valuable recommendations that assisted authors in upgrading their work to meet the high standards of Catalysts. A Review of Surface Analysis Techniques for the Investigation of the Phenomenon of Electrochemical Promotion of Catalysis with Alkaline Ionic Conductors

Electrochemical Promotion of Catalysis (EPOC) with alkali ionic conductors has been widely studied in literature due to its operational advantages vs. alkali classical promotion. This phenomenon allows to electrochemically control the alkali promoter coverage on a catalyst surface in the course of the catalytic reaction. Along the study of this phenomenon, a large variety of in situ and ex situ surface analysis techniques have been used to investigate the origin and mechanism of this kind of promotion. In this review, we analyze the most important contributions made on this field which have clearly evidenced the presence of adsorbed alkali surface species on the catalyst films deposited on alkaline solid electrolyte materials during EPOC experiments. Hence, the use of different surface analysis techniques such as scanning electron microscopy (SEM), energy-dispersive X-ray spectroscopy (EDX), X-ray diffraction (XRD), X-ray photoelectron spectroscopy (XPS), scanning photoelectron microscopy (SPEM), or scanning tunneling microscopy (STM), led to a better understanding of the alkali promoting effect, and served to confirm the theory of electrochemical promotion on this kind of catalytic systems. Given the functional similarities between alkali electrochemical and chemical promotion, this review aims to bring closer this phenomenon to the catalysis scientific community.

1. General Features of Alkaline Electrochemical Promotion

Promoters are widely used in the heterogeneous catalysis field [1,2]. Structural promoters improve the dispersion and stability of the active phase on the catalyst support, while electronic ones enhance the catalytic properties of the active phase itself. This latter kind of promoters can be added to the catalyst *ex situ*, *i.e.*, during the catalyst preparation step, or *in situ*, *i.e.*, in the course of the catalytic reaction, through the phenomenon of Electrochemical Promotion Of Catalysis (EPOC). This phenomenon, also known in literature as "Non-faradaic Electrochemical Modification of Catalytic Activity" (NEMCA effect) [3], is based on the modification

of the performance of a catalyst by the electrochemical pumping of promoter ions from an electro-active catalyst support, which is a solid electrolyte material, e.g., H^+ , Na^+ , K^+ , O^{2-} , or F^- ionic conductors [4]. Although the first works on electrochemical promotion were carried out by using yttria-stabilized zirconia (YSZ), *i.e.*, an O^{2-} ionic conductor material, as solid electrolyte [5], alkaline conductors such as the β -alumina family or NASICON-like compounds (e.g., $Na_3Zr_2Si_2PO_{12}$, $K_2YZr(PO_4)_3$, or $Li_{14}ZnGe_4O_{16}$), among others, have also been widely studied on the electrochemical promotion field [6,7].




Figure 1. Scheme of the electrochemical cell used in electrochemical promotion studies with an alkaline ionic conductor (generally indicated as M^+ -conductor) solid electrolytes.

In the case of electrochemical catalysts based on alkali (M⁺)-conductors, the application of a cathodic polarization (i.e., negative current or overpotential) between the catalyst film-working electrode, which is deposited on one side of the electrolyte, and an inert counter electrode (typically gold) located at the opposite side (see Figure 1) leads to the migration of promoter (M⁺) ions to the catalyst film, which is also called as back-spillover phenomenon. Once located over the catalyst surface, as in chemical (classical) promotion, these ionic species modify its chemisorption properties and hence its catalytic performance [3]. Thus, some of the main advantages of electrochemical promotion vs. classical promotion in heterogeneous catalysis are the capability of optimizing the amount of promoter coverage under changing reaction conditions and the possibility of in situ tuning the catalyst performance to maximize its activity and selectivity toward the desired product, even preventing catalyst deactivation or allowing its regeneration. These operational advantages classical promotion, among others, have recently been revised by A. de Lucas-Consuegra [6]. It should also be noted that there are important differences in operating EPOC systems depending on the nature of the employed electro-active catalyst support. When using ionic conductor materials where the supplied ions can also participate in the catalytic reaction under study (e.g., O^{2-} ions in the case of catalytic oxidations or H⁺ ions in catalytic hydrogenations) then these ions act as "sacrificial promoters" and present a finite mean residence time on the catalyst surface. In these cases, both galvanostatic and potentiostatic operations allow to obtain a steady-state catalytic reaction rate at each applied current or potential, respectively. However, when using solid electrolytes where the ionic conducting species are not involved in the catalytic reaction (e.g., Na⁺ or K⁺ ions) then only potentiostatic operation leads to steady-state reaction rates and, under galvanostatic operation, the coverage of the M^+ promoter, θ_{M^+} , increases with time as long as a constant electric current is maintained [3]. However, in these cases, as will be shown later, these alkali ions typically react with co-adsorbed reactant molecules on the gas-exposed catalyst surface leading to the formation of a large variety of promotional species.

ELECTROCHEMICAL PROMOTION (EPOC)




Figure 2. Scheme of the different surface analysis techniques used for investigating alkaline Electrochemical Promotion effect.

Vayenas et al. performed the first electrochemical promotion study with alkaline solid electrolyte (Na-βAl₂O₃) in 1991 [8]. From this pioneer work, Na⁺-conductors have been widely employed in many catalytic systems such as ethylene [9,10], CO [11], propane [12] and propylene oxidation [13], NO reduction [14–16], Fischer Tropsch synthesis [17], or hydrogenation of benzene [18] and CO₂ [19]. On the other hand, the first EPOC study using a K⁺-conductor electrolyte (K₂YZr(PO₄)₃) dates from 1997 and addressed the Fe-catalyzed ammonia decomposition [20]. Urquhart et al. used other K⁺-conductor solid electrolyte (K-βAl₂O₃) in Fischer-Tropsch reaction studies under both atmospheric [21] and high pressure [22], and de Lucas-Consuegra et al. introduced the use of this kind of ion-conducting catalyst support for the electrochemical promotion of Pt in CO [23] and propylene [24] oxidation, as well as in NO_x reduction reactions [25,26]. More recent alkaline electrochemical promotion studies on CO₂ hydrogenation [27-30] and methanol conversion reactions [31-33] should also be highlighted. Additionally, in order to understand the mechanism of the phenomenon of electrochemical promotion of catalysis with both anionic and cationic conductors, a wide variety of characterization techniques have been used in the fields of catalysis (e.g., TPD, TPO, or work function measurement), electrochemistry (e.g., cyclic/linear sweep voltammetry or impedance spectroscopy), and surface science (e.g., XPS, UPS, SPEM, or STM) [3]. This paper aims to summarize the most relevant contributions relative to the latter techniques carried out in literature on electrochemical promotion with alkaline conductors. For this purpose, the surface characterization studies summarized in the next two sections have been divided into two categories, depending on whether they were performed under potentiostatic/galvanostatic control (in situ analysis) or not (ex situ analysis), as schematically shown in Figure 2. All these techniques have contributed to the further understanding of the alkali electro-promotional effect in good agreement with the general rules of chemical and electrochemical promotion, valid for the different kinds of electronic promoters (both anionic and cationic ones) [3].

2. Ex Situ Characterization of Alkali-Promoted Catalyst Surfaces

The post-reaction characterization and analysis of the surface state of a catalyst film, previously subjected to given electrochemical promotion conditions, can be carried out *ex situ* by the following generic procedure. In the first place, the catalyst film is exposed to the reaction mixture while applying a certain positive or negative overpotential (for establishing an unpromoted or electropromoted state, respectively). After a given time, the reactor is cooled down to room temperature at the same applied overpotential. Then, the reactor and pipe lines are swept with inert gas and open-circuit conditions are established when the temperature is below 373 K (approximately), *i.e.*, when alkali ions mobility is too low. Finally, the electrochemical catalyst is transferred, under inert atmosphere, from the reactor to the characterization equipment. The aim of this procedure is to "freeze out" the catalyst surface state pertaining to the desired unpromoted/electropromoted state.

SEM and other microscopy techniques are widely employed in catalysis field to evaluate the structure and morphology of the catalysts. In EPOC studies, this technique, together with Energy-dispersive X-ray (EDX) spectroscopy, has also been employed to identify the arrangement and nature of the promoter phases present on the catalyst surface. For instance, Figure 3 shows the SEM micrograph, along with the corresponding elemental mapping and spectra by EDX, of a selected region of a Cu catalyst film deposited on a K- β Al₂O₃ pellet (K⁺-conductor) used for the electrochemical promotion of the methanol partial oxidation reaction [32]. Prior to the surface analysis, the catalyst was subjected to certain reaction conditions and an applied potential, $V_{WR} = -0.5$ V, such that K⁺ promoter ions were electrochemically supplied to the catalyst surface. As a consequence, in these micrographs, a large concentration of potassium (in blue) was found on the Cu catalyst surface (in green). This demonstrated that K⁺ ions were able to migrate through the catalyst film and reached the gas-exposed catalyst surface. As also revealed by the EDX analysis taken from different areas of the micrograph (Figure 3c1,c2), oxygen- and potassium-containing surface compounds seemed to be formed on the metal catalyst film during the EPOC experiments, probably in form of some potassium oxides or carbonate molecules. In fact, an excess of these surface species (supplied under high cathodic polarization) could block the Cu active sites causing a decrease in the catalytic reaction rate in agreement with conventional chemical promotion [32]. Furthermore, some nitrogen (in red) was also noticed, homogeneously distributed on the catalyst surface, which was attributed to the K⁺-promotional effect on the ammonia formation via reaction of hydrogen and nitrogen, both of them present in the gas reaction atmosphere.




Figure 4. XRD spectra after EPOC experiments (CH₃OH/O₂ = 7.2%/4.6%, 593 K, overnight at -2 V) of a Pt film prepared by impregnation on a K-βAl₂O₃ solid electrolyte. Reprinted with permission from Ref. [31].

The presence of potassium carbonate/bicarbonate species was also identified on the surface of a promoted Pt/K-βAl₂O₃ electrochemical catalyst employed in a methanol partial oxidation reaction [31]. In this study, these kinds of promoter-derived compounds were also detected ex situ by X-ray diffraction analysis after EPOC experiments, as shown in Figure 4. As in the case of the electropromoted Cu catalyst film, a poisoning effect derived from an excess of K⁺-derived surface species was found on this Pt film [31]. Furthermore, in both mentioned studies [31,32], the obtained electropromotional effect was completely reversible since all the promoter phases were decomposed and the alkali ions were transferred from the catalyst back to the solid electrolyte after applying a positive enough potential at the end of the experiments. In this way, a clean, un-promoted catalyst surface, free of any promoter species, was achieved. These surface species were also observed by SEM-EDX analysis on Pt catalyst films deposited on K-βAl₂O₃ solid electrolyte for propene oxidation reaction [24]. In this case, the presence of potassium oxides and superoxides, along with carbon deposited fragments were observed after catalytic experiments. Moreover, these K⁺-derived species seemed to induce a permanent

EPOC effect and showed to be more stable than potassium carbonates or bicarbonates, since the latter needed lower positive potentials to be decomposed. These results demonstrated that the nature of the final form of alkali promoter species and their chemical structure (e.g., oxides, superoxides, carbonates, *etc.*) strongly influence the final electropromotional behavior.




Figure 3. Top view SEM image of a selected area of a Cu/K- β Al₂O₃ electrochemical catalyst (a) after the EPOC experiments (593 °C, CH₃OH/O₂ = 4.4%/0.3%, $V_{\rm WR}$ = -0.5 V for 1 h), along with the corresponding elemental mapping (**b1** and **b2**) of Cu (green), K (blue), and N (red) and the EDX spectra from different regions (**c1** and **c2**). Reprinted with permission from Ref. [32].

It should be noted that other characterization techniques such as X-ray photoelectron (XPS) [32] and Fourier transform infrared (FTIR) [24] spectroscopies have also been *ex situ* employed in the past to study the chemical state of the different alkali promoter species formed on the catalyst surface under EPOC conditions, obtaining similar information about the nature of the different promotional species.

3. In Situ Characterization of Alkali-Promoted Catalyst Surfaces

During the alkaline electrochemical promotion of a catalyst film, the influence of the applied potential on the promoter coverage, as well as the nature and stability of the alkali-derived surface species, can be *in situ* evaluated by different techniques. Indeed, the progress made in the development and understanding of the phenomenon of electrochemical promotion over the years could not be conceived without the *in situ* spectroscopy studies performed by the group of professor Lambert and co-workers [34–45]. In all cases, the spectra were obtained immediately after exposing the appropriately polarized catalyst film (either unpromoted or electrochemically promoted) to conditions of temperature and reactant partial pressures similar to those encountered in the electrochemical promotion reactor, in order to simulate the different surface conditions of interest. For this purpose, spectrometers equipped with a reaction cell (under galvanostatic/potentiostatic control) and an ultra high vacuum chamber were used, in such a way that the electropromoted sample was mounted on a manipulator that allowed its translation between both chambers.




Figure 5. Na 1s XPS spectra taken on a Rh/Na- β Al₂O₃ electrochemical catalyst (580 K, UHV conditions), showing the effect of catalyst potential (V_{WR}) on sodium coverage (**a**). Invariant component due to Na on Rh; shifting component due to Na in solid electrolyte. Influence of V_{WR} on the integrated Na 1s XPS intensity due to Na on the Rh surface and associated work function change of the catalyst film (**b**). Reprinted with permission from Ref. [41]. Copyright 2000 American Chemical Society.

X-ray photoelectron spectroscopy (XPS) and Auger electron spectroscopy (AES) measurements have been carried out on Pt [34–38,40], Rh [39,41–43] and Cu [41,44,45] catalyst films used in alkaline electrochemical promotion studies for the oxidation of ethylene [34] or propene [37], hydrogenation of acetylene [38], and reduction of NO by CO [36,40–45] or by propene [35,39,42,43]. In first place, all these studies demonstrated that the mode of operation of the electrochemically promoted catalyst films involves reversible pumping (backspillover) of Na⁺ or K⁺ ions from the solid

electrolyte in agreement with the theory and rules of Electrochemical Promotion of Catalysis. For instance, Figure 5a shows the Na 1s XPS spectra obtained on a Rh catalyst supported on Na- β Al₂O₃, at 580 K, as a function of catalyst potential (V_{WR}) under ultra-high vacuum conditions [41]. The +1 V spectrum corresponds to the clean (unpromoted) sample, while increasingly negative values of V_{WR} correspond to increasing amounts of electropumped Na⁺ on the catalyst surface. As typically observed in these studies [35,38,40-42,44,46], the Na 1s emission comprises two components. The first one exhibits invariant binding energy (BE) and its intensity increases with decreasing V_{WR} , i.e., as Na⁺ ions are electropumped to the catalyst. This is ascribed to sodium at the surface of the (grounded) Rh catalyst film. The second (shaded) component exhibits constant intensity and a systematic shift in apparent BE. This shift is numerically equal to the change in catalyst potential, strongly suggesting that this emission arises from the underlying solid electrolyte, whose electrostatic potential differs from that of the Rh film by the change in V_{WR}. This interpretation was confirmed by the experimental results obtained by grazing exit synchrotron photoemission, where the signal from the electrolyte vanished [46]. As also stated in the other referenced studies, the spectral behaviour was reversible and reproducible as a function of V_{WR} , consistent with the reversible and reproducible catalytic response observed during the electrochemical promotion of the Rh catalyst for the NO reduction reaction with both CO and C₃H₆ [41]. Hence, as it can be drawn from Figure 5b, the decrease in the catalyst potential to -1 V leads to a linear increase in the Na⁺ coverage (θ_{Na^+}), up to around 0.025 monolayers, which may be estimated from the integrated Na 1s intensity of the component associated with the metal surface [47]. Moreover, the catalyst work function (ϕ) also shows to vary linearly with V_{WR} in such a low θ_{Na^+} range. In this case, work function changes were determined by ultraviolet photoelectron spectroscopy (UPS), by measuring the change in secondary electron cutoff in the spectrum relative to the Fermi edge [41], although it can also be *in situ* measured with a Kelvin probe [48]. Very interestingly, XPS data also allowed verifying that electrochemically pumped sodium is identical in behavior and in chemical state with Na supplied by vacuum deposition from a Na evaporation source [35], which is in very good agreement with the close similarities found between electrochemically-promoted catalysts and conventionally-promoted ones [35,49].




Figure 6. (a) Sodium KLL XAES, (b) Sodium 1s XPS and (c) Carbon 1s XPS analysis of a Pt/Na-βAl₂O₃ electrochemical catalyst under propene combustion atmosphere (0.6 kPa propene, 2.5 kPa oxygen). All spectra acquired at room temperature, open circuit, after exposure to different un-promoted and electropromoted conditions: 1, poisoned conditions, $V_{\rm WR} = -600$ mV; 1b, as 1 but after heating to 588 K; 2, promoted conditions, $V_{\rm WR} = -100$ mV; 2b, as 2 but after heating to 588 K; 3, as 2 but after imposing $V_{\rm WR} = +500$ mV. (d) XANES spectra after exposure to propene and oxygen at 500 K under promoted and poisoned conditions (See Ref. [37] for temperature and partial pressures conditions). Reference XANES spectra for the cleaned surface, Na₂CO₃ and NaHCO₃ are also shown. Reprinted with permission from Ref. [37].

XPS is also a very useful technique for the in-situ identification of alkali-derived surface compounds and for the study of their formation/decomposition on the catalyst surface during the electrochemical promotion experiments. In this way, depending on the reaction atmosphere, NaNO₂ [40], NaNO₃ [40,43-45] and Na₂CO₃ [34,37,39,43] were found on the electropromoted catalyst surface which, in excess, induced a poisoning effect on the catalytic activity [34,37,40]. A very illustrative example is the work carried out by Filkin et al. on propene oxidation reaction with a Pt/Na-βAl₂O₃ catalyst, where not only XPS but also X-ray excited AES and X-ray absorption near edge structure (XANES) were performed [37]. Figure 6a,b show the Na KLL Auger and Na 1s XPS spectra obtained after exposure of the catalyst to the reaction mixture and to an applied potential (V_{WR}) such that the Pt film was either poisoned ($V_{WR} = -0.6 \text{ V}$, spectrum 1), promoted ($V_{WR} = -0.1 \text{ V}$, spectrum 2) or electrochemically clean ($V_{WR} = +0.5 \text{ V}$, spectrum 3). The Na KLL auger data show that the catalyhst surface promoted at slightly negative potential presents a lower amount of Na-containing compounds than the poisoned surface (i.e., at higher negative potential), and that these promoter phases are stable at reaction temperature (588 K) but decomposed by pumping the Na⁺ ions back to the solid electrolyte. Moreover, as the authors stated, during the positive polarization, the pressure in the vacuum system increased, denoting that gaseous molecules released upon decomposition of the alkali-derived compounds. The Na 1s XPS spectra

confirm the stability of the Na⁺-derived compounds at reaction conditions and their decomposition under positive polarization. However, this kind of spectrometry technique does not allow distinguishing the Na loading obtained under promoted and poisoned conditions, in contrast to Auger electron spectroscopy (Figure 6a). This feature can be explained according to the different electron escape depths related to the AE and XPS spectra (with sampling depths of around 25 and 8 Å, respectively [37]). On the other hand, the carbon 1s XPS spectra (Figure 6c) not only confirm that the poisoned surface presents a much higher amount of Na⁺-derived compounds formed under reaction conditions, but also provide some proof concerning the chemical nature of these species, which likely consist of sodium carbonates, as also verified by the XANES results (Figure 6d).




Figure 7. Pt 4f7/2 and K 2p3/2 photoelectron intensity maps taken on a Pt/K- β Al₂O₃ catalyst as a function of V_{WR} at 473 K during the selective hydrogenation of acetylene. Reprinted with permission from Ref. [38].

In two of the previously mentioned studies [38,46], scanning photoelectron microscopy (SPEM) was also used to *in situ* analyze the surface of Cu [46] and Pt [38] catalysts promoted by Na⁺ and K⁺, respectively. For instance, Figure 7 shows the results obtained on this latter work for the alkali-promoted acetylene hydrogenation reaction. Specifically, 6.4 μ m \times 6.4 μ m Pt 4f_{7/2} (raw data), K 2p_{3/2} (raw data) and topography corrected [50] K 2p_{3/2} intensity maps were taken under different applied potentials (V_{WR}) from +0.4 V (unpromoted state) to -0.8 V (electropromoted state). These micrographs show that the Pt signal does not attenuate as K⁺ ions are electrochemically supplied to the catalyst film and that a very small thermal drift takes place during the experiment. On the other hand, after correcting the intensity modulations derived from topography, the K 2p_{3/2} maps show that the alkali promoter is relatively uniformly distributed on the Pt surface, and that its concentration clearly increases upon decreasing V_{WR} .

Furthermore, it should be mentioned that the back-spillover phenomenon with alkaline ions has also been confirmed by scanning tunneling microscopy (STM) over Pt catalysts [51-53]. In these studies, unfiltered STM images were firstly obtained from an air-exposed Pt(111) catalyst film deposited on a Na-βAl₂O₃ solid electrolyte, under open circuit conditions, i.e., before applying any electric current or potential. In this way, a Pt(111)-(2×2)-O adlattice (interatomic distance of 5.6 Å) was found along with an overlapping Pt(111)-(12×12)-Na adlattice (interatomic distance of 33.2 Å) in some regions, the latter being attributed to thermal diffusion of sodium from the Na- β Al₂O₃ during the deposition of the Pt(111) film [51–53]. Then, STM was carried out under both unpromoted and electropromoted established conditions. In the first case, after the application of a positive current or potential, only the Pt(111)-(2×2)-O adlattice remained on the micrograph, thus denoting a Na-free catalyst surface. This demonstrates that an unpromoted (reference) state can be defined by applying a positive enough potential on the catalyst film supported on an alkaline solid electrolyte. In the second case, after applying a negative current (of the order of $-1 \mu A$) for a few minutes, the Pt(111)-(12×12)-Na adlattice

reappeared [51–53]. Then, all these studies show that the origin of alkali-EPOC is clearly due to the reversible migration (back-spillover) of alkali ions to the catalyst surface. These ions may interact with co-adsorbed reactant molecules depending on the reaction conditions forming a wide variety of surface compounds and altering the chemisorption properties of the catalyst in a pronounce and controllable way.

Finally, it should be noted that there is a kind of *in situ* characterization methodology called operando which is acquiring increasing interest in the catalysis scientific community and could be also very helpful in the study of the alkaline electrochemical promotion. This methodology is based on the *in situ* characterization of the catalyst surface while the catalytic activity is simultaneously measured, under real working conditions. However, the perfect correlation between the catalytic activity measurement and the surface analysis is very difficult mainly due to problems arising from the operando cell reactor design. This reactor cell must operate

under specific pressure and temperature conditions while keeping the three-electrode configuration and allowing the spectra collection under such reaction conditions. Moreover, the presence of spectator species in the reaction and void volumes in the reactor, which are typically high for gas phase reactions, may affect the obtained spectra. Thus, new insights in the *in situ* characterization of the EPOC phenomenon could be opened in so far as the operando reactor design is improved and such limitations are overcome.

4. Conclusions and Prospects

It is well known that alkali promoters play a key role in heterogeneous catalysis with special emphasis on catalytic reactions of large scale industrial application such as ammonia or hydrocarbons synthesis. As classical alkali promotion, the phenomenon of electrochemical promotion of catalysis (EPOC) is based on the addition of promoting species to the catalyst active surface in order to modify its chemisorptive properties and, hence, its activity and selectivity. However, in the case of EPOC, the electrically induced back-spillover of the promoter species enables the straightforward study of the promoting role of certain alkali coverage and the *in situ*, controlled, enhancement of the catalytic performance under dynamic reaction conditions. For this reason, it becomes essential the employment of proper surface analysis techniques which allow monitoring the amount and state of the promoter phases as well as a deep understanding of the back-spillover phenomenon. In this sense, several *ex situ* and *in situ* characterization techniques have been carried out for the last two decades that have been described on this paper.

Although the *ex situ* surface analysis techniques involve a series of inaccuracies derived from the necessary handling and transfer of the electrochemical catalyst to the characterization equipment, they may constitute a useful and easy tool to determine the stability of the electrochemical catalyst and to obtain qualitative information about the different species adsorbed on the catalyst surface. On the other hand, the *in situ* characterization techniques provide detailed information about the mechanism of alkali ions backspillover, the nature of the promoter-derived surface compounds and their influence on the catalytic properties, as a function of both the catalyst potential variation and the reaction conditions. Hence, the implementation of surface analysis techniques herein mentioned and other possible such as fourier transform infrared (FTIR) spectroscopy, photoelectron emission microscopy (PEEM), or atomic force microscopy (AFM), in conjunction with the development of alkaline electrochemical promotion experiments, is of paramount importance not only for better understanding of this phenomenon, but also for the design of more efficient and competitive conventional heterogeneous catalysts.

Charge Transfer Mechanism in Titanium-Doped Microporous Silica for Photocatalytic Water-Splitting Applications

Abstract: Solar energy conversion into chemical form is possible using artificial means. One example of a highly-efficient fuel is solar energy used to split water into oxygen and hydrogen. Efficient photocatalytic water-splitting remains an open challenge for researchers across the globe. Despite significant progress, several aspects of the reaction, including the charge transfer mechanism, are not fully clear. Density functional theory combined with density matrix equations of motion were used to identify and characterize the charge transfer mechanism involved in the dissociation of water. A simulated porous silica substrate, using periodic boundary conditions, with ${\rm Ti}^{4+}$ ions embedded on the inner pore wall was found to contain electron and hole trap states that could facilitate a chemical reaction. A trap state was located within the silica substrate that lengthened relaxation time, which may favor a chemical reaction. A chemical reaction would have to occur within the window of photoexcitation; therefore, the existence of a trapping state may encourage a chemical reaction. This provides evidence that the silica substrate plays an integral part in the electron/hole dynamics of the system, leading to the conclusion that both components (photoactive materials and support) of heterogeneous catalytic systems are important in optimization of catalytic efficiency.

1. Introduction

Economical water splitting technology for the development of low-cost and efficient fuels motivates research in many fields. This particular application of the conversion of solar energy into chemical reaction can be accomplished using a catalytic site mounted on a substrate. The periodic pore system that is characteristic of silica substrates is considered to be one of the best options for use in heterogeneous catalysis research, mostly due to its high surface-to-volume ratio [1]. Microand mesoporous materials have a wide range of functionality, some of which are still being discovered [2]. Solar energy conversion [3], energy storage, and

photodynamic therapy [4] are just a few areas in which these materials have found wide-spread utility.

The addition of titanium atoms to the inner surface of the silica pore walls provides a photoactive material [5] and introduces numerous charge transfer states, which can be analyzed by atomistic computational modeling [6-8]. It has been known since the 1970s that titanium dioxide (TiO₂) can be used in water-splitting applications [9]. Since then, numerous researchers have been trying to improve conditions for photocatalysis using TiO₂ in conjunction with various substrates [10,11], dopants [12–14], dyes [15,16], etc. Titanium's distribution onto a periodic and porous substrate has been shown to increase the effectiveness of hydrogen evolution when compared to bulk TiO2 [17]. Evaluation of these parameters is, by no means, a simple task. It is a goal of this research to evaluate one of these parameters and its role in catalysis: a silica substrate. At present, many materials have been reported as photocatalysts for water splitting. However, titanium-doped microporous silica demonstrates H₂ production reaction using sacrificial reagents such as triethanolamine (TEOA) or methanol. This material, thus, is able to perform a significant part of the water-splitting mechanism. By simulation of this model, we learn more details of the role of charge transfer for photocatalysis. Additionally, while it is important to evaluate the other aspects of catalysis, which are known to improve photocatalytic efficiency (i.e., co-catalysts, alternative dopants, dyes, and the use of sacrificial agents), we ventured to simplify the model in order to eliminate parameters that might obscure the role of the silica substrate.

Charge transfer dynamics that occur prior to the dissociation of water molecules near the titanium atoms can be scrutinized using non-adiabatic molecular dynamics [18]. In order to further understand the process by which charge transfer favors water-splitting, electron dynamics may be employed. Ideally, one would analyze bandgap excitation, electron relaxation and dynamics of ions all at once. Since this is not possible with current molecular simulation techniques, a separation of the governing aspects of the reaction must occur. To make this investigation more practical, ground state electronic structure is explored first. This information helps to identify orbital transitions due to excitations, which are of interest. Molecular dynamics [19] are simulated, which leads to couplings [20] and eventually to electron dynamics of photoexcitation [21] that then provides excitation lifetimes [22] and details of the charge transfer meachanism [6–8]. These lifetimes are an integral part of making conclusions about a material and its photocatalytic properties. If electron relaxation rates are low enough, catalytic reactions may occur.

The ability to use photoexcitations as initial conditions for electron dynamics allows for investigations into the dynamics of the formation of possible charge transfer states, which could lead to chemical reactions. A range of the most important orbitals can be narrowed down by visualizing them and identifying orbitals of

interest based on their locations on the model. These orbitals can be used as an input to electron dynamics to compute relaxation dynamics and rates for electrons and holes. These data (on dynamics and rates) allow for the identification of so-called "trap states" [23]. A trap state is defined as an energy state in which the electron or hole becomes trapped for a relatively long time when compared to the overall time of relaxation. The basic idea is that the existence of trapping states could facilitate charge transfer because it encourages charge separation, which can then induce a chemical reaction.

2. Results and Discussion




Figure 1. (**A**) A silicon dioxide slab was created, measuring $5.4 \times 14.7 \times 17.0 \text{ Å}^3$ (cubic Angstroms). Si and O atoms were removed from bulk silica in a deliberate fashion in order to produce a cylindrical pore with a diameter of 10.5 Å On the inner surface of the pore, a Ti atom was added and capped with two hydroxyl groups, giving a tetrahedrally-coordinated Ti; (**B**) Several units are repeated in the x, y, and z directions to demonstrate periodicity.

An alpha-quartz silica slab, of the dimensions $5.4 \times 14.7 \times 17.0 \text{ Å}^3$ (cubic Angstroms) and composition Si₃₆O₇₂, was the basis for this model. Atoms were systematically removed until a ~1 nm cylindrical pore was created, leading to a modified composition of Si₂₄O₄₈. A tetrahedrally-coordinated Ti atom was added to the inner surface of the pore wall and capped, as well as the addition of H caps onto the exposed O atoms. Water molecules were added to the inside of the pore, giving an overall chemical composition of $Si_{24}O_{48}$ + TiO_2H_2 + $11H_2O$. A fraction of water molecules dissociate and adsorb onto uncoordinated ions from the inner surface of the pore: H⁺ to uncoordinated O, and OH⁻ to uncoordinated Si or Ti atoms. Thus, the model contains intact and dissociated water molecules. Figure 1 displays a diagram of the model, indicating the position of the Ti atom in relation to the placement of water molecules within the pore. Oxygen atoms represent the inner surface of the pore. Utilizing periodic boundary conditions in three dimensions, this model simulates a periodic and tubular pore system, which is similar to forms of silica substrates used in experimental photocatalysis research. We compare four models: silica slab with an empty pore, water alone (single and multiple molecules), silica with Ti and a water-filled pore.




Figure 2. Signatures of electronic structure: densities of states and absorption spectra for the explored model and its partial components. (**A–D**) Densities of states for individual and combinations of components of the model and (**E–H**) absorbance spectra of individual and combinations of components of the model: (**A,E**) H₂O; (**B,F**) 10 H₂O; (**C,G**) SiO₂ pore; and (**D,H**) SiO₂ pore with Ti and 10 H₂O.

In catalytic simulations, it is important to investigate basic electronic properties as a starting point for further inquiries into charge transfer and molecular dynamics. In Figure 2, densities of states and absorbance spectra are computed according to Equations (5)–(8), which are simple ways to visualize observables related to basic electronic properties. Comparing the isolated water molecule and a cluster of H_2O in Figure 2A,B, it is seen that a cluster of H_2O molecules provides an occupied orbital in the valence band that does not exist in a single water molecule. Perhaps this is indicative of water's ability to ionize $(H_2O + H_2O \rightleftharpoons OH^- + H_3O^+)$. A close comparison of the densities of states of all models under consideration (top row, Figure 2) reveals similarities. One notable similarity can be seen between the silica slab only (Figure 2C) and the Ti-functionalized pore (Figure 2D). There is a similar pattern in the valence bands from -10 to ~ 0 eV and conduction band in the range of 0 to 10 eV in these two models. However, the addition of a Ti atom provides more

states in the \sim 0 to 4 eV range in Figure 2D. We expect this to occur with the addition of a transition metal, as these states are Ti d-orbitals. The density of states for this primary model (Figure 2D) shows a small band gap of \sim 0.032 eV. Additionally, one can see electron occupation in the valance band of the water cluster, in the water-filled pore, and also in the Ti-functionalized pore (see Figure 2B–D), potentially indicating a more facile charge transfer.

Absorbance spectra were analyzed with two main goals in mind: first, to gain an understanding of the basic electronic properties of the model, and, second, to obtain the initial conditions for future electron dynamics simulations. With the first goal in mind, the components of the system are investigated separately in order to determine how each contributes to the overall character. The multi-molecular water (Figure 2F) shows an absorbance peak at about 380 nm, which is outside of the visible spectrum. A comparison of the absorbance spectra is made between the components of the model (as displayed in Figure 2E–G), and the complete model's absorbance spectrum (Figure 2H). The complete model has its peaks labeled based on the analysis of orbital transitions and comparison to the spectra of the components of the model. The model absorbs in the UV region of the electromagnetic spectrum, which is consistent with known absorption of silica.




Figure 3. (**Left**) Energies of selected orbitals and (**Right**) orbital energies for LU through LU+5. Plotting these orbitals indicated *d*-orbital character. LU+4 and LU+5 maintain d character but show a signature of orbital mixing, which is why there are a total of six *d*-like orbitals. A gap in energy exists between LU+1 and LU+2, indicating tetrahedral field splitting. Right inset: expected tetrahedral crystal field *d*-orbital splitting.

The inclusion of a Ti atom on the inner pore wall has contributed transition metal d-orbitals to the electronic structure of the model. The titanium exists in a +4 oxidation state, which means all of its d-orbitals are empty, with an electron configuration of [Ar] $3d^0$ $4s^0$. Since the Ti is tetrahedrally-coordinated, it is expected to see tetrahedral crystal field splitting among the orbital energies, ε_i [24,25]. In fact, this was found as one of the results of this research. These orbitals were characterized as d-orbitals by plotting isosurfaces and identifying the characteristic shapes of d-orbitals. LU+5 and LU+4 orbitals have d-character with some p-orbital shape contribution, which is why there are six d-orbitals reported, instead of five. In Figure 3, there exists a gap between the two lowest-energy d-orbitals and the energies of the remaining d-orbitals. Tetrahedral crystal field splitting of Ti's d-orbitals exists within a reasonably-sized sub-gap of energy between energies of the two groups of nearly-degenerate orbitals. This sub-gap energy is about 1.2 eV, which is of realistic magnitude to confirm the accuracy of the model.




Figure 4. Green clouds represents isosurfaces for orbitals of interest, which participate in the charge transfer dynamics of the system: (A–E) unoccupied orbitals and (F–J) occupied orbitals. These pairs of occupied and unoccupied orbitals represent different photoexcitations.




Figure 5. Photo-induced excited state dynamics for two typical excitations: (A–C) (HO-6, LU+7) and (D–F) (HO-11, LU+8). (A,D) Electron population over actual time; (B,E) hole populations over actual time; and (C,F) distribution of electron and hole relaxations over time and computed according to Equation (18). The solid line represents the movement of the hole through orbitals over time, while the dashed line represents electron movement. Time is displayed in a logarithmic scale.

The model can exist in several excited states. Some of the excitations have neutral character, others exhibit charge transfer character. These charge transfer states have been included due to the trapping states that are contained in each of them. Furthermore, HO-11, HO-6, LU+7, and LU+8 orbitals exist on water molecules within the pore, as displayed in Figure 4. In a photoexcited state, one can observe the non-radiative transition from one excitation to another due to non-adiabatic couplings. If there is a possibility of a chemical reaction occurring, the focus should be on those molecules and orbitals involved in such a reaction. In this model, the

dynamics of charge transfer states formation have been identified. The dynamics of charge transfer are triggered by the photoexcitation to a neutral state (HO-6, LU+7) and (HO-11, LU+8). The dynamics induced by different photoexcitations are compared in Figure 5.

The pathways of occupation dynamics are determined by the initial excitation $A \rightarrow B$, see Equation (14). Solutions of Equations (13)–(16) first provide occupations as functions of time, ρ_{ii} (t), which are displayed in Figure 5A,B, for one excitation and another in Figure 5D,E. In Figure 5A, electron occupation relaxes from LU+7, but not before transitioning through several short-lived states and one longer-lived

state at LU+2, which exists on the Ti atom (Figure 4D). LU+2 behaves as an electron trap, which slows its relaxation rate. Ultimately, LU+7 \rightarrow LU relaxation occurs at a rate of $0.8141~{\rm ps}^{-1}$, which is computed according to Equation (22). A summary of relaxation rates can be found in Table 1. In contrast, the HO-6 \rightarrow HO relaxation (Figure 5B) occurs at a much slower rate of $0.0301~{\rm ps}^{-1}$. This slower rate is due to stable hole trapping states, which occur at HO-3 and HO-1 and are located within the silica substrate (Figure 4H,I). Viewing the larger peaks contained in Figure 5A helps to identify more influential trap states. The observation that LU+6 and LU+2 peaks have higher amplitude than other states indicates that more time is spent in those states. The same can be said for Figure 5B, containing larger peaks at HO-3 and HO-1. These states are occupied for a longer time. All of the above information can be included in one figure (Figure 5C and are derived using Equations (17) and (18)). Figure 5C,F is helpful in visualizing the movement of electrons and holes in both orbitals and energy over time.

Figure 5D,E tells similar stories, with meta-stable electron traps occurring at LU+7 and LU+2. The rate of electron relaxation is calculated to be 0.7919 ps^{-1} . A stable hole trap exists at HO-1, which lengthens the hole's relaxation rate compared to the electron, and can be visualized more clearly in Figure 5E. The more interesting aspect of this story is that the hole traps exist on Si orbitals, which could be a testament to why silica is such an effective substrate for heterogeneous catalysis, as it facilitates charge separation. Until the hole relaxes, the model resides in the oxidation state O⁻ + Ti³⁺. The lowest occupied orbital is located on Ti and is occupied by the electron, which means that the titanium is in the Ti³⁺ state rather than Ti⁴⁺, which is specific for the ground state. The titanium in a photo-induced metastable Ti³⁺ state is expected to be a strong reducing agent. Thus, in this excited state, Ti³⁺ is able to promote reducing half reactions $2H^+ + 2Ti^{3+} \rightarrow H_2 + 2Ti^{4+}$ contributing to water splitting and hydrogen evolution. Additionally, the hole trap occurring at HO-1 is a consequence of the energy gap law [26], because there is a sizable energy gap between HO and HO-1 (~3 eV), which makes it difficult for the energy to dissipate into vibrations during the relaxation process, as all vibrational frequencies are below this sub-gap.

The electron traps for both excitations are located on one of the Ti atom's orbitals, which seems logical since the Ti is known to be the catalytic site of the water-splitting reaction. The rates of electron relaxation differ by $0.0222~\mathrm{ps}^{-1}$. The difference of the rates of hole relaxation, however, is only $0.0040~\mathrm{ps}^{-1}$. The hole relaxation rates are less dependent upon initial excitation than the electrons. The excitations of HO-6 \rightarrow LU+7 and HO-11 \rightarrow LU+8 have features in common, such as the existence of the same electron trap state of LU+2 and hole trap state HO-1. This indicates that these two trap states exist, independent of the excitation. Additionally, the rates of hole relaxation are very similar, indicating that the existence of the hole trap is the determining factor in the magnitude of the rate. This feature of dynamics is dictated by electronic structure with an occupied orbital in the middle of the gap.

3. Experimental Section

Atomic structure determines initial positions of each ion, $\overline{R_{\rm I}}$, in the model. Density-Functional Theory (DFT) was chosen because it allows one to analyze electronic structure and spectra [27]. The Vienna *Ab-Initio* Simulation Package (VASP v5.4, Computational Materials Physics, Vienna, Austria, 2015) was used for calculations, with Projector Augmented Wave (PAW) pseudopotentials and Generalized Gradient Approximation (GGA) Perdew-Burke-Ernzerhof (PBE) functionals [28]. Periodic boundary conditions are used in order to simulate the periodicity of typical silica substrate material. Figure 1A provides a visualization of the model as a unit cell. As portrayed in Figure 1B, the unit cell may be replicated and then translated in the x, y, or z directions. The potential is not affected by this replication and subsequent movement along a translation vector, \overrightarrow{t} , and therefore, the potential experienced by the electrons [29,30] of the original unit cell is equivalent to any replica as given by Equation (1)

with component vectors $\vec{a_x}$, $\vec{a_y}$, and $\vec{a_z}$, and integers k, l, and m.

The Kohn-Sham equation is the Schrödinger equation of a fictional system of particles which do not interact and that generate the same density as any system of interacting particles. This is given by Equation (2)

where the first term corresponds to kinetic energy, T, and includes a symbol for the gradient $\nabla = \left(\frac{\partial}{\partial x}, \frac{\partial}{\partial y}, \frac{\partial}{\partial z}\right)$. In solving Equation (1), a set of single-electron

orbitals $\Psi_i^{KS}(\vec{r})$ and their energies ε_i is determined. These orbitals are then combined with an orbital occupation function, f_i , for assembling the overall density of electrons, as given by Equation (3)

In addition, the total density defines the potential, is defined by Equation (4)

which is defined as functional derivative of the total energy with respect to variation of the total density and includes the interactions of electrons with ions, and three electron iterations: Coulomb, correlation, and exchange. Rectangular brackets symbolize a functional. Equations (2)–(4) are solved in a self-consistent and iterative fashion. Electrostatic potential introduced in Equation (4) demonstrates the interaction of a valence electron with the remaining charge of electrons and ions. This electrostatic potential is a consequence computed in DFT.

The electronic density of state (DOS) is defined as the number of states per interval of energy that are capable of electron population [29]. DOS are used to describe electronic structure of the model. DOS is given by Equation (5)

where the index, i, runs over all orbitals calculated and ε_i is the energy of a given orbital (calculated using DFT). The Dirac delta function is approximated by a finite width Gaussian function.

The optical absorption spectrum is computed based on the transition dipole moment, by Equation (6)

which calculates transition dipoles from initial ψ_j to final ψ_i and is directly related to the oscillator strength, which is then given by Equation (7)

Here, v_{ij} is the angular frequency of the excitation from state i to state j, D_{ij} is the transition dipole from state i to state j, with \hbar and e as fundamental constants.

The oscillator strength contributes a weight in the absorption spectrum, leading to Equation (8)

in order to apply intensities to the Eigen energy differences which are most probable to absorb light in specific energy ranges.

Molecular dynamics (MD) [30] was used to simulate the change of the positions of the atoms after the cluster is "heated" at a given temperature for a given amount of time. The kinetic energy of the model should remain constant, so the velocities of all the atoms were rescaled to mimic a constant temperature during the MD process

according to Equation (9), where M_I and $\frac{dR_I}{dt}$ denote the mass and initial velocity of I^{th} nucleus, respectively, N is the number of nuclei, k_B is the Boltzmann constant, and T is the temperature. The Hellman-Feynman forces, F_I , act on each atom to determine the acceleration that is to be used in the Newton equation of motion, Equation (10),

by iterative solving of the Kohn–Sham equation and then updating the ionic positions to generate a single example of nuclear positions trajectory $\{\vec{R}_I(t)\}$ for a micro-canonical ensemble. The time dependent adjustments of KS orbitals ψ_i^{KS} and orbital energies ε_i can also be monitored as a function of time. On-the-fly non-adiabatic couplings [20,31] were computed along the nuclear trajectory $\{\vec{R}_I(t)\}$ by Equation (11).

Next, the autocorrelation functions of these couplings were processed with Equation (12).

According to Redfield theory [32], the Fourier transform of $M(\tau)$ provides parameters R_{jklm} for the equation of motion of electronic degrees of freedom, as per Equation (13)

where $\hat{\zeta}\rho$ and $\hat{R}\rho=\left(\frac{d\rho_{ij}}{dt}\right)_{diss}=\sum_{lm}R_{jklm}\rho_{lm}$ represent the Liouville and Redfield superoperators acting on the density operator.

The initial values of the density matrix at time t=0, were symbolized by $\rho_{ij}^{(A.B)}(0)$ and served as the initial condition for a system of differential equations, as per Equation (14).

Here, indices A and B label specific initial conditions, the Dirac delta function δ_{ij} reflects the fact that off-diagonal elements are set to zero, f_i stands for the initial occupation of ith Kohn–Sham orbital so that $f_i=1, i \leq \text{LUMO}$ and $f_i=0, i \geq \text{LUMO}$. A Dirac delta with a negative sign $-\delta_{ia}$ corresponds to the removal of an electron from the Ath Kohn–Sham orbital, Dirac delta with a positive sign $+\delta_{iB}$ corresponds to the addition of an electron to the Bth Kohn–Sham orbital. Equation (14) summarizes the following situation: an electron-hole pair A \rightarrow B is excited, with A and B being indices of orbitals corresponding to the valence band, where an electron is promoted from, and the conduction band, where the electron is promoted to. The pairs of orbitals, (A,B), were chosen according the maximum values of oscillator strengths for the corresponding excitation f_{AB} .

The time evolution of the electronic state was calculated by solving the equation of motion as follows:

First, Liouville–Redfield superopertor is diagonalized, providing a set of eigenvalues $\{\Omega_{\xi}\}$ and eigenvectors, $\{\rho^{\xi}\}$, according to Equation (15)

Here solutions of Equation 15 are labeled by index ξ . Then, the superposition of eigenvectors, given by Equation (16),

were used to compose the density matrix for each instant of time in such a way that it matches the initial conditions Equation (14) [6-8,22]. The electron in the conduction

band and the hole in the valence band are indicated by e and h, respectively. In addition, index e was used with the appreciation that equations for holes are the same as for electrons.

Utilizing the above information, the charge density distribution, rate of energy dissipation, and rate of charge transfer were calculated as follows [6–8,22,33].

The distribution of a carrier (electron or hole) in space Equation (17) and in energy Equation (18) are as follows:

Here, $\rho_{ii}(t)$ represents the occupation of the ith orbital, $\rho_i(z) = \iint dx dy \psi_i^*(x,y,z) \psi_i(x,y,z)$. The expectation value of energy of a carrier is given by Equation (19)



The constant $\tau^{e(h)}$ represents the average relaxation time for the electron (or hole), and therefore the dynamics of the electronic relaxation.

A photoexcitation from ground state to excited state (A,B) results in a sequence of elementary relaxation events (refer to Scheme 1) with the electron and hole subsequently moving one step towards lower excitation, however, the time needed for each step is different, this relaxation dynamics may often exhibit so-called "trapping" when a charge carrier gets trapped in a specific orbital and requires substantial time for the next relaxation step.



Scheme 1. Description of the initial excitations of electron and hole and their paths to relax down to a neutral state over time. A denotes occupied orbitals and B denotes unoccupied ones.

4. Conclusions

Heterogeneous catalysis, as modeled here, with a silica substrate and titanium atom, has been evaluated using DFT. Since the formation of charge transfer states is a prerequisite for a chemical reaction, it was necessary to identify such states in this model, which was accomplished in this work. This is another successful application of the density matrix method for electron dynamics. A survey of DOS and absorbance spectra of individual components and of the whole system concludes that a composite of the individual components of the system combine to form the whole density of states.

The calculated data reveal a much longer relaxation time for holes relative to that for electrons, which is dictated by energy offsets. It may seem intuitive that only electron trap states would facilitate a catalytic reaction, but hole trap states would also, as this study demonstrates: either would prevent recombination of the electron–hole pair. Holes affect electrons insofar as that the electron cannot recombine if the hole is still in an excited state. In fact, a prolonged separation of charge was found, which may indicate a higher probability of reaction since there is more electron movement within the system's components. In order for water splitting to occur, the reaction must happen while the charge transfer state exists, before it recombines. Interestingly, an important trap state was found to be located within the silica substrate. This trap state prolongs relaxation, widening the window available for a chemical reaction to occur.

The presence and location of the trap state indicates that such heterogeneous substrates may play a greater role in catalysis than previously envisaged. This allows one to modify the system to provide better electronic characteristics for more efficient water-splitting, *i.e.*, tuning the band-gap. In other words, in the future, one may be able to choose substrates and catalytic sites to correspond to desired electronic properties in order to optimize catalytic reactions. This research will continue by

applying this methodology to different situations (such as introduction of oxygen vacancy and other metal oxide materials) to clarify the charge transfer mechanism in various photocatalytic materials.

First-Principles Modeling of Direct *versus* Oxygen-Assisted Water Dissociation on Fe(100) Surfaces

Abstract: The O–H bond breaking in H_2O molecules on metal surfaces covered with pre-adsorbed oxygen atoms is an important topic in heterogeneous catalysis. The adsorption configurations of H_2O and relevant dissociation species on clean and O-pre-adsorbed Fe(100) surfaces were investigated by density functional theory (DFT). The preferential sites for H_2O , HO, O, and H were investigated on both surfaces. Both the first H abstraction from adsorbed H_2O and the subsequent OH dissociation are exothermic on the O-pre-adsorbed Fe(100) surface. However, the pre-adsorbed O significantly reduces the kinetics energy barriers for both reactions. Our results confirmed that the presence of pre-adsorbed oxygen species could significantly promote O dissociation.

1. Introduction

Water (H_2O) is one of the most widespread resources involved in many chemical processes [1]. It has also been proposed as the significant feedstock to produce H_2 in steam and oxidative reforming technologies [2–8], which involve adsorption and dissociation of H_2O molecules. A fundamental study of water-metal surface interactions will assist in understanding the reaction mechanisms of this heterogeneous catalytic reaction. Noble metals such as Ru [9,10], Rh [10,11], Pd [10], Ir [10–13], and Pt [10,14] are active for steam and oxidative reforming but are not preferred in conventional industrial reformers due to their high costs. This motivates studies on non-precious metal catalysts, such as Ni- [15–17], Cu- [18,19], Co- [20,21], and Fe- [22–27] based materials. Due to extremely low cost and high catalytic activity, Fe-based catalysts have caught great attentions.

Adsorbed hydroxyl, atomic oxygen and hydrogen are the simplest dissociation products of water on metal surfaces. Also, hydroxyl can further dissociate, giving rise to adsorbed atomic hydrogen and oxygen. Some experimental studies and theoretical calculations on adsorption/dissociation of water on the Fe(100) surface have been reported [28–37]. Eder and Terakura [33] demonstrated that water preferred to adsorb

at the bridge site via an upright molecular adsorption configuration. However, it was unstable leading to a spontaneous dissociation into H and OH species. The same conclusion was achieved by Jung and Kang [34] using density functional theory (DFT) calculations. The proposed upright H_2O configuration at the bridge site by these authors, however, is not in line with the flat-lying configuration on the top site on other metals, such as Ru, Rh, Pd, Pt, Al, Cu, Ag, and Au [38–41].

The promotion effect of pre-adsorbed O atoms on the surfaces of the catalysts has been discovered and investigated by both experimental and theoretical approaches. The pre-adsorbed O atoms have various degrees of effect towards H₂O dissociation on different metals. A comprehensive review on this topic has been provided by Thiel et al. [42] and Henderson [43]. The positive effect of pre-adsorbed O atoms on water dissociation on Pd single crystals and thin films has been reported [44-48]. On the other hand, the water dissociation on the clean Pd surface has not been observed, in consistent with the DFT calculations [49]. Shavorskiy et al. [50] also found the formation of OH when water reacted with co-adsorbed O on the missing-row reconstructed Pt $\{110\}(1 \times 2)$ surface. A similar promotion effect on the Fe(111) surface has been reported [51]. Hung et al. [52] found that adsorbed oxygen facilitated water dissociation via the hydrogen transfer process on the pre-oxidized Fe(100) surface. Liu et al. [37] studied the effect of the O atom which came from the dissociation of the first H₂O molecule on the consequent dissolution of the second H₂O molecule. The O atom assisted H_2O dissociation (O + H_2O = 2OH) was kinetically favorable, and further OH dissociation was roughly thermo-neutral. In that case, the co-adsorption of H coming from the dissociation of the first H₂O molecule on the Fe(100) might have an effect on the reaction pathway. In our manuscript, we studied the effect of two O atoms which came from the dissociation of O_2 molecule on the adsorption and dissociation of water molecule.

Herein, we report a systematic DFT study of the adsorption of H_2O and its dissociation fragments (OH, H and O) on clean and O-pre-adsorbed Fe(100) surfaces. The effect of two O atoms which came from the dissociation of O_2 molecule on the adsorption and dissociation of water molecule has not been reported previously. The dissociation pathways on both surfaces were also discussed based on the calculation results to understand the effect from the pre-adsorbed O atoms.

2. Results and Discussion

2.1. Adsorption of H_2O , OH, O and H on the Clean Fe(100) Surface




Figure 1. Top views of the adsorption configurations of (a) H_2O ; (b) OH; (c) O; and (d) Hon clean Fe(100) surfaces. The slate blue, red and white balls stand for Fe, O and H atoms, respectively.

The adsorption properties of H_2O and the dissociation products H, O, and OH species on a clean Fe(100) surface will be discussed first. The most stable adsorption configurations of these species are presented in Figure 1. The corresponding adsorption energies and structural details are summarized in Tables 1 and 2. On the

Fe(100) surface, H_2O was found to be preferentially adsorbed on a top site via the oxygen atom with the H_2O plane being almost parallel to the Fe surface (Figure 1a). The interaction between the Fe(100) surface and H_2O molecule is weak, evidenced by a small adsorption energy (-0.65 eV). The O–H bond length of 0.98 Å and the \angle HOH bond angle of 105.4° , as listed in Table 2, are almost identical to those of a free H_2O molecule (0.98 Å and 104.4° , respectively). Similar adsorption behaviors of H_2O on Ni(111) [53–55], Ni(100) [55], Ni(110) [55], Cu(111) [56], Cu(100) [57] and Cu(110) [58,59] were observed.

The adsorption energies of the OH species at the bridge and hcp sites are -3.93 eV and -3.84 eV, respectively. The adsorption at the hollow hcp site is locally unstable. These results suggest that the most stable adsorption site for \mathbf{p} H on Fe(100) is at the bridge, consistent with the previous study [28,33]. The O–Fe bond length is 1.99 Å, which is shorter than that of H₂O adsorbed on clean Fe (100) surface (2.17 Å). Based on these results, one may conclude that the OH can be strongly adsorbed on the Fe(100) surface.

For the O species, Govender $et\ al.\ [35]$ have found that the hcp and bridge sites were equally stable. On the other hand, Błoński $et\ al.\ [60]$ and Lu $et\ al.\ [30]$ suggested that O atom only occupied the hollow hcp sites. We found that the adsorption energy of O atom at the hollow hcp is higher than that at the bridge site $(-3.67\ eV)$ at the former $vs.\ -3.00\ eV$ at the latter). On contrast, the top site is not stable for O adsorption. Thus, our results echo that reported by Błoński $et\ al.\ [60]$ and Lu $et\ al.\ [30]$.

Finally, for the H atom, the adsorption energies at the bridge and hollow hcp sites are -3.99 eV and -3.86 eV, respectively. The top site is not stable for H adsorption. This result suggested that the bridge is the most stable adsorption site for H atoms, which is in good agreement with previous DFT calculation results [61].

Based on the calculated adsorption energies in Table 1, it can be concluded that the interaction with the Fe(100) surface increases in the order of $H_2O < O < OH < H$. In the following sections, we will discuss the dissociation of H_2O on the Fe(100) surface based on these results.

2.2. Adsorption of H₂O and OH on the O-Pre-adsorbed Fe(100) Surface




Figure 2. Top views of the adsorption configurations of (a) $H_2O + O$; and (b) OH+O on O-pre-adsorbed Fe(100) surfaces.

As mentioned in the Introduction, the pre-adsorbed oxygen atoms could play an important role in the activation of O–H bond. Therefore, it is of interest to investigate the adsorption behavior of H_2O on O-pre-adsorbed Fe(100) surface. We found that

the H_2O molecule could also be adsorbed on the top site on the O-pre-adsorbed Fe surface, with a higher interaction energy ($-1.13\,\mathrm{eV}$) than that on a clean surface ($-0.65\,\mathrm{eV}$). The adsorption configuration was listed in Table 2. The pre-adsorbed electronegative O atom may increase the acidity of neighboring Fe atoms [62], and the adsorption energy of H_2O via through-space electronic interaction. Another interesting finding is that the pre-adsorbed O atom and the H atom in the H_2O may form a hydrogen bond with a bond distance of 2.04 Å in the co-adsorption configuration, as shown in Figure 2a.

As for the adsorption of OH on O-pre-adsorbed Fe(100) surface, both OH and O are placed on their favorable bridge sites. The most stable structure of OH co-adsorbed with O atom is shown in Figure 2b. The distance between the O atom of hydroxyl group and the nearest Fe atom remains 1.98 Å. However, the adsorption energy changes from -3.93 eV to -4.02 eV, suggesting a stronger interaction with the O-pre-adsorbed Fe(100) surface than with a clean surface. The bond distance of O–H is 0.98 Å, identical to that on the clean surface. Similar effects from the pre-adsorbed-O atom were also found on an Au(100) surface [63].

2.3. Reaction Mechanisms

2.3.1. H₂O Dissociation on the Clean Fe(100) Surface

Water may partially dissociate to produce OH_{ad} and H_{ad} (Equation (1)), and follow the dissociation of OH_{ad} to form H_{ad} and O_{ad} (Equation (2)). The calculated reaction energies and activation barriers for these two reaction steps are shown in Table 3. The associated transition states (TSs) are displayed in Figure 3. In the first






Figure 4. Schematic energy diagram for the dissociation of H_2O on clean (black lines) and O-pre-adsorbed (red lines) Fe(100) surfaces.

step (Equation (1)), molecular water is adsorbed on the clean Fe(100) surface at the top site as discussed in Section 2.1 (Figure 3a). At TS1, one of the H atoms was stripped from the $\rm H_2O$ molecule (Figure 3b). The bond distance between this H atom and O atom in the $\rm OH_{ad}$ is 1.57 Å. The energy barrier and reaction energy for this step are 1.45 eV and -0.91 eV (Figure 4), respectively. At the equilibrium state, both the H and OH radicals are adsorbed at the bridge sites (Figure 3c).

In the second step of dissociation (Equation (2)), the O atom remains at the bridge site while the H atom diffuses away and forms a new Fe–H bond (TS2 in Figure 3d). The distance between this H atom and the O atom is 1.70 Å, which is much longer than that of the initial value (0.98 Å). The Fe–H bond is not stable and H continues to move towards the nearby bridge site (Figure 3e). The energy barrier of the second step is 2.12 eV, which is almost 1.5 times of that of the first step. The reaction energy is -0.58 eV, indicating that the second step is an exothermic reaction. According to the activation energies for TS1 and TS2, both steps require significant energies to overcome the energy barriers.

2.3.2. H₂O Dissociation on the O-Preadsorbed Fe(100) Surface

The dissociation mechanisms of H_2O on the O-pre-adsorbed metal surfaces are significantly different from those on a clean surface. The process of H_2O dissociation on an iron surface, promoted by adsorbed oxygen, can be expressed as Equations (3) and (4).

The pre-adsorbed O atom may act as a reactant. The reaction energies and activation barriers for Equation (3) and the consequent Equation (4) are also calculated and shown in Table 3. The corresponding reaction steps are illustrated in Figure 4. On the O-pre-adsorbed Fe(100) surface, molecular water is adsorbed at the top site, similar to that on the clean surface (2.20 Å on the O-covered surface *vs.* 2.17 Å




Figure 5. Snapshots of H_2O dissociation process on a O-pre-adsorbed Fe(100) surface. (a) $O_{ad} + H_2O_{ad}$; (b) TS1'; (c) $2OH_{ad}$; (d) $O_{ad} + OH_{ad}$; (e) TS2'; and (f) $2O_{ad} + H_{ad}$.

on the clean surface). The pre-adsorbed O atom forms a hydrogen bond with one of the H atom in the adsorbed H_2O with a bond distance of 2.04 Å (Figure 2a). Due to the interaction with the pre-adsorbed O atom, the adsorption of H_2O molecule is slightly away from the top site (Figure 5a). Next, the pre-adsorbed O pulls away the hydrogen atom to form a new OH_{ad} species adsorbed at the short bridge site, leaving the remaining OH at another bridge site (Figure 5b,c). The energy barrier and heat energy for this step were 0.92 eV and -0.53 eV, respectively. Therefore, the energy barrier of H_2O splitting in the presence of O atom on the Fe(100) surface is much lower than that on the clean surface. The strong promotion effect of pre-adsorbed-O atoms on the Fe(100) surface may help design more active catalyst by considering partially oxidizing the metal surfaces. The decrease of the bond length of O–H from 1.57 Å in TS1 to 1.42 Å in TS1' leads to the reduction of the water dissociation barrier from 1.45 eV on a clean surface to 0.92 eV on an O-pre-adsorbed one. We may conclude that the pre-adsorbed O can significantly promote H_2O dissociation.

The energy barrier for Equation (4) reported in our work (0.92 eV) is significantly higher than that reported by Liu *et al.* (0.18 eV) [37]. One of the reasons is the different computation methods used. In the current study, GGA-PBE functional in CASTEP code was used, rather than GGA-PBE-D2 functional in VASP code that includes the long-range dispersion correction for van der Waals (vdW) interactions [37].

OH is also difficult to dissociate on clean Fe surfaces due to the high energy barrier (2.12 eV). In the presence of a pre-adsorbed O atom, the energy barrier is reduced to 2.02 eV. According to Figure 5d, the bond length of O–H at TS2' (1.56 Å) is shorter than that on clean Fe surfaces (1.70 Å), suggesting that the O atom promotes the dissociation of hydroxyl. These results are also elucidated on Au(100) [61] and Pd (111) [64] surfaces. The high energy barriers of OH dissociation on the clean and O-pre-adsorbed Fe(100) surfaces make the occurrence of this reaction kinetically difficult. Consequently, the decomposition of the O-H bond in the OH_{ad} (Equations (2) and (4)) are the rate-determining steps of the whole dissociation reaction of $\rm H_2O$.

3. Computational Methods

Spin-polarized periodic DFT calculations were performed using the Cambridge Sequential Total Energy Package (CASTEP) program in the Materials Studio 6.0 package (Accelrys Software Inc., San Diego, CA, USA). All calculations were performed using ultrasoft pseudopotentials, with kinetic energy cutoff of 400 eV. Electronic exchange and correlation effects were described within the generalized gradient approximation (GGA) [65] using Perdew-Burke-Ernzerhof (PBE) [66] functionals.

The optimized lattice parameter of bulk Fe was calculated using a bcc unit cell sampled with a $15 \times 15 \times 15$ Monkhorst-Pack k-point grid. The calculated value was 2.816 Å, which was comparable to the most accepted experimental value of 2.87 Å [67], with a difference of less than 2.0%.

A (3 × 3) surface unit cell with a slab of four layers' thickness was selected as the model. This slab was repeated periodically with a 15 Å of vacuum region between the slabs. Only one H_2O molecule per super cell was adsorbed on one side of the slab to reduce lateral interactions between adsorbates. The geometry optimization including all degrees of freedom of the adsorbates and the two topmost metal layers were considered. The total energy calculation and the surface structural relaxation were performed by sampling the Brillouin zone with a 6 × 6 × 1 Monkhorst-Pack grid. All of the considered geometries were fully relaxed so that the forces became smaller than 0.01 eV·Å⁻¹. A 0.1 eV Fermi smearing was used and the convergence criteria for the geometry optimizations were 10^{-5} eV for the total energy. The computed lattice constant (2.643 Å) and magnetic moment (2.22 µB) are close to the experimental values (2.866 Å [68] and 2.22 µB [69]).

As usually defined [70], the adsorption energy (E_{ad}) was calculated by Equation (5):

$$E_{\rm ad} = E_{\rm T} - E_{\rm Fe} - E_{\rm S} \tag{5}$$

where E_T , E_{Fe} and E_S are the total energy of the system, the energy associated to the isolated surface, and the energy of the isolated species (H, O, OH and H₂O in the present study), respectively. A negative value of E_{ad} indicates an exothermic chemisorption process. The linear synchronous transit (LST) calculation [71] combined with a quadratic synchronous transit (QST) calculation and conjugate gradient refinements [72] were used to obtain the transition state (TS). A LST optimization was performed in the calculations of LST/QST, while QST maximization was used to obtain the TS approximation. The same conjugate gradient minimization was repeated until a stationary point was obtained.

We carried the Hubbard correction for H_2O adsorption on the Fe(110) surface using the DFT+U method. DFT + U implementation in the code was based on the formalism summarized in Ref. [73]. Only on-site Coulomb repulsion was used and all higher-order multipolar terms were neglected. The effect of the Hubbard correction was found to be negligible for adsorption energies of H_2O , O, OH and H on the Fe(100) surface (Table 4).

4. Conclusions

The adsorption configurations of H_2O and relevant dissociation species on clean and O-pre-adsorbed Fe(100) surfaces were investigated by DFT. It was found that H_2O is preferably adsorbed on the top site, O is absorbed on the bridge and hollow hcp site, while OH and H are adsorbed on the bridge site. The calculated adsorption energies revealed that the interactions between the adsorbates and the Fe surface increase in the order of $H_2O < OH < H < O$. In addition, we found that both the first H abstraction from adsorbed H_2O and the subsequent OH dissociation are exothermic on both clean Fe(100) and O-pre-adsorbed Fe(100) surfaces. However, the pre-adsorbed O significantly reduces the kinetics energy barriers for both reactions. Our results confirmed that the presence of pre-adsorbed oxygen species significantly promotes H_2O dissociation and will help in the design of better catalysts for water dissociation.

Study of N₂O Formation over Rh- and Pt-Based LNT Catalysts

Abstract: In this paper, mechanistic aspects involved in the formation of N_2O over Pt-BaO/ Al_2O_3 and Rh-BaO/ Al_2O_3 model NO_x Storage-Reduction (NSR) catalysts are discussed. The reactivity of both gas-phase NO and stored nitrates was investigated by using H_2 and NH_3 as reductants. It was found that N_2O formation involves the presence of gas-phase NO, since no N_2O is observed upon the reduction of nitrates stored over both Pt- and Rh-BaO/ Al_2O_3 catalyst samples. In particular, N_2O formation involves the coupling of undissociated NO molecules with N-adspecies formed upon NO dissociation onto reduced Platinum-Group-Metal (PGM) sites. Accordingly, N_2O formation is observed at low temperatures, when PGM sites start to be reduced, and disappears at high temperatures where PGM sites are fully reduced and complete NO dissociation takes place. Besides, N_2O formation is observed at lower temperatures with P_2 than with P_3 in view of the higher reactivity of hydrogen in the reduction of the PGM sites and onto Pt-containing catalyst due to the higher reducibility of Pt vs. Rh.

1. Introduction

The removal of NO_x under lean conditions according to the NO_x Storage-Reduction (NSR) technique is a viable approach for both diesel and lean gasoline fueled engines [1]. In this process NO_x conversion is based on a cyclic engine operation alternating between fuel lean and rich conditions: NO_x (NO+NO₂) are adsorbed on the catalyst surface during lean operations, while the surface of the trap is regenerated under the fuel rich environment. The NO_x adsorption step involves oxidation sites (generally provided by noble metals like Pt, Pd or Rh) and alkali or alkaline-earth oxides storage sites (Ba, K, Sr), whereas the reduction stage involves reduction sites provided by the noble metals. All these components are deposited over a high surface area support like γ -Al₂O₃.

The operation of NSR catalysts (also known as Lean NO_x Traps, LNTs) reduces NO_x mainly to N_2 although undesired by-products like NH_3 or N_2O may also be generated. NH_3 is not generally a concern since an ammonia Selective Catalytic

Reaction (SCR) catalyst can be placed downstream of the NSR system, such as in the case of combined NO_x storage and NH_3 -SCR catalytic systems [2]. At variance, N_2O is a highly undesired by-product in view of its very high global warming potential (nearly 300 times that of CO_2). Over fully formulated catalysts, it has been shown that N_2O formation is apparent both upon switch from lean to rich mode but also during the alternation from rich to lean regime [3–8]. It has been suggested that N_2O formation at the lean to rich transition occurs at the regeneration front, upon reduction of the stored NO_x over not fully reduced Platinum-Group-Metal (PGM) sites. On the other hand, N_2O formation upon the rich to lean transition originates from reaction between residual surface NO_x with reductive species (like NCO, CO or NH_3) in an adsorbed state [3,4,7]. This N_2O peak can be reduced if a neutral or slightly lean phase is inserted between the rich and the lean phase, since a more complete regeneration of the catalyst can be attained [9].

In order to provide further insights on the pathway involved in N_2O formation, a fundamental study was carried out on a model Pt-BaO/Al₂O₃ catalyst under simplified and controlled reaction conditions [10]. Accordingly the reactivity of gaseous NO alone and in the presence of various reducing agents like H₂, NH₃, and CO was analyzed by micro-reactor transient reactivity experiments and *operando* Fourier transform infrared (FT-IR) spectroscopy, to provide a complementary overview on the pathway of N₂O evolution. It has been shown that N₂O is formed from gaseous NO provided that a proper oxidation degree of the Pt sites is attained [10]. Accordingly the N₂O evolution was observed only in a narrow temperature range corresponding to the PtO to Pt transformation, determined by the reactivity of the reducing agents (H₂ > NH₃ > CO).

In this study the investigation previously carried out over the model Pt-BaO/Al $_2$ O $_3$ sample has been extended to a Rh-containing sample. Since Rh is generally considered to play an important role in the reduction of NO $_x$ [11], it is of interest to analyze the role of this component in the pathways involved in N $_2$ O formation. For this purpose the reduction of gaseous NO in the presence of various reductants (H $_2$, NH $_3$) was investigated by transient microreactor experiments and *operando* FT-IR spectroscopy to combine gas-phase data with surface species analysis. To point out the role of NO $_x$ surface species (nitrates) in the formation of N $_2$ O, experiments were also performed with the same reductants after adsorption of NO $_x$ on the catalyst surface.

2. Results and Discussion

2.1. NO-Temperature Programmed Reaction (NO-TPR)




Figure 1. NO-TPR experiments with NO (1000 ppm) in He from 40–400 $^{\circ}$ C (10 $^{\circ}$ C/min) over pre-reduced Rh-BaO/Al₂O₃ (**A**) and Pt-BaO/Al₂O₃ (**B**) catalysts (rig #1).

The reactivity of NO over the reduced Pt-BaO/Al₂O₃ and Rh-BaO/Al₂O₃ was investigated at first. The results of the gas phase analysis are shown in Figure 1A,B

for the Rh-BaO/Al₂O₃ and Pt-BaO/Al₂O₃ catalyst, respectively. In both cases a NO consumption peak is observed, with a minimum in NO concentration centered near 250 and 200 $^{\circ}$ C for Rh-BaO/Al₂O₃ and Pt-BaO/Al₂O₃, respectively. The NO consumption is more evident in the case of the Pt-BaO/Al₂O₃ catalyst sample; in both cases it is accompanied by evolution of N₂O and of minor amounts of N₂. Notably, the NO consumption is not balanced by the evolution of N₂O (and of N₂), indicating the build up of N-containing species on the catalyst surface.

The results of surface analysis are shown in Figure 2. In the case of Rh-BaO/Al₂O₃ catalyst (Figure 2A) upon exposure of NO at 50 °C (spectrum a) a band appears at 1210 cm⁻¹ corresponding to $\nu_{asym}(NO_2)$ vibration of chelating nitrites on the barium phase. The presence of the $\nu_{sym}(NO_2)$ mode of nitrites may also be observed near 1365 cm⁻¹. Upon heating, the band located at 1210 cm⁻¹ increases, reaches a maximum intensity around 200–250 °C (spectra e–g) and then decreases with temperature. The decrease of the bands of nitrites is accompanied by an increase in the bands located near 1327 and 1405 cm⁻¹ associated with ionic

nitrates ($v_{asym}(NO_3)$) at 1327 and 1405 cm⁻¹). The presence of an isosbestic point suggests the occurrence of the transformation of nitrites into nitrates on the catalyst surface. The appearance of nitrate species is also confirmed by the presence of a low intensity peak at 1030 cm⁻¹ ($v_{sym}(NO_3)$). Furthermore, a shoulder near 1545 cm⁻¹, associated with bidentate nitrates (v(N=O)) is also detected. At the end of the temperature ramp (350 °C) the surface of the catalyst is dominated by the presence of nitrate species, however nitrites are still present (band at 1210 cm⁻¹).




Figure 2. Operando FT-IR spectra recorded during NO-TPR experiments with NO (1000 ppm) in He over Rh-BaO/Al₂O₃ (**A**) and Pt-BaO/Al₂O₃ (**B**) from 50 to 350 °C (10 °C/min), spectra recorded every 1 min, displayed at selected temperatures: (**a**) 50 °C; (**b**) 100 °C; (**c**) 120 °C; (**d**) 150 °C; (**e**) 200 °C; (**f**) 220 °C; (**g**) 250 °C; (**h**) 300 °C; (**i**) 320 °C; (**l**) 350 °C (rig#2).

A similar picture was observed over the Pt-BaO/Al $_2$ O $_3$ catalyst (Figure 2B), with only minor differences. Also in this case the formation of chelating nitrites (1218 cm $^{-1}$) is seen at the initial stage, reaching a maximum in the same temperature range (220–250 °C) observed for the Rh-based catalyst. Then the bands decrease in favor of nitrate formation, as pointed out by the isosbestic point and by the growth of

the bands near 1350 and 1405 cm $^{-1}$. At the end of the run (350 $^{\circ}$ C), the final amount of nitrites on the Pt containing catalyst is higher if compared to the Rh-based sample, as pointed out by the relative intensity of the bands at 1218 cm $^{-1}$ (nitrites) and at 1350–1405 cm $^{-1}$ (nitrates).

The above results clearly show that upon contacting NO with the reduced catalyst surface, NO is consumed leading to N_2O and nitrites adsorbed over the barium surface. In particular the results are in line with the occurrence, below 250 $^{\circ}$ C, of the following NO disproportion reaction Equation (1):

$$4 \text{ NO} + \text{BaO} \rightarrow \text{N}_2\text{O} + \text{Ba}(\text{NO}_2)_2 \tag{1}$$

In fact the ratio between NO consumption and N_2O formation is not very far from the theoretical value 1:4 expected from the stoichiometry of the overall reaction Equation (1). At higher temperature, above 250 $^{\circ}$ C, nitrites are transformed into nitrates, in line with previous results [10].

The overall stoichiometry of the NO disproportion reaction Equation (1) can be explained by considering the occurrence of the following reactions Equations (2)–(4):

$$NO + 2Me \rightarrow Me-N + Me-O$$

$$NO + Me-N \rightarrow N_2O + Me$$

$$2 \text{ NO} + \text{Me-O} + \text{BaO} \rightarrow \text{Me} + \text{Ba(NO}_2)_2$$

where Me is the metal site (Pt or Rh). According to this scheme, the reaction is initiated at low temperature by the decomposition of NO over reduced Me sites, leading to the formation of N- and O-adspecies (reaction Equation (2)). The formation of oxidized metal sites (Me-O species) prevents the dissociation of other NO molecules and this results in the formation of N_2O (reaction Equation (3)) and of nitrites on Ba (reaction 4)). The occurrence of reaction Equation (4) removes O-adatoms on metal sites leaving vacant metal sites accessible for further NO dissociation. Reactions Equations (2)–(4) lead to the overall stoichiometry of reaction Equation (1).

Worth noting is that reactions Equations (2)–(4) require the presence of reduced metal sites, to initiate the NO dissociation reaction. In fact the NO disproportion reaction is observed to a much lower extent over an oxidized Pt-based catalyst sample (data not reported). Along similar lines, the storage component BaO is also important in that it provides the adsorption sites for the nitrite (and nitrate) surface species. In fact, experiments carried out over a bare Pt/Al_2O_3 sample pointed out a much lower N_2O (and nitrite) formation. However, the presence of BaO may also increase the activity of the metal sites in the dissociative chemisorption of NO, as reported elsewhere [12].

2.2. NO/H2-TPR




Figure 3. NO/H₂-TPR experiments with NO (1000 ppm) + H₂ (2000 ppm) over (**A**) Rh-BaO/Al₂O₃ and (**B**) Pt-BaO/Al₂O₃ from 40–400 $^{\circ}$ C (4 $^{\circ}$ C/min), (rig#3).

To investigate the effect of the presence of a reductant in N_2O formation, experiments were carried out in the presence of H_2 and results are shown in Figure 3A,B in the case of Rh-BaO/Al₂O₃ and Pt-BaO/Al₂O₃ catalysts, respectively.

In the case of the Rh-based catalyst, NO starts to be converted near 150 $^{\circ}$ C, with formation of N₂O and N₂ in nearly equal amounts. Then, above 200 $^{\circ}$ C, NO is fully consumed and N₂O formation rapidly drops. Accordingly above 200 $^{\circ}$ C only N₂ and NH₃ are seen in the reaction products.

Very similar results are observed in the case of the Pt-BaO/Al $_2$ O $_3$ catalyst (Figure 3B). However, in this case NO consumption is observed at much lower temperatures (onset temperature near 50 $^{\circ}$ C), and the NH $_3$ selectivity at high temperatures is much higher if compared to the Rh-BaO/Al $_2$ O $_3$ sample.




Figure 4. FT-IR spectra obtained during NO/H₂–TPR with NO (1000 ppm) + H₂ (2000 ppm) over Pt-BaO/Al₂O₃ from 40–400 °C (4 °C/min) at: (a) 40 °C; (b) 77 °C; (c) 85 °C; (d) 152 °C; (e) 252 °C; (f) 354 °C; (g) 400 °C (rig#3).

The correspondent surface analysis is shown for the Pt-BaO/Al₂O₃ sample in Figure 4. Upon NO admission, the formation of a very weak band at 1218 cm^{-1} is seen, related to the formation of chelating nitrites on the Ba phase. This band

slightly increases with temperature, reaches a weak maximum near 85 $^{\circ}$ C and then disappears at higher temperatures, along with N₂O. The spectra also show complex bands in the range 1300–1600 cm⁻¹, with positive and negative contributions. These bands are related to modifications of a covalent carbonate species, initially present on the surface, into more symmetric, ionic species upon interaction with water formed during the reduction of NO with H₂ and upon the temperature increase.

Very similar results were obtained in the case of the Rh-based sample (not shown): also in this case we observed the formation of a weak nitrite band in the temperature range where N_2O is formed.

Upon comparing these results with those obtained in the absence of H_2 (*i.e.*, the NO-TPR runs, Figures 1 and 2), it clearly appears that N_2O formation is seen at much lower temperatures in the case of the Pt-BaO/Al $_2O_3$ sample, and at slightly higher temperatures in the case of the Rh-based sample. In both cases N_2O formation is accompanied by nitrite evolution, although the band of nitrites is much lower in the presence of H_2 .

As suggested above (see reactions Equations (2)–(4)), N_2O (and nitrite) formation requires the presence of reduced Me (Pt, Rh) sites. Hence the reaction is initiated by the reduction of the PGM sites by H_2 : the lower onset temperature for NO reduction illustrates the much higher reducibility of the Pt-based sample if compared to the Rh-BaO/Al₂O₃ catalyst.

As shown in Figure 3, the NO reduction reaction leads at low temperatures to the formation of N_2 and N_2O . Then, at higher temperatures, N_2O formation becomes nil and the selectivity shifts towards N_2 and NH_3 . It is speculated that upon reduction of the PGM sites by H_2 , N_2O (and nitrite) formation occurs according to reactions

Equations (2)–(4). The presence of H_2 leads also to the formation of Rh-H and Pt-H species, according to the reaction Equation (5).

$$H_2 + 2 Me \rightarrow 2 M-H \tag{5}$$

where Me is the metal site (Pt or Rh). The so formed Me-H species scavenge O-adatoms, reaction Equation (6):

$$2 Me-H + Me-O \rightarrow 3 Me + H_2O$$

The scavenging of O-adatoms according to reaction Equation (6) limits the formation of nitrites according to reaction Equation (4), as indeed is observed in the presence of H_2 .

Besides, N_2 formation is also observed along with N_2O , coming from the coupling of N-adatoms (reactions Equations (2) and (7)):

$$2 \text{Me-N} \rightarrow 2 \text{Me} + N_2 \tag{7}$$

Since the O-removal efficiency by H_2 increases with temperature, upon increasing the temperature NO completely dissociates and N-adatoms lead to the formation of N_2 (reaction Equation (7)) or of NH_3 (reaction Equation (8)), thus shifting the selectivity towards N_2 and NH_3 :

$$M-N + 3M-H \rightarrow 4M + NH_3$$

Notably, in the case of the Rh-containing catalyst, the NH_3 concentration decreases above 275 °C. This is due to the occurrence of the NH_3 decomposition reaction, which is efficiently catalyzed over Rh, as it is shown below.

2.3. NO/NH₃-TPR




Figure 5. NO/NH₃-TPR experiments with NO (1000 ppm) + NH₃ (1000 ppm) over (**A**) Rh-BaO/Al₂O₃ and (**B**) Pt-BaO/Al₂O₃ from 40–400 $^{\circ}$ C (4 $^{\circ}$ C/min) (rig#3).

Figure 5 shows the results obtained during the reduction of NO with NH₃ in the case of Rh-BaO/Al₂O₃ (Figure 5A) and Pt-BaO/Al₂O₃ catalysts (Figure 5B). The onset temperature for NO reduction is seen near 200 and 100 °C for the Rh- and Pt-based catalysts, respectively. These temperature thresholds are higher than those measured in the case of H₂, but show the same order of reactivity of the investigated samples, being the Pt-BaO/Al₂O₃ catalyst more reactive than Rh-BaO/Al₂O₃. Over both the catalytic systems the initial formation of N₂O and N₂ is observed; then, when complete NO consumption is attained (*i.e.*, near 295 °C and 185 °C over Rh-BaO/Al₂O₃ and Pt-BaO/Al₂O₃, respectively) the N₂O concentration drops to zero resulting in complete N₂ selectivity. In the case of the Rh-based sample, above 300 °C an increase in the N₂ concentration is observed, along with H₂ and a

correspondent decrease of the NH₃ concentration. This is due to the occurrence of the NH₃ decomposition reaction:

$$2NH_3 \rightarrow N_2 + 3H_2$$

which is catalyzed by the Rh component.

The results of the FT-IR analysis carried out over the Rh-BaO/Al $_2$ O $_3$ and the Pt-BaO/Al $_2$ O $_3$ catalysts are shown in Figure 6A,B respectively. In the case of Rh-BaO/Al $_2$ O $_3$ (see Figure 6A), upon NH $_3$ admission, bands at 1095 and 1647 cm $^{-1}$ (low intensity) immediately appear (spectrum a). These bands are related to the symmetric and antisymmetric bending modes of ammonia. Then, upon NO admission, a weak band of nitrites appears at 1212 cm $^{-1}$. Upon heating, the bands associated with NH $_3$ decrease and eventually disappear. Besides, the nitrite band slightly increases up to 275 $^{\circ}$ C and then disappears. In addition to these bands,

positive and negative bands are evident in the spectra due to the distortion of carbonate species, as previously discussed.

The Pt-BaO/Al $_2$ O $_3$ catalyst shows similar features (see Figure 6B) but a much higher amount of nitrites is formed upon NO admission, with respect to Rh-BaO/Al $_2$ O $_3$. Nitrites readily disappear near 200 $^{\circ}$ C (spectrum g).




Figure 6. Operando FT-IR spectra during NO/NH₃–TPR with NO (1000 ppm) + NH₃ (1000 ppm) from 40–400 °C (4 °C/min) over (**A**) Rh-BaO/Al₂O₃ at: (**a**) 40 °C with NH₃; (**b**) 40 °C with NH₃+NO; (**c**) 40 °C before temperature ramp; (**d**) 50 °C; (**e**) 104 °C; (**f**) 260 °C; (**g**) 292 °C; (**h**) 400 °C. Panel (**B**) Pt-BaO/Al₂O₃ at: (**a**) 40 °C with only NH₃; (**b**) 40 °C NH₃ + NO; (**c**) 40 °C before temperature ramp; (**d**) 104 °C; (**e**) 153 °C; (**f**) 178 °C; (**g**) 203 °C; (**h**) 328 °C; (**i**) 400 °C (rig#3).

The picture obtained from the analysis with NH_3 is consistent with that discussed in the case of H_2 . Upon reduction of the PGM sites by NH_3 , NO is dissociated into N- and O-adatoms and formation of N_2O and nitrites is observed (reactions Equations (2)–(4)). Formation of these species is observed at lower

temperatures over the Pt-based sample in view of its higher reactivity, in line with data obtained during the NO/H_2 -TPR.

By comparing NO/NH₃-TPR and NO/H₂-TPR data, it is apparent that the onset of N_2O formation is shifted towards higher temperatures (compare Figures 3A and 4A) and also higher amounts of nitrites are formed. This can be explained considering that NH₃ is a much less efficient reductant (*i.e.*, a less efficient O-scavenger) compared to H₂. This results in a higher onset temperature for the reaction and a higher temperature for complete NO dissociation.

In the case of NO/NH₃-TPR experiments, N_2O and N_2 formation involves coupling of N-containing species coming from NO and/or NH₃ molecules. To investigate such aspects, isotopic labeling experiments were carried out with NH₃ and ^{15}NO over both Pt- [13] and Rh-BaO/Al₂O₃ [14]. In both cases the low-T NO consumption (*i.e.*, below the maximum in N₂O concentration) is accompanied by the evolution of double labeled $^{15}N_2O$ and of single labeled N₂ ($^{15}N^{14}N$), with only minor amounts of single labeled N₂O ($^{15}N^{14}NO$). Then, at higher temperatures (near the complete NO consumption) N₂O is no more detected among the reaction products and all the N₂ isotopes are observed.

These results indicate that N_2O formation involves primarily NO molecules only, according to reactions Equations (2) and (3). In this pathway, the role of NH_3 is hence that of keeping the noble metal sites in a reduced state, with formation of Me-H and Me- NH_2 species according to reaction Equation (10):

Me-H scavenges O-adatoms, resulting in H_2O formation while Me-N H_2 reacts with (labelled) nitrite species leading to the formation of the single labelled N_2 ($^{15}N^{14}N$), according to reaction Equation (11), where $O^=$ is lattice oxygen:

This accounts for the formation of single labelled N_2 that accompanies N_2O evolution. At higher temperatures, near complete NO consumption where no N_2O is seen, all N_2 isotopes are detected due to the statistical coupling of N-adatoms coming from NO- and NH₃-decomposition [13].

2.4. H₂-Temperature Programmed Surface Reaction (H₂-TPSR)




Figure 7. H₂-TPSR experiments with H₂ (2000 ppm) from 40–400 $^{\circ}$ C (4 $^{\circ}$ C/min) after NO/O₂ adsorption at 350 $^{\circ}$ C over (**A**) Rh-BaO/Al₂O₃ and (**B**) Pt-BaO/Al₂O₃ (rig#3).

Figure 7 shows the results of the H_2 -TPSR experiments performed over Rh-BaO/Al₂O₃ and Pt-BaO/Al₂O₃ after NO_x adsorption at 350 °C. The gas phase results are shown in Figure 7A,B for the Rh- and Pt-based catalyst samples, respectively. In the case of the Rh-containing sample, the temperature threshold for hydrogen consumption is seen near 170 °C. Above 200 °C NH₃ evolution is

seen, followed by that of N_2 above 300 °C. The initial H_2 consumption is probably related to the reduction of the Rh sites, since it is not accompanied by the release of reaction products.

The corresponding FT-IR spectra are shown in Figure 8A. The spectrum recorded prior to H_2 consumption (spectrum a) corresponds to the surface ionic nitrate ($\nu_{asym}(NO_3)$) mode split into two peaks at 1400 and 1330 cm $^{-1}$; $\nu_{sym}(NO_3)$ mode at 1035 cm $^{-1}$). The band near 1470 cm $^{-1}$ is an artefact due to the presence of carbonate species, which have been partially displaced upon adsorption of NO_x and therefore lead to the formation of negative peaks in the subtraction spectra. Consequently, FT-IR analysis confirms that NO_x have been stored at 350 $^{\circ}$ C in the form of nitrate species.

Upon heating, the reduction of nitrates occurs from 200 $^{\circ}$ C, as it is obvious from the corresponding decrease of the bands. The nitrate bands decrease in intensity with temperature, and no new bands are apparent. At 388 $^{\circ}$ C (spectrum j) the surface is clean and only a negative band at 1440 cm⁻¹ is visible, due to carbonates that have been displaced upon nitrate adsorption from NO/O₂ at 350 $^{\circ}$ C.

These results indicate that, over Rh-BaO/Al $_2$ O $_3$, the stored nitrates are reduced by hydrogen selectively into NH $_3$ (and minor amounts of N $_2$), without any formation of NO or N $_2$ O.




Figure 8. Operando FT-IR spectra obtained during H_2 -TPSR experiments with H_2 (2000 ppm) from 40–400 °C (4 °C/min) after NO/O₂ adsorption at 350 °C over (A) Rh-BaO/Al₂O₃ at: (a) 157 °C; (b) 200 °C; (c) 215 °C; (d) 232 °C; (e) 248 °C; (f) 264 °C; (g) 281 °C; (h) 322 °C; (i) 355 °C; (j) 388 °C; and (B) Pt-BaO/Al₂O₃ at: (a) 40 °C; (b) 49 °C; (c) 107 °C; (d) 115 °C; (e) 124 °C; (f) 132 °C; (g) 140 °C; (h) 148 °C; (i) 157 °C; (j) 165 °C; (k) 182 °C; (l) 198 °C (rig#3).

Similar results were obtained in the case of the Pt-containing catalyst (Figures 7B and 8B). Gas phase analysis (Figure 7B) shows that H_2 consumption is seen starting

from 100 $^{\circ}$ C, *i.e.*, at lower temperatures than Rh-BaO/Al₂O₃. The H₂ consumption is accompanied by the formation of ammonia with traces of nitrogen; no other reaction products (e.g., NO, N₂O) are formed. Also in this case the H₂ consumption is seen before the evolution of the reaction products, likely indicating the reduction of the catalyst metal sites.

Surface analysis (Figure 8B) showed the presence of the ionic nitrates (v_{asym} (NO₃)) mode split into two peaks at 1417 and 1320 cm⁻¹; v_{sym} (NO₃) mode at 1035 cm⁻¹) and minor amounts of bidentate nitrates (v(N=O) mode at 1555 cm⁻¹) on the catalyst surface at the beginning of the run (spectrum a). The reduction of nitrates is observed above 115 °C, in line with gas-phase results. Upon increasing the temperature the reduction of nitrates proceeds faster and complete reduction is attained above 200 °C, at a much lower temperature with respect to Rh-BaO/Al₂O₃. Also in this case, residual carbonates, present on the surface before the NO_x storage, were removed and this results in weak negative bands at 1440 and 1380 cm⁻¹.

 H_2 -TPSR experiments hence indicate that the reduction with H_2 of nitrates stored over both Pt- and Rh-containing catalyst samples does not lead to the formation of N_2O . The Pt-BaO/Al $_2O_3$ sample is more active than the Rh-containing catalyst but in both cases only NH_3 was observed as reduction product, along with traces of N_2 . These results are in line with previous data obtained over the same Pt-containing sample used in this study and published elsewhere [15].

2.5. NH_3 -TPSR




Figure 9. NH₃-TPSR experiments with NH₃ (1000 ppm) from 40–400 $^{\circ}$ C (4 $^{\circ}$ C/min) after NO/O₂ adsorption at 350 $^{\circ}$ C over: (**A**) Rh-BaO/Al₂O₃ and (**B**) Pt-BaO/Al₂O₃ (rig#3).

Figures 9 and 10 show the results obtained during TPSR experiments performed with NH₃ after NO_x adsorption at 350 °C. The gas phase results are shown in Figure 9A,B for Rh-BaO/Al₂O₃ and Pt-BaO/Al₂O₃, respectively. In the case of the Rh-catalyst (Figure 9A), ammonia desorption is observed at the beginning of the heating ramp. Then the temperature onset for ammonia consumption is seen near 250 °C, *i.e.*, at higher temperatures if compared to H₂ (see Figure 7A). The NH₃ consumption is accompanied by the formation of nitrogen, whose concentration shows a peak with maximum near 280 °C. At temperatures above 300 °C ammonia is further consumed leading to the evolution of N₂ and H₂. The initial N₂ formation, with maximum near 280 °C, is due to the reduction of the stored nitrates, whereas the nitrogen formation above 300 °C is due to occurrence of the NH₃ decomposition reaction. Notably, the reduction of the stored nitrates with ammonia is fully selective to N₂, and neither N₂O nor NO formation was observed.

FT-IR spectra recorded during the NH₃-TPSR are shown in Figure 10A. Ionic nitrates (bands at 1402, 1338, and 1036 cm⁻¹) and adsorbed ammonia (bands at 1095 and 1640 cm⁻¹) are initially present on the catalyst surface at 40 $^{\circ}$ C (spectrum a). The increase of the temperature leads at first to the disappearance of the 1095 and 1640 cm⁻¹ bands, in line with the desorption of NH₃ (spectrum b). At further

temperature increase, nitrates are reduced and at 400 $^{\circ}$ C (spectrum i) the surface is free from nitrates.

In the case of the Pt-catalyst (Figure 9B), the temperature threshold for ammonia consumption is observed near 150 °C, *i.e.*, at lower temperatures if compared to the Rh-containing sample, and leads to N_2 formation with a maximum near 220 °C. At 270 °C nitrogen evolution is completed and the NH $_3$ concentration reaches the inlet concentration value. Also in this case the reaction is fully selective towards nitrogen, and no N_2O formation was observed. Above 350 °C the Pt-catalyst shows a limited activity in the dissociation of NH $_3$, as pointed out by the small evolution

of H_2 and of nitrogen. Concerning the surface phase (Figure 10B), ionic nitrates (bands at 1415, 1348, and 1035 cm $^{-1}$), bidentate nitrates (1555 cm $^{-1}$) and adsorbed ammonia (band at 1090 cm $^{-1}$) are initially present (40 °C, spectrum a). Upon increasing the temperature, initially bidentate nitrates are transformed into ionic nitrates (spectrum b) and then ionic nitrates decrease. Above 250 °C nitrates are completely removed (spectra j and k).




Figure 10. Operando FT-IR spectra obtained during NH₃-TPSR experiments with NH₃ (1000 ppm) from 40–400 °C (4 °C/min) after NO/O₂ adsorption at 350 °C over (**A**) Rh-BaO/Al₂O₃ at: (**a**) 40 °C; (**b**) 275 °C; (**c**) 283 °C; (**d**) 291 °C; (**e**) 300 °C; (**f**) 308 °C; (**g**) 316 °C; (**h**) 333 °C; (**i**) 400 °C; and (**B**) Pt-BaO/Al₂O₃ at: (**a**) 40 °C; (**b**) 171 °C; (**c**) 196 °C; (**d**) 204 °C; (**e**) 213 °C; (**f**) 221 °C; (**g**) 229 °C; (**h**) 237 °C; (**i**) 246 °C; (**j**) 254 °C; (**k**) 303 °C (rig#3).

The results hence indicate that over both catalyst samples NH_3 is an effective reductant for the stored nitrates, although it is less efficient than H_2 . The Pt-containing sample is more reactive than the Rh-based catalyst. Notably, no N_2O is formed upon the reduction of the stored nitrates, the reaction being very selective towards N_2 . This apparently rules out the involvement of surface nitrates and/or nitrate containing compounds (e.g., ammonium nitrate) in the formation of N_2O , at least under the investigated experimental conditions.

3. Pathways for N2O Formation

The results of the reactivity of gas-phase NO and adsorbed NO_x species with H_2 and NH_3 clearly illustrated that N_2O is formed only during the run with the presence of gas-phase NO. In fact no nitrous oxide formation has been observed both over the Pt- and Rh-BaO/Al $_2O_3$ catalysts upon the reduction of stored nitrates, where no gas-phase NO is fed to the catalyst samples.

Notably, N_2O is formed even in the absence of reductants (*i.e.*, from NO alone), provided that reduced PGM sites are present over the catalyst surface. Reduced Pt or Rh sites catalyze the NO dissociation reaction into N- and O-adatoms; N-species further interact with undissociated NO molecules (either in the gas-phase or from an adsorbed state) leading to the formation of N_2O . This pathway is represented by reactions Equations (2) and (3) previously discussed.

In the absence of any reductant, the reaction is self-inhibited by the formation of oxidized PGM sites (*i.e.*, O-adatoms), formed upon NO dissociation. In this respect, NO itself acts as a weak reductant, being able to scavenge O-adatoms and resulting in the formation of nitrite species adsorbed over the storage component (Ba). The overall stoichiometry of the process is then well described by following NO disproportion reaction Equation (1).

Hence also the storage element participates in the reaction, providing the adsorption sites for nitrites. It may also increase the reactivity of the PGM sites in the NO dissociative chemisorption, as suggested in the literature [10,12]. In fact, experiments carried out over a Ba-free sample showed a much lower N_2O formation if compared to the Ba-containing catalysts [14].

Reduced Pt- and Rh-based catalysts show similar reactivity in the N_2O formation from NO, N_2O being formed at the same temperature, although in the case of the Rh-containing catalyst much lower amounts of N_2O were detected. This is likely related to the lower metal dispersion of the Rh-BaO/Al₂O₃ catalyst if compared to the Pt-containing sample (6.8% vs. 48%, see Table 1), and hence to the lower amounts of surface reduced sites.

When a reductant (H₂ or NH₃) is co-fed with NO, N₂O always appears as the first NO reduction product, along with nitrogen. The onset temperature for NO reduction (and N₂O evolution) depends on the nature of the reductant (with H₂ showing a greater reactivity than NH₃) and on the catalyst as well (Pt-based catalyst being more active than the corresponding Rh-containing sample). The pathways involved in N2O formation are those already depicted for NO alone: the reductant leads to the reduction of the PGM sites, leading to NO dissociation into N- and O-adatoms. However in this case O-adatoms are scavenged by the reductant, and nitrite formation is reduced with respect to the reaction of pure NO. When the reactivity of the reductant is not very high (i.e., near the onset temperature for NO reduction) the PGM sites are not fully reduced and hence there is the chance for N-adspecies to react with undissociated NO molecules, leading to N₂O evolution. At variance, when the reductant maintains the PGM sites in a fully reduced state, NO is readily dissociated and the reduction products are N₂ and NH₃ (when H₂ is used as reductant) or N₂ (reductant NH₃). It is concluded that the formation of N₂O occurs only in the presence of undissociated NO molecules, i.e., when the PGM sites are not fully reduced. Accordingly, the temperature onset for N₂O formation depends on the reactivity of the reductant: it is seen at lower temperature when H₂ is used as a reductant instead of NH_3 , due to the higher reactivity of H_2 .

Notably, no N_2O formation was observed under our experimental conditions upon reduction with both H_2 and NH_3 of nitrates stored over both Pt- and Rh-BaO/Al₂O₃. Notably, the intermediacy of species like ammonium nitrate in N_2O formation is apparently ruled out since no N_2O was observed in the NH_3 /nitrate reaction over both Pt- and Rh-based catalytic materials. It has been suggested that the reduction of the stored NO_x species is involved in the release of NO from the stored NO_x as first step, followed by the reduction of the released NO over the PGM sites [16–19]. The reduction process is initiated by the reduction of the PGM sites by the reductant, which precedes the NO release. The observation that no N_2O is formed in this case may be explained by considering that the rate determining step in the reduction of the stored NO_x is the NO release step [16]; once NO is released, it is readily converted to the reduction products. Accordingly the gas-phase concentration of NO is small and this prevents N_2O formation. However under real operating

conditions, where significant temperature effects may take place, significant release of NO may take place and accordingly N₂O formation is likely to occur.

4. Materials and Methods

Model Pt-BaO/Al₂O₃ (1/20/100 w/w/w) and Rh-BaO/Al₂O₃ (0.5/20/100 w/w/w) samples were prepared by incipient wetness impregnation of a commercial γ -alumina (Versal 250 UOP, Des Plaines, IL, USA) support with Pt(NO₂)₂(NH₃)₂ (Strem Chemicals, 5% w/w, Newburyport, MA, USA) and Rh(NO₃)₃ (Sigma Aldrich, 10% w/w, St. Louis, MO, USA) aqueous solutions, respectively, followed by impregnation with Ba(CH₃COO)₂ (Sigma Aldrich, 99% w/w) aqueous solution. After each impregnation step the samples were dried at 80 °C overnight and calcined at 500 °C for 5 h. The obtained catalysts were characterized by Brunauer-Emmett-Teller (BET) analysis for specific surface area and H₂ chemisorption for metal dispersion and results are reported in Table 1.

The reactivity of NO alone and with different reductants (H_2 , NH_3) was investigated *via* temperature programmed reaction (TPR) experiments. In the case of NO alone, the catalysts were heated in the temperature range 40–400 °C (heating rate 10 °C/min) under a flow of NO (1000 ppm in He, NO-TPR). Before performing the experiments, the catalysts were reduced with H_2 (2000 ppm in He) at 350 °C for 30 min and cooled to 40 °C in He. Such experiments were carried out in a flow micro-reactor apparatus consisting of an home made quartz tube reactor (7 mm I.D.) connected to a mass spectrometer (Omnistar 200, Pfeiffer Vacuum, Asslar, Germany), a micro-gas chromatograph (Agilent 3000A, Santa Clara, CA, USA) and a ultraviolet (UV) analyzer (Limas 11HW, ABB, Zurich, Switzerland) for the on-line analysis of the outlet gases (rig #1). An amount of 60 mg of catalyst was used with a flow rate of 100 cc/min (at 0 °C and 1 atm).

Information on the surface species formed during the experiments was collected in this case by performing the NO-TPR experiments under the same experimental conditions inside an IR reactor cell (ISRI Infrared Reactor, Granger, IN, USA) by using the catalysts in form of self-supported wafers (15 mg, diameter = 13 mm, thickness = 0.1 mm) (rig #2). The IR measurements were collected with a FT-IR Vertex 70 (Bruker, Billerica, MA, USA) spectrometer with 4 cm $^{-1}$ spectral resolution and accumulation of 64 scans using a mercury-cadmium-telluride (MCT) detector.

The reactivity of NO with H_2 and NH_3 (NO/ H_2 -TPR and NO/ NH_3 -TPR, respectively) was investigated by heating the catalyst samples in a flow of NO (1000 ppm) with H_2 (2000 ppm) or NH_3 (1000 ppm) in Ar in the temperature range 40–400 °C (heating rate 4 °C/min). These experiments were carried out in an *operando* FT-IR spectroscopy setup (rig #3) consisting in a "Sandwich" IR cell containing the catalyst (15 mg) in the form of a self-supported wafer; the gases leaving the cell were analyzed by a mass spectrometer (ThermoStar TM GSD 301, Pfeiffer Vacuum)

and a chemiluminescence analyzer (42i-HL MEGATEC, Thermo Fisher Scientific, Waltham, MA, USA). Total flow was 25 cm 3 · min $^{-1}$ (at 1 atm and 0 °C). Surface FT-IR spectra were collected with a FT-IR Nicolet Nexus spectrometer (Thermo Fisher Scientific) with 4 cm $^{-1}$ spectral resolution and accumulation of 64 scans using a deuterated-triglycine sulfate (DTGS) detector.

The same apparatus was used to perform temperature programmed surface reaction (H_2 - and NH_3 -TPSR) experiments. In this case the catalysts were at first saturated with NO_x species at 350 °C by feeding NO (1000 ppm) in O_2 (3% v/v) + Ar. This resulted in the formation of surface nitrate species. Then the catalyst was cooled under He at 40 °C and subsequently heated in flowing H_2 (2000 ppm in Ar, H_2 -TPSR) or NH_3 (1000 ppm in Ar, NH_3 -TPSR) up to 400 °C (heating rate 4 °C/min). Notably, due to the low reductant concentration, experiments were carried out under nearly isothermal conditions, *i.e.*, in the absence of significant temperature effects during the experiments. Further details concerning apparatuses and procedures can be found in [10,15].

Since the fresh catalyst samples were covered by carbonate species, before the experiments few adsorption-reduction cycles under isothermal conditions at 350 $^{\circ}$ C, (*i.e.*, NO/O₂ (1000 ppm NO + O₂ 3%, v/v) and H₂ (2000 ppm)) were performed. This procedure partially replaces the originally present BaCO₃ species with BaO/Ba(OH)₂ species [20].

5. Conclusions

In this paper, mechanistic aspects involved in the formation of N_2O over Pt-BaO/ Al_2O_3 and Rh-BaO/ Al_2O_3 model NSR catalysts were investigated. In particular, the reactivity of both gas-phase NO and stored nitrates were investigated by using H_2 and NH_3 as reductants. Transient experiments with simultaneous gas phase and surface analysis using FT-IR spectroscopy were used to correlate the concentration of the gas-phase species with adsorbed surface species.

The data herein obtained provides clear indication of the fact that over both Rh-and Pt-BaO/Al $_2$ O $_3$ catalysts, N $_2$ O formation involves the presence of gas-phase NO. In fact under our experimental conditions no nitrous oxide formation was observed upon the reduction of the stored nitrate species. The data show that N $_2$ O formation involves the coupling of undissociated NO molecules with N-adspecies formed upon NO dissociation onto reduced PGM sites. The reductant keeps the PGM sites in a reduced state by scavenging O-adatoms formed upon NO dissociation, the initial step of the process. However when complete dissociation of gas-phase NO occurs, N $_2$ O formation is prevented. In fact N $_2$ O formation is observed at temperatures where the reductants start to be active in the reduction of the PGM sites, whereas at higher temperatures, where the reductants effectively keep the PGM sites in a fully reduced state, complete dissociation of NO takes place and N $_2$ O formation is not

effective. This explains why N₂O formation is observed at low temperatures and then disappears at high temperatures.

Over both Rh- and Pt-BaO/Al $_2$ O $_3$ catalysts N $_2$ O formation is observed at lower temperatures with H $_2$ than with NH $_3$, in view of the higher reactivity of hydrogen in the reduction of the PGM sites. Also, N $_2$ O formation occurs at lower temperatures onto Pt-containing catalyst if compared to the Rh-based sample, due to the higher reducibility of Pt vs. Rh.

In the absence of reducing agents, N_2O can be formed from NO provided that reduced PGM sites are present. In such a case O-adatoms formed upon NO decomposition are scavenged by NO itself leading to the formation of nitrite species so that the formation of N_2O occurs according to the stoichiometry of the NO disproportionation reaction Equation (1).

Finally, the fact that N_2O formation was not observed upon the reduction of stored nitrates with both H_2 and NH_3 is due to the slow rate of the NO release process from the stored species. This limits the NO gas-phase concentration during the reduction of the stored species thus preventing N_2O formation.

Methanol Reforming over Cobalt Catalysts Prepared from Fumarate Precursors: TPD Investigation

Abstract: Temperature-programmed desorption (TPD) was employed to investigate adsorption characteristics of CH₃OH, H₂O, H₂, CO₂ and CO on cobalt-manganese oxide catalysts prepared through mixed Co-Mn fumarate precursors either by pyrolysis or oxidation and oxidation/reduction pretreatment. Pyrolysis temperature and Co/Mn ratio were the variable synthesis parameters. Adsorption of methanol, water and CO₂ was carried out at room temperature. Adsorption of H₂ and H₂O was carried out at 25 and 300 °C. Adsorption of CO was carried out at 25 and 150 °C. The goal of the work was to gain insight on the observed differences in the performance of the aforementioned catalysts in methanol steam reforming. TPD results indicated that activity differences are mostly related to variation in the number density of active sites, which are able to adsorb and decompose methanol.

1. Introduction

Mixed cobalt-manganese fumarate salts are useful precursors leading to catalysts with different structure depending on the type of surrounding atmosphere during activation [1]. Thus, activation in air leads to burn-off of the fumarate group and concomitant formation of mixed $Co_xMn_{1-x}O_y$ spinel oxides, while activation in inert gas leads to pyrolysis of the fumarate group and formation of species with lower oxidation state, such as metallic cobalt, mixed oxides of Co^{2+} and Mn^{2+} and residual carbon. Combination of *in-situ* XRD, H_2 -TPR and methanol-TPR has shown that catalysts produced by pyrolysis are almost fully reduced [1]. Thus, catalysts derived from pyrolysis do not need prereduction and are more active than those with an initial spinel structure in the reaction of steam reforming of ethanol or methanol [2]. State-of-the-art catalysts for steam reforming of methanol are copper-based and operate at 250–300 °C, while ethanol reforming requires higher temperatures of the order of 600 °C [3–9]. Cobalt is a less efficient catalyst than copper in the steam reforming of methanol operating at temperatures around 400 °C [2].

From a mechanistic point of view, adsorption is a key step in catalytic reactions. Hence, study of adsorption and desorption of relevant molecules on catalytic surfaces can provide insight on the population and intrinsic properties of active sites. TPD, in particular, is a standard technique via which one can obtain information concerning: (i) adsorption site homogeneity, as reflected in the presence of one or more desorption peaks; (ii) strength of the adsorbate-surface bond, as reflected in the peak temperature of desorbed species; and (iii) number density of adsorption sites, as reflected in the amount of desorbed species. It is especially useful in comparative parametric studies of a catalyst family.

Adsorption of methanol on a Co(0001) surface takes place as methoxide via OH bond scission. During heating, a small amount of methanol desorbs molecularly, while the majority of methoxide decomposes to CO and hydrogen [10]. Infrared spectra produced by adsorbed species formed during the exposure of silica-supported Co to methanol have been obtained by Bliholder *et al.* [11]. Methanol was found to adsorb to a small extent on the silica support -probably as a methoxide, while varying mixtures of methoxide, acyl, and chemisorbed CO species were produced on Co. The interaction between Co_3O_4 or CoO with methanol under either atmospheric or high vacuum conditions was examined by Natile *et al.* [12]. Methanol was found to chemisorb mainly molecularly on cobalt oxide surfaces, while its dissociation became evident at higher temperatures. In the case of Co_3O_4 , the presence of formate and formaldehyde species was evident in the temperature range 200–350 °C, whereas under high vacuum conditions, formaldehyde and several decomposition and fragmentation products were observed along with carbon oxides.

Adsorption of water on a hexagonal Co(1120) surface was studied by means of photoelectron spectroscopies (XPS, UPS) by Grellner *et al.* [13]. Molecular adsorption of water at 100 K was accompanied by the formation of small amounts of OH in the submonolayer range. When the temperature is increased, desorption of the multilayer occurs first at 150 K and OH remains on the surface. Disproportionation of OH takes place at 270 K leaving oxygen on the surface. A systematic study of the adsorption and dissociation of water on transition and noble metal dimers was presented by Heras *et al.* [14].

Activated hydrogen chemisorption on unsupported and supported (silica, alumina, titania, magnesia, and carbon supports) cobalt catalysts prepared by a variety of techniques has been reported by Bartholomew *et al.* [15–17]. The surface interaction of CO, CO₂ and H₂ with the perovskite-type oxide LaCoO_x has been studied as a function of reduction temperature using XPS and TPD by Tejuca *et al.* [18]. Hydrogen was found to adsorb on cobalt both weakly and strongly (desorption peaks at 70 °C and above 200 °C). Dissociative adsorption yielding hydroxyl groups was also detected. Narayanan *et al.* [19] studied H₂ adsorption at 100 °C on Co/Al₂O₃ catalysts with varying cobalt content (10%–50%). The amount of adsorbed H₂ was

15 μ mol· g⁻¹ at 20% cobalt loading and increased to 67 μ mol· g⁻¹ for 50% cobalt loading. Hydrogen adsorption/desorption characteristics on Co-TiN nanocomposite particles have been studied using TPD by Sakka *et al.* [20]. Hydrogen desorption was observed in the temperature range 100–320 °C. Activated chemisorption of hydrogen on prereduced MnFe₂O₄ spinel oxides was reported by Soong *et al.* [21]. Hydrogen desorption at 570–630 °C was attributed to chemisorbed species on MnO.

Gauthier et al. [22] investigated CO adsorption on PtCo(111) surfaces by scanning tunneling microscopy. It was found that CO molecules reside exclusively on top of Pt sites and never on Co. High-pressure, in-situ diffuse reflectance, Fourier Transform Infrared Spectroscopy was employed by Jiang et al. [23] to study CO adsorption on samples derived from precipitated cobalt-manganese oxides of different Co/Mn ratios reduced by H₂. According to their results the adsorption features of the samples vary significantly with manganese loading. CO linearly adsorbed, bridged and multiple-bridged on Co° sites was identified. Mohana et al. [24] found that CO adsorption at room temperature on cobalt particles supported on MgO leads mainly to the formation of linearly adsorbed species, while the disproportionation reaction accompanied by carbon deposition already takes place at room temperature. Carbon deposition on cobalt catalysts in Fischer-Tropsch and steam reforming reactions is well-documented [25–31]. Regarding methanol reforming, the pathway of carbon deposition on cobalt catalysts appears to be the Boudouard reaction since CO is the main reaction product. The structure of carbon deposits originating from CO depends on reaction temperature with amorphous and filamentous carbon prevailing at low temperatures (350-600 °C), which are relevant to methanol steam reforming [31]. Formation of filamentous carbon does not lead to catalyst deactivation but rather to reactor plugging leading to excessive pressure drop.

In the present study, TPD experiments of pre-adsorbed CH₃OH, H₂O, H₂, CO₂ and CO were employed in order to examine the adsorptive properties of cobalt catalysts prepared through mixed cobalt-manganese fumarate precursors by activation under oxidative or reducing conditions. The objective of this study was to investigate the effect of catalyst synthesis parameters on the corresponding adsorptive properties. More specifically, the examined catalyst synthesis parameters were: (i) the activation type, pyrolysis or calcination; (ii) the Co/Mn ratio; and (iii) the pyrolysis temperature. These are the main parameters influencing the structure [1] and activity [2] of the specific catalysts in methanol steam reforming. To our knowledge, an extensive investigation of the adsorption of a variety of catalysis relevant molecules on Co-Mn based catalysts has not been reported previously.

2. Results and Discussion

2.1. TPD of Adsorbed CO or CO₂




Figure 1. TPD following CO adsorption at 25 °C or 150 °C on CoMn11AFp600 catalyst: (a) CO desorption; and (b) CO₂ desorption.

No significant CO adsorption was found on the catalysts (both pyrolyzed and preoxidized ones) following exposure to CO at room temperature. As an example, TPD results following CO adsorption on the CoMn11AFp600 catalyst at 25 and 150 °C are presented in Figure 1a,b. The curve called "blank" corresponds to the amounts of CO and CO₂ observed during TPD without any prior CO adsorption. CO and CO₂ production in the blank experiment is due to residual decomposition of organic species originating from the fumarate precursor. It can be observed that after adsorption of CO at room temperature, there is minimal desorption of CO during TPD (less than 20 ppm of CO in the gaseous stream) and no CO₂ desorption. Following CO adsorption at 150 °C, both CO and CO2 were found in the TPD profile. CO desorbs in the form of two peaks at 50 °C and 140 °C, while CO₂ appears with a main peak at 200 °C followed by a shoulder at 350 °C and a smaller peak at 500 °C. The origin of CO₂ could be either the Boudouard reaction or oxidation of adsorbed CO by surface oxygen. Based on literature findings, the occurrence of the Boudouard reaction is highly probable. For example, formation of carbon on a Co/Al₂O₃ catalyst by CO disproportionation at 230 °C has been reported by Nakamura et al. [32]. This temperature is in the same range as the one shown in Figure 1b regarding CO₂ formation. CO disproportionation on Co/MgO catalysts has been found to take place already at room temperature [24]. Since the catalyst samples of this work, however, contain carbon in their composition (residual carbon from fumarate pyrolysis), it is not possible to measure any carbon formed on the catalysts from CO disproportionation via subsequent temperature-programmed oxidation.




Figure 2. TPD of CO₂ following its adsorption at 25 °C on (a) CoMn1xAFc500 (TPR), x = 1, 2; and (b) CoMn11AFpi, i = 500, 600, 700 °C and CoMn12AFp600.

The corresponding results of TPD following CO₂ adsorption at 25 °C on catalysts prepared via oxidation and oxidation/reduction or pyrolysis are given in Figure 2a,b, respectively. CO₂ profiles from oxidized/reduced catalysts (Figure 2a) show a main peak at ~100 °C and a smaller high temperature peak above 500 °C. CO₂ profiles from pyrolyzed catalysts are quite complicated and broad from 30 to 600 °C with multiple desorption peaks. The population of sites that adsorb CO₂ strongly appears to decrease with increase of pyrolysis temperature and this leads to concomitant decrease of the amount of desorbed CO₂ with increase of pyrolysis temperature. More specifically, the amount of desorbed CO₂ is 240 μ mol· g $^{-1}$ for CoMn11AFp500 and decreases to 100 and 57 μ mol· g $^{-1}$ for catalysts prepared by pyrolysis at 600 and 700 °C, respectively. At the same time, the specific surface area of pyrolyzed samples is more or less independent of pyrolysis temperature in the range of 200–220 m 2 · g $^{-1}$, as measured by the BET method. This indicates that pyrolysis temperature affects mostly active sites for adsorption of CO₂ and not the exposed surface area in general. The amount of adsorbed CO₂ on catalysts prepared by oxidation/reduction is

17–19 μ mol· g⁻¹, *i.e.*, considerably smaller than the one found over the pyrolyzed catalysts. This is in line with the smaller specific surface area of these samples by one order of magnitude.

2.2. TPD of Adsorbed H₂




Figure 3. H₂-TPD profiles following its adsorption at 25 $^{\circ}$ C and 300 $^{\circ}$ C on CoMn11AFp600, CoAFp600, MnAFp600 and CoMn11AFc500 (TPR) samples.

 $\rm H_2$ -TPD studies were carried out following $\rm H_2$ adsorption at 25 or 300 °C under a flow of pure hydrogen. Representative TPD profiles of hydrogen are presented in Figure 3. The oxidized/reduced sample (CoMn11AFc500(TPR)) adsorbed no measurable amount of hydrogen at room temperature and trace amounts at 300 °C. The pyrolyzed cobalt-only sample indicates the presence of rather weakly bound hydrogen desorbing with peak at ~70 °C. Increase of adsorption temperature to 300 °C leads to population of more strongly-bound adsorbed hydrogen, as evidenced

by the appearance of a shoulder at 100–200 °C. TPD profiles from the manganese-only sample show the presence of strongly-bound hydrogen desorbing in the range of 400–650 °C after adsorption at room temperature. Increase of adsorption temperature to 300 °C leads to the appearance of an intermediate-strength state with desorption at ~300 °C. The TPD profile from the CoMn11AFp600 sample, which contains both cobalt and manganese, incorporates features that are attributable to the presence of both cobalt crystallites and MnO. Strongly-bound hydrogen desorbs at 460 °C and is larger in quantity compared to the manganese-only sample. Therefore, the observed profile is not just the sum of isolated contributions of cobalt and MnO species, but is influenced by mutual interactions. Table 1 presents the amounts of desorbed hydrogen during TPD after adsorption at 25 and 300 °C. The oxidized catalyst which had been reduced prior to H2 adsorption adsorbs no H2 at room temperature and 10 μ mol· g⁻¹ at 300 °C, which is one to two orders of magnitude smaller than the corresponding values of catalysts from the same precursor prepared by pyrolysis. Concerning the effect of adsorption temperature, it is observed that the amount of desorbed hydrogen increases by up to 350% with increase of adsorption temperature from 25 to 300 °C. The smallest increase is found for the sample adsorbing the largest amount of hydrogen at room temperature, i.e., CoMn11AFp600. amounts of desorbed hydrogen in samples containing both cobalt and manganese are considerably larger than the ones found over single-component samples, indicating the presence of synergy and creation of additional adsorption sites. Contrary to what was found in the case of CO₂ adsorption, the amount of adsorbed hydrogen does not decrease with increase of pyrolysis temperature, indicating that at least some of the adsorption sites for hydrogen and CO₂ are not identical. Using the data in Table 1, estimates of the maximum dispersion of cobalt in the various catalysts can be provided assuming that no adsorption takes place on MnO sites in the case of Co-Mn catalysts. Taking that the stoichiometry of hydrogen adsorption is one hydrogen atom per one surface cobalt atom, the dispersion (H/Co) ratio is ~2% for the cobalt-only catalyst and becomes even higher than 20% for Co-Mn catalysts pyrolyzed at 600 °C.

 H_2 -TPD results for the cobalt-only catalysts are in agreement to those reported by Popova and Babenkova for thermal desorption of preadsorbed hydrogen on a-Co and b-Co prepared by formate decomposition in a hydrogen flow at 300, 350 and 600 °C, whereas hydrogen desorption was completed at 300 °C [24].

2.3. TPD of Adsorbed H_2O

Water adsorption was carried out at 25 and 300 $^{\circ}$ C. A characteristic feature of water adsorption at 300 $^{\circ}$ C over catalysts prepared by pyrolysis is the accompanying appearance of hydrogen in the gas phase indicative of reactive adsorption according to:

$$Co + H_2O \rightarrow Co-(O) + H_2$$




Figure 4. TPD profiles of H_2O and H_2 after water adsorption at 25 °C over pyrolyzed catalysts.

TPD profiles of H_2O and H_2 after water adsorption at room temperature over pyrolyzed catalysts are shown in Figure 4. H_2O profiles are characterized by a main

peak with maximum at 90–100 °C followed by a broad descending feature up to 450 °C. Increase of pyrolysis temperature leads to decrease of the amount of adsorbed water. This trend is analogous to what was found for CO₂ adsorption (Section 2.1). The profiles of H₂ during TPD after water adsorption at room temperature over pyrolyzed catalysts are also presented in Figure 4. Hydrogen desorption is observed mostly above 400 °C with CoMn11AFp600 catalyst showing also minor hydrogen desorption at 60 °C. Since TPD profiles following H₂ adsorption are characterized by hydrogen peaks in the 400–600 °C range, it is not clear whether appearance of hydrogen in the gas phase is desorption or reaction limited. However, taking into account that water decomposition does take place at 300 °C, it is most probable that the profile of hydrogen is desorption limited. In addition, the absence of hydrogen in the low-temperature range implies that adsorbed water decomposition takes place at temperatures higher than ~150 °C. The amount of produced hydrogen during H_2O -TPD was 0.2–0.3 mmol· g^{-1} while the amount of desorbed hydrogen after its adsorption at room temperature was 0.17–0.33 mmol·g⁻¹. This implies that the extent of adsorbed water decomposition is related to the number of surface centers available for adsorption of produced H₂.




Figure 5. TPD profiles of H_2O and H_2 after water adsorption at 300 °C over pyrolyzed catalysts.

Water adsorption at 300 $^{\circ}$ C was accompanied by gaseous H₂ production for all pyrolyzed catalysts with the exception of MnAFp600. TPD profiles of H₂O and H₂ after water adsorption at 300 $^{\circ}$ C over pyrolyzed catalysts are shown in Figure 5. TPD profiles of water consist of a main peak at 60–100 $^{\circ}$ C followed by a tail up to 500 $^{\circ}$ C. The profiles of hydrogen during TPD are quite broad and they show measurable desorption of hydrogen at the whole temperature range from 30 to 600 $^{\circ}$ C. These

are in general agreement to TPD profiles obtained following adsorption of hydrogen at 300 $^{\circ}\text{C}.$




Figure 6. (a) Total absorbed H_2O at 300 $^{\circ}C$ and H_2 produced during water adsorption; and (b) H_2O and H_2 desorbed during TPD from CoAF, MnAF, CoMn11AF and CoMn12AF pyrolyzed at 600 $^{\circ}C$.

Quantitative results of the total adsorbed water (mmol· g^{-1}) at 300 °C (sum of water absorbed at 300 °C and during cooling to RT), hydrogen produced during H_2O adsorption, and subsequent TPD as a function of catalyst content in Mn are given in Figure 6a,b. The total adsorbed water is four times higher on MnAFp600 than on CoAF600, although this difference is mostly due to water adsorbed during cooling. The highest amount of water adsorption is, however, observed over the Co-Mn catalysts. In an analogous manner, the amount of formed H_2 , *i.e.*, the sum of hydrogen produced during adsorption and desorbed during TPD, is considerably higher over the Co-Mn catalysts compared to the cobalt-only catalyst and especially to the Mn-only sample.

The CoAFp600 catalyst contains 11.6 mmol Co· g $^{-1}$ and produced 0.4 mmol H $_2$ · g $^{-1}$ during water adsorption and TPD. Assuming one adsorbed hydrogen atom per surface cobalt atom, the resulting H/Co ratio is 0.069. The corresponding H/Co ratio for hydrogen adsorption at 300 °C is 0.021 (Table 1). In the case of the CoMn11AFp600 catalyst, the total amount of hydrogen was 0.8 mmol· g $^{-1}$, which compares well with the amount of hydrogen adsorbed during hydrogen adsorption (0.66 mmol· g $^{-1}$).




Figure 7. (a) Total absorbed H_2O at 300 °C and H_2 produced during water adsorption; and (b) H_2O desorbed and H_2 producing during TPD. CoMn11AFpi with i = 500, 600, 700 °C.

The effect of pyrolysis temperature of the CoMn11AF catalyst on adsorbed/desorbed water and H_2 amounts is presented in Figure 7a,b, respectively. It can be observed that although the amount of total adsorbed water does not change appreciably with variation of pyrolysis temperature, there are changes in the "strength" of water adsorption. Thus, the amount of water desorbed during TPD decreases, because there is an increase in the amount of weakly adsorbed water, which desorbs already at room temperature before initiation of the TPD run. Similarly, the amount of water adsorbing during cooling decreases and the amount of water adsorbing at 300 °C increases with increase of pyrolysis temperature. This also relates to the fact that the extent of cobalt reduction increases with increase of pyrolysis temperature.




Figure 8. (a) Total absorbed H_2O at 300 $^{\circ}C$ and H_2 produced during water adsorption; and (b) H_2O desorbed and H_2 producing during TPD from CoMn11AFc500, CoMn11AFc500(AIR) and CoMn11AFc500(TPR).

The effect of catalyst activation procedure on quantitative behavior of water adsorption is presented in Figure 8. Three catalysts are compared, all activated at 500 °C: CoMn11AFp500 prepared by pyrolysis, CoMn11AFc500(AIR) prepared by oxidation of the precursor and CoMn11AFc500(TPR) prepared from CoMn11AFc500(AIR) by subsequent reduction by H₂ up to 600 °C. The two latter catalysts adsorb significantly less water than CoMn11AFp500 and, in addition, they produce almost no hydrogen during exposure to water at 300 °C.

2.4. TPD of Adsorbed CH₃OH




Figure 9. CH₃OH-TPD on CoMn11AFp500 and CoMn11AFp700.

CH₃OH, CO, H₂, CO₂ and H₂O profiles during CH₃OH-TPD for CoMn11F samples pyrolyzed at 500 or 700 $^{\circ}$ C are shown in Figure 9a,b, respectively. Dashed lines in Figure 9a represent CO₂, H₂, CO and H₂O production during the blank

experiment (without prior methanol adsorption). The appearance of these molecules is due to residual pyrolysis of the fumarate precursor. TPD profiles following adsorption of methanol at room temperature indicated the presence of CO, CO₂, H₂ and H₂O in addition to methanol. Methanol desorption profiles are composed of a main peak at 90 °C and a less intense second peak in the form of a shoulder at 160 °C. Methanol desorption is completed at 300 °C for CoMn11AFp500 and at 210 °C for CoMn11AFp700. At the same time, methanol decomposition to CO and H₂ takes place above 150 °C for both catalysts. The hydrogen peak is shifted by ~10 °C to the right compared to CO peak, probably due to readsorption effects. At the maximum CO production temperature (230 °C), CO₂ starts also appearing in the gas phase. One possible explanation for the production of CO₂ is reaction of CO with catalyst surface oxygen. This hypothesis is supported by the fact that less CO₂ is produced over the CoMn11AFp700 catalyst, which is in a more reduced state due to its activation at higher temperature. In addition, CO₂ production is accompanied by water production (at least for CoMn11p500), which also indicates oxidation of hydrogen by surface oxygen. Another possibility is that (part of) CO₂ is produced via the Boudouard reaction. This hypothesis cannot be checked by oxidation of surface carbon (also produced during Boudouard), since pyrolyzed catalysts already contain residual carbon in their structure. Judging from the fact that water production is minimal over the CoMn11AFp700, the occurrence of the Boudouard reaction cannot be disregarded.




Figure 10. CH₃OH-TPD on CoMn11AFp600 and CoMn12AFp600.

CH₃OH, CO, H₂, CO₂ and H₂O profiles during CH₃OH-TPD from CoMn11AF and CoMn12AF catalysts prepared from pyrolysis at 600 °C are shown in Figure 10a,b, respectively. For both catalysts methanol is desorbed with a main peak at 90 °C and a tail extending up to 250 °C. The CO profile of CoMn11AFp600 includes two main peaks at 210 and 390 °C and is completed at 500 °C. Decrease of cobalt content leads to CO production with a similar profile, but in this case its production extends even above 600 °C. The hydrogen profile follows generally the CO profile. For both catalysts, CO₂ production is also detected and is more intense on CoMn11AFp600. Overall, the profiles indicate the presence of more than one adsorbed species of methanol and have interference by CO₂ readsorption effects (Figure 2b).




Figure 11. CH₃OH-TPD on CoMn11AFc500(AIR) and CoMn11AFc500(TPR).

CH₃OH, CO, H₂, CO₂ and H₂O profiles during CH₃OH-TPD for the catalyst prepared by oxidative pretreatment (CoMn11AFc500(AIR)) or oxidation/reduction (CoMn11c500(TPR)) are shown in Figure 11. Methanol adsorbed on the oxidized catalyst mainly acts as a reducing agent during TPD. Hence, CO₂ and H₂O are produced from the oxidation of adsorbed methanol by surface oxygen. Oxidation of methanol takes place in the form of two peaks, indicative either of the presence of two different modes of adsorbed methanol or of stepwise reduction of the surface. The peaks of oxidation products, CO₂ and H₂O, do not coincide evidently due to readsorption effects. The high temperature CO₂ peak is accompanied by production of small quantities of CO and H₂, which implies that active sites for methanol decomposition have been created only at that point (and not after the first CO₂ peak). On the contrary, the TPD profile of CoMn11AFc500 (TPR) corresponds to decomposition of adsorbed methanol towards CO and H₂ in the range of 150–250 °C.

The production of small amounts of CO_2 can be attributed to additional surface reduction of the catalyst. Comparison of Figures 9–11 shows that the onset and the main peak of methanol decomposition to CO and H_2 take place in the same temperature range for both the oxidized/reduced catalyst and all pyrolyzed catalysts. One important difference is that pyrolyzed catalysts contain additional states of adsorbed methanol which decompose at higher temperatures up to 500–600 $^{\circ}$ C.




Figure 12. Desorbed amounts of CH_3OH , CO, CO_2 , H_2 and H_2O during TPD after CH_3OH adsorption. Adsorbed amount of methanol is shown with asterisks (*).

The quantitative analysis of methanol adsorption and TPD experiments is presented in Figure 12. The amounts of adsorbed methanol are indicated with asterisks, while the amounts of desorbed CH₃OH, CO, CO₂, H₂ and H₂O during TPD are given in column form. The following observations can be made concerning Figure 12:

- With the exception of catalyst CoMn11AFp500, which adsorbs 1 mmol· g^{-1} , all catalysts adsorb methanol in the range of 0.2–0.5 mmol· g^{-1} . The lowest quantity is found over the oxidized/reduced sample.
- Less than half of adsorbed methanol desorbs molecularly.
- Increase of pyrolysis temperature and decrease of cobalt content lead to decrease of adsorbed methanol.
- The amounts of CO and CO₂ produced during methanol TPD are 2–4 times higher over the pyrolyzed catalysts compared to those prepared via oxidation or oxidation/reduction.

- The oxygen mass balance between output and input shows a surplus indicating
 that adsorbed methanol acts as a reducing agent scavenging lattice oxygen from
 the catalysts. The amount of adsorbed methanol that gets oxidized towards CO₂
 and H₂O depends on the oxidation state of the catalyst surface.
- The carbon mass balance is overall satisfied (error <10%) with the exception of the CoMn11AFp500 catalyst, because its reported values correspond to temperatures below 400 °C (at higher temperatures interference from residual pyrolysis does not allow for reliable measurement).

2.5. Discussion

Application of the catalysts examined in the present work in methanol steam reforming has shown that the catalysts obtained via pyrolysis are more active than those prepared via oxidative pretreatment [1,2]. The former are already in reduced state exemplified by the presence of metallic cobalt and a mixed $\text{Co}_x \text{Mn}_{1-x} \text{O}$ phase, while the latter consist initially of a mixed Co-Mn spinel oxide phase. When exposed to the reforming reaction mixture, however, the spinel oxide phase gets gradually reduced and the catalyst becomes activated. It is understandable that surface reduction of the spinel phase is a prerequisite for switching on the catalytic function. The findings of the present work during TPD of methanol indicate that adsorbed methanol acts as the reduction agent and the preoxidized catalyst is indeed initially inactive in methanol decomposition (Figure 11). On the other hand, all

pyrolyzed catalysts, as well as the oxidized/reduced catalyst, are active in the decomposition of preadsorbed methanol towards CO as well as CO₂. The appearance of CO₂ takes place at higher temperatures than CO and its profile is matched well by the profile of coproduced H₂ (Figures 9 and 10). This implies that both CO₂ and H₂ originate from a common surface species, which is most probably formate. At this point, it would be interesting to compare the observed behavior of cobalt catalysts in methanol-TPD with the one of copper catalysts and, more specifically, CuO/Al₂O₃ [33]. The TPD profile from CuO/Al₂O₃ contains minor amounts of methanol (170 $^{\circ}$ C) and production of CO₂ and H₂ with peak at 200–250 $^{\circ}$ C. Small amounts of HCOOH are also produced in the same temperature range. CO is observed at higher temperatures with peak at 350 °C. Therefore, the main difference in the function of cobalt and copper catalysts is that CuO forms surface formate from adsorbed methanol, which decomposes at relatively low temperature to CO₂ and hydrogen. The observed CO at higher temperatures may be attributed to the reverse water-gas shift reaction. The cobalt catalysts of the present work, on the other hand, produce CO and H₂ at 200–250 °C, while CO₂ and H₂ production from formate decomposition is observed at much higher temperatures. These results exemplify nicely the superiority of copper versus cobalt in steam reforming of methanol: copper creates formate species which decompose at low temperatures to CO₂ and H₂, while cobalt decomposes methanol to CO and H2 and the created formate species are stable so that they act rather as spectators occupying a fraction of the active sites [34].

The higher activity of pyrolyzed catalysts can be attributed mainly to their higher number density of active sites since peak temperatures of CO during TPD after methanol adsorption are similar in pyrolyzed and oxidized/reduced catalysts. During pyrolysis of the fumarate precursors, residual carbon is left behind and helps stabilize cobalt and MnO crystallites against extensive sintering. The resulting specific surface area of pyrolyzed catalysts is thus approximately one order of magnitude higher than the one of spinel oxide samples [1]. The higher available area for adsorption has been confirmed for water (Figure 8) and CO₂ (Figure 2) adsorption, whereas pyrolyzed samples adsorb up to one order of magnitude more water or CO₂ per unit weight. This applies to a lesser extent for methanol adsorption, whereas pyrolyzed samples adsorb up to 5 times more methanol. It is understandable that a certain fraction of these adsorbed molecules on pyrolyzed catalysts may reside on the carbonaceous support, whose surface composition in terms of oxygen content is strongly dependent on pyrolysis temperature. This may explain the observed variations in the adsorbed amounts of water, methanol and CO2 as a function of pyrolysis temperature, which causes no change in the BET surface area otherwise. Comparison of relative amounts of adsorbed hydrogen and methanol on pyrolyzed and oxidized/reduced catalysts shows considerable discrepancies. Using hydrogen adsorption as a measure of cobalt dispersion and hence of active sites would lead to

a wrong conclusion regarding differences among the various samples as related to activity in methanol reforming. In this respect, methanol is a more suitable probe, since it is the molecule of interest in the target reaction. Following this train of thought, one should further consider not the total amount of adsorbed methanol, but rather the amount of irreversibly adsorbed methanol that decomposes during heating. In this respect, the concentration of active sites in pyrolyzed catalysts is smaller than the one expected if one takes BET surface area or the amount of adsorbed hydrogen as indicators.

Concerning the role of water, it has been found in the present work that the catalysts are effective in dissociating the water molecule at temperatures of interest for the reforming reaction getting themselves oxidized in the process. The extent of water adsorption and dissociation is directly related to available sites responding to hydrogen adsorption (H₂-TPD experiments). Although one could envisage, based on this finding, methanol reforming taking place through a surface reduction-oxidation mechanism, *i.e.*, surface reduction by methanol leading to CO₂ and H₂O production followed by surface reoxidation by water leading to hydrogen production, this does not appear to be the case. Indeed, the product distribution during methanol reforming over all cobalt catalysts examined indicates a mechanism comprising methanol decomposition and the water–gas shift reaction and CO selectivity is higher or at best equal to the one predicted by thermodynamic equilibrium.

3. Experimental Section

3.1. Catalyst Preparation

The precursor compounds for catalyst synthesis were mixed fumarate salts of cobalt and manganese, which were prepared by mixing aqueous solutions of cobalt and manganese acetate with a solution of fumaric acid in ethanol followed by drying at 120 °C. The corresponding catalysts were prepared by pyrolysis of the salts under inert gas with a linear heating rate of 5 °C/min to the target temperature, 500, 600 or 700 °C, soak for 5 min and cooling down to adsorption temperature. The pyrolyzed catalysts are named CoMn1xAFpTTT, with TTT being the pyrolysis temperature and 1x (x = 1 or 2) being the Co/Mn atomic ratio. For example, the CoMn11AFp600 catalyst has a Co/Mn atomic ratio of 1/1 and has been prepared by pyrolysis at 600 °C. Samples were also prepared via oxidative treatment of the salts at 500 °C for 2 h for comparison purposes (named CoMn11AFc500). Calcined catalysts that had been reduced before adsorption are named CoMn11AFc500 (TPR).

3.2. Catalyst Characterization

Catalysts were characterized by nitrogen physisorption (BET), H₂-TPR, CH₃OH-TPR and *in-situ* XRD. Characterization results have been reported in [1,2].

3.3. TPD Experiments

Temperature-programmed desorption (TPD) of pre-adsorbed CH₃OH, H₂O, H₂, CO₂ and CO at room temperature were performed. TPD of pre-adsorbed H₂O and H₂ at 300 °C were performed also. Temperature Programmed Desorption (TPD) experiments were carried out at atmospheric pressure in a fixed-bed reactor system with two independent gas lines equipped with mass flow controllers (Aera GmbH, Kirchheim, Germany). A mass spectrometer (Omnistar/Pfeiffer Vacuum, Asslar, Germany) was used for on-line monitoring of effluent gases. Prior to each CO or CO₂ adsorption experiment, the calcined catalysts were reduced by 3% H₂/He mixture at 400 °C for 20 min with a linear heating rate of 5 °C min⁻¹. For all the other molecules examined reduction of calcined catalysts was performed by 3% H₂/He mixture at 600 °C for 30 min. For all molecules whose adsorption was studied at room temperature following completion of the adsorption, indicated by stable signals in the mass spectrometer, the reactor was purged with pure He until all signals met their baselines. Then, the TPD run was started under a helium flow of 50 cm³· min⁻¹ with a heating rate of $10 \,^{\circ}\text{C} \cdot \text{min}^{-1}$. For all molecules whose adsorption was studied at 300 °C, cooling from adsorption temperature to 30 °C was performed in the presence of the same gaseous flow. After cooling, the reactor was purged with 50 cm³· min⁻¹ He and TPD was started as soon as the signals had been stabilized. For all catalysts, blank experiments were also performed. Adsorption of CO and CO_2 was carried out under a flow of 1.1% CO/He (50 cm³· min⁻¹) or 1.1% CO_2/He (50 cm³· min⁻¹) mixture, respectively. Hydrogen adsorption was performed under pure hydrogen flow of 20 cm³· min⁻¹ for 10 min. Water adsorption was carried out using a 5400 ppm H_2O/He mixture (50 cm³·min⁻¹). Methanol adsorption was carried out using a 17,000 ppm CH₃OH/He mixture. The following masses were recorded in the mass spectrometer during all TPD experiments: 18 (H₂O), 28 (CO), 44 (CO₂), 31 and 32 (CH₃OH), 15 (CH₄), 29 and 30 (HCHO), 45 (CH₃OCH₃) and 49 (HCOOH).

4. Conclusions

The employment of TPD in order to investigate the interaction of CO, CO_2 , H_2 , H_2O and CH_3OH with cobalt catalysts prepared from cobalt-manganese fumarate precursors via pyrolysis or oxidation has led to the following findings:

- Adsorption of CO and H₂ is activated. Although activated hydrogen adsorption on cobalt is well established, activated adsorption of CO has not been reported previously.
- Hydrogen appears to adsorb both on cobalt and MnO components. Taking
 into account literature results concerning cobalt and MnO and results of the
 present work concerning cobalt, MnO and Co-MnO samples, it is inferred that

hydrogen desorbing below 250 °C originates from cobalt crystallites, hydrogen desorbing above 500 °C originates from MnO, while hydrogen desorbing in the intermediate temperature range (250–500 °C) probably originates from sites created at the interface of Co and MnO or from a mixed reduced oxide phase.

- Water adsorption is dissociative at an adsorption temperature of 300 °C, but not at 25 °C, leading to surface oxidation of the catalyst. Hydrogen produced from water dissociation remains partially adsorbed on the catalyst surface confirming that part of hydrogen is quite strongly bound on the catalysts.
- Reaction paths of adsorbed methanol during TPD include decomposition to CO and H₂, as well as creation of rather stable surface formates, which decompose at higher temperatures to CO₂ and H₂. Adsorbed methanol acts as a reducing agent during TPD leading to catalyst reduction.
- Differences of the pyrolyzed and oxidized/reduced catalysts appear to be mainly in the number density of active sites, which, however, is not directly analogous to differences in specific surface area.

Hydrogen Production by Ethanol Steam Reforming (ESR) over CeO₂ Supported Transition Metal (Fe, Co, Ni, Cu) Catalysts: Insight into the Structure-Activity Relationship

Abstract: The aim of the present work was to investigate steam reforming of ethanol with regard to H₂ production over transition metal catalysts supported on CeO₂. Various parameters concerning the effect of temperature (400–800 °C), steam-to-carbon (S/C) feed ratio (0.5, 1.5, 3, 6), metal entity (Fe, Co, Ni, Cu) and metal loading (15–30 wt.%) on the catalytic performance, were thoroughly studied. The optimal performance was obtained for the 20 wt.% Co/CeO₂ catalyst, achieving a H₂ yield of up to 66% at 400 °C. In addition, the Co/CeO₂ catalyst demonstrated excellent stability performance in the whole examined temperature range of 400-800 °C. In contrast, a notable stability degradation, especially at low temperatures, was observed for Ni-, Cu-, and Fe-based catalysts, ascribed mainly to carbon deposition. An extensive characterization study, involving N₂ adsorption-desorption (BET), X-ray diffraction (XRD), Scanning Electron Microscopy (SEM/EDS), X-ray Photoelectron Spectroscopy (XPS), and Temperature Programmed Reduction (H₂-TPR) was undertaken to gain insight into the structure-activity correlation. The excellent reforming performance of Co/CeO₂ catalysts could be attributed to their intrinsic reactivity towards ethanol reforming in combination to their high surface oxygen concentration, which hinders the deposition of carbonaceous species.

1. Introduction

Energy is a vital element in our everyday lives, mostly generated, however, from fossil fuels. Furthermore, our continuous dependence on fossil fuels is strongly coupled with natural resource depletion and serious environmental implications, such as greenhouse effect, stratospheric ozone depletion, photochemical smog, etc. Therefore, the need for renewable energy is becoming ever more urgent. In view of

this fact, solar, wind, and biomass have become promising renewable energy sources (RES). Although significant technological progress has been accomplished in their efficient energy conversion, their share in the world energy mix is limited due to their intermittent character and site-dependence. On the other hand, hydrogen has been acknowledged as an ideal energy currency for sustainable energy development. Hydrogen can be employed as feedstock in a fuel cell to directly generate electricity at high efficiencies and low environmental footprint. In this regard, hydrogen production in a clean and renewable manner is essential for a sustainable energy future [1–4].

Nowadays, the steam reforming of natural gas is the most frequently employed and economically feasible method for hydrogen production [1–3]. This process, however, is based on a fossil resource and is linked with CO₂ emissions, unless carbon capture and storage (CCS) techniques are employed, which inevitably increase the complexity and overall costs. The rising concerns, related to the reduction of atmospheric pollutants in conjunction with the continuously increasing energy demands, have stimulated the research toward hydrogen production from renewable sources. In this direction, ethanol is among the most promising feedstocks, due to its relatively high hydrogen content, wide availability, non-toxicity, as well as storage and handling safety. Moreover, ethanol can be generated in a renewable manner through biomass (energy crops, agricultural and industrial wastes, forestry residues, and the organic fraction of municipal solid waste) fermentation [5–7]. The employment of bio-fuels in hydrogen production incorporates important environmental advantages, since the generated CO₂ can be recycled through photosynthesis during plant growth, resulting in a carbon neutral process.

Hydrogen production by reforming processes is usually achieved either by steam or auto-thermal reforming. Compared to auto-thermal reforming, ethanol steam reforming (ESR) has received more focus due to the higher H_2 yields obtained through this route [8–12]:

Furthermore, the water gas shift (WGS) reaction, taking place at excess H_2O conditions, can further increase the H_2 yield:

Nevertheless, the overall reforming process consists of a complex network of reactions, such as ethanol dehydrogenation, dehydration, or decomposition, which can lead to the formation of several byproducts (methane, ethylene, acetaldehyde, acetone, coke, *etc.*) [10,13].

Furthermore, technological advances in the direct utilization of bio-fuels, like bio-ethanol, in Solid Oxide Fuel cells (SOFCs) have stimulated the research toward the development of high efficiency fuel processing electro-catalysts with adequate activity and durability. Under these perspectives, several catalytic systems, involving mainly base (e.g., Ni, Co, Cu) and precious (e.g., Pt, Rh, Ru, Pd, and Ir) metal supported catalysts have been reported for ESR [10,12]. Although the noble metal-based catalysts demonstrate sufficient reforming activity in a wide temperature range [10,12,14–19], their large-scale implementation in practice is limited by their significant high cost [20]. Hence, the development of active and stable non-precious metal catalysts for ESR is highly desirable. Ni-based catalysts are the most commonly employed catalytic systems, due to their inherent activity on C-C and C-H bond cleavage [21]. However, their insufficient tolerance to carbon deposition in conjunction with the sintering of Ni particles at elevated temperatures, have been considered the main barriers for industrial application [22]. Recent studies, however, have shown that highly active and stable Ni-based catalysts can be obtained by appropriately adjusting their physicochemical properties by means of advanced synthesis procedures and/or structural/surface promotion (e.g., [23,24]). Strong Ni-ceria interactions can be accounted for the enhanced ESR activity [25–27].

Regarding the catalyst support, it should generally possess adequate chemical and mechanical properties to provide the required activity and stability under reaction conditions. Most importantly, supporting carriers should provide strong metal-support interactions and high oxygen mobility (redox properties), preserving the active phase from sintering and coking deactivation. Ceria has been widely employed in several catalytic reactions, involving the WGS reaction [28], NOx reduction [29,30], oxidation or partial oxidation of hydrocarbons [31], steam reforming [32], etc., owing to its excellent redox properties. The mobile oxygen related to the ceria lattice, is considered to be responsible for the oxidation of deposited carbonaceous fragments, thus protecting the catalyst surface from poisoning [33–36]. In addition, mobile oxygen can activate water, with regard to the formation of hydroxyl groups, resulting in higher ESR efficiency [25,33]. In a comprehensive study by Xu et al. [25], utilizing both in situ and ex situ characterization techniques it was revealed that metallic Ni and Ce(III) entities were the active components under ESR conditions. Ce(III) facilitates the decomposition of H₂O to –OH groups, which are essential for the transformation of C_xH_yO_z intermediates to CO₂ and H₂O, whereas Ni promotes the adsorption of ethanol and dissociation of C-C bonds. Moreover, strong Ni-ceria interactions perturb the electronic and chemical properties of Ni ad-atoms, resulting in an inferior ability of Ni with regard to CO methanation [26,27].

Besides Ni-based catalysts, various transition metals have been also tested for ESR, with Co-based catalysts being among the most efficient [34–46]. In particular, Co/Mg/Al hydrotalcites are very active and stable for ESR, due to the formation of

highly reactive Co²⁺ species instead of less active metallic cobalt [42–44]. Moreover, Co/CeO₂ catalysts demonstrated excellent ESR activity, ascribed mainly to the high oxygen storage capacity (OSC) of ceria, which suppresses the carbon deposition (e.g., [35,36,41]). In this regard, very active Co-based catalysts can be designed by properly adjusting the local surface structure of Co species by means of support and/or active phase modification [35–46]. For instance, it was found that the addition of Rh as a promoter at small amounts (0.1 wt.%) on 2.0 wt.% Co/CeO₂ catalysts can notably increase the ESR performance [45,46]. Rhodium, through hydrogen spillover phenomena, facilitates the reduction of both cobalt oxides and ceria, which then is reflected on steam reforming performance. The presence of Rh in Co/Ceria catalysts hinders the formation of acetone as well as the build-up of strongly bonded carbide species, leading to improved activity and stability [45,46].

In the light of the above aspects, the present manuscript aims to comparatively explore ESR performance over different CeO₂-supported transition metal (Ni, Fe, Cu, Co) catalysts. The effect of several operation parameters, related to reaction temperature (400–800 °C), time on stream (24 h), S/C feed ratio (0.5, 1.5, 3, 6), and metal loading (15–30 wt.%) on the activity and stability performance is systematically examined. Furthermore, an extensive characterization study—N₂ adsorption-desorption (BET), X-ray diffraction (XRD), Scanning Electron Microscopy (SEM/EDX), X-ray Photoelectron Spectroscopy (XPS), and Temperature Programmed Reduction (H₂-TPR)—was carried out to attain a possible structure-activity relationship. Although recent efforts on ESR are focusing to develop efficient catalysts with low metal contents (e.g., [45,46]), relatively high metal loadings (15–30 wt.%) are employed in the present study, motivated by the potential application of these materials as anodic electrodes in internal reforming ethanol fed SOFCs.

2. Results

2.1. Characterization Studies

2.1.1. Textural Characterization (BET Analysis)

Table 1 presents the textural characteristics (surface area, pore volume, pore diameter) of as prepared catalysts. It is obvious that the addition of transition metals to the ceria carrier has a detrimental effect on the resulted BET area, which, in general, is exacerbated upon increasing the metal content. However, the decrease of BET area upon increasing the cobalt content is not monotonic. The latter can be attributed to the different crystallite size of Co_3O_4 and CeO_2 phases in Co/CeO_2 catalysts, as determined by XRD analysis presented in the sequence. The size of Co_3O_4 is about 3-fold higher than CeO_2 indicating the segregation of cobalt species over the catalyst surface (Table 2). Thus, a significant decrease of bare ceria area (71.5 m²/g) is expected upon increasing Co loading, due to the blockage of ceria pores. However,

this decrease could not be monotonic, since above a certain Co content the formation of large Co_3O_4 particles hampers the dispersion of Co_3O_4 entities into CeO_2 pores and consequently any further decrease of BET area. The same trend was observed upon increasing Cu content in Cu/CeO_2 catalysts [47].

Regarding the M/CeO₂ catalysts with a constant metal loading (20 wt.%), Niand Fe-based catalysts possess the higher BET area (\sim 57 m²/g), while the Cu- and Co-based samples exhibited lower values of surface area, *i.e.*, 44.6 and 33.4 m²/g, respectively. These variations in the textural characteristics could be related with the different crystallite size of the metal oxides formed in each case, as is discussed later.

2.1.2. Structural Characterization (XRD Analysis)




Figure 1. X-ray powder diffraction patterns of 20 wt.% M/CeO_2 catalysts (**A**) where M stands for Fe (a), Co (b), Ni (c) and Cu (d), and of Co/CeO_2 catalysts (**B**) with 15 (a), 20 (b), 25 (c) and 30 wt.% (d) Co loading.

Figure 1A depicts the XRD spectra of M/CeO₂ catalysts, whereas Figure 1B presents the corresponding spectra of Co-based catalysts of different metal loading. Table 2 lists the phases that were detected for each sample, the corresponding structure, and approximate crystallite size as determined by Scherrer analysis. All metals crystallized in the form of oxides, *i.e.*, iron as Fe₂O₃, cobalt as Co₃O₄, nickel as NiO, and copper as CuO, with their average particle size following the order: CuO > Co₃O₄ > Fe₂O₃ > NiO (Table 2). Regarding CeO₂ crystallites their size increases with the decrease of the corresponding size of the metal oxide phase. Concerning the Co-based catalysts of different metal content, cobalt is again presented in the form of oxide (Co₃O₄), regardless of the Co loading. The crystallite size of CeO₂ remains almost constant upon increasing the Co content. Additionally, the size of Co₃O₄ phase is increased from 30.8 to 37.7 nm with the increment of Co content from 15 to 20 wt.%. However, no further increase was observed for higher Co loadings, confirming the stabilization of BET area values above a certain Co loading.

2.1.3. Reducibility Studies (H₂-TPR)




Figure 2. Temperature programmed reduction profiles of 20 wt.% Fe (a), Co (b), Ni (c) and Cu (d) catalysts supported on CeO₂.

Temperature-programmed reduction (TPR) experiments were performed to gain insight into the role of metal entity on the reducibility of M/CeO $_2$ catalysts. Figure 2 depicts the TPR profiles of M/CeO $_2$ catalysts, in terms of hydrogen consumption as a function of temperature.

In the Cu/CeO₂ sample the overlapping peaks at 100–300 $^{\circ}$ C temperature interval are assigned to Cu oxide species reduction along with the surface oxygen reduction [48–52]. Specifically, the peak at 133 $^{\circ}$ C is attributed to the reduction of Cu ions in close proximity to CeO₂, while, the features at 215 $^{\circ}$ C and 267 $^{\circ}$ C are assigned to Cu entities not closely associated with ceria [52].

In the Co/CeO₂ sample no obvious peaks were detected at temperatures lower than 300 $^{\circ}$ C, denoting that Co species, in contrast to Cu, are more difficult to reduce. The Co/CeO₂ reduction profile was comprised of several overlapping features in the *ca.* 300–400 $^{\circ}$ C temperature range. These peaks are related to the reduction of surface oxygen groups along with the stepwise reduction of Co oxides to metallic cobalt [53].

Ni/CeO $_2$ catalysts mainly exhibit two reduction peaks at 231 and 330 °C. The peak at 231 °C is attributed to adsorbed surface oxygen reduction, while the peak at 330 °C to the reduction of the bulk NiO and surface CeO $_2$ [54–57].

Concerning the reduction profile of Fe/CeO₂ sample, it has been widely recognized that hematite (Fe₂O₃) reduction to metallic iron (Fe⁰) takes place through the formation of magnetite (Fe₃O₄) and wustite (FeO). Wustite is metastable and

disproportionates into magnetite and metallic iron (4FeO \rightarrow Fe₃O₄ + Fe) below 620 °C [58]. Commonly, bare iron oxide shows overlapping features at *ca.* 300–800 °C, corresponding to the stepwise reduction of hematite to metallic iron [58–60]. The Fe/CeO₂ sample exhibits in addition a main peak at 296 °C, which can be attributed to surface oxygen reduction as well as to the facilitation of the stepwise reduction of Fe oxides to metallic iron. Based on the main hydrogen TPR peaks, the following order of reducibility was recorded: Cu/CeO₂ > Fe/CeO₂ > Ni/CeO₂ > Co/CeO₂.

2.1.4. Surface Characterization (XPS Analysis)




Figure 3. Cont.

XPS measurements were carried out next to obtain insights into the elemental oxidation states and surface composition. Figure 3 depicts the XPS spectra in the 2p region of Fe, Co, Ni, and Cu catalysts supported on ceria. In the case of the Fe/CeO₂ sample, peaks in the region of 709–713 eV with satellites at *ca.* 725 eV appear. Curve-fitting revealed the contribution of Fe²⁺ and Fe³⁺ ions at 709–711 eV and 711–713 eV, respectively [61,62]. The presence of a certain amount of Fe²⁺ ions probably implies the co-existence of Fe₂O₃ (as indicated by XRD) with lower valence iron oxides (FeO/Fe₃O₄). The Co 2p spectrum of Co/CeO₂ catalyst is characterized by a main peak at 780.6 eV accompanied by a low intensity satellite and a spin-orbit doublet Co2p_{1/2}-Co2p_{3/2} of 15.2 eV. These characteristics point to the formation of Co³⁺ species in Co₃O₄-like phase [54]. The Ni2p_{3/2} can be analyzed into two components corresponding to different Ni chemical states. The peak at *ca.* 854 eV is usually assigned to NiO, whereas the higher BE peak at 855–856 eV to Ni bonded with OH groups, *i.e.*, Ni(OH)₂ and/or NiOOH [63,64]. It should be noted, however, the

difficulty of unambiguously assigning the different chemical states of Ni oxides due to the complexity of Ni 2p spectra arising from multiplet splitting, shake-up satellites, and plasmon loss structures [65]. In any case the majority of Ni species seems to be related with NiO in accordance with the XRD findings. The spectrum of the Cu/CeO₂ sample is characterized by a Cu $2p_{3/2}$ band at 933.8 eV and shake-up satellites at *ca.* 944.0 eV, typical characteristics of Cu²⁺ species in CuO-like phase [20,48,66–70]. The above assignments are in line with the XRD findings, which revealed the formation of the corresponding metal oxides in M/CeO₂ samples (Table 2).

Figure 4 depicts the O1s spectra of M/CeO₂ samples. Curve-fitting, based on a mixture of Lorentzian and Gaussian curves, revealed three components. The low binding energy peak (O_I) at ~529 eV can be ascribed to lattice oxygen, the intermediate peak (O_{II}) at ~531 eV to surface O, OH groups and oxygen vacancies and the high energy band (O_{III}) at ~534 eV to adsorbed water [68,71,72]. In the case of Ni/CeO₂ the low BE peak at *ca.* 527 eV could be due to the differential charging of the oxide. Based on the area of O_I, O_{II} and O_{III} envelopes, a relative comparison between the M/CeO₂ samples could be obtained (Table 3). It is evident that the ratio between the lattice oxygen to the sum of surface oxygen species notably changes with the metal type. Co/CeO₂ catalysts possess the highest amount of O_I species (70%), which are related to lattice oxygen in ceria and cobalt oxides. These differences in the population of surface oxygen species are expected to affect the redox reactions between the gaseous reactants and solid carbonaceous deposits with lattice oxygen ions, as is discussed in the sequence.




Figure 3. Core level 2p spectra of 20 wt.% Fe (**a**); Co (**b**); Ni (**c**) and Cu (**d**) catalysts supported on CeO₂.

The surface composition of M/CeO₂ samples obtained by XPS analysis, along with the bulk atomic concentrations (at. %), is presented in Table 4. Comparison of the XPS and nominal values of transition metal (Fe, Co, Ni, Cu) atomic concentrations reveals a decrease in metal surface species for all samples. These findings can be understood to a good extent considering surface characterization studies over Co-Ce binary oxides [53], where it was demonstrated the impoverishment of catalyst surface in Co species during the calcination procedure. The latter has been mainly attributed to the low surface energy of cobalt compared to ceria, resulted in a localization of ceria on the outer surface. In a similar manner, it has been revealed that the surface concentration of metal ions (such as Ni and Co) supported on ceria-based materials can be notably decreased due to the incorporation of metal ions into the support lattice [73–75]. This particular configuration, involving the coexistence of metal ions in the outer surface and inside the support structure, could largely favor the oxygen mobility, with large consequences in the catalytic activity (e.g., [75]).




Figure 4. Cont.




Figure 4. O1s spectra of Fe (a); Co (b); Ni (c) and Cu (d) catalysts supported on CeO₂.

2.2. Catalytic Activity Studies

2.2.1. Effect of Metal Entity on Steam Reforming Performance




Figure 5. Schematic representation of the reaction network in the ethanol steam reforming (ESR) process.

Ethanol Steam Reforming (ESR) is a multi-molecular reaction involving several pathways producing hydrogen, CO, CO₂ and numerous by-products, such as methane, ethylene, acetaldehyde, acetone, coke, *etc.* [76]. The simplified reaction network, presented in Figure 5, can be considered for the different product distribution during ESR [77,78]. This mainly involves apart from the ESR (Equation (1)) and water gas shift (Equation (2)) reactions, the ethanol decomposition (Equation (3)), ethanol dehydrogenation (Equation (4)), acetaldehyde decarbonylation (Equation (5)), acetone formation via acetaldehyde condensation, followed by decarboxylation (Equation (6)),

ethanol dehydration (Equation (7)), methanation (Equation (8)), and carbon deposition (Equation (9)) reactions:




Figure 6. Cont.

Figure 6 depicts the effect of temperature ($400-800\,^{\circ}$ C) on ethanol conversion and product selectivity during the ESR over M/CeO₂ catalysts, at a constant S/C feed ratio of 3. The reforming process resulted mainly to H₂, CO, CO₂, and CH₄.

Minor quantities of C₂H₄, C₂H₆, and traces of CH₃CHO and CH₃COCH₃ are also observed. The H₂ selectivity follows, in general, a downward shift with increasing temperature, in contrast to CO selectivity. The particular high hydrogen selectivities at lower temperatures (400–500 °C) in the case of Fe-, Co- and Cu-based samples, which exceed the expected theoretical values from reaction stoichiometry, maybe due to the thermal decomposition and/or parallel reactions taking place at low temperatures. The latter keeps in step with the extended carbon formation at low temperatures, as will be discussed in the sequence. The selectivity towards CO₂ and CH₄ decreases up to 600 °C and then gradually level-off until 800 °C. The variation of H₂, CO, CO₂, and CH₄ selectivity upon increasing temperature can be realized by taking into account the different reactions involved in ESR (Figure 5). At low temperatures the WGS reaction (Equation (2)) is favored, increasing the selectivity towards H₂ and CO₂. In contrast, at high temperatures the reverse WGS reaction enhances the production of CO and H_2O at the expense of H_2 and CO_2 . The decrease of CH₄ formation at higher temperatures may be ascribed to its reforming to CO and H₂ [32].

The impact of catalyst type (Fe, Co, Ni, Cu) and temperature on product distribution is more evident in Figure 7, which comparatively depicts the major product yield at 400, 600 and 800 °C. For comparison purposes the corresponding results over bare CeO₂ are also depicted. The superior performance of M/CeO₂ catalysts compared to bare CeO₂ is clearly shown. The latter implies the pronounced effect of transition metal and/or metal-support interfacial sites on ethanol steam reforming, as discussed in the sequence. At 400 °C the best performance, in terms of H₂ yield, is achieved by Co- and Cu-based catalysts both exhibiting a H₂ yield of ~66%. Fe- and Ni-based catalysts demonstrated lower H2 yields of 59% and 48%, respectively. Ni/CeO₂ catalysts display very high CH₄ yield (24%), compared to all other M/CeO₂ catalysts (~0.4%). This can be attributed to the acetaldehyde decarbonylation to CH₄ (Equation (5)) over Ni sites at low temperatures [77,79–83]. At 600 °C, the Co-, Ni-, and Cu-based catalysts demonstrated a similar H₂ yield of ~62%, with Fe/CeO₂ catalyst exhibiting a slightly better yield (~67%). It is worth mentioning that at 600 °C CO formation is in general favored at the expense of CO₂, probably implying participation of the reverse WGS reaction on the ESR reaction network (Figure 5). At 800 °C the Co- and Ni-based catalysts showed H₂ yields of 65% and 62%, respectively, followed by a CO yield of 35% and 38%. Therefore, in these catalysts, the ESR reaction leads almost exclusively to H2 and CO. In contrast, the Feand Cu-based catalysts as well as the bare CeO₂ exhibited significantly lower syngas yields and higher amounts of CH₄, implying an inferior reforming performance at high reaction temperatures.




Figure 6. Effect of temperature on product selectivity and C_2H_5OH conversion over M/CeO₂ catalysts. Reaction conditions: S/C = 3, $m_{cat} = 250$ mg, $F_T = 150$ cm³/min.

2.2.2. Effect of Metal Loading

Figure 8 depicts the effect of Co loading on the main products yield at 400, 600, and 800 $^{\circ}$ C. It is evident that in the absence of metal (bare CeO₂), the yields toward the reformate products (CO and H₂) are much lower compared to the corresponding ones over Co/CeO₂ catalysts. At 400 $^{\circ}$ C the optimum H₂ yield

 $(\sim66\%)$ is obtained for 20 wt.% metal loading, whereas at higher temperatures both the absolute products yields and product distribution are almost independent of the metal loading (0-30 wt.%).




Figure 7. Effect of metal type on major product yield at 400 °C (**A**); 600 °C (**B**) and 800 °C (**C**). Reaction conditions: S/C = 3, $m_{cat} = 250$ mg, $F_T = 150$ cm³/min.




Figure 8. Effect of Co loading in Co/CeO₂ catalysts on products yield at 400 $^{\circ}$ C (**A**); 600 $^{\circ}$ C (**B**) and 800 $^{\circ}$ C (**C**). Reaction conditions: S/C = 3, m_{cat} = 250 mg, F_T = 150 cm³/min.

2.2.3. Effect of S/C Ratio




Figure 9. Cont.

Figure 9 presents the effect of S/C (0.5, 1.5, 3, 6) feed ratio on the major product yield achieved over the 20 wt.% Co/CeO_2 catalyst. At low temperatures, *i.e.*,

at 400 °C, the optimum performance is obtained for S/C reactants ratio of 3 (~66%), whereas for temperatures higher than 400 °C the H_2 yield is maximized for a S/C feed ratio of 6. At 800 °C the yield toward H_2 is equal to 77% for a S/C ratio of 6, as compared to approximately 63% for lower S/C ratios. However, it is worth noticing, that for a S/C ratio of 3 the largest fuel production was experienced, *i.e.*, sum of H_2 and CO, as the yield with regard to CO_2 and hydrocarbons is essentially negligible. Therefore, the S/C ratio equal to 3 can be regarded as optimal, in terms of ethanol energy exploitation.




Figure 9. Effect of $H_2O/Carbon$ (S/C) feed molar ratio on product yield at $400 \, ^{\circ}C$ (**A**); $600 \, ^{\circ}C$ (**B**) and $800 \, ^{\circ}C$ (**C**) over 20 wt.% Co/CeO_2 catalyst. Reaction conditions: $m_{cat} = 250 \, mg$, $F_T = 150 \, cm^3/min$.

2.2.4. Stability Experiments




Figure 10. Stability performance of M/CeO₂ catalysts (M: Fe, Co, Ni, Cu) at 400 °C (**A**); 600 °C (**B**) and 800 °C (**C**) during ESR. Reaction conditions: S/C=3, m_{cat} = 250 mg, F_T = 150 cm³/min.

Short-term (24 h) stability experiments were then carried out over Co-, Ni-, Fe- and Cu-CeO₂ catalysts to assess the catalyst life time characteristics. Stability experiments were performed at low (400 $^{\circ}$ C), intermediate (600 $^{\circ}$ C) and high (800 $^{\circ}$ C) temperatures to reveal the effect of temperature on stability performance. Figure 10 depicts the H₂ production rate at 400 $^{\circ}$ C (A), 600 $^{\circ}$ C (B) and 800 $^{\circ}$ C (C) *versus* time on stream (TOS) at a steam-to-carbon (S/C) ratio equal to 3. In these experiments the catalyst was first exposed to pure He up to the desired temperature, and then the standard feed mixture was introduced into the reactor.

The superiority of Co/CeO₂ catalysts in terms of H_2 production and stability is obvious. Co-based catalysts demonstrated an excellent stability performance at 600 and 800 °C whereas a slight degradation was observed at 400 °C. At low temperatures (400 °C) the formation rate of hydrogen was gradually decreased over Ni/CeO₂ catalysts during the first 13 h, remaining then stable. A more rapid deactivation was obtained with Cu- and Fe-based catalysts, which were totally deactivated after about 12 and 4 h, respectively. A similar picture was recorded at intermediate temperatures (Figure 10B), although in this case the deactivation was milder. Ni/CeO₂ catalysts were stable in the first 14 h, declined then steadily. Cu- and Fe-based catalysts followed a downgrade trend in the first 10 h, stabilized then at very low levels. In contrast, at high temperatures, *i.e.*, 800 °C (Figure 10C), all catalysts demonstrated an adequate stability performance throughout the period of 24 h.

3. Discussion

The present findings clearly demonstrated the superior steam reforming performance of Co/CeO_2 catalysts, in terms of H_2 production and stability, in the examined temperature range of 400– $800\,^{\circ}C$. In contrast all other catalysts (Fe-, Ni-, Cu-CeO₂) exhibited satisfactory stability only at high temperatures ($800\,^{\circ}C$), whereas at low and intermediate temperatures a gradual deactivation was observed, being more intense for Cu- and Fe-based catalysts. The optimum performance of high metal loading Co-based catalysts, compared to conventional Ni-based catalyst, should be also emphasized. The latter is of major importance with regard to the direct utilization of ethanol in SOFCs, where highly active, conductive and robust electro-catalysts are required [84].

To better understand the influence of temperature and catalyst nature on stability performance indicative morphological studies (SEM/EDS) were carried out over the fast deactivated Cu/CeO₂ catalysts and very stable Co/CeO₂ catalysts (not shown for brevity's sake). In general, a significant amount of carbon was detected over Cu/CeO₂ exposed for 24 h to reaction conditions at 400 °C, which, however, decreased at 600 °C and was almost eliminated at 800 °C. To be specific, a small amount of deposited carbon, mostly in the form of carbon fibers, was identified at elevated temperatures. Moreover, no significant changes in the particle size were recorded upon temperature increase.

Given that the Cu/CeO₂ catalyst maintains its activity at 800 °C (Figure 10C) it could be argued that neither catalyst particle sintering nor the formation of carbon fibers could affect the catalysts' stability at high temperatures. In this regard, it has been shown that filamentous carbon does not directly lead to the poisoning of CeO₂-based catalysts in ESR, although it delaminates metal particles from the support; amorphous carbon tends to block active sites leading to deactivation [85]. Therefore, the deactivation of Cu/CeO₂ catalysts at low (400 °C), and to a lesser extent at intermediate (600 °C) temperatures, can be mainly ascribed to amorphous carbon deposition. The improved stability performance at 600 °C, compared to 400 °C, can be attributed to the facile gasification of carbonaceous deposits at elevated temperatures [85–87].

Similar conclusions, in relation to the impact of reaction temperature on the carbon deposition and particle size of Co/CeO₂ catalysts were obtained by means of SEM/EDS analysis. The particle size remained practically unaffected by temperature increase to 600 °C, whereas it was slightly increased after reaction at 800 °C. Amorphous carbon was revealed by EDS analysis and elemental mapping for spent Co/CeO₂ at 400 °C, although at a relatively lesser amount compared to Cu/CeO₂. Carbon was also identified at 600 °C, but at a significantly lower amount to that observed at 400 °C. At higher temperature of 800 °C the carbon was almost absent.

In the light of the above results, it could be stated that Co/CeO_2 catalyst displayed the optimum reforming performance in terms of H_2 yield and life-time stability. In contrast, an inferior performance was obtained over Ni-, Cu- and Fe-based catalysts. In a similar manner, it was found that neither Cu nor Ni supported on ZnO catalysts were stable in ESR conditions [24]. On Cu/ZnO the dehydrogenation of ethanol into acetaldehyde was favored, whereas on Ni/ZnO the decomposition of ethanol to CH_4 and CO_x took place.

The present findings can be mainly interpreted by taking into account the surface and redox properties of transition metal-based catalysts. TPR studies revealed the lower reducibility of Co/CeO_2 catalyst amongst the investigated samples. The latter, could be possibly related to the strong metal-support interactions, maintaining the Co species in an oxidized state ($\text{Co}^{\delta+}$ species). This factor could be considered responsible for the adequate ESR performance of Co/CeO_2 catalysts, in agreement with relevant literature studies [42–44,88–91].

On the other hand, although Cu-based materials are highly reducible under mild conditions, they are almost inactive toward reforming reactions, leading mainly to ethanol dehydrogenation. In this regard, it has been reported that the over-reduction of CeO_2 -based materials under H_2 -rich environments, can lead to the blockage of the redox mechanism involved in ESR and the carbon gasification reaction network [92–94].

In addition, the high concentration of lattice oxygen in Co/CeO_2 , as compared to Fe-, Cu- and Ni-CeO₂ catalysts, can be further considered for their superior ESR performance. To this end, the key role of oxygen availability in both H₂ yield and stability of Co-based catalysts has been revealed [36]; the gas-solid interactions between the adsorbed hydrocarbon species (C_nH_m) and the surface oxygen groups (O_x) can facilitate hydrocarbon species gasification instead of their decomposition to carbon.

The inhibition of carbon deposition by gas-solid interactions between hydrocarbons and lattice oxygen has been already demonstrated in several catalytic systems [95–98]. In this regard, isotopic tracer and nuclear reaction analysis (NRA) clearly suggested that methane is selectively oxidized by lattice oxygen ions to produce carbon monoxide during the catalytic partial oxidation (CPOX) of methane to synthesis gas on Rh/Ce $_{0.56}$ Zr $_{0.44}$ O $_{2-x}$ catalysts [97].

Based on the above aspects it can be stated that the intrinsic reactivity of Co entities, along with the strong metal-support interactions in Co/CeO_2 composites, maybe accounted for the high oxidation degree of cobalt entities, as well as for their lower reducibility under reaction conditions. Furthermore, the high concentration of lattice oxygen in the Co/CeO_2 catalyst can be further regarded for the inhibition of carbon deposition through the gas-solid interactions between the adsorbed hydrocarbon species and the lattice oxygen. These factors could be considered

equally crucial for the transformation of the deposited carbonaceous species into gaseous products during the stream reforming process.

The present results are in agreement with those obtained over Cu- and Co-based catalysts during ethanol [90] or iso-octane [48,93] steam reforming. Highly reducible Cu-based catalysts are almost inactive for ESR, leading mainly to ethanol dehydrogenation [90]. In contrast, Co/SiO₂ catalysts demonstrated superior reforming performance, despite their limited reducibility at low temperatures due to the strong metal-support interactions [90]. Along the same lines, it has been demonstrated that the oxygen storage capacity of the support can greatly affect the reforming performance of Co-based catalysts by promoting the gasification of carbon deposits [88,91]. To this end, the superior ESR performance of Co/CeO₂ catalysts as compared to ZrO₂- or Al₂O₃-based samples has been ascribed to the abundance of redox sites on the catalyst surface [36,40,41]. More specifically, it has been clearly revealed by means of steady-state reaction experiments coupled with post-reaction characterization techniques that the high oxygen mobility in Co/CeO₂ samples—linked with the high oxygen storage capacity (OSC) of ceria—not only suppresses the carbon deposition, but also allows delivery of oxygen to ethoxy species, thus promoting the complete oxidation of carbon to CO₂ [36].

In the light of the above analysis, it is evident that in order to fully understand the complex and dynamic ESR mechanism of ceria-based transition metal catalysts, it is essential to know the local surface structure and chemistry of active entities under real "working" conditions. This requires the combination of advanced *ex situ* characterization studies with *in situ* operando measurements. In this regard, the key role of metal-ceria interactions on the ESR performance, has been verified by combining *in situ* and *ex situ* characterization techniques [25,41].

4. Materials and Methods

4.1. *Materials Synthesis*

A series of CeO₂ supported transition metal catalysts (Fe, Co, Ni, Cu) were synthesized using the incipient wet impregnation method. Initially, the bare CeO₂ was prepared by diluting CeO₂ precursor salt (Ce(NO₃)₃· 6H₂O, Sigma Aldrich, Taufkirchen, Germany) in double distilled water. The whole contents were heated and stirred until the evaporation of water. The resulted sample was dried at 100 °C for 16 h and then calcined at 600 °C for 2 h (heating rate: 5 °C/min). The ceria-based catalysts were then prepared via the impregnation of calcined ceria in an aqueous metal (Fe, Co, Ni, Cu) solution, employing the corresponding nitrate salts (Sigma Aldrich, Taufkirchen, Germany) as precursors, at the appropriate concentration so as to yield 20 wt.% metal loading. To explore the impact of metal loading a series of cobalt-based catalysts with metal contents of 15, 20, 25 and 30 wt.% were also

prepared following the same synthesis route. The resulted solutions were heated at first under stirring, then dried overnight at 120 $^{\circ}$ C and calcined at 600 $^{\circ}$ C for 2 h.

4.2. Characterization Studies

4.2.1. Textural Characterization (BET)

The textural characteristics of as prepared composites were determined by $\rm N_2$ adsorption/desorption isotherms at 77 K, employing the multipoint BET analysis in a Tristar Micromeritics 3000 flow apparatus. BET area was measured according to the Brunauer-Emmett-Teller (BET) method at the relative pressure in the range of 0.005–0.99. The total pore volume was estimated by the nitrogen volume at the highest relative pressure. The Barret-Joyner-Halenda (BJH) method was employed to obtain the average pore diameter. Prior to measurements the catalysts were degassed at 250 $^{\circ}$ C for 16 h.

4.2.2. Structural Characterization

The crystalline structure was determined using the X-ray powder diffraction (XRD) method. A Siemens D 500 diffractometer was employed for the XRD measurements with a Cu K α radiation (λ = 0.154 nm) operated at 40 kV and 30 mA. Diffractograms were collected in the 2θ = 10° – 80° range at a scanning rate of 0.04° over 2 s. The DIFFRAC plus Basic data evaluation software was employed to identify the diffraction peaks and through the Scherrer equation to calculate the crystallite sizes of the detected phases within an experimental error of 10%.

4.2.3. Morphological Characterization

The morphology of fresh and spent catalysts was investigated by scanning electron microscopy (SEM) using a JEOL 6300 microscope, coupled with EDX (Oxford Link ISIS-2000) for the determination of local elemental composition.

4.2.4. Redox Characterization (H₂-TPR)

TPR studies were elaborated in a flow system assembled with a quadrupole mass spectrometer (Omnistar, Balzers). The TPR tests were carried out in a quartz micro-reactor loaded with ca. 100 mg of catalyst. Typically, ~100 mg of the material is placed in the reactor and heated to 1000 °C with a heating rate of 10 °C/min under 5% H₂/He flow (50 cm³/min). All samples were heated at 600 °C for 1 h under 5% O₂/He flow and then cooled down to room temperature, prior to the TPR measurements.

4.2.5. Surface Characterization (XPS)

The photoemission experiments were performed in an ultrahigh vacuum system (UHV), comprised of a fast entry specimen assembly, a sample preparation chamber and an analysis chamber. The base pressure in both chambers was kept at 1×10^{-9} mbar. Non-monochromatized Al K_{α} line at 1486.6 eV and an analyzer pass energy of 97 eV, giving a full width at half maximum (FWHM) of 1.7 eV for the Au $4f_{7/2}$ peak, were employed in all XPS studies. The XPS core level spectra were analyzed using a fitting routine, which can decompose each spectrum into individual mixed Gaussian-Lorentzian peaks after a Shirley background subtraction. The calibration of the analyzer's kinetic energy scale was accomplished according to ASTM-E 902–88. The binding energy (BE) scale was calibrated by attributing the main C1s peak at 284.8 (adventitious carbon) eV. The powdered samples were pressed into pellets with a thickness of 1 mm and 1 cm diameter before being introduced into the ultrahigh vacuum system.

4.3. Catalytic Activity Measurements

The apparatus used to perform the ESR experiments has been already described in our previous relevant studies regarding the iso-octane steam reforming over Cu supported on rare earth oxides catalysts [48,93]. In brief, it is comprised of: (i) a liquid reactants feed unit equipped with He mass flow controllers and the gas-liquid saturator units; (ii) a fixed bed U-shaped quartz tubular reactor (9.6 mm, i.d.) loaded with 250 mg catalyst admixed with an equal amount of quartz particles and (iii) a gas analysis system.

A mixture of ethanol and water vapors of different steam-to-carbon (S/C) molar ratios was introduced into the reactor by bubbling He (99.999% purity, Air Liquid) through two separate vessels containing liquid C_2H_5OH (99.5% purity, Riedel-de Haen) and twice distilled water. The S/C feed ratio was adjusted by controlling the temperature and He-bubbled flow in the H_2O and ethanol saturators (based on their corresponding vapor pressures). The inlet volumetric flow rate was held constant at 150 cm³/min, corresponding to a weight/flow (W/F) and Gas Hourly Space Velocity (GHSV) of 0.1 g.s/cm³ and 21,000 h⁻¹ (based on a catalyst bed volume of about 0.45 cm³), respectively. The feed concentration used during the activity and stability experiments is: $P_{EtOH} = 2$ kPa, $P_{H2O} = 2$, 6, 12, 24 kPa, corresponding to a S/C feed ratio of 0.5, 1.5, 3, 6, respectively. Short-term durability experiments were performed by continuously monitoring the product rate as a function of time-on-stream (TOS, 24 h) at three different temperatures, *i.e.*, 400, 600, and 800 °C.

An on-line gas chromatograph (HP 6890), equipped with thermal conductivity and flame ionization detectors, was employed to qualitatively and quantitatively analyze reactants and products. The separation of H_2 , CH_4 , and CO was achieved with a Molecular Sieve 5A column (10 ft \times 1/8 in), whereas CO_2 , H_2O , C_2H_4 ,

 C_2H_6 , C_2H_5OH , CH_3CHO and CH_3COCH_3 were separated in a Poraplot Q column (10 ft \times 1/8 in) in a series bypass configuration.

The equations used to calculate the ethanol conversion (X_{EtOH}) , product selectivity (S_i) , and yield (Y_i) , have as follows:

where [EtOH] denotes the ethanol concentration and r_i the formation rate of product i (mol/s) considering the following produced chemical species: H_2 , CO, CO₂, CH₄, C_2H_4 , C_2H_6 , CH₃CHO, CH₃COCH₃.

The formation rate of product i, r_i , is calculated on the basis of its % v/v concentration in the reactor outlet, according to the equation:

where F_T , is the total flow rate and v_m , is the gas molar volume at STP conditions (298 K and 1 bar).

5. Conclusions

In the present work, the steam reforming of ethanol over transition metal catalysts (Fe, Co, Ni, Cu) supported on CeO₂ was examined. Various parameters, concerning the effect of operation temperature, steam-to-carbon ratio, and metal loading on the catalytic activity and stability were explored. The optimal catalytic performance was observed for the 20 wt.% Co/CeO₂ catalyst, which offers H₂ yields up to 66% at a steam-to-carbon feed ratio of 3. Stability experiments demonstrated the excellent stability of Co/CeO₂ catalysts in the temperature range of 400–800 °C. An inferior stability performance, particularly at low temperatures, was observed for all the other tested catalysts, following the order: Co >Ni >Cu >Fe. The excellent stability of Co/CeO₂ catalysts can be mainly assigned to the strong metal-support interactions which in turn leads to an increased population of surface oxygen species, related to lattice oxygen in ceria and cobalt oxides. This factor is thought to be responsible for the facile gasification of the adsorbed species, thus preventing catalyst deactivation. The enhanced performance of Co-based catalysts, compared to a conventional Ni-based catalyst, is of major importance towards the direct

utilization of ethanol in SOFCs, where highly active and robust electro-catalysts need to be developed.

Ni Catalysts Supported on Modified Alumina for Diesel Steam Reforming

Abstract: Nickel catalysts are the most popular for steam reforming, however, they have a number of drawbacks, such as high propensity toward coke formation and intolerance to sulfur. In an effort to improve their behavior, a series of Ni-catalysts supported on pure and La-, Ba-, (La+Ba)- and Ce-doped γ-alumina has been prepared. The doped supports and the catalysts have been extensively characterized. The catalysts performance was evaluated for steam reforming of *n*-hexadecane pure or doped with dibenzothiophene as surrogate for sulphur-free or commercial diesel, respectively. The undoped catalyst lost its activity after 1.5 h on stream. Doping of the support with La improved the initial catalyst activity. However, this catalyst was completely deactivated after 2 h on stream. Doping with Ba or La+Ba improved the stability of the catalysts. This improvement is attributed to the increase of the dispersion of the nickel phase, the decrease of the support acidity and the increase of Ni-phase reducibility. The best catalyst of the series doped with La+Ba proved to be sulphur tolerant and stable for more than 160 h on stream. Doping of the support with Ce also improved the catalytic performance of the corresponding catalyst, but more work is needed to explain this behavior.

1. Introduction

PEM (proton-exchange membrane) fuel cell technology promises to be an efficient and clean alternative with respect to fuel combustion for primary power generation in stationary and mobile source applications. All fuel cells currently being developed for near term use in electric vehicles require hydrogen as a fuel. Hydrogen can be stored directly or produced onboard the vehicle by reforming methanol, or hydrocarbon fuels derived from crude oil—e.g., gasoline, diesel, or middle distillates. The vehicle design is simpler with direct hydrogen storage, but requires the development of a more complex refuelling infrastructure [1]. Thus the H₂ production onboard by the catalytic reforming of liquid fuels is very attractive [2]. Hence, there is great interest in converting hydrocarbons and oxygenated hydrocarbons into hydrogen. The process of converting petroleum fuels to hydrogen-rich gas products that have been developed in the past generally fall into one of the following

classes—steam reforming (SR), partial oxidation (POX), autothermal reforming (ATR), dry reforming (DR) or a combination of two or more of the above. Despite their advantages, each of these processes has drawbacks with respect to design, fuel, and operating temperature [3]. The choice of reforming processes for producing fuel-cell feeds of the necessary quality has been thermodynamically analyzed using different fuels [4]. Similarly, the challenges and opportunities of various fuel reforming technologies for application in low and high-temperature fuel cells have been thoroughly reviewed [5].

Fuels produced by pure steam-reforming contain ~70%–80% hydrogen [6] proving this process the most productive one. Recently, Remiro *et al.* [7] have reported on the possibility to obtain an almost pure H₂ stream (99% H₂) by in situ capturing of CO₂ produced in the steam reforming process. Fuels, such as natural gas, methanol, propane, gasoline, or aqueous bio-oil/bio-ethanol mixtures have been widely studied for their reforming characteristics [8–12]. Due to the complexity of diesel fuel, its conversion by steam reforming is a complicated problem [13].

The design of a fuel reforming catalyst is a difficult undertaking. Weight, size, activity, cost, transient operations, versatility to reform different fuels/compositions, catalyst durability, and fuel processor efficiency are critical considerations for both stationary and automotive fuel cell applications. A desirable catalyst is one which catalyzes the reaction at low temperatures and is resistant to coke formation and tolerant for various concentrations of poison (e.g. sulfur, halogens, heavy metals, *etc.*) for extended periods of time [2].

Generally, reforming catalysts consist of a base metal (Ni, Co, etc.) promoted by a noble metal (Pt, Pd, Rh, Ru, etc.) supported on stabilized supports (alumina, ceria, ceria promoted alumina, zeolite, etc.) [14]. Steam reforming Ni-based catalysts are the most popular. Although these catalysts are cost effective and commercially available, they have a number of drawbacks when considered for fuel cell applications. For instance, they have a high propensity toward coke formation, whereas in their active state they are pyrophoric and intolerant to sulfur. Diesel is a complex hydrocarbon mixture characterized by the presence of sulphur. Even though desulfurization can be used to remove most of the sulphur from a traditional fuel, the small quantities that remain (10 ppm in EU since 2010) can lead to deactivation after many hours on stream.

In the present work, we have tried to minimize the above mentioned drawbacks of the Ni-based steam reforming catalysts by preparing such catalysts supported on modified alumina. Alumina has been chosen, as it has several advantages in comparison with other ceramic materials: it is inexpensive, quite highly refractory, and supposedly relatively inert to water in the range of the SR process conditions [15]. BaO, La₂O₃, and CeO₂ have been used as modifiers, as these materials have already been tried in similar processes, namely catalytic

partial oxidation of hydrocarbons [16]. Although La and Ce-promoted Ni/ γ -Al₂O₃ catalysts have been reported in the steam reforming of light hydrocarbons [17–19], there are few studies on the rare-earth promoted catalysts in the diesel steam reforming [20]. The prepared catalysts have been characterized by using a combination of N₂ adsorption-desorption, X-ray diffraction (XRD), UV-Vis diffuse reflectance spectroscopy (DRS), temperature programmed reduction (TPR), X-ray photoelectron spectroscopy (XPS), and microelectrophoresis techniques.

The catalysts' performance was evaluated in a fixed bed micro-reactor using *n*-hexadecane with or without dibenzothiophene doping as surrogate for desulphurized commercial (10 ppm S) or sulphur free diesel, respectively. Thus, we attempted to gain insight concerning the influence of support modification on carbon deposition and sulfur poisoning during steam reforming.

2. Results and Discussion

2.1. Physicochemical Characteristics of the Supports

Five supports, pure alumina as well as La-, Ba-, (La+Ba)-, Ce-doped alumina, were used for the preparation of nickel catalysts studied in the present work. The doped supports were prepared by wet impregnation of pure alumina with aqueous solutions of the nitrate salts of the above ions. The composition, specific surface areas, and isoelectric points of these supports are shown in Table 1.

Inspection of this table shows that the doping of alumina by La, Ba or (La+Ba) results in doped supports with specific surface areas ($S_{\rm BET}$) lower than that of the parent alumina. However, the calculation of the surface area per gram of alumina ($S_{\rm BET/Al}$) results in values equal to that of undoped alumina. This indicates no pore blockage of the support and eventually quite good dispersion of the dopant on the support surface. In contrast, doping with Ce provoked a slight increase in the specific surface area due to the porous nature of the corresponding oxide itself.




Figure 1. Pore size distributions of the supports used.

Figure 1 presents the pore size distributions of the prepared supports. One can observe a very small narrowing of the distributions along with a small shift towards lower pore diameters. This picture corroborates that no pore blockage takes place upon doping.




Figure 2. XRD patterns of pure (Al) and doped with La (Al-La), Ba (Al-Ba), Ce (Al-Ce), and La+Ba (Al-(La+Ba)) alumina after calcination at 850 $^{\circ}$ C.

Figure 2 illustrates the XRD patterns of the supports used for the preparation of the corresponding Ni-catalysts. These patterns have been recorded after calcination at 850 °C. Diffraction peaks at $2\theta = 37.2$, 45.8, and 66.7° correspond to γ -Al₂O₃ (JCPDS 86-1410). The most intensive of these three peaks are visible in the patterns of all the supports studied.

Diffraction peaks assigned to crystalline species of either La₂O₃ (JCPDS 83-1355) or LaAlO₃ (JCPDS 85-1071) were not observed in the Al-La support. However, the corresponding pattern shows that doping with La decreases the alumina crystallinity broadening the corresponding peaks. Doping with Ba provoked a similar effect on the alumina crystallinity, while additional diffraction peaks, with the most intensive at $2\theta = 28.3^{\circ}$, indicate the formation of BaAl₂O₄ phase (JCPDS 82–2001). The formation of the latter is much more pronounced in the support doped with La+Ba. Doping with Ce had a little influence on the alumina crystallinity, while a diffraction peak arising at $2\theta = 28.6^{\circ}$ suggests the segregation of a CeO₂-phase (JCPDS 081-0792) over the γ -Al₂O₃ surface [21]. The formation of a porous CeO₂ phase explains the increase of the specific surface area of the Al-Ce support discussed previously (see Table 1).

The isoelectric point (IEP) values in Table 1 show that the doping with La and/or Ba increases the basicity of alumina, while the doping with Ce has a slightly opposite action. It is well known that the acid-base properties of the support influence the deposition mechanism of the active phase [22] and, thus, the active species formed on the support surface, as well as the resistance of the final catalyst to coke formation. It has been shown that the rate of carbon deposition on catalyst surfaces is reduced when the active metal is supported on a more basic carrier [23,24].

2.2. Physicochemical Characteristics of the Ni-Catalysts

The Ni-catalysts studied were prepared by wet impregnation of the support with a Ni(NO₃)₂ aqueous solution of appropriate concentration to obtain catalysts with Ni loading equal to 15wt. %. Comparing the specific surface areas of the final Ni-catalysts (SSA_C) presented in Table 2 with those of the corresponding supports (SSA_S) compiled in Table 1, we observe that the deposition of Ni caused a decrease of the specific surface area of ~20% in the case of the doped samples. This decrease was smaller in the undoped catalyst (~13%), which might indicate a higher dispersion of the Ni-phase in the undoped catalyst or a relatively high extent of NiAl₂O₄ formation by incorporation of Ni²⁺ ions into the alumina lattice.




Figure 3. Pore size distributions of the catalysts studied.

Figure 3 shows the pore size distributions of the prepared catalysts. Similar distributions can be observed for all catalysts. However, in the Ni/Al sample a slightly higher contribution of small pores can be observed, in agreement with our previous comments for the Ni deposited on the surface of un-doped alumina.




Figure 4. XRD patterns of Ni-catalysts supported on pure (Ni/Al) and doped with La (Ni/Al-La), Ba (Ni/Al-Ba), Ce (Ni/Al-Ce), and La+Ba (Ni/Al-(La+Ba)) alumina after calcination at 850 $^{\circ}$ C.

Figure 4 shows the XRD patterns of the Ni-catalysts studied after calcination at 850 °C. The diffraction peaks observed in the XRD patterns of the corresponding supports (see Figure 2) can be also found in these patterns. A careful inspection of Figure 4 reveals that there is no evidence of a NiO phase (37.3, 43.3, and 62.9 JCPDS 78-0643). On the other hand, diffraction peaks attributed to NiAl₂O₄ crystallites can be found in the XRD patterns of all catalysts studied. Although, it is difficult to discriminate between NiAl₂O₄ and γ -Al₂O₃ from their XRD patterns, because almost all the diffraction peaks of these phases overlap, they can be distinguished from each other by the peak intensities of the main diffractions. Table 2 summarizes the crystal phases detected in the calcined Ni-catalysts.

The formation of NiAl $_2$ O $_4$ crystallites is attributed to the fact that Ni 2 + ions preferentially incorporate into the tetrahedral vacancies of γ -Al $_2$ O $_3$ at low nickel loading [25]. However, detailed analysis of the XRD patterns revealed that the NiAl $_2$ O $_4$ content of the catalysts prepared depends on the alumina doping. More precisely, NiAl $_2$ O $_4$ seems to be the predominant nickel phase in the Ni/Al sample. Its content decreases in the catalyst prepared using La doped alumina. La-phase has not been detected in the latter sample confirming its very good dispersion suggested by the SSA results discussed previously (Table 1).

Doping of alumina with Ba caused, in addition, the formation of $BaAl_2O_4$ as new peaks appeared in the corresponding XRD pattern at 2θ : 19.08° , 27.85° , 34.24° , and 40.09° [26]. The formation of this crystal phase seems to take place by insertion of Ba^{2+} ions into γ -Al₂O₃ lattice maintaining intact the corresponding SSA_{Al} (see Table 1). In such a case the Ba^{2+} insertion probably competes with the insertion of the Ni^{2+} ions for the same alumina lattice vacancies. This is corroborated by the observation that the intensities of the peaks assigned to $NiAl_2O_4$ are lower in the XRD pattern of Ni/Al-Ba sample than those recorded in the previous samples. Thus, the doping of alumina with Ba leads to a decrease of $NiAl_2O_4$ content in the corresponding catalyst. The XRD pattern of Ni/Al-(La+Ba) catalyst was similar to that of Ni/Al-Ba one. However, the $NiAl_2O_4$ content of the doubly doped catalyst seems to be the lowest detected among the catalysts studied in the present work.

The XRD pattern of Ni/Al-Ce catalyst showed the formation of CeO₂ crystallites in addition to those of γ -Al₂O₃ and NiAl₂O₄.




Figure 5. Diffuse reflectance spectra of the catalysts recorded in the range 500–800 nm.

Figure 5 illustrates the diffuse reflectance (DR) spectra of the prepared catalysts recorded in the range 500–800 nm. An intense doublet with maxima at 595 and 635 nm appears in these spectra. This doublet is assigned to $\mathrm{Ni^{2+}}$ ions in tetrahedral symmetry and thus it is associated with the formation of the $\mathrm{NiAl_2O_4}$ phase detected by XRD. Two shoulders appearing at 561 and 715 nm are assigned to $\mathrm{Ni^{2+}}$ ions in octahedral symmetry associated with the NiO phase [27,28].

To study the effect of doping on the catalysts, it is necessary to analyze the peaks of various $\mathrm{Ni^{2+}}$ species. However, the quantitative analysis of these species based on the DR spectra is relatively difficult because of the overlapping of the absorption domains of various $\mathrm{Ni^{2+}}$ ions. Thus, for obtaining a rough indication of the relative content of $\mathrm{NiAl_2O_4}$ to NiO we used the ratio ($\mathrm{R_{DRS}}$) of the height of the peak at 635 nm to the height of the peak at 715 nm [29].

The R_{DRS} values for the catalysts studied are included in Table 2. Taking into account these values one can conclude that doping of alumina with La and Ba decreases the NiAl₂O₄ content of the catalysts in accordance with XRD results mentioned before. More precisely, the NiAl₂O₄ content of the catalysts follows the order Ni/Al > Ni/Al-La > Ni/Al-Ba > Ni/Al-(La+Ba). On the other hand, doping of alumina with Ce does not influence the relative amount of NiAl₂O₄/NiO.




Figure 6. TPR profiles of the prepared catalysts recorded in the temperature range 150-1000 °C.

The reducibility of the Ni-species and their interaction with the support were studied via TPR experiments. It is evident from the TPR profiles (Figure 6) that the catalysts consume hydrogen in three temperature ranges. The first and minor peak

appears at 350 $^{\circ}$ C but only in the TPR profile of Ni/Al-Ce catalyst. It is assigned to the reduction of loosely attached NiO crystals. The small size of this peak shows that the relative amount of these crystals is very low. According to the literature [30,31], doping of Ni-catalysts with Ce promotes the NiO reduction due to action of the Ce³⁺/Ce⁴⁺ redox pairs, which facilitate electron transfer.

The second and relatively more intense event characterized by a broad peak appearing in all TPR profiles, with maxima in the range 400–650 °C, arises from the reduction of NiO species exhibiting stronger interaction with the support. The fact that the peak is broad and asymmetric indicates the presence of a multitude of such NiO species with different strength of binding to the support [32,33]. The third and most important reduction event appears at 817 \pm 10 °C. The corresponding well resolved peak should be assigned to the reduction of the NiAl₂O₄ phase [34] detected by XRD and DRS.

Deconvolution of the TPR curves has been performed in order to calculate the $NiAl_2O_4/NiO$ ratio (R_{TPR}). The corresponding values are given in Table 2. These values follow the same trend as those calculated from the DR spectra.

Taking into account the amount of hydrogen required for complete reduction of the supported Ni $(Ni^{2+} \rightarrow Ni^{0})$ and the total amount of hydrogen experimentally consumed, the percentage of Ni-phase reduced upon TPR measurements (experimental/theoretical amount of hydrogen consumed) is obtained. The percentage values of this parameter ((Ni^{0})) are illustrated in the last column of Table 2. An inspection of these values reveals that doping with La and Ba and especially the combined doping with La and Ba increases the reducibility of the

Ni-phase. These results are in good agreement with the decrease of the $NiAl_2O_4$ content in the corresponding catalysts indicated by the XRD and DRS results. In contrast, doping with Ce seems to have a slight, if any, negative effect on the total reducibility of Ni-phase, although, as already mentioned, it facilitated the reduction of NiO loosely bound on the support surface. Taking into account the corresponding R value appearing in Table 2, which indicates relatively higher $NiAl_2O_4$ content in the Ni/Al-Ce catalyst, this behavior could be easily explained.

The surface analysis of the catalysts prepared was performed by X-ray photoelectron spectroscopy (XPS). XPS resulted in the expected detection of Ni, Al, and O on the surfaces of all catalysts studied, as well as of La in Ni/Al-La and Ni/Al-(La+Ba) catalysts, Ba in Ni/Al-Ba and Ni/Al-(La+Ba) catalyst and Ce in the Ni/Al-Ce one. Organic carbon from a surface contamination layer, which consists mainly of CH_x with the dominant C1s peak set at 284.8 eV as a binding energy (BE) reference and some organic oxygen of the CO_x type, was found in all specimens due to the atmospheric exposure. The quantitative surface analysis of the catalysts was based on the following peaks: Ni2p_{3/2} (855.9 eV), O1s (531.0 eV), Al2s (118.9 eV), Ba3d_{5/2} (780.2 eV), La3d_{5/2} (835.2 eV), and Ce3d_{5/2} (~885 eV).

Table 3 summarizes the results obtained from the quantitative analysis of the XPS data, based on measured peak areas, one for each detected element as mentioned above, and taking into account the respective relative sensitivity factors (RSF).

Inspection of Table 3 reveals that doping of the γ -Al $_2$ O $_3$ carrier with La leads to only a slight surface enrichment of the corresponding catalyst with Ni-species. This effect becomes more intense by doping with Ba and even more intense when combined doping with La and Ba takes place. This surface enrichment with Ni-species is in good accordance with the increase of reducibility of these catalysts and the decrease in the R value discussed previously.

Although we do not have direct experimental measurement for Ni particle size (e.g., TEM), the XPS data (Table 3) offer strong evidence of enhanced Ni dispersion over the Ba-doped support. The measured Ni/Al atomic ratio on the Ba-doped

alumina is more than two times larger than in the case of undoped alumina, whereas Ba has a tendency to be incorporated in alumina and not to cover it. Indeed the surface atomic concentration of Ba in the Ni/Al-Ba and Ni/Al-(La+Ba) catalysts was found to be relatively low compared to the nominal Ba concentration. This suggests the easy insertion of Ba ions into the alumina lattice and is in very good agreement with our XRD results, which indicated the formation of BaAl₂O₄ crystals (see Table 2). Doping with Ce seems to have a slight, if any, positive influence on the surface enrichment of Ni-species, while the surface concentration of Ce atoms was found to be extremely low. The latter effect can be explained by the formation of relatively large CeO₂ crystallites, as suggested also by XRD.

2.3. Catalyst Evaluation




Figure 7. Hydrogen production rates measured over the Ni-catalysts supported on pure (■), La- (•), Ba- (△), and (La+Ba)- (♦) modified γ -Al₂O₃ with the time on stream. (Reaction conditions: Steam to Carbon ratio = 2.67, Reaction temperature: 795 °C, catalyst mass = 0.05 g, GHSV= 20000 h⁻¹)

The catalytic performance of the catalysts studied was evaluated in a fixed bed micro-reactor for the steam reforming of hexadecane (surrogate sulphur-free diesel) and hexadecane doped with dibenzothiophene corresponding to surrogate commercial diesel with 10 ppm sulphur. The only products detected in the gas stream at the reactor outlet were H_2 , CO, CO_2 and CH_4 . Figure 7 shows the production rate of H_2 measured over the Ni-catalysts supported on pure, La-, Ba-, and (La+Ba)-doped γ -Al₂O₃. Complete conversion of n-hexadecane was observed at 795 °C over all of the catalysts studied in accordance with the results described recently by Kaynar *et al.* [35].

In all catalytic runs the H₂ mass flow rates (F) measured at the reactor outlet increased initially and reached their maximum value after 0.5–1 h on stream. This is in accordance with the fact that metallic nickel is the active phase of the catalysts studied, while the reactor was loaded with their oxide form. Thus, the initial increase of H₂ production rate should be attributed to the in situ activation (reduction) of the catalyst by the H₂ produced (see Experimental section). The Ni/Al and Ni/Al-La catalysts exhibited important initial activities (after ~0.5 h on stream) but they were fully deactivated after 2 and 2.5 h on stream, respectively. However, the beneficial action of doping with La was clear resulting in higher initial activity and longer deactivation time compared to that of un-doped catalyst. The enhanced initial H₂ production observed over the Ni/Al and Ni/Al-La samples can be attributed to decomposition of the hydrocarbon, which is expected to increase the coke formation over the catalysts, thus explaining the simultaneous rapid deactivation of these samples [35]. Coke formation in the form of both amorphous and graphitic filamentous carbon was identified as the main reason for deactivation of rich in NiAl₂O₄ catalysts studied by Jiménez-González et al. [11] for steam reforming of isooctane.

Doping of the catalyst support with Ba or (Ba+La) further improved the catalytic performance of the corresponding samples (Figure 7). This improvement could be attributed to the following effects caused by doping with Ba or (Ba+La): surface enrichment of the nickel phase as observed by the XPS analysis, decrease of the support acidity measured by microelectrophoresis and increase of the Ni-phase reducibility determined by TPR. Taking into account that all the catalysts studied in the present work had the same Ni loading, their surface enrichment with nickel phase caused by doping of the support with Ba or Ba+La indicates an increase of the dispersion of the active phase. Christensen *et al.* [36] reported that lower coking rates are possible for Ni-catalysts with higher metallic dispersion, and Quitete *et al.* [37] found that coke formation is favored by increasing nickel particle size. On the other hand, it is well known that low tendency to coke formation is observed when the Ni active phase is dispersed on less acidic supports [38]. As to the influence of Ni-phase reducibility on catalytic performance it is well known that metallic Ni atoms are active sites for the steam reforming of hydrocarbons [39].

Figure 8 shows the production rates of H_2 , CO, CO_2 , and CH_4 measured at the outlet of the reactor on a dry basis after 4 h on stream over all catalysts under sulfur free conditions and over the Ni/Al-(La+Ba) catalyst, which is the most promising one, in the presence of sulphur in the feed. Comparing the Ni/Al-Ba and Ni/Al-(La+Ba) catalysts one can observe that the enhanced H_2 production rate observed in the latter is accompanied by lower CH_4 and higher CO and CO_2 production rates. This probably shows that doping hinders the methanation reactions.




Figure 8. Production rates of H_2 , CO, CO_2 , and CH_4 after 4 h on stream over the catalysts under sulphur free conditions and over the Ni/Al-(La+Ba) catalyst in the presence of 10 ppm sulphur in the feed (Steam/Carbon ratio: 2.67, Reaction temperature: 795 °C, catalyst mass: 0.05 g, GHSV= 20000 h⁻¹).

The Ni/Al-(La+Ba) catalyst proved to be quite active even in the presence of sulphur in the stream because only a small decrease (<10%) in its activity has been observed when the reactor was fed with surrogate diesel containing 10 ppm sulphur. The activity of this most promising Ni/Al-(La+Ba) catalyst was tested for long times under sulphur free conditions and proved to be quite stable for more than 168 h on stream (see Figure 7).

Doping of the support with Ce caused also significant increase in the activity of the corresponding catalyst, which could not be explained taking into account the physicochemical characteristics of the Ni-phase examined in the present work. According to the literature, the beneficial action of Ce could be attributed to the scavenging of the coke from the surface of the Ni phase via oxygen provided by the CeO_x phase [40]. Indeed, this phase has been detected in our Ni/Al-Ce sample by XRD. However, more work is necessary in order to explain the important catalytic behavior of the Ni/Al-Ce sample.

3. Experimental Section

Alumina extrudates (AKZO, HDS-000-1,5mmE, SSA = $264 \, \mathrm{m}^2/\mathrm{g}$, pore volume: $0.65 \, \mathrm{cm}^3/\mathrm{g}$) were crushed and sieved to obtain a support powder with particle size $90\text{--}105 \, \mu\mathrm{m}$. It was wet impregnated with aqueous nitrate solutions of $\mathrm{La(NO_3)_3 \cdot 6H_2O}$ (Sigma-Aldrich, Taufkirchen, Germany, 99.999%), $\mathrm{Ce(NO_3)_3 \cdot 6H_2O}$ (Alfa Aesar, Lancashire, United Kingdom, 99.5%), and $\mathrm{Ba(NO_3)_2}$ (Sigma-Aldrich, 99.999%) of volume equal to 20 times the total pore volume of the support used. The solution contained the appropriate amount of salt to obtain the desired concentration

of dopant in the doped support and the final catalyst. After the evaporation of water in a rotary evaporator (BUCHI, Flawil, Switzerland) impregnates were dried overnight at 120 $^{\circ}$ C in air, then they were calcined by increasing the temperature initially up to 400 $^{\circ}$ C (3 $^{\circ}$ C/min) and then up to 850 $^{\circ}$ C (10 $^{\circ}$ C/min), where they remained for 3 h. A series of Ni catalysts supported on pure and modified alumina containing 15% w/w Ni, was prepared following the above described procedure for the deposition of the nickel phase using aqueous solution of Ni(NO₃)₂ 6H₂O (Sigma-Aldrich, Taufkirchen, Germany 98%). The final impregnates were submitted to the same thermal treatment (drying and calcination) with that described above for the preparation of the supports.

The determination of the specific surface area ($S_{\rm BET}$) of the samples was based on the nitrogen adsorption–desorption isotherms recorded using a Micromeritics apparatus (Tristar 3000 porosimeter, Micromeritics, Aachen, Germany) and the corresponding software. Pore size distributions have been determined using the BJH method and the N_2 desorption curve.

XRD measurements were carried out with a D8 Advance X-Ray diffractometer, Bruker, Leiderdorp, The Netherlands, equipped with nickel-filtered Cu Ka (0.15418 nm) radiation source. The step size and the time per step were respectively fixed at 0.02° and 0.5 s in the range of $20^{\circ} \le 20 \le 80^{\circ}$.

The diffuse reflectance spectra of the calcined samples were recorded in the range 200–800 nm at room temperature. A UV-Vis spectrophotometer (Varian Cary 3, Agilent Technologies, Santa Clara, CA, USA) equipped with an integration sphere was used. The corresponding support was used as reference. The samples were mounted in a quartz cell. This provided a sample thickness greater than 3 mm to guarantee the "infinite" sample thickness.

The isoelectric points of the pure and modified alumina supports were determined using a Zetasizer Nano-ZS apparatus (Malvern, United Kingdom) equipped with a DTS 1060C-Clear disposable zeta cell (Malvern, United Kingdom).

XPS measurements were carried out on catalyst powders prepared as described above and pressed in a hollow aluminum metal receptacle. The experiments took place in a MAX200 (LEYBOLD/SPECS, Berlin, Germany) Electron Spectrometer using non-monochromatic MgK $_{\alpha}$ radiation (1253.6 eV) and an EA200-MCD analyzer (SPECS, Berlin, Germany) operated at a constant pass energy (PE) of 140 eV in order to maximize signal intensity while maintaining a resolution of the order of 1.1 eV. The analysis was performed along the surface normal and the analyzed specimen area was a ~4 × 7 mm² rectangle near the specimen center with a depth of analysis of the order of 10nm. The binding energy (BE) scale was corrected for electrostatic charging via the main C1s peak from surface contamination set at 284.8 eV BE, the uncertainty in the corrected values being of the order of ± 0.15 eV. The relative sensitivity factor (RSF) database used for quantitative analysis has been adapted to

the MAX200 spectrometer (SPECS, Berlin, Germany) operating conditions from the empirical collection of Wagner *et al.* [41], whereas the assignment of the BE for the various chemical states of the elements was made using an appropriate database [42].

The TPR experiments were performed in a laboratory-constructed equipment described elsewhere [43]. An amount of sample, 0.1 g, was placed in a quartz reactor and the reducing gas mixture ($H_2/Ar: 5/95 \, v/v$) was passed through it for 2 h with a flow rate of 40 mL min⁻¹ at room temperature. Then the temperature was increased to 1000 °C with a constant rate of 10 °C min⁻¹. Reduction leads to a decrease of the hydrogen concentration of the gas mixture, which was detected by a thermal conductivity detector (TCD) (Shimadzu, Duisburg, Germany). The reducing gas mixture was dried in a cold trap (-95 °C) before reaching the TCD.

Catalytic performance of the prepared samples was evaluated using a stainless steel fixed-bed reactor (diameter: 1/4 inch) loaded with 0.05 g of catalyst in its oxide form diluted with 0.05 g of quartz sand. Helium from a cylinder was fed through mass flow-meter (Brooks) into a saturator containing hexadecane or hexadecane/dibenzothiophen to simulate sulfur-free diesel and a diesel containing 10 ppm of sulfur, respectively. The temperature of the saturator was set at 153 $^{\circ}$ C for obtaining constant partial pressure of surrogate diesel in the He stream. Triply distilled water was fed to the latter stream with a syringe pump (Braintree Scientific Inc., Braintree, MA, USA). A steam/carbon ratio of 2.67 was ensured. The line from the saturator to the reactor entrance was maintained at 350 °C in order to avoid any condensation. Thus, a GHSV= 20000 h^{-1} was obtained. The reactor temperature was set at 795 \pm 1 $^{\circ}$ C. The outlet stream of the reactor was analyzed after cooling and gas-liquid separation (at 0-5 °C). Two gas chromatographs (GC-8A and GC-14B, Shimadzu, Duisburg, Germany) equipped with thermal conductivity detectors and SUPELCO columns (100/120 Carbosieve SII 10 ft × 1/8IN SS and 60/80 Carboxen 1000 15 ft \times 1/8IN SS) were used for the dry-base analysis of the gas products. Sampling was performed using six port valves every 15 minutes for the first four hours of each catalytic test and then every four hours for the long term test performed over the Ni/Al-(La+Ba) catalyst. A delay was observed in the evolution of H₂ in the outlet of the reactor. Thus the maximum H₂ production was observed after 0.5 h on stream over the Ni/Al and Ni/Al-La samples and after 1 h over the rest of the catalysts. The aforementioned delay of H₂ evolution is attributed to its consumption for the in situ activation (reduction) of the catalysts by the H₂ initially produced.

4. Conclusions

The main conclusions drawn from the present work can be summarized as follows:

Doping of the γ -alumina support with Ba or (La+Ba) resulted in Ni catalysts with improved activity and stability for surrogate diesel steam reforming. This

improvement can be attributed to the increase of the dispersion of the nickel phase, the decrease of the support acidity and the increase of Ni-phase reducibility.

Doping of the support with Ce caused also significant increase in the activity of the corresponding catalyst.

The doubly doped (La+Ba) catalyst proved also to be sulphur tolerant and stable for more than 160 h on stream.

Synthesis of Ethanol from Syngas over Rh/MCM-41 Catalyst: Effect of Water on Product Selectivity

Abstract: The thermochemical processing of biomass is an alternative route for the manufacture of fuel-grade ethanol, in which the catalytic conversion of syngas to ethanol is a key step. The search for novel catalyst formulations, active sites and types of support is of current interest. In this work, the catalytic performance of an Rh/MCM-41 catalyst has been evaluated and compared with a typical Rh/SiO₂ catalyst. They have been compared at identical reaction conditions (280 °C and 20 bar), at low syngas conversion (2.8%) and at same metal dispersion (H/Rh = 22%). Under these conditions, the catalysts showed different product selectivities. The differences have been attributed to the concentration of water vapor in the pores of Rh/MCM-41. The concentration of water vapor could promote the water-gas-shift-reaction generating some extra carbon dioxide and hydrogen, which in turn can induce side reactions and change the product The extra hydrogen generated could facilitate the hydrogenation of a C₂-oxygenated intermediate to ethanol, thus resulting in a higher ethanol selectivity over the Rh/MCM-41 catalyst as compared to the typical Rh/SiO₂ catalyst; 24% and 8%, respectively. The catalysts have been characterized, before and after reaction, by N2-physisorption, X-ray photoelectron spectroscopy, X-ray diffraction, H₂-chemisorption, transmission electron microscopy and temperature programmed reduction.

1. Introduction

At present, fuel-grade ethanol is utilized as a renewable component in gasoline or as a pure fuel in flex-fuel vehicles [1,2]. In 2013, about 70 million tons of fuel-grade ethanol were produced worldwide [3]. Most of the production technologies use food-related raw materials, such as corn in the USA or sugar cane in Brazil. Non-food related resources such as forest and agricultural biomass (known as cellulosic biomass) are being considered as alternative raw materials. Indeed, several public

and private institutions have started R&D programs in order to produce fuel-grade ethanol from cellulosic biomass, at competitive cost [4].

In principle, any kind of biomass can be converted into fuels and chemicals thermochemically [5,6]. The thermochemical process is divided in two stages; in the first, biomass is converted to an intermediate mixture of gases known as "synthesis gas" or "syngas" typically via gasification, in the second, syngas is catalytically converted to the final product. In the latter stage, the performance of the selected catalyst is of key importance for the overall process. Much effort has been put into designing a selective catalyst for the synthesis of ethanol from syngas. The rhodium-based catalysts are among the most selective catalysts reported in the literature [7,8]. However, few reports are found using mesoporous silica as catalyst support [9-11], although various mesoporous materials have been applied in other catalytic reactions showing interesting results [12,13]. MCM-41 is a mesoporous silica that has 1D-hexagonal porous arrangement with a pore diameter between 1.6–10 nm and a wall thickness of around 0.8 nm [14,15]. The large surface area of MCM-41, usually 1000 m²/g or more, can be of great utility for dispersing the active sites and hence boost the catalyst activity per unit of mass. To the best of our knowledge, there is no comparison between a mesoporous Rh/MCM-41 catalyst and a typical Rh/SiO₂ catalyst. Ma et al. [9] have compared Rh-Mn/MCM-41 with Rh-Mn/SiO₂, however, the presence of manganese may considerably affect the reactivity of the catalysts and no direct information about the effect of MCM-41 could be inferred. Chen et al. [10,11] have studied the effect of metal promoters (Mn and Fe) using another type of mesoporous silica (SBA-15).

In order to evaluate the catalytic performance of Rh/MCM-41 and Rh/SiO₂, some considerations regarding the metal loading, degree of metal dispersion (H/Rh) and syngas conversion level must be taken. Arakawa et al. [16] and Underwood and Bell [17] have studied the effect of metal dispersion, from 10% to 82%, which was obtained by increasing the metal loading from 0.1% to 30% Rh. Both studies showed a large effect of the metal dispersion on the product selectivity. However, the experiments carried out by Arakawa et al. [16] might have been affected by secondary reactions since the syngas conversion level was not the same in all the experiments (it varied from 0.4% to 27.9% depending on the metal loading). Underwood and Bell [17] kept the syngas conversion level below 0.1%, thus reducing the risk of secondary reactions, however, the various extents of metal loading could have affected their results. Tago *et al.* [18] showed that the extent of metal loading affects the product selectivity, according to their experiments carried out at constant H/Rh = 25% with the metal loading varied from 0.6% to 3.5% Rh. In a more recent work, Zhou et al. [19] used Rh/SiO₂ catalysts with different metal dispersions while keeping the same metal loading (3% Rh) testing them at low syngas conversion level (0.7%–1.5%). They observed that the degree of metal dispersion directly affects the

product selectivity. Therefore, in order to avoid the effects of (i) secondary reactions; (ii) degree of metal dispersion and (iii) extent of metal loading over the product selectivity, the catalytic testing of Rh/MCM-41 and Rh/SiO₂ should be carried out at (1) low syngas conversion level; (2) equal degree of metal dispersion and (3) equal metal loading.

In the present work, we have evaluated the catalytic performance of a mesoporous Rh/MCM-41 catalyst and compared it with a typical Rh/SiO₂ catalyst. Both catalysts were tested for the synthesis of ethanol from syngas at low syngas conversion level (2.8%), same metal dispersion (H/Rh = 22%) and equal Rh loading (3 wt. %). Different product selectivities were found over Rh/MCM-41 and Rh/SiO₂. Additional experiments have been made in order to clarify the obtained results: (a) addition of water to the syngas feed-stream and (b) lowering of the syngas ratio (H₂/CO). The results from these experiments together with the catalyst characterization (BET, XPS, XRD, TEM, TPR), before and after reaction, indicate that the differences in the product selectivities can be attributed to the concentration of water vapor in the pores of Rh/MCM-41, which promote the water-gas-shift-reaction (WGSR) and produce extra CO_2 and H_2 . These results confirm a previous study where high selectivity to CO_2 was observed over Rh/MCM-41 at various levels of syngas conversion as well as at different catalyst reduction temperatures [20].

2. Results and Discussion

The results obtained in the present study are divided into two sections. The first, Section 2.1, describes the catalytic performances of Rh/SiO₂ and Rh/MCM-41, which includes the effect of water addition and different syngas ratios (H₂/CO) (Section 2.1.1.). The second, Section 2.2, describes the catalysts characterization, before and after reaction, through the following techniques: N₂-physisorption (Section 2.2.1.), X-ray photoelectron spectroscopy (Section 2.2.2.), powder X-ray diffraction (Section 2.2.3.), transmission electron microscopy (Section 2.2.4.) and temperature programmed reduction (Section 2.2.5.). Finally, an interpretation of the obtained results and a discussion are then presented (Section 2.3.).

2.1. Catalytic Performances of Rh/SiO₂ and Rh/MCM-41

In order to examine the activity of the Rh/SiO₂ and Rh/MCM-41 catalysts, similar reaction conditions were used, that is reaction temperature and pressure of 280 °C and 20 bar, respectively. The gas hourly space velocity (GHSV) was varied in order to obtain a syngas conversion equal to 2.8% and the syngas ratio was equal to $H_2/CO = 2/1$. Similar conversion levels were applied for studies regarding the metal dispersion on rhodium-based catalysts [17–19]. At low syngas conversion, the occurrence of secondary reactions can be diminished and, at the same time, a uniform catalyst bed temperature can be reached. In all the experiments, the axial temperature

gradient through the catalyst bed (measured by a mobile thermocouple introduced in a thermowell inside the catalyst bed) was always less than 1 °C.




Figure 1. Product selectivities obtained from the conversion of syngas over Rh/SiO₂ and Rh/MCM-41. Higher hydrocarbons: ethane, propane and butane. Acetate compounds: methyl acetate and ethyl acetate. Reaction conditions: 280 $^{\circ}$ C, 20 bar, GHSV = 12,000 mL_{syngas}/g_{cat}·h for Rh/SiO₂ and GHSV = 3000 mL_{syngas}/g_{cat}·h for Rh/MCM-41.

Different product selectivities are obtained over Rh/SiO₂ and Rh/MCM-41 catalysts, as shown in Figure 1. If the selectivity toward all hydrocarbon compounds (methane and higher hydrocarbons) and the selectivity toward all oxygenated compounds (methanol, carbon dioxide, ethanol, acetaldehyde, acetic acid, methyl acetate and ethyl acetate) are considered in Figure 1, the following results are obtained: 58.2% hydrocarbon compounds and 41.8% oxygenated compounds for Rh/SiO₂, while for Rh/MCM-41 results 43.4% hydrocarbon compounds and 56.6% oxygenated compounds. This indicates that more hydrocarbon compounds are formed in Rh/SiO₂ than in Rh/MCM-41. Underwood and Bell have used a Rh/SiO₂ catalyst with a similar metal dispersion to the one used in our study (H/Rh = 10%) and also found a higher selectivity to hydrocarbons than to oxygenates [17].

Regarding the formation of the C_2 -oxygenated compounds (ethanol, acetaldehyde and acetic acid), it can be seen from Table 1 (syngas ratio $H_2/CO = 2/1$) that the selectivity trend for Rh/SiO₂ decreases in the following order: acetaldehyde > acetic acid > ethanol. While for Rh/MCM-41 it decreases as: ethanol > acetaldehyde >

acetic acid. Interestingly, the total selectivity to C_2 -oxygenated compounds is similar in both catalysts; 34% for Rh/SiO₂ and 32% for Rh/MCM-41.

2.1.1. Addition of Water Vapor and Lower Syngas Ratio ($H_2/CO = 1/1$)




Figure 2. Comparison of the product selectivities obtained from the conversion of syngas with and without addition of water over Rh/SiO₂ and Rh/MCM-41. Reaction conditions (with addition of water): 280 °C, 20 bar, GHSV = 6000 mL_{syngas}/g_{cat}·h (H₂:CO:H₂O = 2:1:2.7) for Rh/SiO₂ and GHSV = 3000 mL_{syngas}/g_{cat}·h (H₂:CO:H₂O = 2:1:1.5) for Rh/MCM-41. Reaction conditions for the experiments without addition of water as indicated in Figure 1.

Figure 2 shows the effect of the addition of water to the syngas feed-stream for Rh/SiO₂ and Rh/MCM-41 catalysts. The addition of water vapor decreases the syngas conversion from 2.8% to 1.0% for Rh/MCM-41 at GHSV = $3000 \text{ mL}_{\text{syngas}}/\text{g}_{\text{cat}}\cdot\text{h}$. For Rh/SiO₂, since a very low syngas conversion was found at GHSV = $12,000 \text{ mL}_{Syngas}/g_{cat} \cdot h$, it was necessary to decrease the space velocity to GHSV = $3000 \text{ mL}_{\text{syngas}}/g_{\text{cat}}$ h to achieve a syngas conversion of 1.6%, which indicates a considerable decrease of the activity for Rh/SiO₂ in the presence of water vapor. It can also be observed that the addition of water notably increases the selectivity to CO₂ in both catalysts; from 0.3% to 18.5% for Rh/SiO₂ and from 4.1% to 90.4% for Rh/MCM-41. Likewise, while the selectivity to the rest of the products is reduced in both catalysts, the selectivity to methanol is considerably increased over Rh/SiO₂, but it is somewhat reduced over Rh/MCM-41. Finally, the total selectivity to C₂-oxygenated compounds is notably reduced in both catalysts, as can be seen in Table 1 (syngas ratio $H_2/CO = 2/1$ *), being more marked in Rh/MCM-41. Moreover, the selectivity trends are kept in the same order for Rh/SiO₂ (acetaldehyde > acetic acid > ethanol) and for Rh/MCM-41 (ethanol > acetaldehyde > acetic acid) as in the experiments without water addition (Table 1).




Figure 3. Comparison of the product selectivities obtained from the conversion of syngas with $H_2/CO = 2$ and $H_2/CO = 1$ over Rh/SiO_2 and Rh/MCM-41. Reaction conditions (syngas $H_2/CO = 1$): 280 °C, 20 bar, GHSV = 6000 mL_{syngas}/g_{cat}·h for Rh/SiO_2 and GHSV = 3000 mL_{syngas}/g_{cat}·h for Rh/MCM-41. Reaction conditions for the experiments with syngas $H_2/CO = 2$ as indicated in Figure 1.

Figure 3 shows the effect of changing the syngas ratio from $H_2/CO = 2/1$ to $H_2/CO = 1/1$ for Rh/SiO₂ and Rh/MCM-41 catalysts. The lowering of syngas ratio from $H_2/CO = 2$ to $H_2/CO = 1$ decreases the syngas conversion in both catalysts; from 2.8% to 0.4% for Rh/MCM-41 at GHSV = 3000 mL_{syngas}/g_{cat}·h and from 2.8% (GHSV = 12,000 mL_{syngas}/g_{cat}·h) to 2.1% (GHSV = 6000 mL_{syngas}/g_{cat}·h) for Rh/SiO₂. The reduction of the syngas conversion by the lowering the syngas ratio has also reported in the literature, which is attributable to a lesser extent of the hydrogenation reactions (hydrocarbon formation) [7,8].

In both catalysts, the lowering of the syngas ratio results in less production of methane and methanol while, in contrast, more higher hydrocarbons, carbon dioxide, and acetate compounds are obtained (Figure 3). When the syngas H_2/CO ratio is lowered, the partial pressure of hydrogen is expected to be decreased. This suggests that the products with high H/C ratios, such as CH_4 and CH_3OH , could be favored at high partial pressure of hydrogen (high syngas H_2/CO ratio). Likewise, the products with lower H/C ratios, such as the higher hydrocarbons and oxygenated compounds could be favored at low partial pressure of hydrogen (low syngas H_2/CO ratio). These results are in agreement with the literature regarding the effect of the syngas ratio for rhodium-based catalysts [7,8]. In addition, among the C_2 -oxygenated

compounds it can be observed that the selectivity to acetic acid is favored at low syngas H_2/CO ratio, while the selectivities to the more hydrogenated compounds (ethanol and acetaldehyde) are favored at higher syngas H_2/CO ratio, as is observed in Table 1 (see syngas ratio $H_2/CO = 2/1$ and $H_2/CO = 1/1$).




Figure 4. Selectivities and conversion with time on stream for the Rh/SiO₂ catalyst. Oxyg.: alcohols, acetaldehyde, acetic acid and esters. HC: methane and higher hydrocarbons. See Table S1 in supporting information for details about the reaction conditions in periods A–G.




Figure 5. Selectivities and conversion with time on stream for the Rh/MCM-41 catalyst. Oxyg.: alcohols, acetaldehyde, acetic acid and esters. HC: methane and higher hydrocarbons. See Table S1 in supporting information for details about the reaction conditions in periods A'-H'.

In a previous study a high selectivity to CO_2 in the Rh/MCM-41 catalyst was also observed, it was found to be independent of the catalyst reduction temperature and the syngas conversion level [20]. Figures 4 and 5 show the product selectivities and the syngas conversion with time on stream at different reaction conditions for the Rh/SiO₂ and MCM-41 catalysts, respectively. It can be noted that almost no CO_2 is formed over the Rh/SiO₂ catalyst (Figure 4, Period A–F) whatever the reaction condition (T, P, GHSV) or catalyst reduction temperature (200, 370, 500 °C and non-reduced) applied. On the other hand, a high selectivity to CO_2 is observed over the MCM-41 catalyst at all reaction conditions studied and at different catalyst reduction temperatures (Figure 5, Period A′-G′). Thus, the product selectivity is notably affected by the MCM-41 support in a large range of reaction conditions and at different catalyst reduction temperatures. These results together with the catalysts characterization (Section 2.2) are discussed later on in Section 2.3.

2.2. Catalyst Characterization

2.2.1. N₂-Physisorption

In Table 2 the results obtained from N_2 -physisorption are reported. When comparing the pure supports, the surface area of MCM-41 is about four times larger than the surface area of SiO₂. A similar relation is observed when 3 wt. %




Figure 6. Small and wide angle XRD patterns of pure supports SiO₂ and MCM-41, impregnated with Rh (**A**); after catalytic testing (**B**); and after catalytic testing with addition of water (**C**). Catalytic testing at same conditions as indicated in Table 2.




Figure 7. TEM images of Rh/SiO₂ and Rh/MCM-41 catalysts; reduced (**A**); after catalytic testing (**B**); and after catalytic testing with addition of water (**C**). Catalytic testing at same conditions as indicated in Table 2.

Rh is impregnated in both supports. This indicates that the process of rhodium incorporation (aqueous impregnation, drying and calcination) affects to a similar extent the surface area of MCM-41 and the surface area of SiO₂. In some reported studies, the surface area of MCM-41 is drastically affected by metal incorporation: for example, the impregnation with 5wt. % Co reduced the original MCM-41 surface area by nearly 50% [21]. However, the incorporation of Rh into MCM-41 only reduces the original MCM-41 surface area by 0.9%, as shown in Table 2. After catalytic testing, the surface area was reduced by 3.7% for Rh/SiO₂ and 9.0% for Rh/MCM-41. More notable changes are observed when water is added to the syngas feed-stream, then the surface areas of Rh/SiO2 and Rh/MCM-41 are reduced by 10.3% and 19.3%, respectively (Table 2). The more significant effect of water on the surface area of Rh/MCM-41 is consistent with the structure degradation of mesoporous materials proposed by Landau et al. [22]. Therefore, the hydration of the siloxane structure is followed by siloxane hydrolysis-hydroxylation and their rearrangement-redehydroxylation during calcination. This results in a few 1D-channels collapsing into a single one [22]. As a consequence, there is a loss of Bragg intensity (as will be evidenced by XRD analysis, Figure 6), decreasing the pore volume (as observed in Table 2), while retaining uniform pore size (as described below and further shown by TEM analysis, Figure 7).

Regarding the pore size distribution of Rh/SiO₂ and Rh/MCM-41 (see Figure S1 in supporting information) confirmed, a wide pore size distribution is observed in the pure SiO_2 , which is narrowed after Rh impregnation. Pure MCM-41 presents a narrow pore size distribution and smaller pore sizes as compared to SiO_2 ; after Rh impregnation no significant changes are observed. From the adsorption isotherms, the average pore size of Rh/SiO₂ is much larger than in the case of Rh/MCM-41; 19 nm and 2.5 nm, respectively. Finally, after catalytic testing (with and without water) there is no significant change in the pore size distribution for any of the catalysts.

2.2.2. X-ray Photoelectron Spectroscopy (XPS)

In Table 2, the results from XPS analysis are summarized. Before the catalytic testing, we can observe that the oxidation state of Rh is similar in both Rh/SiO₂ and Rh/MCM-41 catalysts. After the catalytic testing (without addition of water), the fraction of Rh³⁺ is increased in Rh/SiO₂ while it is decreased in Rh/MCM-41. After the catalytic testing with addition of water, all Rh species are in the form of Rh⁰ in both catalysts. Finally, the Rh/Si ratio indicates that Rh species migrate to the surface of the catalysts as a consequence of the catalytic testing. The latter phenomenon is more pronounced when water is added to the catalytic system.

2.2.3. Powder X-ray Diffraction (XRD)

Mesoporous MCM-41 has characteristic signals at small-angle XRD, which are indicated in Figure 6 as (100), (110), and (200) reflections. These signals correspond to a hexagonal structure with unit cell parameter $a=2d_{100}/\sqrt{3}$ [14]. An additional (210) reflection is reported in the literature, which gives a low intensity signal at around $2\theta=5.9$ [14]. In qualitative terms, the intensity of the XRD signals can be attributed to the long-range periodic structure of MCM-41 [21]. Although the long-range ordering in Rh/MCM-41 decreases after impregnation with Rh (Figure 6A) and after catalytic testing (Figure 6B,C), it does not completely disappear. In addition, it can be observed that all signals appear at the same 2θ , *i.e.*, same d-spacing, which suggests that there is no significant lattice contraction either after Rh impregnation or after catalytic testing. Typical SiO₂ support does not present a pore ordering as mesoporous MCM-41, thus no signals are found at small-angle XRD (Figure 6).

The wide-angle XRD patterns in Figure 6 indicate that both catalysts Rh/SiO_2 and Rh/MCM-41 are amorphous materials. It also indicates that there is no

segregation of rhodium oxides (or at least they are not large enough to be detected by the XRD technique) after impregnation with Rh (Figure 6A) and after catalytic testing without addition of water (Figure 6B). After catalytic testing with addition of water (Figure 6C) a low-intensity and broad signal appears at around $2\theta = 35$ –40. This range of 2θ corresponds to the characteristic signals of Rh_2O_3 and Rh^0 . According to the XPS analysis, all Rh species are converted to Rh^0 when water is added to the catalytic system. Therefore, we can conclude that the presence of water in the syngas feed-stream slightly favors the growth of Rh^0 clusters.

2.2.4. Transmission Electron Microscopy (TEM)

In Figure 7, TEM images for Rh/SiO₂ and Rh/MCM-41 catalysts are shown. Before reaction, the average Rh particle size is similar in both catalysts; 4 nm for Rh/SiO₂ and 3 nm for Rh/MCM-41. Which agrees with the average metal particle size equal to 4 nm derived from the metal dispersion (H/Rh = 22%), assuming an icosahedral particle shape [23]. For the Rh/SiO₂ catalyst, the average Rh particle size has grown after the catalytic testing (with and without water). Less effect is observed for the Rh/MCM-41 catalyst, where the average particle size is kept to 3 nm after the catalytic testing, even with addition of water. It can be noted that the pore diameter of MCM-41 is in the same range as the Rh particle size in the Rh/MCM-41 catalyst (Figure 7A-Rh/MCM-41), it may suggest that the pore diameter of MCM-41 limits the growth of Rh particles. This is supported by Zhou *et al.* [19] who observed a relation between the Rh particle size and the pore diameter in various silica supports. If it is so, it could explain the narrow Rh particle size

distribution in the mesoporous Rh/MCM-41 catalyst, even after the catalytic testing (Figure 7B,C-Rh/MCM-41), as compared to the particle size distribution in the Rh/SiO₂ catalyst (Figure 7A–C-Rh/SiO₂).

From XRD analysis (Figure 6), after the catalytic testing (with addition of water) a new and broad signal is observed in both catalysts. This signal corresponds to Rh⁰ according to XPS (Table 2). For the Rh/SiO₂ catalyst, these results agree with the growth of the particle size observed in TEM images (Figure 7). For the Rh/MCM-41 catalyst, it seems that the pores of MCM-41 support limit the growth of Rh and thus

the particle size distribution is little affected. Possibly, the signal detected in XRD for Rh/MCM-41 may be due mostly to an increased number of $\rm Rh^0$ dispersed along the pores.

2.2.5. Temperature Programmed Reduction (TPR)




Figure 8. Temperature programmed reduction profiles of the Rh/SiO_2 and Rh/MCM-41 catalysts.

Figure 8 shows the TPR profiles for the Rh/SiO₂ and Rh/MCM-41 catalysts. It can be seen that the reduction of rhodium oxide species begins at low temperatures, in agreement with the literature [24,25]. All Rh species seem to be reduced at temperatures below 200 °C. The TPR profile of the Rh/MCM-41 catalyst suggests some metal-support interactions, which widen the reduction peak at higher temperatures. Metal-support interactions are observed in other mesoporous catalysts as well as in traditional catalysts [13,26]. Moreover, after the reduction treatment at 370 °C the surface of the Rh/SiO₂ and Rh/MCM-41 catalysts are composed of a similar proportion of Rh⁰ and Rh³⁺, as is indicated by XPS analysis (Section 2.2.2.).

2.3. Interpretation of the Catalytic Performance of Rh/MCM-41 Compared to Rh/SiO₂

As observed in Figure 1, the product selectivity obtained for the conversion of syngas over Rh/MCM-41 is notably different compared to the product selectivity found over Rh/SiO₂. These differences can be due to the different characteristics of the supports: MCM-41 and SiO₂. It may be that the 1D-channels with small pore diameter of MCM-41, which seem to be retained in Rh/MCM-41 (as suggested from N₂-physisorption, XRD and TEM analyses), could affect the catalytic performance when comparing with a typical SiO_2 support which has large and non-ordered pore diameters. Another characteristic is the metal-support interactions in Rh/MCM-41,

which seems to be absent in Rh/SiO₂ (as suggested from TPR analysis). However, the later characteristic may not be important during the catalytic testing since the final surface composition is similar in both catalysts (as indicated from XPS analysis). The product selectivity could neither have been affected by the Rh particle size because, on the one hand, both catalysts have been pre-reduced at conditions to obtain similar metal dispersion (*i.e.*, similar metal particle size, which is confirmed by TEM images). On the other hand, we cannot relate the slight growth of the Rh particle size in the Rh/SiO₂ catalyst with the increased selectivity to CO_2 (approx. 20%), because, if this would be the case, the selectivity to CO_2 in the Rh/MCM-41 catalyst should be less than 20% since the growth of the Rh particle size is even lower for this catalyst (as shown the TEM images), but its selectivity to CO_2 is above 90%.

It has been suggested that a high concentration of water vapor can be formed in the pores of MCM-41 during catalyst reduction, which could promote metal-support interactions [13,27]. If so, water vapor can also be concentrated in the catalyst pores during catalytic testing, since most of the syngas reactions produce water as a main by-product (reactions 1-4) [7,8]. As a consequence, an environment rich in water vapor can be formed which may induce some reactions, such as the water-gas-shift-reaction (WGSR). WGSR generates extra carbon dioxide and hydrogen (reaction 5). In concordance, more carbon dioxide is produced by Rh/MCM-41 than by Rh/SiO₂ (see Figure 1). Hydrogen was unfortunately not measured due to analytical limitations since hydrogen has similar thermal conductivity to the carrier helium in the GC analysis. However, if we consider the selectivity towards the C_2 -oxygenated compounds (Table 1), the selectivity to the more hydrogenated compounds, i.e., ethanol and acetaldehyde, accounts for 92% over Rh/MCM-41, while it is only 75% over Rh/SiO₂. This may suggest that the extra hydrogen generated from the WGSR over Rh/MCM-41 would facilitate the hydrogenation of acetic acid (or a C2-oxygenated intermediary, perhaps an acetyl intermediate [28]) to acetaldehyde and ethanol.

In accordance with this view, the WGSR should also be promoted over the Rh/SiO₂ catalyst if water were to be concentrated in the catalyst particle. In effect, when water is added to the syngas feed-stream (Figures 2 and 4) the selectivity to CO₂ is enhanced from almost zero to approximately 20%. In the case of the Rh/MCM-41 catalyst, an even higher concentration of water is obtained in the 1-D channel pores, boosting the selectivity to CO₂ (>90%). This means that the WGSR is highly favored in the presence of water, whatever kind of silica support is used, SiO₂ or MCM-41. In the presence of water vapor, all Rh species are in the form of Rh⁰ (as suggested by XPS analysis). Still there is no agreement in the literature on which Rh species (Rh 0 , Rh^{n+}) is more active for the oxygenate formation. Chuang *et al.* [29] suggest that Rh^{0} is less active than the oxidized form. Our results might support this idea since the lowest activities found in both catalysts occurred when both catalysts had 100% Rh⁰. At the same time, as CO₂ is produced by the addition of water in both catalysts, the selectivity to methanol is increased in Rh/SiO₂ (Figure 2). For Rh/MCM-41, although the selectivity to methanol is somewhat reduced by the addition of water, it is not as drastically reduced as the selectivity to the rest of products (Figure 2). Therefore, it seems that the formation of CO₂ and methanol is favored in the presence of water, where the WGSR would play an important role. Indeed, it is generally accepted that the synthesis of methanol from syngas occurs primary via the hydrogenation of CO₂ [30]. This means that the occurrence of the WGSR, as a consequence of the concentration of water vapor in Rh/MCM-41, may contribute to the generation of methanol from CO₂, which may explain the higher selectivity to methanol observed in Rh/MCM-41 compared to Rh/SiO₂ (Figure 1).

Regarding the effect of the hydrogen partial pressure on the selectivity to the C_2 -oxygenated compounds, when it decreases, the selectivity towards acetic acid should increase in both catalysts. It can be observed that when changing the syngas ratio from $H_2/CO = 2/1$ to $H_2/CO = 1/1$ (Table 1), more acetic acid is evidently formed in both catalysts. This may also support the idea that WGSR occurs in Rh/MCM-41 producing extra H_2 , which may facilitate the hydrogenation of acetic acid (or a C_2 -oxygenated intermediary) yielding more acetaldehyde and ethanol than in the typical Rh/SiO₂ catalyst (Table 1). Furthermore, the product distribution between the C_2 -oxygenates in Rh/MCM-41 always keeps the relation according to the extent of oxidation of each compound: ethanol > acetaldehyde > acetic acid (Figures 1–3).

The reaction mechanism for the conversion of syngas to oxygenated compounds over rhodium-based catalyst, is not fully understood [7,8,28]. For example, it is suggested that acetate compounds can be formed by the reaction of CO_2 with surface intermediates such as CH_x^* species [31]. If this reaction occurs over Rh/SiO_2 and Rh/MCM-41, the additional formation of CO_2 via WGSR in Rh/MCM-41 would consume much more CH_x^* species than in Rh/SiO_2 . This means that a lesser number

of CH_x^* species would be available for conversion into hydrocarbon compounds and more acetate compounds should be expected in the Rh/MCM-41 catalyst. This is in accordance with our results, since lower selectivity to hydrocarbon compounds and higher selectivity to acetate compounds are found over Rh/MCM-41 as compared to Rh/SiO₂ (Figure 1). However, we must indicate that the discussion of the elementary steps or reaction mechanism for ethanol formation is not the objective of this work, we rather study the performance of a Rh/MCM-41 catalyst. Studies such as micro-kinetics together with theoretical calculations can be helpful for a fundamental understanding of the reaction mechanism. Very interesting reports on this topic have been published in recent years [32,33]. The inclusion of the WGSR and its effect on the product distribution can be interesting to study and compare with the results obtained in the present work.

From the above discussion, we believe that the differences in activity and selectivity observed for Rh/SiO₂ and Rh/MCM-41 are highly related to the concentration of water vapor in Rh/MCM-41. This is also supported by a previous investigation where high selectivity to CO₂ was found over the mesoporous Rh/MCM-41 catalyst at various levels of syngas conversion as well as at different catalyst reduction temperatures [20] (Figures 4 and 5). The metal-support interactions in Rh/MCM-41 might contribute to the observed differences, but probably to a much lower extent than the effect of water vapor. In summary, the high concentration of water vapor in the pores of Rh/MCM-41 may promote the occurrence of the WGSR, generating extra CO₂ and H₂, which in turn facilitate side reactions changing the product selectivity. Finally, it seems that, as a consequence of the extra hydrogen generated from the WGSR in Rh/MCM-41, more acetaldehyde and/or acetic acid (or a C₂-oxygenated intermediary) is hydrogenated yielding more ethanol than in the typical Rh/SiO₂ catalyst.

3. Experimental Section

3.1. Catalyst Preparation and Characterization Techniques

Hexagonal mesoporous silica (MCM-41) is usually obtained by the "atrane route" [34]. In this method, cetyltrimethylammonium bromide is used as the structural directing agent, and triethanolamine (TEA) is used as a hydrolysis retarding agent. Silatrane complexes are formed between tetraethyl orthosilicate and TEA, as metal precursors of Si. Further preparation procedure has been described elsewhere [34,35]. A commercial MCM-41 from Sigma Aldrich (Sigma Aldrich, St. Louis, MO, USA) was indistinctly used to the MCM-41 obtained from the "atrane route". Silica (SiO₂) catalyst support was purchased from Alfa Aesar (Alfa Aesar, Karlsruhe, Germany). The Rh/MCM-41 and Rh/SiO₂ catalysts were prepared by successive incipient wetness impregnation, using an aqueous solution

of RhCl $_3$ ·nH $_2$ O. After impregnation, the catalysts were dried and then calcined at 500 °C/5 h. The total metal loading was 3 wt. % Rh for both Rh/MCM-41 and Rh/SiO $_2$ catalysts.

Powder X-ray diffraction (XRD) was performed using a Siemens D5000 instrument (Siemens, Karlsruhe, Germany) with Cu K- α radiation ($2\theta = 10^{\circ}$ – 90° , step size = 0.04°) equipped with a Ni filter and operated at 40 kV and 30 mA. N₂-physisorption was carried out using a Micromeritics ASAP 2000 instrument (Micromeritics, Norcross, GA, USA). The Brunauer-Emmett-Teller (BET) method was used to calculate the surface area and the Barrett-Joyner-Halenda (BJH) method was used to calculate the pore size and pore volume from the desorption isotherm. Temperature programmed reduction (TPR) was carried out in a Micromeritics Autochem 2910 instrument (Micromeritics, Norcross, GA, USA), a reducing gas mixture (5% H₂ in Ar) at a flow of 50 mL/min passed through the catalyst sample while the temperature was increased by 5 °C/min up to 900 °C. Transmission electron microscopy (TEM) images were obtained using a JEOL JEM 1400 microscope (JEOL, Tokio, Japan). Samples were mounted on 3 mm holey carbon copper grids. Particle size and distribution were estimated after examination of more than 100 metal particles.

The metal dispersion was measured by H_2 -chemisorption using a Micromeritics ASAP 2020 instrument (Micromeritics, Norcross, GA, USA). Prior to the analysis, the catalyst sample was reduced with hydrogen. After vacuum evacuation, a dynamic mode of hydrogen injection was performed at 40 °C [36]. Repeated analyses were made in order to discriminate between the amount of hydrogen adsorbed via physisorption or chemisorption [37]. The stoichiometry of hydrogen chemisorbed on metallic rhodium was considered to be 1:1. Different degrees of metal dispersion were obtained by changing the reduction temperature and the reduction time. In order to obtain the same metal dispersion, the catalysts were reduced at 370 °C during 1h for Rh/MCM-41 and 6 h for Rh/SiO₂, resulting in H/Rh = 22% in both catalysts.

X-ray photoelectron spectroscopy (SPECS, Berlin, Germany) data were recorded on 4 mm \times 4 mm pellets of 0.5 mm thickness that were obtained by gently pressing the powdered materials, following outgassing to a pressure below 2 \times 10⁻⁸ Torr at 150 °C in the instrument pre-chamber to remove chemisorbed volatile species. The main chamber of a Leybold-Heraeus LHS10 spectrometer was used, capable of operating down of 2 \times 10⁻⁹ Torr, which was equipped with an EA-200MCD hemispherical electron analyzer with a dual X-ray source using AlK α (hv = 1486.6 eV) at 120 W, 30 mA, with C(1s) as energy reference (284.6 eV). The catalyst samples were analyzed as; (i) reduced at the same conditions as in the catalytic testing; (ii) after catalytic testing and; (iii) after catalytic testing with addition of water. The reaction conditions are indicated in Table 2.

3.2. Catalytic Testing

The experiments were carried out in a stainless-steel, down-flow fixed bed reactor. The system components and the on-line gas chromatograph (GC) analysis are similar to those described by Andersson *et al.* [38]. The internal diameter of the reactor was 8.3 mm, in which about 300 mg of catalyst was charged with a particle size between 160 and 250 μ m. Before reaction, the catalysts were reduced following the same procedure as the H₂-chemisorption described above, in order to obtain a metal dispersion of H/Rh = 22%. After reduction, the reactor was cooled to 280 °C and pressurized with syngas up to 20 bar. The gas hourly space velocity (GHSV) was varied between 3000–19,000 mL_{syngas}/g_{cat}. Premixed syngas bottles (AGA Linde) with a H₂/CO ratio of 2:1 and 1:1 were used. The amount of water added to the system was regulated by means of a Gilson 307 pump, then the dosed water was evaporated by an external tape heater at 225 °C and then mixed with the syngas feed-stream.

An on-line GC Agilent 7890A (Agilent, Santa Clara, CA, USA) was used to quantify the reaction products. A detailed description of the GC configuration and the analytical procedure have been published previously by Andersson *et al.* [38]. N₂ added to the syngas mixture was used as internal standard to quantify CH₄, CO and CO₂ in a thermal conductivity detector [39]. The internal normalization of corrected peak areas was used to quantify the hydrocarbon and oxygenated compounds in a flame ionization detector [39]. The expressions used to calculate the syngas conversion, carbon mole selectivity and carbon balance are reported in [38]. In all the experiments the carbon balance was in the range of 99.1%–100%.

Preliminary estimations were carried out to ascertain transport effects on the Rh/MCM-41 catalyst. At the experimental conditions used in this study, intraparticle diffusion limitation might slightly initiate at high syngas conversion (>70% in term of CO conversion), according to Weisz-Prater's criterion [40]. However, a proper estimation of the diffusion limitation would require a careful determination of the morphology of the Rh/MCM-41 catalyst, which is outside the scope of the present study. The Koros-Nowak criterion indicates that the reaction rate, in the kinetic regime, is directly proportional to the concentration of the active material [40]. This means that the turnover frequency (TOF, s^{-1}) must be invariant as the concentration of the active material is changed. An experimental test was carried out at 230 °C, 20 bar and 40,000 mL_{syngas}/ g_{cat} h (H₂/CO = 2/1) using a catalyst sample with a fixed number of active sites (3 wt. % Rh and metal dispersion of H/Rh = 22%). A fraction of this sample was diluted with pure MCM-41 support at a ratio of 1:3, resulting in a catalyst with nominal composition 0.75 wt.% Rh and a metal dispersion of H/Rh = 22%. A minor variation (<10%) was observed between the TOFs of the non-diluted catalyst and the diluted catalyst, suggesting that the reaction operates in the kinetic regime.

4. Conclusions

The catalytic performance of Rh/MCM-41 catalyst has been evaluated for the synthesis of ethanol from syngas and compared with a typical Rh/SiO₂ catalyst. Equal reaction conditions have been applied (280 °C and 20 bar), low syngas conversion (2.8%), the same metal dispersion (H/Rh = 22%) and the same Rh loading (3 wt. %). Under these conditions, different product selectivities have been obtained for Rh/SiO₂ and Rh/MCM-41 catalysts. In order to clarify the obtained results, additional experiments were conducted: addition of water to the syngas feed-stream and lowering of the syngas ratio (H₂/CO). The results from these experiments together with the catalyst characterization, before and after reaction, indicate that the differences in the catalytic performances of Rh/SiO₂ and Rh/MCM-41 can be attributed to a high concentration of water vapor in the pores of Rh/MCM-41, which seem not to occur in Rh/SiO₂. The concentration of water vapor in Rh/MCM-41 could essentially promote the occurrence of the water-gas-shift-reaction (WGSR) which generates some extra carbon dioxide and hydrogen. The extra carbon dioxide and hydrogen could induce side reactions and thus change the product selectivity, as compared with Rh/SiO₂. The extra hydrogen generated from the WGSR in Rh/MCM-41 could possibly facilitate the hydrogenation of acetic acid and/or acetaldehyde (or a C2-oxygenated intermediary) to ethanol, which may be related to the higher selectivity to ethanol observed in Rh/MCM-41 (24%) compared to Rh/SiO₂ (8%).

Influence of Cobalt Precursor on Efficient Production of Commercial Fuels over FTS Co/SiC Catalyst

Abstract: β -SiC-supported cobalt catalysts have been prepared from nitrate, acetate, chloride and citrate salts to study the dependence of Fischer-Tropsch synthesis (FTS) on the type of precursor. Com/SiC catalysts were synthetized by vacuum-assisted impregnation while N₂ adsorption/desorption, XRD, TEM, TPR, O₂ pulses and acid/base titrations were used as characterization techniques. FTS catalytic performance was carried out at 220 °C and 250 °C while keeping constant the pressure (20 bar), space velocity (6000 Ncm 3 /g·h) and syngas composition (H $_2$ /CO:2). The nature of cobalt precursor was found to influence basic behavior, extent of reduction and metallic particle size. For β -SiC-supported catalysts, the use of cobalt nitrate resulted in big Co crystallites, an enhanced degree of reduction and higher basicity compared to acetate, chloride and citrate-based catalysts. Consequently, cobalt nitrate provided a better activity and selectivity to C₅⁺ (less than 10% methane was formed), which was centered in kerosene-diesel fraction ($\alpha = 0.90$). On the contrary, catalyst from cobalt citrate, characterized by the highest viscosity and acidity values, presented a highly dispersed distribution of Co nanoparticles leading to a lower reducibility. Therefore, a lower FTS activity was obtained and chain growth probability was shortened as observed from methane and gasoline-kerosene ($\alpha = 0.76$) production when using cobalt citrate.

1. Introduction

In general, there are several factors that affect the performance of Fischer–Tropsch synthesis (FTS) catalysts: media type, nature of the precursor, nature and quantity of promoters as well as dispersion of the active phase [1–3]. Regarding active metal, the production of commercial fuels from syngas is mostly based on supported Co catalysts. Iglesia et al. established that neither the nature of the support nor the dispersion of Co particles influenced turnover frequency (TOF) of these catalysts, but it was proportional to the concentration of active sites on the surface [4–6]. Johnson et al. [7] agree with the fact that TOF was not affected

by dispersion, although CO conversion seemed to be strongly dependent on Co reducibility. However, Reuel and Bartholomew [8] or Bessell [9] exposed that both low metal–support interactions and high dispersion are required parameters to obtain a really active cobalt based catalyst. Furthermore, catalysts with high surface density favor the formation of n-paraffins of high molecular weight [4], which is desirable to maximize the production of hydrocarbons in the range of diesel fraction. Hence, at a certain Co loading and established catalyst support, the number of active centers would mainly depend on two parameters, dispersion and degree of reduction of cobalt oxide supported particles [5,7]. Key in this regard is the strength of the metal–support interaction, which depends largely on the preparation method [10–12] and nature of metal precursor [12–15].

The methods most commonly employed in the preparation of cobalt nitrate based catalysts are vacuum assisted and incipient wetness impregnation (IWI) [5,9]. However, the use of nitrate often results in a catalyst characterized by large Co particles and therefore, a lesser active surface area [16]. On the other hand, a large particle size would favor chain growth probability and low metal–support interactions and therefore, reducibility would be enhanced. For that reason, several authors [13,14,16,17] have studied the influence of the nature of precursor on particle size showing that the use of different salts other than nitrate (acetate, chloride, carbonyl, citrate, EDTA, etc.) results in particles of different size by changing Co^0 dispersion and hence, metal–support interaction. It has been further shown that the final dispersion of metallic cobalt usually depends on the dispersion of Co_3O_4 in the oxidized precursor [18,19].

 β -SiC is a ceramic material that despite of a low-to-medium surface area, presents potential properties for its use as support in heterogeneous catalytic processes. These include chemical inertness, excellent mechanical strength and thermal conductivity. In this sense, β -SiC has been tested in several highly endo-/exothermic reactions, including Fischer–Tropsch synthesis [20–26]. Its superior thermal conductivity (one hundred times higher than that of SiO₂ [27]) is of practical interest for FTS since allows hindering hot spots inside the reactor, reducing thermal gradients and consequently, improving plant security and selectivity to heavy hydrocarbons. Nature of precursor of nickel or iron [28] supported over SiC has been investigated showing important differences in catalytic activity. Nonetheless, literature related to the nature of Co/SiC is still scarce and more research is required to improve Co/SiC composition for a highly selective FTS catalyst. Then, the present work was conducted to study the dependence of FTS catalytic performance on the nature of Co metal precursors (nitrate, acetate, chloride and citrate) supported on porous β -SiC.

2. Results and Discussion

Results related to the phase and surface composition, extent of reduction and dispersion of cobalt oxide precursor along with the catalytic activity of Com/β -SiC catalysts are presented and discussed. "m" denotes cobalt precursor as N (nitrate), A (acetate), Cl (chloride) and Cit (citrate).

2.1. Thermal Analysis




Figure 1. TG/DTG Co precursors: (a) CoN; (b) CoA; (c) CoCl; and (d) CoCit.

The decomposition of cobalt precursor is a fundamental stage in the preparation of FTS catalyst since the heat released during this step may affect the structure of cobalt species in the final catalyst and consequently, change reducibility and dispersion [29]. Therefore, in order to determine a proper calcination temperature, thermogravimetric analysis (TG/DTG) of the corresponding parent salts were performed (Figure 1).

Nitrate and cobalt acetate are the most common precursors in the preparation of FTS catalysts. From Figure 1a, it can be observed that in case of the nitrate precursor, there is a progressive weight loss between 25 °C and 210 °C attributable to residual water desorption, while the oxidation of the nitrate ligands occurred at 210–260 °C. The decomposition of cobalt acetate proceeded at slightly higher temperatures, being the main weight loss at 285 °C (Figure 1b). However, from Figure 1c, it can be noted that the decomposition of cobalt chloride took place in several stages, losing water from room temperature to 200 °C and producing dechlorination over 500 °C [30]. Figure 1d shows that cobalt citrate decomposed between 212 °C and 307 °C. It is important to mention that these characterization experiments were run until 600 °C since β -SiC support was reported to be stable under oxidant atmosphere up to this temperature [22,31,32].

Considering the above, and taking into account that supported cobalt catalysts are known to need higher reduction temperatures due to the precursor–support interaction (as demonstrated later by TPR analysis, Section 2.4), higher calcination temperatures are required. In this sense, 550 °C has been recently reported as the optimum calcination temperature for FTS on Co/ β -SiC since prevents deactivation by formation Co₂C species. In addition, the resulting metal–support interaction was found to stabilize cobalt particles against sintering [33]. Therefore, 550 °C was selected as a suitable calcination temperature to completely decompose the precursor into Co₃O₄ as well as to ensure the stability of cobalt species supported on porous β -SiC. In agreement, after calcination step, water appeared to be removed and all ligands were decomposed to the corresponding cobalt oxide phase, as confirmed by XRD measurements (Section 2.3).

2.2. Nitrogen Adsorption/Desorption Measurements

Table 1 summarizes textural properties of each oxidized catalyst, estimated from N_2 adsorption–desorption isotherms and BJH method, as described in Section 3.2.3.




Figure 2. (a) N_2 adsorption/desorption isotherms; and (b) average pore size distribution.

N₂ adsorption/desorption isotherms associated to all of these samples (Figure 2a) show as a combination of isotherms II and IV, as referenced by IUPAC designation. Type II corresponded to the beginning of the isotherm and was caused by adsorption of monolayer/multilayer [34]. Type H3 hysteresis loop observed at higher partial pressures fitted type IV isotherm, characteristic of capillary condensation in presence of mesoporous [35], as denoted by pore distribution (Figure 2b).

Moreover, in agreement with isotherms type, pore sizes values shown in Table 1 are within the range of mesopores (2–50 nm) [35]. Particularly, a very similar pore size distribution was found for the four samples, as depicted in Figure 2b, exhibiting a maximum peak ca. 1.9 nm and a second one ca. 8.7 nm, typical of β -SiC support. It should be noted that all samples presented an average Co_3O_4 crystallite size larger than support pore size, as detailed later by means of XRD and TEM imaging, demonstrating that the location of cobalt crystallites on the external surface of β -SiC and not inside its pores may be considered.

From Table 1, it can be also observed that specific surface areas (SA) were similar, $21.5\text{--}34.9~\text{m}^2/\text{g}$, within the measurement error range. Upon impregnation of cobalt solutions over $\beta\text{-SiC}$, a decrease of specific surface area occurred. This effect was significant on CoCl- and CoN-based catalysts, probably resulting from a partial pore overlay by aggregate particles. However, BET surface area diminished in a lesser extent when cobalt acetate was used as precursor. In addition, pore volume was found to increase probably due to a smaller crystallite size and the slight acid nature of this precursor. It seemed that, for a similar cobalt loading, the more acidic the precursor is, the more amount of metal impurities blocking SiC pores would be eliminated while a lower particle size would be deposited on the support surface, increasing SA and porosity. Accordingly, CoCit/SiC presented the highest total pore volume and SA as detected after acid treatment of silicon carbide catalyst surface [22].

2.3. XRD and TEM




Figure 3. XRD patterns of bulk Co_3O_4 , β -SiC support and catalysts Com/SiC.

X-ray diffractograms related to β -SiC support, bulk Co_3O_4 and calcined Com/SiC catalysts under study are presented in Figure 3.

β-SiC support presented characteristic spectra of the two main SiC polytypes, namely α and β . Reflections at 20: 35.5° [111] and 33.7° [0001] are ascribed to hexagonal α -SiC, being the first one (C-SiC) caused by heaping defects generated during the formation of the material [36]. However, those at 20: 41.4° [002], 59.9° [202] and 71.7° [113] are assigned to face-centered cubic, β -SiC [37,38]. As depicted in Figure 3, catalyst preparation procedures were confirmed to result in the formation of a pure cobalt oxide spinel phase, Co₃O₄, regardless of the type of precursor. Different to that reported by Cook et al. [39], no evidence of CoO, whose crystal phase arises at 36.5°, 42.4° and 61.5° (JCPDS 75-0393), was found in our samples. Thus, only crystalline Co₃O₄ and β -SiC were detected after calcination.

According to XRD, average Co_3O_4 size related to each synthetized catalyst, deduced from the Scherrer equation at $20:36.9^\circ$, is listed in Table 1. It was found to increase in the following order: CoCit/SiC < CoA/SiC < CoN/SiC < CoCl/SiC. According to Panpranot et al. [40], cobalt chloride provided the largest particle size and, therefore, the lowest dispersion. It was also noted that, for all samples, particle size was bigger than support pore diameter, which predicts that crystallites

of Co oxide were deposited on the outer surface, rather than in the pores of the β -SiC support.




Figure 4. TEM Images: (a) CoN/SiC; (b) CoA/SiC; (c) CoCl/SiC; and (d) CoCit/SiC.

In order to verify the accuracy of XRD characterization results, several TEM micrographs of all the catalysts were collected. Figure 4 shows some examples of TEM images related to Com/SiC catalysts revealing that Co particles disposition on β -SiC support was well determined by the nature of precursor.




Figure 5. TEM particle size distribution: ■ CoN/SiC; □ CoA/SiC; □ CoCl/SiC; and □ CoCit/SiC.

TEM image of Figure 4a (CoN/SiC) shows several agglomerates (nm) that turned out to form large Co nanoparticles, even bigger than those expected from XRD. Figure 4b presents a better dispersion of cobalt for CoA/SiC with an average Co⁰ particle size of 27 nm, in accordance with XRD data. CoCl/SiC (Figure 5c) displays a broaden size distribution since 15–35 nm crystallites were found to merge into coarse particles. In this case, particle size was proved to be lesser than that of CoN/SiC. In contrast, Figure 4d exhibits a high dispersion of quite fine grains that clumped together in 15–25 nm agglomerates. This also confirms XRD estimation of CoCit/SiC (16–17 nm) crystallite diameter.

Dispersion percentage, D (%), was calculated by assuming spherical cobalt crystallites of uniform diameter (dCo^0) with a site density of 14.6 at/nm², using the formula reported by Jones and Bartholomew [41], i.e.,

$$[dp = 96/D] \tag{1}$$

where dp refers to metallic cobalt particle diameter in nm (i.e., dCo^0). Consistent with TEM micrographs in which small crystallites are observed, the oxide produced from decomposition of Co citrate is shown by XRD to be more highly dispersed than the oxides produced from other Co precursors. Considering that both nature of support and average Co^0 size are known to strongly influence cobalt–support interactions, large crystallites of cobalt-nitrate based catalyst were supposed to result in a weaker interaction $Co-\beta-SiC$. This fact would lead to a high degree of reduction of cobalt species. It is important to remark that cobalt crystallites on $\beta-SiC$ support presented globular form, as observed from TEM images, corroborating the proposed hypotheses on spherical particles.

As displayed in Figure 5 average particle size distribution obeyed the series: CoCit/SiC < CoA/SiC < CoCl/SiC < CoN/SiC. The use of citrate as cobalt precursor

was confirmed to provide the smallest particle size and a most uniform and narrow disposition (15–20 nm). In case of cobalt acetate and cobalt chloride precursors, particle size distribution was wider, specifically centered on 20 to 30 nm and 30 to 50 nm, verifying estimation from XRD. However, size classification provided by cobalt nitrate was much more heterogeneous, exhibiting a distribution mainly based on medium (35–60 nm) crystallites although the formation of large particles (even higher than 130 nm) from crystalline aggregates was also observed. These data are consistent with XRD diffraction peaks broadening and intensity, indicating heterogeneously distributed large cobalt oxide crystallites, and results reported by Martinez et al. [3] on Co/SBA-15, wherein particle size of cobalt nitrate was bigger than those coming from acetate or acetylacetonate that lead to a higher dispersion and a stronger metal–support interaction. Accordingly, the reducibility of CoN/SiC catalyst should be favored and therefore, its catalytic performance [1,5,42].

As evidenced by XRD and TEM, Co particle size distribution on β -SiC support is attributed to the nature of precursor salts. Cobalt citrate, chloride and acetate proved to be much smaller than that of Co-nitrate based catalyst. Terörde et al. [43] reported that both the viscosity of dissolved salts and their interactions with the support surface are critical parameters in the preparation of iron catalysts by impregnation technique. Thus, citrate precursor was shown to result in a smaller particle size of iron oxide than that of the other precursors used in their study, mainly due to its

higher viscosity. Considering this argument, as a result of the drying step, cobalt nitrate crystallizes on β -SiC outer surface, whereas cobalt citrate, which presented a high viscosity, produces a gel that provides well dispersed and scarcely-crystallized species interacting with the support [28].

2.4. Cobalt Oxide Reducibility

Fischer–Tropsch synthesis exclusively proceeds on Co^0 sites. As shown from XRD patterns, Co_3O_4 is the main phase in the prepared catalysts, thus requiring a pretreatment. Despite most of the cobalt is commonly referred to exist as Co^0 phase under reaction conditions, some parameters may hinder reduction step. Co particles would be agglomerated under a high calcination temperature, consequently diminishing the active surface and catalytic performance despite providing a good degree of reduction. On the other hand, small particles frequently lead to a partial degree of reduction [44]. Co particle size and dispersion were found to depend on parent compounds, modifying the corresponding interaction of active sites with the support and therefore, reducibility. Since the degree of reduction of cobalt species seems to play a key role on FTS catalyst activity, the corresponding extent was studied by pulses re-oxidation and TPR techniques.

Figure 6a–e outlines TPR profiles of bulk Co_3O_4 and Com/SiC catalysts, respectively. It is important to mention that a blank test was carried out on fresh β -SiC with no evidence of hydrogen consumption. Hence, TPR peaks can only be attributed to cobalt oxide species reduction.




Figure 6. TPR profiles: (a) Bulk Co₃O₄; (b) CoN/SiC; (c) CoA/SiC; (d) CoCl/SiC; and (e) CoCit/SiC.

It can be seen in Figure 6a that bulk Co_3O_4 was completely reduced to Co^0 at temperatures lower than 350 °C. However, supported cobalt catalysts were expected to show a displacement to higher reduction temperatures. For conventional Co/SiO_2 , which is the most similar catalyst to establish a comparison, four TPR reduction peaks are usually reported and identified as: (i) peak α , assigned to Co_3O_4 to CoO reduction; (ii) peak β , related to successive reduction of CoO to Co, at lower temperatures than $CoSiO_2$ to $CoSiO_2$; and (iv) peak δ , at temperatures higher than $CoSiO_2$ to $CoSiO_2$; and (iv) peak δ , at temperatures higher than $CoSiO_2$ to $CoSiO_3$ to $CoSiO_4$ to $CoSiO_3$ to $CoSiO_4$ to $CoSiO_5$ and (iv) peak δ , at temperatures higher than $CoSiO_4$ to $CoSiO_5$ to $CoSiO_5$ and (iv) peak $CoSiO_5$ to $CoSiO_5$

In Figure 6b,c, it can be observed that TPR-spectra of catalysts CoN/SiC and CoA/SiC consisted of two main reduction peaks. In agreement with Schanke et al. [19] and Rodrigues et al. [47], and as described above, the first maximum of CoN/SiC at 350 $^{\circ}$ C could be attributed to the reduction of Co₃O₄

agglomerates to Co^0 (α and β peaks). The second peak (550–650 °C) was indicative of Co^0 formation from mild-interaction of surface multilayer Co species (CoO_x) [46]. Nevertheless, the presence of immobilized cobalt ions (silicate and hydrosilicates $Co-SiO_x$ species) may not be excluded as revealed by a third small, diffuse maximum between 800 and 850 °C. In the case of catalyst CoA/SiC (Figure 6c), the first maximum of H₂ consumption was observed to be quite lower compared to that of CoN/SiC. Moreover, TPR profile of CoA/SiC was shifted to higher reduction temperatures (420 °C and 720 °C), confirming a lesser degree of reduction due to a stronger interaction between Co species and β-SiC support. This fact would corroborate that catalysts with larger particles are more easily reduced than those with smaller ones, which lead to a higher concentration of hardly reducible cobalt species (silicate-type) [48–50]. TPR profiles associated to CoCl/SiC (Figure 6d) or CoCit/SiC (Figure 6e) resulted to be more complex, showing different Co-species formation upon preparation. Broad maxima indicated the presence of several species reducing at approximately the same temperature, whereas the sharp peaks indicated the existence of a single species. Despite its particle size, a poorer degree of reduction was supposed for catalyst CoCl/SiC compared to CoN/SiC or even CoA/SiC, since its broader profile was found to be widely shifted to higher temperatures. Catalyst CoCit/SiC, presenting the smallest particle size and higher dispersion, also showed a set of overlapped peaks indicating, apart from cobalt oxide reduction (200–450 °C), superposition of mild to strongly immobilized Co species with degrees of different order at temperatures between 500 and 800 °C. Therefore, citrate precursor would provide a diminished degree of reduction to the active phase than that of CoN/SiC.

In order to quantify the reducibility of cobalt oxide precursors, a series of pulse oxidation experiments of reduced samples was developed. The corresponding results, sorted in Table 1, determined that the extent of reduction increased accordingly to: CoCl/SiC~CoCit/SiC < CoA/SiC < CoN/SiC. This trend confirmed that concluded from TPR reduction profiles. It should be mentioned that some authors [51] have found that the degree of reduction may be underestimated for large Co crystallites (10–12 nm) under present pulse oxidation conditions. Titration is then proposed to be conducted at higher O₂ partial pressure (1–2 atm), temperature (450 °C instead of 400 $^{\circ}$ C), and exposure times (longer than 1 h) to completely oxidize Co⁰ to Co₃O₄. In this sense, it should be specified that despite authors have not found evidence of that commented above, large crystallites in this work may subject to the same problem. Therefore, working under suggested conditions may improve the extent of reduction results. In any case, catalyst CoN/SiC would be expected to provide the best FTS catalytic behavior, since it showed a higher extent of reduction. A greater selectivity towards C₅⁺ hydrocarbons would be also favored due to its large particle size that would promote chain growth probability [52]. Conversely, theoretically, acid-based (acetate, citrate and especially chloride) samples showed a

lower re-oxidation performance, which indicated that a higher amount of Co species were anchored to the support, remarkably decreasing their reducibility.

2.5. Acid-Base Titrations




Figure 7. Acid/base titration measurements: Reference; — CoN/SiC; — CoA/SiC; — CoCl/SiC; and — CoCit/SiC.

Finally, since basicity was established to modify C_5^+ hydrocarbon product distribution [52,53], Figure 7 presents the acid-base titration curves of the different catalysts under study.

Titration curves evolved towards higher HCl consumption values as follows: CoCit/SiC < CoA/SiC < CoCl/SiC < CoN/SiC. Table 1 reports surface basicity data, expressed as spent HCl (cm³) per gram of catalyst sample to reach neutral pH level, confirming differences depending on cobalt precursor. As expected, CoN/SiC was the only catalyst that showed certain basicity with respect to acetate, chloride and citrate, which are postulated as acid ligands. Consequently, in addition to a higher extent of reduction and particle size, as basicity was reported to favor chain growth probability [52,54], this catalyst should result in a shift of C_5^+ hydrocarbon product distribution from gasoline towards higher molecular weights valuable products.

2.6. Fischer–Tropsch Synthesis

In order to study the differences on FTS catalytic performance attributed to the nature of cobalt precursor, a series of catalytic tests were carried out over those synthetized catalysts whose physicochemical characteristics were found to be more diverse, i.e., CoN/SiC and CoCit/SiC. Table 2 collects steady state performance parameters.

Nature of precursor was observed to significantly modify CO conversion and selectivity to C_5 ⁺ hydrocarbons, improving both of them when cobalt nitrate-based catalyst was used. Despite providing a higher CO conversion in the selected range of temperature, CoCit/SiC exhibited a lower catalytic activity when referred to FTS rate. Moreover, this catalyst favored the production of light hydrocarbons (mainly CH₄) and CO₂, compared to CoN/SiC. According to several authors [3,8] and in agreement with characterization results, the increased selectivity to methane can be due to the formation of well dispersed and hardly reducible compounds, which could also catalyze Water Gas Shift reaction, as observed from the increase of CO₂ formation. CoCit/SiC, with a significant acidity, registered a strong Co-β-SiC interaction and deducible low reducibility, then providing low FTS activity. Zhang et al. [55] found that the presence of a relevant amount of acid sites enhanced cobalt-support interactions leading to a lower degree of reduction and a poorer catalytic activity. The chelating ligand facilitated the formation of coordinate species, where Co²⁺ is fixed on the support surface and cobalt-silicate compounds hindered FTS activity. Compared with Co-citrate, CoN/SiC presented Co nanocrystallites whose size, higher than those from the citrate precursor, provided a compromise between an enhanced extent of reduction and a suitable density of active sites, thus improving the performance for FT synthesis. A lower CO conversion was observed at 220 °C for this catalyst, which may occurred due to support pore filling with HC products. It can be seen that, at this temperature, a high selectivity toward C₅⁺ hydrocarbons is pointed out and hence, further CO hydrogenation could be prevented by blockage of the active cobalt sites. It is worth it to mention that, under the fixed operating condition, CoN/SiC did not result in CO₂ formation and produced less than 10% of methane, the main FTS side reaction. Moreover, an increase in the reaction temperature was found to only enhance catalytic activity, whereas selectivity to C_5^+ was barely modified when using this catalyst under the fixed range. It should be mentioned that no evidence of catalytic performance deactivation or carbon deposition was found for at least 24 h of reaction, indicating that metal sintering or Boudouard reaction were prevented, probably due to the relatively moderate interaction of Co nanoparticles with β -SiC support, as recently reported by Koo et al. [56].




Figure 8. C_5^+ hydrocarbon product distribution: \square CoCit/SiC; and \square CoN/SiC. Reaction conditions: 20 bar; 250 °C; 6000 Ncm³/g·h; H₂/CO: 2.

Regarding FTS selectivity to C_5^+ , Table 3 and Figure 8 detailed liquid hydrocarbon product distribution obtained for each catalyst at 250 °C.

FTS selectivity is known to depend on cobalt particle size [1] and basicity [53]. Accordingly, the distribution of C_5^+ hydrocarbons was also modified by the nature of the precursor. Larger cobalt particles are more selective for higher molecular weight hydrocarbons in FTS reaction because of dissociative adsorption of CO, which leads to the formation of -CH₂- required for chain growth. Basicity was also reported to promote chain growth [52,53,57]. It can be observed that catalyst CoCit/SiC, with the smallest particle size and the highest acidity, enhanced the production of gasoline fraction while catalyst CoN/SiC mainly shifted C_5^+ distribution towards the production of kerosene and diesel. It is important to note that although in a lesser extent, the latter reached a diesel yield twice (17%) than that of CoCit/SiC (6%). In agreement, alpha value (α) was set to 0.90 instead of 0.76. Therefore, cobalt nitrate was demonstrated to be the most suitable precursor for the production of synthetic diesel via Fischer–Tropsch synthesis over β -SiC-based catalyst.

3. Experimental Section

3.1. Synthesis of Com/SiC Catalyst

Extrudates of porous β -SiC (1 mm diameter and length, SICAT Catalyst) were used as catalytic support in this study. Medium specific surface area (35 m²/g) β -SiC was successively vacuum-assisted impregnated with aqueous solutions of: (a) cobalt nitrate (CoN) [Co(NO₃)₂·6H₂O] (Merck KGaA, Darmstadt, Germany); (b) cobalt chloride (CoCl) [CoCl₂.6H₂O] (Panreac Química S.A.U., Barcelona, Spain) or (c) cobalt acetate (CoA) [C₄H₆CoO₄.4H₂O] (Panreac Química S.A.U., Barcelona,

Spain), in order to prepare a final catalyst with nominal 10 wt % Co loading. β-SiC was precalcined in a SELECTA muffle furnace (224129 model), under static air atmosphere at 550 °C (at a rate of 5 °C/min from ambient temperature) for 6 h before impregnation. Since pore volume of β -silicon carbide support is quite low, synthesis procedure was not based on incipient wetness impregnation technique. In order to obtain the specified Co content, usually, 15 g of β-SiC support were repeatedly impregnated (with intermediate drying) with aqueous solutions comprising the minimum amount of deionized water to dissolve 6.7-8.2 g of cobalt chloride, cobalt acetate or cobalt nitrate. Cobalt concentrations were determined from precursor weight change. After impregnation, the as-prepared mixture was dried in a SELECTA oven (240099 model) under static air atmosphere at 120 °C for 12 h. In addition, another 10 wt % cobalt-based catalyst was prepared by the citrate method as described elsewhere [58]. Cobalt nitrate was dissolved in an appropriate volume of deionized water to give a 0.1 M solution and then, citric acid $[C_6H_8O_7]$ (Panreac Química S.A.U., Barcelona, Spain) was added in 5 wt % excess to guarantee entire complexation. Water was removed at 40 °C, under vacuum, to form a gel that was subsequently dried overnight at 70 °C. The resulting precursor presented a highly hygroscopic nature.

After impregnation and drying steps, all samples were calcined, in the same muffle furnace described above, at 550 °C for 6 h (5 °C/min heating rate) under static air atmosphere, to transform chloride, nitrate, acetate and citrate-ligands into the oxidized phase and then reduced to the $\rm Co^0$ (Sections 2.4 and 3.3). Each catalyst was denoted as $\rm Co\it m/SiC$ where $\it m$ refers to the cobalt precursor. Physicochemical properties of synthetized $\rm Co\it m/SiC$ are shown in Table 1.

3.2. Catalyst Characterization

3.2.1. Thermal Analysis (TG/DTG)

Thermal analysis over bulk salt precursors (7–12 mg) was conducted in a METTLER TOLEDO model TGA-DSC 1 STAR_e SYSTEM (Mettler-Toledo AG, Schwerzenbach, Switzerland), under oxidant atmosphere. TG/DTG curves were registered from room temperature to 600 °C (5 °C/min heating rate), with an experimental error of $\pm 0.5\%$ in the weight loss measurement and ± 2 °C in the temperature measurement.

3.2.2. Atomic Absorption (AA)

The final composition, referred to as wt % Co of calcined catalysts, was determined in a SPECTRAA 220FS (Varian Australia Pty Ltd., Mulgrave, Victoria, Australia), comprising a simple beam and background correction ($\pm 1\%$ error). The samples were dissolved in HF before analysis.

3.2.3. Textural Characteristics

A Micromeritics ASAP 2010 sorptometer (Micromeritics, Norcross, GA, USA) was employed to measure porosity and surface area, with an error of $\pm 3\%$. Catalysts were outgassed under vacuum at 433 K for 16 h before measurement. Total specific surface areas were estimated by the multi-point Brunauer-Emmett-Teller (BET) [59] method using liquid N₂ (77 K) as sorbate, while pore size distributions were determined using Barrett–Joyner–Halenda (BJH) method [60].

3.2.4. X-ray Powder Diffraction

XRD spectra were collected using a Philips model X'Pert MPD (Philips, Eindhoven, the Netherlands) with Co-filtered Cu K α radiation (λ = 1.54056 Å). Patterns were recorded from 2θ = 3° to 90° with 0.04° step using a 0.4 s acquisition time per step. Crystalline phase's identification after drying and calcination steps was made by comparison to Joint Committee on Powder Diffraction Standards. Co_3O_4 average particle size (dCo_3O_4 , nm) was estimated by Scherrer's equation at $20:36.9^{\circ}$ [61,62]. Then, metallic Co crystallite size (dCo^0 , nm) was estimated by Equation (2) [63]:

3.2.5. Transmission Electron Microscopy

Morphology and structure of the catalysts were characterized by a JEOL 2100 Transmission electron microscope (JEOL USA, Inc.), operated at 200 kV with a resolution of 0.194 nm. The catalysts were reduced ex situ under the same conditions as for FTS testing and then cooled to room temperature and passivated with low oxygen containing mixture (1 vol %) before performing the TEM analysis. Both Co dispersion and diameter distribution were calculated by counting a minimum of 400 particles. Average surface Co particle diameter was evaluated according to Equation (3) [64,65]:

where n_i refers to the number of particles with diameter d_i . The standard deviation (σ) of the obtained particle diameter was calculated with the following formula (Equation (4)):

where $\overline{\boldsymbol{d}}$ is the mean Co particle diameter and \boldsymbol{n} the total number of particles.

3.2.6. Temperature Programmed Reduction

Reducibility of Co₃O₄ particles was examined by TPR experiments performed in an Autochem HP 2950 analyzer (Micromeritics, Norcross, GA, USA). Calcined samples were firstly outgassed under flowing argon at 250 °C (10 °C/min heating rate) for 30 min. TPR was then performed using Ar forming gas with 17 v/v % H₂ as reductant (50 mL/min). Data of temperature and detector signal was monitored from room temperature to 900 °C (5 °C/min heating rate). TPR profiles were consistent, standard deviations for the temperature of the peak maxima being ± 2 %.

3.2.7. O₂ Pulse

Degree of reduction was calculated in an Autochem HP 2950 (Micromeritics, Norcross, GA, USA) by oxygen titration of reduced samples ($\pm 2\%$ average error). After reduction at the same conditions fixed for FTS testing [550 °C (5 °C/min heating rate) for 2 h under pure H₂ (\geqslant 99.9990%) flow], the flow was switched to helium for 1 h to desorb any chemisorbed H₂. Then, O₂ was injected at 400 °C, by means of calibrated pulses in helium carrier, until complete saturation of the catalyst surface (no further O₂ is detected to react with the sample by the TCD) [66]. Calculation of dispersion was based assuming that the H/Co stoichiometric ratio was 1/1 [19], while for the degree of reduction, stoichiometric re-oxidation of Co⁰ to Co₃O₄ [67,68] was supposed.

3.2.8. Titrations

A Metrohm 686 apparatus (Metrohm Ltd., Herisau, Switzerland) was used to conduct acid/base titrations. 25 mg of catalyst were dissolved in 50 cm 3 of a NaCl solution (0.1 M, also used as a reference) and basified to pH = 10.3 (0.1 M NaOH). Then, titrant (0.1 M HCl) was dosed by an automatic Dosimat 665 at a rate of 3 cm 3 /h under constant stirring and N_2 atmosphere.

3.3. Activity Test

FTS experiments were conducted in a bench scale, fully automated facility, under a pressure of 20 bar, as described elsewhere [24]. Typically, 5 g of catalyst dispersed on inert α -SiC (in a 1:4 wt. ratio in order to minimize temperature gradients) were charged into the reactor (1 m length and 1.77 cm internal diameter, comprising a volume of 0.24 L, made of Inconel 600). The catalyst was firstly pretreated by reduction in pure H₂ (\geqslant 99.999%) flow (1.5 NL/min) at 550 °C (5 °C/min heating rate) under atmospheric pressure for 2 h. Then, temperature was decreased to the required reaction temperature under flowing N₂ while pressure was set on 20 bars. FTS catalytic performance was then studied at 220 °C, 235 °C and 250 °C, a gas space velocity of 6000 Ncm³/g·h and a molar ratio H₂/CO of 1.8 (considering a previous

Water Gas Shift stage). Temperature was checked (with an error of ± 0.5 °C) in the bed of catalyst and along the whole tube through a series of thermocouples disposed to control temperature gradients in the fixed-bed reactor. The feed gas consisted of highly pure N_2 (10 vol %), CO (60 vol %), and H_2 (30 vol %), being N_2 the internal standard used to ensure an accurate carbon balance. Downstream, a Peltier cell was located prior to the analysis system in order to separate non-condensate water and to avoid overpressure on the input of the chromatographic unit. Light hydrocarbons and unreacted reactants were analyzed online every 90 min, using a CP-4900 Varian microgas chromatograph equipped with: (a) a Molsieve 5A capillary column (H₂, N₂, CH₄ and CO); and (b) a Pora Pack Q capillary column (CO₂, ethane and propane). C₅⁺ hydrocarbons, collected for 8–12 h to ensure reaching the steady state, were extracted with n-hexane from liquid products stream. After this step, organic phase was analyzed offline in a gas chromatograph equipped with a FID detector and an ultrafast capillary column, supplied by Thermo Fisher Scientific. Hydrocarbon selectivity was estimated as reported elsewhere [23]. Three replicate experiments were randomized conducted in order to avoid systematic errors while quantifying reproducibility of each precursor system. Confidence interval was calculated from experimental data by means of the Student test (t-test, 95% confidence level), and the corresponding standard deviation measurement.

4. Conclusions

This work explored the dependence of FTS catalytic performance on cobalt precursor supported on β -SiC. The use of different parent cobalt compounds significantly modified physicochemical characteristics of Com/SiC catalyst and, therefore, their FTS catalytic performance. There was an increase in the basicity of the catalyst in the following order: CoCit/SiC < CoA/SiC < CoCl/SiC < CoN/SiC. The same trend was found for the average Co particle size, although a wide distribution was found for CoCl/SiC and CoN/SiC, affecting the extent of reduction. Consequently, FTS activity and chain growth probability were found to depend on the nature of the precursor used for the preparation of Com/SiC catalysts. The use of an organic compound such as cobalt citrate resulted in a significant increase of dispersion, exhibiting a homogeneous disposition of small cobalt crystallites on β-SiC compared with those from CoN/SiC. Consequently, citrate-based catalyst provided a lower FTS rate and an enhanced selectivity to CO₂ and C₁–C₄ fraction. Moreover, cobalt citrate also led to a C₅⁺ product distribution centered on gasoline fraction ($\alpha = 0.76$). Nevertheless, cobalt nitrate, related to the highest particle size, degree of reduction and basicity, resulted in a better FTS activity with a low formation of CH₄, shifting the production of C₅⁺ hydrocarbons towards kerosene-diesel fraction (0.90), with diesel yield twice that produced by CoCit/SiC.

Gold-Iron Oxide Catalyst for CO Oxidation: Effect of Support Structure

Abstract: Gold-iron oxide (Au/FeO_x) is one of the highly active catalysts for CO oxidation, and is also a typical system for the study of the chemistry of gold catalysis. In this work, two different types of iron oxide supports, *i.e.*, hydroxylated (Fe_OH) and dehydrated iron oxide (Fe_O), have been used for the deposition of gold via a deposition-precipitation (DP) method. The structure of iron oxide has been tuned by either selecting precipitated pH of 6.7–11.2 for Fe_OH or changing calcination temperature of from 200 to 600 °C for Fe_O. Then, 1 wt. % Au catalysts on these iron oxide supports were measured for low-temperature CO oxidation reaction. Both fresh and used samples have been characterized by multiple techniques including transmission electron microscopy (TEM) and high-resolution TEM (HRTEM), X-ray diffraction (XRD), X-ray photoelectron spectroscopy (XPS), X-ray absorption near edge structure (XANES) and temperature-programmed reduction by hydrogen (H₂-TPR). It has been demonstrated that the surface properties of the iron oxide support, as well as the metal-support interaction, plays crucial roles on the performance of Au/FeO_x catalysts in CO oxidation.

1. Introduction

Since the 1990s, nanosized gold interacting with oxide supports have been reported to be active for diverse redox reactions, among those low temperature oxidation of carbon monoxide is the most studied [1–3]. Such unique catalytic properties were found to be strongly dependent on electronic structure and local coordination environment of Au atoms. During the last two decades, different reducible metal oxides such as titanium oxide (TiO_2) [4], cerium oxide (CeO_x) [5,6] and iron oxide (FeO_x) [7] have been proven to be active supports for deposition of gold. Although a full mechanism of this catalytic process still needs to be established, careful studies on strong metal-support interaction by the aid of various characterization techniques may provide further mechanistic insight [8–11]. For instance, Hutchings group reported that the delayered Au structure that was determined by high-angle annular dark-field scanning transmission electron microscopy (HAADF-STEM) characterization plays crucial roles in the CO oxidation reaction [8].

As one of the important functional materials, iron oxide (FeO_x) has been extensively investigated in heterogeneous catalysis for its potential applications in CO oxidation [12,13], water-gas shift [14-17] and preferential oxidation of CO reaction [18–20]. The general FeO_x supports include two different types: hydrated (Fe_OH), such as goethite or lepidocrocite FeOOH, and dehydrated (Fe_O), such as hematite α -Fe₂O₃, maghemite γ -Fe₂O₃ or magnetite Fe₃O₄. These complexities in composition and crystal periodicity provide rich structural models for gold deposition. On the other hand, various synthetic approaches, including so-gel method [21,22], hydrothermal method [23,24] and precipitation method [10,25], have been applied to control the size and shape of the iron oxide itself, aiming to delicately tune the interaction between metal and oxide matrix, as well as the local structure of active metals. Among them, the precipitation method is simple and easy to operate. It can easily control the synthesis parameters and achieve larger surface area. Furthermore, the precipitating conditions of Fe²⁺ or Fe³⁺ precursor has been identified as one of the key factors governing the structure and texture of the FeO_x products. Focusing on synthesis, the final pH value of the stock solution and the calcination temperature of the as-dried materials, which have not been widely studied so far [26,27], could be very important parameters for the preparation of high-quality iron oxide support.

Different techniques, including X-ray diffraction (XRD) [25], X-ray absorption fine structure (XAFS) [16], X-ray photoelectron spectroscopy (XPS) [16] and transmission electron microscopy (TEM) [28], have been used to characterize both bulk and surface structure of gold-iron oxide catalysts and further study the related active site for the low-temperature CO oxidation. Due to the complicated crystal and local structures in bulk and microdomain, the combination of multiple characterization skills, rather than a single means, is extremely important to obtain the real structural information.

Therefore, in the present work, we try to broadly explore the relationship between the nature of the oxide matrix and the catalytic reactivity of Au/FeO_x via deposition-precipitation with two series of iron oxides, namely hydrated (Fe_OH) and dehydrated (Fe_O) supports, to fully investigate the importance of preparation parameters such as precipitating pH values and calcination temperature in synthesis of FeO_x , and to deeply study the "structure-activity" relationship in Au/FeO_x system for the low-temperature CO oxidation reaction.

2. Results and Discussion

2.1. Structure and Texture of Gold-Iron Oxide Catalyst

The inductively coupled plasma atomic emission spectroscopy (ICP-AES) characterization was conducted to identify the gold loadings in both Fe_OH and

Fe_O supports. Table 1 shows that the experimental bulk Au concentrations (Au_{bulk}) in all the measured samples are in good agreement with the target value (0.54 at. %), revealing no gold loss in DP synthesis. The BET specific surface areas (S_{BET}) of the fresh Au/FeO_x catalysts are summarized in Table 1. Since the hydrated iron oxide (Fe_OH) supports were uncalcined, the corresponding S_{BET} values for Au/Fe_OH (151–212 m²/g) are distinctly higher than those for Au/Fe_O (27–136 m²/g), in which the dehydrated iron oxide (Fe_O) supports were calcined at different temperatures in the range of 200–600 °C. For Au/Fe_OH series, the S_{BET} number decreases with the increase of precipitating pH value of Fe_OH from 6.7 to 11.2, possibly indicating better crystallinity of iron oxide support with more hydroxyls used in preparation. For Au/Fe_O series, the S_{BET} number decreases with the increase of calcination temperature of Fe_O from 200 to 600 °C, giving hints on the elimination of surface OH groups during the heat-treatment process. Thus, the textural properties of iron oxide supports, as well as the final Au/FeO_x catalysts, are strongly dependent by the synthetic parameters used in experiments.




Figure 1. XRD patterns of fresh Au/FeO_x catalysts: (a) Au/Fe_OH and (b) Au/Fe_O .

XRD was carried out to determine the crystal structure of the fresh Au/FeO_x catalysts. Figure 1a displays an amorphous phase for $Au/Fe_OH_6.7$ and $Au/Fe_OH_8.2$, or partially crystallized structure of $Au/Fe_OH_9.7$ and $Au/Fe_OH_11.2$ with further increasing on the applied pH value. The corresponding crystal phase is hematite α -Fe $_2O_3$ (JCPDS card No: 2-919), consistent with previous reports on gold-iron oxide catalysts [28]. Comparable to the above characterization results on surface area, the precipitating pH significantly affected the crystallinity of Fe $_2OH$ support, and further modified the structural properties of Au/Fe_OH catalyst. Figure 1b exhibits that the crystallinity of Au/Fe_O was clearly enhanced by applying higher calcination temperature on Fe $_2OH$ 0 support, while the crystal phase was kept as hematite α -Fe $_2O_3$. We also noticed that all measured samples were fully crystallized if the iron oxide support was calcined above 200 $_2OH$ 0, which is in good agreement with the previous findings [28]. However, no Au diffraction peaks can be identified in Figure 1 due to the presence of gold in the form of amorphous or the low Au concentrations ($_2OH$ 0.54 at. %).





Figure 2. TEM images of fresh Au/FeO_x catalysts: (a) $Au/Fe_OH_11.2$; (b) $Au/Fe_OH_9.7$; (c) $Au/Fe_OH_8.2$; (d) $Au/Fe_OH_6.7$; (e) Au/Fe_O_600 ; (f) Au/Fe_O_500 ; (g) Au/Fe_O_400 ; (h) Au/Fe_O_300 ; and (i) Au/Fe_OH_200 .

TEM was conducted to identify the morphology of fresh Au/FeO_x catalysts, *i.e.*, the size and shape for gold or iron oxide support. No Au nanoparticles have been observed in all the pictures in Figure 2, confirming that gold was still in the form of atoms or ultra-fine (<2 nm) clusters for the as-dried (60 °C) samples. This was also in good agreement with our previous results on Au/FeO_x [28]. For the iron oxide support, it can be seen from the TEM images that small-size (<5 nm) aggregates were observed for amorphous Fe_OH, Au/Fe_OH_6.7 (Figure 2d), Au/Fe_OH_8.2 (Figure 2c) and Au/Fe_O_200 (Figure 2i); big-size particles (10–50 nm) were identified for fully crystallized Au/Fe_O_600 (Figure 2e), Au/Fe_O_500 (Figure 2f), Au/Fe_O_400 (Figure 2g) and Au/Fe_O_300 (Figure 2h); and a mixture of small

aggregates and big particles was confirmed for partially crystallized Au/Fe_OH_11.2 (Figure 2a) and Au/Fe_OH_9.7 (Figure 2b). These results were well consistent with the related XRD data.






Figure 3. TEM images of used Au/FeO $_x$ catalysts: (a) Au/Fe_OH_11.2; (b) Au/Fe_OH_9.7; (c) Au/Fe_OH_8.2; (d) Au/Fe_OH_6.7; (e) Au/Fe_O_600; (f) Au/Fe_O_500; (g) Au/Fe_O_400; (h) Au/Fe_O_300; and (i) Au/Fe_O_200.








Figure 4. HRTEM images (**a**–**d**) of Au/FeO_x catalysts: (**a**) Au/Fe_O_300, fresh; (**b**) Au/Fe_O_200, fresh; (**c**) Au/Fe_O_300, used; and (**d**) Au/Fe_O_200 used.

For the used catalysts, we found from Figure 3 that the morphologies of iron oxide supports were maintained for all the tested samples under the mild reaction conditions (up to 300 $^{\circ}$ C and less than 1.5 h). Gold particles with size of ca. 2 nm can be identified for gold on the fully crystallized Fe_O supports (Figure 3e–h). However, gold species cannot be distinguished clearly in Au/Fe_OH catalysts due to the amorphous state of Fe_OH particles, so the structure of gold in Au/Fe_OH is to be investigated using other techniques such as XPS and XAFS (these will be mentioned

later). HRTEM was used to determine the crystallinity of iron oxide supports. Figure 4a–d exhibits the highly crystallized nature of Fe_O for Au/Fe_O_300 and Au/Fe_O_200, either fresh or used in CO oxidation.

2.2. Catalytic Performance and Reducibility of Gold-Iron Oxide Catalyst

The catalytic performance of the Au/FeO_x catalysts was evaluated for the low-temperature CO oxidation. The transient profiles in Figure 5a reveal a lower "light off" temperature or a higher activity for gold on hydrated iron oxide support synthesized with an increasing pH value. The 90% CO conversion temperature (T_{90}) was 62 °C for Au/Fe_OH_6.7, while it was 25 °C for Au/Fe_OH_11.2. The corresponding "steady-state" experiments in Figure 5c confirmed that the long-term CO conversions at 30 °C after 6 h were stabilized at 53%, 41%, 20% and 11% for the Fe_OH precipitating pH value of 11.2, 9.7, 8.2 and 6.7, respectively. All of the above demonstrate the following sequence of catalytic reactivity on Au/Fe_OH for the CO oxidation reaction: $Au/Fe_OH_11.2 > Au/Fe_OH_9.7 > Au/Fe_OH_8.2 >$ $Au/Fe_OH_6.7$. In our previous work, pH = 8.2 was applied to prepare $Fe_OH[28]$, which was based on reported synthesis [8,12]. It is noticed that the long-term stability of Au/Fe_OH_8.2 in final CO conversion was lower than that reported previously [28]. We repeated the catalytic tests at 30 °C several times and found that the deactivation behavior varied with the testing periods. Thus, we selected the catalytic data collected during the same periods between different gold-iron samples. The current results shown in Figure 5 justifies the optimized pH value is 11.2 for the hydrated iron oxide support, and thus the catalytic reactivity can be enhanced by tuning the precipitation pH values in the synthesis of Fe_OH supports.

For gold on dehydrated iron oxide support, the related CO oxidation transient profiles are shown in Figure 5b. Here, we need to control the CO conversion at the modest level and select the pH value of 8.2 for the preparation of initial Fe_OH. This can effectively avoid the too small differences on the reactivity of CO oxidation when we investigate the effect of calcination temperature towards the Fe_O support. Clearly, Au/Fe_O_300 was superior to Au/Fe_O_200, displaying distinct lower T_{90} $(20 \,^{\circ}\text{C} \text{ vs. } 85 \,^{\circ}\text{C})$. Au/Fe_O_400 was almost identical to Au/Fe_O_300, while the reactivity of Au/Fe_O_500 and Au/Fe_O_600 dropped quickly with higher T₉₀ of $35\,^{\circ}\text{C}$ and $103\,^{\circ}\text{C}$, respectively. The long-term "steady-state" experiments in Figure 5d verify a similar trend for Au/Fe_O series. At a constant temperature of 30 °C, the stabilized CO conversions after 6–10 h on stream were 85%, 70%, 40%, 32% and 20% for the Fe_O calcination temperature of 300, 400, 500, 600 and 200 °C, respectively. All of the above demonstrate the following sequence of catalytic reactivity on Au/Fe_O for the CO oxidation reaction: Au/Fe_O_300 > Au/Fe_O_400 > Au/Fe_O_500 > Au/Fe_O_600 > Au/Fe_O_200. Previously, air-calcination at 400 °C was chosen to obtain the Fe_O support [28] which is also the optimized parameter according to our present work.




Figure 5. CO conversions of fresh Au/FeO_x catalysts for the low-temperature CO oxidation reaction: (a) Au/Fe_OH, transient; (b) Au/Fe_O, transient; (c) Au/Fe_OH, stability at 30 °C; and (d) Au/Fe_O, stability at 30 °C. Reaction conditions: 1% CO/20% $O_2/79\%$ N_2 , 80,000 mL· $h^{-1} \cdot g_{cat}^{-1}$.




Figure 6. H₂-TPR profiles of fresh Au/FeO_x catalysts: (**a**) Fe_OH; (**b**) Au/Fe_OH; (**c**) Fe_O; and (**d**) Au/Fe_O.

To correlate the catalytic reactivity of CO oxidation with the structure of gold-iron oxide, we carried out the H_2 -TPR tests on both fresh Au/Fe_OH or Au/Fe_O catalysts and the corresponding Fe_OH or Fe_O supports. For the Au/Fe_OH series, the reduction of Fe_OH supports (Figure 6a) can be divided into two parts. The low-temperature reduction peaks between 180–220 °C and 350–400 °C can be attributed to the transformation of Fe_OH \rightarrow Fe₃O₄ (first Fe_OH \rightarrow Fe₂O₃ and then Fe₂O₃ \rightarrow Fe₃O₄) [29], and the hydrogen consumption amount as shown in Table 2 clearly decreased from Fe_OH_6.7 to Fe_OH_11.2, probably due to less surface hydroxyls for the high precipitating pH value. The onset of high-temperature reduction peak, assigned to the conversion of Fe₃O₄ \rightarrow FeO or Fe [29], was located at 350–400 °C.

By the introduction of gold, Figure 6b exhibits that the reduction of $Fe_3O_4 \rightarrow FeO$ or Fe was almost maintained. However, the reduction of $Fe_2OH \rightarrow Fe_3O_4$ was significantly shifted to lower temperature range of 30-230 °C, and included a broad peak around 30-180 °C ($Fe_2OH \rightarrow Fe_2O_3$) and a sharp reduction centered at 195-214 °C ($Fe_2O_3 \rightarrow Fe_3O_4$). This shift originated from the Au activation [30], or the strong interaction between gold and iron oxide support delivered by the structure of Au-OH-Fe or Au-O-Fe [31]. It can also be seen from Figure 6b that the transformation of $Fe_2OH \rightarrow Fe_2O_3$ (Au-OH-Fe) was kept the same, while the conversion of $Fe_2O_3 \rightarrow Fe_3O_4$ (Au-O-Fe) was distinctly promoted with the increasing pH value in Fe_2OH synthesis. This reveals a much stronger Au-O-Fe interaction in $Au/Fe_2OH_11.2$ than in $Au/Fe_2OH_6.7$, which could account for its better catalytic performance on the CO oxidation reaction.

Similarly, for the Au/Fe_O series, the reduction of Fe_O supports (Figure 6c) can be divided into two parts. The low-temperature reduction peaks between 200-300 °C and 350-400 °C can be attributed to the transformation of Fe_O (or Fe₂O₃)→Fe₃O₄ [30,32], while the onset of high-temperature reduction peak, assigned to the conversion of Fe₃O₄ \rightarrow FeO or Fe [32], was located at 350–400 $^{\circ}$ C. Again, by the gold doping, Figure 6d exhibits that the reduction of Fe₃O₄→FeO or Fe was kept the same, but the reduction of Fe₂O₃→Fe₃O₄ was obviously shifted to lower temperatures below 270 °C, possibly due to the presence of Au–O–Fe interaction [31]. This reduction temperature was increased with the calcination temperature of iron oxide support from 200 to 600 °C. The corresponding hydrogen consumption amount (Table 2) was raised from Au/Fe_200 to Au/Fe_400 and remained constant if the calcination temperature was further higher (400-600 °C). It hints that the strong interaction of Au-O-Fe reached a spike at Au/Fe_400. Besides, a minor peak below 170 °C can be identified for the transformation of Fe_OH \rightarrow Fe₂O₃ for Au/Fe_200, Au/Fe_300 and Au/Fe_400, while it disappeared for Au/Fe_500 and Au/Fe_600 since the higher calcination temperature on Fe_O can effectively remove the surface hydroxyls.

2.3. Effect of Iron Oxide Support

Previously, we utilized *in-situ* XAFS and XRD techniques to investigate the gold-iron oxide catalysts obtained by deposition-precipitation, and reported that metal–support interaction (Au–O–Fe) is key factor to govern the CO oxidation reactivity of Au/FeO_x [28]. In this work, we focused on the effect of iron oxide support and optimized the synthetic parameters for the Fe_OH and Fe_O preparation. To further study the reaction mechanism in Au-Fe-O system, we selected four typical samples to reveal the "structure–activity" relationship by different characterization methods. Two of them were gold on hydrated iron oxide (Au/Fe_OH) with higher (Au/Fe_OH_11.2) and lower reactivity (Au/Fe_OH_6.7); another two were gold on dehydrated iron oxide (Au/Fe_O) with higher (Au/Fe_O_300) and lower reactivity (Au/Fe_200).

In Section 2.1, using TEM/HRTEM, we found that ~2 nm Au particles formed during the CO oxidation reaction, whether on Fe_OH (see Figure 4a,b) or on Fe_O (see Figure 4c,d). Since no such gold structure has been detected for the corresponding fresh samples, the transformation of Au species under the reaction conditions is crucial to the explanation for the different reactivity of the Au/FeO $_x$ catalysts. In Section 2.2, using H2-TPR, the strong interaction between metal (Au) and support (Fe_OH or Fe_O) has been demonstrated for the structural evolution of Fe_OH \rightarrow Fe₃O₄ and Fe₂O₃ \rightarrow Fe₃O₄, respectively. This could be the main reason for the origin of high activity for Au/Fe_OH_11.2 and Au/Fe_O_300. However, the information on gold chemistry, especially oxidation state and short-range local structure around Au, in the active Au/FeO $_x$ catalysts is still unknown.

XPS was conducted to determine the surface Au concentrations (Au_{surf}), and the related analysis results have been included in Table 1. Most of the Au_{surf} values in the gold-iron oxide catalysts are close to the corresponding Au_{bulk} numbers, except for the used $Au/Fe_OH_11.2$ (1.20 at.%) and Au/Fe_O_300 (0.74 at. %)

samples, in which their surfaces were obviously Au-richer compared with that in the corresponding fresh catalysts. Thus, the larger fraction of gold on the surface of iron oxide support during the catalytic tests can be attributed to the promotion in reactivity.




Figure 7. XPS spectra of Au/FeO_x catalysts: (a) Fe 2p, fresh; (b) Fe 2p, used; (c) Au 4f, fresh; and (d) Au 4f, used.

Furthermore, the XPS spectra of Fe 2p in Figure 7a,b clearly demonstrate that the oxidation state of iron was kept the same as Fe³⁺ [33,34] for all the measured samples before and after the CO oxidation reaction. This reveals that the oxidized iron species were very stable during the catalytic measurements, even with the introduction of reducing gas (CO). The XPS spectra of Au 4f in Figure 7c,d distinctly confirm that the oxidation state of gold was more ionic, exhibiting higher binding energies (also see Table 1), in all the fresh catalysts (Au/Fe_OH_11.2, Au/Fe_OH_6.7, Au/Fe_O_300, and Au/Fe_O_200) than after reaction. This indicates that CO reduced Au to form metallic species, which was in good agreement with the TEM/HRTEM results.

Therefore, XAFS technique was used to investigate the electronic structure in the gold-iron oxide catalysts before and after the CO oxidation reaction. The related white line in the XANES profiles distinctly changes with the structural evolution on



Au (Au⁰ and Au^{δ +}) [28]. Compared to XPS, XANES test can be conducted under milder ambient conditions and exclude the effect of ultra-high vacuum level. Thus, we selected the XANES approach to identify the oxidation states of gold in this work.




Figure 8. XANES profiles of Au L3 edge for Au/FeO_x catalysts: (a) fresh and (b) used.

The Au L3-edge XANES spectrum of Au/FeO_x catalysts is compared with that of Au foil in Figure 8. For the fresh samples (see Figure 8a), the Au L3 edges were obviously shifted to higher energies, if compared to that of Au° standard, confirming their $Au^{\delta+}$ nature. Meanwhile, strong white line was clearly observed, which verifies that the ionic gold species were dominant in the fresh catalysts [35,36]. Interestingly, according to the height of white line in Figure 8a, the oxidation state of Au in each gold-iron oxide sample follows this sequence: $Au/Fe_OH_11.2 > Au/Fe_O_300 > Au/Fe_OH_6.7 > Au/Fe_O_200$. This was well consistent with the catalytic reactivity order: $Au/Fe_OH_11.2 > Au/Fe_OH_6.7$ and $Au/Fe_O_300 > Au/Fe_O_200$.

However, after the reaction, gold in all the used Au/FeO_x catalysts was reduced to almost pure Au° species based on the XANES profiles in Figure 8b. This was in good agreement with the TEM/HRTEM and XPS data. Therefore, the different Au oxidation states in the fresh samples were crucial for the significant differences in reactivity between gold supported on various Fe_OH and Fe_O matrices.

3. Experimental Section

3.1. Catalyst Preparation

3.1.1. Preparation of Fe_OH with Different pH Values [8]

 $Na_2CO_3 \cdot 10H_2O$ (99.9%) and $Fe(NO_3)_3 \cdot 6H_2O$ (99%) were purchased from Tianjin Kermal Chemical Reagent Factory (Tianjin, China). Typically, 0.25 mol·L⁻¹ Na_2CO_3 aqueous solution was added drop wisely to 200 mL of 0.1 mol·L⁻¹ $Fe(NO_3)_3$

aqueous solution under stirring at 80 °C until specific pH value (6.7, 8.2, 9.7, and 11.2) was reached. The stock solution was aged under stirring at 80 °C for another 1 h, and then the as-formed precipitate was collected by filtration. The solid product was washed with deionized (DI) water at 80 °C several times until the final pH was neutral. This powder was dried at 120 °C in still air for 12 h to generate the Fe_OH supports, marked as Fe_OH_6.7, Fe_OH_8.2, Fe_OH_9.7 and Fe_OH_11.2.

3.1.2. Preparation of Fe_O with Different Calcination Temperatures

The Fe_OH_8.2 supports were ground into fine powders, and calcined at different temperatures (200, 300, 400, 500 and 600 $^{\circ}$ C) for 2 h (rate of 5 $^{\circ}$ C· min⁻¹) to generate the Fe_O supports, marked as Fe_O_200, Fe_O_300, Fe_O_400, Fe_O_500, and Fe_O_600.

3.1.3. Deposition of Gold onto Fe_OH or Fe_O

For the sequential deposition-precipitation process, 0.5 g Fe_OH or Fe_O support powders were suspended in 23 mL Millipore water (18.25 M Ω) under stirring. Then, 2 mL of $0.0125 \text{ mol} \cdot \text{L}^{-1}$ HAuCl₄ aqueous solution was added to the above solution at 60 °C. After 30 min, 25 mL of aqueous solution containing 0.5 g of urea was quickly added into the stock solution. Thereafter, the stock solution was heated up to 80 °C under vigorously stirring and the temperature was kept for 3 h. The pH value of this solution was raised from 4.0 to 8.6, resulting in the full decomposition of urea. The stock solution was further aged at room temperature for another 20 h. The as-prepared product was collected by filtration, and washed with Millipore water at 60 °C several times until the final pH value was neutral. After being dried at 60 °C overnight in still air, the fresh Au/Fe_OH and Au/Fe_O catalysts were obtained. The designed gold concentration in each sample was fixed at 1 wt. %, calculated as Au/Fe(OH)₃, or 0.54 at. %, calculated as Au/(Au + Fe). HAuCl₄· 4H₂O (99.9%) were purchased from National Chemicals (Shanghai, China).

3.2. Characterization

The actual gold loadings of catalysts were determined by inductively coupled plasma atomic emission spectroscopy (ICP-AES) on an IRIS Intrepid II XSP instrument (Thermo Electron Corporation, Waitham, MA, USA).

The nitrogen adsorption-desorption measurements were performed on a NOVA 4200e instrument (Quantachrome Corporation, Boynton Beach, FL, USA) at 77 K. The samples were outgassed at 120 $^{\circ}$ C for 12 h under vacuum prior to measurements. The BET specific surface areas (S_{BET}) were calculated from the adsorption data in the relative pressure range between 0.05 and 0.30.

X-ray photoelectron spectroscopy (XPS) analysis was performed on an Axis Ultra XPS spectrometer (Kratos, UK) with 225 W of Al K_{α} radiation. The C 1s line at

284.8 eV was used to calibrate the binding energies. The surface gold concentrations (Au_{surf} in at. %) were determined by integrating the areas of Au 4f and Fe 2p peaks.

X-ray Diffraction (XRD) was operated on a Bruker D8 Advance diffractometer (Bruker-AXS; Karlsruhe, Germany, 40 kV, 40 mA), using Cu K_{α} radiation (λ = 0.15406 nm). The powder catalyst after grinding was placed inside a quartz-glass sample holder before test.

X-ray absorption near edge structure (XANES) spectra at Au K-edge (E_0 = 11,919 eV) were performed at BL14W1 beam line of Shanghai Synchrotron Radiation Facility (SSRF) operated at 3.5 GeV under "top-up" mode with a constant current of 240 mA. The XAFS data were recorded under fluorescence mode with 32-element Ge solid-state detector. The energy was calibrated accordingly to the absorption edge of pure Au foil. Athena codes were used to extract the data. The experimental absorption coefficients as function of energies $\mu(E)$ were processed by background subtraction and normalization procedures, and reported as "normalized absorption". Based on the normalized XANES profiles, the oxidation state of Au in each catalyst can be determined.

Transmission electron microscopy (TEM) was conducted on a field emission TEM (JEOL 2100F, Tokyo, Japan) machine equipped with a $2k \times 2k$ CCD camera at 200 kV. High-resolution TEM (HRTEM) and the related energy dispersive X-ray analysis (EDAX) was carried out on a Philips Tecnai G^2 F20 instrument (FEI Company, Hillsboro, TX, USA) at 200 kV. All the tested sample powders were suspended in ethanol before deposition on an ultra-thin carbon film-coated copper grid.

Temperature-programmed reduction by hydrogen (H_2 -TPR) was carried out in a Builder PCSA-1000 instrument (Beijing, China) equipped with a thermal conductivity detector (TCD) to detect H_2 consumption. The sieved catalysts (20–40 mesh, 30 mg) were heated (5 °C·min⁻¹) from room temperature to 400 °C in a 20% H_2 /Ar (30 mL·min⁻¹) gas mixture. Before the measurements were taken, the fresh samples were pretreated in pure O_2 at 300 °C for 30 min.

3.3. Catalytic Test

CO oxidation activities of Au/FeO_x catalysts were evaluated in a plug flow reactor using 50 mg of sieved (20–40 mesh) catalyst in a gas mixture of 1 vol. % CO, 20 vol. % O₂, and 79 vol. % N₂ (99.997% purity from Deyang Gas Company, Jinan, China), at a flow rate of 67 mL· min⁻¹, corresponding to a space velocity of 80,000 mL· h⁻¹· g_{cat}^{-1} . Prior to the test, the catalysts were pretreated in air at 300 °C for 30 min for activation. After the catalysts cooled down to room temperature under a flow of pure N₂ gas, reactant gases were passed through the reactor. The catalytic tests in "transient" mode were carried out in the reactant atmosphere by ramping the catalyst temperature (5 °C· min⁻¹) from room temperature to 300 °C. The outlet gas compositions of CO and CO₂ were monitored online by a non-dispersive IR

spectroscopy (Gasboard-3500, Wuhan Sifang Company, Wuhan, China). A typical "steady-state" experiment (30 $^{\circ}$ C) was conducted in the same gas-mixture at 30 $^{\circ}$ C for more than 10 h.

4. Conclusions

In summary, we have prepared two series of gold-iron oxide catalysts, Au/Fe_OH and Au/Fe_O , by depositing Au onto hydrated and dehydrated supports, and further investigated their catalytic performance for the low-temperature CO oxidation reaction. Based on the related activity test results, we have demonstrated that the precipitating pH value and the calcination temperature for the iron oxide support are two key factors governing the gold catalysis. By multiple characterization techniques, including XRD, N_2 adsorption, TEM/HRTEM, XPS, XAFS and H_2 -TPR, we have found that the metallic Au strongly interacting with the oxide support is the active site for CO oxidation.

Competition of CO and H₂ for Active Oxygen Species during the Preferential CO Oxidation (PROX) on Au/TiO₂ Catalysts

Abstract: Aiming at an improved mechanistic understanding of the preferential oxidation of CO on supported Au catalysts, we have investigated the competition between CO and H_2 for stable, active oxygen (O_{act}) species on a Au/TiO₂ catalyst during the simultaneous exposure to CO and H_2 with various CO/ H_2 ratios at 80 °C and 400 °C by quantitative temporal analysis of products (TAP) reactor measurements. It is demonstrated that, at both higher and lower temperature, the maximum amount of active oxygen removal is (i) independent of the CO/ H_2 ratio and (ii) identical to the amount of active oxygen removal by CO or H_2 alone. Hence, under preferential CO oxidation (PROX) reaction conditions, in the simultaneous presence of CO and H_2 , CO and H_2 compete for the same active oxygen species. In addition, also the dependency of the selectivity towards CO oxidation on the CO/ H_2 ratio was evaluated from these measurements. Consequences of these findings on the mechanistic understanding of the PROX reaction on Au/TiO₂ will be discussed.

1. Introduction

Gold nanoparticles supported on a variety of metal oxides are well known for their exceptional high activity and selectivity for various oxidation and reduction reactions already at very low temperatures [1–4]. One of the most prominent examples is the CO oxidation reaction on supported Au catalysts, e.g., on Au/TiO₂, since it also serves as a test reaction for gas phase oxidation catalysis in heterogeneous Au catalysis in general [5]. Practical applications of monometallic supported Au catalysts are rare, so far, but they are claimed to be promising candidates for the selective removal of CO from H_2 -rich reformates to values below 10 ppm [6–8] for use in low temperature Polymer Electrolyte Membrane (PEM) fuel cells [6,9]. The ultra-purification of H_2 -rich fuels via the selective CO oxidation (or preferential CO oxidation—PROX) reaction requires catalysts that are highly active for the CO oxidation (Equation (1)). At the same time, the catalysts should have a very low activity for the continuous oxidation of H_2 to water (Equation (2)), although H_2

reaches concentrations up to 75% (depending on the process of H_2 generation) and is, hence, present in large excess compared to CO in the reaction gas [6,9–11]. One should note, however, that an oxidation of H_2 to adsorbed hydroperoxy-like species, which have previously been proposed to represent reaction intermediates in the preferential CO oxidation in the presence of H_2 , may even be beneficial for the PROX activity of supported Au catalysts [10,12].

In previous studies it has been demonstrated that metal oxide-supported Au nanoparticles (NPs) are highly selective for CO oxidation in the presence of hydrogen [9–11,13–15], where the selectivity is defined by the ratio between the oxygen consumption for CO oxidation, which equals half of the CO consumption according to the reaction stoichiometry (Equation (1)), and the overall oxygen consumption (for CO and H_2 oxidation), or the ratio between CO_2 formation and the sum of CO_2 and H_2O formation (Equation (3)):

Despite the large excess of H_2 , typically about 1% CO and up to 75% H_2 in previous studies, the selectivity of metal oxide supported Au catalysts towards CO oxidation is considerably higher than 50% under typical reaction conditions, at a reaction temperature of 80 °C [13–15], but decreases with decreasing CO content in the reaction gas atmosphere [10,13]. Considering the very low CO concentrations that can be tolerated in PEM fuel cells (<10 ppm), further improvements of existing catalysts, in particular their selectivity, is still mandatory.

Most crucial in the CO oxidation reaction on supported Au catalysts, and also most controversially debated, is the activation of molecular oxygen, which includes issues such as the active site for oxygen activation and the resulting active oxygen species for the oxidation of adsorbed CO [16]. For reaction in a CO/ $\rm H_2$ mixture as in the PROX reaction, this also includes the question whether CO and $\rm H_2$ compete for the same adsorption sites and/or the same active oxygen species. These questions are topic of the present work, where we investigated the selective oxidation of CO in CO/ $\rm H_2$ mixtures on a Au/ $\rm TiO_2$ catalyst by quantitative temporal analysis of products (TAP) reactor measurements.

Before presenting the results of the present study, we will briefly summarize previous findings relevant for the present work. It is well known that CO mainly adsorbs on the surface of the Au nanoparticles under relevant reaction conditions, at room temperature and above [17–19], and also dissociatively adsorbed hydrogen

is assumed to be located on these sites [20,21] or at Au atoms located at the perimeter of the Au-TiO₂ interface [22,23], resulting in the formation of a highly active, atomically-adsorbed hydrogen species [20,22-24]. Furthermore, there seems to be increasing agreement that CO adsorbed on the Au NPs mainly reacts with active oxygen species located at the perimeter sites of the Au- M_xO_y interface in the dominant reaction pathway for CO oxidation [19,25,26], and that for Au catalysts supported on reducible metal oxides, e.g., for Au/TiO₂, and for reaction temperatures above room temperature, surface lattice oxygen of the support represents the active oxygen species [27–33]. Based on TAP reactor measurements, we recently proposed a Au-assisted Mars-van Krevelen mechanism as the dominant reaction pathway for the CO oxidation at T \geqslant 80 °C on Au/TiO₂, where TiO₂ surface lattice oxygen located at the interface between Au nanoparticles and TiO₂ support represents the active oxygen species for CO oxidation, and is continuously removed and replenished during the reaction [27,31]. At lower temperatures, (below -120 °C), the dominant reaction pathway is expected to change and molecularly adsorbed oxygen is proposed to represent the active oxygen species [19,34]. Furthermore CO adsorption on the TiO₂ support becomes increasingly important for the overall reaction [19,34]. Based on similar type TAP reactor measurements, specifically from the identical amount of active oxygen species for the CO oxidation and the H₂ oxidation, and from their almost identical dependency on the Au particle size, we recently proposed that hydrogen oxidation at 80 °C and higher also proceeds via a Au-assisted Mars-van Krevelen mechanism, identical to CO oxidation, with surface lattice oxygen located at the perimeter of the Au-TiO₂ interface acting as active oxygen species [35]. This conclusion was supported recently by density functional theory (DFT) based calculations, where the lowest H2 dissociation barrier was obtained for H₂ interacting with O²⁻ surface lattice oxygen species in TiO₂ close to the Au/TiO₂ perimeter [36]. We had speculated already from those TAP results that CO and H₂ compete for this O_{act} species when present simultaneously, and that this competition is a crucial factor for the catalysts selectivity towards CO oxidation [35]. Experimental proof for this mechanism, in the simultaneous presence of CO and H₂, is still lacking. Here one has to consider that under PROX reaction conditions the formation of hydroxyl groups and adsorbed water on the catalysts surface upon interaction with H_2 may significantly influence its CO oxidation activity [14,37–40].

In the following we report results of TAP reactor measurements, where the absolute amount of active oxygen removal by CO and $\rm H_2$ and its replenishment by $\rm O_2$ was evaluated upon exposure of a $\rm Au/TiO_2$ catalyst to alternate sequences of $\rm CO/H_2/Ar$ and $\rm O_2/Ar$ pulses, using different $\rm CO/H_2$ mixtures. From these data we will derive whether CO and $\rm H_2$ compete for the same active oxygen species also in the simultaneous presence of CO and $\rm H_2$. Moreover, the selectivity for CO oxidation during mixed $\rm CO/H_2$ pulses can be determined. Finally we will discuss

the consequences of the present finding for the mechanism of the PROX reaction on Au/TiO_2 catalysts.

2. Results and Discussions

2.1. Active Oxygen Removal by CO and H₂

Before focusing on the reaction with mixed CO/H₂/Ar pulses, we determined the removal of stable, active oxygen from the Au/TiO₂ catalyst surface by CO/Ar and H₂/Ar pulses only for calibration. The absolute amounts of active oxygen determined in these measurements will then be used as references for the active oxygen removal in the simultaneous presence of CO and H_2 . Similar to our previous study [35], the catalyst was alternately exposed to several sequences of (i) CO/Ar and O_2 /Ar or (ii) H_2/Ar and O_2/Ar , respectively, in order to reactively remove and replenish the available active oxygen from the catalyst surface. These measurements were performed after in situ calcination (O400) of the Au/TiO₂ catalyst and subsequent saturation of its surface by adsorbed water by exposure to 5000 H₂/Ar pulses at 80 °C. Additional experiments including the exposure of the catalyst to various amounts of H₂/Ar pulses and subsequent temperature programmed desorption (TPD) measurements revealed that (i) there is formation of stable adsorbed water upon exposure to H₂/Ar pulses at 80 °C and (ii) treatment with 5000 H₂/Ar pulses results in a surface saturation and, hence, equal surface concentrations of adsorbed water during all subsequent experiments. Note that, at 400 °C, in contrast, water formed during the H₂ oxidation readily desorbs, and does not need to be considered in the following measurements.

The multi-pulse experiments following this treatment (O400 and H_2 pulses) revealed an oxygen consumption of the fully-reduced catalyst during O_2/Ar pulses at $80~^{\circ}C$ of 3.3×10^{18} O atoms g_{cat}^{-1} . This is almost identical to the CO consumption/ CO_2 formation in the subsequent sequence of CO/Ar pulses $(3.4 \times 10^{18} \text{ molecules} \cdot g_{cat}^{-1})$, as well as to the oxygen consumption during subsequent O_2/Ar pulses (after 250 CO/Ar pulses). Hence, this (partial) reduction and re-oxidation of the catalyst surface is fully reversible under present conditions. Furthermore, in agreement with previous findings, the amount of CO_2 formation in each CO/Ar sequence always equals the amount of CO_2 consumed, indicating that there is no significant build-up of stable adsorbed, carbon containing surface species (surface carbonates, *etc.*) under present reaction conditions [25,41]. Finally, all CO_2 is formed during CO_2 pulses (and not during O_2 pulses), as expected for CO_2 weakly adsorbed on the Au NPs at $80~^{\circ}C$, and completely desorbed before O_2 is introduced [31].

The oxygen storage capacity (OSC) at 80 $^{\circ}$ C is slightly lower in the present study (3.3 \times 10¹⁸ O atoms· g_{cat}^{-1}) than determined previously for a comparable

Au/TiO₂ catalyst, which was also saturated with adsorbed water by H_2 pulses prior to the pulse experiments (4.6 \times 10¹⁸ O atoms· g_{cat}^{-1}) [35], but of a similar order of magnitude. More important for the present study, however, is the comparison between the absolute amounts of active oxygen on (fully oxidized) Au/TiO₂ for the CO oxidation and the H_2 oxidation. From the oxygen uptake during O_2/Ar pulses after 1500 H_2/Ar pulses on the Au/TiO₂ catalyst at 80 °C we obtained a value of 3.3×10^{18} O atoms· g_{cat}^{-1} for the total amount of stable oxygen which is active for the H_2 oxidation (see Table 1). Note that compared to CO/Ar a significantly higher number of H_2/Ar pulses is necessary to completely remove the active surface oxygen. While for a complete removal of all availabe O_{act} species via the CO oxidation about 200 CO/Ar pulses were needed, almost 1500 H_2/Ar pulses are necessary for its removal via the H_2 oxidation. This reflects the much lower efficiency of hydrogen for active oxygen removal compared to CO, as was already demonstrated previously [31]. The total amounts of active oxygen for CO and H_2 oxidation, however, are almost identical also for the present Au/TiO_2 catalyst [31].

Additionally, for reaction at 400 °C, the total amounts of active oxygen for CO oxidation and for $\rm H_2$ oxidation are also almost identical (12.7 × 10¹⁸ O atoms· $\rm g_{cat}^{-1}$ and 12.6 × 10¹⁸ O atoms· $\rm g_{cat}^{-1}$, respectively; see Table 2). The higher amount of $\rm O_{act}$ species available and, accordingly, a higher amount of $\rm TiO_2$ surface lattice oxygen removal at 400 °C is in agreement with findings in previous studies, where this was explained by the migration of $\rm TiO_2$ surface lattice oxygen to Au-TiO₂ perimeter sites at elevated temperatures [27]. This enables the removal also of $\rm O_{act}$ species which were originally located further away from the Au-TiO₂ interface perimeter. At 80 °C, in contrast, the mobility of surface lattice oxygen is negligible, and only surface lattice oxygen species located directly at Au-TiO₂ interface perimeter sites can be removed by reaction with $\rm CO_{ad}$ or $\rm H_{ad}$ [25,35]. Considering the Au loading and the Au particle

size distribution (from TEM imaging), and assuming hemispherical Au nanoparticles, the total amount of these species can be estimated to be 6.2×10^{18} O atoms \cdot \cdot \cdot g_{cat}⁻¹.

Hence, the data are in full agreement with our previous proposal that CO and hydrogen are both oxidized by the same active oxygen species at both 80 $^{\circ}$ C and 400 $^{\circ}$ C, by TiO₂ surface lattice oxygen close to Au-TiO₂ perimeter sites [27]. For more details see Ref. [35].

2.2. Active Oxygen Removal by CO/H₂ Mixtures




Figure 1. Mass spectrometer signals of CO, CO₂, H₂, and H₂O measured during a sequence of CO/H₂/Ar pulses (CO/H₂ ratio = 1/2) on Au/TiO₂ at 80 $^{\circ}$ C after oxidation by O₂/Ar pulses, as well as the O₂ signal measured during subsequent O₂/Ar pulses at 80 $^{\circ}$ C.

Similar multi-pulse experiments were performed with alternate sequences of O_2/Ar and $CO/H_2/Ar$ pulses with various CO/H_2 ratios. At both temperatures (80 °C and 400 °C) five different CO/H_2 mixtures were investigated, with CO/H_2 ratios ranging from 1/0.5 to 1/8 (see also Tables 1 and 2). The trends in the pulse signals of CO, CO_2 , H_2 , H_2O , and O_2 during reduction and re-oxidation with $CO/H_2/Ar$ pulses ($CO/H_2 = 1/2$) and subsequent O_2/Ar pulses, respectively, are illustrated in Figure 1 for reaction at 80 °C on Au/TiO_2 . Only the first 50 pulses of each sequence are shown, where differences in the measured intensities due to consumption of educts (CO, CO, CO, and CO)/formation of products (CO, CO, CO, are visible in the raw data, while the actual number of pulses per sequence are significantly higher (see Section 3.2). For $CO/H_2/Ar$ and CO/Ar at 80 °C the number of pulses in each sequence was 250 and 150, respectively.

During the first $10 \, \text{CO/H}_2/\text{Ar}$ pulses on the fully oxidized Au/TiO_2 catalyst there is a significant consumption of CO, indicated by the much lower CO intensity compared to that after about 50 or more pulses, and in parallel the formation of CO_2 (Figure 1). Hence, also under these conditions CO oxidation proceeds by reaction with stable surface oxygen of the catalyst. With increasing number of pulses the CO consumption/CO₂ formation during each pulse decreases, until there is no visible discrepancy to the steady-state situation after about 10 pulses. The absolute amount

of CO consumed/CO₂ formed during the 250 CO/H₂/Ar pulses in this sequence at 80 °C was 2.2×10^{18} molecules g_{cat}^{-1} . The significantly lower amount of CO₂ formation during the exposure of the fully oxidized Au/TiO2 catalyst to CO/H2 pulses as compared to CO pulsing $(3.3 \times 10^{18} \text{ molecules} \cdot \text{g}_{\text{cat}}^{-1})$, see above) indicates already that stable adsorbed active oxygen is not only consumed by reaction with CO, but also by reaction with hydrogen. From the H_2 signal shown in Figure 1, however, no (or only very little) H2 consumption can be detected, in contrast to the CO signal. A somewhat lower H₂ signal is observed only during the first 1–2 pulses, with the lower intensity measured during the first pulse originating from a generally lower overall pulse size for the first pulse in every sequence (an artifact of our TAP reactor system). Hence, from the raw data there is no indication for reduction of Au/TiO₂ by H₂ during these pulses, and also the quantitative evaluation of all CO/H₂/Ar pulses could not resolve significant H₂ consumption. From previous TAP reactor studies on Au/TiO₂ as well as on Au/CeO₂ it is already known that the efficiency of H₂ for active oxygen removal is considerably lower compared to CO [35,42]. The H₂ consumption during a single pulse is, accordingly, too low to be resolved in these measurements, and the same is true for the formation of water during exposure to H₂ or CO/H₂ pulses at 80 °C [35]. As described in Section 3.2 (see below), the consumption of active oxygen by H2 can, nevertheless, be calculated from the total oxygen uptake during subsequent O₂/Ar pulses, from the more than stoichiometric consumption of O₂ compared to the preceding CO₂ formation during two consecutive runs at 80 °C.

The O₂ signal measured during re-oxidation of Au/TiO₂ by O₂/Ar pulses, after reduction of the catalyst by CO and H2, is also shown in Figure 1 (lower panel). Similar to CO consumption during CO/H₂/Ar pulses, O₂ consumption during the first 10–15 O₂/Ar pulses is obvious already from the raw data by the lower intensity compared to that after saturation. Quantitative evaluation of the O2 consumption during the whole sequence (150 O_2 /Ar pulses) revealed that 3.1×10^{18} O atoms g_{cat}^{-1} are needed to fully re-oxidize the catalyst at 80 °C (see also Table 1). This value is almost identical to the one determined after reduction by CO or H₂ only $(3.3 \times 10^{18} \text{ O atoms} \cdot \text{g}_{\text{cat}}^{-1} \text{ in both cases})$, but significantly higher than the CO₂ formation during the preceding CO/H₂/Ar pulses (2.2×10^{18} molecules g_{cat}^{-1}). Accordingly, the amount of active oxygen removed by reaction with hydrogen amounts to 0.9×10^{18} O atoms g_{cat}^{-1} . These results clearly demonstrate that under present reaction conditions, with CO and hydrogen being simultaneously present on the surface, these species compete for the same active oxygen species. The higher amount of active oxygen removal by CO, in spite of the considerable excess of H₂ during the $CO/H_2/Ar$ pulses (CO/H_2 ratio of 1/2) illustrates the high selectivity of Au/TiO₂ for the CO oxidation (71% in this case) under present reaction conditions.

The results of additional measurements with different CO/ H_2 ratios during the CO/ H_2 /Ar pulses, where the amount of CO molecules per pulse was kept constant at 3 \times 10¹⁵ molecules CO per pulse, while the amount of H_2 was varied between 1.5 \times 10¹⁵ and 24 \times 10¹⁵ molecules H_2 per pulse, are plotted in Figure 2a and listed in Table 1, together with the absolute amounts of active oxygen consumption/replenishment for CO only (0% H_2) and H_2 only (100% H_2).




Figure 2. (a) Absolute amounts of active oxygen (O_{act}) removal from a fully oxidized Au/TiO₂ catalyst (after O_2 /Ar pulses) by CO and/or H_2 during CO, H_2 , and CO/ H_2 pulses with varying ratios of H_2 (33%–89% H_2) at 80 °C, and (b) corresponding selectivities for CO oxidation/CO₂ formation during the CO/ H_2 /Ar pulses at 80 °C.

These data clearly demonstrate that the total amount of oxygen that can be removed by CO/H_2 is almost identical for all mixtures and, moreover, also for "CO only" and " H_2 only" experiments. Obviously, under present reaction conditions, in the simultaneous presence of CO and H_2 , these reactants are oxidized by the same active oxygen species as we have already concluded for the individual reactants before (see Section 2.1 and [35]). The existence of other active oxygen species, which may be active only for H_2 oxidation when CO and H_2 are present simultaneously, can be ruled out, since this would result in a higher amount of active oxygen species for the simultaneous CO and CO and CO oxidation only.

On a first glance these findings seem to contradict recent conclusions from Saavedra $et\ al.$, who studied, in detail, the role of water in the catalytic CO oxidation on Au/TiO₂ [40]. Based on experimental results and DFT calculations they concluded (i) that weakly adsorbed water on TiO₂ determines the catalysts activity at room temperature by changing the effective number of active sites; and (ii) that O₂ activation in the dominant reaction pathway under these conditions requires the presence of both water and CO [40]. Considering that our experiments were

performed at 80 °C and under vacuum conditions (not during pulses, but between individual pulses and pulse sequences), the presence of weakly-adsorbed water on the catalyst surface can be excluded. Temperature programmed desorption (TPD) measurements performed after saturation of the catalyst with water by 1500 H₂/Ar pulses had shown that stable adsorbed water is formed upon H2 pulsing, which desorbs with a maximum in the TPD spectra at about 230 °C. This is the only water species present during O₂ pulsing at 80 °C. Hence, our results clearly demonstrate that as long as only stable adsorbed water is present on the catalyst surface, coexisting adsorbed CO and hydrogen both are oxidized by TiO2 surface lattice oxygen and compete for this Oact species. Weakly-adsorbed water species, whose presence during continuous PROX reaction cannot be ruled out from our data, may also enable another oxygen activation mechanism as described in the recent study by Saavedra et al. [40]. In that case, however, the dominant reaction mechanisms of CO and H₂ oxidation under PROX reaction conditions are expected to sensitively depend on the reaction temperature, due to the facile desorption of these species at higher temperatures. Similar kinds of temperature effects have been proposed earlier for the CO oxidation reaction under dry reaction conditions [31]. Another possibility that has to be considered under continuous PROX conditions, in the simultaneous presence of CO, O_2 , and H_2 in the catalyst bed, is the H-assisted O_2 activation. Rousset and coworkers previously demonstrated that the presence of H₂ promotes the CO oxidation activity over various Au catalysts supported on different (reducible and non-reducible) metal oxides [10,12]. According to them, this beneficial effect of H₂ results most probably from the reaction of adsorbed hydrogen atoms with molecular oxygen to active hydroperoxy-like species that represent additional reaction intermediates in the CO oxidation. In the present approach there is an inherent difficulty in studying this effect, since CO/H₂ and O₂ are never present simultaneously in the catalyst bed during the alternate pulse sequences. Here, further work is planned to more closely investigate the influence of H_2 on the O_2 activation in pulse experiments, in particular by exposing the catalyst to mixed CO/H₂/O₂/Ar pulses. In that approach it will also be highly interesting to compare the oxygen activation in the presence of H₂ on different Au catalysts supported on reducible and non-reducible metal oxides (Au/TiO2, Au/ZnO, Au/Al2O3, and Au/SiO2, for example). Numerous previous studies have demonstrated that the activity for CO oxidation largely depends on the reducibility of the metal oxide support, with Au catalysts supported on reducible oxides being much more active [43,44]. Applying TAP reactor pulse experiments we could even demonstrate a quantitative relation between the catalysts reducibility (measured by its oxygen storage capacity) and its activity for CO oxidation [41]. In the presence of H₂, however, the activity of Au catalysts supported on reducible and non-reducible metal oxides becomes very similar [10,12], reflecting a more pronounced promotional effect of H₂ on

the CO oxidation activity (see above) for non-reducible than for reducible metal oxide supports.

In addition to the absolute amount of active oxygen on Au/TiO2 we also calculated the selectivity for active oxygen removal by CO at 80 °C for different CO/H₂ ratios, where the selectivity was given by the ratio between the absolute amount of CO₂ formation and the overall oxygen removal during CO/H₂/Ar pulses (see Section 3.2). Figure 2a illustrates already that the amount of CO consumption/CO₂ formation continuously decreases with increasing H₂ content in the CO/ H_2 pulses at 80 °C, despite the almost constant amount of O_{act} removal (for combined CO and hydrogen oxidation). This results in a decrease of the selectivity for CO₂ formation from 92% in the presence of 33% H₂ to slightly below 50% in the presence of 89% H₂ (see Figure 2b and Table 1). A similar trend of a decreasing selectivity with decreasing CO/H₂ ratio was also observed in kinetic measurements of the PROX reaction on a Au/TiO₂ catalyst under continuous flow, but otherwise similar reaction conditions (80 °C) [14,45]. The high selectivities fully agree with the much lower efficiency for O_{act} removal by H₂ (including H₂ adsorption, dissociation, and reaction with Oact) compared to reaction with CO. This was already demonstrated by the much higher number of H₂ pulses needed for the complete removal of the available active oxygen species compared to reaction with CO in multi-pulse TAP reactor experiments (see Section 2.1 and Refs. [35,42]). Considering the selectivity of about 50% in the presence of 89% H₂ (CO/H₂ ratio of 1/8), this difference in the efficiency for O_{act} removal can be estimated to be about 8. This value is also in close agreement to the approximately eight times higher amount of H₂ molecules compared to CO molecules that are needed for a complete removal of all available O_{act} species (see Section 2.1). One has to keep in mind, however, that the latter averages over the entire pulse sequence, and does not necessarily reflect the difference in efficiency of a single CO or H₂ molecule. The selectivity largely originates from the competition between adsorbed CO and hydrogen for the same active oxygen species when simultaneously present on the catalyst surface. Additional effects arising, e.g., from the competition of the two adsorbing species (CO, H₂) for adsorption sites and from (de-)stabilizing interaction between the coadsorbed species, which had been suggested previously [13,14], can neither be excluded nor supported from our TAP reactor experiments measurements. It should be noted, however, that the steady-state coverages under typical reaction conditions (≤0.5% CO, 60%–70% H₂, 80 °C, atmospheric pressure) are well below saturation. Accordingly, such effects are expected to be small, and similar conclusions were put forward also in the above studies [13,14].

Finally, we performed similar multi-pulse experiments with alternate sequences of O_2/Ar pulses and $CO/H_2/Ar$ pulses at 400 °C, using the same reaction gas mixtures for O_{act} removal from Au/TiO_2 as described above (CO, H_2 , and




Figure 3. Absolute amounts of active oxygen (O_{act}) removal from a fully oxidized Au/TiO₂ catalyst (after O₂/Ar pulses) by CO and/or H₂ during CO, H₂, and CO/H₂ pulses with varying ratios of H₂ (33%–89% H₂) at 400 °C.

 $\rm CO/H_2$ = 1/0.5 – $\rm CO/H_2$ = 1/8). The main characteristics during reduction and re-oxidation were identical to those obtained in the experiments at 80 °C: For all measurements, $\rm CO_2$ and $\rm H_2O$ are only formed during $\rm CO$ and/or $\rm H_2$ pulses, respectively, and the processes of catalyst reduction and re-oxidation are fully reversible, as evidenced by at least three cycles of reduction and re-oxidation with identical absolute amounts of $\rm O_{act}$ removal/replenishment for each gas mixture. The absolute amounts of active oxygen removal upon exposure to $\rm CO$ only, $\rm H_2$ only, and $\rm CO/H_2$ mixtures are presented in Figure 3 and listed in Table 2.

Similar to the results at 80 °C also in this case the absolute amount of active oxygen (12×10^{18} O atoms· g_{cat}^{-1}) is essentially independent of the composition of the reaction gas pulses used for reduction. Hence, also at 400 °C CO and H_2 seem to compete for TiO_2 surface lattice oxygen close to the Au nanoparticles when present simultaneously. The only difference to the measurements at lower reaction temperature is that at 400 °C the increasing thermal mobility of surface lattice oxygen and surface oxygen vacancies enables the migration and, therefore, the removal and replenishment of oxygen and oxygen vacancies which were originally located further away from the perimeter sites. At 80 °C, in contrast, only oxygen species directly adjacent to the Au nanoparticles participate in the oxidation reactions [27]. Nevertheless, also at 400 °C removal of O_{act} species upon reaction with CO or H_2 is expected to occur only at Au-TiO₂ interface perimeter sites.

As described below (Section 3.3) it is not possible to calculate the selectivity for reaction at 400 $^{\circ}$ C, since even in the absence of H₂ there is no stoichiometric

consumption of O_2 and CO (with respect to the CO oxidation). Hence, the differences between O_2 consumption and CO consumption in consecutive sequences of O_2/Ar and $CO/H_2/Ar$ pulses cannot be assigned to active oxygen removal via the H_2 oxidation only. Nevertheless, from the continuously-decreasing amount of CO_2 formation with increasing H_2 ratio in $CO/H_2/Ar$ pulses, from 9.3×10^{18} CO_2 molecules g_{cat}^{-1} to 6.1×10^{18} CO_2 molecules g_{cat}^{-1} at $CO/H_2 = 1/0.5$ and $CO/H_2 = 1/8$ (see Table 2), it is evident that also at 400 °C the reaction is dominated by the same trend of decreasing selectivity towards CO_2 formation with increasing H_2 content. Moreover, considering that even for the highest amount of H_2 during CO/H_2 pulses ($CO/H_2 = 1/8$) and, hence, in an eight-fold excess of H_2 compared to CO_2 still 6.1×10^{18} CO_2 molecules g_{cat}^{-1} are formed, which is about 60% of the amount of CO_2 formed upon reduction by CO only (see Table 2), it can be concluded that also at 400 °C the catalyst still selectively catalyses the CO oxidation under present reaction conditions.

In total, these results, obtained at different temperatures as well as for reaction in different atmospheres, point to a competition of CO and H_2 for the same active oxygen species when present simultaneously and, hence, under PROX reaction conditions. This competition will mainly determine the catalyst selectivity towards CO oxidation, and strategies for even more selective Au catalysts under these conditions (80 $^{\circ}$ C and higher) should accordingly focus on the efficiency of H_2 and CO for active oxygen removal, which may be achieved by a systematic modification of the support material and/or the Au-support interface perimeter sites, which both significantly influence the activity for CO and H_2 oxidation via a Au-assisted Mars-van Krevelen mechanism [31,41].

3. Materials and Methods

3.1. Preparation and Characterization of Au/TiO₂

For all measurements we used a home-made Au/TiO₂ catalyst with a Au loading of 2.2 wt. %, which was prepared via a deposition-precipitation method using commercial, non-porous TiO₂ as support material (P5, surface area 56 m²· g⁻¹). Prior to all measurements the catalyst was pre-treated *in situ* by calcination at 400 °C in a continuous flow of 10% O₂/N₂ (20 Nml· min⁻¹) at atmospheric pressure for 30 min (hereafter denoted as O400), resulting in a surface-volume mean diameter of 2.4 \pm 0.5 nm. The mean Au particle size was determined by transmission electron microscopy (TEM), evaluating the diameter of more than 500 Au nanoparticles after pre-treatment (O400).

3.2. TAP Reactor Measurements

Pulse experiments were performed in a TAP reactor system, which was built in our laboratory and which is described in detail in Ref. [46]. This system consists of a gas mixing unit, two piezo-electrically driven pulse valves, and a quartz glass micro-reactor (length: 90 mm, inner diameter: 4 mm), which is connected to an analysis chamber (under ultrahigh vacuum conditions), which houses the mass spectrometer for gas phase analysis. For *in situ* catalyst pre-treatment at atmospheric pressure, the micro-reactor with the catalyst inside can be separated from the analysis chamber via a differentially-pumped gate valve. This latter gate valve enables fast transitions from vacuum to ambient conditions in the micro-reactor and *vice versa* [46].

Gas pulses containing between 8×10^{15} and 3×10^{16} molecules per pulse were generated by the piezo-electrically driven pulse valves and directed to the micro-reactor. At the centre of this reactor the catalyst bed was fixed by stainless steel sieves. For all measurements the catalyst bed consisted of two outer layers of SiO₂ powder (inert under present reaction conditions) and a central catalyst zone with 10 mg of the Au/TiO₂ catalyst diluted with 10 mg SiO₂ (dilution 1:1) in between the SiO₂ layers.

Multi-pulse experiments were performed with a separation time of 5 s between two consecutive pulses. During these measurements the catalyst was alternately exposed to sequences of (i) CO/Ar; (ii) H_2/Ar ; or (iii) CO/ H_2/Ar and O_2/Ar pulses for removal and replenishment of stable, active oxygen species. The number of pulses in each sequence was chosen such that there is no measurable reactive removal or oxygen uptake at the end of each sequence, i.e., at the end of CO/Ar, H_2/Ar , and CO/H₂/Ar pulse sequences or after the O₂/Ar pulse sequences. The exact numbers of pulses in each sequence are stated together with the results obtained (see Sections 2.1 and 2.2). Moreover, these cycles with alternate reduction and re-oxidation of the catalyst surface were always repeated at least three times in order to demonstrate the reversibility of the observed processes and, hence, to exclude permanent changes of the catalysts state during pulse experiments. The absolute amount of reversible oxygen removal and replenishment is defined as the catalysts oxygen storage capacity (OSC). Note that in each pulse Ar was included in order to enable the quantitative evaluation of the amount of CO, H_2 , or O_2 consumed during every single pulse on an absolute scale. This is based on the comparison of the ratio of the intensities of the respective species and Ar during reaction (uptake/consumption of CO, H₂ and O₂) to that after saturation, where no more consumption of the corresponding species was detected. CO/Ar and O2/Ar pulses always consisted of 50% CO or 50% O₂ and 50% Ar at a pulse size of 8×10^{15} molecules per pulse. Hence, the catalyst was exposed to about 4×10^{15} molecules CO or O_2 during each of the pulses. For pulses with a CO/H₂/Ar mixture, in contrast, the overall pulse size was between 1.2×10^{16} and 3.0×10^{16} molecules per pulse. Here we kept the amount

of CO constant at 3×10^{15} molecules CO per pulse, while varying the amount of H_2 between 1.5×10^{15} and 24×10^{15} molecules H_2 per pulse. This way, CO/ H_2 ratios between 1/0.5 and 1/8 were realized for the CO/ H_2 /Ar pulses. Note that in the discussions the H_2 ratio during CO/ H_2 /Ar pulses is always stated with respect to CO and H_2 only (not considering Ar), which are accordingly between 33% H_2 (CO/ H_2 = 1/0.5) and 89% H_2 (CO/ H_2 = 1/8).

In order to avoid complications in the direct comparison of active oxygen removal by CO and H_2 at 80 °C due to adsorption of water, which is always formed on the catalyst surface during H_2 oxidation and has a distinct impact on the CO oxidation activity (see above), we saturated the Au/TiO₂ catalyst surface with adsorbed water by exposing it to 5000 H_2 /Ar pulses before starting the measurements. Note that this treatment additionally resulted in a complete removal of stable reactive oxygen (O_{act}) species for H_2 oxidation. The starting point of subsequent measurements is, hence, a fully reduced Au/TiO₂ catalyst.

3.3. Calculation of the Selectivity

Usually the selectivity for CO oxidation in CO/H₂ mixtures is defined by the ratio between the CO₂ formation rate and the overall oxygen consumption rate (for CO oxidation and H₂ oxidation, see also Equation (3)), which are determined in kinetic measurements. This is not possible in the present study, where we focused on the absolute amounts of oxygen removal and replenishment during alternate sequences of CO/H₂/Ar and O₂/Ar pulses rather than on their kinetics. In this case we calculated the selectivity for CO oxidation at 80 °C by the ratio between the absolute amount of CO consumption/CO₂ formation (N_{CO} during a sequence of CO/H₂/Ar pulses) and the absolute amount of atomic oxygen consumption ($2 \cdot N_{O2}$) during a subsequent sequence of O₂/Ar pulses (Equation (4)). Note that it was not possible to determine the absolute amount of H₂O formation during CO/H₂/Ar pulses at 80°C, since water desorption is too slow to be resolved.

$$S = \frac{N_{CO}}{2 \cdot N_{O_2}} \tag{4}$$

For reaction at 400 $^{\circ}$ C it was not possible to calculate the selectivity in that way. From previous studies it is known that at this temperature, even in the absence of H₂, the O₂ uptake is always slightly higher than the oxygen consumption during subsequent exposure to CO during alternate sequences of O₂/Ar and CO/Ar pulses [27,35]. Therefore, the difference between CO consumption/CO₂ formation during exposure to CO/H₂/Ar pulses to that of O₂ consumption during subsequent exposure to O₂/Ar pulses is not solely due to active oxygen consumption by H₂ oxidation/H₂O formation, and can not be used for determination of the

selectivity. For this reason we can only provide values for O_{act} removal and CO_2 formation at 400 $^{\circ}C$.

4. Conclusions

From the comparison of the active oxygen removal from a Au/TiO₂ catalyst by CO, H_2 , and CO/ H_2 pulses with varying CO/ H_2 ratios in quantitative temporal analysis of products (TAP) reactor measurements at 80 °C and 400 °C, we arrived at the following conclusions on the PROX reaction mechanism:

- (1) CO and hydrogen are oxidized by the same stable active oxygen species under present reaction conditions, also in the simultaneous presence of CO and H₂ in the reaction atmosphere, as evidenced by the similar amounts of active oxygen removal from a O₂/Ar pulse oxidized Au/TiO₂ catalyst upon exposure to multi-pulse sequences of CO, H₂, and CO/H₂ mixtures. This is independent of the CO/H₂ ratio. Hence, also under PROX reaction conditions CO and H₂ compete for TiO₂ surface lattice oxygen close to the Au nanoparticles/at the perimeter of the Au-TiO₂ interface as active oxygen species.
- (2) The selectivity of Au/TiO₂ catalysts for CO oxidation in CO/H₂ containing gas mixtures observed in kinetic measurements is proposed to mainly result from the much higher efficiency of CO for active oxygen removal compared to hydrogen under present reaction conditions, in the simultaneous presence of H₂ and CO in the reaction atmosphere. The latter is illustrated also by the much higher amount of H₂ pulses required for complete removal of active oxygen from the catalyst compared to CO pulsing.
- (3) Since we can rule out the presence of weakly-bound adsorbed water under present reaction conditions, in multi-pulse sequences, the much higher efficiency of CO for reaction with active oxygen species or the preference for this reaction pathway cannot result from effects caused by weakly-bound water species. On the other hand, stable adsorbed (strongly bound) water species, which are known to be present on the surface upon H₂ pulsing, leave the dominant reaction pathway for CO oxidation under present reaction conditions, namely reaction of CO_{ad} with surface lattice oxygen at the perimeter of the Au NP-support interface, unchanged, although the reaction rate may change.

Since the selectivity of pure Au/TiO_2 catalysts originates mainly from the intrinsic difference in the reactivity of TiO_2 surface lattice oxygen located at $Au-TiO_2$ perimeter sites for CO oxidation and H_2 oxidation under present reaction conditions, further improvements in the selectivity of TiO_2 -based Au catalysts should include a modification of these perimeter sites, for example by doping of the TiO_2 support.

We cannot rule out from the present data, however, that other reaction pathways contribute as well at lower reaction temperature and/or during reaction under

continuous flow conditions at atmospheric pressure. Under those conditions, weakly-adsorbed water, as well as adsorbed H_{ad} , are present and may also be involved in the reaction, as recently proposed by Saavedra *et al.* [40] and Rousset *et al.* [12].

Overall, the present findings confirm previous ideas on the CO oxidation mechanism and the physical origin of the high selectivity for CO oxidation in the PROX reaction on supported Au catalysts, specifically on Au/TiO_2 catalysts, which were based on plausibility arguments extending mechanistic insights from CO oxidation and H_2 oxidation to the present case of reaction in CO/H_2 mixtures.

Characterization and Catalytic Activity of Mn-Co/TiO₂ Catalysts for NO Oxidation to NO₂ at Low Temperature

Abstract: A series of Mn-Co/TiO₂ catalysts were prepared by wet impregnation method and evaluated for the oxidation of NO to NO₂. The effects of Co amounts and calcination temperature on NO oxidation were investigated in detail. The catalytic oxidation ability in the temperature range of 403–473 K was obviously improved by doping cobalt into Mn/TiO₂. These samples were characterized by nitrogen adsorption-desorption, X-ray diffraction (XRD), X-ray photoelectron spectroscopy (XPS), transmission electron microscope (TEM) and hydrogen temperature programmed reduction (H₂-TPR). The results indicated that the formation of dispersed Co₃O₄·CoMnO₃ mixed oxides through synergistic interaction between Mn-O and Co-O was directly responsible for the enhanced activities towards NO oxidation at low temperatures. Doping of Co enhanced Mn⁴⁺ formation and increased chemical adsorbed oxygen amounts, which also accelerated NO oxidation.

1. Introduction

Nitrogen oxides (NO_x) in the exhaust from stationary and mobile sources are toxic to human's health and have brought environmental problems, such as photochemical smog, acid rain and ozone depletion. NO_x storage-reduction (NSR) and selective catalytic reduction (SCR) are considered to be promising technologies to achieve high NO_x reduction efficiency. It is known that most nitrogen oxides from exhaust emissions exist in the form of NO (>90%). NO oxidation is considered to be a key step for NO_x reduction on both the NSR and SCR reactions. In the process of NSR, NO is first oxidized to NO_2 and then stored on the basic components of catalysts as nitrates [1]. For SCR, NO_2 is favored for NO_x conversion according to the so-called Fast SCR reaction, which is thought to be faster by one order of magnitude than the Standard SCR reaction under oxidizing conditions [2]. The light-off temperature in the NO oxidation to NO_2 is significant for the low-temperature SCR of NO_x reduction. Therefore the research into NO oxidation catalysts is important for the

 NO_x removal and various catalysts have been researched, including the supported noble metals [3–6] and other metal oxides [7–9].

Among these catalysts, there has been some attention focused on cobalt oxides [10] and manganese oxides [11]. It was reported that cobalt oxides possess better oxidation ability [12–14]. $\text{Co}^{2+}/\text{Co}^{3+}$ oxidation states were found to interconvert readily in oxidizing and reducing conditions [15]. The presence of Co_3O_4 means high activity for oxidation reactions [10,16]. In addition, Mn-based catalysts have been proven to be highly active for the low-temperature SCR reaction, which would avoid the disadvantages associated with the commercial high-temperature catalysts. Several manganese based catalysts, such as the Mn/TiO₂ [17,18] and the Mn catalysts doped with other metal (Fe, Co, Ni, Cu, Ce, etc.) oxides [19–21], have been reported for the low-temperature SCR reaction. As reported in the literature [22,23], Mn oxides not only acted as highly efficient SCR catalysts, but also showed certain catalytic activity for NO oxidation. The Mn-Co/TiO₂ catalysts have been evaluated for the low temperature SCR reaction [19]. However, the activities of Mn-Co/TiO₂ for NO oxidation to NO₂ have been reported rarely.

The present work aims to investigate the catalysts of Mn-Co composite oxides loaded on TiO_2 for NO oxidation at low temperatures. The catalysts with different Co contents and calcined at different temperatures were investigated to determine the interactions between cobalt oxides and manganese oxides. Special attention was paid to the Mn-O-Co mixed oxides which can change the properties of the catalysts and enhance the oxidation ability. The Mn-Co/ TiO_2 catalysts were characterized by means of N_2 adsorption-desorption, X-ray diffraction (XRD), transmission electron microscopy (TEM), X-ray photoelectron spectroscopy (XPS) and hydrogen temperature-programmed reduction (H₂-TPR).

2. Results and Discussion

2.1. Activity of NO Oxidation to NO₂




Figure 1. NO oxidation efficiency of Mn-Co/TiO₂ catalysts with different Co contents. Reaction conditions: [NO] = 400 ppm, $[O_2] = 5\%$, Ar balance, GHSV = 42,000 h⁻¹.

Figure 1 shows the oxidation efficiency of NO to NO₂ over a series of Mn-Co/TiO₂ catalysts with different cobalt contents and a constant loading of 10 wt. % manganese. These catalysts were calcined at 773 K. As a reference, the activities of 10Co/TiO₂, 10Mn/TiO₂ and 20Mn/TiO₂ were also tested. As shown in Figure 1, the NO conversion efficiencies of 10Mn/TiO₂ and 20Mn/TiO₂ were higher than that of 10Co/TiO₂ below 513 K. Dramatic increase in the NO oxidation ratio within the temperature range of 403–473 K was observed upon addition of cobalt oxides to Mn/TiO₂. However, the NO conversion increased slowly with increasing Co content above 473 K. The 10Mn-10Co/TiO₂ exhibited a maximum oxidation efficiency of 61% at 543 K, which was nearly equal to that of 10Co/TiO₂. The activity results implied

that strong interactions might exist between Co and Mn oxides, which could promote the NO oxidation to NO₂ at low temperatures.




Figure 2. NO oxidation efficiency of 10Mn-5Co/TiO_2 catalysts calcined at different temperatures. Reaction conditions: [NO] = 400 ppm, [O₂] = 5%, Ar balance, GHSV = 42,000 h⁻¹.

Figure 2 shows the oxidation efficiency of NO to NO_2 over a series of $10Mn-5Co/TiO_2$ catalysts calcined at various temperatures. It can be seen that the catalytic activity increased with the calcination temperature increase from 573 to 773 K, and then decreased. The catalyst $Mn-Co/TiO_2$ (773 K) had the highest oxidation efficiency at 543 K among these samples. However, the $Mn-Co/TiO_2$ calcined at 573 and 673 K exhibited excellent catalytic activities in the temperature range of 403-483 K.

2.2. Nitrogen Adsorption-Desorption Characterization

The specific surface areas and pore volumes for Mn-Co/TiO $_2$ catalysts were determined by nitrogen adsorption-desorption method. The results are listed in Table 1. A consistently decreasing trend of surface areas with increasing calcination temperature was noted for $10Mn-5Co/TiO_2$ samples, and a little decrease with the increased Co contents was also showed.

2.3. XRD Characterization




Figure 3. XRD patterns of the catalysts Mn-Co/TiO₂ (773 K) with different Co contents: (a) 10Co/TiO_2 ; (b) 10Mn/TiO_2 ; (c) 10Mn-2Co/TiO_2 ; (d) 10Mn-5Co/TiO_2 ; (e) 10Mn-8Co/TiO_2 ; (f) 10Mn-10Co/TiO_2 ; and (g) 20Mn-10Co/TiO_2 . (A = anatase phase of TiO₂, R = rutile phase of TiO₂).

Figure 3 shows the X-ray powder diffraction patterns of the Mn-Co/TiO₂ catalysts calcined at 773 K, with different Co contents ranged from 0 to 10 wt. %. It can be seen that the relative strong patterns showed diffraction peaks corresponding to anatase TiO_2 phase (PDF#21-1272) and rutile phase (PDF#21-1276), while anatase was the main form in these catalysts. In the pattern of $10Co/TiO_2$ (Figure 3a), several weak diffraction peaks were detected at 2θ values of 18.8° , 31.2° , 44.7° , 59.3° and 65.2° , corresponding to Co_3O_4 phase (PDF#43-1003). In the pattern of $10Mn/TiO_2$ (Figure 3b), these weak peaks at 2θ values of 37.3° and 42.7° can be

attributed to MnO₂ (PDF#50-0866). However, the crystalline MnO₂ was poor since its corresponding diffraction peaks were very weak.

For the Mn-Co/TiO₂ samples with different Co contents, several weak peaks appeared at 18.4° , 30.8° , 33.4° , 44.1° , 58.9° and 65.5° (Figure 3d–g). The intensities of these peaks were enhanced slightly by the increase of Co contents. Compared with the pattern of 10Co/TiO_2 , these peaks had a slight shift toward lower or higher 20 value. These peaks at 30.8° , 33.4° , 58.9° and 65.5° can be assigned to CoMnO₃, while the peaks at 18.4° and 44.1° were ascribed to CoMn₂O₄. These peaks were also weak, inferring that most of the binary metal oxides existed in highly dispersed state. However, the intensities of these peaks were enhanced when the content of Mn increased to 20 wt. % and the Co content was 10 wt. % (Figure 3g). The existence of CoMnO₃ and CoMn₂O₄ was also demonstrated by Meng *et al.* [24] when Co oxides and Mn oxides were mixed without the support TiO₂. It can be deduced that CoMnO₃ and CoMn₂O₄ were two types of Mn-Co composite oxides formed on surface of TiO₂, in which Mn ions existed mainly in valence states of Mn⁴⁺ and Mn³⁺, respectively.





Figure 4. XRD patterns of the $10Mn-5Co/TiO_2$ catalysts calcined at various temperatures: (a) 573 K; (b) 673 K; (c) 773 K; (d) 873 K; and (e) 973 K. (A = anatase phase of TiO_2 , R = rutile phase of TiO_2).

Figure 4 shows the XRD patterns of $10Mn-5Co/TiO_2$ catalysts calcined at various temperatures. It can be seen that the intensities of rutile TiO_2 peaks were enhanced with calcination temperature increasing while the intensities of anatase peaks were decreased, indicating the transformation of anatase to rutile. The samples calcined at 573 and 673 K were low crystallized with the Mn-O-Co mixed oxides (Figure 4a,b). The weak crystal structure of $CoMnO_3$ and $CoMn_2O_4$ were only detected until the calcination temperature reached 773 K, represented by the peaks at 18.4° , 30.8° , 33.4° , 44.1° and 65.5° . These peaks decreased or disappeared above 873 K. Evidently, NO oxidation efficiency is related to the dispersion of $CoMnO_3$ and the crystal types of TiO_2 .

As the calcination temperature increased to 873 and 973 K, the peaks at 18.4° , 30.8° and 33.4° shifted slightly toward lower 2θ value. We considered that was due to the transformation of Mn^{4+} to Mn^{3+} and Mn^{3+} to Mn^{2+} in the process of sintering. The peak at 32.9° can be attributed to $CoMn_2O_4$ phase and the peaks appeared at 18.1° , 29.2° and 60.6° can be attributed to a more complex $(Co,Mn)(Co,Mn)_2O_4$ phase, which had a higher crystallinity.

2.5. XPS Characterization

The surface oxidation states and atomic concentrations of 10Mn/TiO₂ (773 K) and 10Mn-5Co/TiO₂ calcined at 673, 773 and 973 K were determined by XPS analysis. The photoelectron profiles of Mn 2p and O 1s are shown in Figure 6. The atomic concentrations of Mn, Co and O are listed in Table 2. To evaluate Mn valence states, a peak-fitting deconvolution was performed for these profiles fitted with a mixing of Gaussian and Lorentzian peaks after removal of a Shirley background.




Figure 5. Cont.





Figure 5. TEM images of the catalysts: **(A)** $10Mn-5Co/TiO_2$ (673 K); and **(B)** $10Mn-5Co/TiO_2$ (773 K). (a. $CoMnO_3$ (012); b. $CoMnO_3$ (003); c. $CoMn_2O_4$ (111); d. anatase (101); e. MnO_2 (200); f. $CoMnO_3$ (012); g. $CoMnO_3$ (101)).



lower binding energy were attributed to Mn^{4+} , Mn^{3+} and Mn^{2+} , respectively [25,26]. Their relative atomic ratios in the surface layer are listed in Table 2. The increase of Mn^{4+} ratio after Co doping indicated the transformation of Mn^{2+} to Mn^{3+} and Mn^{3+} to Mn^{4+} by the addition of cobalt oxides. The reduction was resulted from the strong interaction between Mn and Co oxides. In addition, as the calcination temperature increased, the relative ratio of Mn^{4+} decreased gradually while the relative ratio of Mn^{2+} increased. The main valence state of manganese in Mn-Co/ TiO_2 (673 K) was Mn^{4+} , whereas Mn^{2+} was the dominant valence state in the catalyst calcined at 973 K. It can be concluded that the Mn^{4+} oxidation state was responsible for the activity of NO oxidation at low temperatures.

Figure 6B shows the O 1s XPS spectra for these catalysts. The O 1s spectra can be separated into two peaks at around 528.6-529.2 eV and 530.5 eV. The higher binding energy one with less intensity was ascribed to adsorbed oxygen or surface hydroxyl species [27,28], referred to as O_{α} , whereas the lower binding energy one was due to lattice oxygen O^{2-} [28,29], denoted as O_{β} . The value of binding energy of $O_{\mbox{\scriptsize B}}$ decreased from 529.2 to 528.6 eV when the calcination temperature increased from 773 to 973 K. The binding energies of 529.2 and 528.6 eV were attributed to the lattice oxygen of anatase TiO₂ and rutile TiO₂, respectively. The ratios of O_{α} : O_{β} in Table 2 showed an increase in chemical adsorbed oxygen by doping of Co oxides. The reason is that as a nonstoichiometric compound-like, Co oxides can adsorb and exchange oxygen easily in several surface layers [15,30], and then promote oxygen adsorption. In addition, it was found out that the relative ratio of O_{α} reduced from 54% to 17% when calcination temperature increased from 673 K to 973 K, indicating the inhibition for adsorption of oxygen after high-temperature calcination. The XPS results indicated that the decline of NO oxidation efficiency was related to the decrease of chemical adsorbed oxygen. Wu et al. [31] have suggested that chemisorbed oxygen was helpful to the oxidation of NO to NO₂.

2.6. H₂-TPR Characterization




Figure 7. H₂-TPR profiles of the catalysts Mn-Co/TiO₂ (773 K) with various Co contents: (**a**) 5Co/TiO₂; (**b**) 10Mn/TiO₂; (**c**) 10Mn-2Co/TiO₂; (**d**) 10Mn-5Co/TiO₂; (**e**) 10Mn-8Co/TiO₂; and (**f**) 10Mn-10Co/TiO₂.

Figure 7 presents the H_2 -TPR profiles of the Mn-Co/TiO₂ catalysts with various Co contents and calcined at 773 K. The reduction profile of 5Co/TiO₂ was also

provided to identify the peaks of Co oxides (Figure 7a). The profile of $5\text{Co}/\text{TiO}_2$ was characterized by two reduction peaks at 693 and 824 K, due to reduction of Co_3O_4 to CoO and CoO to Co° , respectively [32]. In terms of $10\text{Mn}/\text{TiO}_2$ (Figure 7b), two separate reduction peaks were observed. According to the literature [33], the lower temperature one at 670 K (T₁) could be ascribed to the reduction of MnO_2 to Mn_2O_3 . The higher temperature peak could be separated to two peaks at 763 and 796 K, corresponding to the reduction of Mn_2O_3 to Mn_3O_4 and Mn_3O_4 to MnO_7 respectively [33]. The prominent peak at 670 K indicated that MnO_2 was present in Mn/TiO_2 .

For the Mn-Co/TiO₂ catalysts with various Co contents (Figure 7c–f), it can be seen that after the addition of Co oxides into Mn/TiO₂, the profiles of the first and second peaks were similar to the reduction peaks of Mn/TiO₂. These two peaks became more and more narrow and their intensities increased with increasing Co content. Meanwhile, the summits shifted toward low temperature with the increase of Co content. As can be seen, after 10 wt. % Co was added into the catalyst, the first peak at 625 K was lower for about 45 K than the first reduction peak of Mn/TiO₂, and lower for about 68 K than that of Co/TiO₂. Consequently, it can be deduced that an interaction existed between Mn and Co oxides, leading to the down-shift of the reduction temperature and related to the higher NO oxidation efficiency at low temperatures for Mn-Co/TiO₂. Combining with the XPS results, the interaction between Mn and Co ions can be represented as reaction (1):

It is known that the Co³⁺ probably corresponds to [Co²⁺Co³⁺₂O₄] with a normal spinel structure [30]. Based on XRD and TEM results, CoMnO₃ is the main physical phase on Mn-Co/TiO₂ (773 K). From the perspective of standard electrode potential, the standard electrode potential of Co³⁺→Co²⁺ is higher than that of $Mn^{4+} \rightarrow Mn^{3+}$ [34], and the lower the standard electrode potential, the more easily the coordinated oxygen is obtained. Apparently, if the oxygen vacancy exists in the mixed oxide of Co_3O_4 and $CoMnO_3$, the oxygen ion will preferentially coordinate to Mn^{4+} ion rather than Co³⁺ ion, which will lead to oxygen vacancy of Co₃O₄. Meanwhile, Co₃O₄ adsorbs oxygen easily on Co-contained surface and exchange with the oxygen on several surface atom layers to form $Co_3O_{4+\nu}$: CoMnO₃ [15,30]. These oxygen ions are highly active and reduced easily, leading to the shift of the reduction peak toward lower temperatures compared with the Co/TiO₂. Consequently, Co doping into Mn/TiO₂ can lower the reduction temperature. When the y is small, we write Co₃O_{4+y}·CoMnO₃ as Co₃O₄·CoMnO₃. Therefore, the first peak of Mn-Co/TiO₂ could be ascribed to the reduction of the compound Co₃O₄·CoMnO₃. The second and third reduction peak temperatures were also lower than those of Mn/TiO₂ in

the similar way. Combining with XRD and XPS results, the second peak could be ascribed to the reduction of the composite oxide $CoMn_2O_4$ and the third peak could be ascribed to the reduction that the final product was $CoO^{\circ}MnO$. These two peaks trended to combination with increasing Co content, probably due to the strong oxygen adsorption ability of Co oxides. Consequently, the Mn^{3+} ions were easy to be directly reduced to Mn^{2+} . The fourth peak was due to the reduction of Co^{2+} to Co° . It shifted toward higher temperature after co-doping of Mn oxides. The Mn^{3+} ions are much reducible than the Co^{2+} ions and request lower activation energy for reduction. Accordingly, the Co^{2+} can be reduced only until the Mn^{3+} ions were reduced completely.




Figure 8. H₂-TPR profiles of 10Mn-5Co/TiO₂ catalysts calcined at various temperatures: (a) 573 K; (b) 673 K; (c) 773 K; (d) 873 K; and (e) 973 K.

Figure 8 shows the H_2 -TPR profiles of $10Mn-5Co/TiO_2$ catalysts calcined at various temperatures. The catalysts calcined at 573 and 673 K clearly showed similar reduction peaks. The T_1 and T_2 peaks were mainly due to the reduction of Co_3O_4 ·CoMn O_3 and $CoMn_2O_4$, respectively. The intensities of the two peaks decreased gradually and the peaks broadened with the increase of calcination temperature. It indicated that the Mn-O-Co mixed oxides formation and the oxygen mobility of Mn-O-Co were affected by the calcination temperature. The

TPR results were associated with the NO oxidation ability in Figure 2. For the Mn-Co/TiO₂ calcined at 573 and 673 K, the H₂ reduction peaks of T₁ corresponded to their NO oxidation peaks at 443 K. This also demonstrated that the formation of highly dispersed $\text{Co}_3\text{O}_4\cdot\text{CoMnO}_3$ through synergistic interaction between Mn-O and Co-O was responsible for the enhanced activities towards NO oxidation. The high calcination temperature leads to catalyst sintering, difficulty in oxygen mobility of Mn-O-Co, the reduction of Mn⁴⁺ to Mn³⁺ and Mn²⁺, and the transformation of CoMnO₃ to (Co,Mn)(Co,Mn)₂O₄. These factors are responsible for the decrease of NO oxidation efficiency.

3. Experimental Section

3.1. Catalyst Preparation

The catalysts were prepared by wet impregnating method using TiO_2 P25 (99.5%, Evonic Degussa, Germany) as support materials. $Mn(NO_3)_2$ solution (50.0%, Damao, Tianjing, China) and $Co(NO_3)_3 \cdot 6H_2O$ (99.0%, Damao, Tianjing, China) were used as the precursors. The required amounts of precursors were dissolved into 5 mL deionized water and then 6.0 g of support was added into the solution. The mixed solution was stirred for 1 h and left at room temperature for 24 h. Subsequently, the samples were dried at 383 K for 12 h, followed by calcination in air for 3 h

at 573–973 K. The manganese loadings were selected as 10 wt. %, and the cobalt contents were varied ranging from 0 to 10 wt. %. The catalysts were simply denoted as xMn-yCo/TiO₂ (T), where x and y represented the weight percentages of Mn and Co to TiO₂, respectively, and T represented the calcination temperature.

3.2. Catalyst Evaluation

The catalytic activity tests were carried out in a fixed bed quartz reactor (i.d. 8 mm) containing 0.15 g of the catalyst (60–100 mesh). The simulated gas mixture (contained 400 ppm NO, 5 vol. % O_2 and Ar balance) was fed to the reactor with a gas hourly space velocity (GHSV) of 42,000 h⁻¹. The reaction temperature was increased from 373 to 593 K at a heating rate of 1 K/min. The reactor temperature was controlled by a thermocouple and a PID-regulation system (CKW-2200, Bachy, Beijing, China). The outlet gas was monitored using an online nitrogen oxides analyzer (EC9841B, Ecotech, Ferntree Gully, Australia) to test the concentrations of NO, NO₂ and NO_x.

The percentage of NO oxidation to NO₂ was calculated as Equation (2):

3.3. Catalyst Characterization

Specific surface area and pore size distribution of the samples were measured using a BELSORP-mini II instrument (Ankersmid, Holland), through nitrogen adsorption at liquid nitrogen temperature (77 K) after degassing samples in vacuum at 573 K for 3 h.

The crystalline phases of the catalysts were determined by X-ray diffractometer (RIGAKU, D/Max 2500PC, Tokyo, Japan) in the 2θ angle range of 10– 80° using Cu K α radiation combined with nickel filter.

Detailed physical structural characteristics were observed with a transmission electron microscope (Tecnai G² F30, FEI, Hillsboro, OR, USA). Samples were prepared by ultrasonic dispersion in ethanol. The suspension was deposited on a Lacey-carbon film (Beijing, China), which was supported on a copper grid.

The surface oxidation states and atomic concentrations of samples were analyzed by a X-ray photoelectron spectrometer (ULVAC-PHI 1800, Tokyo, Japan) using Al K α as a radiation source. The binding energy of the C 1s peak at 284.6 eV was taken for correcting the obtained spectra.

The H_2 -Temperature programmed reduction experiments were carried out with 0.05 g catalysts under a total flow rate of 40 mL/min. Before the TPR measurements, the catalysts were pretreated in a flow of N_2 at 573 K for 1 h and subsequently cooled to 323 K. Then the TPR runs were carried out from 323 to 923 K with a flow of 5% H_2/N_2 at a heating rate of 10 K/min. The consumption of H_2 was continuously

monitored using an online gas chromatograph (GC 6890, Qingdao, China) with a thermal conductivity detector (TCD).

4. Conclusions

A series of Mn-Co/TiO₂ catalysts were prepared by wet impregnation method and developed for the catalytic oxidation of NO to NO₂ below 593 K. The bimetallic catalysts Mn-Co/TiO₂ showed higher catalytic abilities than the Mn/TiO₂ and Co/TiO₂ within the temperature range of 403–473 K. The Mn-Co/TiO₂ calcined at 573 and 673 K showed excellent activities for NO oxidation at low temperatures. The correlations among the catalytic performances and the redox properties of the catalysts were investigated. It was found from the XRD, TEM and H₂-TPR results that the CoMnO₃ mixed oxides were formed, which led to the shift of the reduction peak toward low temperatures. The XPS results revealed the increase of chemical adsorbed oxygen and Mn⁴⁺ ratio by doping Co into Mn/TiO₂. Increasing calcination temperature led to the decrease of chemical adsorbed oxygen amounts and the reduction of Mn⁴⁺ to Mn³⁺ and Mn²⁺. In conclusion, the higher the amount of chemically adsorbed oxygen, the higher the amount of Mn⁴⁺ ions, and the formation of dispersed Co₃O₄·CoMnO₃ mixed oxides were helpful to the oxidation of NO to NO₂ at low temperatures.

Aerobic Catalytic Oxidation of Cyclohexene over TiZrCo Catalysts

Abstract: The aerobic oxidation of hydrocarbon is of great significance from the viewpoints of both fundamental and industry studies as it can transfer the petrochemical feedstock into valuable chemicals. In this work, we investigated the aerobic oxidation of cyclohexene over TiZrCo catalysts, in which 2-cyclohexen-1-one was produced with a high selectivity of 57.6% at a conversion of 92.2%, which are comparable to the best results reported for the aerobic oxidation of cyclohexene over heterogeneous catalysts. The influences of kinds of solvent, substrate concentration and reaction temperature were evaluated. Moreover, the catalytic performance of the TiZrCo catalyst and the main catalytic active species were also discussed. The results of SEM, XRD and XPS suggested that the surface CoO and Co₃O₄ species are the catalytic active species and contribute to the high activity and selectivity in the present cyclohexene oxidation. The present catalytic system should have wide applications in the aerobic oxidation of hydrocarbons.

1. Introduction

The selective oxidation of hydrocarbon is of great importance in the chemical industry, and the oxidation of alkenes to value-added chemicals has been paid more attention [1–4]. For example, 2-cyclohexen-1-one, which can be produced from oxidation of the C–H bond at the allylic site of cyclohexene, is one of the important fine chemicals because it is widely used in the manufacture of perfumes, pharmaceuticals, dyestuff and agrochemicals [5–7]. However, the yield of 2-cyclohexen-1-one produced from cyclohexene oxidation is quite low due to the existence of two active sites (C–H and C=C bond) on the cyclohexene molecule [8]. Thus, it is still a great challenge to enhance the selectivity of 2-cyclohexen-1-one by designing an efficient catalyst. For oxidation of cyclohexene, the traditional oxidants are iodosylbenzene, sodium hypochlorite, chromium trioxide, t-butyl hydroperoxide, H₂O₂, *etc.* These strong oxidants can improve the oxidation rate and increase the yield of product, but they are expensive and harmful to the environment. Therefore, developing a green oxidation process is of importance in view of the academic research and industrial application. Recently, the oxidation with molecular

oxygen as an oxidant has received much attention as it is a cheap, abundant and environmentally benign process and some achievements have been obtained [9-13]. For example, the ionic liquids with metal chelate anion $[C_{10}mim][C_0(F_6-acac)_3]$ exhibited high catalytic activity for the allylic oxidation of cyclohexene in the absence of solvent with a high selectivity of 81% to 2-cyclohexen-1-one at a conversion of 100% [10], and the Cu-[cationic salphen][Br-]₂ complex presented a selectivity of 64.1% to 2-cyclohexen-1-one at a 100% conversion for the aerobic oxidation of cyclohexene in acetonitrile [11]. Although these homogeneous catalysts are efficient for the selective allylic oxidation of cyclohexene, their industrial application is limited due to the difficult separation, and the residual metal ions will affect the quality of the product. Hence, heterogeneous catalysts have been developed by immobilizing metal complexes on solid supports, such as resinate-immobilized Co(II), which exhibited high catalytic activity with a 44.4% selectivity to 2-cyclohexen-1-one at a 94.5% conversion of cyclohexene [12]. Core-shell type Fe₃O₄@chitosan-Schiff base-immobilized Co(II), Cu(II) and Mn(II) complexes were also reported active for the cyclohexene oxidation, and a selectivity of 77.2% to 2-cyclohexen-1-one was obtained at a conversion of 46.8% [13]. On the other hand, the supported transition metal or oxides were also employed as heterogeneous catalysts for the allylic oxidation of cyclohexene [6,14–20]. Recently, Au nanoparticles supported on modified bentonite and silica gave a high conversion (92%) and an excellent selectivity (97%) to 2-cyclohexen-1-one in the aerobic oxidation of cyclohexene without solvent [21]. It was also reported that PdO/SBA-15 was an active catalyst for the oxidation of cyclohexene in acetonitrile, and a conversion of 56% and a selectivity of 82% to 2-cyclohexen-1-one were obtained [6]. In addition, nitrogen-doped carbon nanotubes, and graphitic carbon nitride-supported FeO and CoO were also effective catalysts for the oxidation of cyclohexene [14,22]. Until now, it was still a hot topic to design a heterogeneous catalyst for the aerobic allylic oxidation of cyclohexene.

In our previous work, we found that Ti-Zr-Co metallic catalyst was effective for the oxidation of cyclohexane and ethylbenzene [23–25], in which cyclohexanol and cyclohexanone were produced with a high selectivity of 90% at a conversion around 7%, and acetophenone was produced with a 69.2% selectivity at a high conversion of 61.9%. The Ti-Zr-Co metallic catalyst is simple and cheap in production and sturdy to wearing in the utilization, as compared to those reported catalysts such as metal-organic complex, metal nanoparticles and nanocarbon materials. Therefore, it inspires us to study its efficiency in catalyzing other hydrocarbon oxidations. In the present work, the catalytic performances of the Ti-Zr-Co catalysts were discussed for the aerobic oxidation of cyclohexene. We found that 2-cyclohexen-1-one was produced with a high selectivity of 57.6% at a conversion of 92.2%, which are comparable to the best results reported for the aerobic oxidation of cyclohexene

over heterogeneous catalysts. It was confirmed the surface CoO and Co₃O₄ acted as the catalytic active sites and contributed to the excellent conversion and selectivity.

2. Results and Discussion

For the oxidation of cyclohexene, it is very difficult to control product selectivity due to the existence of the two active groups of the C-H bond at the allylic site and the C=C bond, as when the C-H bond is oxidized, 2-cyclohexene-1-ol, 2-cyclohexene-1-one or cyclohexene hydroperoxide will be generated; as the C=C bond is oxidized, cyclohexene oxide, cyclohexanol, cyclohexanone, cyclohexanediol and dialdehyde will be produced (Scheme 1) [26].

Firstly, we examined several organic solvents for the oxidation of cyclohexene and the results are listed in Table 1. Among the examined solvents, acetone and acetonitrile are more effective, and the higher conversion and selectivity of 2-cyclohexen-1-one were obtained; in contrast, ethanol and cyclohexane are less efficient. However, it was found that acetone could be oxidized (to 2,2-diethoxypropane) during the reaction. As a result, acetonitrile is a suitable solvent which led to a conversion of cyclohexene of 38.0% and a selectivity to 2-cyclohexen-1-one of 60.6%. Therefore, the acetonitrile was selected as solvent in the following studies.

Next, the reaction conditions were evaluated for the oxidation of cyclohexene in acetonitrile. The results for the effect of the concentration of cyclohexene are shown in Table 2. The conversion of cyclohexene increased significantly with the concentration of cyclohexene; it increased from 33.8% to 97.5% when the cyclohexene concentration was raised from 4.8% to 13.0%. However, the selectivity to 2-cyclohexen-1-one decreased linearly due to deep oxidation of 2-cyclohexen-1-one to undesired byproducts at a higher conversion. The aerobic oxidation of cyclohexene is a radical reaction; it contains the chain-initiation, -propagation and -termination steps [1]. The produced radical in the initial step could promote the following steps and was more efficient at higher cyclohexene concentrations as it enhanced the impact probability of radicals, resulting in an increase of the conversion of

cyclohexene. It is notable that when the concentration of cyclohexene increased to 16.7%, the reaction became very violent with a sharp increase of pressure (up to 10 MPa at 3.3 h); for safety, the concentration of cyclohexene was controlled below 16.7% under the present reaction conditions.




Figure 1. Effect of temperature on the oxidation of cyclohexene. Reaction conditions: acetonitrile 20 mL, cyclohexene 1 mL (at a concentration of 4.8%), $Ti_{60}Zr_{10}Co_{30}$ 20 mg, 2 MPa O_2 , 12 h.

It is well known that temperature is one of the most important factors for oxidation reactions. Generally, high temperature is in favor for the oxidation of hydrocarbons. As the results show in Figure 1, the conversion increased from 17.8% to 98.2% while the selectivity of 2-cyclohexen-1-one decreased from 70.1% to 43.7% with the temperature rising from 80 to $140\,^{\circ}$ C. Deep oxidation is serious at higher temperatures and undesirable byproducts such as ring-opening acids are produced. The selectivity of cyclohexene oxide, cyclohexanol and cyclohexanone changed

slightly, within 5%. The optimal temperature was 120 °C, at which a 57.6% selectivity of 2-cyclohexene-1-one was obtained at a high conversion of 92.2%.




Figure 2. The variation of the conversion and selectivity with extending reaction time. Reaction conditions: cyclohexene 2 mL (at a concentration of 9.1%), acetonitrile 20 mL, $Ti_{60}Zr_{10}Co_{30}$ 20 mg, 2 MPa O_2 , 120 °C.

In addition, the influence of reaction time on the conversion and product selectivity were examined at conditions of $120\,^{\circ}$ C, a cyclohexene concentration of 9.1% and an oxygen pressure of 2 MPa. As shown in Figure 2, the conversion increased to 96.1% with extending the reaction time to 8 h. The selectivity of 2-cyclohexen-1-ol and 2-cyclohexen-1-one decreased from 20.3% to 4.0% and 68.8% to 55.3% due to the formation and accumulation of deep oxidation products with the reaction proceeding. The other products derived from deep oxidation such as the ring-opening acids increased with a selectivity up to 40% (8 h) from 6% (1 h), and the intermediates such as cyclohexene oxide, cyclohexanol and cyclohexanone changed very little (<5.5%).




Figure 3. Comparison of the catalytic performances of different catalysts in the oxidation of cyclohexene. Reaction conditions: cyclohexene 2 mL, acetonitrile 20 mL, catalyst 20 mg, O_2 2 MPa, 120 °C, 3 h.

Generally, the aerobic radical oxidation of hydrocarbons can automatically occur in the absence of catalyst [27], but it is very slow and the selectivity of the desired product is poor. The oxidation of cyclohexene can also automatically occur somewhat at certain conditions without catalyst; however, the conversion and selectivity to 2-cyclohexen-1-one are quite low [22]. Herein, we also found that the cyclohexene can convert with a conversion of 14.4% under the aerobic oxidation conditions without catalyst. As expected, the presence of TiZrCo catalysts can promote the reaction rate significantly as shown in Figure 3. The catalytic performances of TiZrCo catalysts were discussed according to the composition and the surface active species. It is clear that the catalytic activity depends on the Co content in the TiZrCo metallic catalysts, as the conversion of cyclohexene increased to 38.5% over $Ti_{50}Zr_{10}Co_{40}$ from 32% over $Ti_{70}Zr_{10}Co_{20}$, while the selectivity to 2-cyclohexene-1-one was around 66%–69%, and changed very little. These results indicate that the ternary TiZrCo metallic catalysts

are effective for the present cyclohexene oxidation, and the content of Co affects the catalytic activity significantly. In order to check the catalytic efficiency of Co species in the present oxidation, $CoTi_2$ and Co_3O_4/TiO_2 with the higher content of Co species were also examined. Unfortunately, both of them gave lower activity compared to the ternary TiZrCo metallic catalysts, as seen in Figure 3. These results suggested not only the Co species but the surface and bulk structure of the TiZrCo catalysts play an important role in the present oxidation. It is assumed that the addition of Zr may produce surface defects and induce the formation of many more CoO and Co_3O_4 active species.




Figure 4. The SEM image of $Ti_{60}Zr_{10}Co_{30}$ (a); and the XRD patterns of Ti-Zr-Co catalysts and the JCPDS 07-0141 file identifying CoTi₂ (b).

Therefore, the structure of the TiZrCo catalysts and their relationship to the catalytic performances were discussed. The SEM image of a representative sample of $Ti_{60}Zr_{10}Co_{30}$ is shown in Figure 4a. The size of the particles is at a range of 50–100 µm, and the other two samples with different compositions should have a similar morphology as all the samples were crushed and screen-separated by 140 meshes before being examined. The bulk structure of these samples was characterized with XRD as shown in Figure 4b. For $Ti_{60}Zr_{10}Co_{30}$, with a molar ratio of Co/Ti of 1/2, the diffraction patterns are in accordance with the CoTi₂ phase without other crystal phases. For $Ti_{70}Zr_{10}Co_{20}$, an I-phase was found beside the CoTi₂ phase [28]. However, for $Ti_{50}Zr_{10}Co_{40}$, a new CoTi phase was detected beside the CoTi₂ phase.




Figure 5. The XPS spectra of (a) Co 2p; (b) Ti 2p and (c) Zr 3d for Ti-Zr-Co catalysts.

Therefore, the variation of Co content will impact the bulk structure of TiZrCo significantly, which may have an effect on the catalytic activity. By comparison, the surface species will play a more important role in the catalysis due to the catalytic reaction always occurring on the surface of the heterogeneous catalyst. The surface composition of TiZrCo was studied by XPS. As shown in Figure 5, the Ti and Zr existed on the surface with oxidation states of TiO_2 and TiO_2 , and Co mainly existed on the surface with metallic Co, oxides of CoO and TiO_2 and TiO_3 as confirmed by the peak at the binding energy of 777.6 eV and intense shake-up satellites Co 2p XPS spectra around 6 eV above the primary spin-orbit Bes [29–31]; TiO_3 was confirmed by TiO_3 are listed in Table 3. To consider the main active species of the Co element, it is clear that all the catalysts contained the same species of Co, CoO and TiO_3 on their surfaces, including TiO_3 . The most active TiO_3 catalyst contains a higher ratio of CoO on the surface and different bulk phases, which suggested CoO may be more effective than the TiO_3 species, and the bulk phase

may be also involved in the present catalysis based on the reaction results in Figure 3. In addition, the surface area of TiZrCo catalysts was also examined, as shown in Table 3; it should have less effect on the present oxidation compared to the surface active species, as the $Ti_{70}Zr_{10}Co_{20}$ with the largest surface area did show a lower conversion, which contains a lower ratio of CoO and Co_3O_4 on the surface.

3. Experimental Section

3.1. Ti-Zr-Co Alloy Preparation

The series of Ti-Zr-Co alloys, as reported in our previous works [25], were prepared by arc-melting of Ti (99 wt. %), Zr (97 wt. %) and Co (99 wt. %) metals with a certain mole ratio on a water-cooled cuprum hearth in a high-purity argon atmosphere at 250 A. To make the chemical compositions homogenous, the ingot of alloy was turned over and remelted at least three times. After that, the surface of the cast ingot was burnished in order to eliminate the oxide layer. Then the alloy ingot was crushed by repeated manual beating with a steel pestle and mortar, and the alloy powders were screen separated by 140 meshes.

3.2. Catalyst Characterization

The phase composition and microstructure of the alloys were examined by X-ray diffraction (XRD) on a Bruker-AXS D8 ADVANCE (Bruker AXS, Karlsruhe, Germany) with K α . The leaching of Ti, Zr or Co in the filtrate was not detected by ICP-OES measurement (iCAP6300, Thermo Waltham, MA, USA). XPS measurements were performed by using a VG Microtech 3000 Multilab. The electronic states of Co 2p, Zr 3d and Ti 2p were determined. All XPS spectra were corrected to the C 1s peak at 284.6 eV. Scanning electron microscopy (SEM) image was performed on a Hitachi S-4800 field emission scanning electron microscope (HITACHI, Tokyo, Japan) at an accelerating voltage of 10 kV, and the size of particles was in a range of 50–100 μ m. Nitrogen porosimetry measurement was performed on a Micromeritics ASAP 2020M instrument (Micromeritics, Norcross, GA, USA). The surface areas were calculated using the BET equation.

3.3. Catalytic Tests

The catalytic performance was tested in a stainless steel autoclave with a Teflon inner liner (50 mL). Typically, the Ti-Zr-Co catalyst (20 mg), cyclohexene (2 mL) and acetonitrile (20 mL) were added. The reactor was then sealed, and placed into an oil bath preset to 120 °C for 5 min. O_2 (2 MPa) was introduced and the reaction was started with a continuously stirring at 1200 rpm. When the reaction finished, the reactor was cooled to room temperature and then depressurized carefully. Then the reaction solution was diluted with ethanol to 50 mL, the composition of reaction products was confirmed by gas chromatography/mass spectrometry (Agilent 5890, Santa Clara, CA, USA) and analyzed with a gas chromatograph (Shimadzu, Kyoto, Japan, GC-2010) equipped with a capillary column (RTX-50, Bellefonte, PA, USA, 30 m \times 0.25 mm \times 0.25 mm, carrier: N_2) and a flame ionization detector (FID).

Safety warning: The use of compressed O₂ in the presence of organic substrates requires appropriate safety precautions and must be carried out in suitable

equipment. When the pressure decreased far more quickly, the reaction must be stopped immediately. Note, the reaction should be diluted by solvent, otherwise, the blast occur as the reaction is very violent.

4. Conclusions

In summary, TiZrCo catalysts were studied for the first time for the oxidation of cyclohexene. High selectivity (57.6%) to 2-cyclohexen-1-one was obtained at a high conversion (92.2%) of cyclohexene. CoO and Co_3O_4 on the surface are the main active species and contribute to the high activity and selectivity in the present cyclohexene oxidation. These results indicate that TiZrCo metallic catalysts are effective for the aerobic oxidation of cyclohexene. It is important and significant to extend the studies of the metallic alloy catalyst in catalyzing the aerobic oxidation of hydrocarbons. It is expected that the TiZrCo catalysts may have a broad prospect in industrial applications.

Phosphotungstate-Based Ionic Silica Nanoparticles Network for Alkenes Epoxidation

Abstract: An inorganic-organic porous silica network catalyst was prepared by linking silica nanoparticles using ionic liquid and followed by anion-exchange with phosphotungstate. Characterization methods of FT-IR, TG, SEM, TEM, BET, *etc.*, were carried out to have a comprehensive insight into the catalyst. The catalyst was used for catalyzing cyclooctene epoxidation with high surface area, high catalytic activity, and convenient recovery. The conversion and selectivity of epoxy-cyclooctene could both reach over 99% at 70 $^{\circ}$ C for 8 h using hydrogen peroxide (H₂O₂) as an oxidant, and acetonitrile as a solvent when the catalyst was 10 wt. % of cyclooctene.

1. Introduction

Inorganic-organic hybrid [1–8] materials have attracted considerable interest as the combination of the features of different parts can generate high performance. As the development of nanoscale materials, SiO₂ has indeed stimulated remarkable scientific interest because of its excellent performance and promising applications in scientific and technological fields. In contrast to other inorganic materials, the preparation of SiO₂ nanoparticles has been very mature with a wide source of raw materials, and they possess the merits of high specific surfaces, as well as excellent thermal stabilities. Furthermore, the presence of a large number of silanol (Si–OH) groups on the surface makes it easily for surface organic functionalization [9,10]. Ionic liquids, a class of new type of green environmental protection organic compounds with outstanding properties, were introduced as the organic part, recently. The resulting materials can be applied into numerous fields, like catalysts, anion exchange, selective gas trapping, drug delivery, or electrochemistry [11].

The modification of silica nanoparticles with ionic liquids has been already reported by some researchers [12–14]. Ionic liquids are usually just grafted or absorbed onto the surface for next use. However, this is no longer a hot spot and novel method. Meanwhile, it remains separation problems if the nanoparticles are smaller than a certain size. For a few years now, the newly-arising challenge in the field of nanoparticle research is focusing on the development of specific materials based

on assemblies of nanoparticles, which approaches to make use of the nanoparticle collective properties [15–20]. Thus, a silica network is being prepared by connecting silica nanoparticles with ionic liquid to take the advantage of covalent link of ionic liquid by two different parts.

Epoxides are important raw materials in chemical industrial production [21]. Polyoxometalates (POMs), as is known to all, have been widely used as epoxidation catalysts with H_2O_2 for their high efficient active centers [22–24]. However, POMs, themselves, are low efficient and soluble in some epoxidation systems which results in the difficulty in separation of the catalysts. Therefore, ionic liquid-based POM hybrid catalysts come into being.

In this study, we first prepared a silica network by connecting silica nanoparticles with covalent-linked ionic liquid. This material was proved to be porous with high surface area. Phosphotungstic acid anions were then introduced into the material by ion exchange between Keggin-type $H_3PW_{12}O_{40}$ and ionic liquid as well as protonation of amino group. Ionic liquid had played an important role in two aspects: linking silica nanoparticles and introduction of an active center. The catalysts were used in catalytic epoxidation of olefin for the first time. Structural characteristics and catalytic performance of as-prepared catalysts were carried out to have a comprehensive insight into the catalyst. The study potentially propels the development of nanoparticle networks as promising materials for various fields to take advantage of the collective properties of nanoparticles.

2. Results and Discussion

2.1. Characterization

2.1.1. FT-IR Analysis




Figure 1. FT-IR spectra of (a) SiO_2 ; (b) SiO_2 -Im; (c) SiO_2 -Cl; (d) SiO_2 Im⁺Cl⁻ SiO_2 ; (e) $PW(0.058)/SiO_2$ Im⁺Cl⁻ SiO_2 .

The basic modification moieties on the SiO₂ particles were characterized by FT-IR, which were shown in Figure 1. The bands at 3450 and 1630 cm⁻¹ were corresponding to stretching and bending vibrations of surface Si–OH groups on the surface of SiO₂. After grafting with silane coupling agent, the peak intensity decreased and new bands that assigned to the C–H stretching and bending rocking mode respectively appeared in the region of 2970 cm⁻¹ and 1460 cm⁻¹ (Figure 1b–e), which indicated the successful functionalization on the surface of SiO₂ particles. The other bands at 1100 cm⁻¹ and 814 cm⁻¹ were attributed to symmetric and anti-symmetric stretching vibration of Si–O–Si, and band at 960 cm⁻¹ was attributed to the Si–O stretching vibration of Si–OH. For PW (0.058)/SiO₂ Im⁺Cl⁻ SiO₂, a band at 890 cm⁻¹ appeared in Figure 1e, which was assigned to asymmetric stretching of W–O_b–W in the corner-shared octahedral of Keggin-type HPW. Other characteristic bands at 1080, 983, and 805 cm⁻¹ were all overlapped with the bands of SiO₂.

2.1.2. Thermal Stability and Structure




Figure 2. Thermogravimetric curves of (a) SiO_2 ; (b) SiO_2 -Cl; (c) SiO_2 -Im; (d) SiO_2 Im⁺Cl⁻ SiO_2 ; and (e) $PW(0.058)/SiO_2$ Im⁺Cl⁻ SiO_2 .

The TG analyses of SiO₂, SiO₂-Cl, SiO₂-Im, SiO₂ Im⁺Cl⁻ SiO₂, and PW (0.058)/SiO₂ Im⁺Cl⁻ SiO₂ were shown in Figure 2. For the pure SiO₂ nanoprticles (Figure 2a), the weight loss of 5.65 wt. % could be only observed before 100 °C, which was assigned to the desorption of water. No weight loss could be seen even with the increasing of temperature to 800 °C. In reality, the formed ionic units of imidazolium presents a higher thermal stability than the aromatic precursors. The precursors started to decompose before 200 °C, while the imidazolium mainly decomposes around 300 °C. From Figure 2b,c, SiO₂-Cl started to decompose at 180 °C, SiO₂-Im started to decompose at 120 °C, and the main weight loss was around 400 °C. From Figure 2d, the first stage ranging from 25 to 120 °C was ascribed to the elimination of adsorbed water. After 120 °C the unreacted organic groups started to decompose and the weight loss around 300 °C was mainly attributed to the decomposition of imidazolium ionic units, which could verify the occurrence of nucleophilic reactions, on one hand. For the $PW(0.058)/SiO_2$ Im⁺Cl⁻ SiO₂ (Figure 2e), the mass loss after 300 °C also contained the collapse of PW anions in the remainder form of P₂O₅ and WO₃.

2.1.3. SEM, EDS, TEM, and DLS Characterization

The morphology changes between SiO₂ nanoparticles and the modified product of SiO₂-Cl, SiO₂-Im, and SiO₂ Im⁺Cl⁻ SiO₂ were provided by the SEM and TEM images presented in Figure 3. Figure 3a,b were the SEM images for SiO₂ nanoparticles before reaction, which presented scattered and small particles size of SiO₂. The particle size could be observed in TEM in Figure 3f,g with an average of 15 nm

diameter which was in slight agglomeration. After functionalization, the particle morphology of SiO₂-Cl and SiO₂-Im had almost no change (showed in (c) and (d)) compared to SiO₂ nanoparticles. Figure 3e,h showed the SEM and TEM micrographs after linking nanoparticles through the ionic liquid-like bond. The product, by observation of "islands", connected into a larger group, like sponge-cake with dispersed holes.




Figure 3. SEM, TEM and EDS images at different magnifications. (**a,b**) for SEM of SiO₂; (**c**) for SEM of SiO₂-Cl; (**d**) for SEM of SiO₂-Im; (**e**) for SEM of SiO₂ Im⁺Cl⁻ SiO₂; (**f,g**) for TEM of SiO₂; and (**h**) for TEM of SiO₂ Im⁺Cl⁻ SiO₂ respectively; (**i**) for EDS elemental mapping images of the Si, O, N, Cl, P, and W, respectively.

In order to get a profound insight into the microscopic structure, scanning SEM-energy dispersive spectroscopy (EDS) elemental mapping images of catalyst PW(0.058)/SiO₂-Im-SiO₂ was produced, and the results were shown in Figure 3i. Si, O, N, Cl, P, and W were uniformly distributed in this catalyst.




Figure 4. DLS measurement of (**A**) the starting SiO_2 nanoparticles; (**B**) SiO_2 -Im; and (**C**) resultant SiO_2 Im⁺Cl⁻ SiO_2 .

DLS (Dynamic Light Scattering) was carried out after dispersing the samples in ethanol with previous sonication and the results were shown in Figure 4. It also indicated that the particle size of the product SiO₂ Im⁺Cl⁻ SiO₂ was much larger than the one before reaction, which corresponded to the SEM and TEM micrographs. For Figure 4A, a diffraction peak could be observed around 30 nm. The result was larger than the measurement by TEM micrographs, which was due to the slight agglomeration. When reacting with *N*-(3-triethoxysilylpropyl)-4,5-dihydroimidazol, the particle size was slightly increased in Figure 4B. Nevertheless, for the resulted SiO₂ Im⁺Cl⁻ SiO₂, the most average size showed in Figure 4C was at 700 nm after nucleophilic reaction. The smaller size distribution was due to the incomplete or partial reaction of the functionalized silica particles. Overall, this size was much larger than SiO₂, also indicating the change after the reaction.

2.1.4. Nitrogen Sorption




Figure 5. Nitrogen adsorption-desorption isotherms (**A**) and pore size distribution (**B**) of the samples SiO_2 , SiO_2 $Im^+Cl^ SiO_2$, and PW/SiO_2 $Im^+Cl^ SiO_2$.

The porous characteristic of the materials were investigated Brunauer-Emmet-Teller (BET) method. The N2 adsorption-desorption isotherms and corresponding pore size distribution curves were shown in Figure 5 (the curves of PW/SiO₂ Im⁺Cl⁻ SiO₂ were particularly similar, so PW(0.058)/SiO₂ Im⁺Cl⁻ SiO₂ was chose as representative). All samples displayed typical type-IV isotherms with a clear adsorption-desorption hysteresis loops at the relative pressure of $0.8 < P/P_0 < 1$ (Figure 5, left) as well as broad pore size distribution (Figure 5, right). For the SiO₂ nanoparticles, the pore size was mainly distributed in less than 2 nm, which was due to the micropores of nanoparticles themselves. The size formed above 2 nm was mainly due to the accumulation between the particles. However, when linked by ionic liquid, the SiO₂ network and its catalyst showed more regular in pore size distribution between 20–40 nm. Data of surface area, pore diameter, and pore volume were presented in Table 1. The BET specific surface area of the prepared SiO₂ particles (entry 1) was as high as $381 \text{ m}^2 \cdot \text{g}^{-1}$ and the average pore size was 11.2 nm. When modified by organic reagents and then linked by nucleophilic reaction, specific surface of SiO₂ network (entry 2) was obviously lower than the pure SiO₂ due to the introduction of the organic moieties. After introducing phosphotungstic acid anions into the material by ion exchange, the specific surface of $PW(x)/SiO_2$ Im⁺Cl⁻ SiO₂ (entries 3–6) also decreased and were lower than the SiO₂ network. Meanwhile, compared to the pure SiO₂, the SiO₂ network and its catalysts exhibited an increase of pore size and pore volume. In particular, the pore size seemed more centralized. This increased the contact area of the substrate and catalysts and led to better catalytic effect. Meanwhile, increased PW anions loading of PW(x)/SiO₂ Im⁺Cl⁻ SiO_2 led to a gradual decrease in pore volume and average pore size (entries 3–6).

2.1.5. More Evidence of the Synthesis of the Network




Figure 6. XRD analyses of (**a**) the exchange solvent, after separation and washing; (**b**) NaBF₄. The obtained salt reflection was marked with a star and was consistent with NaCl.




Figure 7. EDX spectra of the resulting materials.

In order to further confirm the occurrence of nucleophilic substitution between the imidazoline functional group and chloroalkyl group, anion exchange experiment was carried out as an indirect proof. Once the nucleophilic substitution happened, the chloride ion was easily exchanged by the fluorinated anion to obtain the SiO₂ Im⁺BF₄⁻ SiO₂ and NaCl. First, we detected chloride ions in the solvent and washing phase by the signature of the halide salts in the X-ray diffraction pattern after drying (Figure 6). In the XRD pattern, the obtained salt reflection was marked with a star and was consistent with NaCl. The other Bragg peaks belonged to the fluorinated salt which was in an excess in order to confirm the exchange. Next, EDX analysis of the hybrid material SiO₂ Im⁺BF₄⁻ SiO₂, obtained after the exchange reaction also showed the existence of newly-introduced anions (Figure 7). Typical peaks of fluorine from the newly exchanged anions could be obviously observed while the boron was hidden by the carbon peak. After the exchange reaction, it was noted that chlorine could still be observed in a small amount. The presence of chlorine was due to the residue alkyl chloride groups which did not react with APTES or the residue chlorine ions which were not exchanged.

2.2. Catalytic Performances

It is known to all that the Keggin-type $[PW_{12}O_{40}]^{3-}$ (PW) can be degraded to peroxo-active species, $[PW_4O_8(O_2)_8]^{3-}$ species, by excess hydrogen peroxide, which is the active species in alkenes epoxidations [25]. The solvent has a great influence on the activity of catalytic reaction and acetonitrile is commonly used in epoxidation reaction as an efficient solvent. Moreover, using H_2O_2 as an oxygen source can do great benefits on the environment and industry [26]. Thus, Table 2 listed the catalytic performance of different catalysts for the epoxidation of cyclooctene in acetonitrile using aqueous 30% H_2O_2 as an oxidant. The results showed that the

catalyst PW/SiO $_2$ Im $^+$ Cl $^-$ SiO $_2$ had much better catalytic effect than the Keggin-type H $_3$ PW $_{12}$ O $_{40}$. One reason was the super-hydrophobic of H $_3$ PW $_{12}$ O $_{40}$, which made it difficult to contact with the oily substrates. Meanwhile, the cations of imidazolium and NH $_2$ $^+$ in imidazoline made it easier for the redox of PW. Physical loading of HPW on the pure SiO $_2$ nanoparticles was carried out and the catalytic activity was very low, which also illustrated the serviceability of SiO $_2$ Im $^+$ Cl $^-$ SiO $_2$ for loading the PW anions. In order to further compare the catalytic activity of the network catalysts with traditional silica grafted ionic liquid catalyst, we also performed a catalytic reaction in the presence of the imidazolium and the silica particles labeled as HPW/SiO $_2$ -IL which was prepared by nucleophilic reaction between SiO $_2$ -Cl and methylimidazole, and then reacted with phosphotungstic acid. The catalytic activity showed that the conversion was lower than the network catalysts with similar selectivity (Table 2, entry 4), which demonstrated that the formed network catalysts could lead to high conversion and selectivity.

Furthermore, Table 2 also showed that the loading of PW anions of PW/SiO₂Im⁺Cl⁻SiO₂ affected the catalytic activity of the catalysts. This was correlation with the amount of active sites in the catalyst and the inside structure of material. Obviously, PW(0.058)/SiO₂Im⁺Cl⁻SiO₂ showed the best activity. When the loading of PW anions was less than 0.058, the conversion decreased accordingly. However, excessive PW loading resulted in the agglomeration of excessive HPW in the channel, which might change the specific surface area and pore volume, therefore, led to the decrease of catalytic activity.

To investigate the importance of the IL moiety, the imidazoline based PW/SiO_2 -Im was prepared by stirring 0.6 g HPW with 1 g SiO_2 -Im, and the loading of PW were *ca.* 0.082 mmol/g. The catalytic activity and reusability were compared in Table 3. Imidazoline-modified SiO_2 can be protonated with

HPW. The results showed that the catalyst of PW/SiO₂-Im offered even higher conversion than PW(0.058)/SiO₂Im $^+$ Cl $^-$ SiO₂ in the first run. This is because of the increased protonating of SiO₂-Im per unit mass leading to more PW loading, and the PW(0.058)/SiO₂Im $^+$ Cl $^-$ SiO₂ also contains the part of SiO₂-Cl. However, the reusability of PW/SiO₂-Im was far less active than the catalyst of PW(0.058)/SiO₂ Im $^+$ Cl $^-$ SiO₂. There were two possible reasons: one was that the stability of NH₂ $^+$ in imidazoline was low and the other was that the recovery efficiency of individual SiO₂ nanoparticles was much lower than the collective SiO₂ network on account of the catalysts size.



2.2.1. Effects of Temperature and Time





Figure 8. Effect of temperature and time on (**A**) conversion; and (**B**) selectivity. (a): $60 \,^{\circ}\text{C}$; (b): $70 \,^{\circ}\text{C}$; and (c): $80 \,^{\circ}\text{C}$.

Each chemical reaction was accompanied by thermal effects. The same reaction carried out at different temperatures would result in quite different results. The reaction time was an important basis to judge it effective or not. The effects of temperature and time on the epoxidation of cyclooctene using catalyst PW(0.058)/SiO₂Im⁺Cl⁻SiO₂ were shown in Figure 8. It was observed that with the increase of temperature, the molecular energy, and relative content of activated molecules increased, which increased the effective collision between the reactant molecules, thereby improving the conversion. However, the increase of temperature also increased the possibility of ring rupture, resulting in the decrease of selectivity. When temperature reached 70 °C, the reaction had tended to balance. However, the conversion decreased at 80 °C and the selectivity was in a sharp decline which might be due to the excessive activation of the catalyst. And with the increase of reaction time, the conversion increased while selectivity decreasing. As a whole, the conversion and selectivity were both higher than 90% at 70 °C in 6 h; specifically, 94.4% and 99.3%, respectively.

2.2.2. Effect of Catalyst Dosage




Figure 9. Effect of temperature and time on (**A**) conversion and (**B**) selectivity. (a): 0.01 g; (b):0.02 g; (c): 0.03 g; (d): 0.04 g.

The influences of different catalyst amounts were investigated and the results were shown in Figure 9. It was indicated that the conversion increased with the increase of catalyst amount, but further improved slightly when the amount was over 300 mg. The selectivity had almost no change when the amount was over 200 mg. Taking economics and green chemistry into consideration, a low catalyst amount (200 mg) was used in further experiments.

2.2.3. Effect of Solvent

In order to investigate the general application of the synthetic catalyst in different solvents, the influences of solvents on the oxidation of cyclooctene were studied and the results were summarized in Table 4. Acetonitrile, methanol, ethanol, chloroform, 1,2-dichloroethane, and ethyl acetate were used as solvents. The results demonstrated that the solvents were general relevant to alkenes epoxidation, especially for acetonitrile, methanol, and chloroform. In particular, the catalytic reaction was more suitable in the polar solvent. Due to the high boiling point and stable selectivity of the product, acetonitrile was, thus, chosen as the reaction medium in our experiment.

3. Experimental Section


3.1. Materials and Methods

N-(3-triethoxysilylpropyl)-4,5-dihydroimidazol and 3-aminopropyltrimethoxysilane (APTES) were purchased from Meryer (Meryer, Shanghai, China). Other commercially-available chemicals were bought from local suppliers (Sinopharm Chemical Reagent, Beijing, China). All reagents were purified by standard procedures before use. FT-IR spectra were obtained as potassium bromide pellets in a Nicolet 360 FT-IR thermoscientific spectrometer in the 4000–400 cm⁻¹ region (Thermo Fisher Scientific, Waltham, MA, USA). The elemental analyses were performed on a CHN elemental analyzer (Elementar, Hanau, HE, Germany). TG analysis was carried out with a STA409 instrument in dry air at a heating rate of 10 °C⋅ min⁻¹ (Mettler Toledo, Zurich, Switzerland). SEM image was performed on a HITACHI S-4800 field-emission scanning electron microscope (Hitachi, Tokyo, Japan). Transmission electron microscopic (TEM) photographs of the prepared samples were taken in JEOL JEM 2100 electron microscope under an accelerating voltage of 200 kV (JEOL, Tokyo, Japan). The metal loading of the host materials of Tungsten were determined by inductively-coupled plasma atomic emission spectroscopy (ICP-AES) on a Perkin-Elmer AA-300 spectrophotometer (Shimadzu, Kyoto, Japan). Nitrogen adsorption/desorption isotherms were measured at -196 °C using a Quantachrome Quadrasorb SI automated gas sorption system

(Micromeritics instrument corp, Atlanta, GA, USA). Samples were degassed under vacuum for 5 h at 120 °C. The micropore volume was obtained with the t-plot method, while the Brunauer-Emmet-Teller (BET) method was applied to calculate the specific surface area. Pore size distributions were evaluated from desorption branches of nitrogen isotherms using the BJH model. The total pore volume was determined at P/P_0 0.95. The X-ray diffraction (XRD) pattern of the material was recorded on a Bruker D8 advanced powder X-ray diffractometer using Cu Ka (k = 1.5406 Å) as the radiation source in 20 range of 4°–70° with a step size of 4° and a step time of 1 s (Bruker Axs Gmbh, Karlsruhe, BW, Germany). DLS experiments were carried out with previous sonication of the samples. The run time of the measurements was 10 s. Every size distribution curve was obtained by averaging six measurements. The apparatus was an ALV/DLS/SLS-5022F light scattering electronic spectrometer (ALV-GmbH, Langen, Germany).

3.2. Catalyst Preparation

Silica nanoparticles, as well as the surface functionalization of the silica nanoparticles with N-(3-triethoxysilylpropyl)-4,5-dihydroimidazol and APTES, were prepared according to literature with minor modification [27]. The typical preparation procedure of the catalyst was in Scheme 1.

3.2.1. Synthesis of Silica Nanoparticles

 $74~\mu L$ ammonia solution (25%–28%) and 1.98 g (110 mmol) water were added to 100 mL absolute methanol in a 250 mL round bottom flask. The solution was stirred for 5 min before adding dropwise 10.41 g (500 mmol) TEOS. The final solution was stirred for three days at ambient temperature. The resulting solid was centrifuged and washed with methanol and water several times, and dried under vacuum.

3.2.2. Synthesis of Modified Silica Nanoparticles

0.6 g (0.01 mol) previously prepared silica nanoparticle was dispersed in 50 mL anhydrous toluene by sonication for 60 min. Then 0.005 mol N-(3-triethoxysilylpropyl)-4,5-dihydroimidazol (or APTES) was added dropwise. The solution was stirred under 110 °C for 24 h. The product was filtered, washed in a Soxhlet apparatus with diethyl ether and dichloromethane for 24 h, and then dried at 50 °C under vacuum. The obtained powder was named as SiO₂-Im and SiO₂-Cl, respectively.

3.2.3. Synthesis of Silica Nanoparticle Network

The synthesis was driven by a nucleophilic substitution occurring between an imidazoline functional group and a chloroalkyl group present on the surface of the silica nanoparticles. $0.5~\rm g$ silica nanoparticles modified with N-(3-triethoxysilylpropyl)-4,5-dihydroimidazol and $0.5~\rm g$ silica nanoparticles modified with APTES were introduced into a $100~\rm mL$ round bottom flask with $50~\rm mL$ anhydrous toluene. The solution was stirred over 2 days at $70~\rm ^{\circ}C$ and filtered, washed, finally dried under vacuum. A pale yellow powder was obtained and labelled as $\rm SiO_2$ Im $\rm ^{+}Cl^{-}$ SiO $_2$. Elemental analysis: found C: $7.25~\rm wt$. %, H: $1.45~\rm wt$. %, N: $1.96~\rm wt$. %.

3.2.4. Synthesis of Phosphotungstate-Loaded Silica Nanoparticle Network

Catalysts of PW(x)/SiO₂ Im⁺Cl⁻ SiO₂ with different H₃PW₁₂O₄₀ loadings on SiO₂ Im⁺Cl⁻ SiO₂ were prepared by following strategy. 1.0 g silica nanoparticle network was dispersed in 20 mL deionized water and then added dropwise into an aqueous solution (20 mL) with various amount of H₃PW₁₂O₄₀ (0.2 g, 0.6 g, 1.0 g, 1.4 g). The solution was stirred for 24 h at ambient temperature. Upon centrifugation, the precipitate was washed with deionized water several times, and then dried in vacuum overnight at room temperature. The obtained catalysts were labelled as PW(x)/SiO₂ Im⁺Cl⁻ SiO₂, where x was the loading amount of PW. The PW loading could be calculated by ICP-AES. The results showed that the loading of PW were ca. 0.035, 0.058, 0.074, or 0.17 mmol/g, respectively.

3.2.5. Anion Exchange Experiment

The starting compound SiO_2 Im $^+Cl^ SiO_2$ was dispersed in 25 mL acetone. The salt NaBF₄ for the exchange was added in mass in a ratio of 1:1, compared to the starting compound. The dispersion was stirred for 24 h at room temperature. Then, the resultant product SiO_2 Im $^+BF_4^ SiO_2$ was centrifuged and washed with acetone and deionized water. The solvent and washing phases were combined and evaporated under vacuum. The salt obtained after evaporation and was dried in vacuum over P_2O_5 . White powders are obtained as NaBF₄ and NaCl.

3.3. Catalytic Performance

Cyclooctene (2 mmol), CH_3CN (5 mL), and catalyst (0.02 g) were added to a 25 mL flask. The reaction started after the addition of aqueous H_2O_2 (30 wt. %, 6 mmol) at a definite temperature within 10 min under vigorous stirring. After reaction, the product mixture was analyzed by gas chromatography mass spectrometry (GC-MS). The catalyst was recovered by centrifugation, dried and used for the next run.

4. Conclusions

In this research, a silica network catalyst was prepared by connecting silica nanoparticles with ionic liquid and followed reacting with phosphotungstate. A series of characterization methods were carried out to confirm the successful synthesis of the material. The synthetic catalyst was effective heterogeneous catalyst for the epoxidation of cyclooctene with H_2O_2 . Conversion and selectivity of epoxy-cyclooctene could both reach over 99% at 70 °C for 8 h using hydrogen peroxide as an oxidant in acetonitrile. Compared with silica nanoparticles, the reported work demonstrated that the inorganic-organic hybrid silica network performed as a more promising material in various fields for its collective properties: better pore structure, much easier to separate and, thus, to recycle.
